probe of FIG. 1;

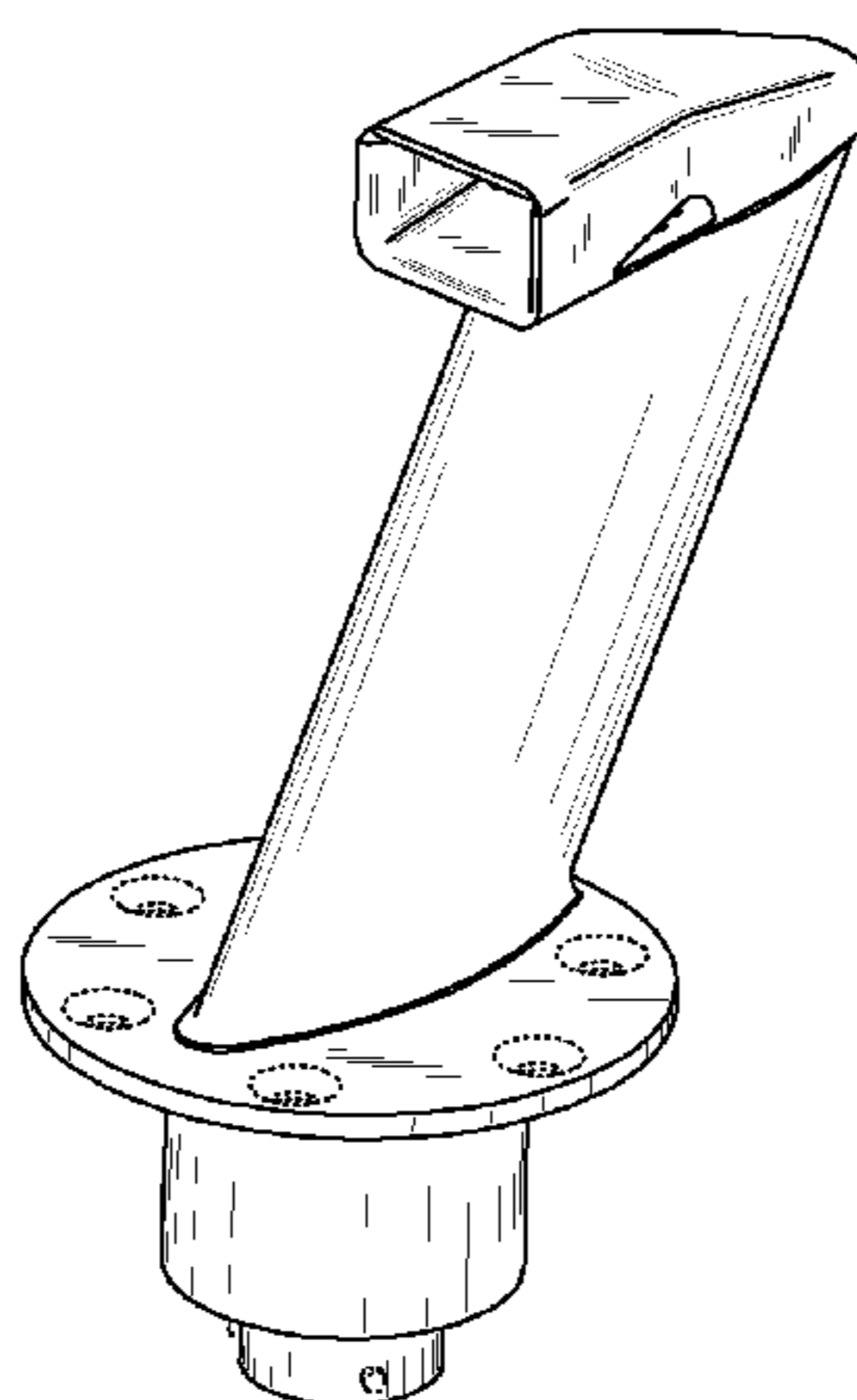
FIG. 5 is a rear elevational view of the total air temperature

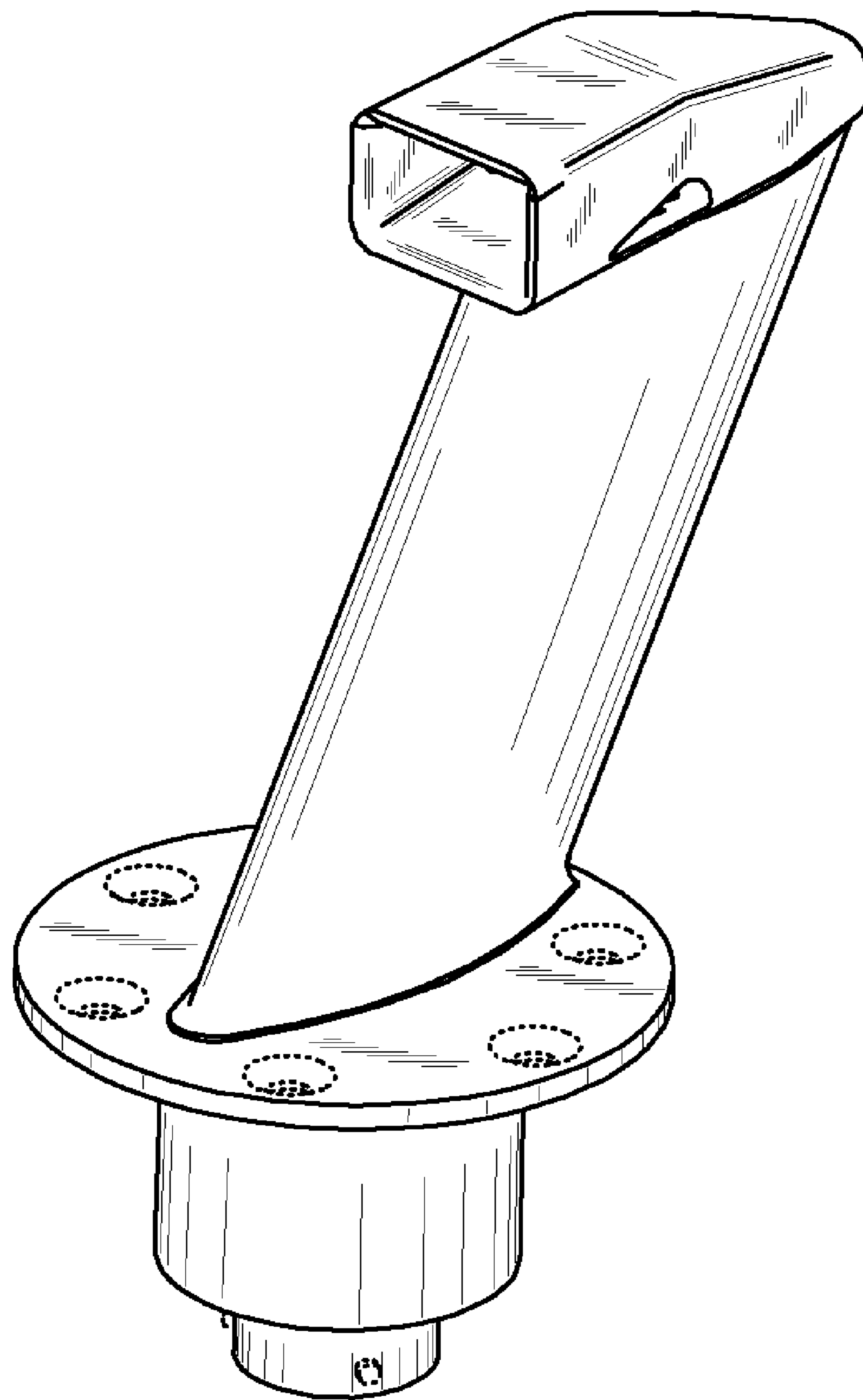

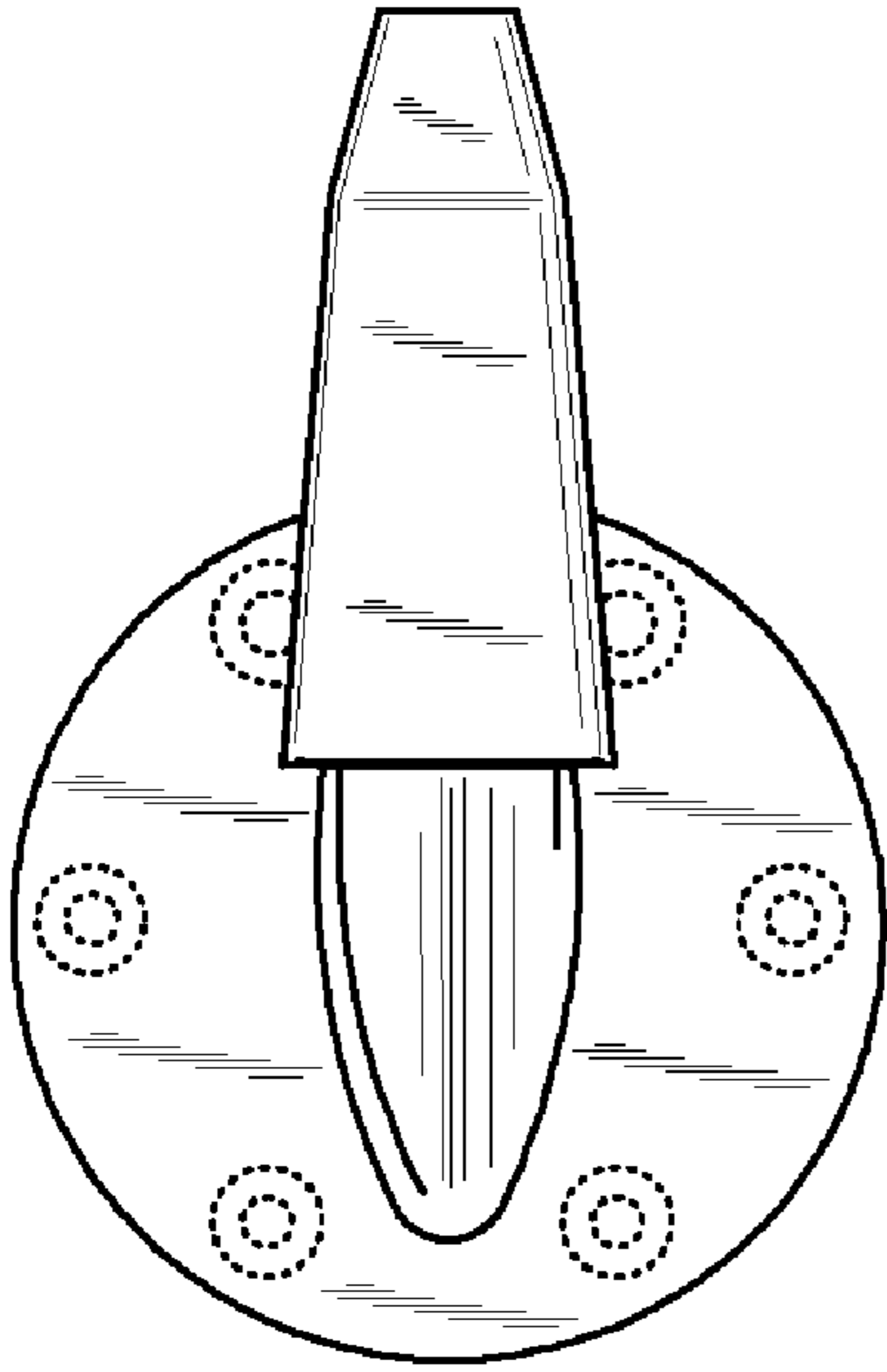
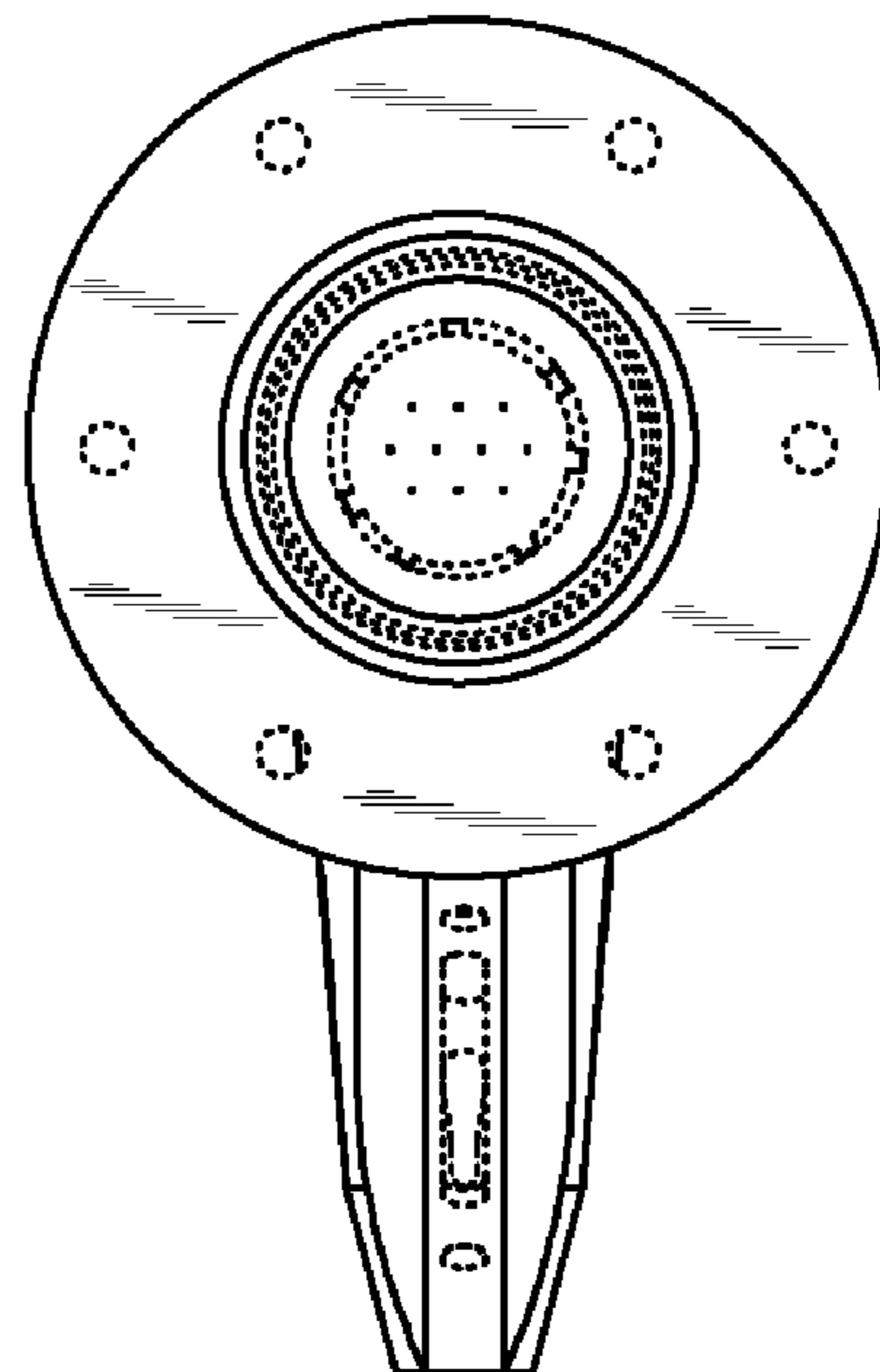

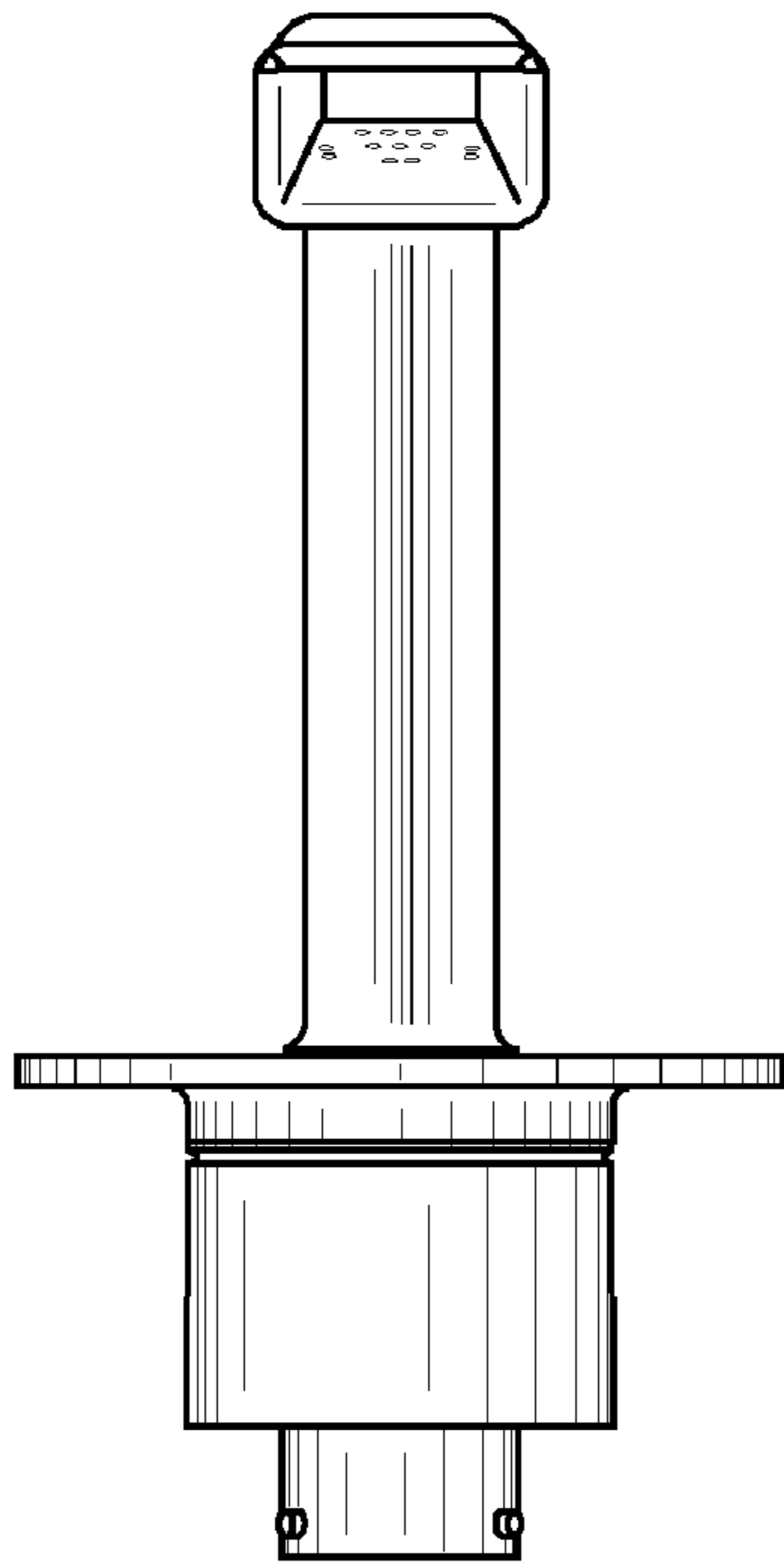
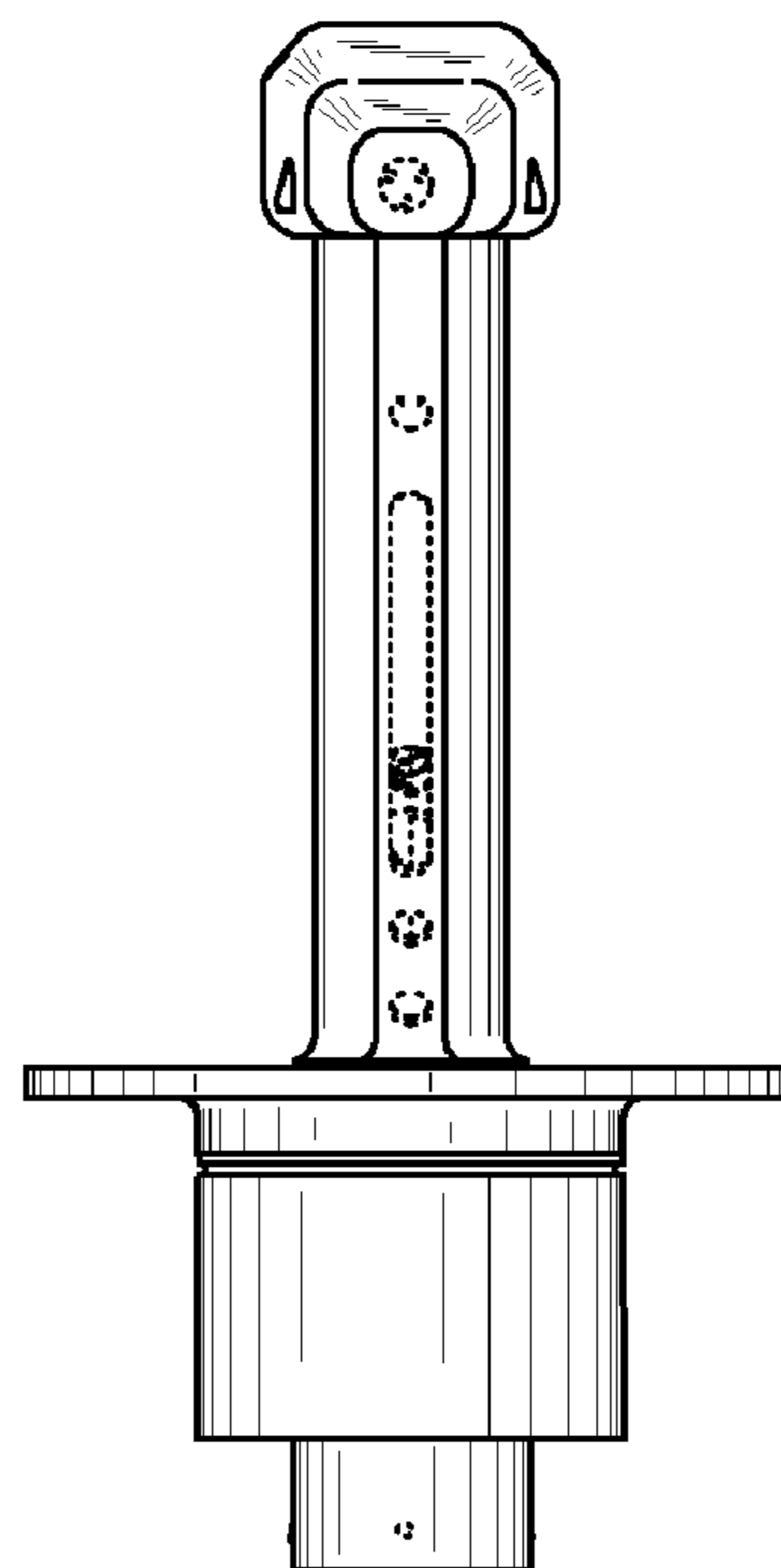

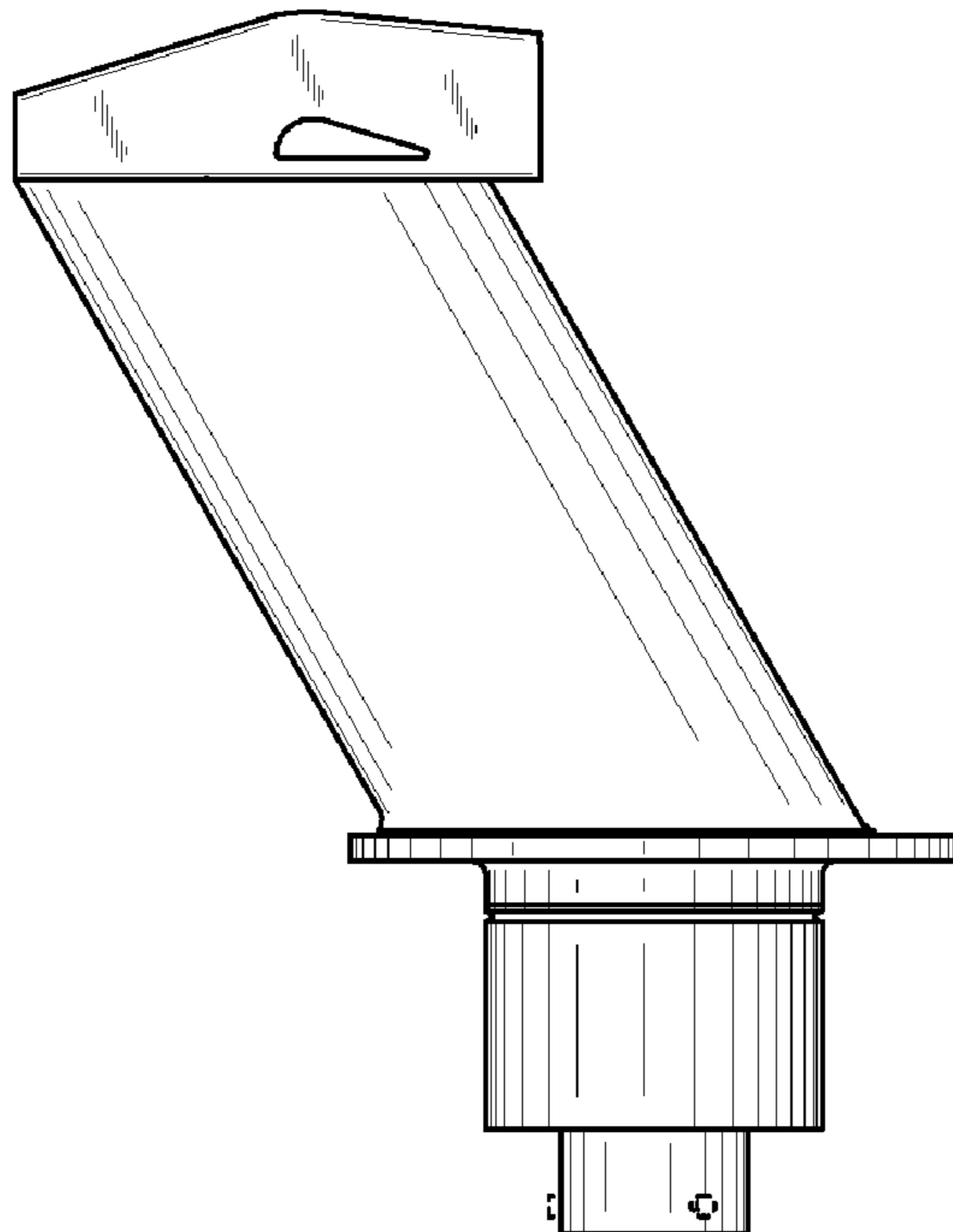
