DESCRIPTION

FIG. 1 is a perspective view of a fire alarm sounder showing my new design;

FIG. 2 is a front elevational view thereof;

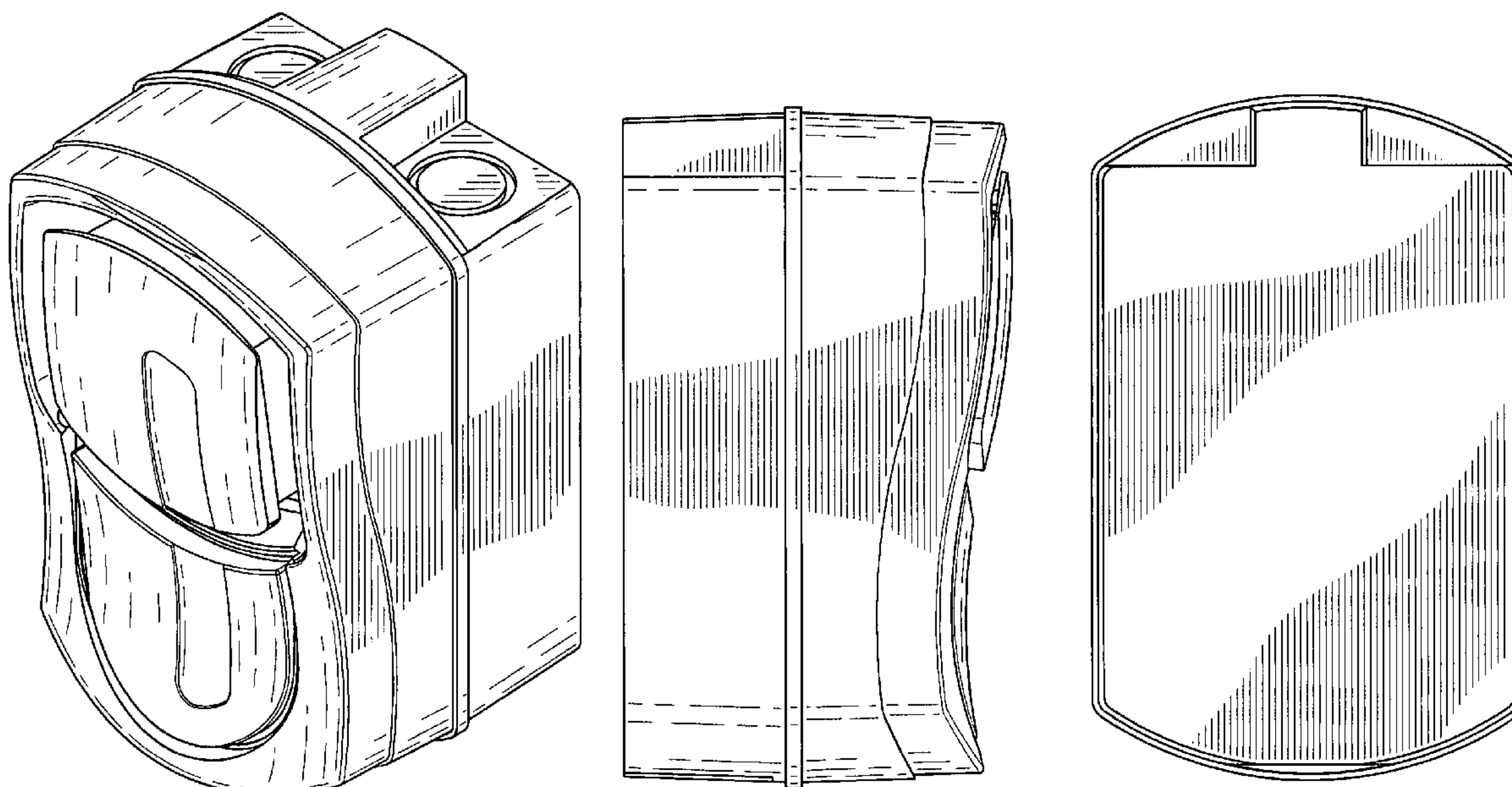
FIG. 3 is a side elevational view, the opposite side elevational view being a mirror image thereof;

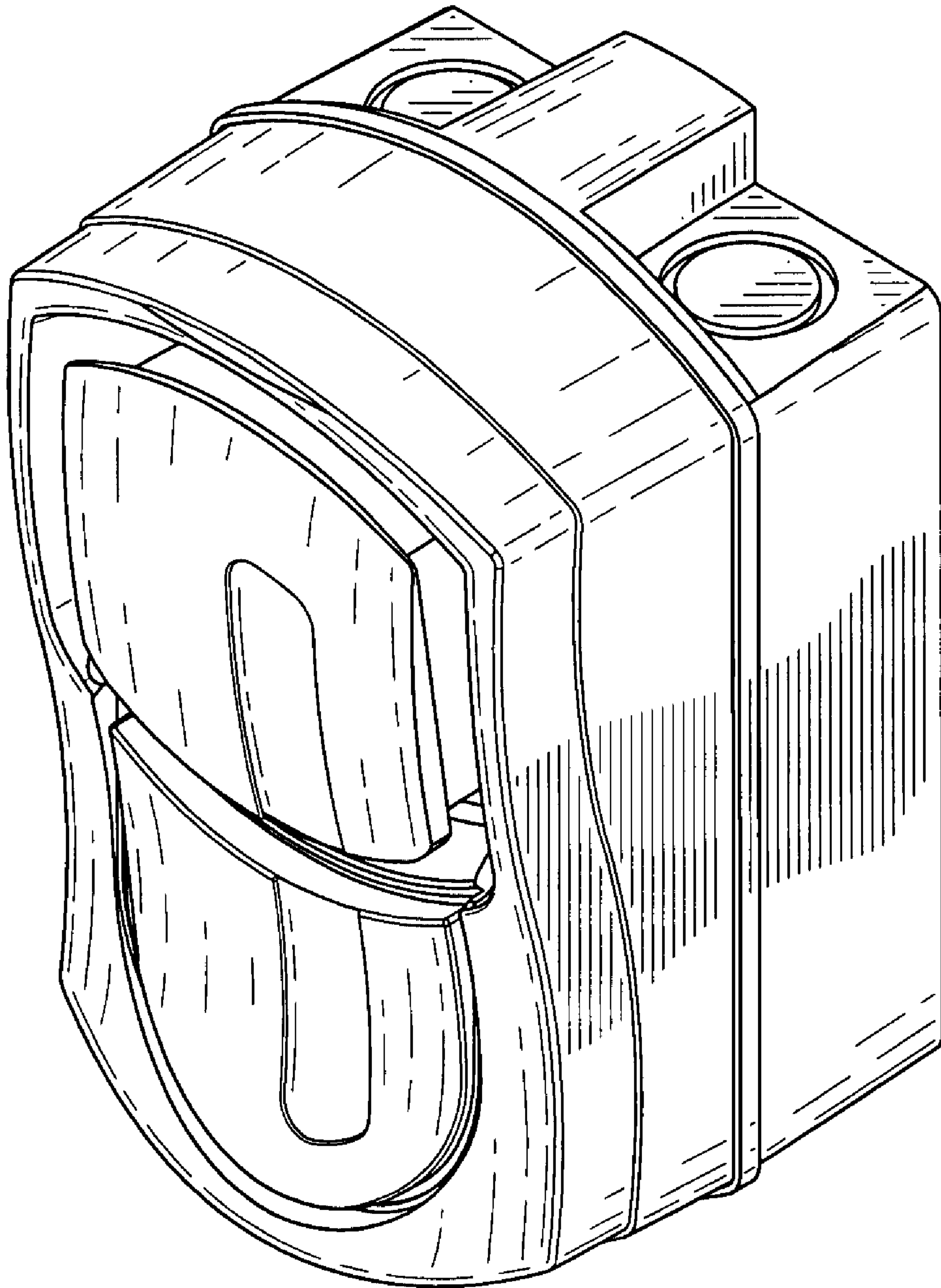

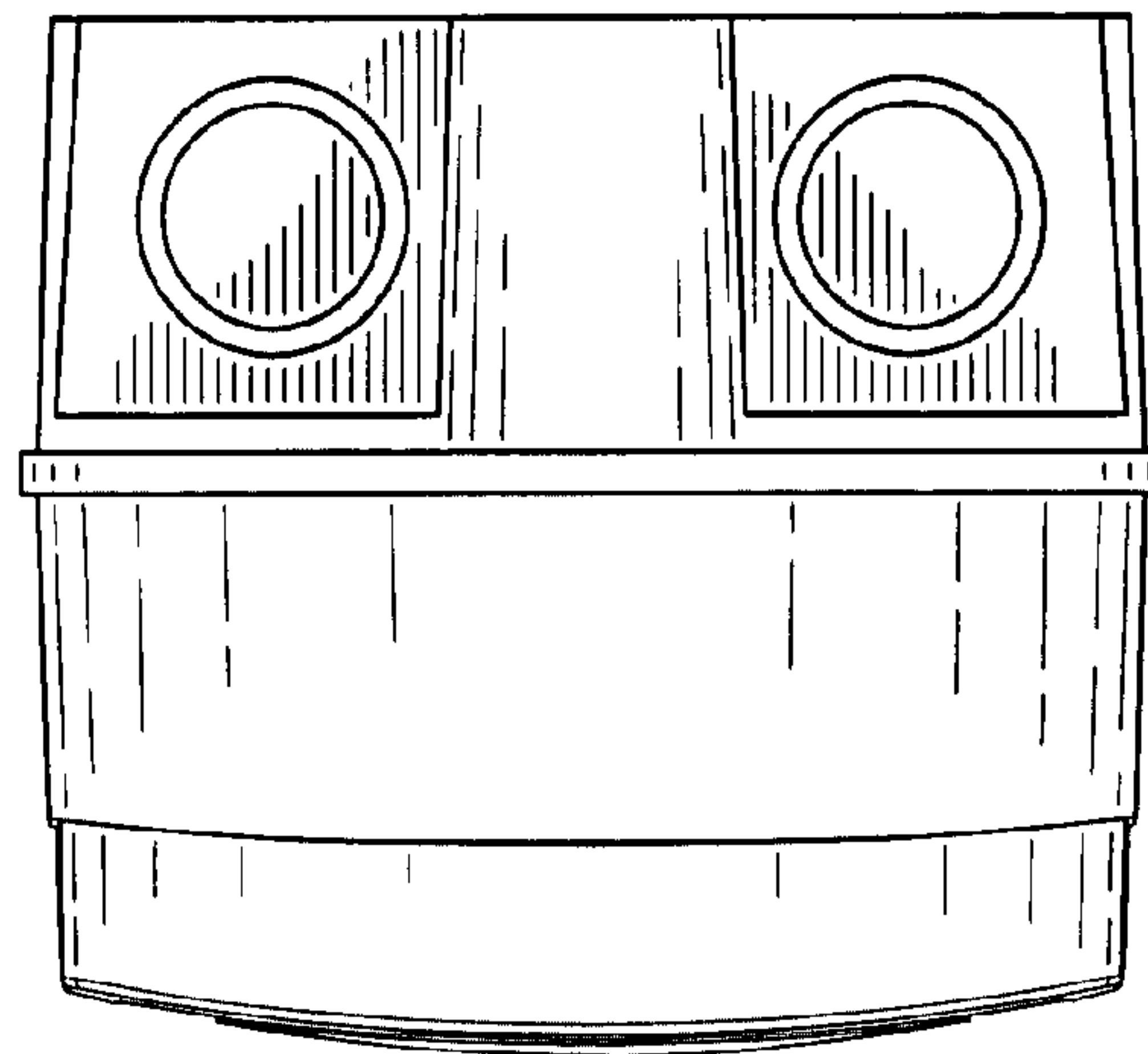

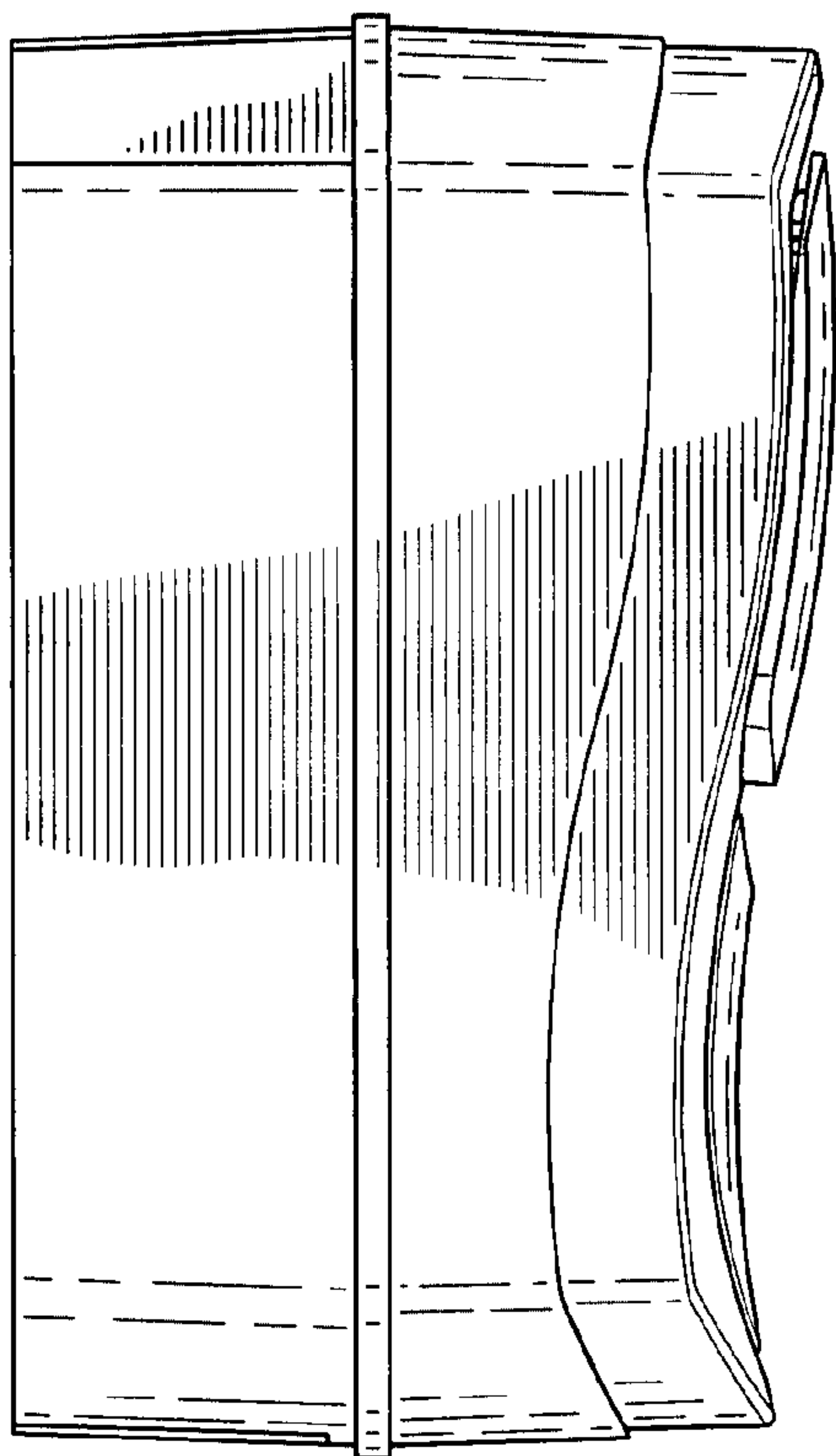

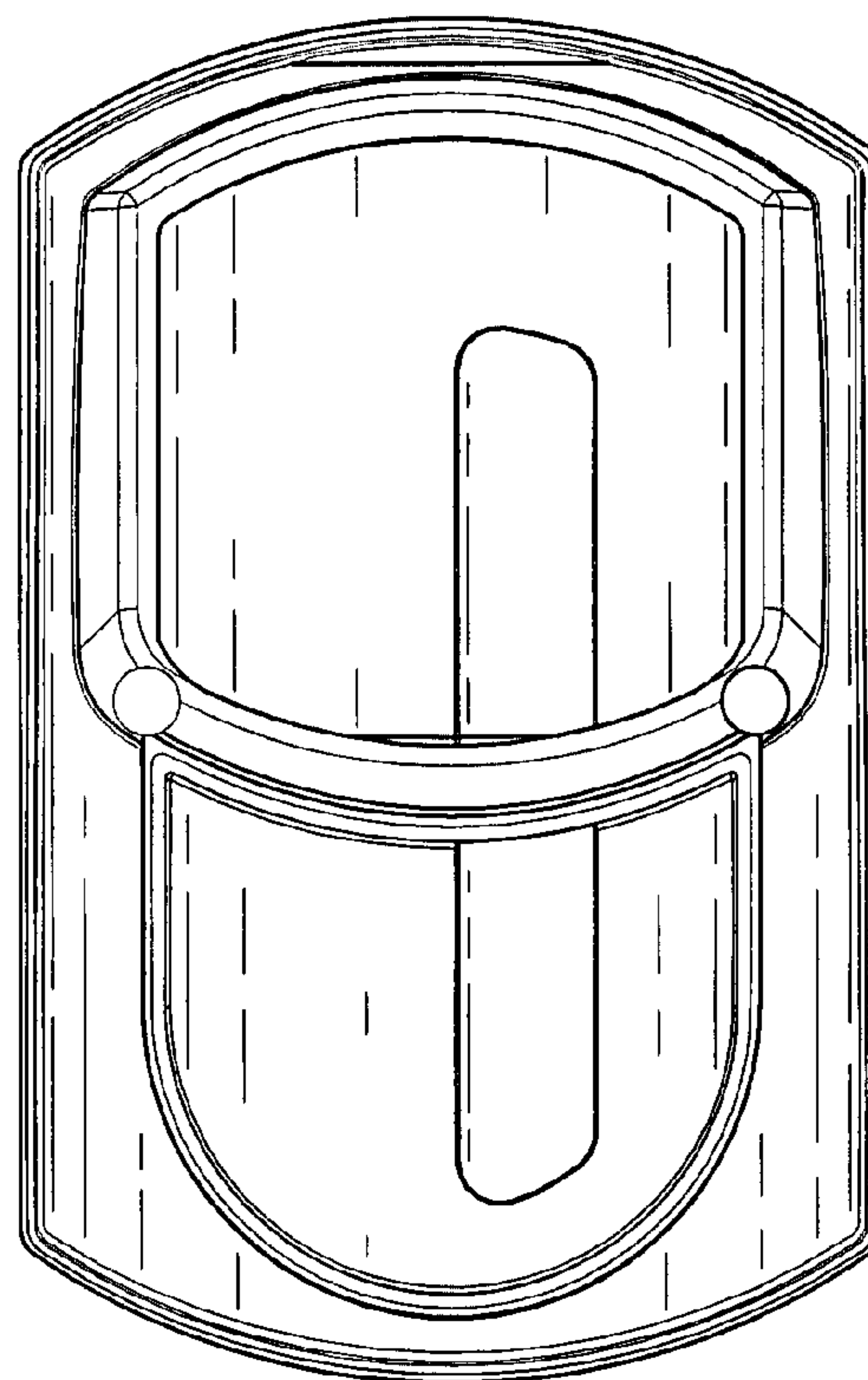

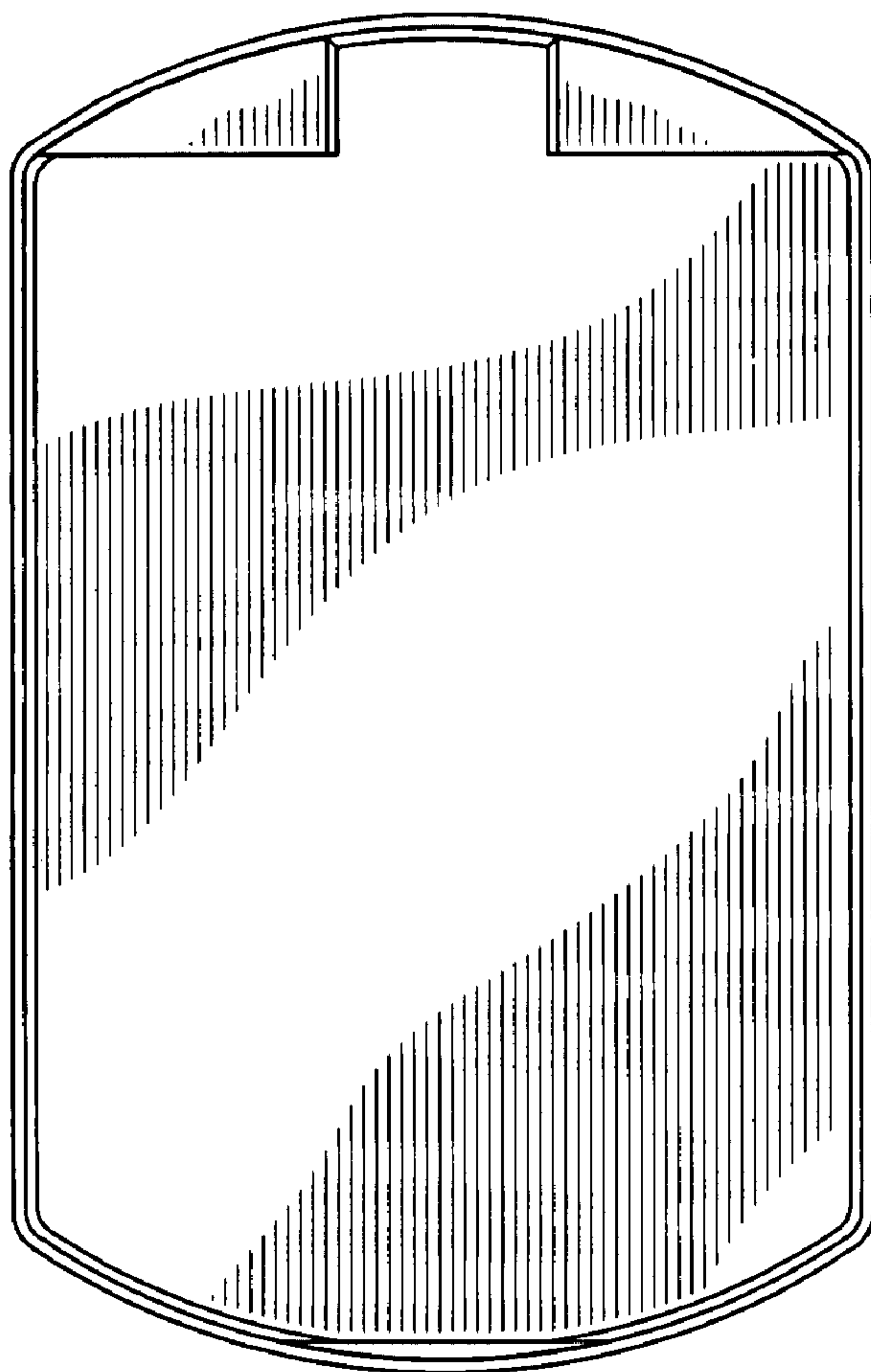

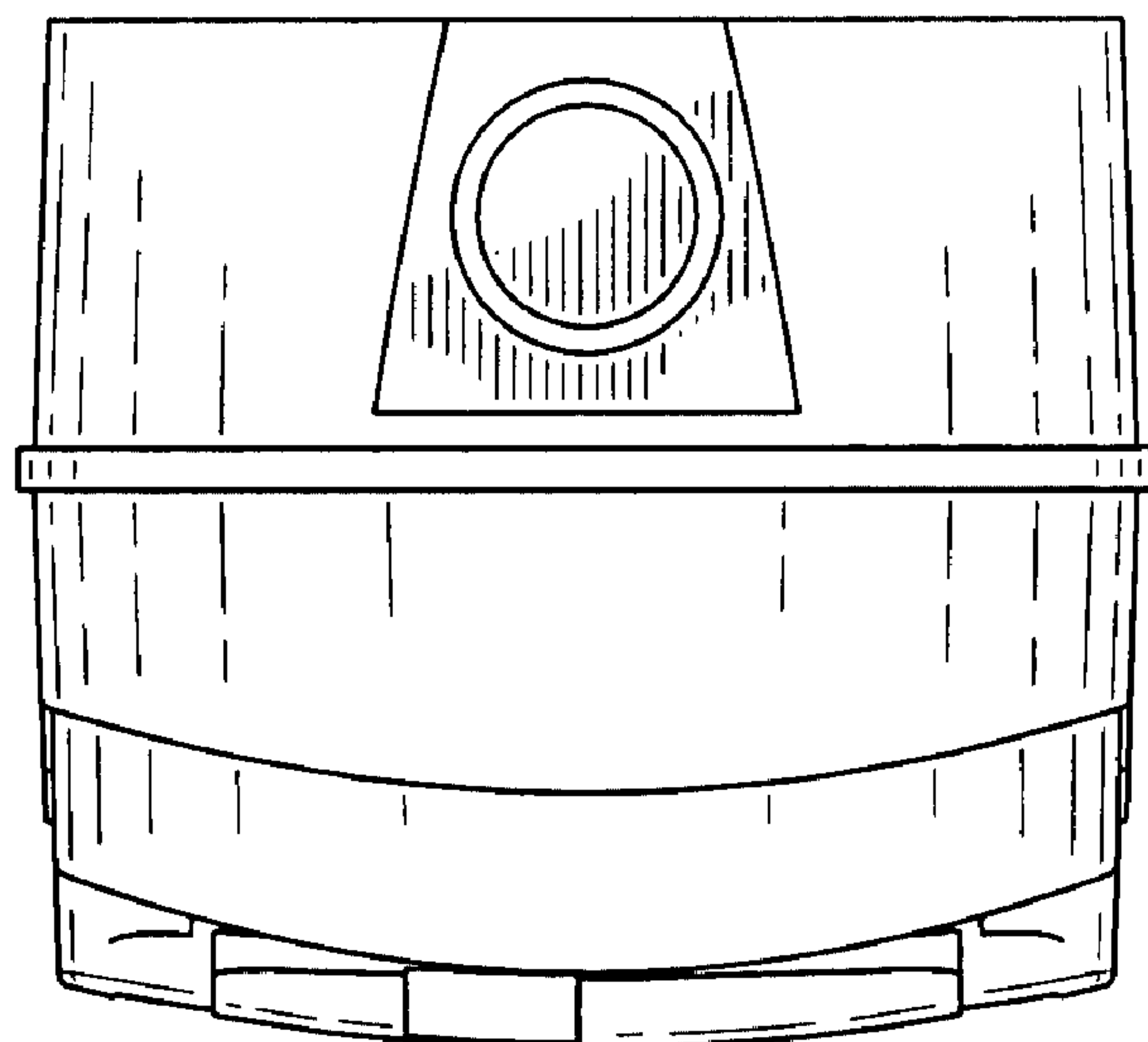
