FIG. 3 is a back plan view thereof;

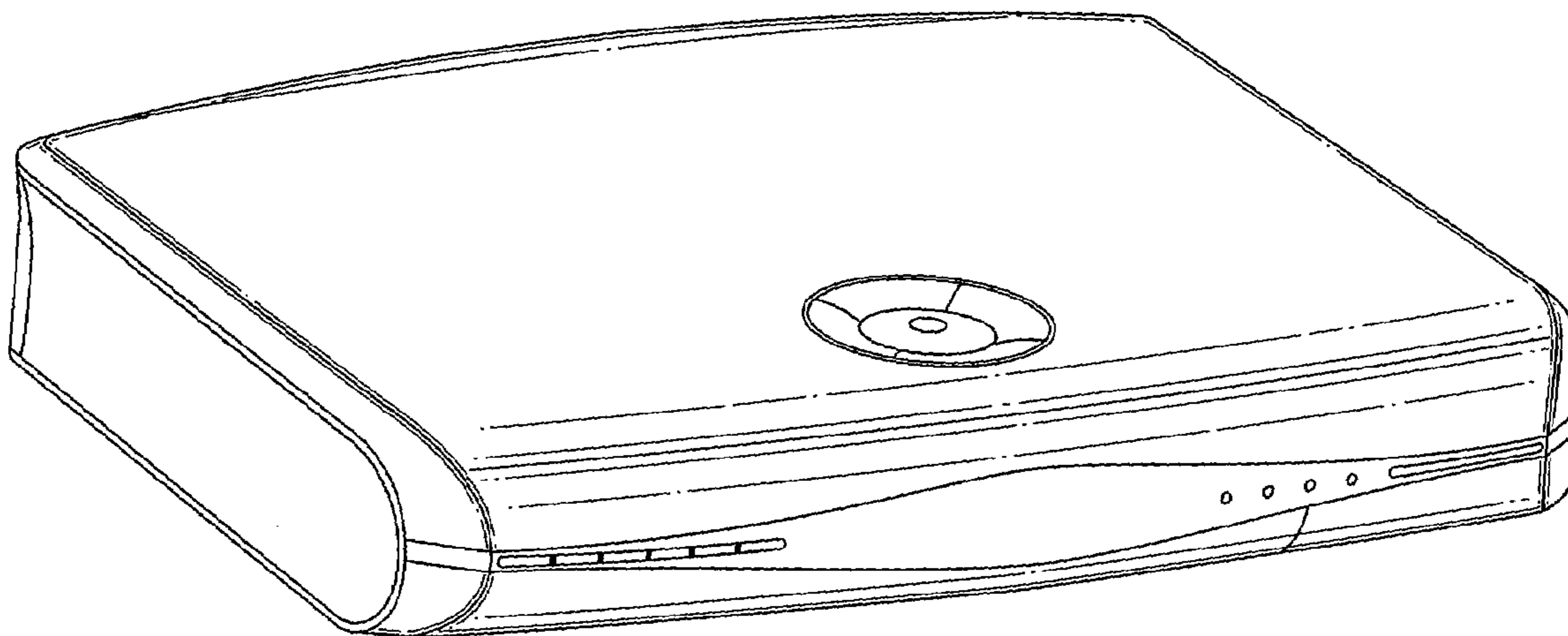
FIG. 4 is a side plan view of one side thereof;

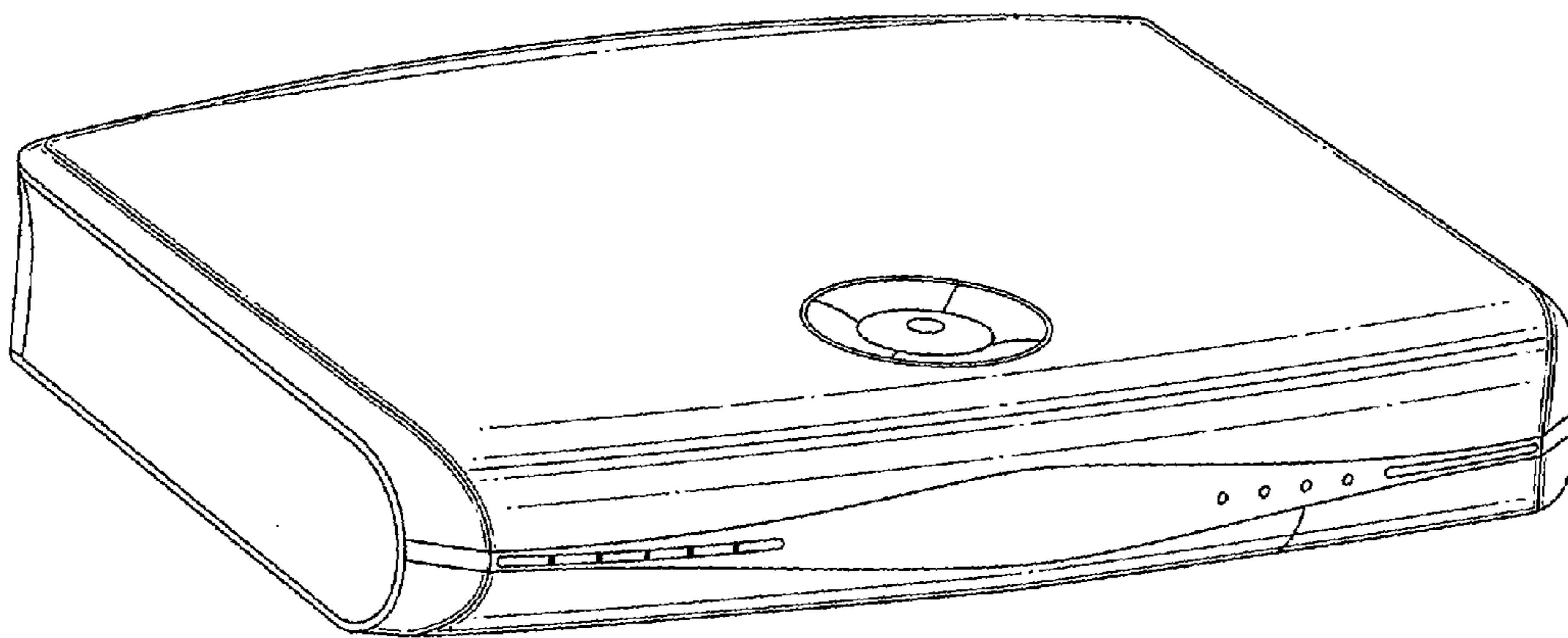

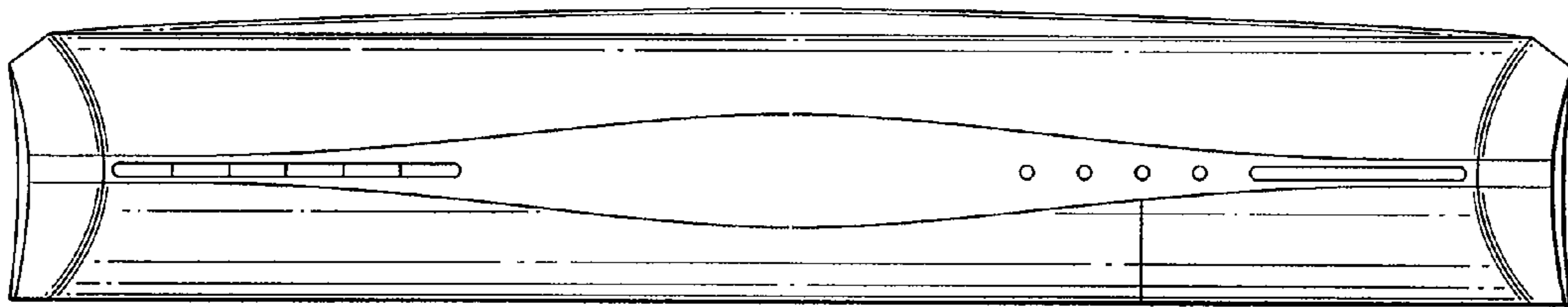

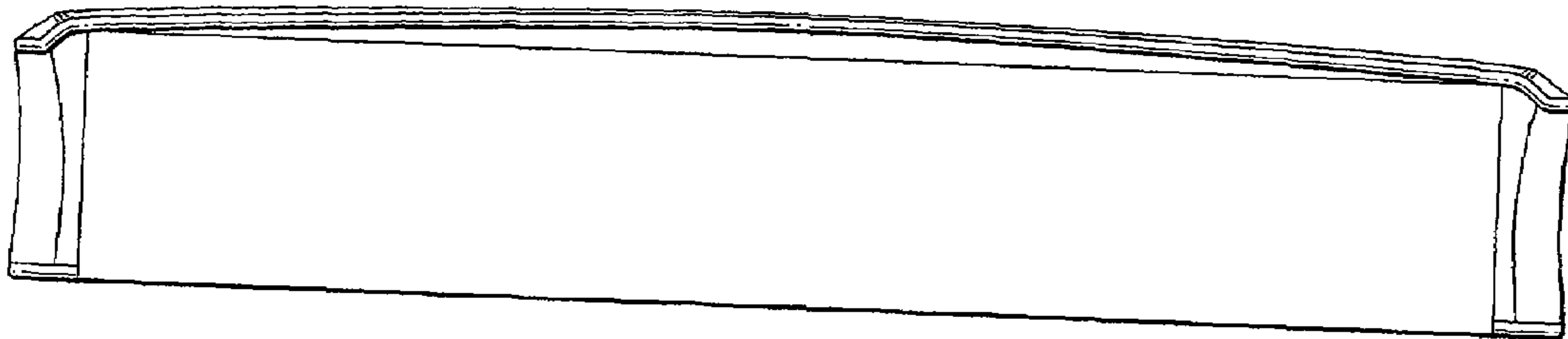

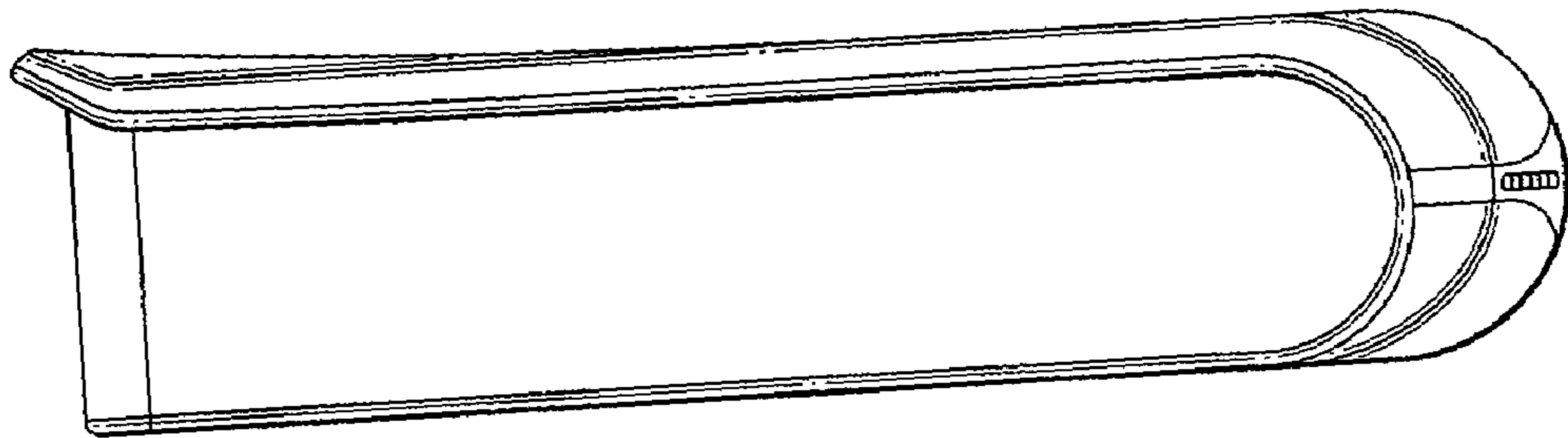

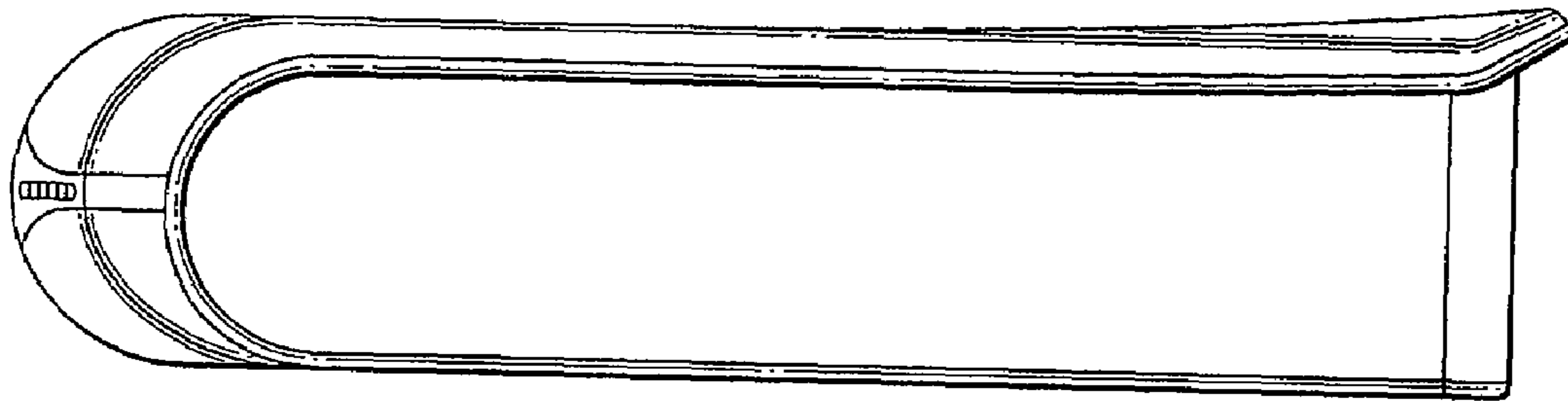

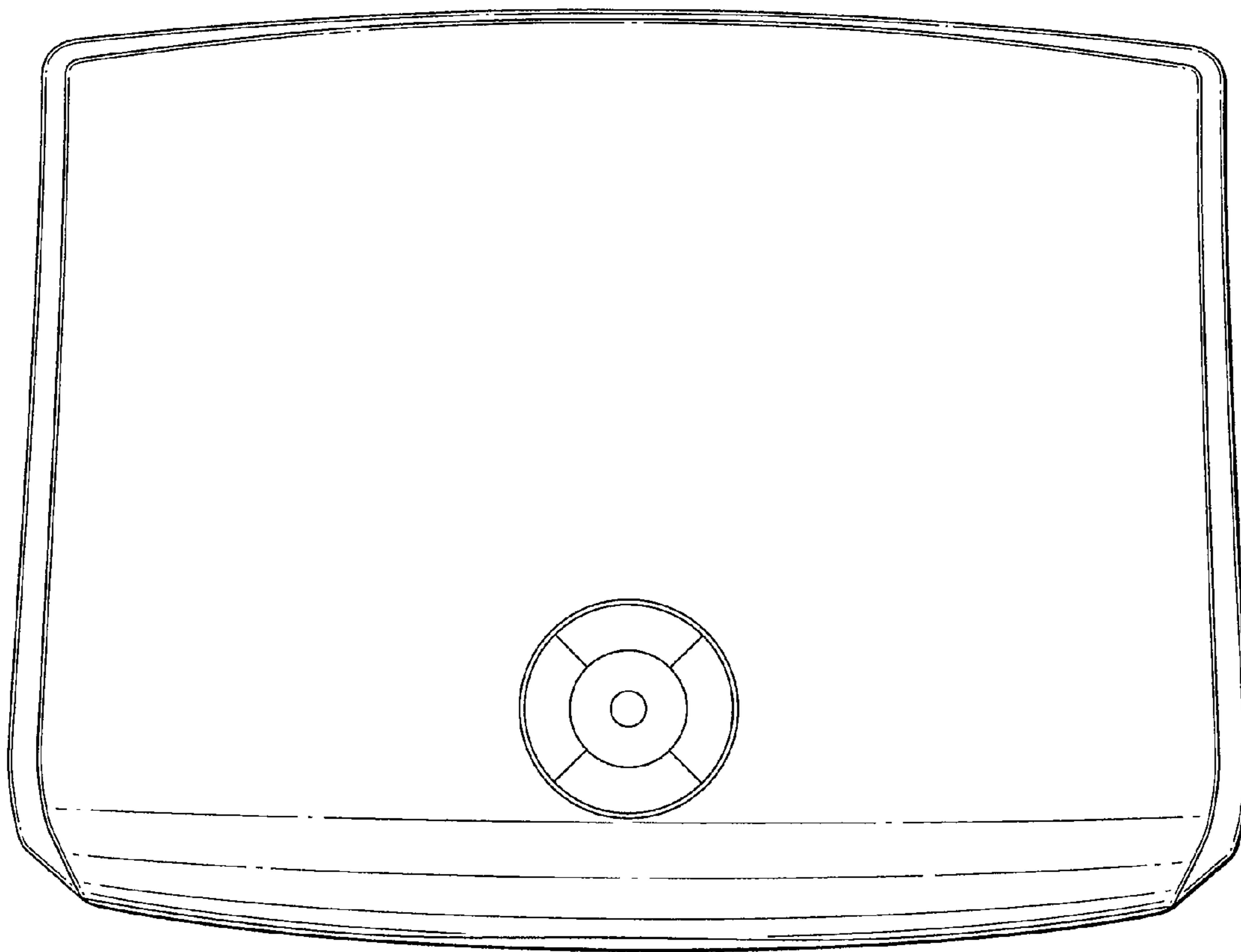

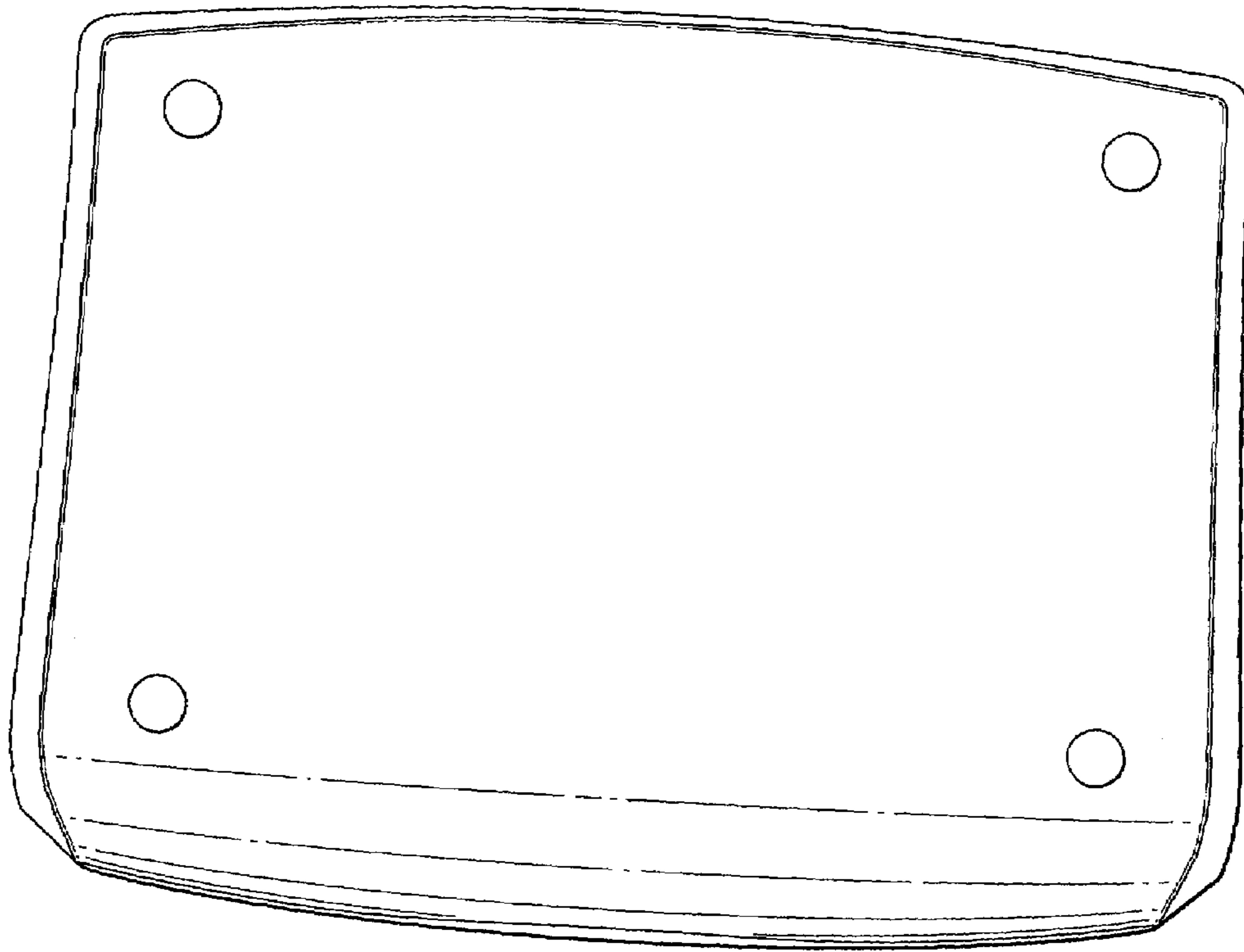
