(57) **CLAIM**

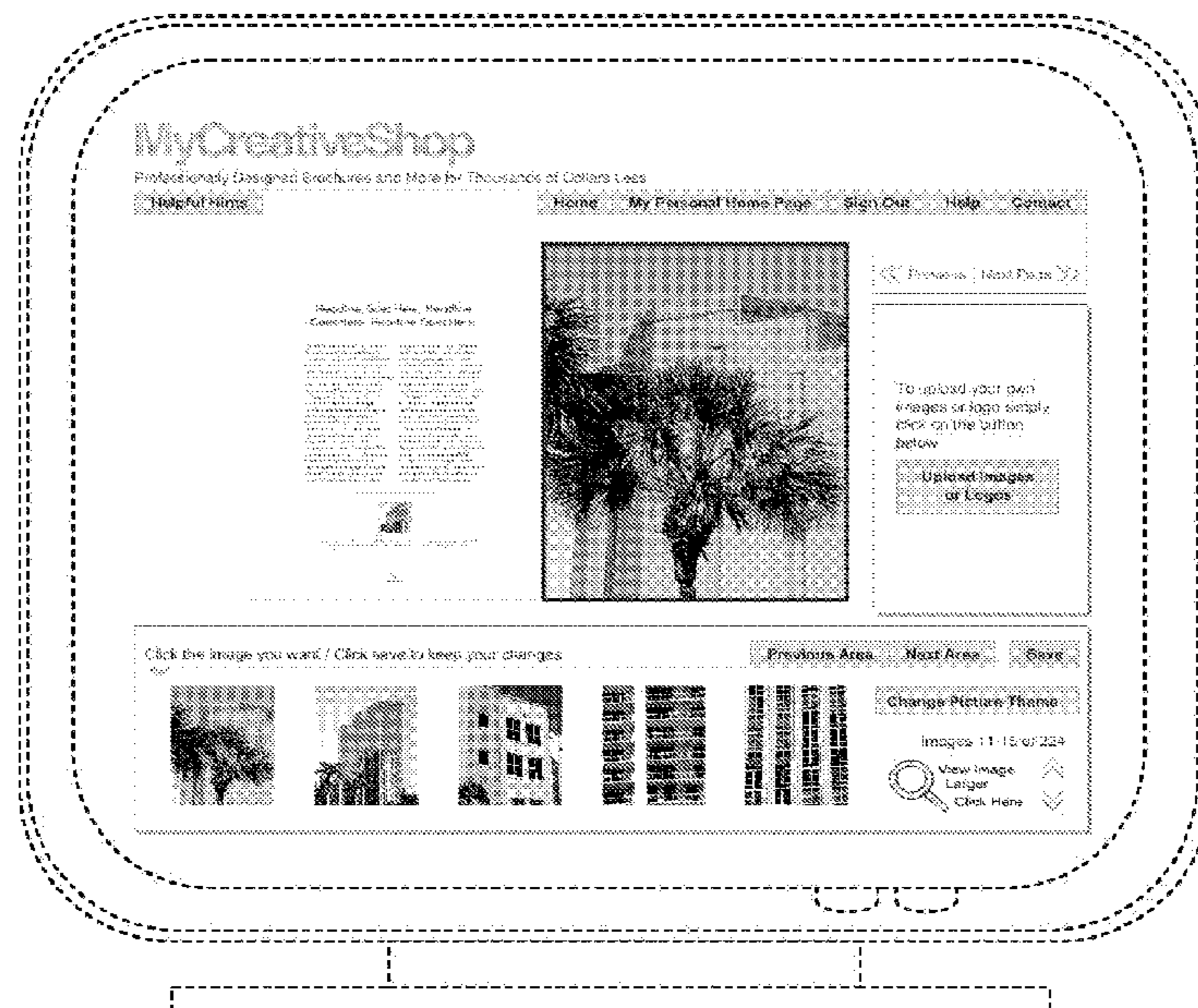
I claim the ornamental design for a computer graphical interface for designing brochures with a computer monitor, as shown and described.
