The ornamental design for a portion of a computer screen with an icon image, as shown and described.

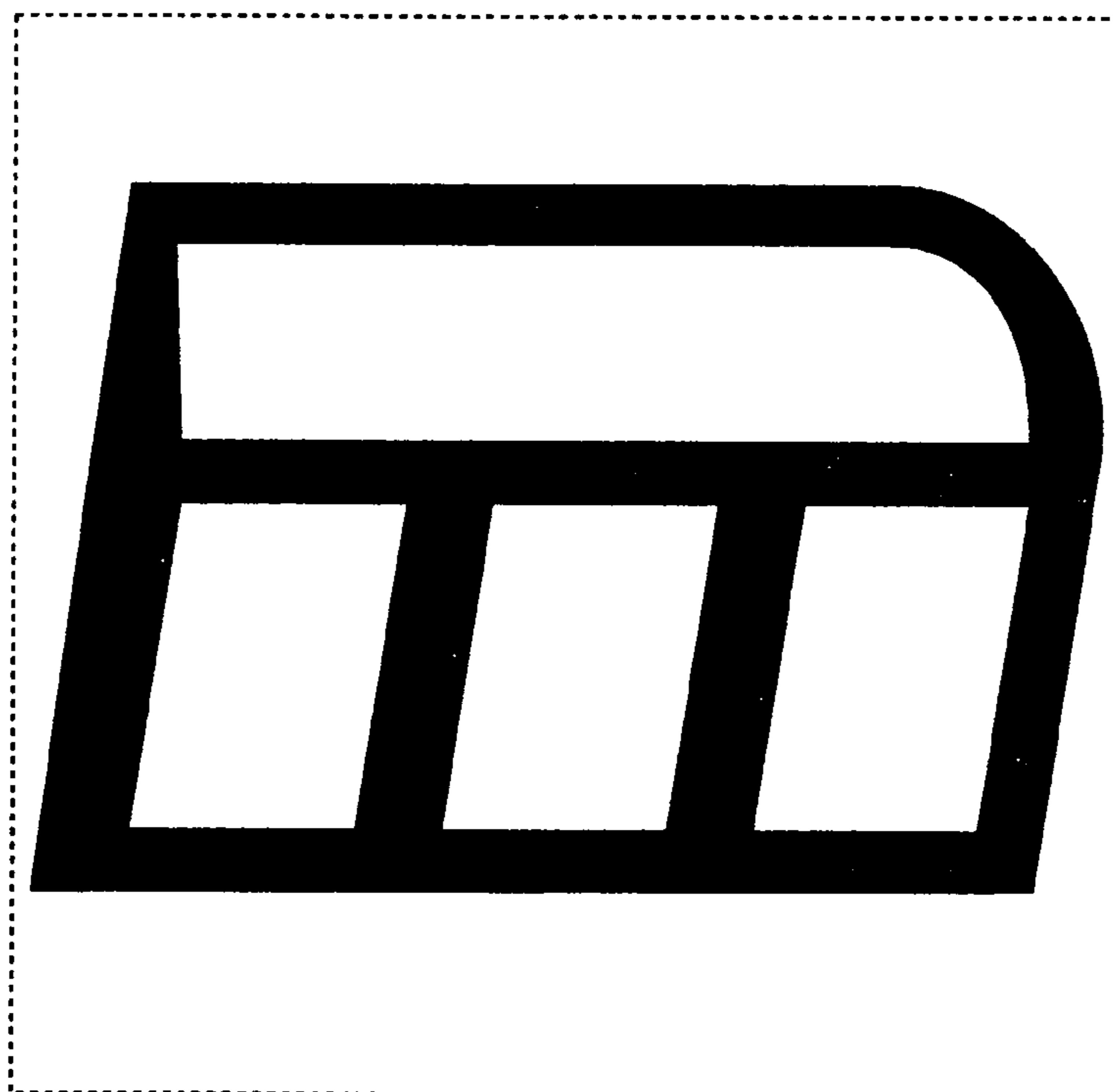
DESCRIPTION

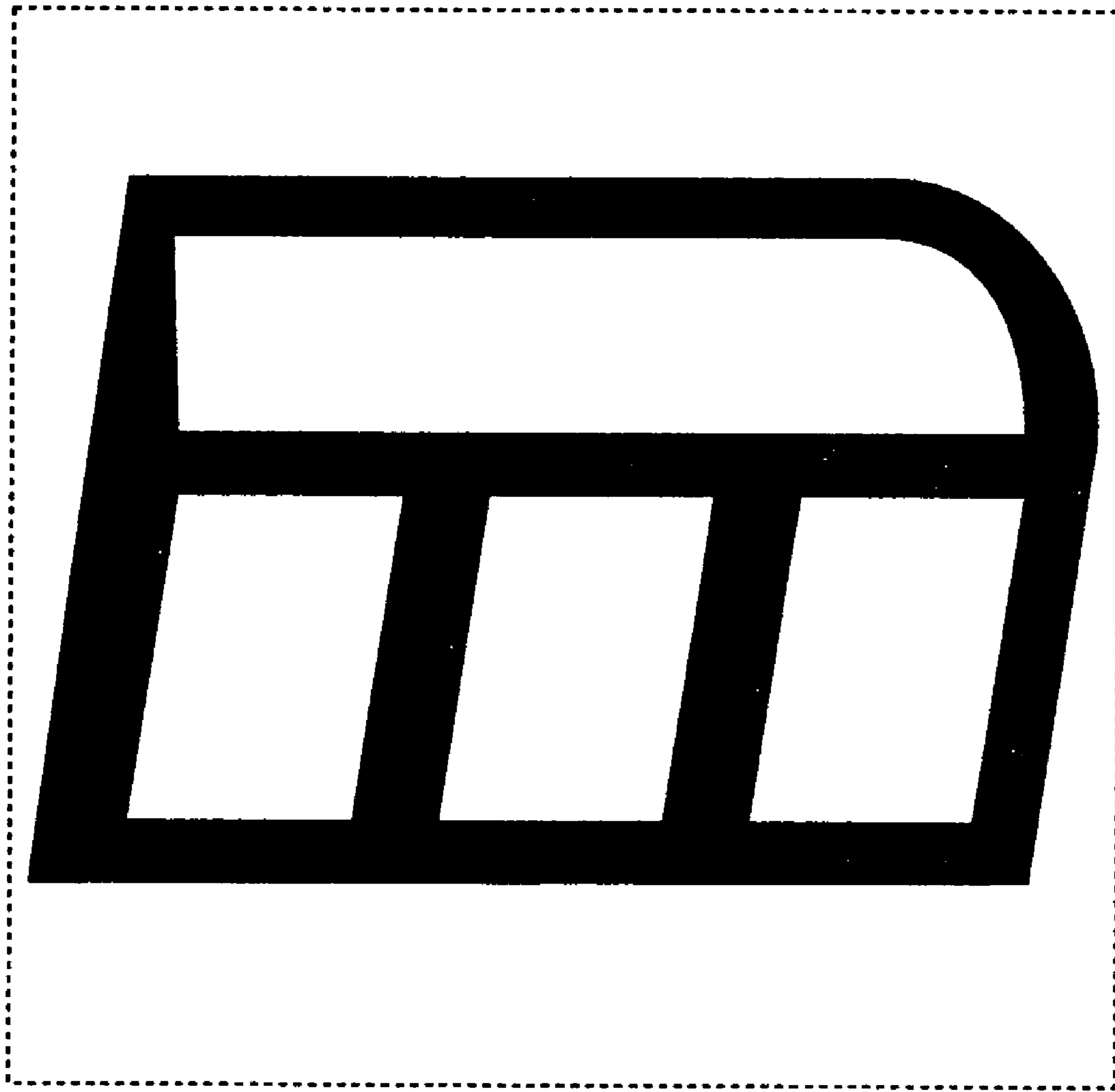

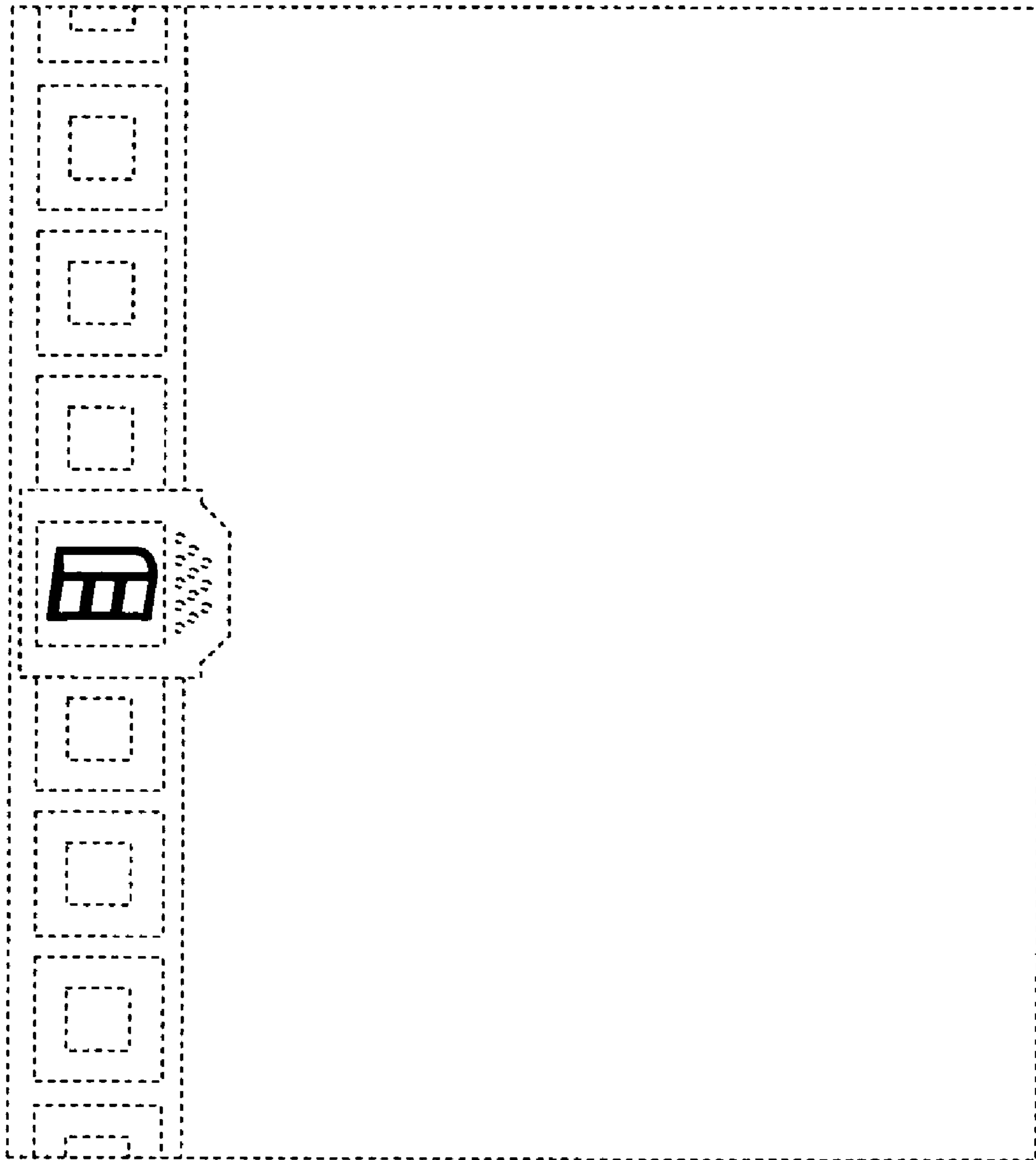
