The ornamental design for a vertical support for books and other bound items, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side perspective view of a vertical support for books and other bound items showing the present invention;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a right front perspective view in use, thereof; and,

FIG. 4 is a front elevational view, thereof.

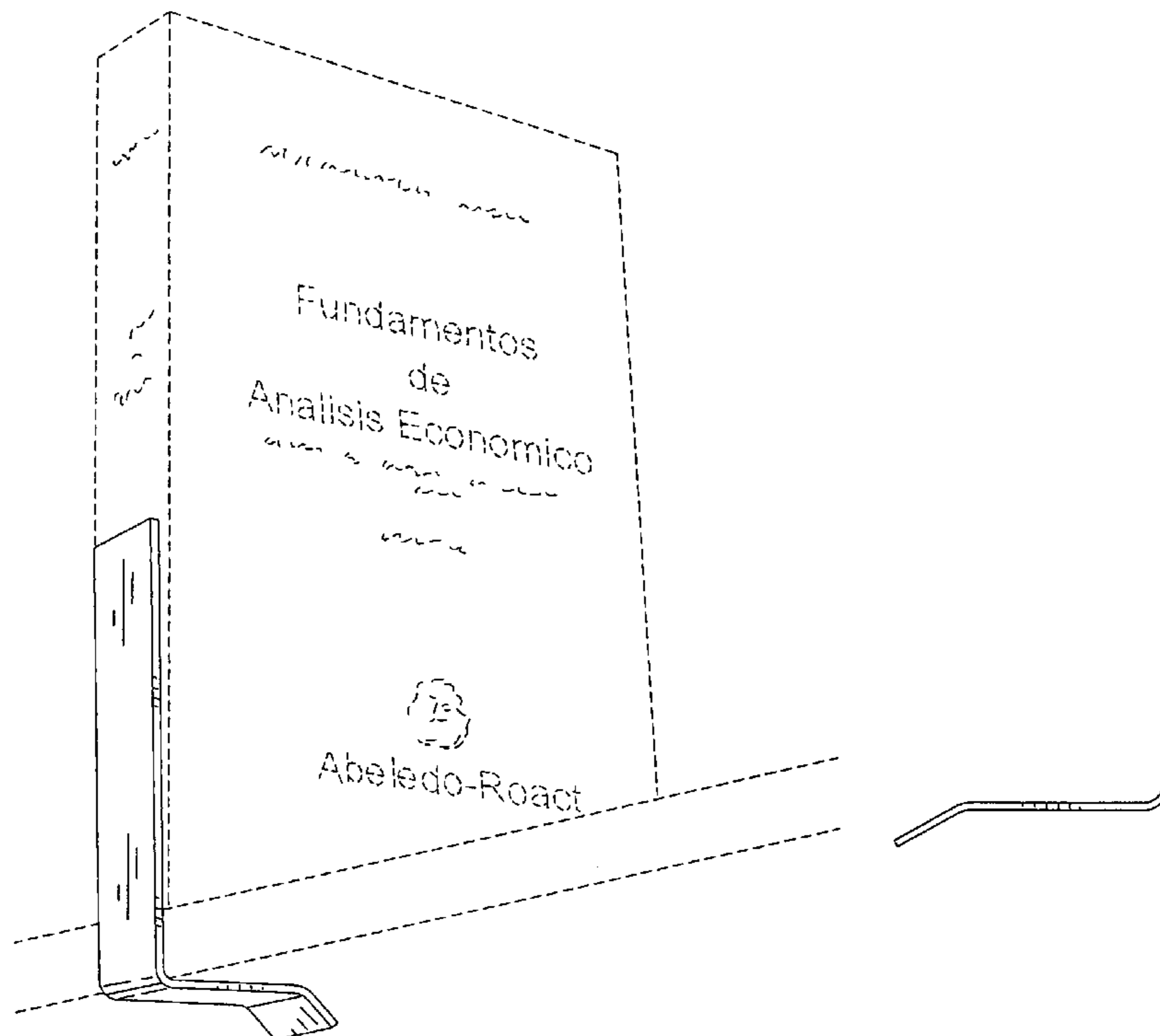

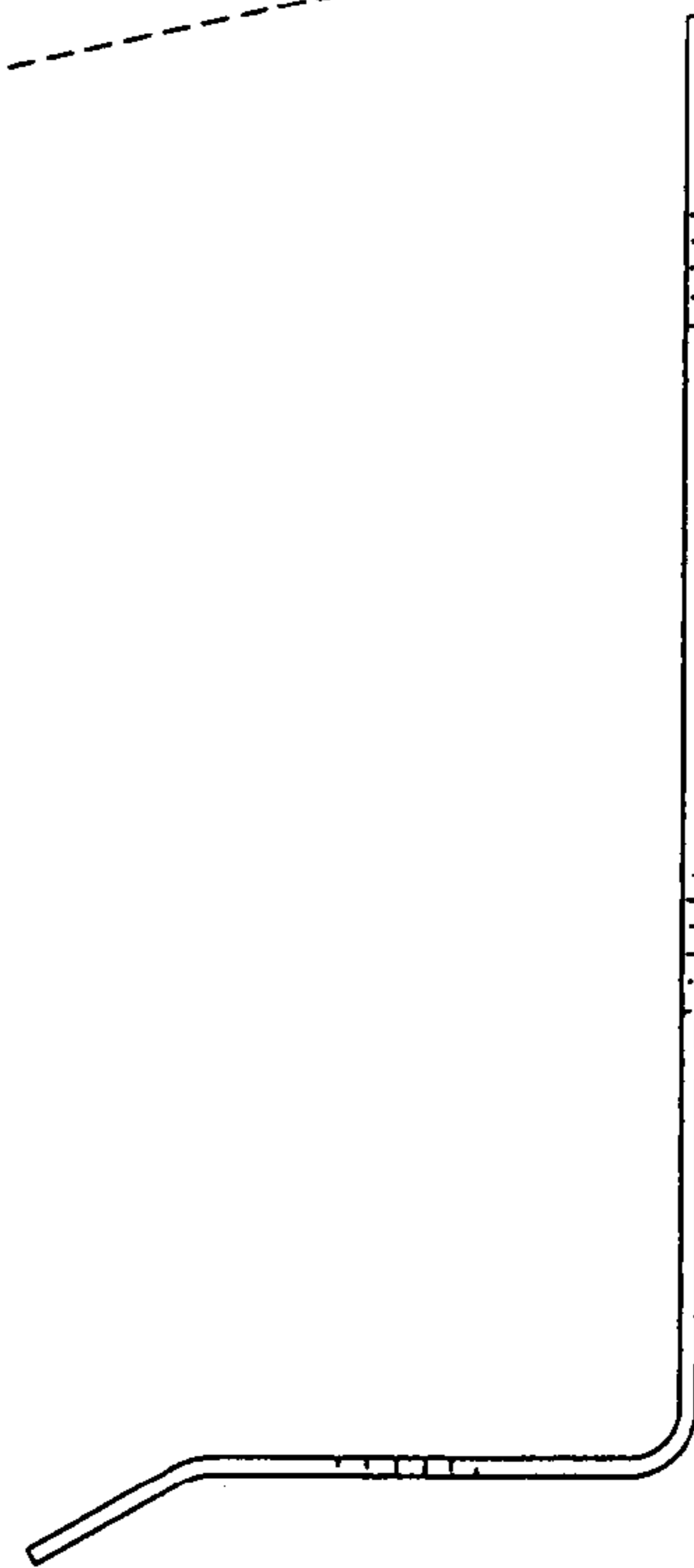
