FIG. 3 is a rear view of the dry erase board of FIG. 1;

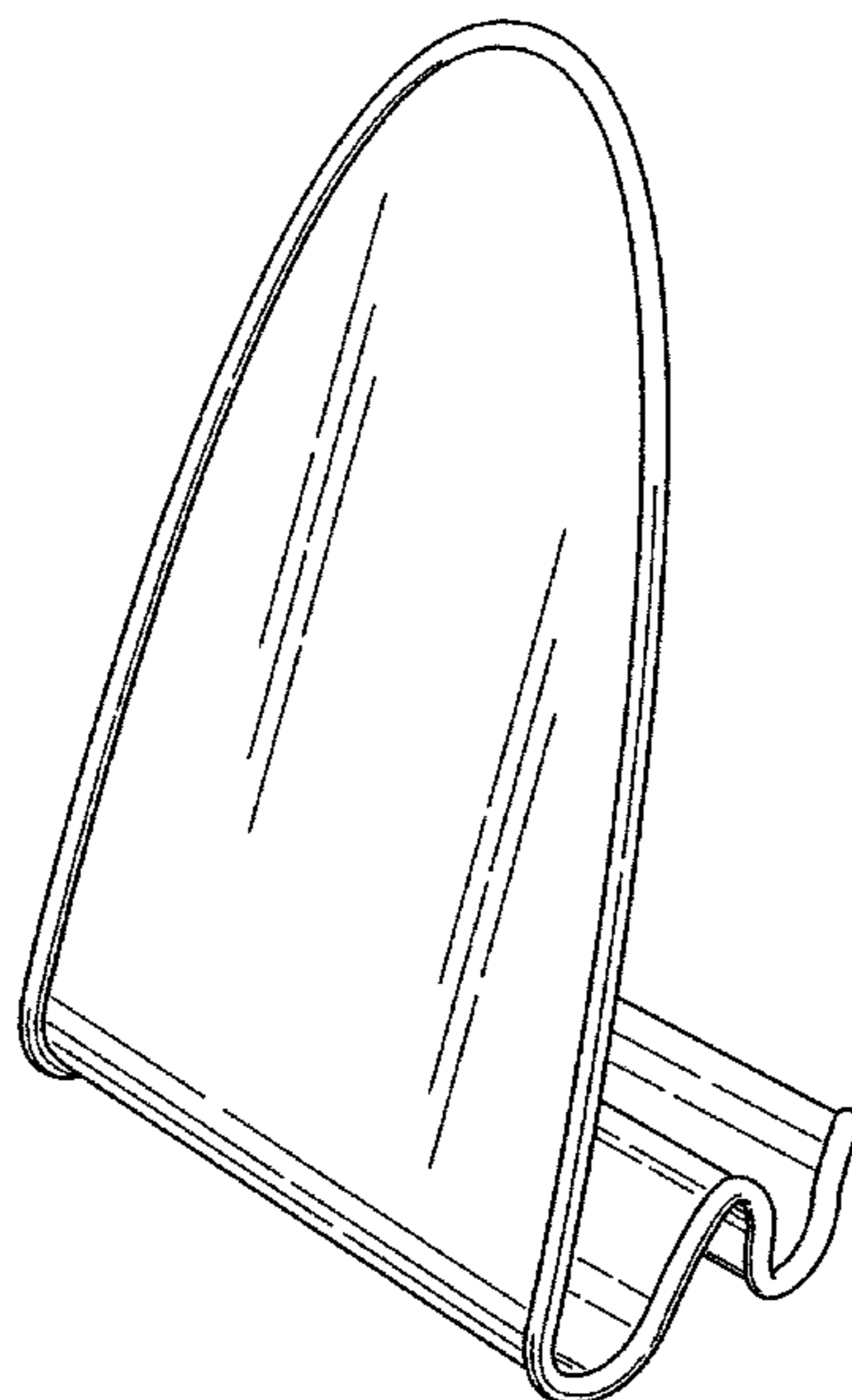
FIG. 4 is a side view of the dry erase board of FIG. 1;

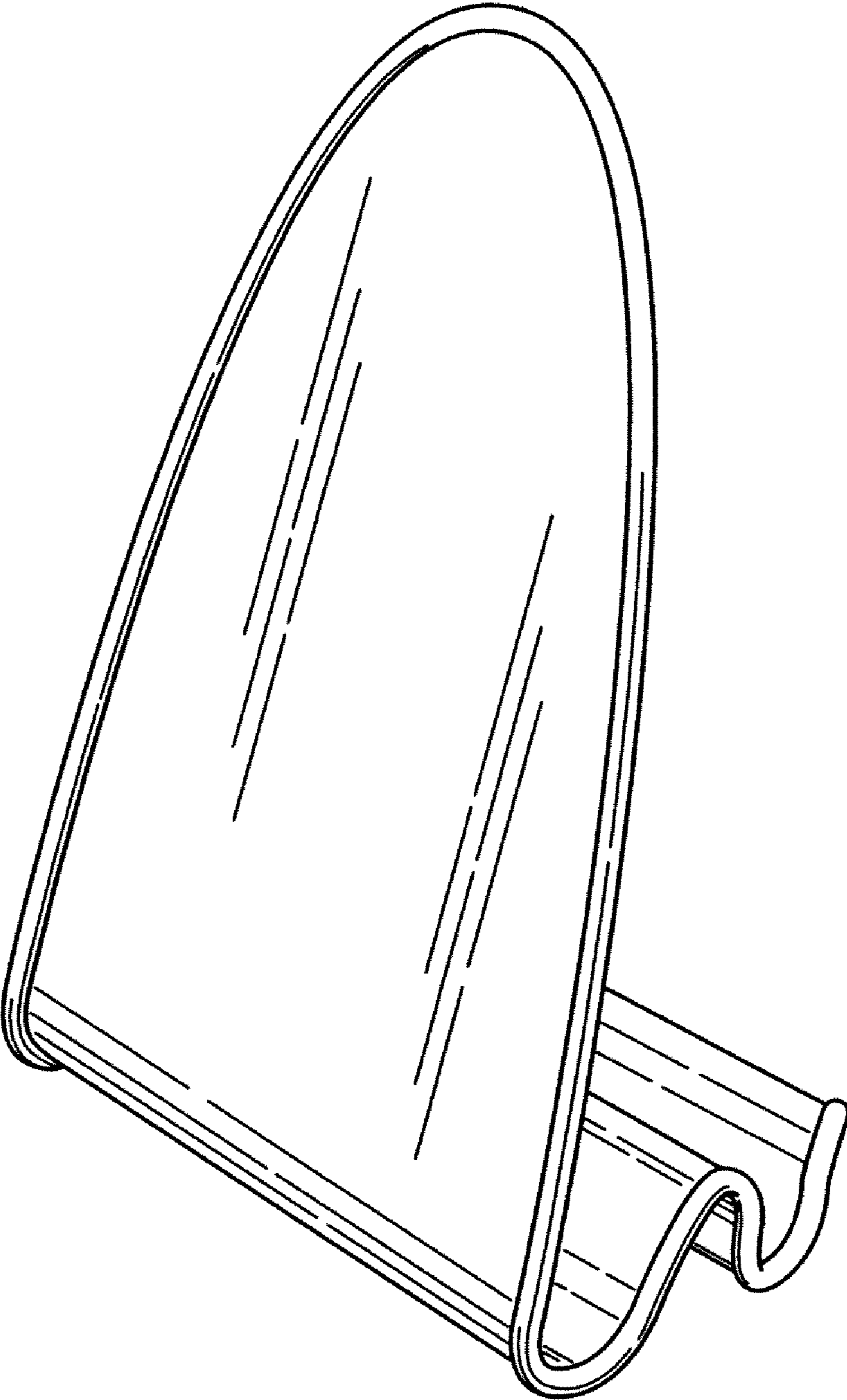

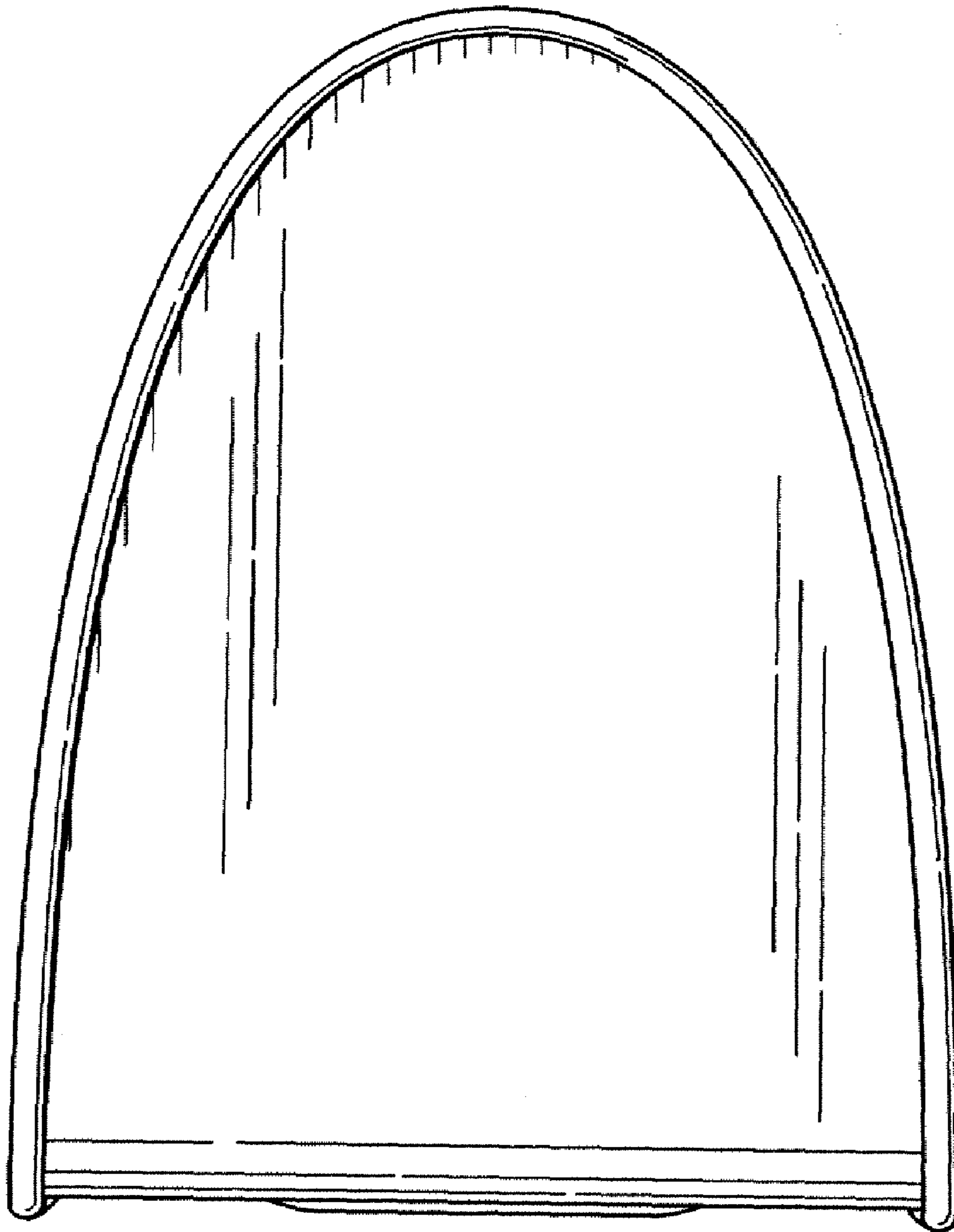

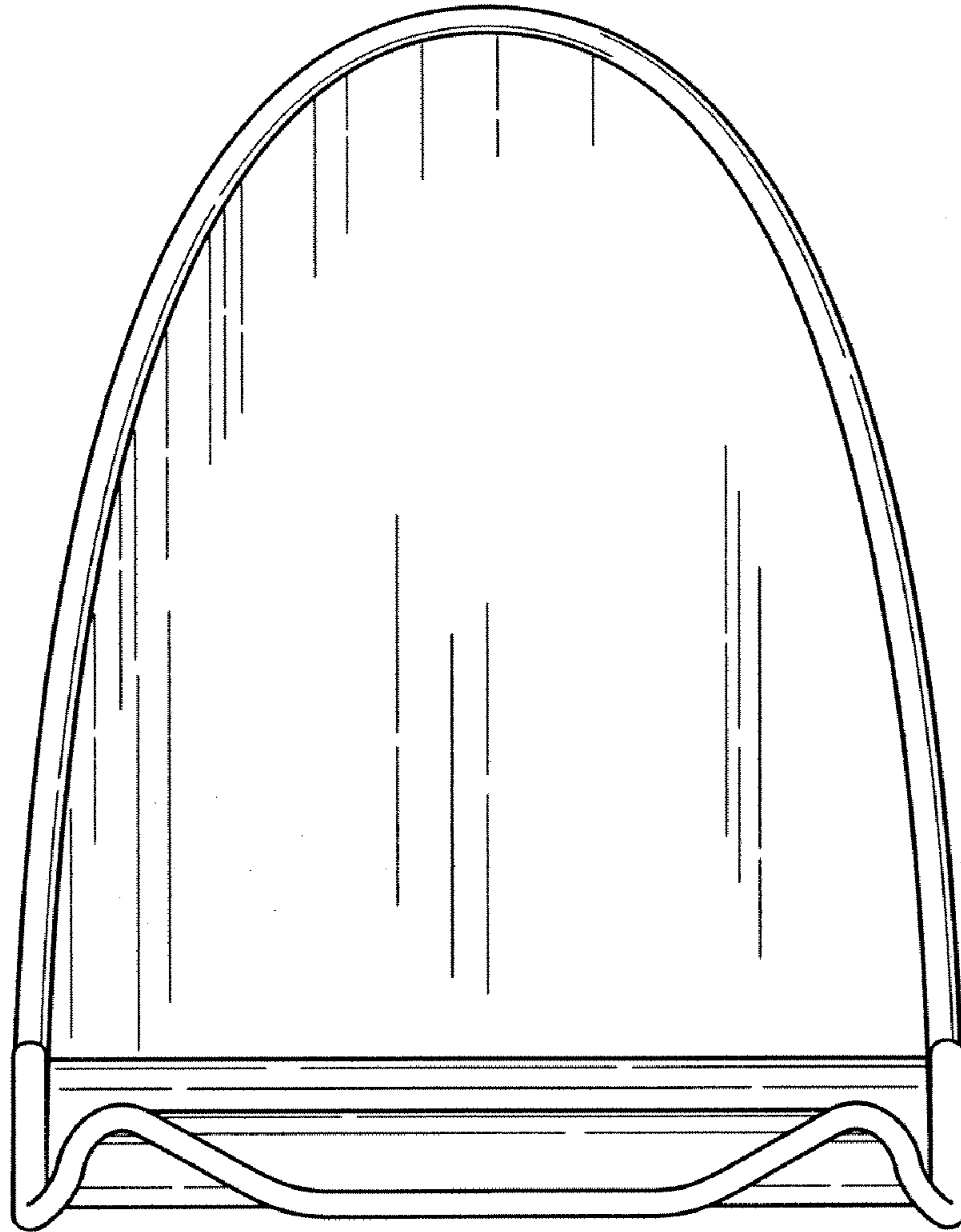

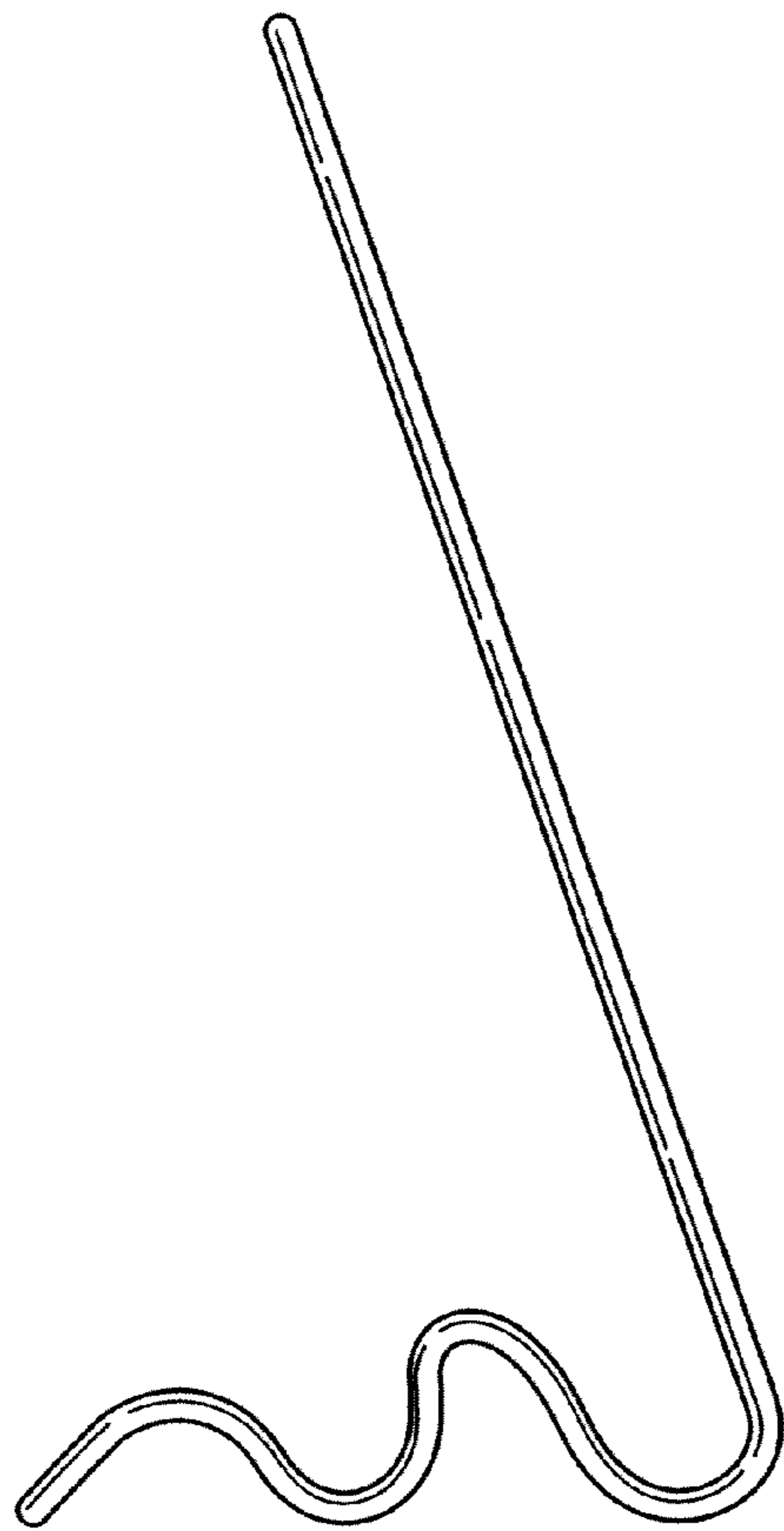

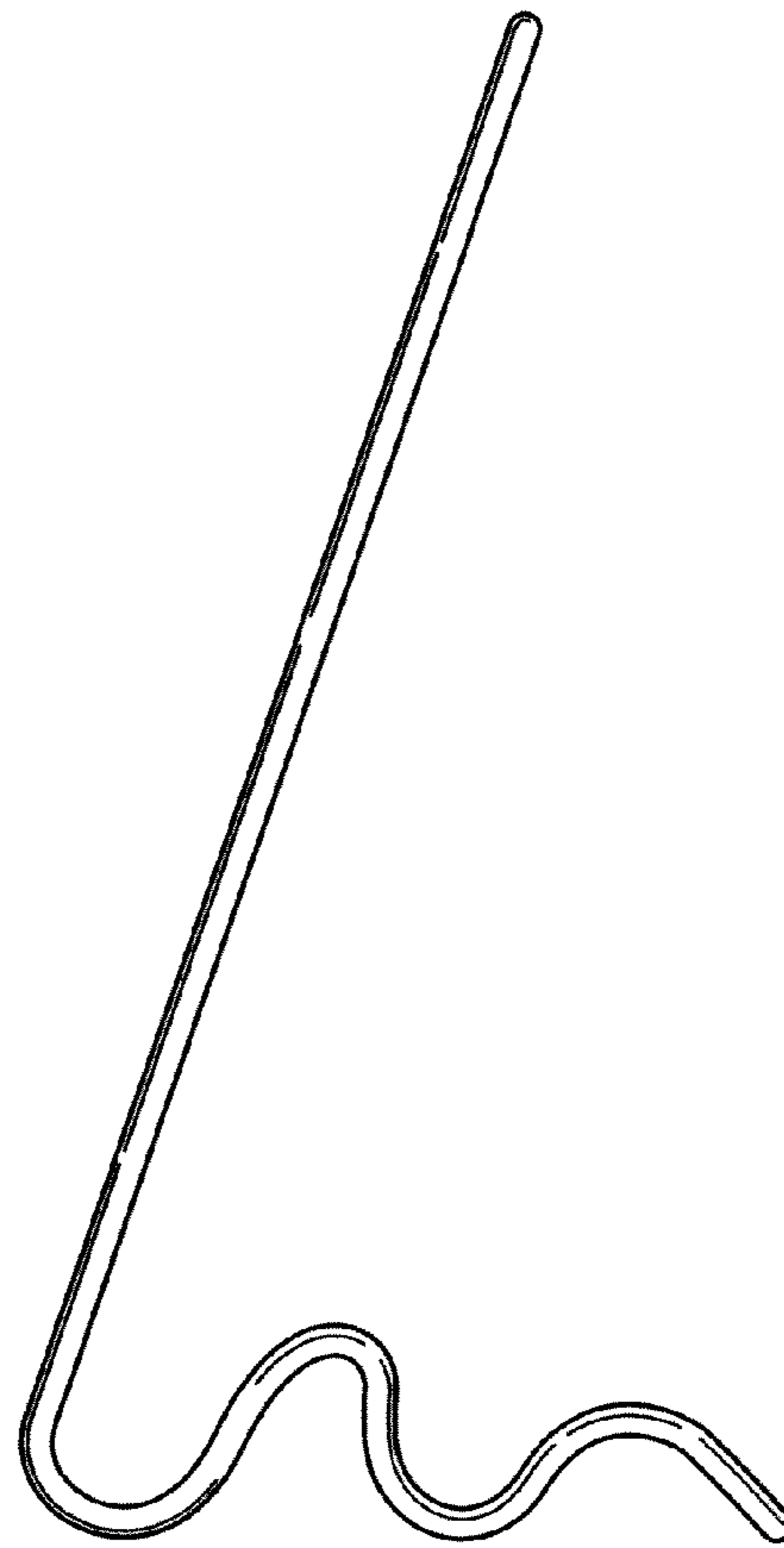

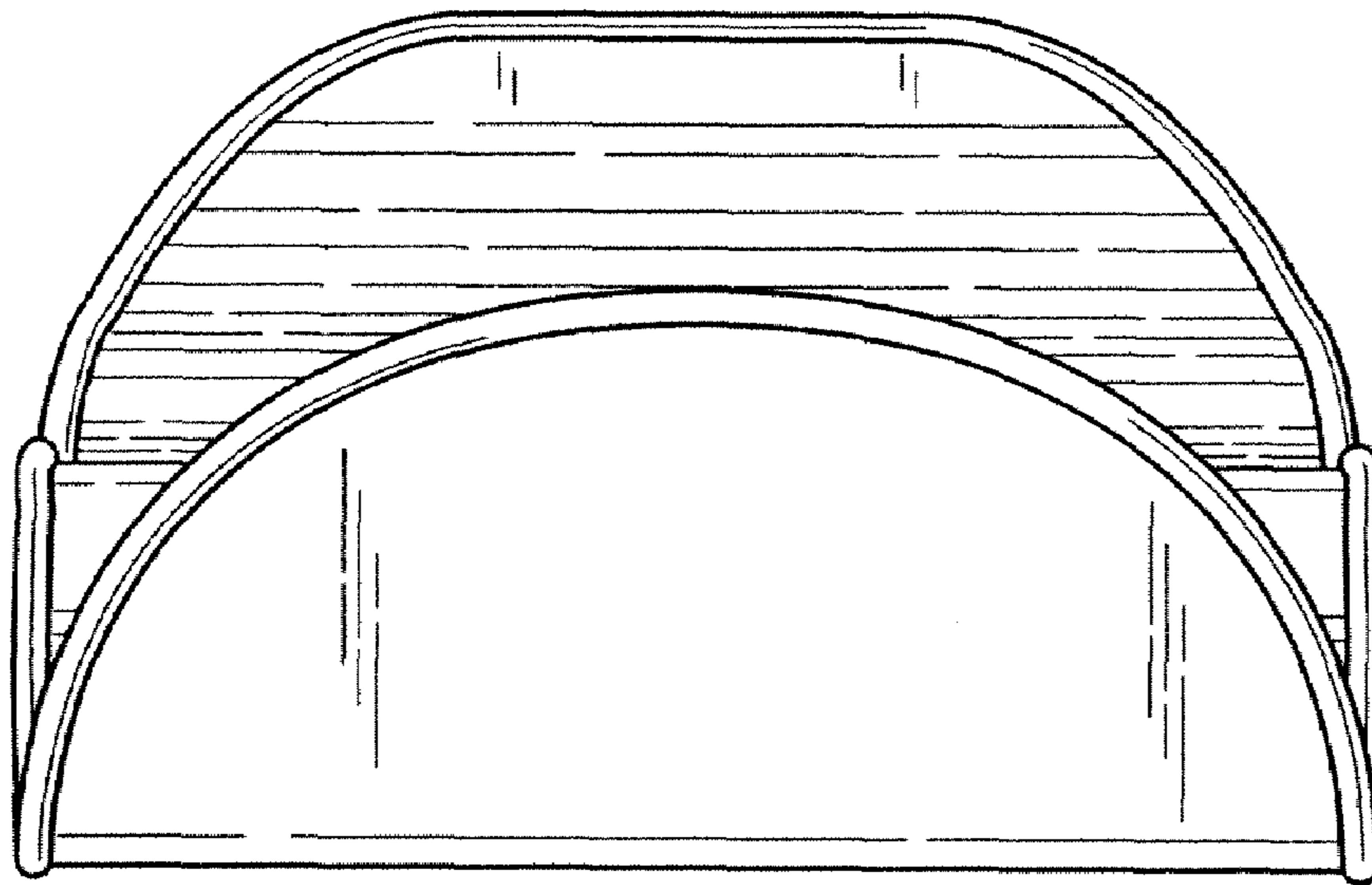

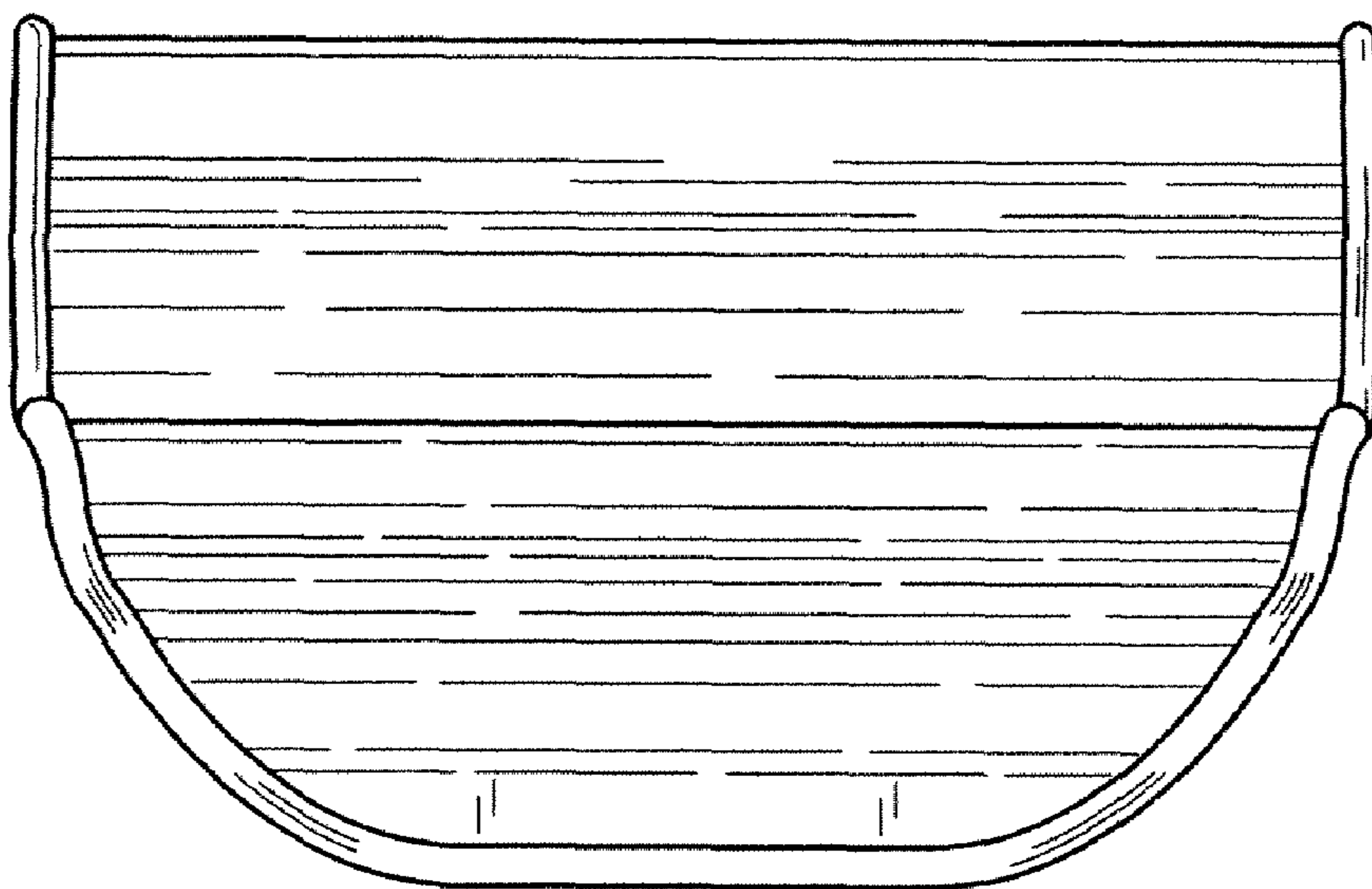
