(57) **CLAIM**

The ornamental design for a board game, as shown and
described.

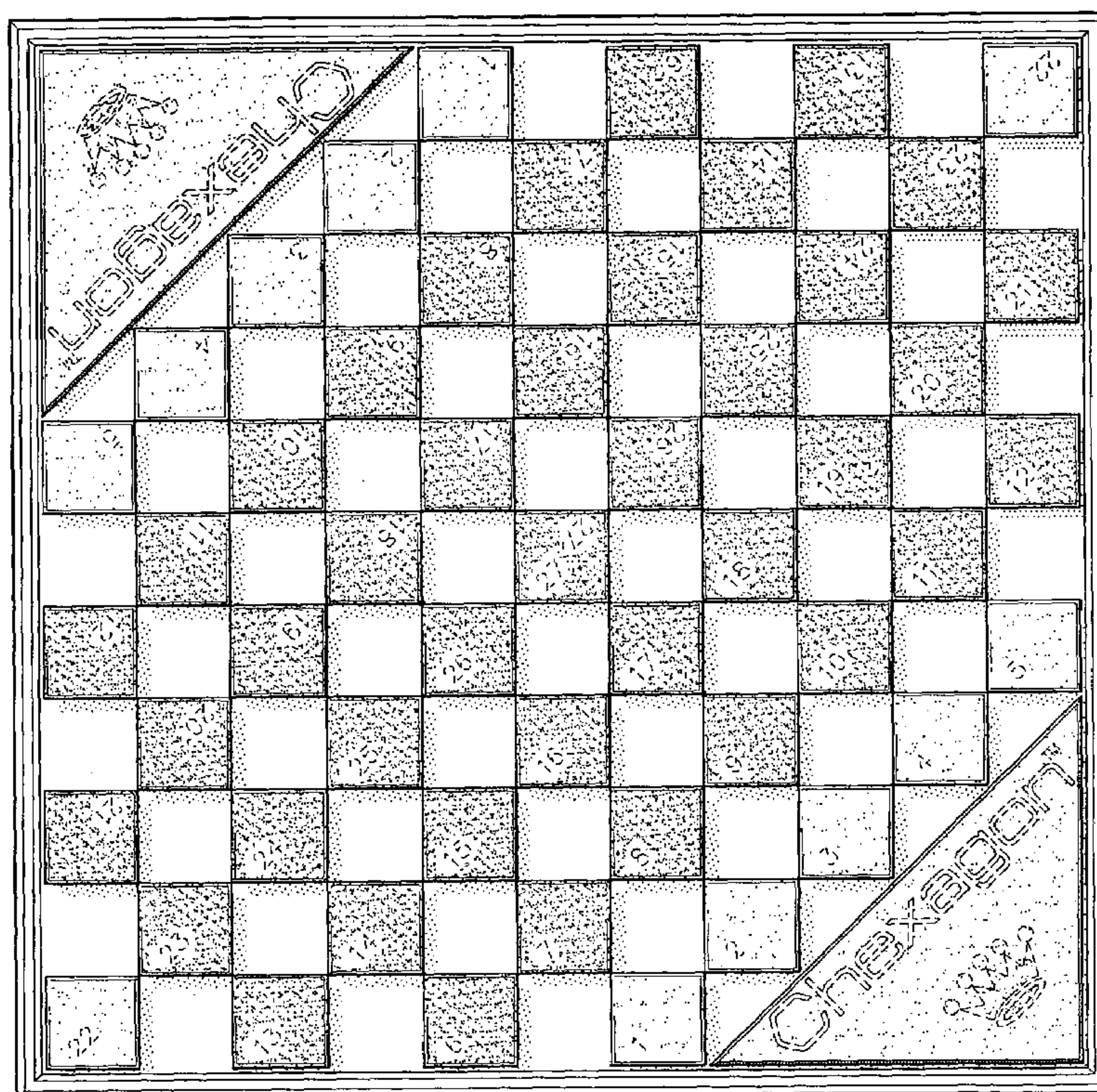
DESCRIPTION

FIG. 1 is a top plan view of a board game, showing my new
design; and,

FIG. 2 is a perspective view thereof.

The broken line showing of the numbers in FIG. 1 is for
illustrative purposes only, merely disclosing that numbers
may be used, and forms no part of the claimed design. The
broken line showing of the thickness in FIG. 2 is for
illustrative purposes only and forms no part of the claimed
design. The shading in FIGS. 1 and 2 is not representative
of a specific color, rather it illustrates a color pattern, i.e.
similarly shaded areas are the same color.

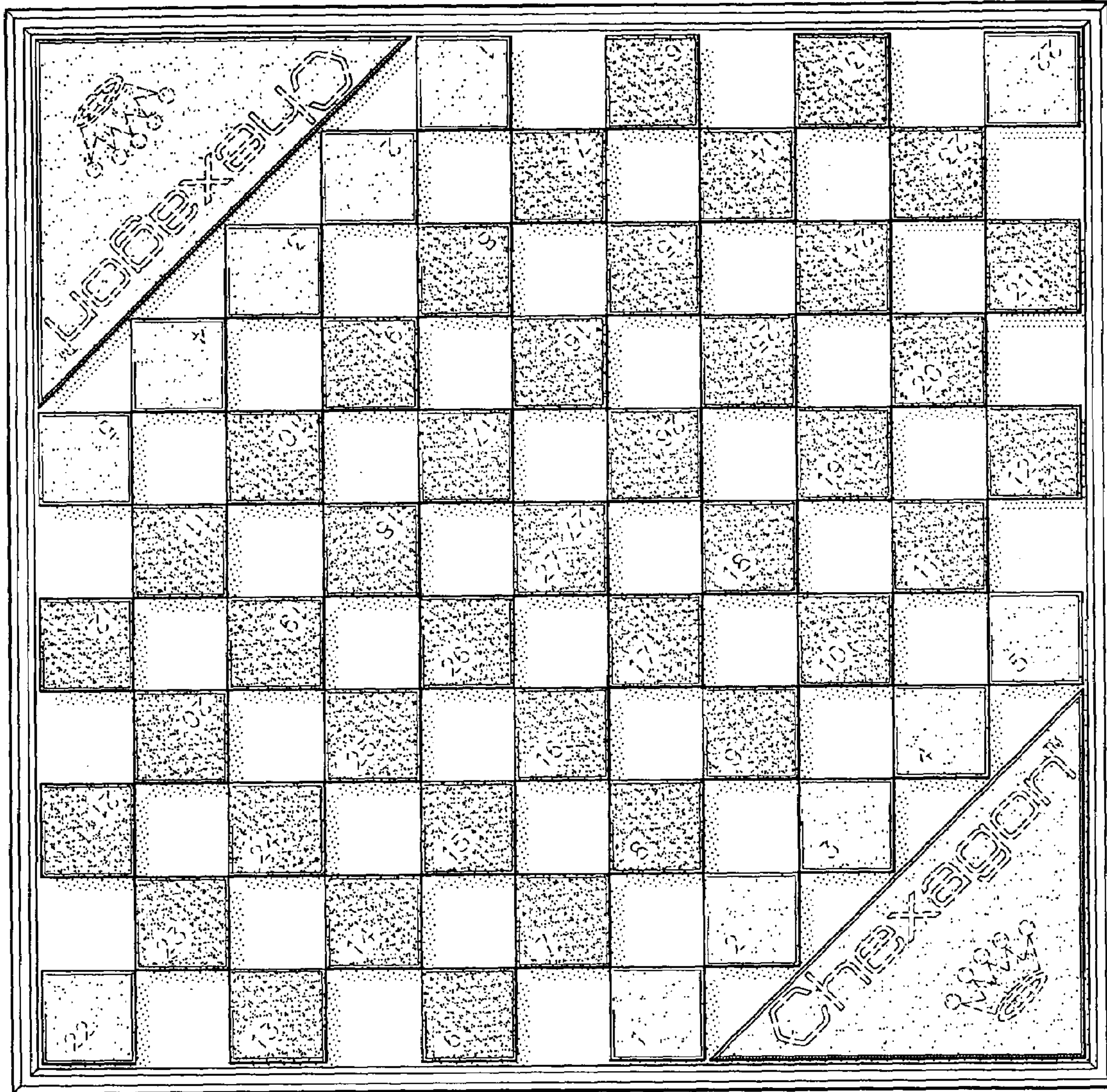

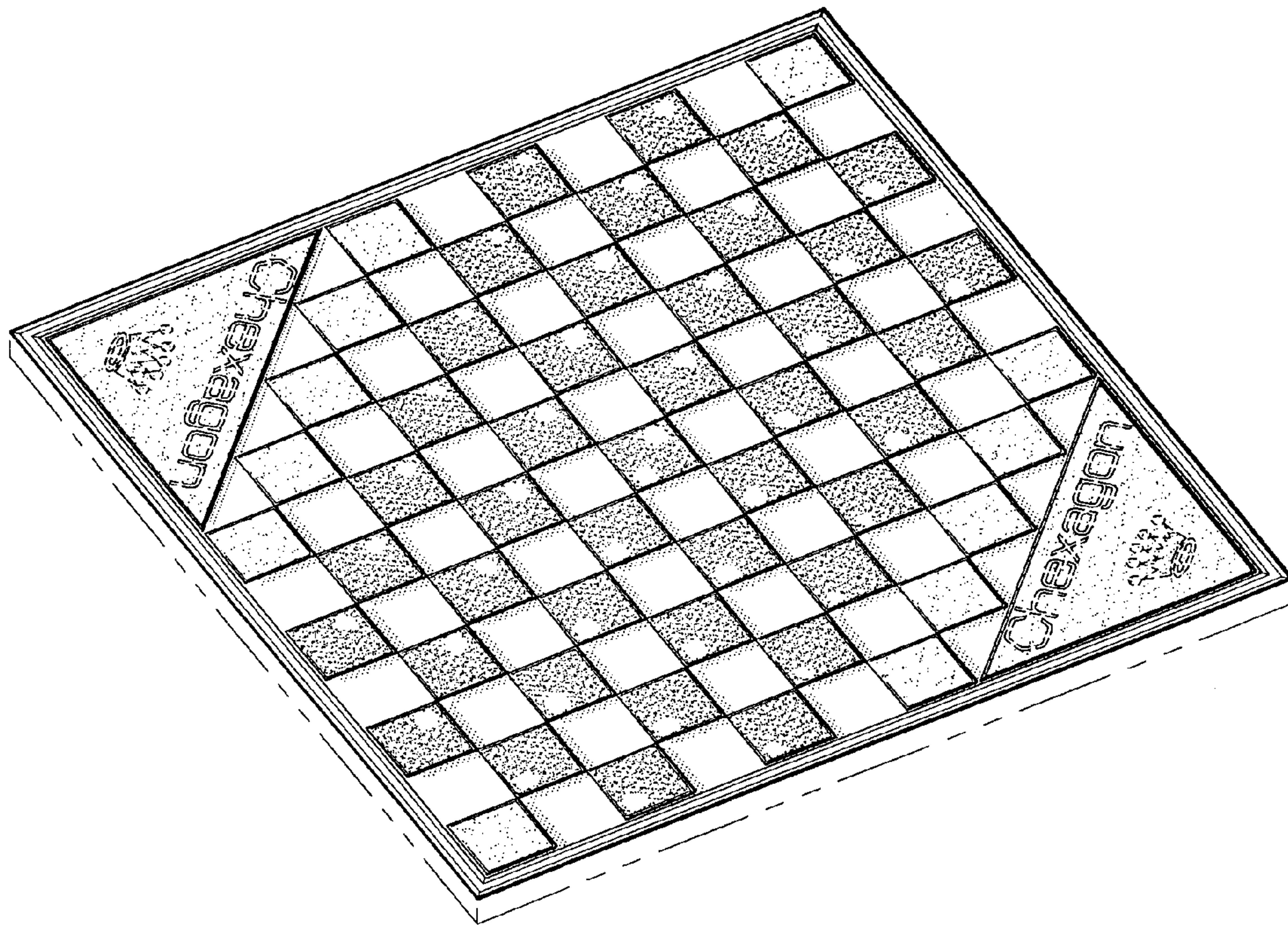
