The ornamental design for a standing type air conditioner, as shown and described.

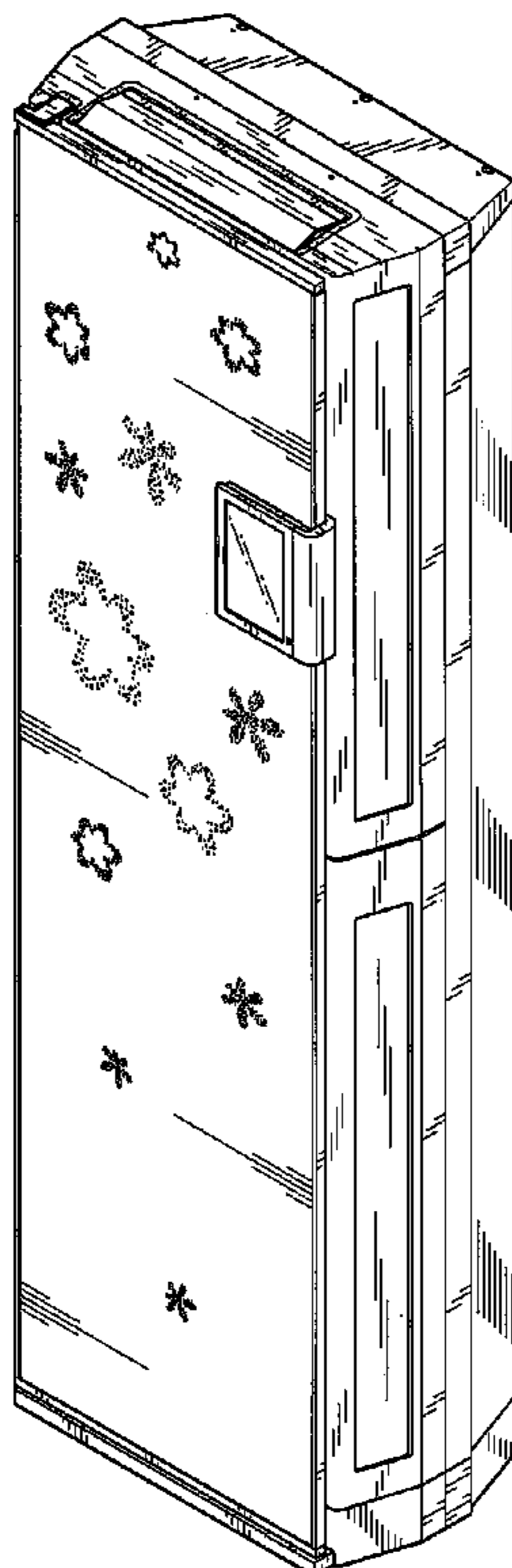

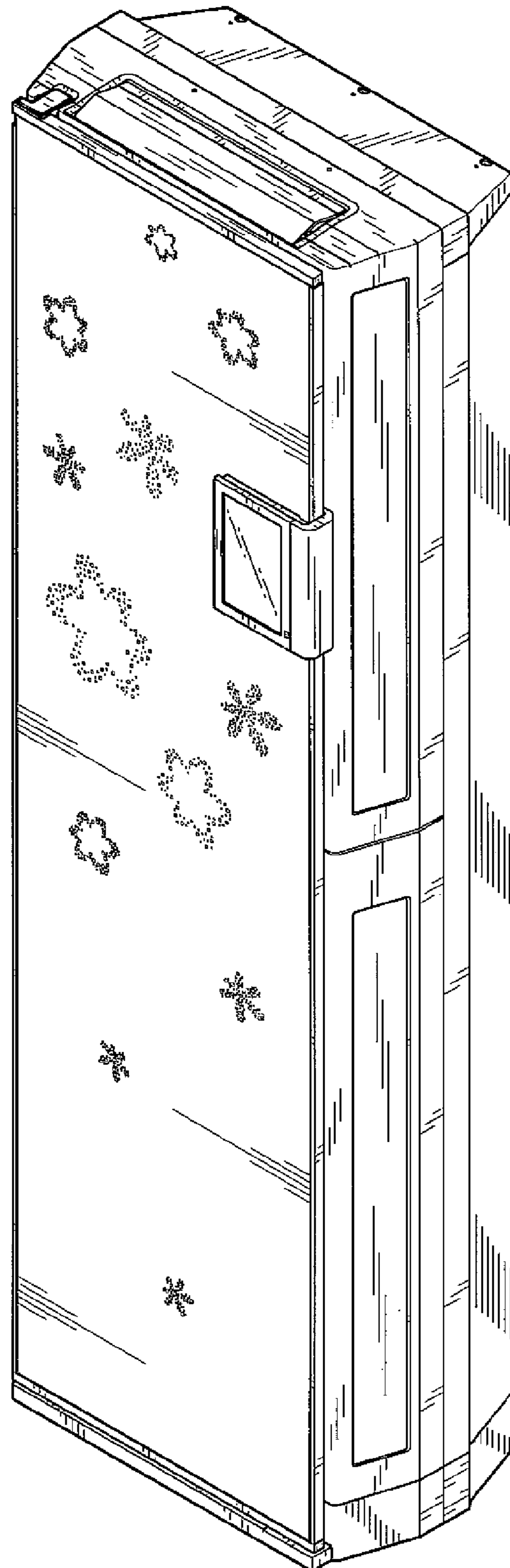

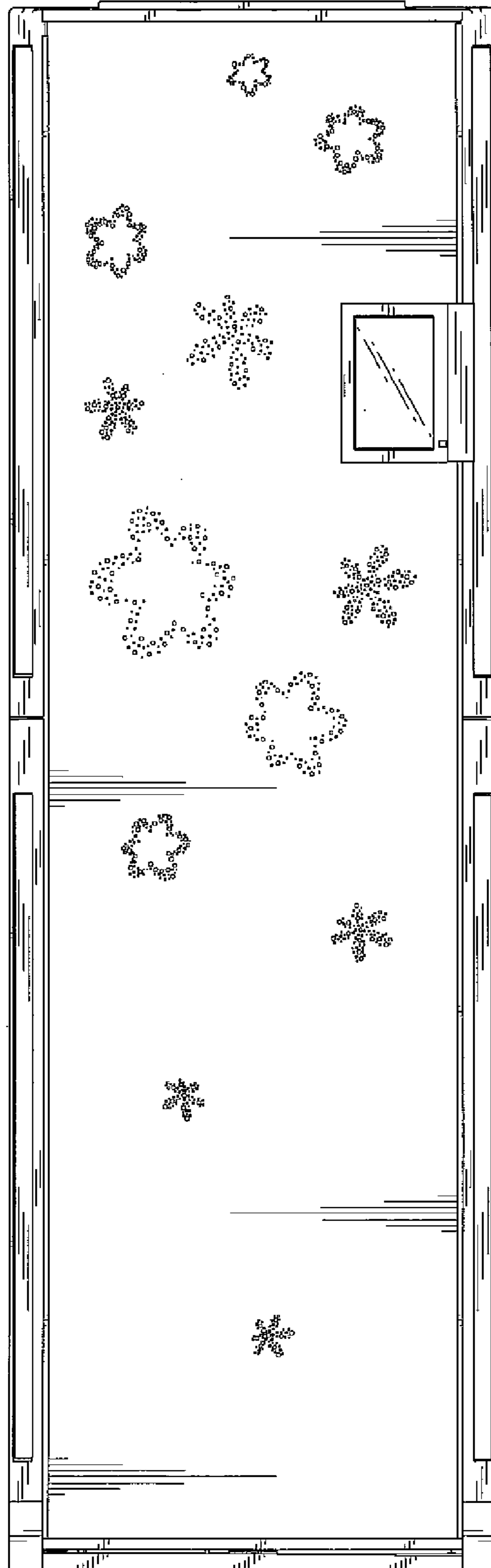

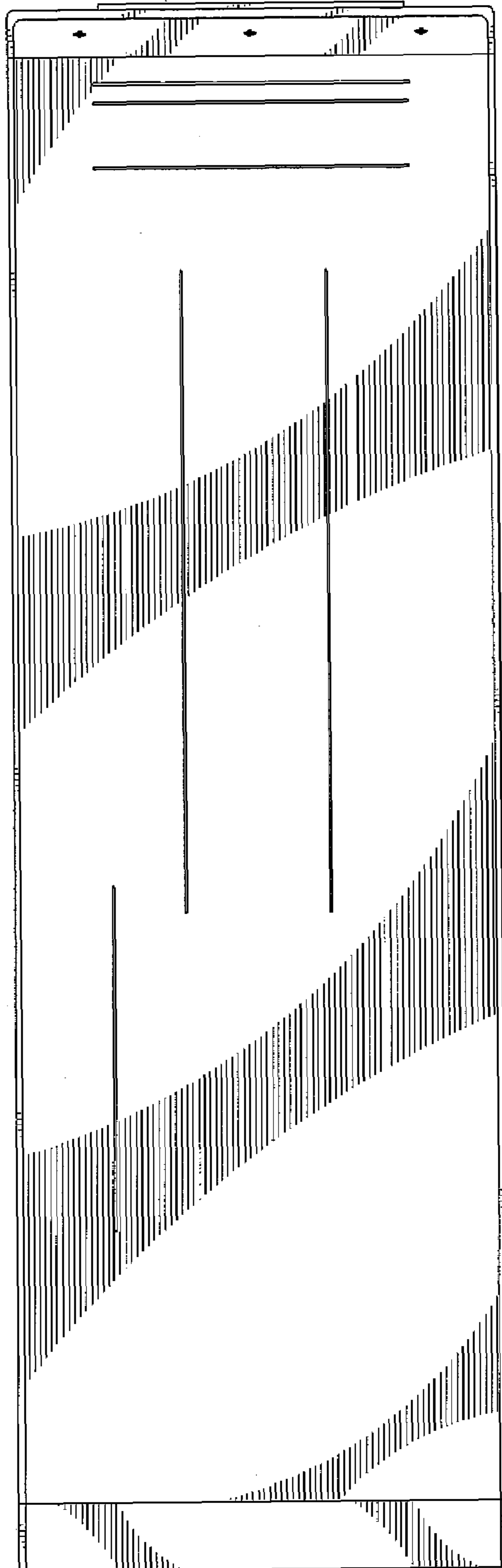

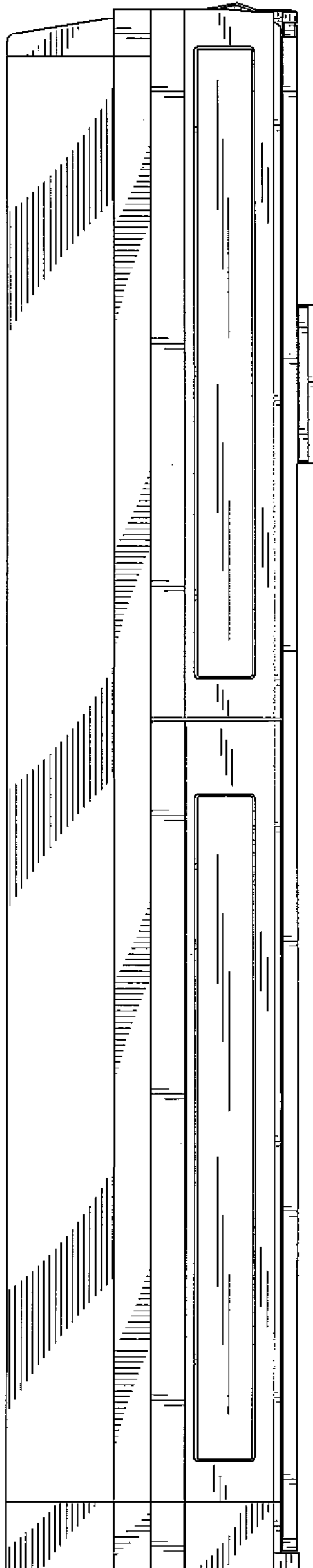

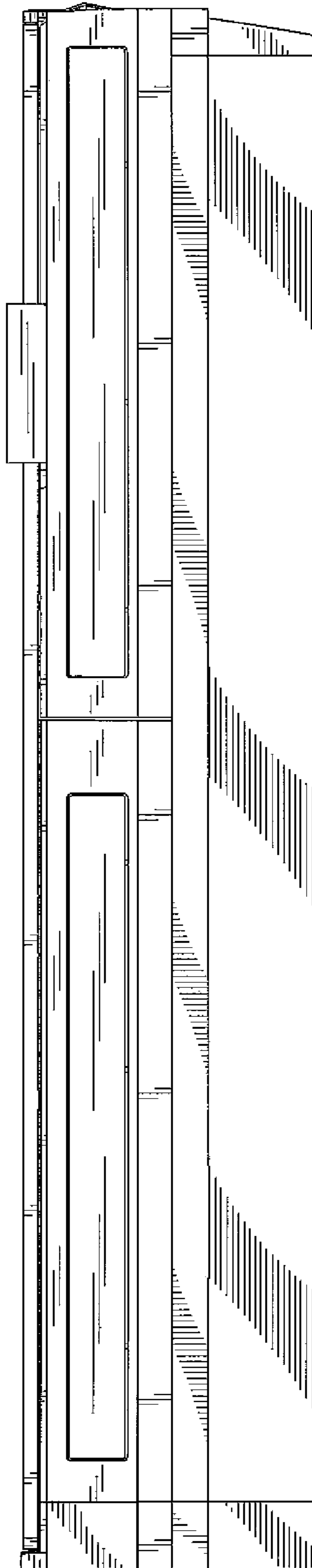

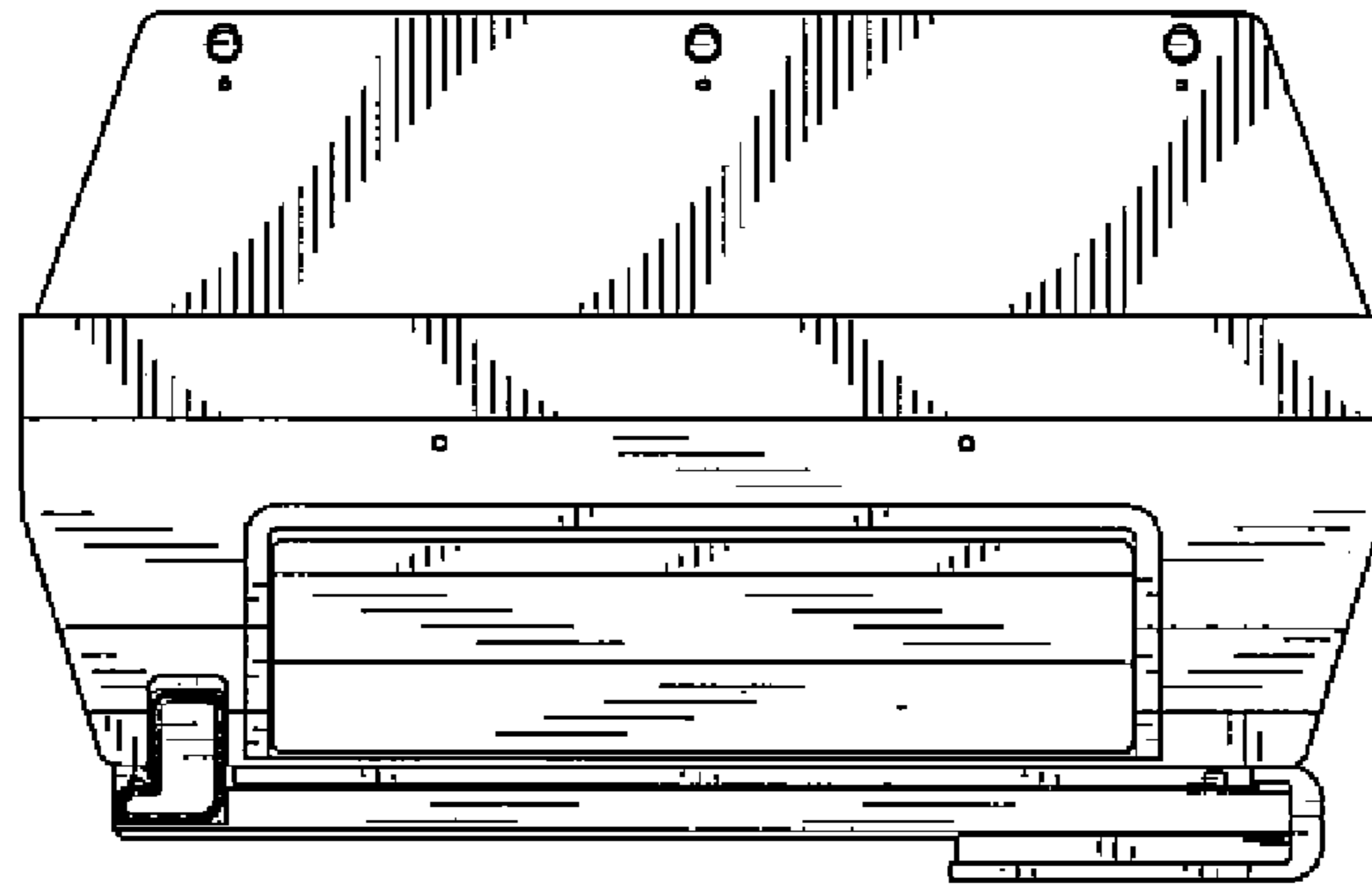
