I claim the ornamental design for a sports helmet, as shown and described.

DESCRIPTION

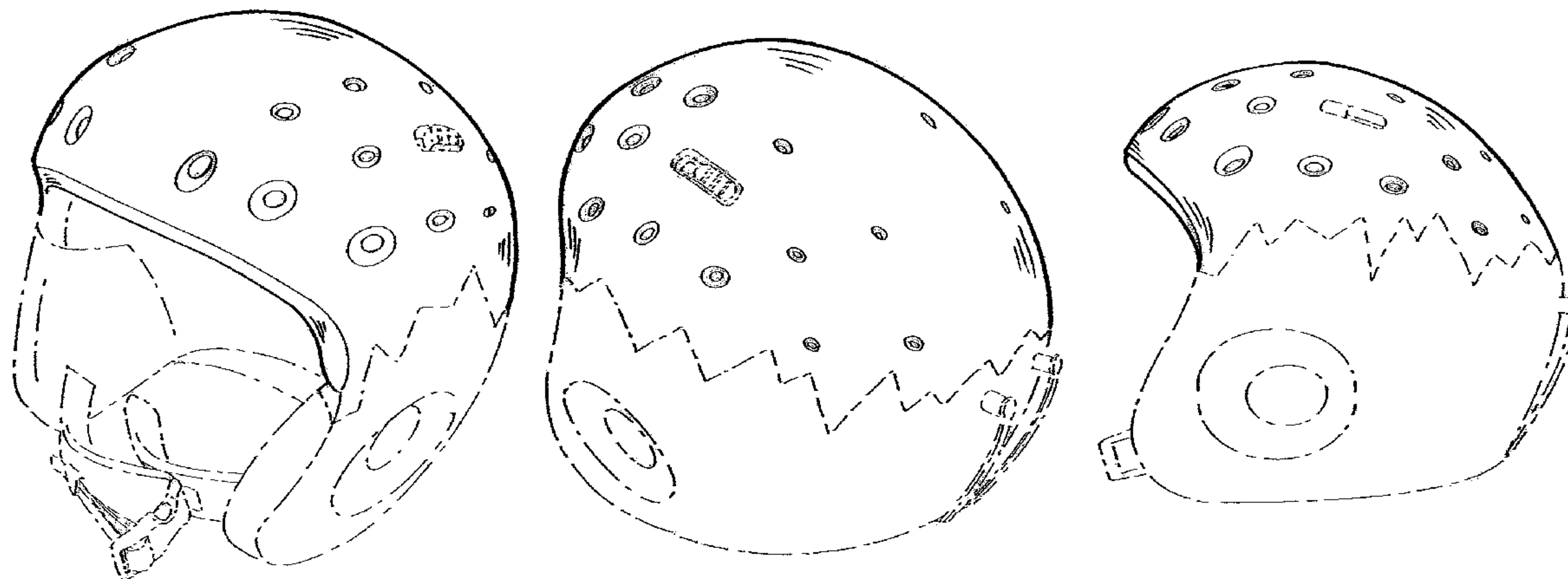
FIG. 1 is a perspective view, showing the front and left side of a sports helmet, showing my new design;

FIG. 2 is another perspective view, showing the rear and left side thereof; and,

FIG. 3 is a left side elevation view thereof.

The jagged broken lines in FIGS. 1-3 represent a boundary that is not claimed. The remaining details shown in broken lines form no part of the claimed design.

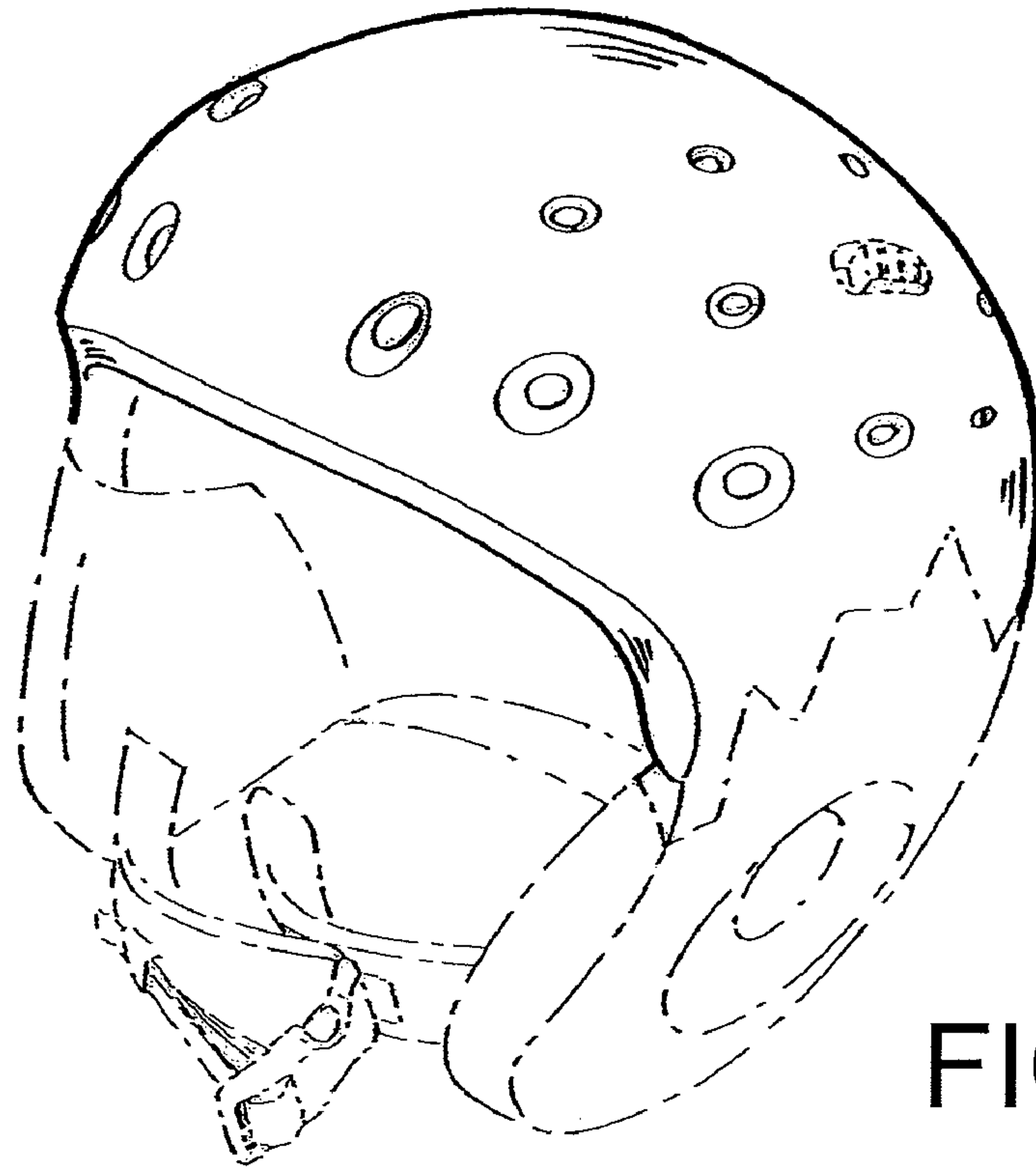

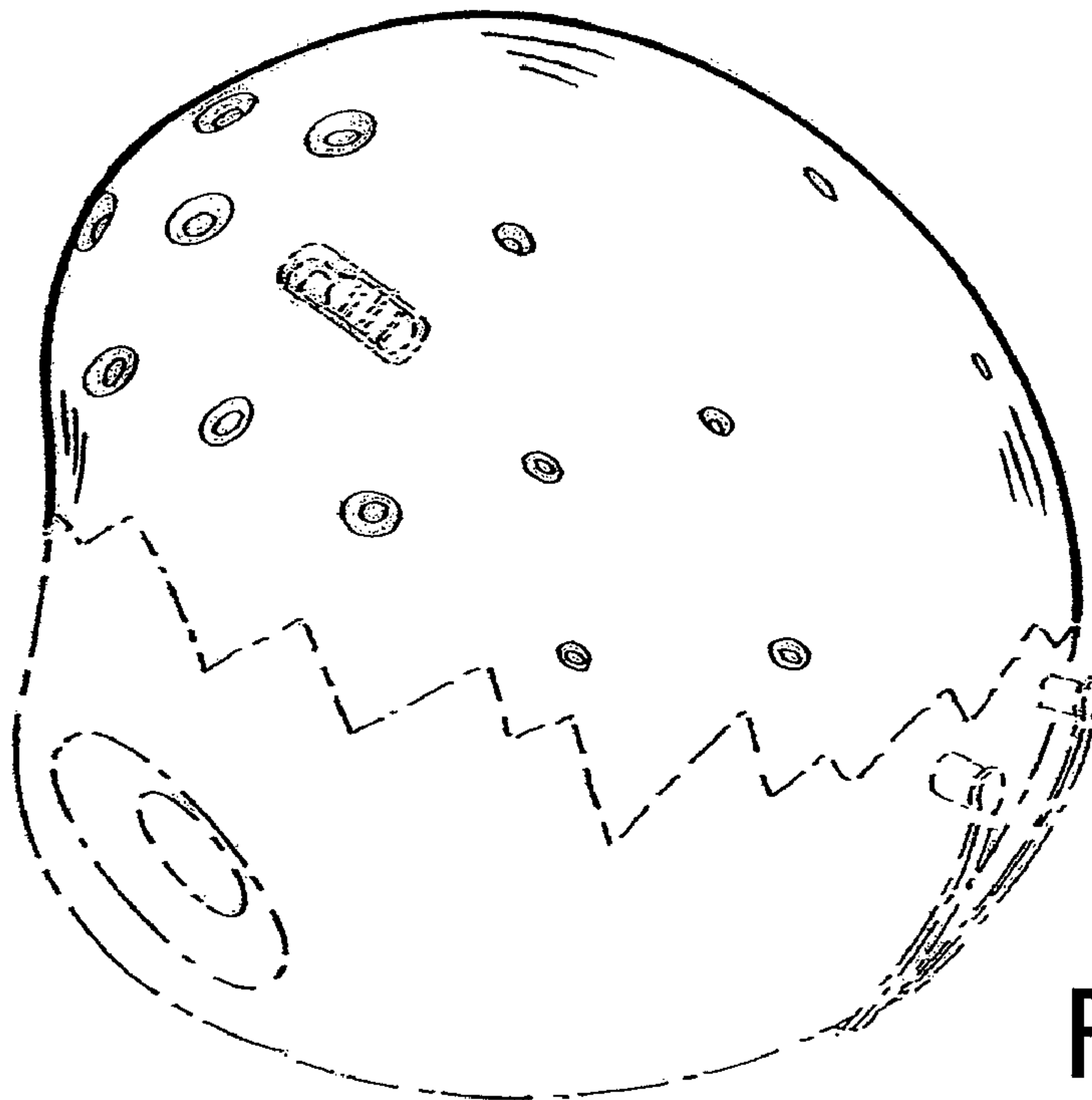

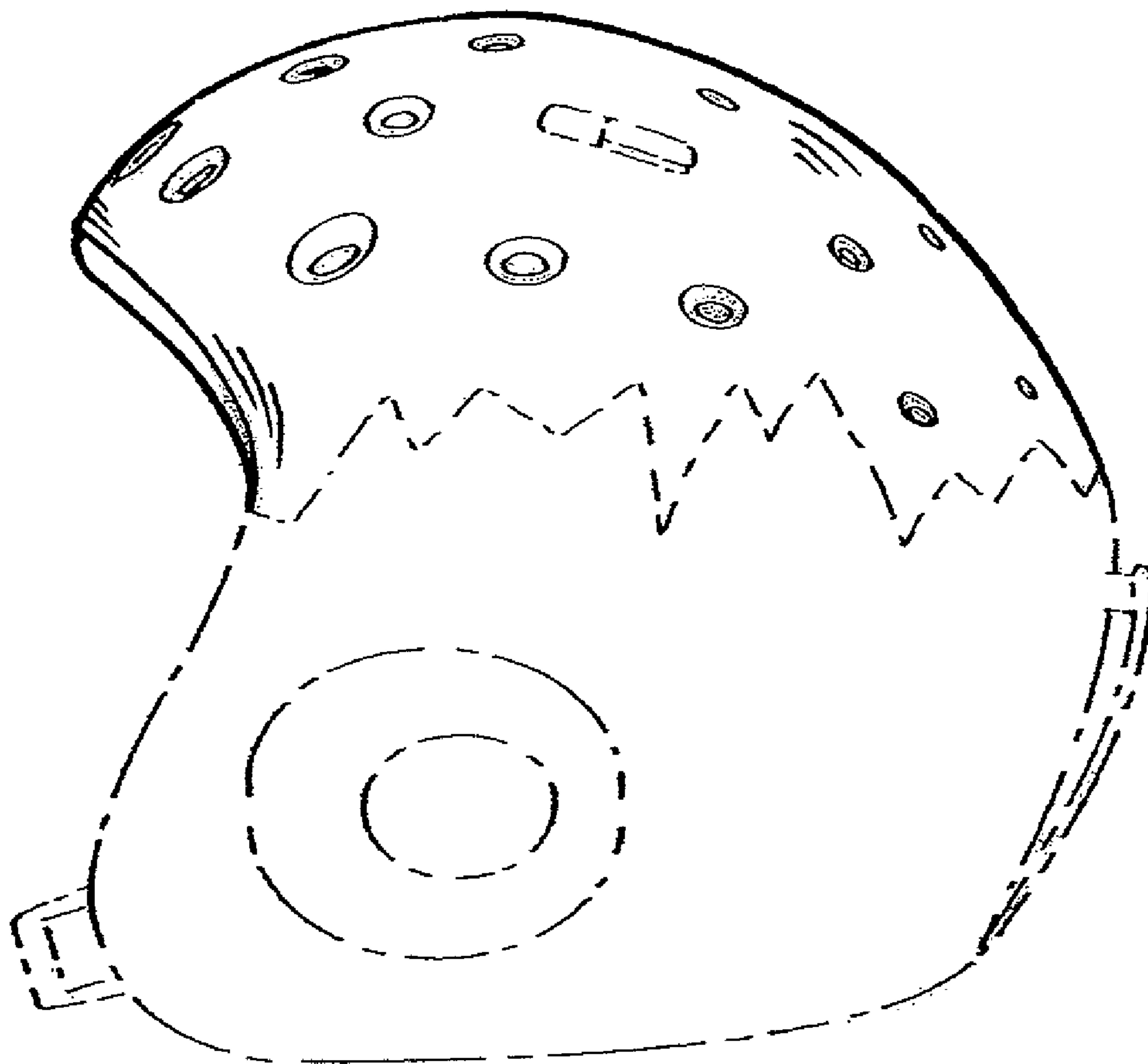
