(57) **CLAIM**

The ornamental design for a paint container cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a paint container cover, as viewed from the top, front and left side, showing my new design;

FIG. 4 is a right side view of the paint container cover of FIG. 1;

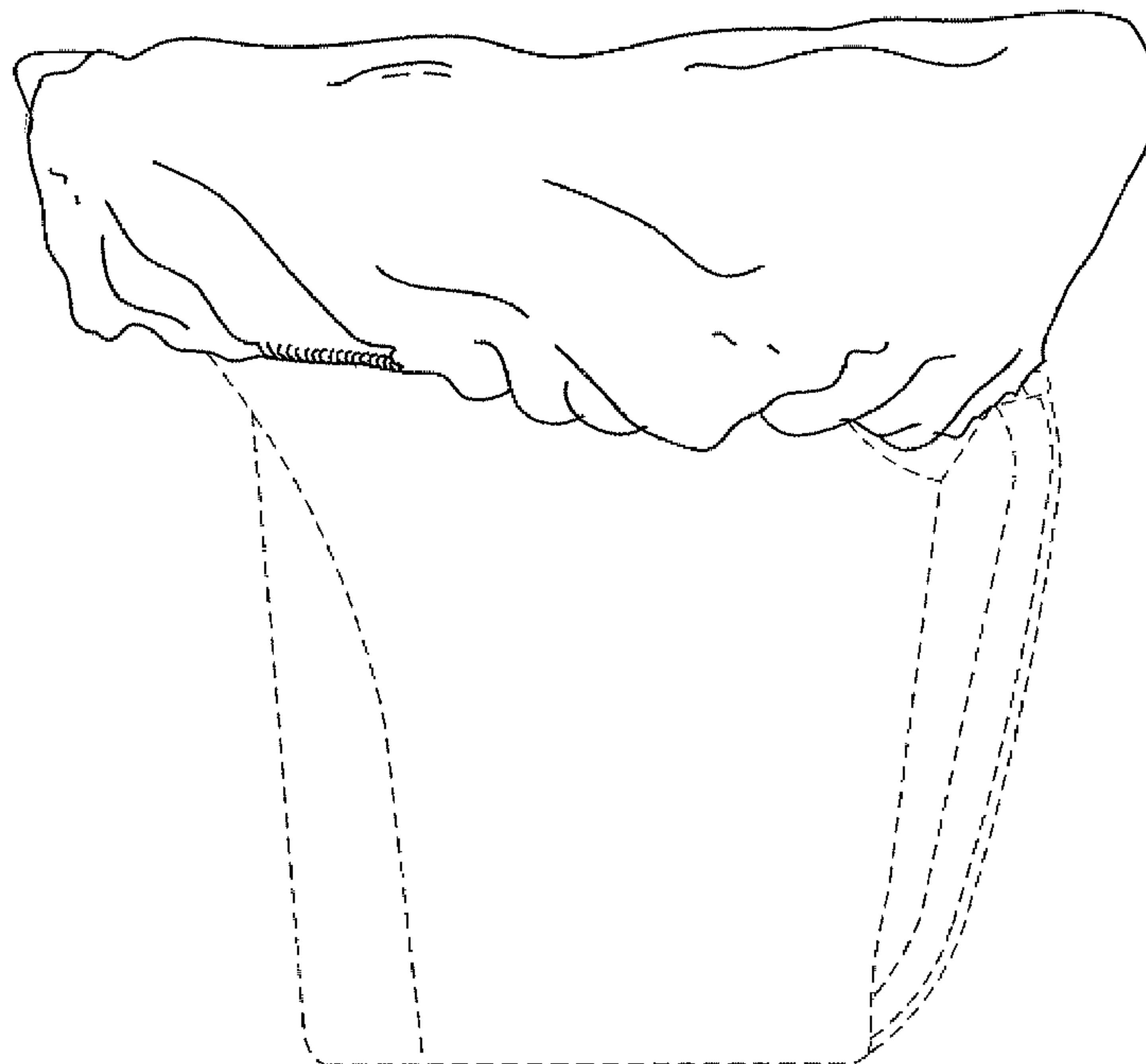
FIG. 5 is a left side view of the paint container cover of FIG. 1;

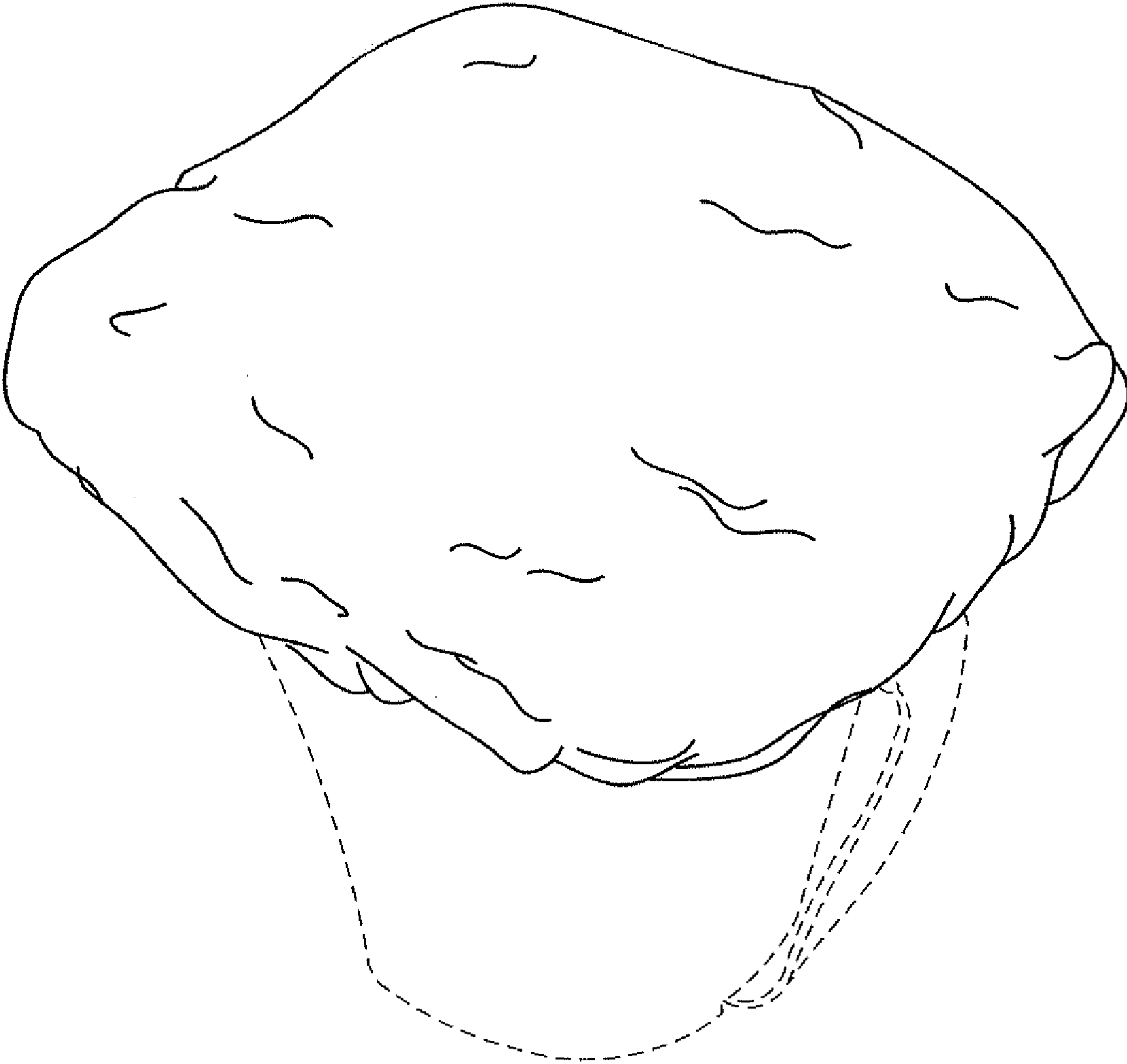
FIG. 6 is a rear side view of the paint container cover of FIG. 1; and,

FIG. 7 is a bottom plan view of the paint container cover of FIG. 1.

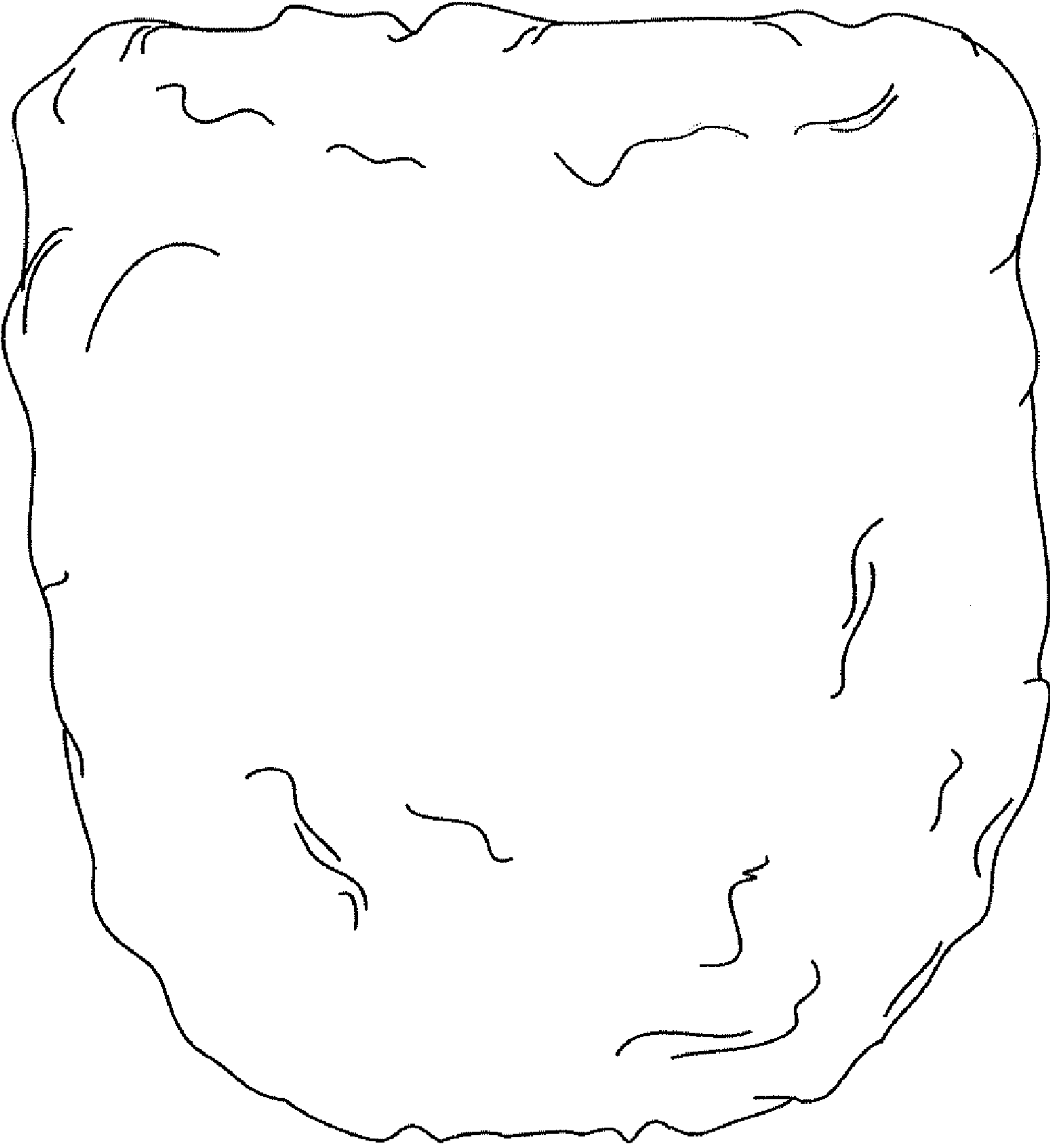

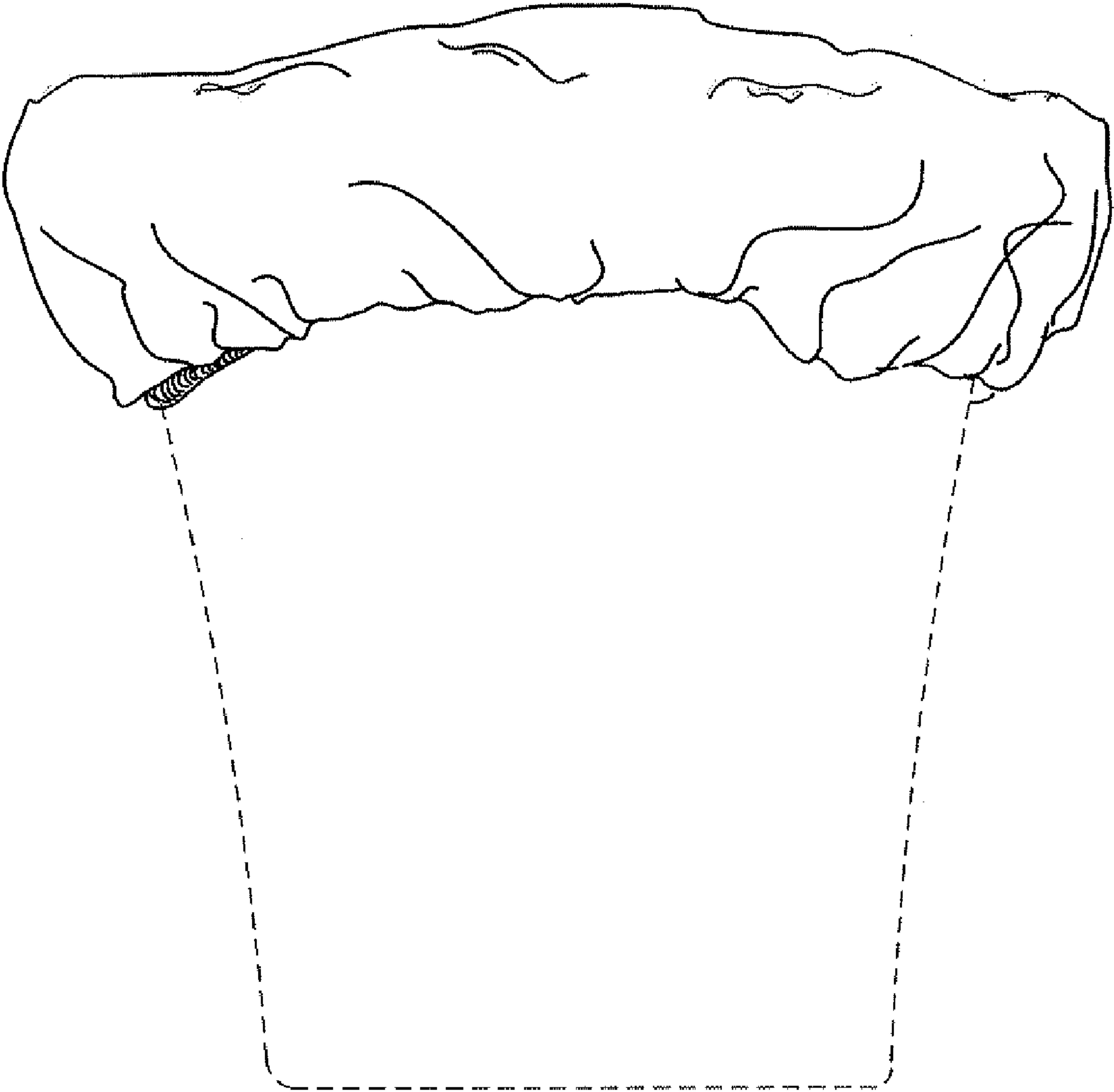




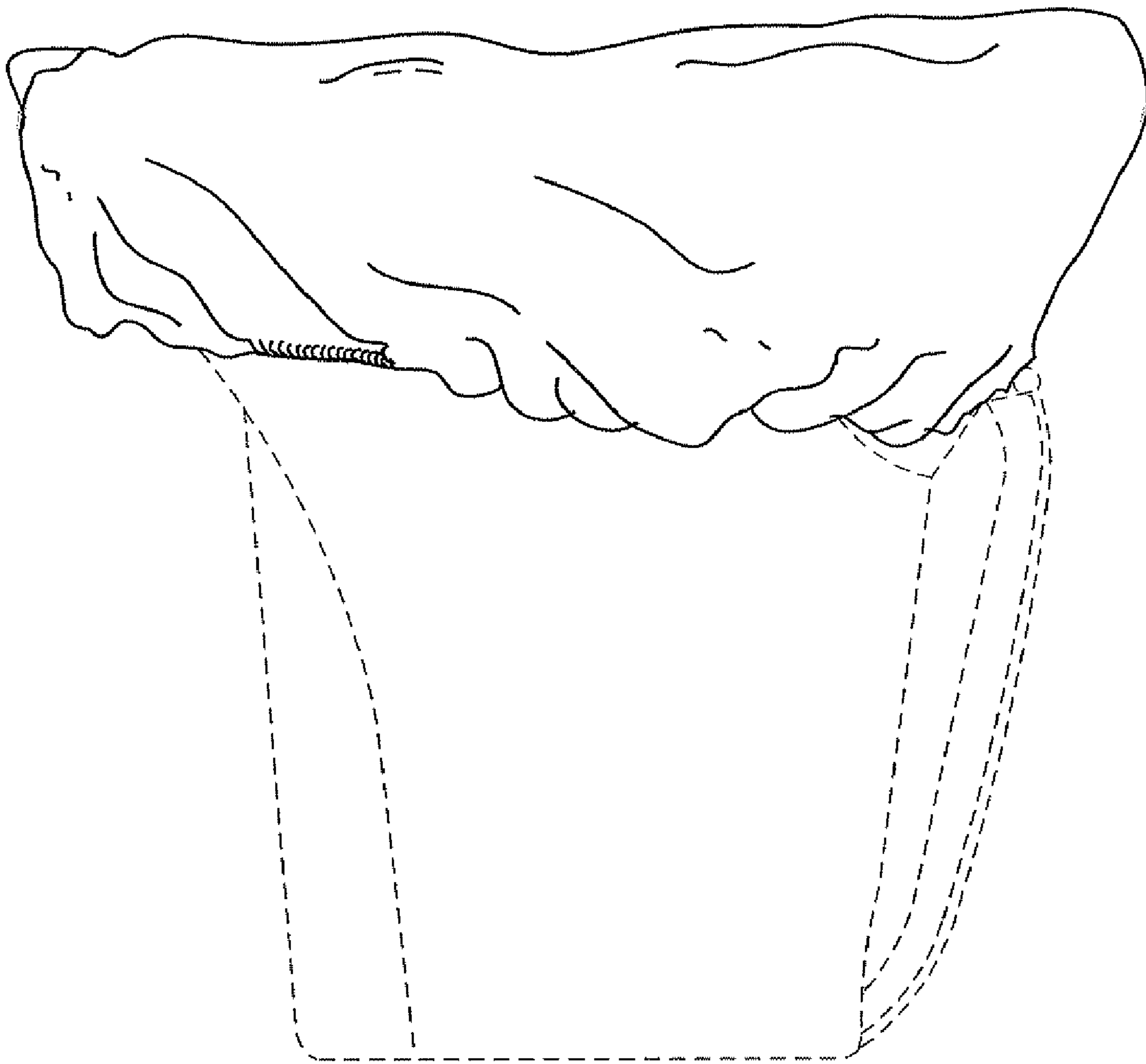

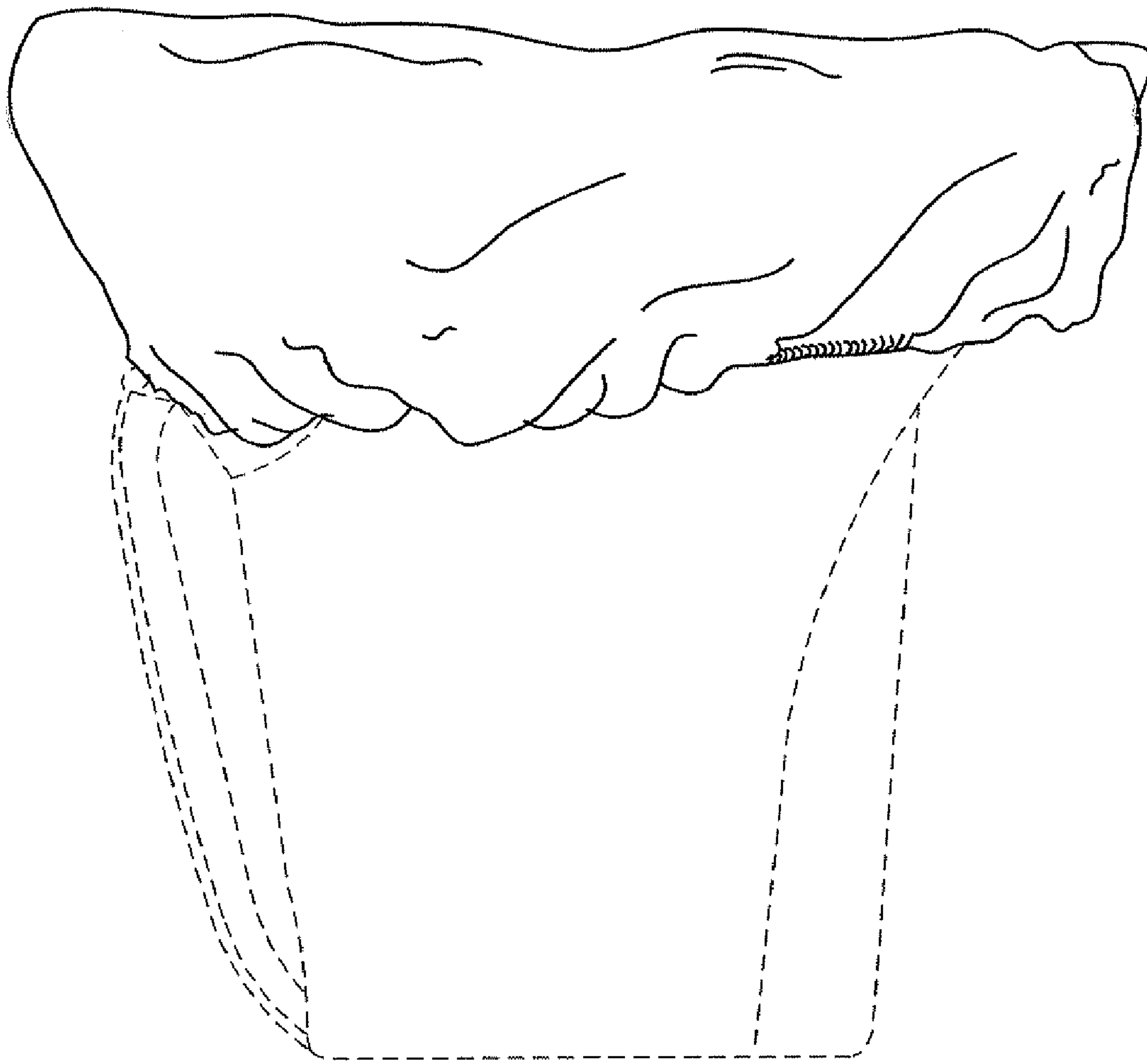

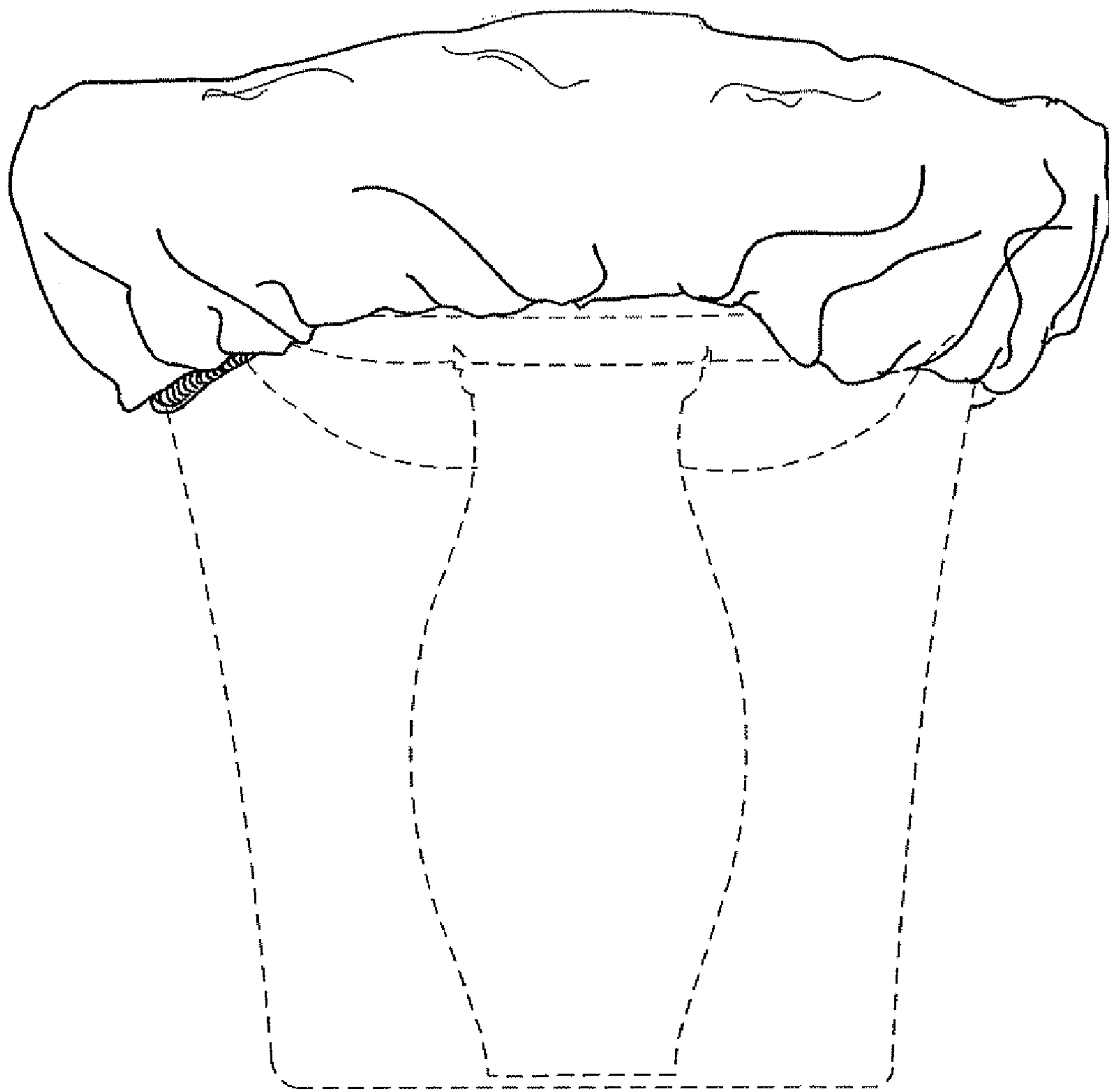

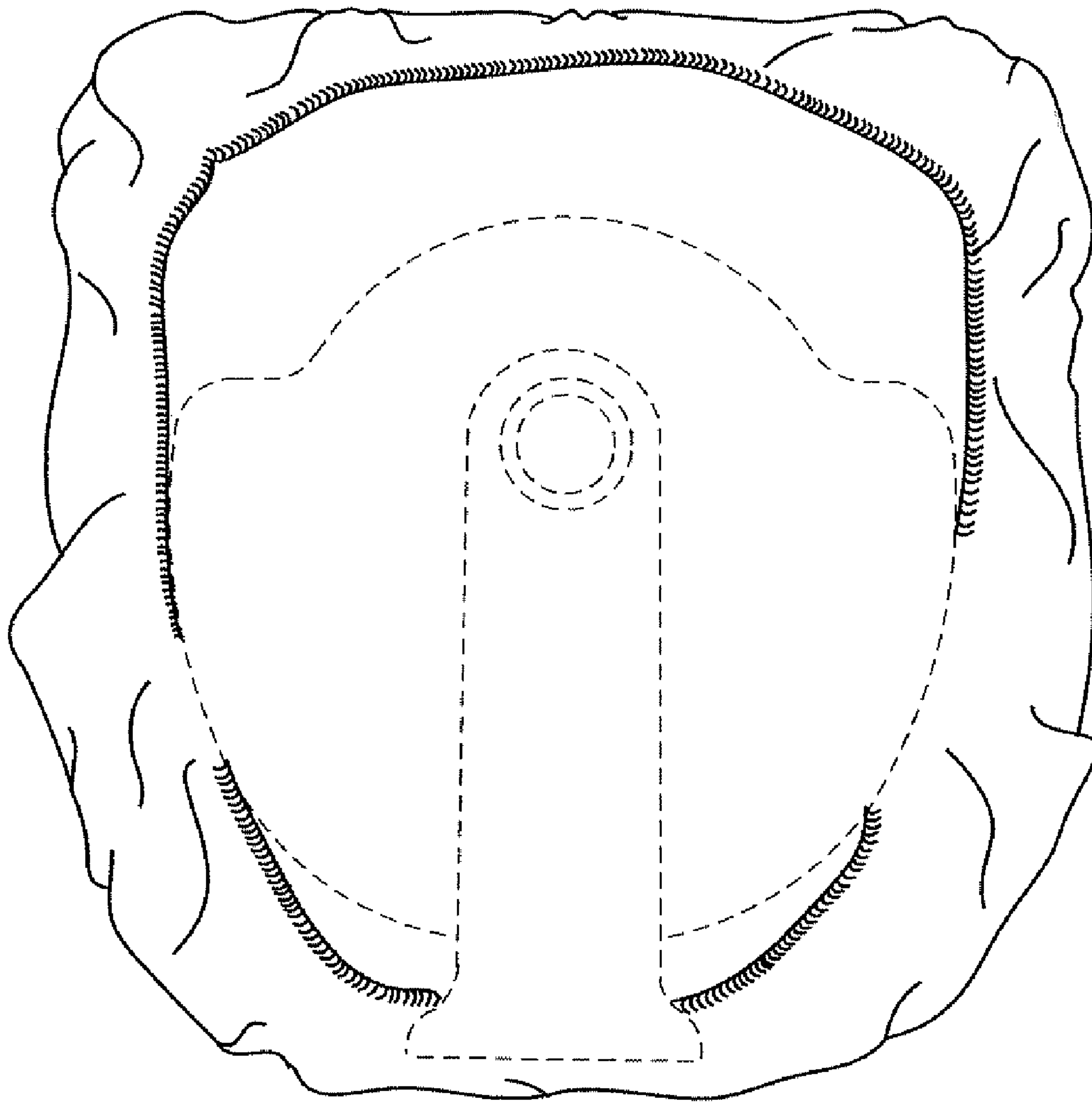
