(57) **CLAIM**

The ornamental design for an adjustable strap with handles for lifting objects safely, as shown and described.

**DESCRIPTION**

FIG. 1 is an environmental view of the adjustable strap with handles for lifting objects safely showing my new design;

FIG. 2 is a perspective view of the handle and a portion of the strap;

FIG. 3 is a perspective view of the clip and a portion of the strap;

FIG. 4 is a front elevational view of the strap;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a side elevational view thereof, with the opposite side being a mirror image;

FIG. 7 is a top plan view thereof;

FIG. 8 is a bottom plan view thereof;

FIG. 9 is a front perspective view of the handle portion, removed for clarity of disclosure;

FIG. 10 is a rear perspective view thereof;

FIG. 11 is a front elevational view thereof;

FIG. 12 is a side elevational view thereof; with the opposite side being a mirror image;

FIG. 13 is a top plan view thereof;

FIG. 14 is a rear elevational view thereof;

FIG. 15 is a bottom plan view thereof;

FIG. 16 is a front perspective view of the clip portion, removed for clarity of disclosure;

FIG. 17 is a rear perspective view thereof;

FIG. 18 is a front elevational view thereof, with the opposite side being a mirror image;

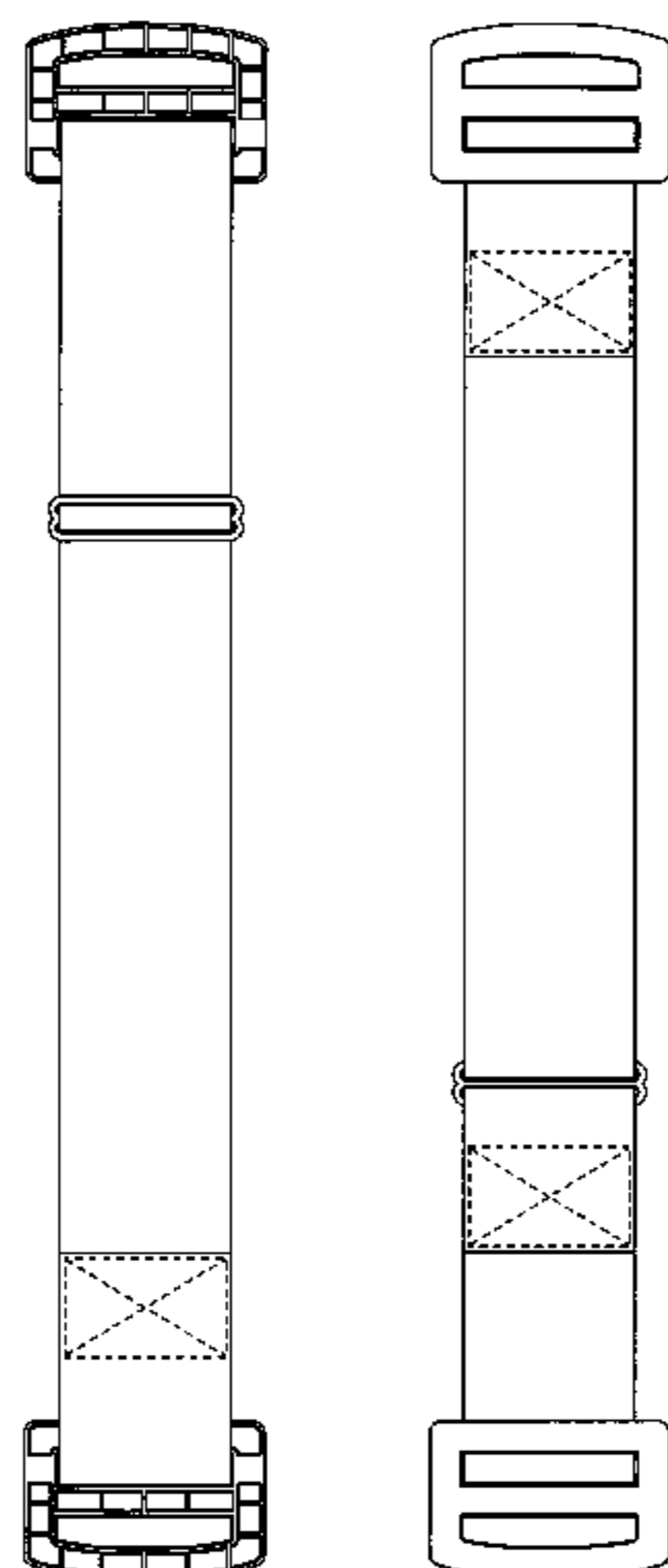
FIG. 19 is a side elevational view thereof, with the opposite side being a mirror image; and,

FIG. 20 is a top plan view thereof.

The dashed lines shown in FIGS. 4 and 5 represent conventional stitching.

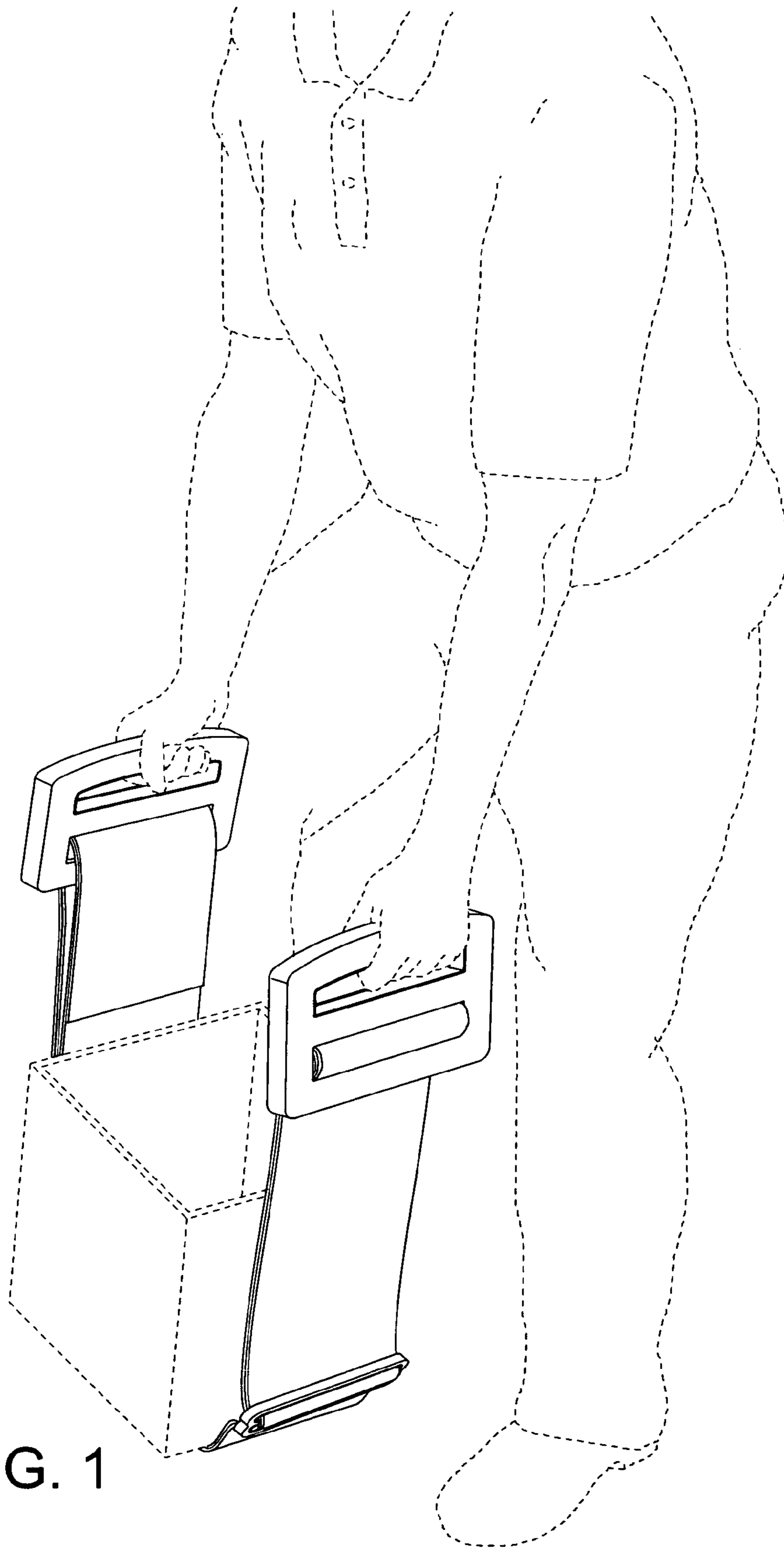

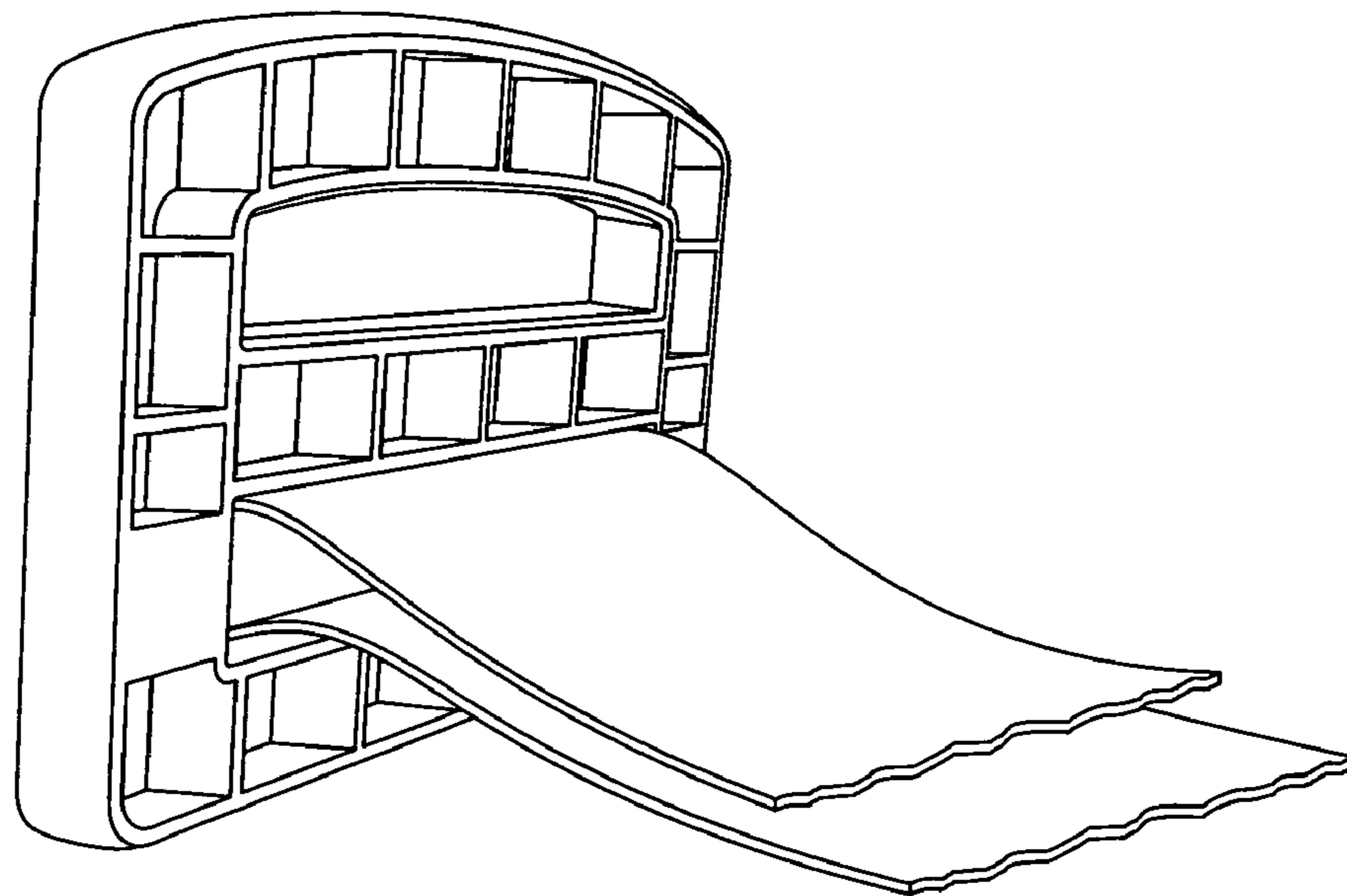

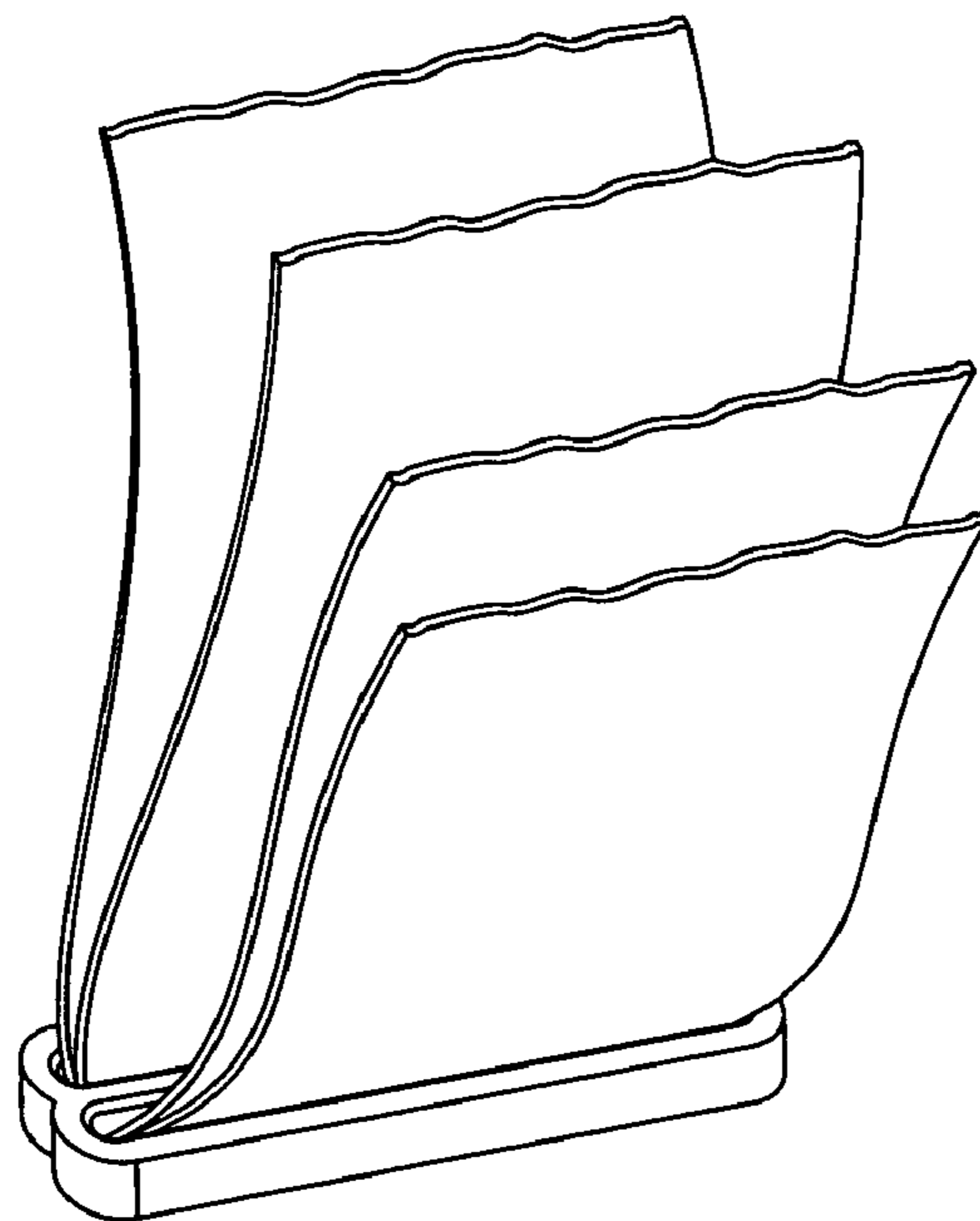

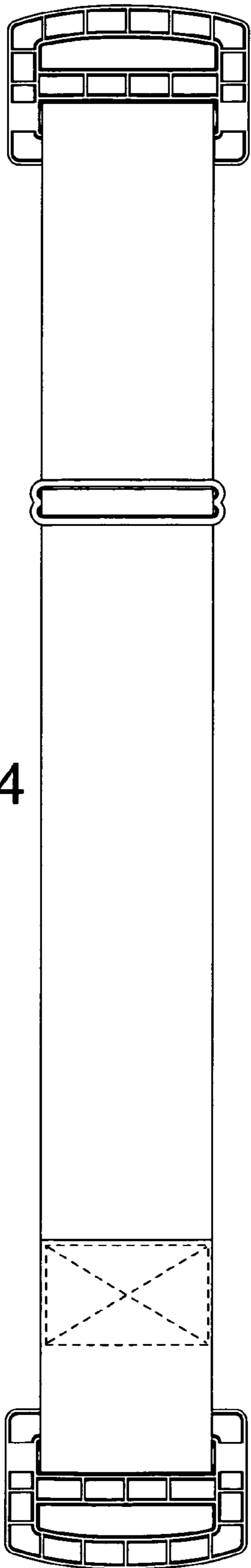

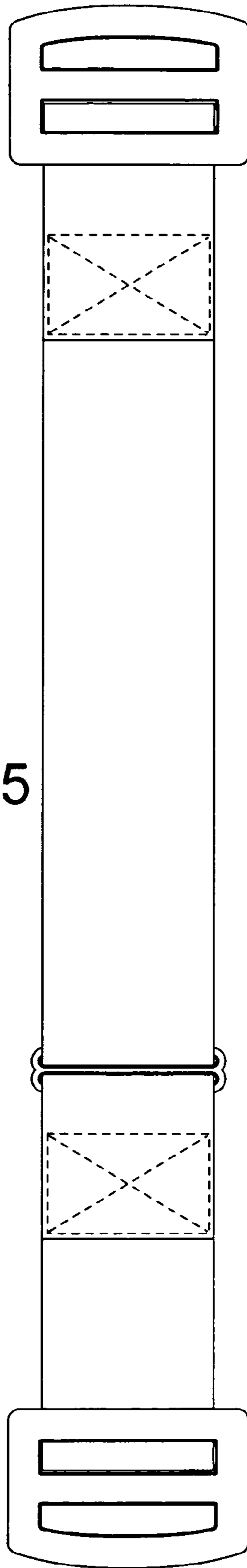

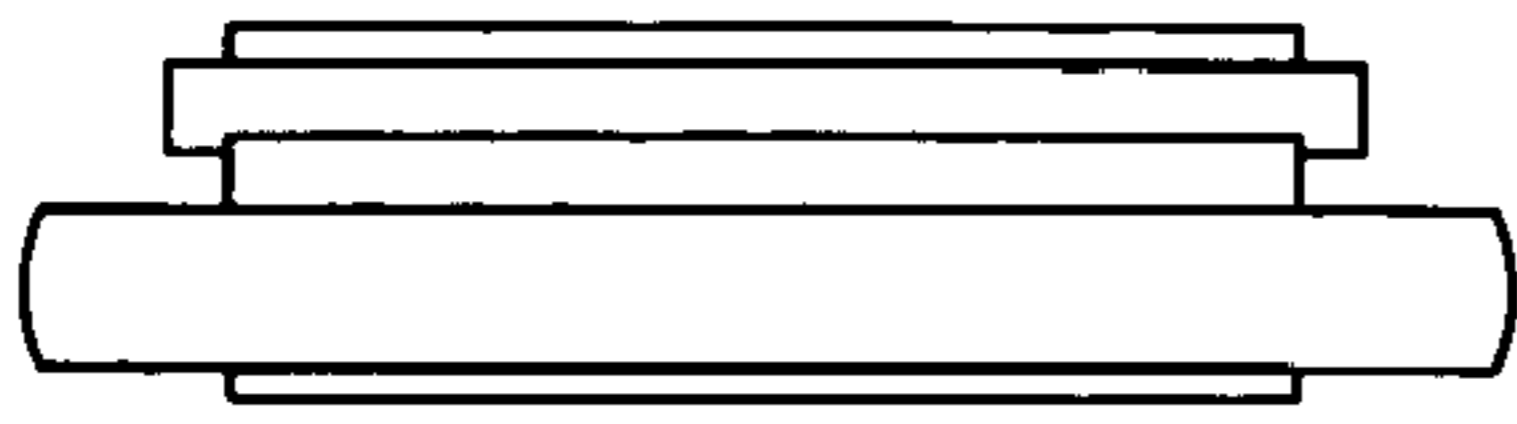

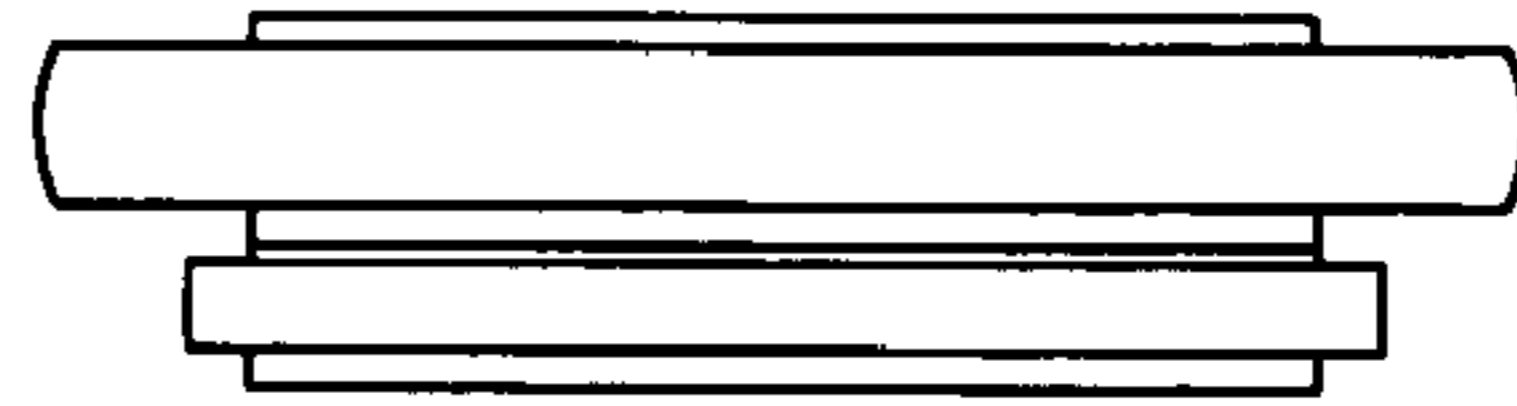

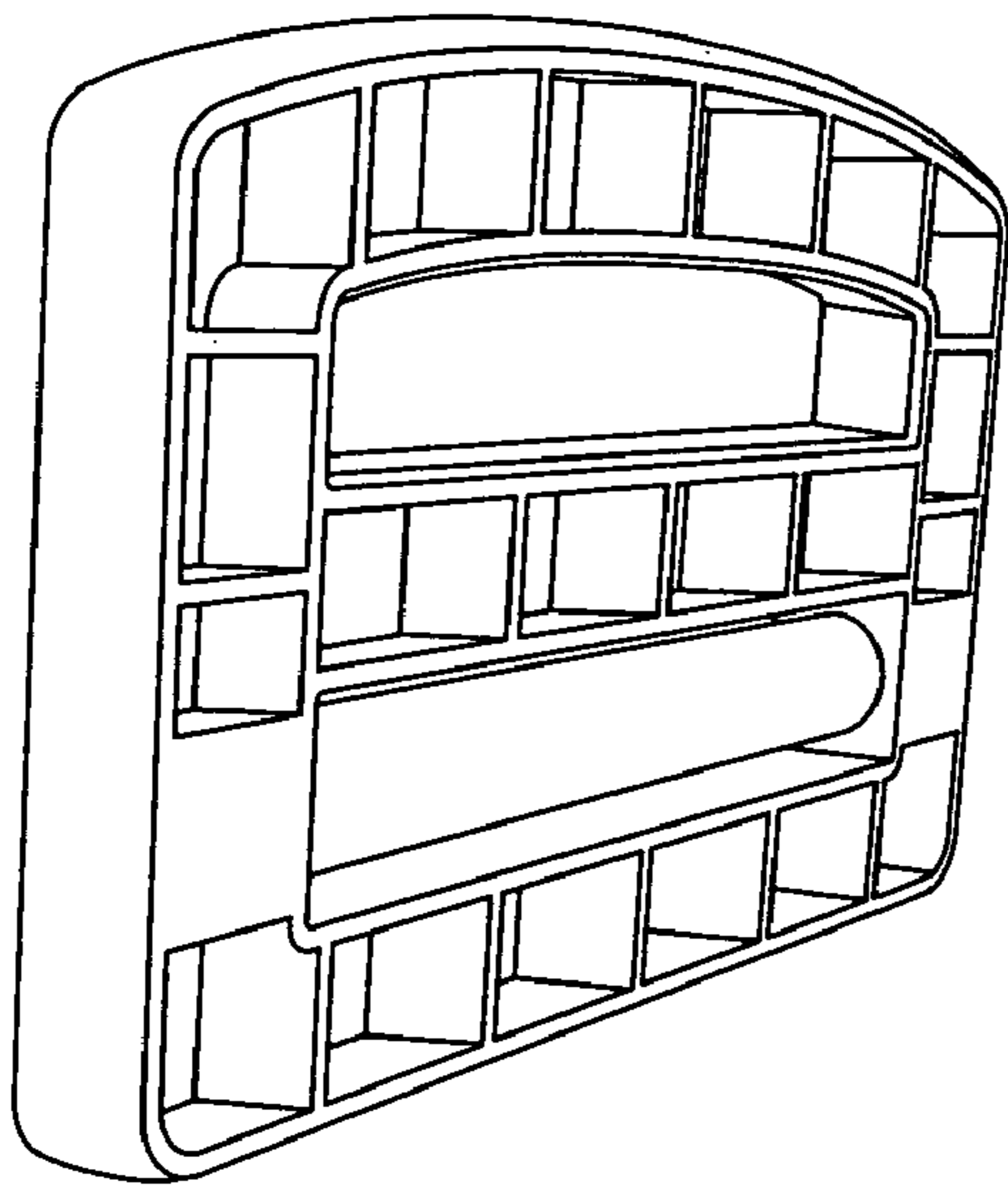

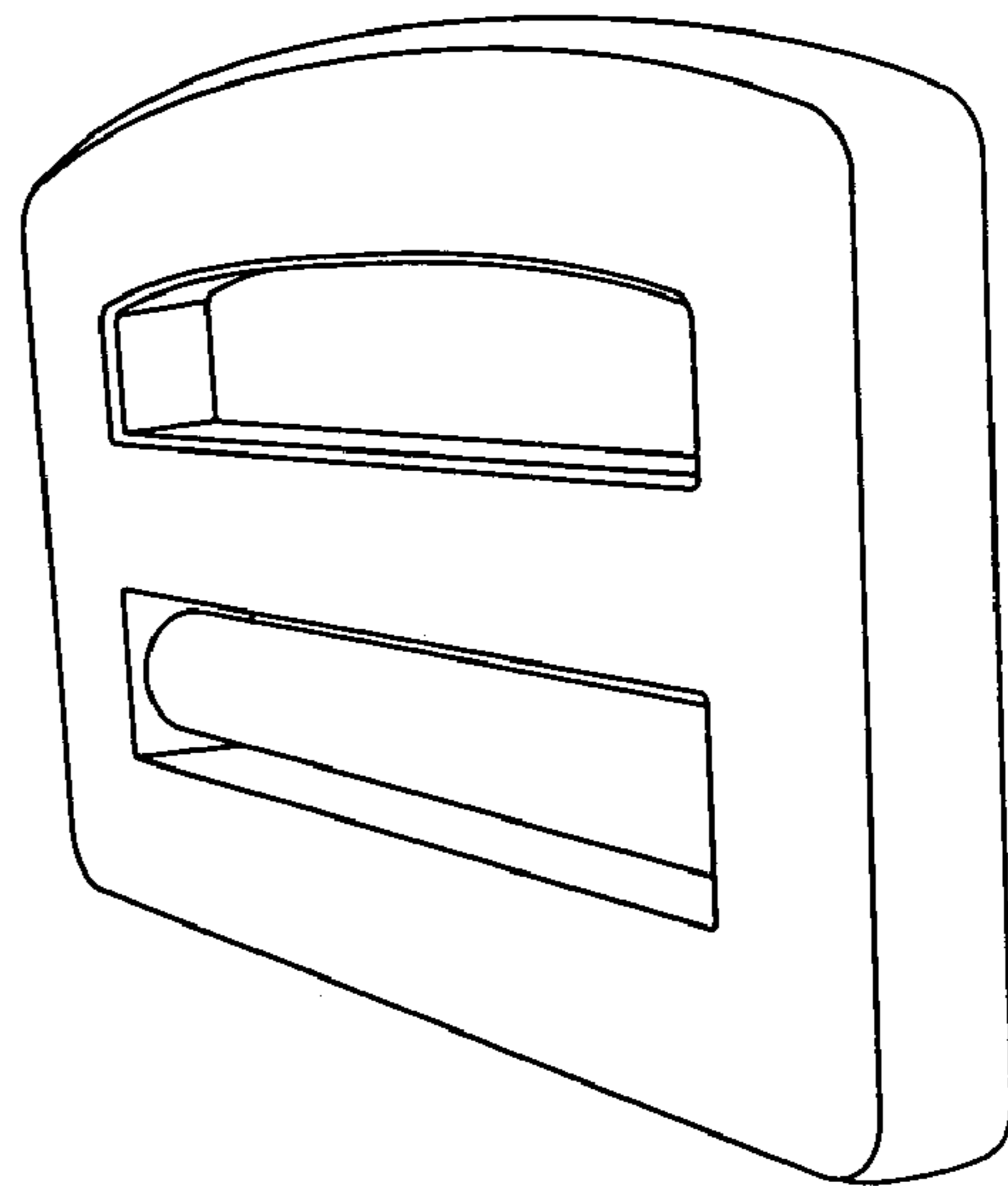

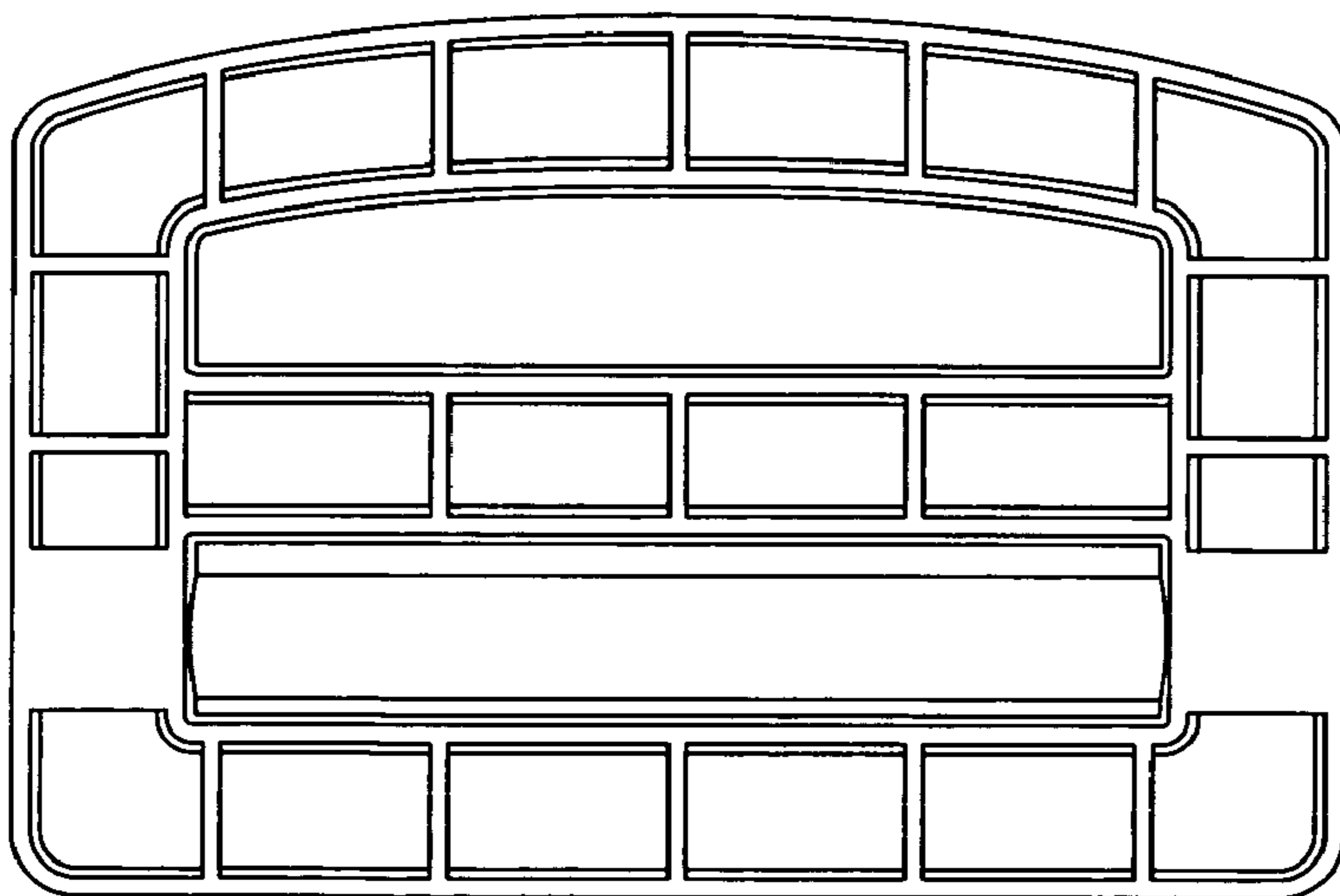

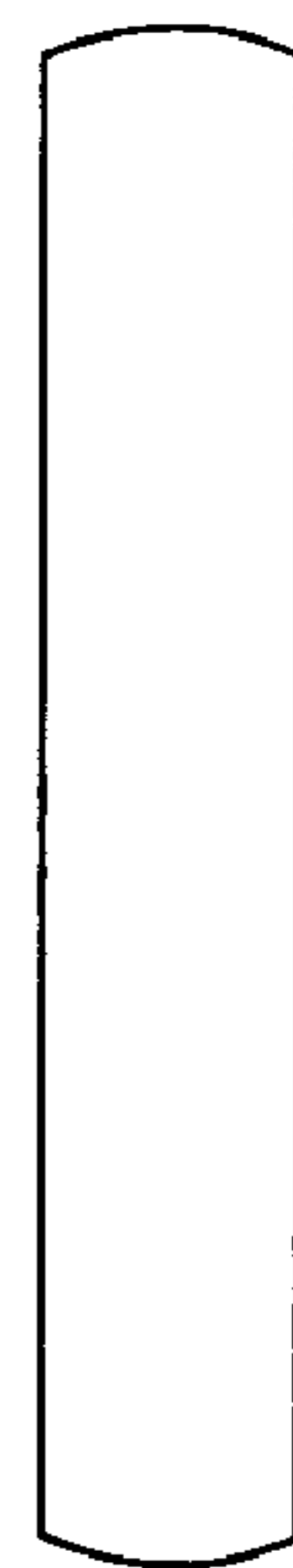

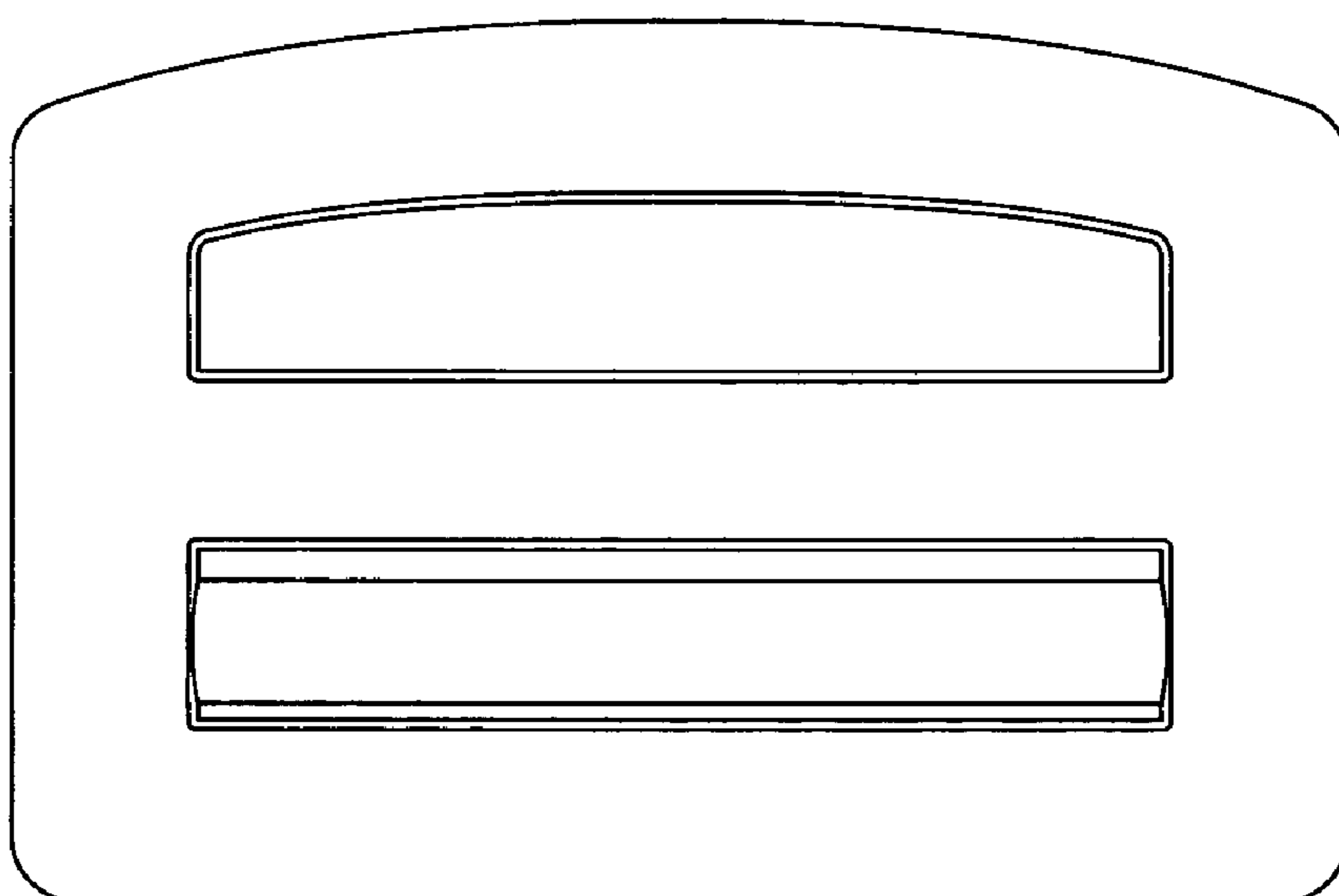

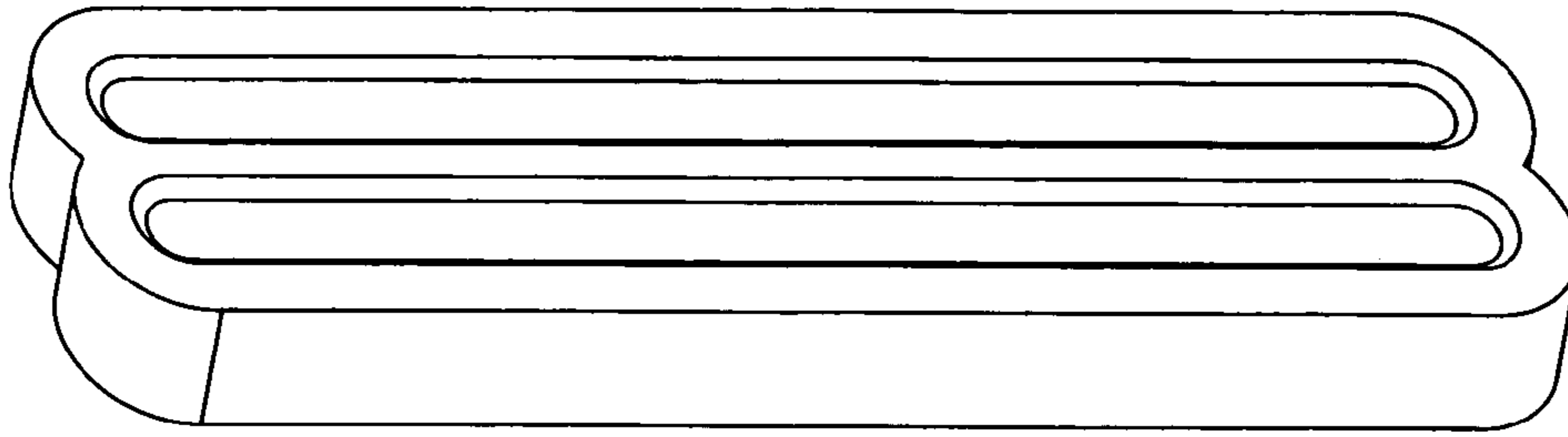

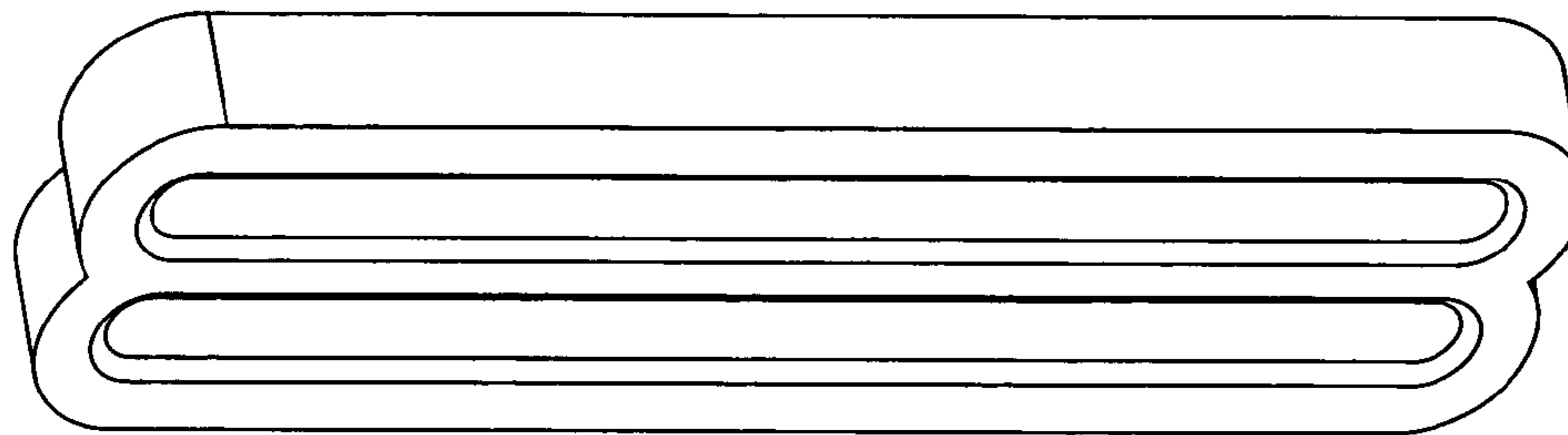

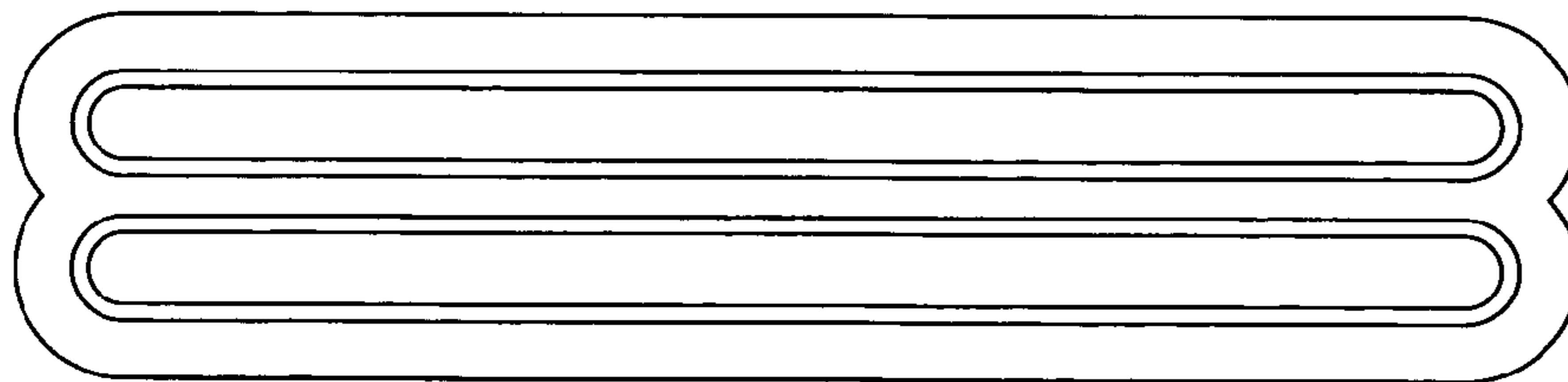

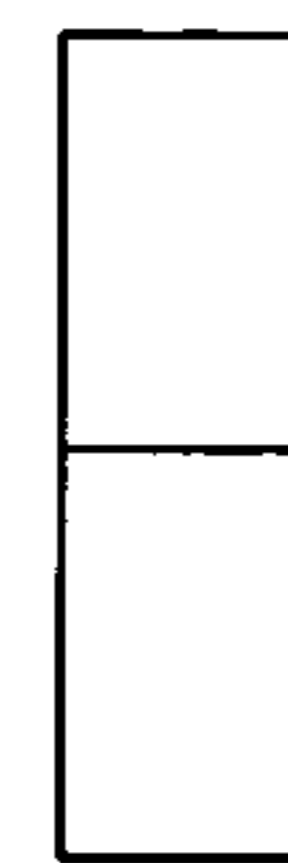
