The ornamental design for a bowl and base assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and left side perspective view of a bowl and base assembly showing our new design;

FIG. 2 is a top, rear, and left side perspective view, shown in an exploded position;

FIG. 3 is a top plan view of FIG. 1;

FIG. 5 a left elevation view thereof;

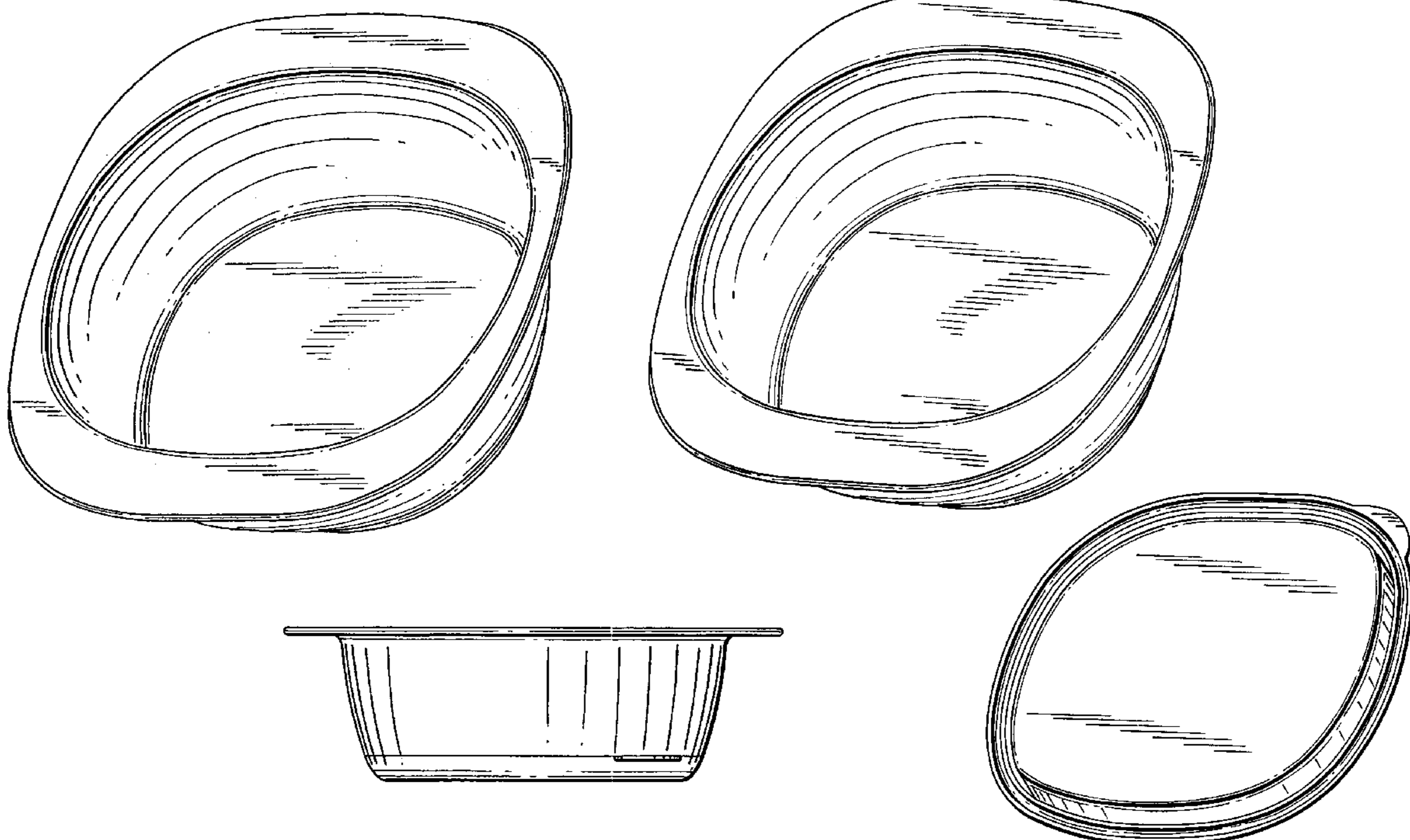
FIG. 6 is a right elevation view thereof;

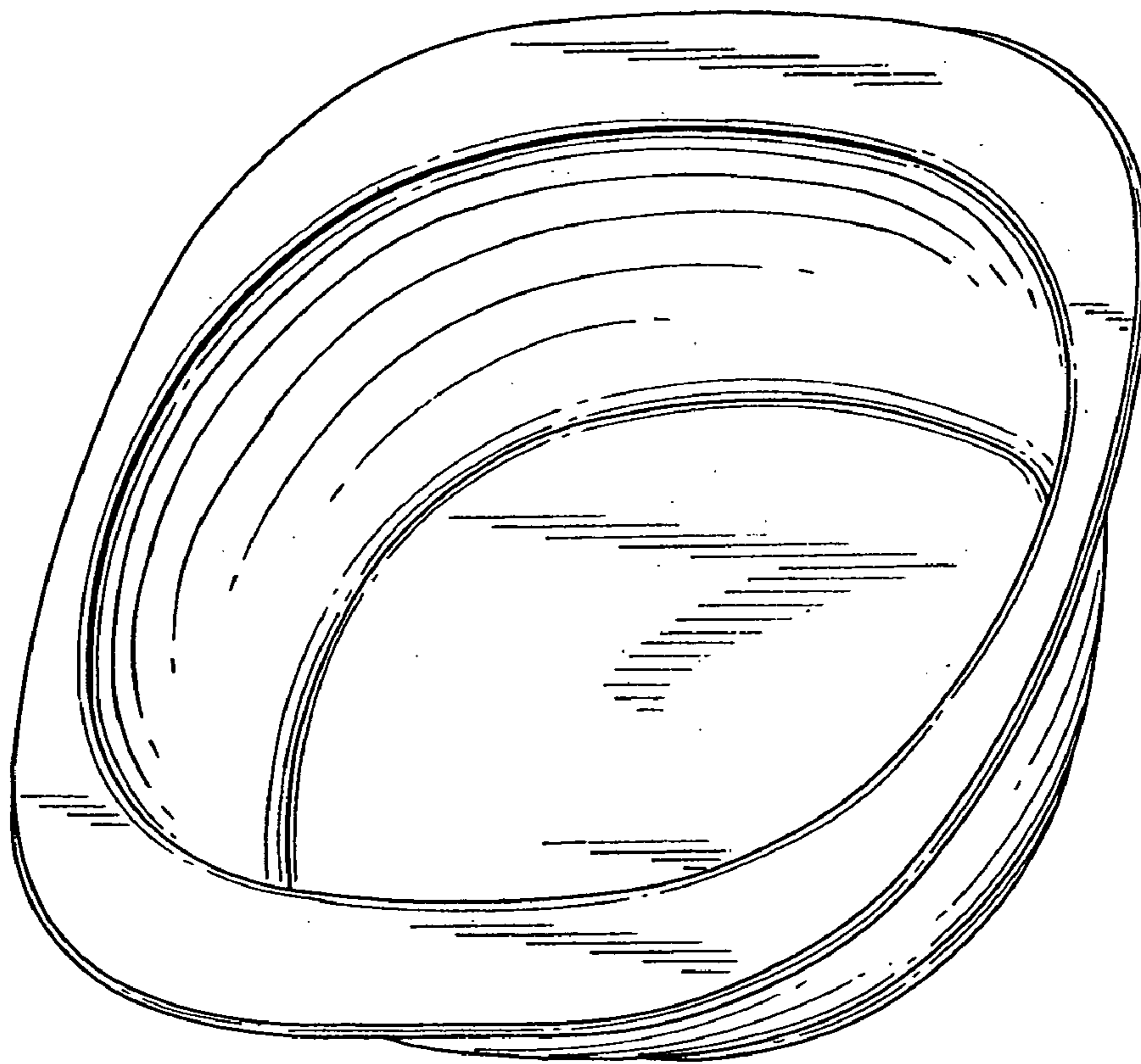

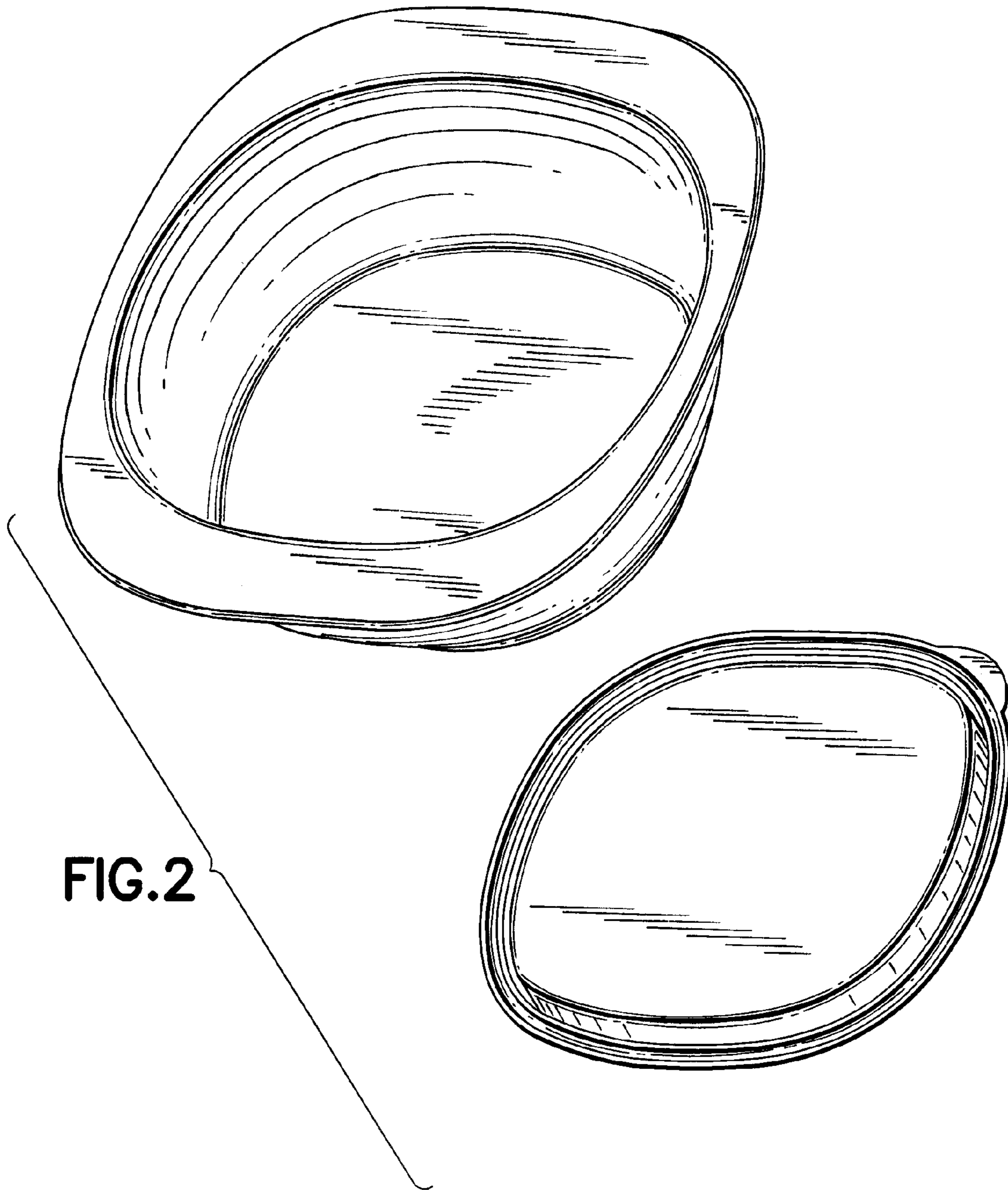

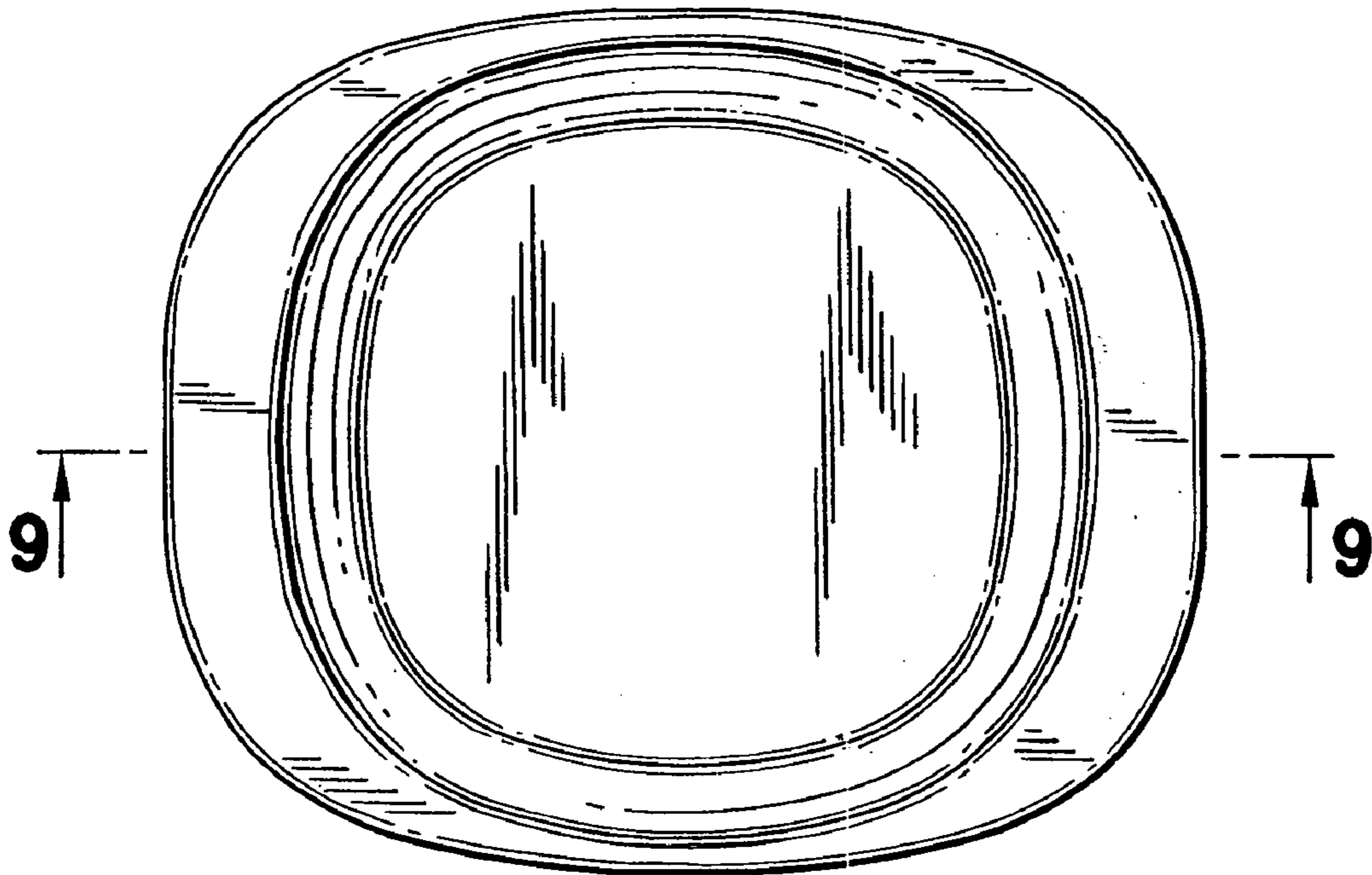

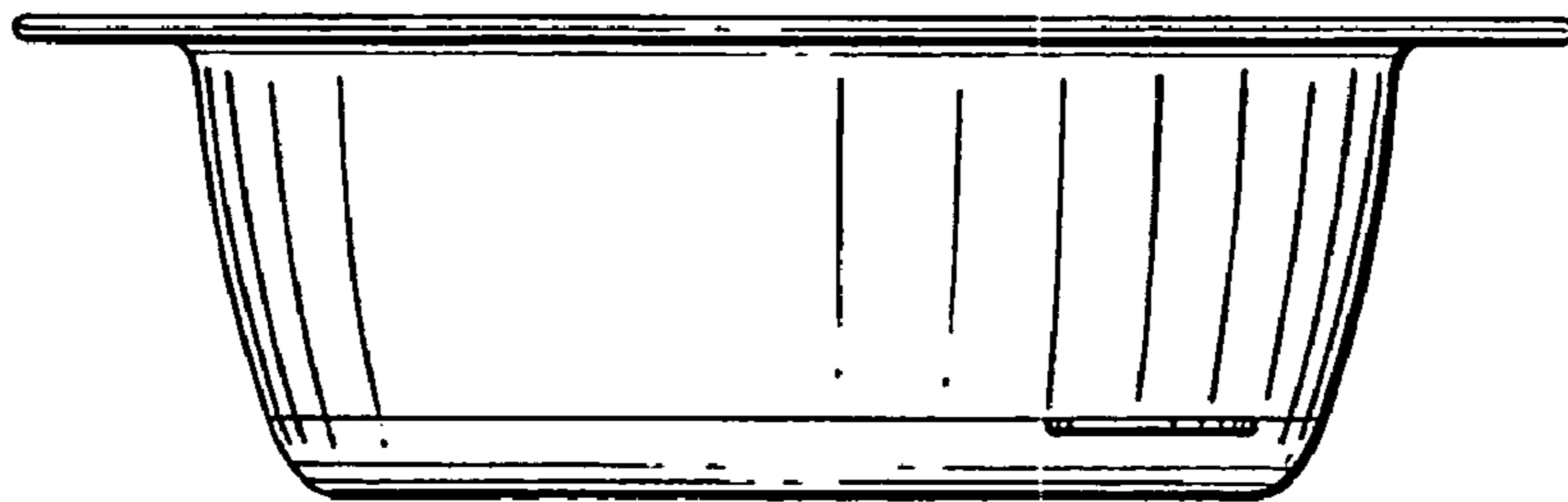
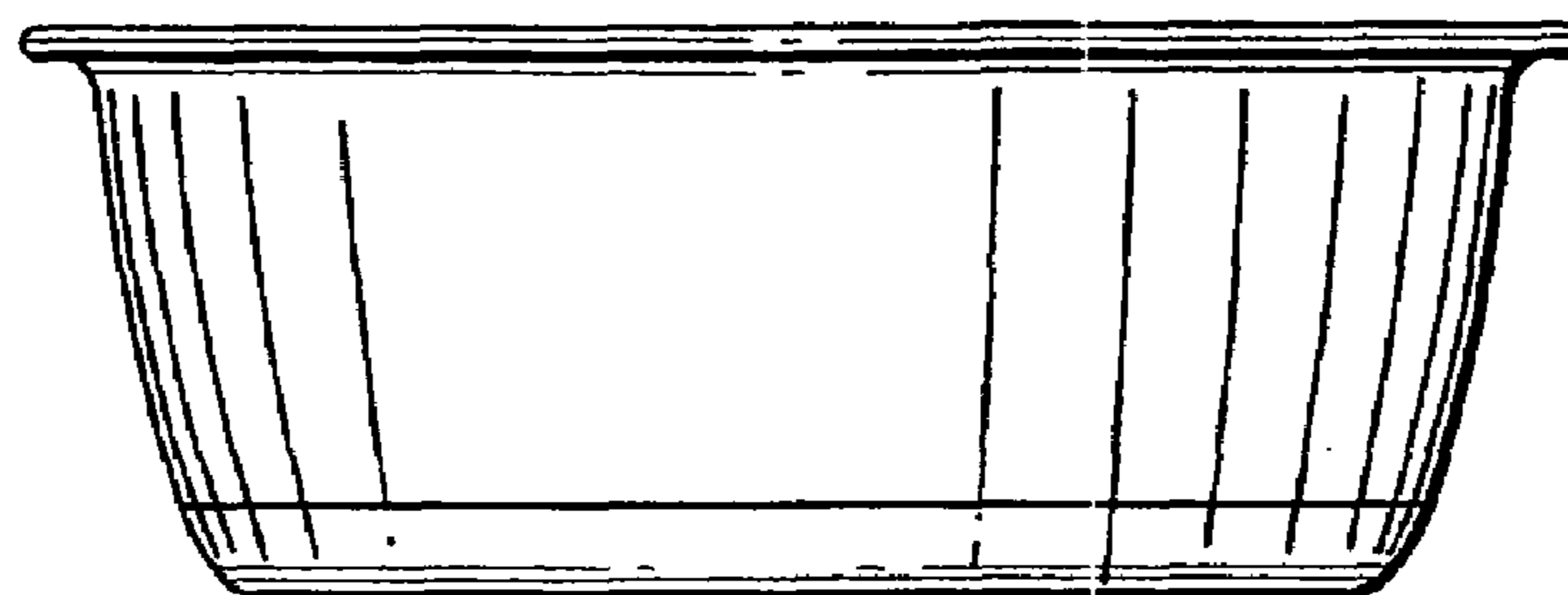
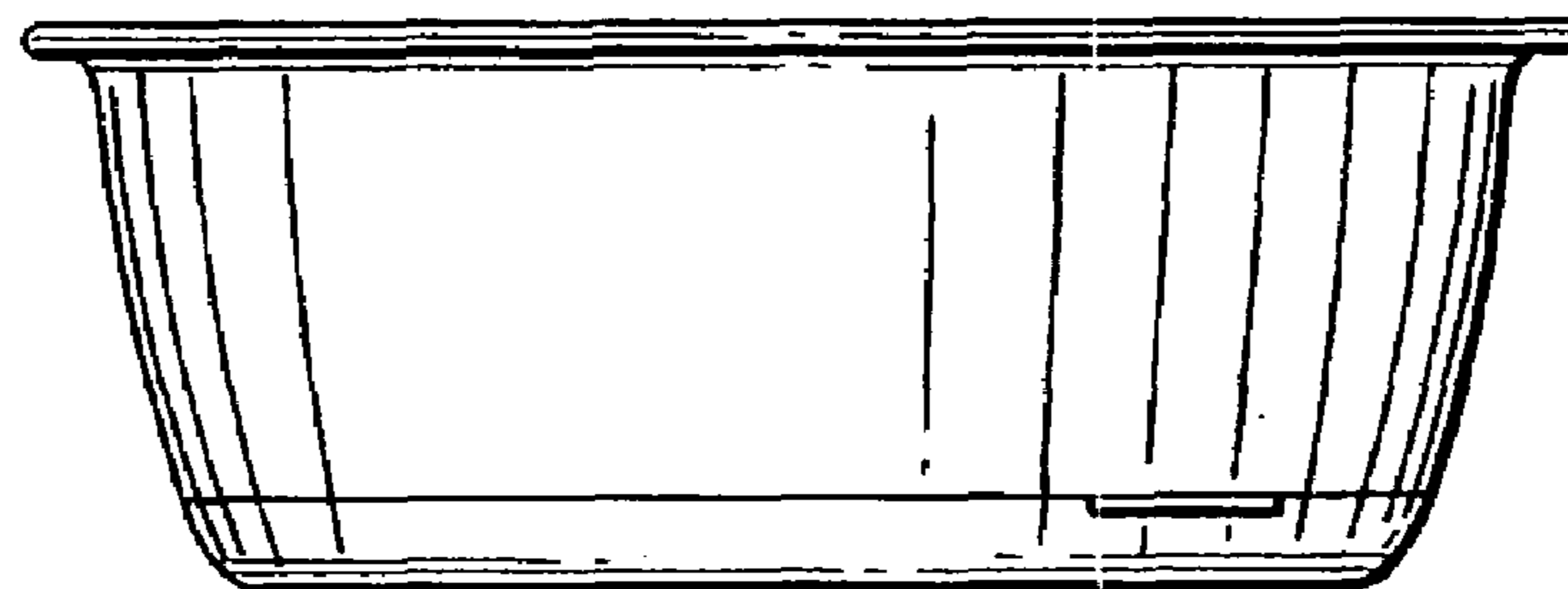

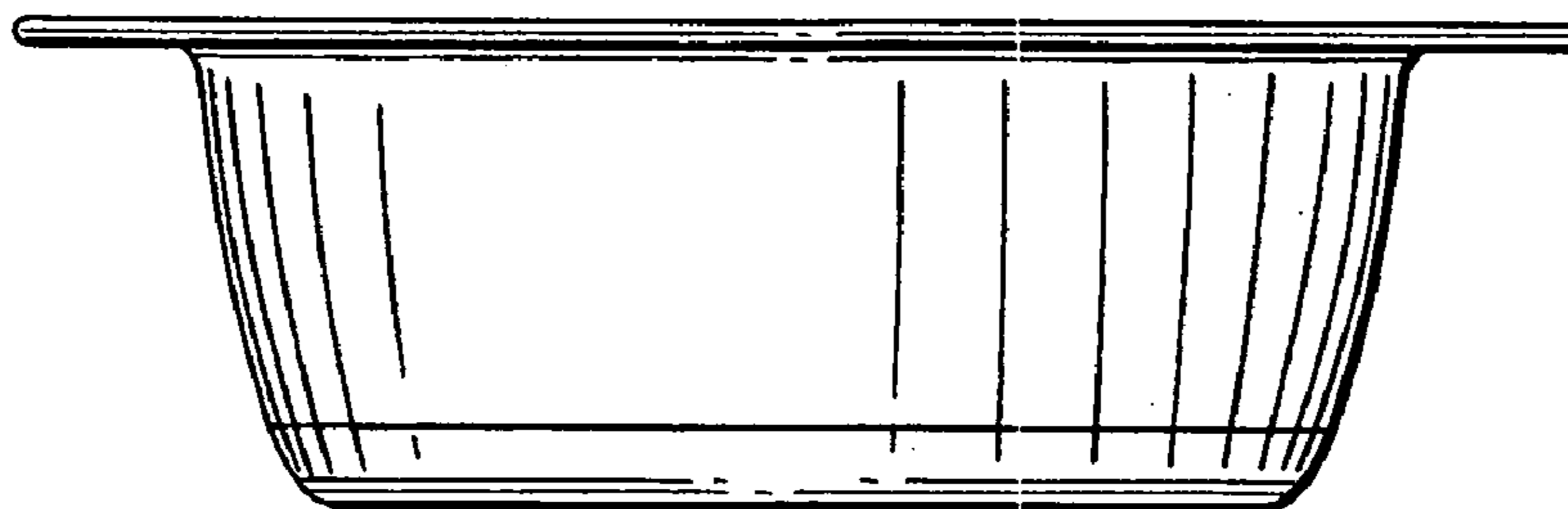

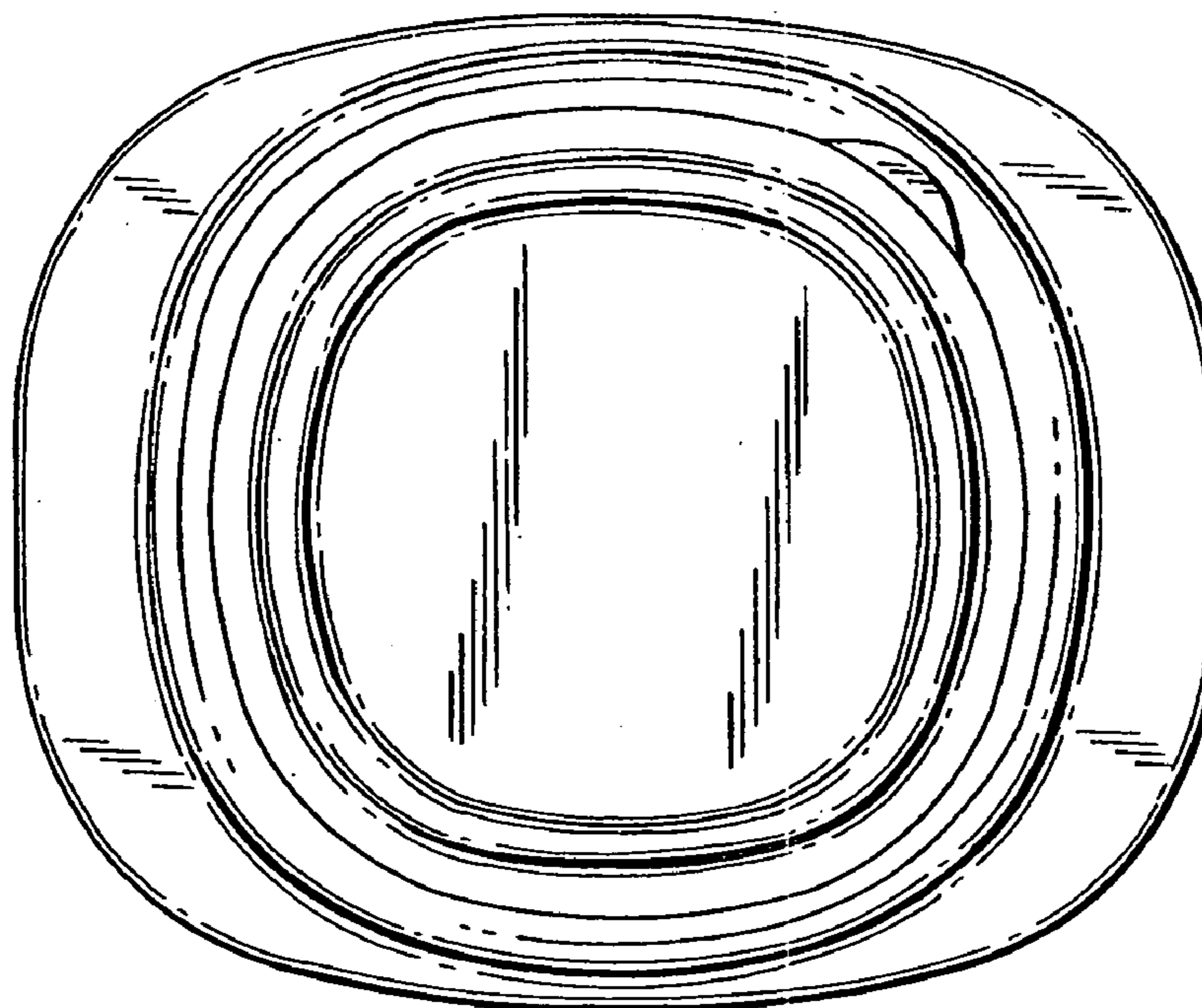

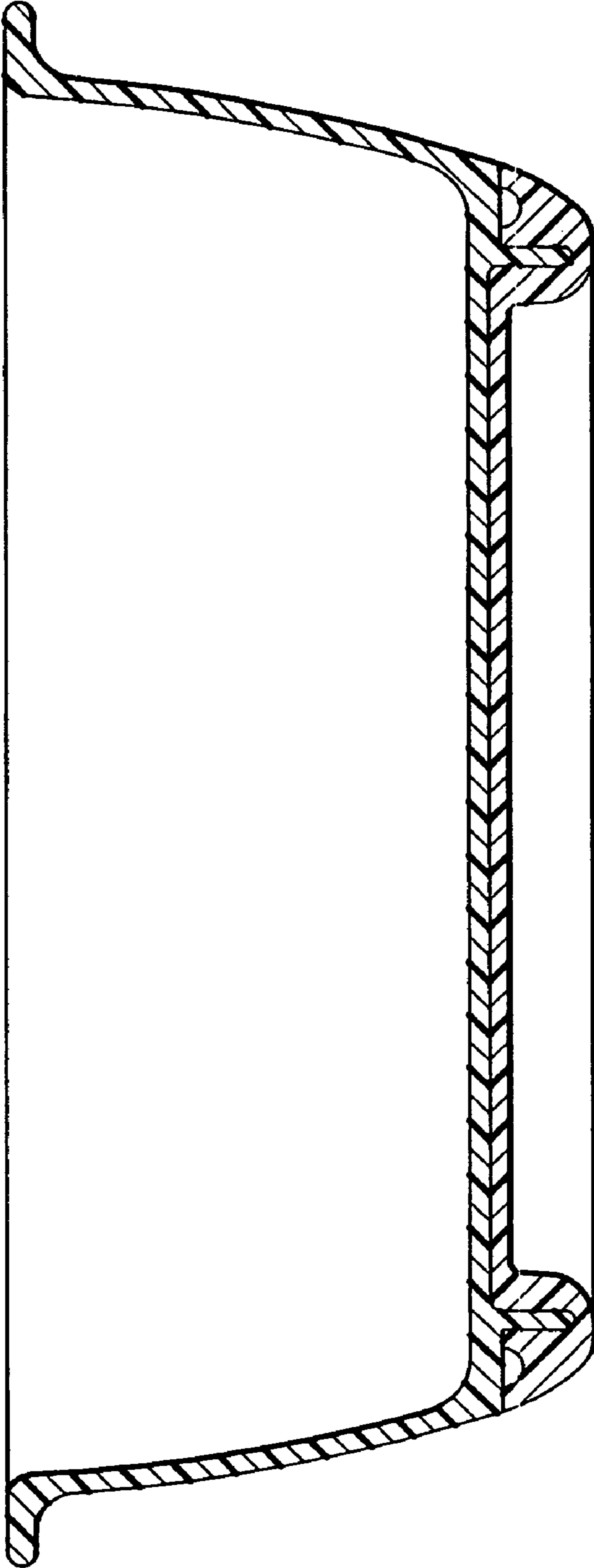
