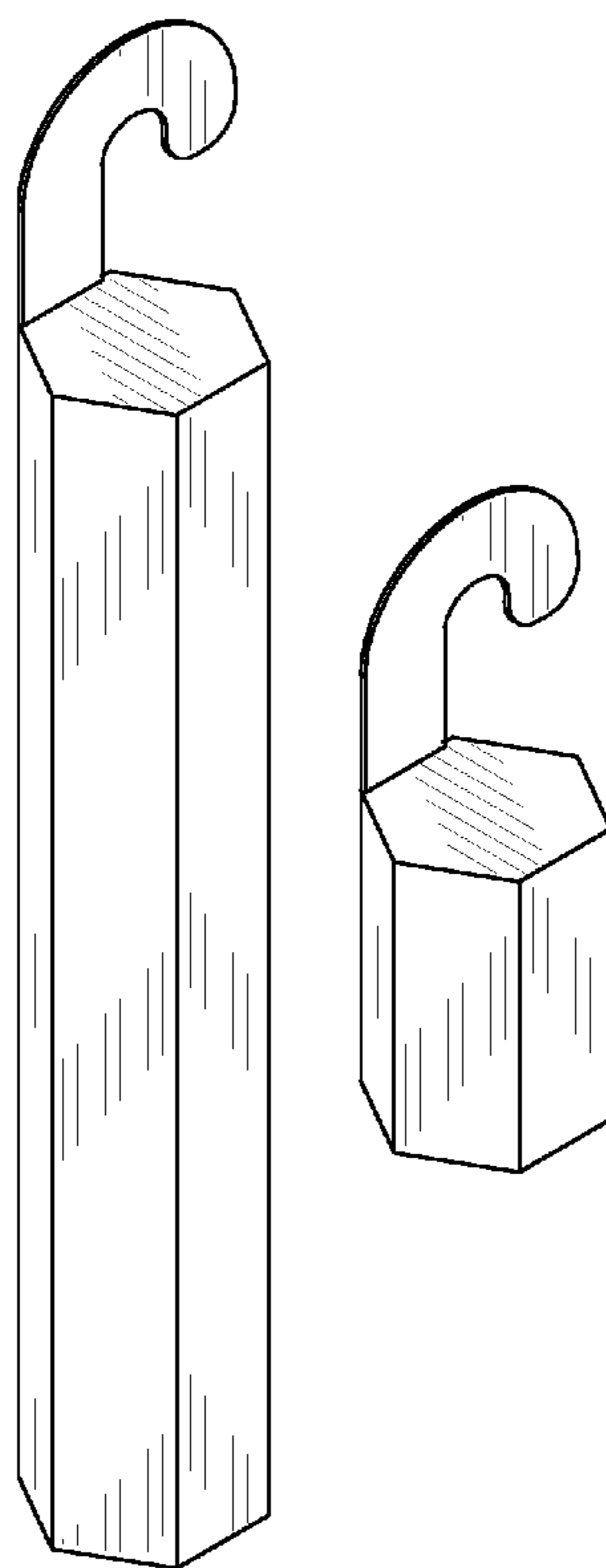
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a carton according to the present invention;
FIG. 2 is a front elevational view of the carton of FIG. 1;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;

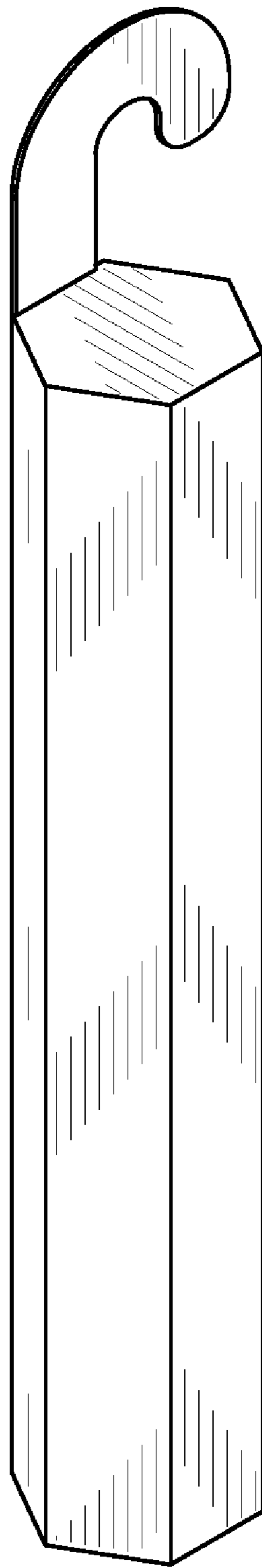

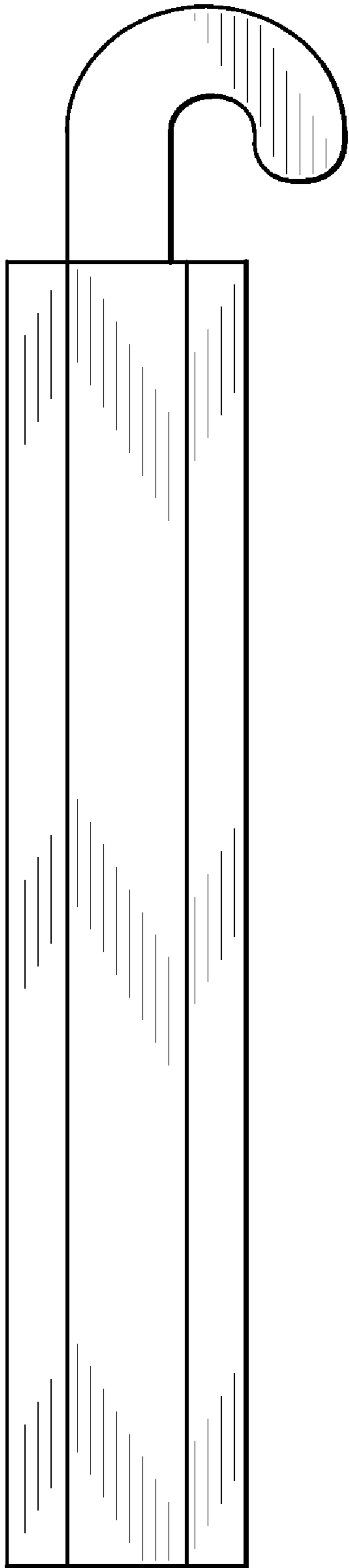

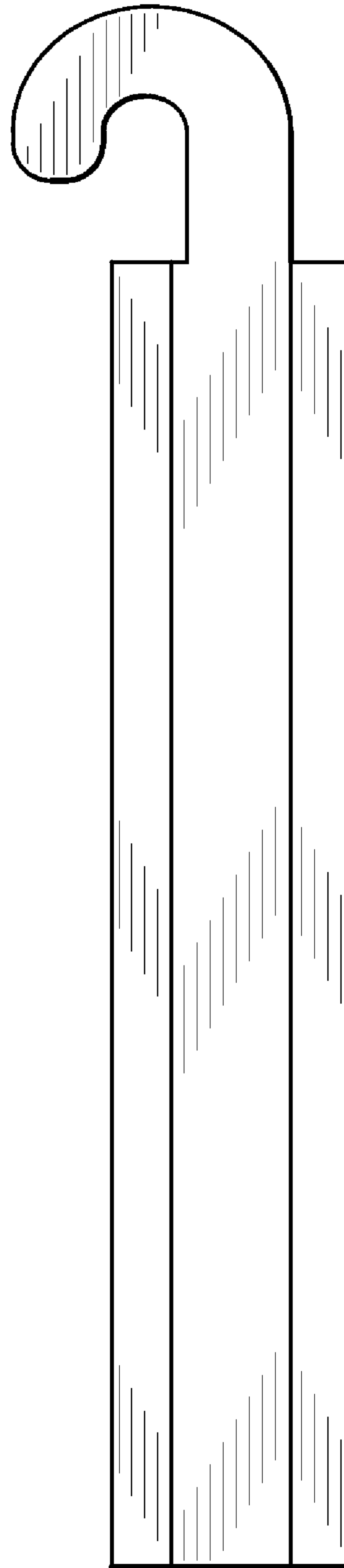

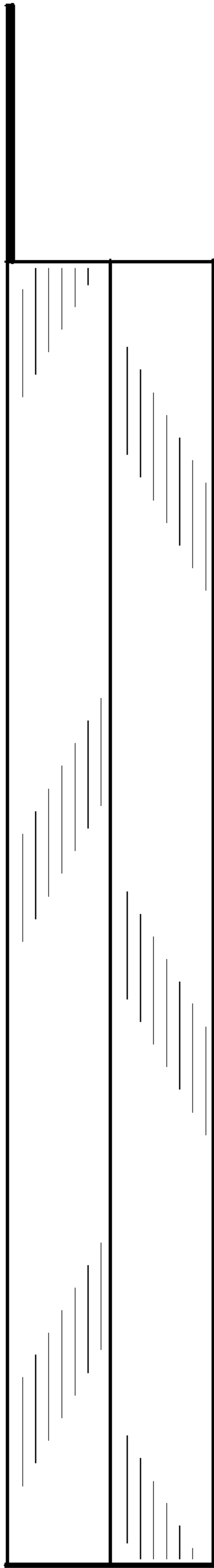

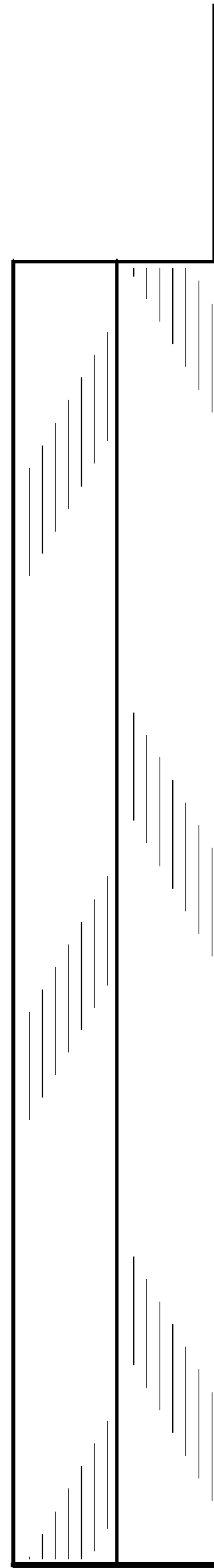

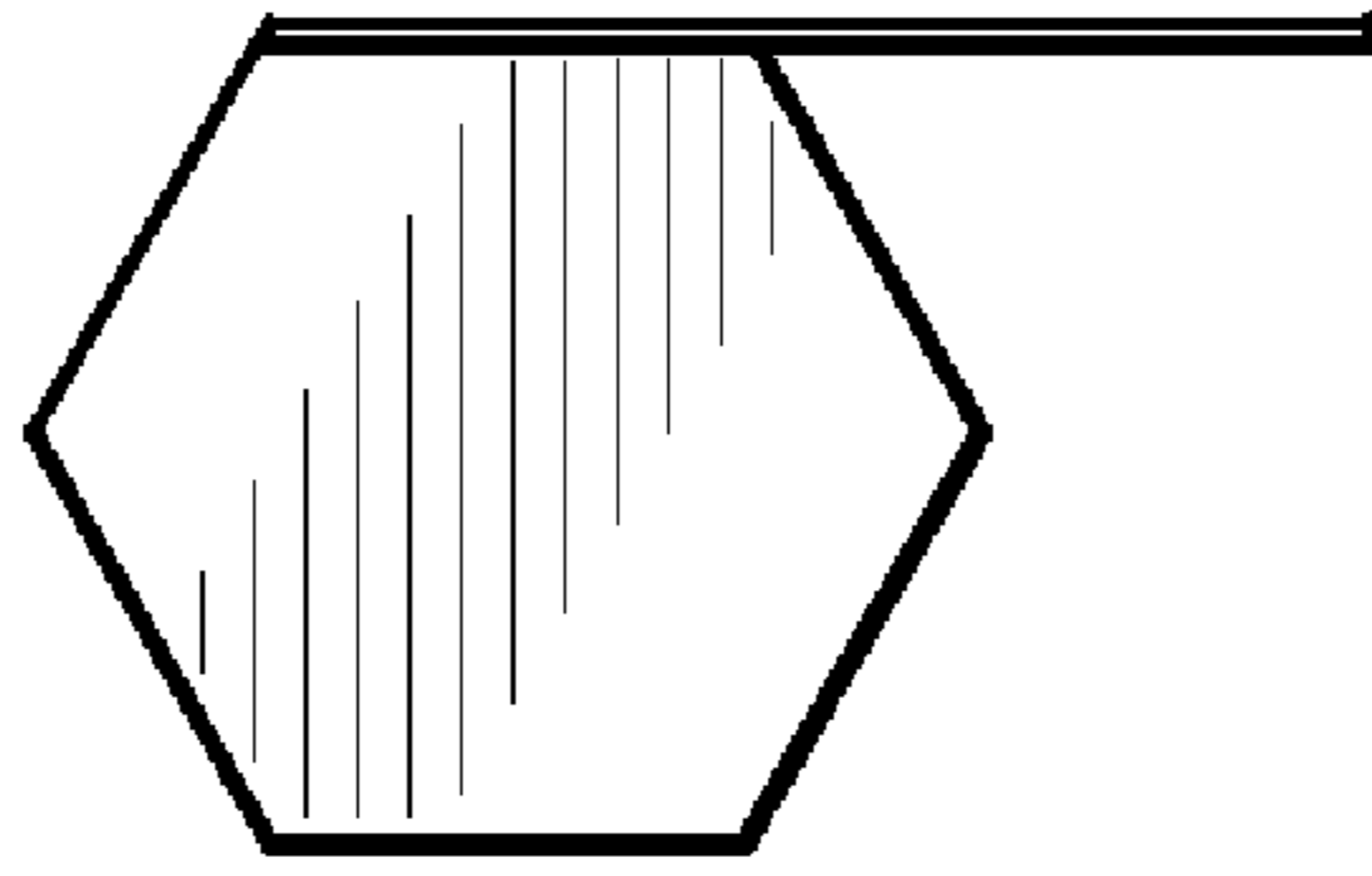

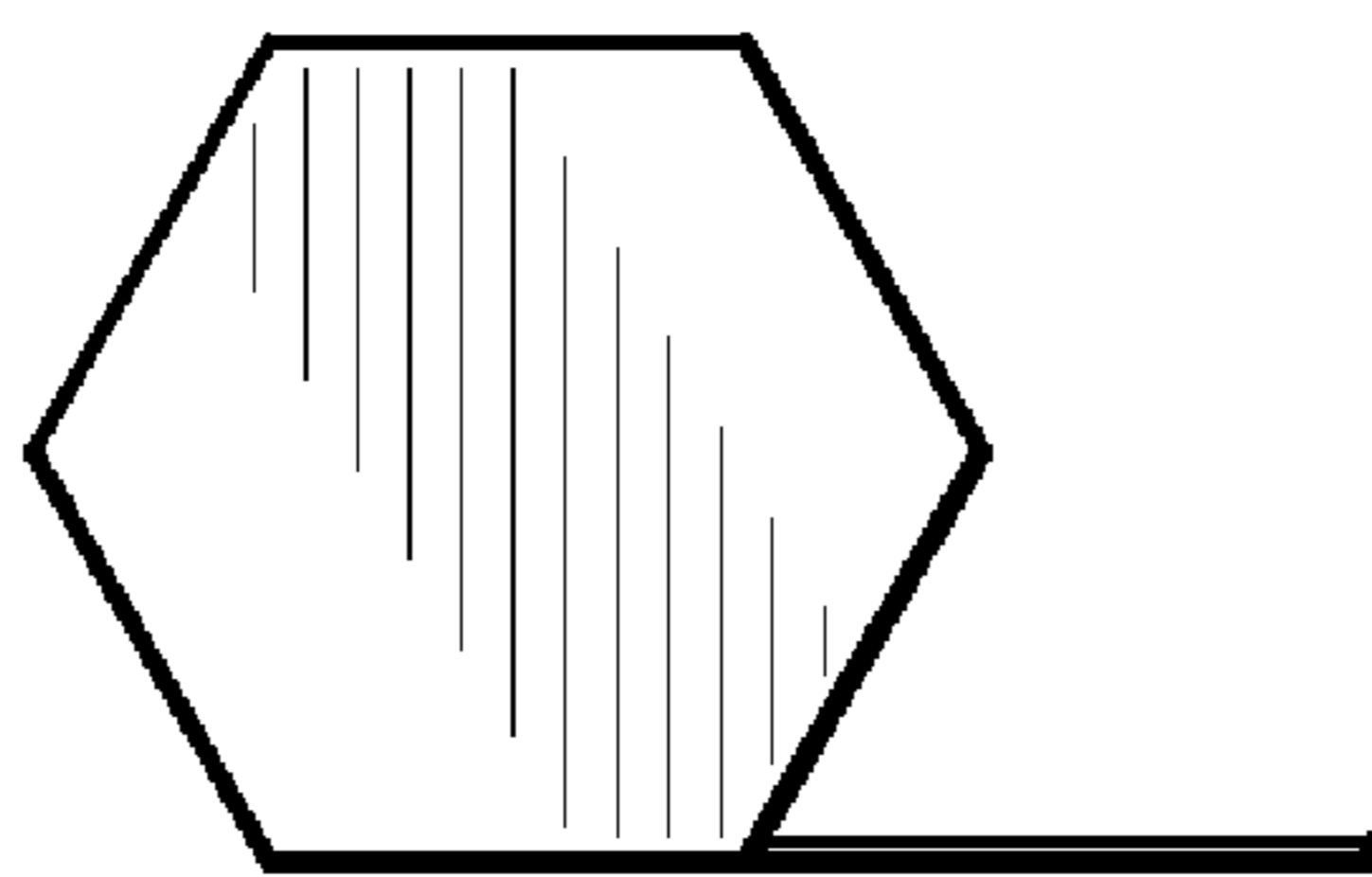

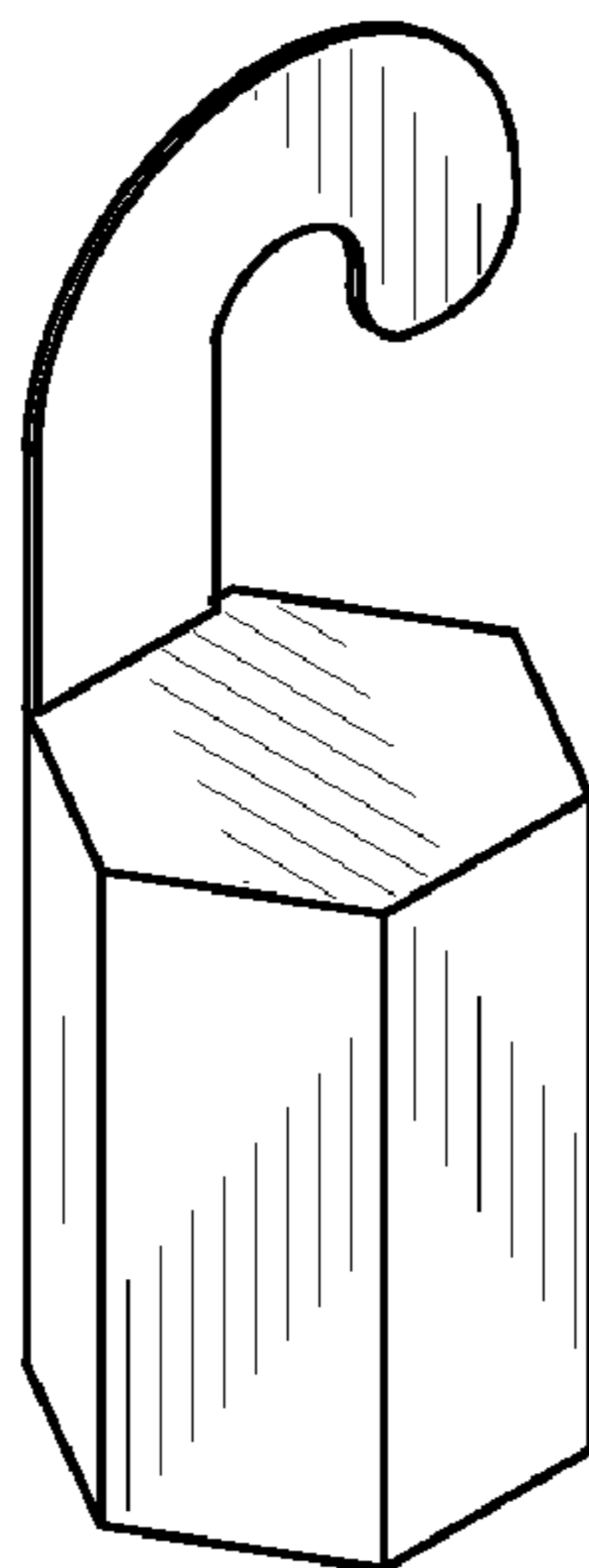

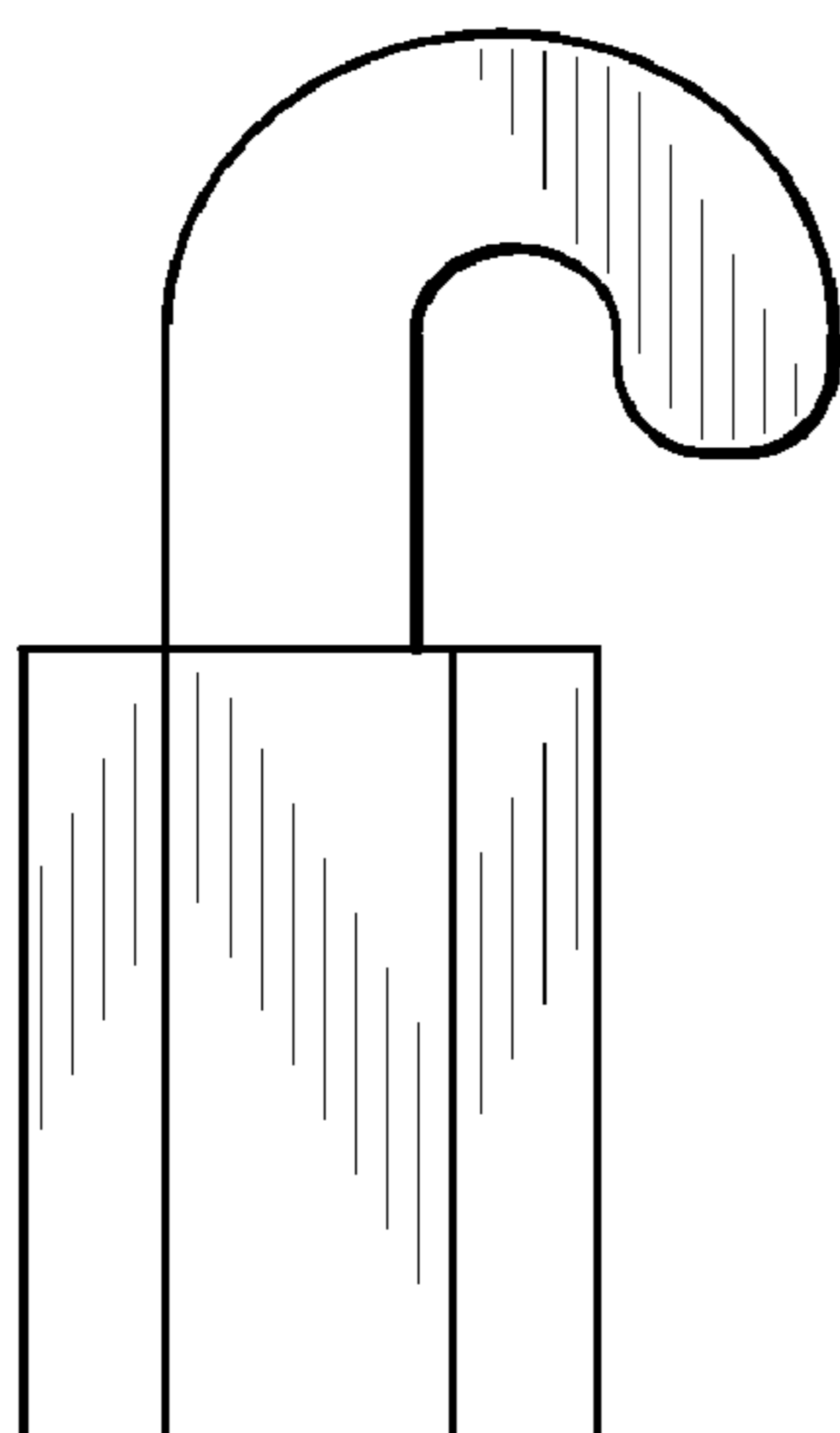

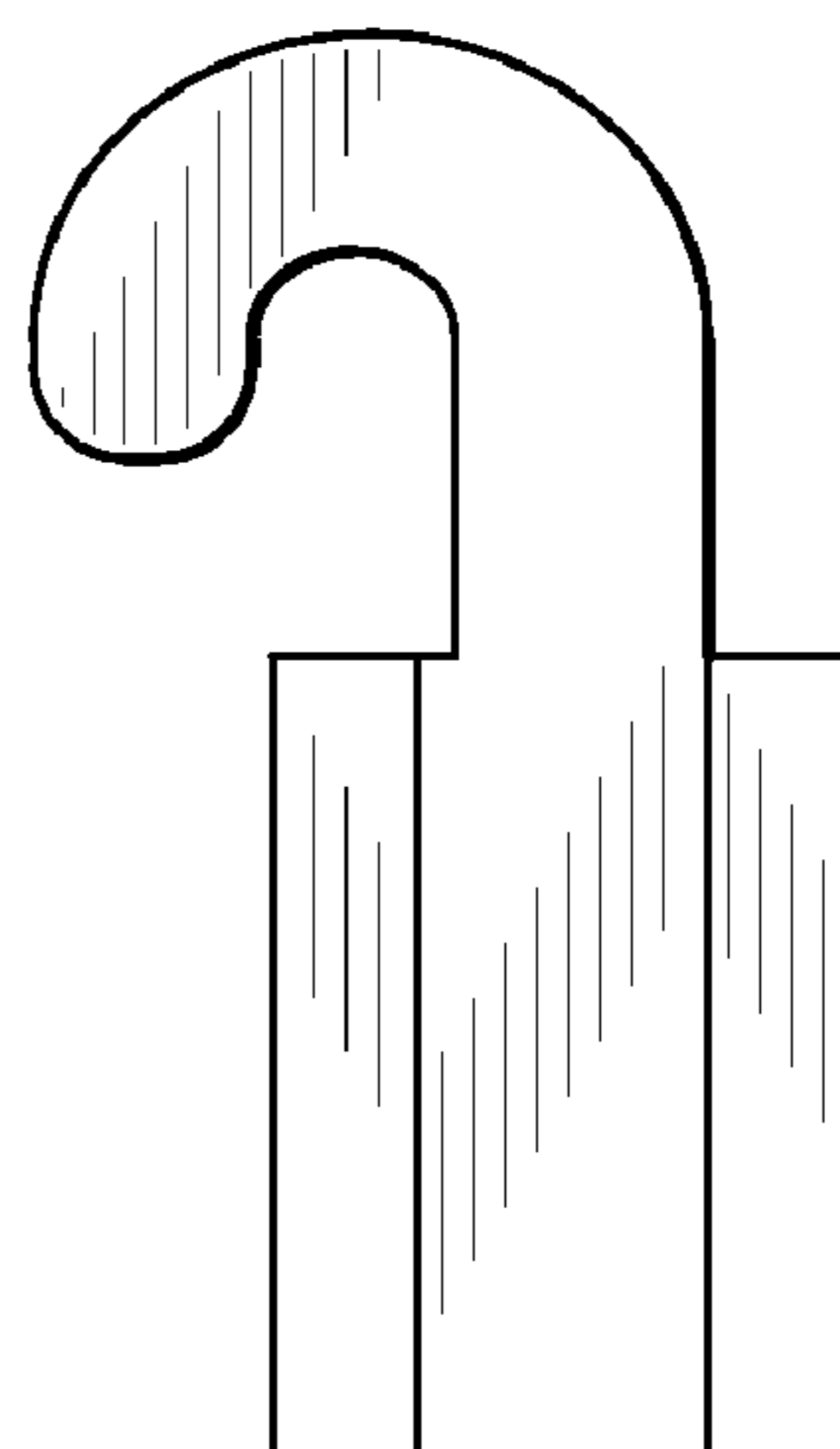

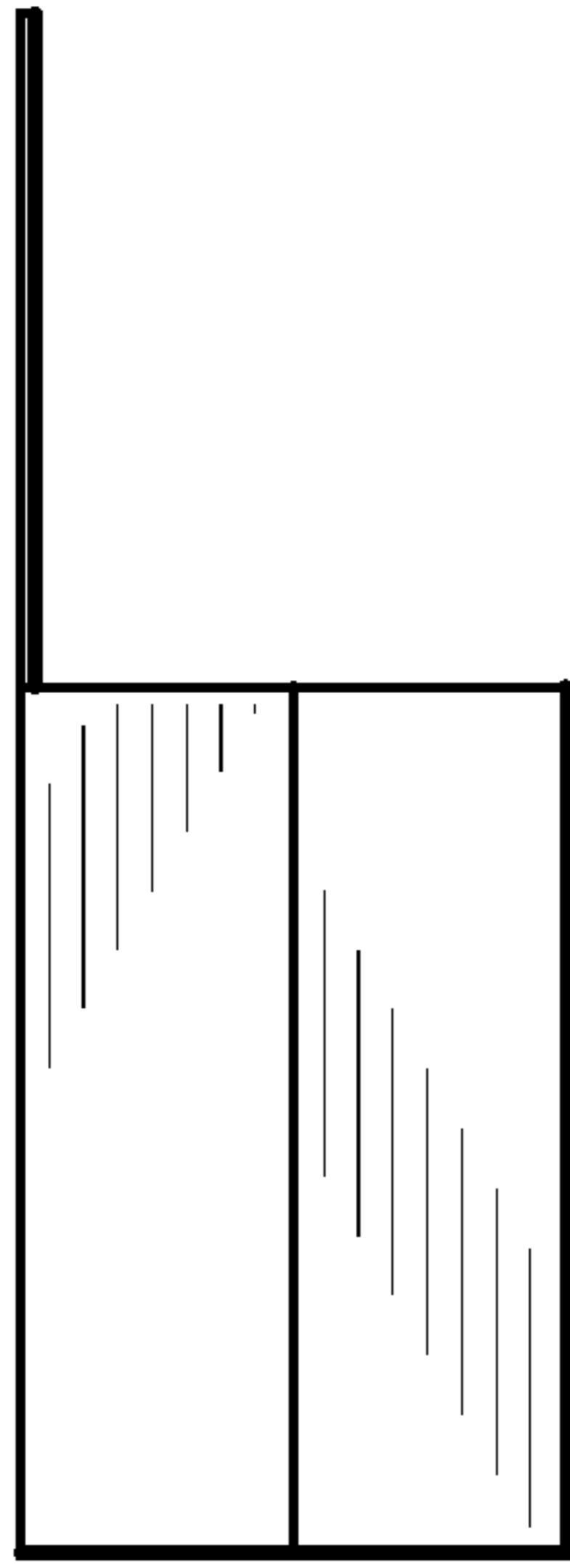

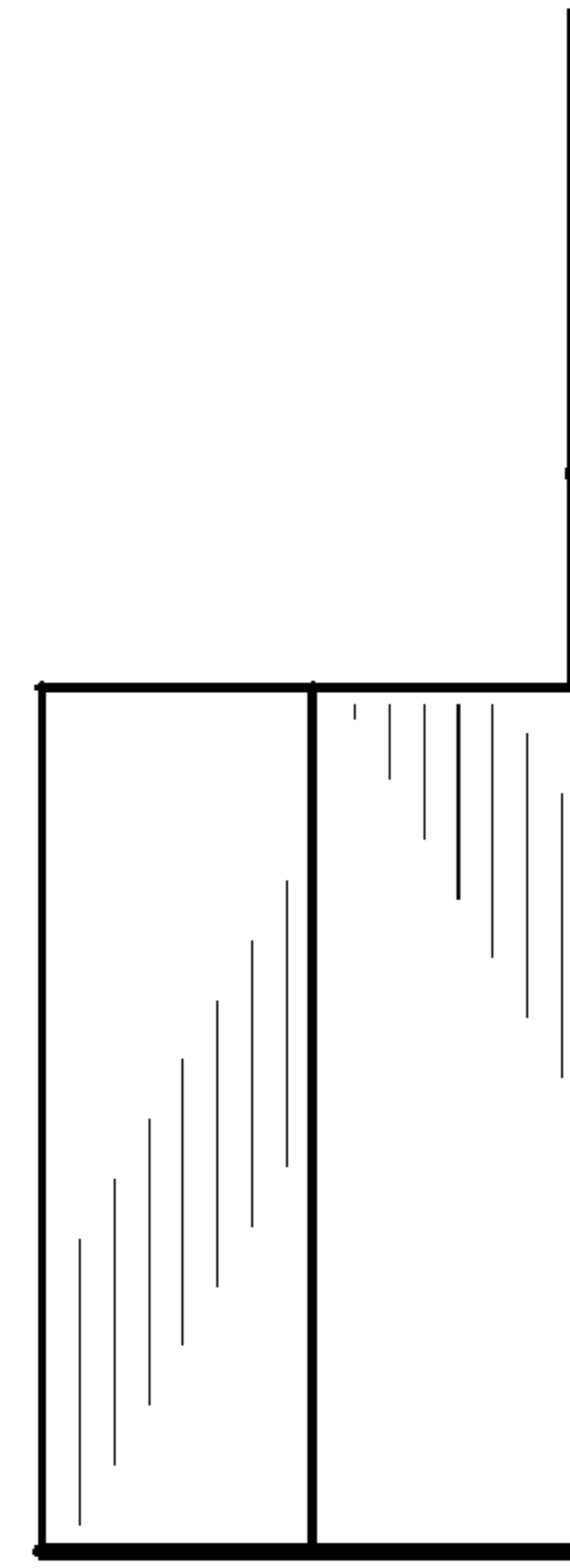

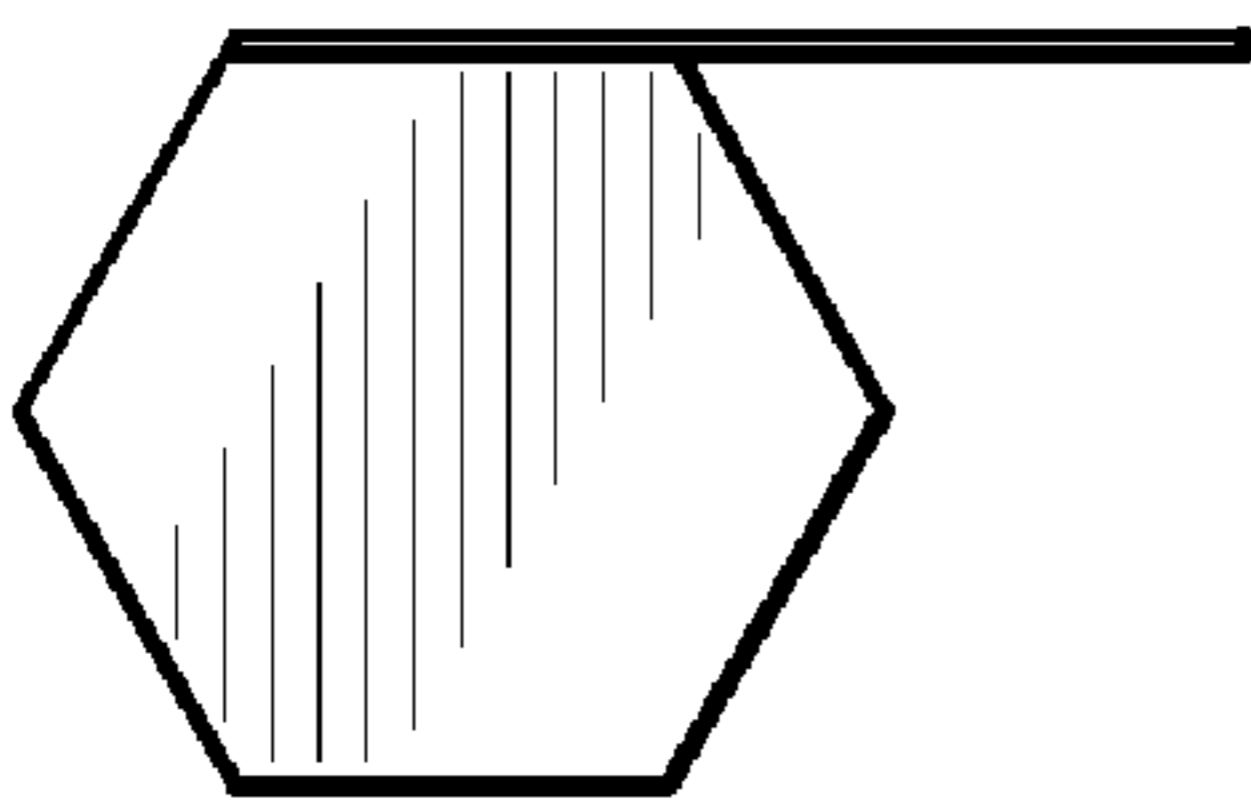

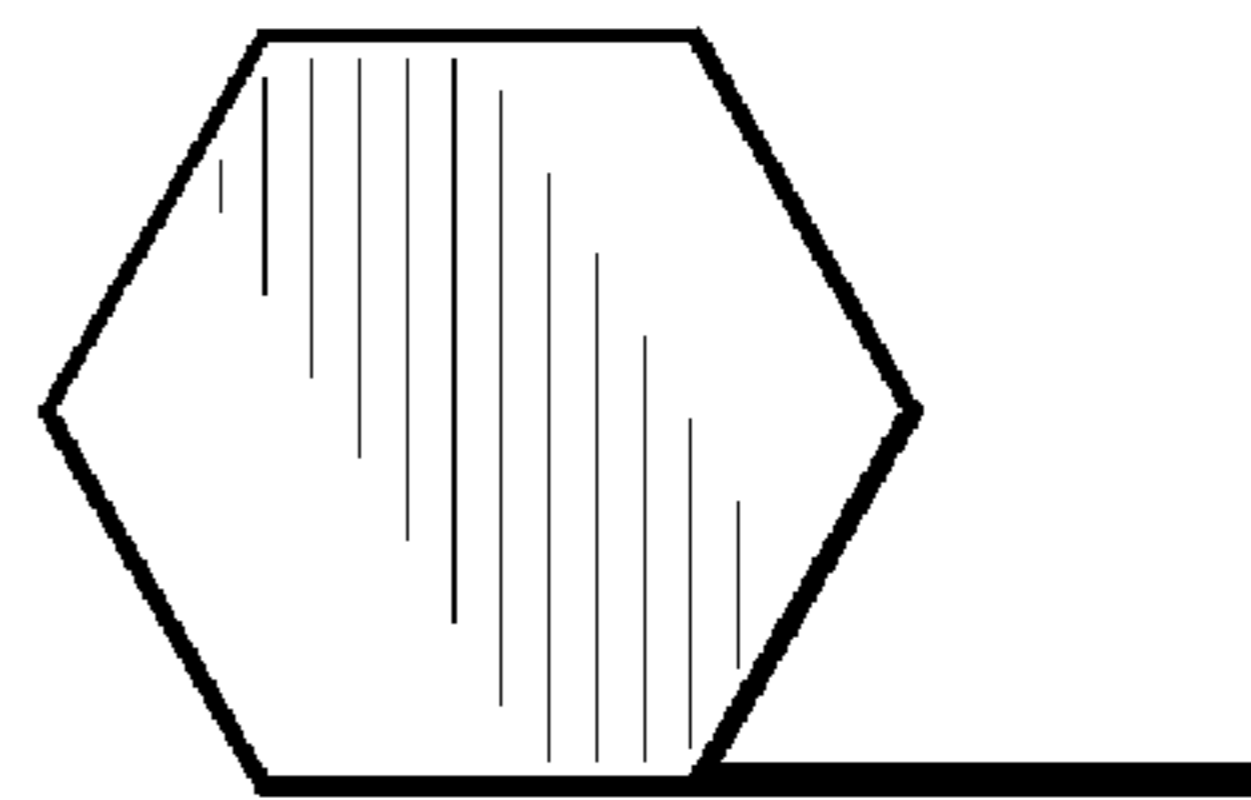
