FIG. 3 is a bottom view of the carton with extended printable surface of FIG. 1;

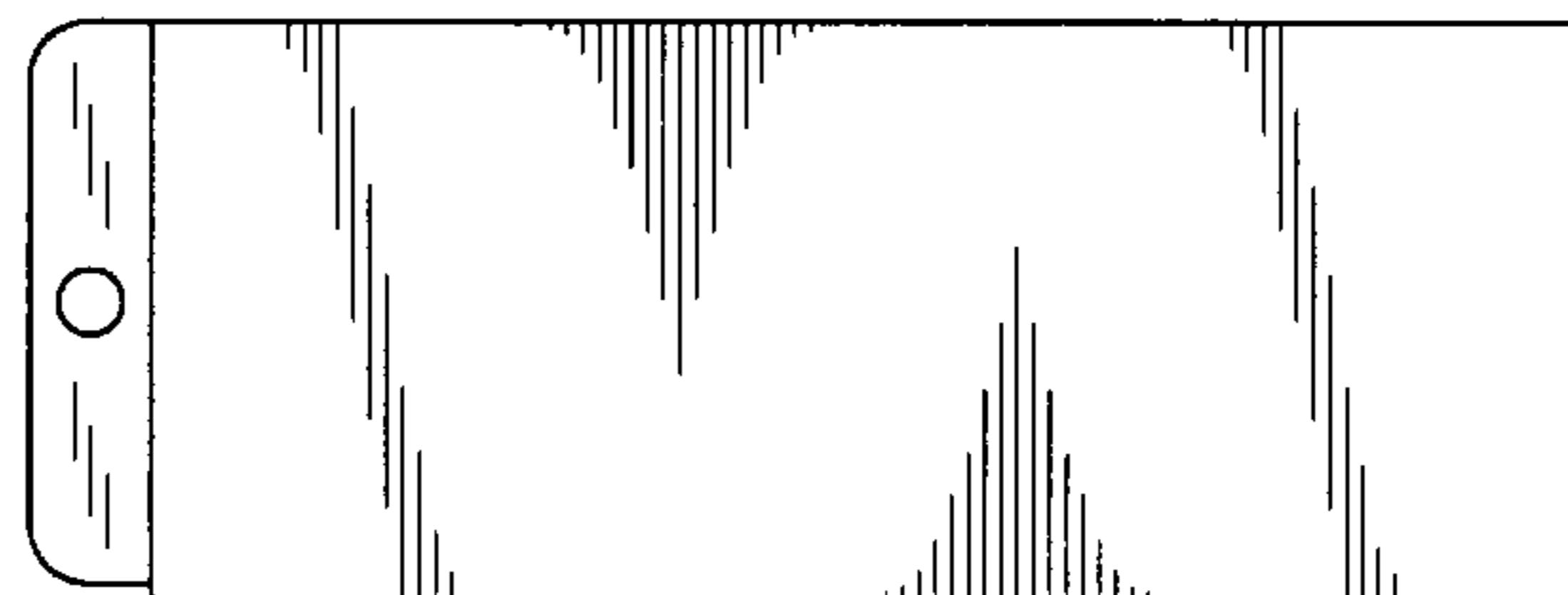
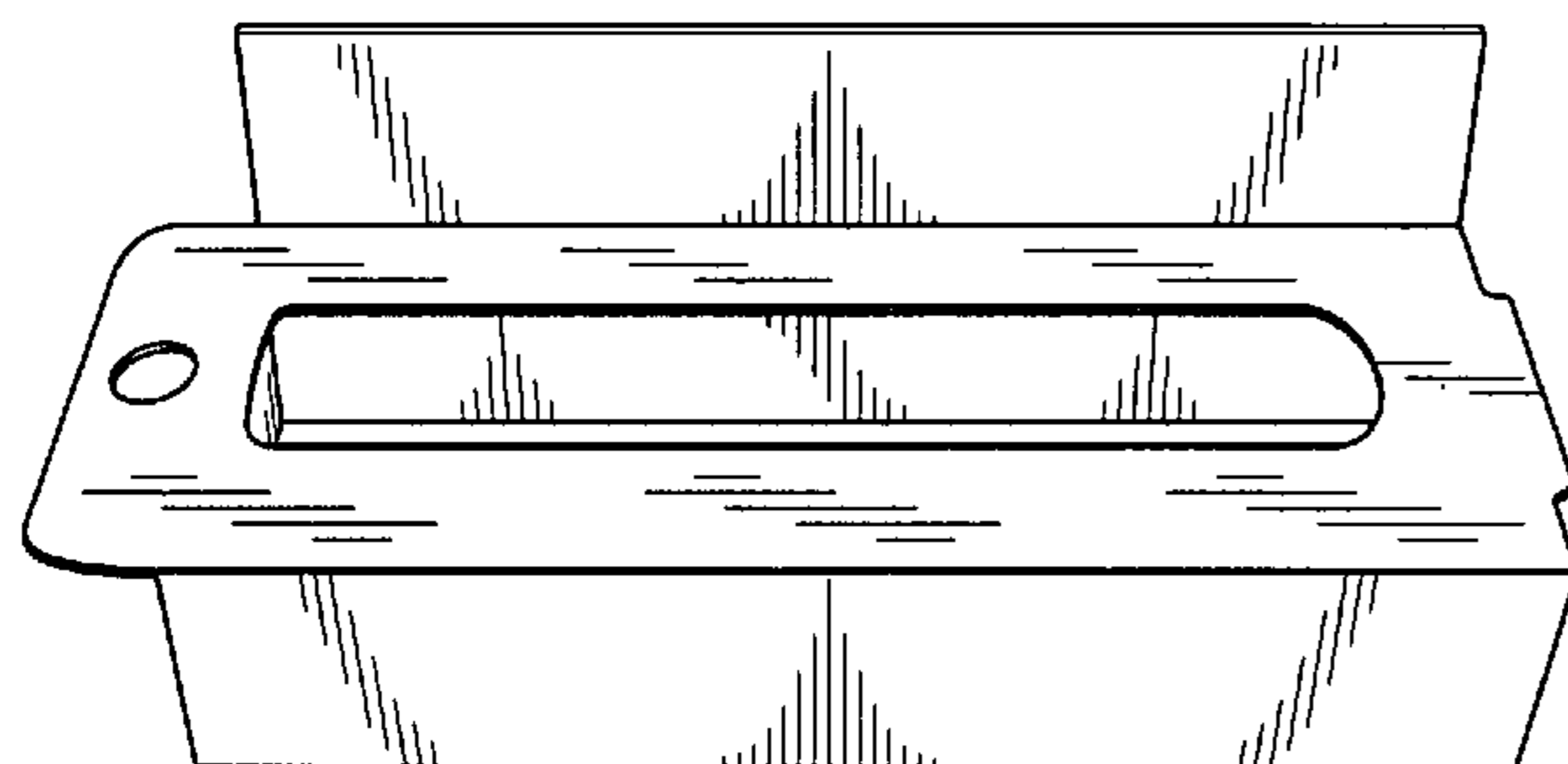
FIG. 4 is a front view of the carton with extended printable surface of FIG. 1;

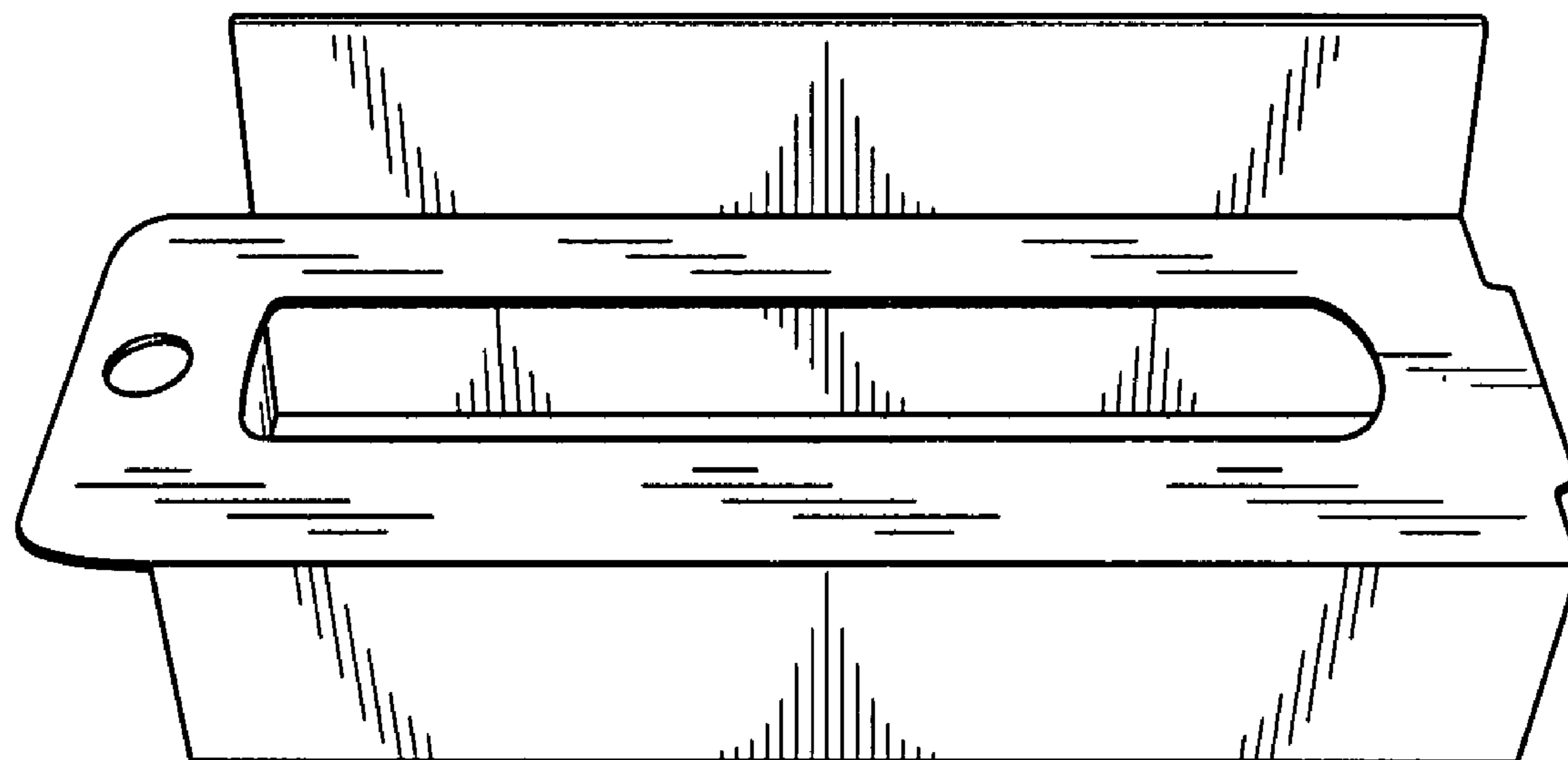
FIG. 5 is a back view of the carton with extended printable surface of FIG. 1;

FIG. 6 is one end view of the carton with extended printable surface of FIG. 1; and,

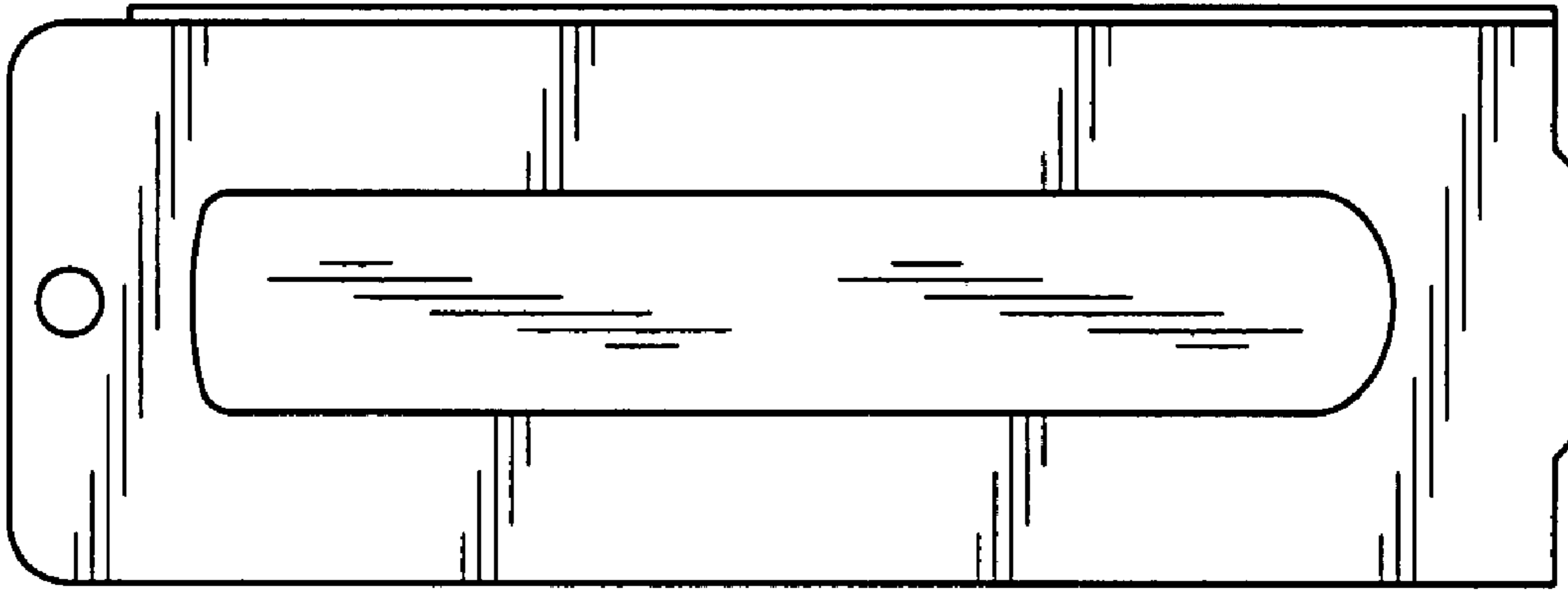
FIG. 7 is another end view of the carton with extended printable surface of FIG. 1.

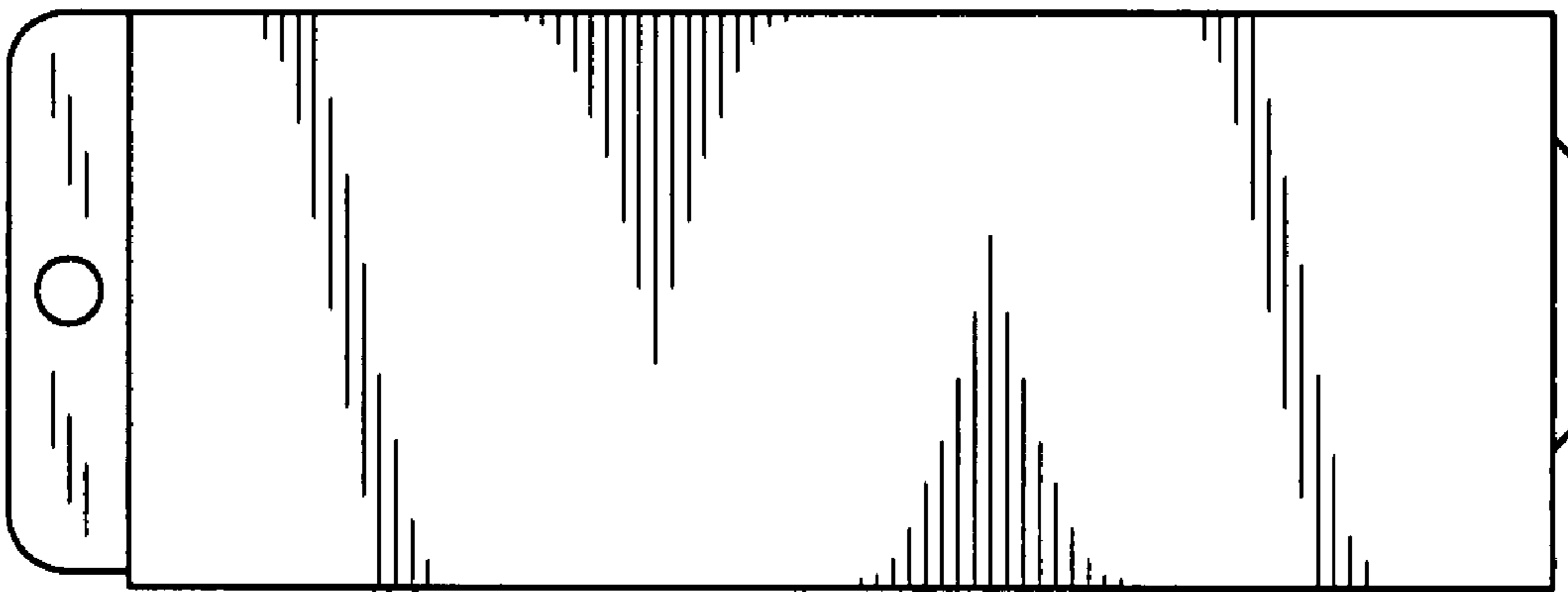




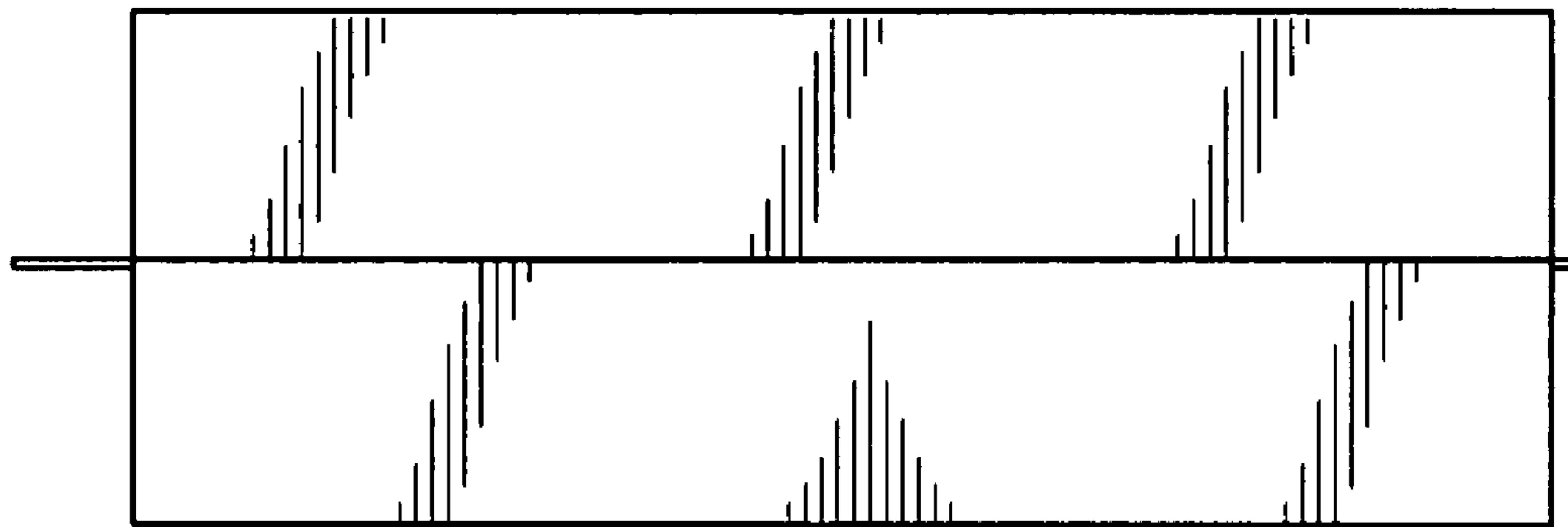

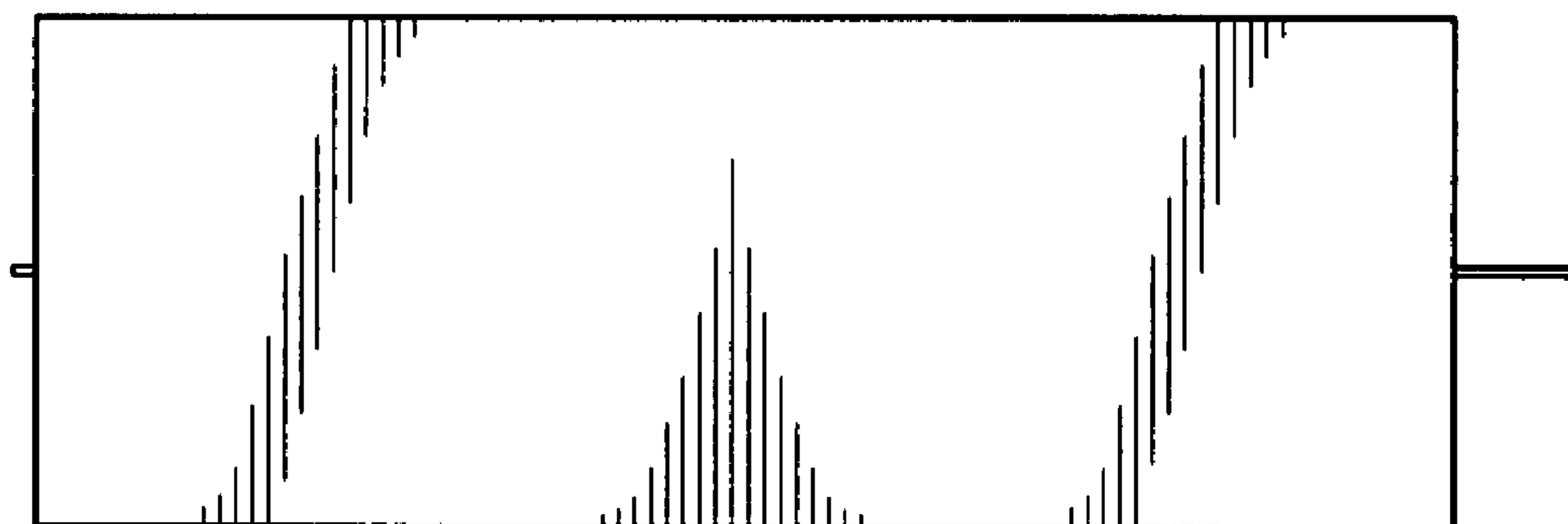

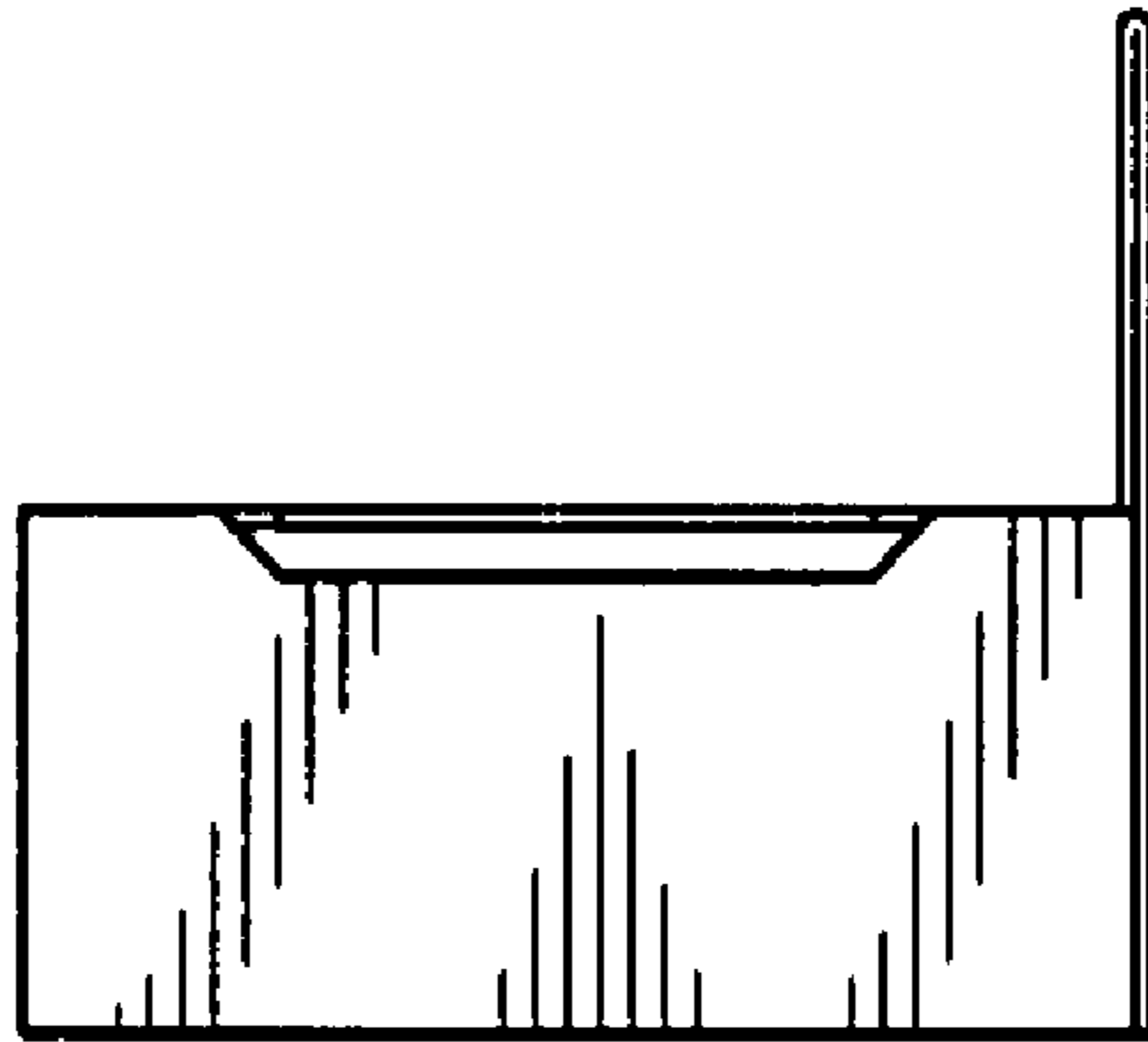

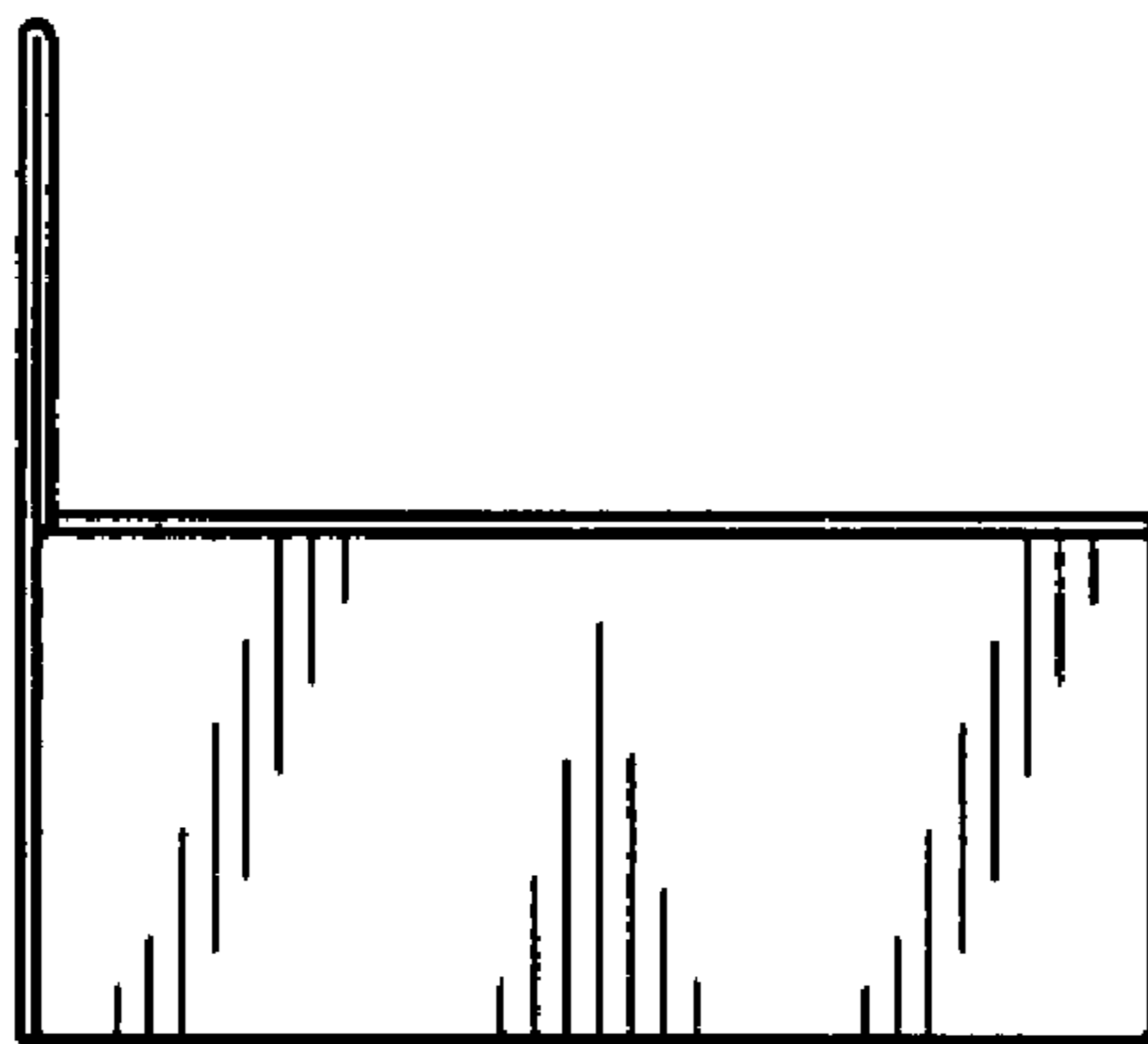
