The ornamental design for a packaging, as shown and described.

DESCRIPTION

FIG. 1: is a perspective view of the two components of our inventive design, bearing indicia;

FIG. 2: is a perspective view of a first component thereof;

FIG. 3: is a front view of the first component;

FIG. 4: is a front view of a second component thereof in an open configuration;

FIG. 5: is a front view of the second component in a closed configuration;

FIG. 6: is a front view of both components together;

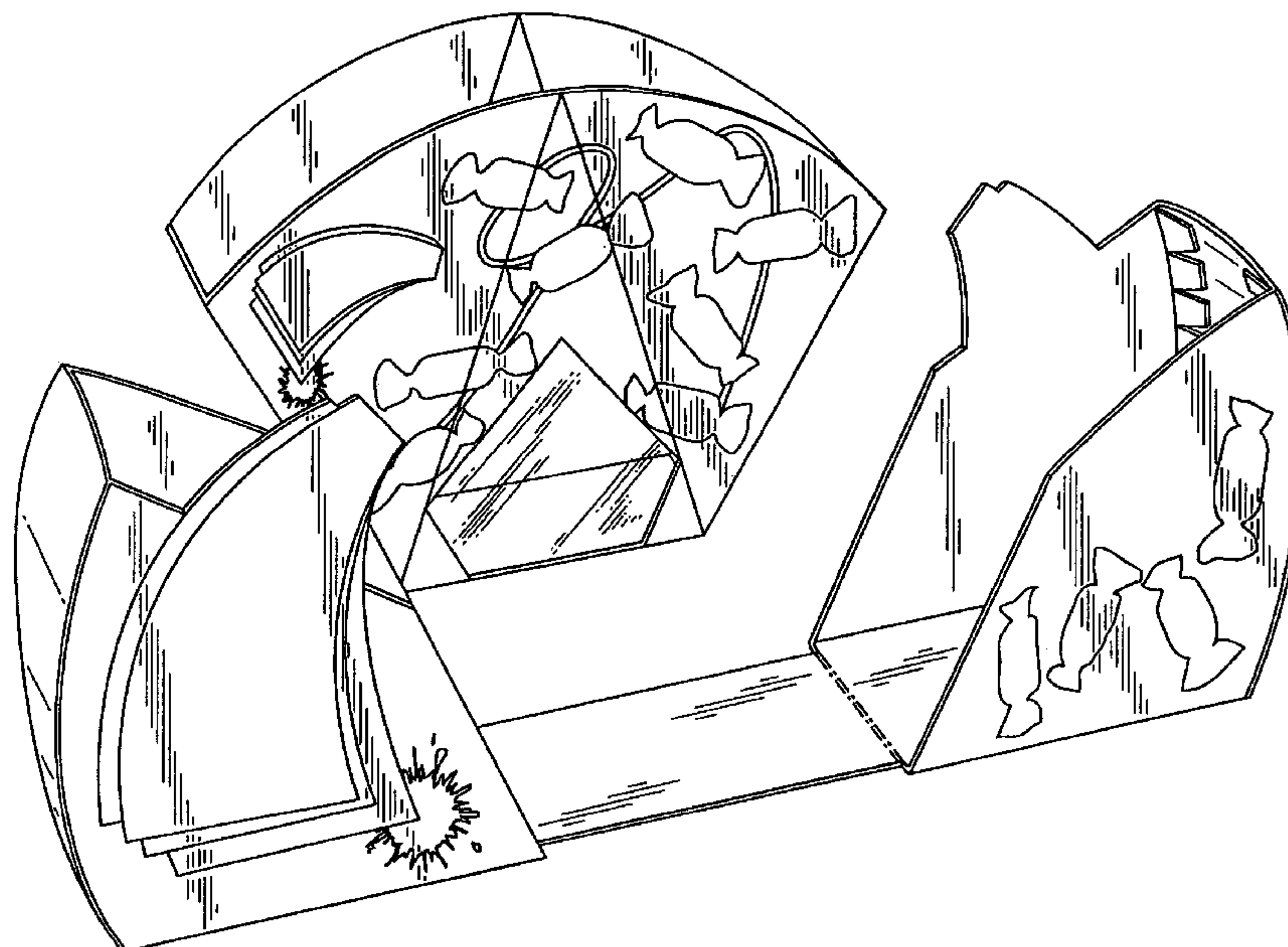
FIG. 7: is a left side view of the second component in the closed configuration, the right side view being identical;

FIG. 8: is a top view of the second component in the closed configuration; and,

FIG. 9: is a bottom view of the second component in the closed configuration.

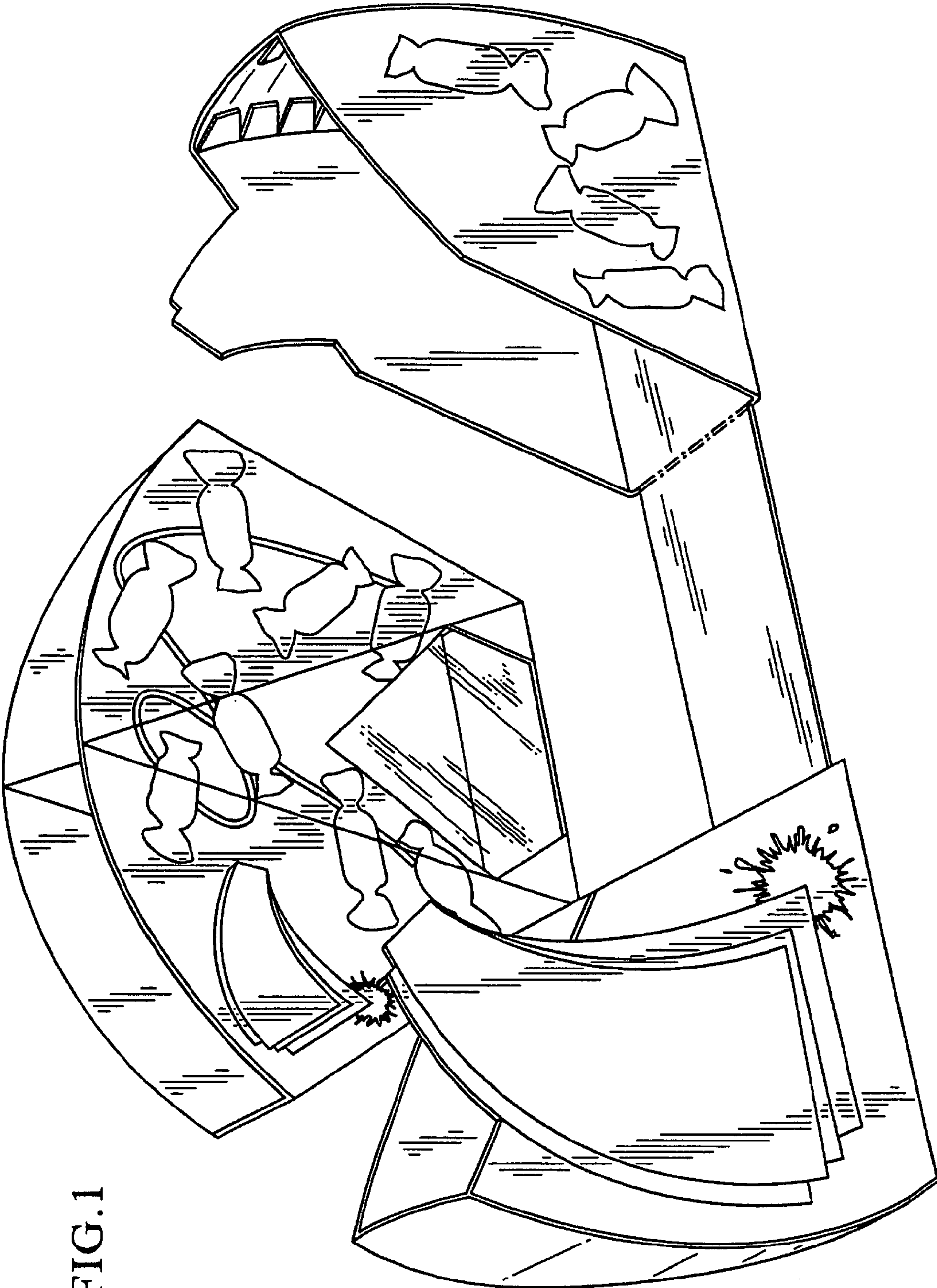

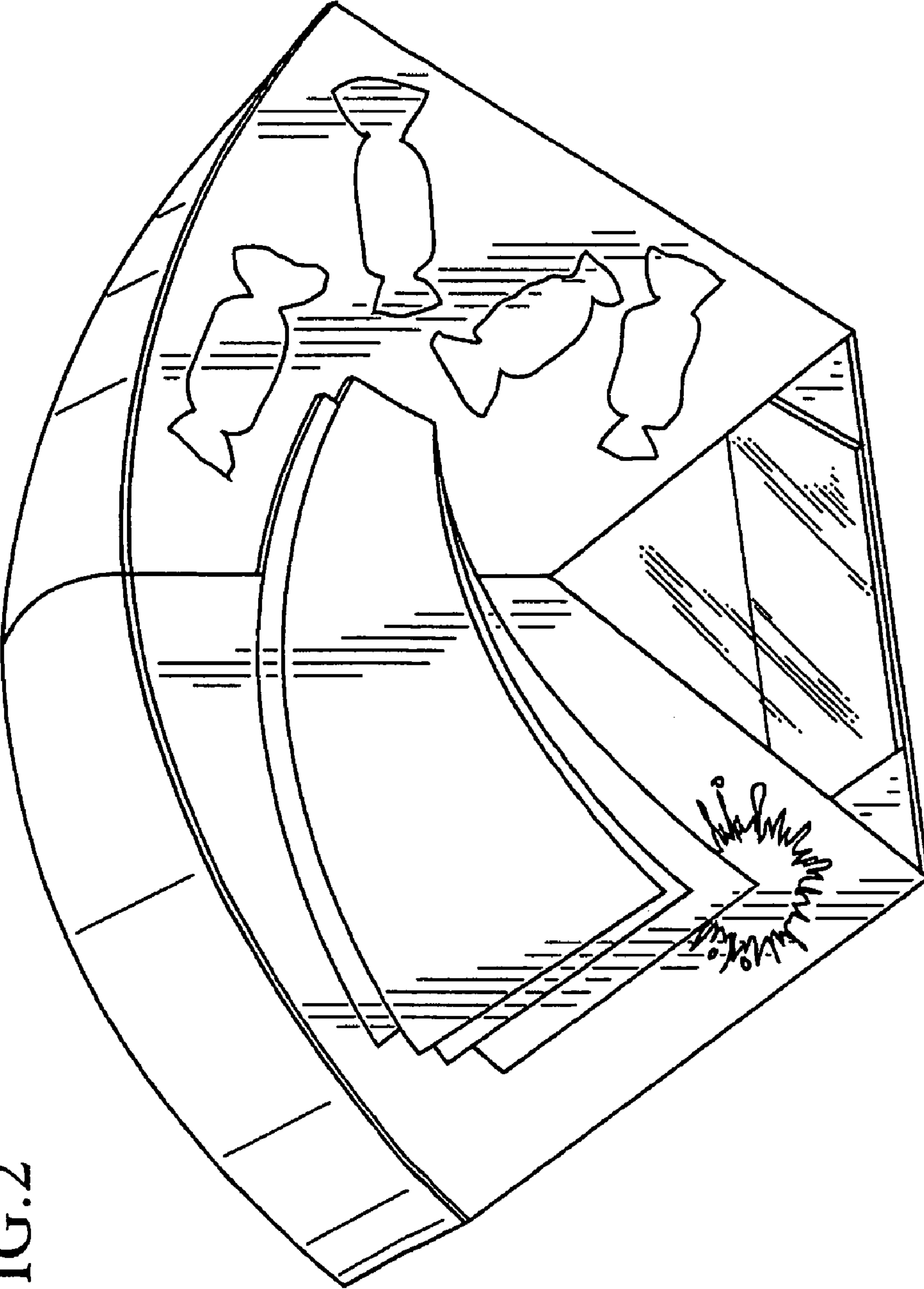
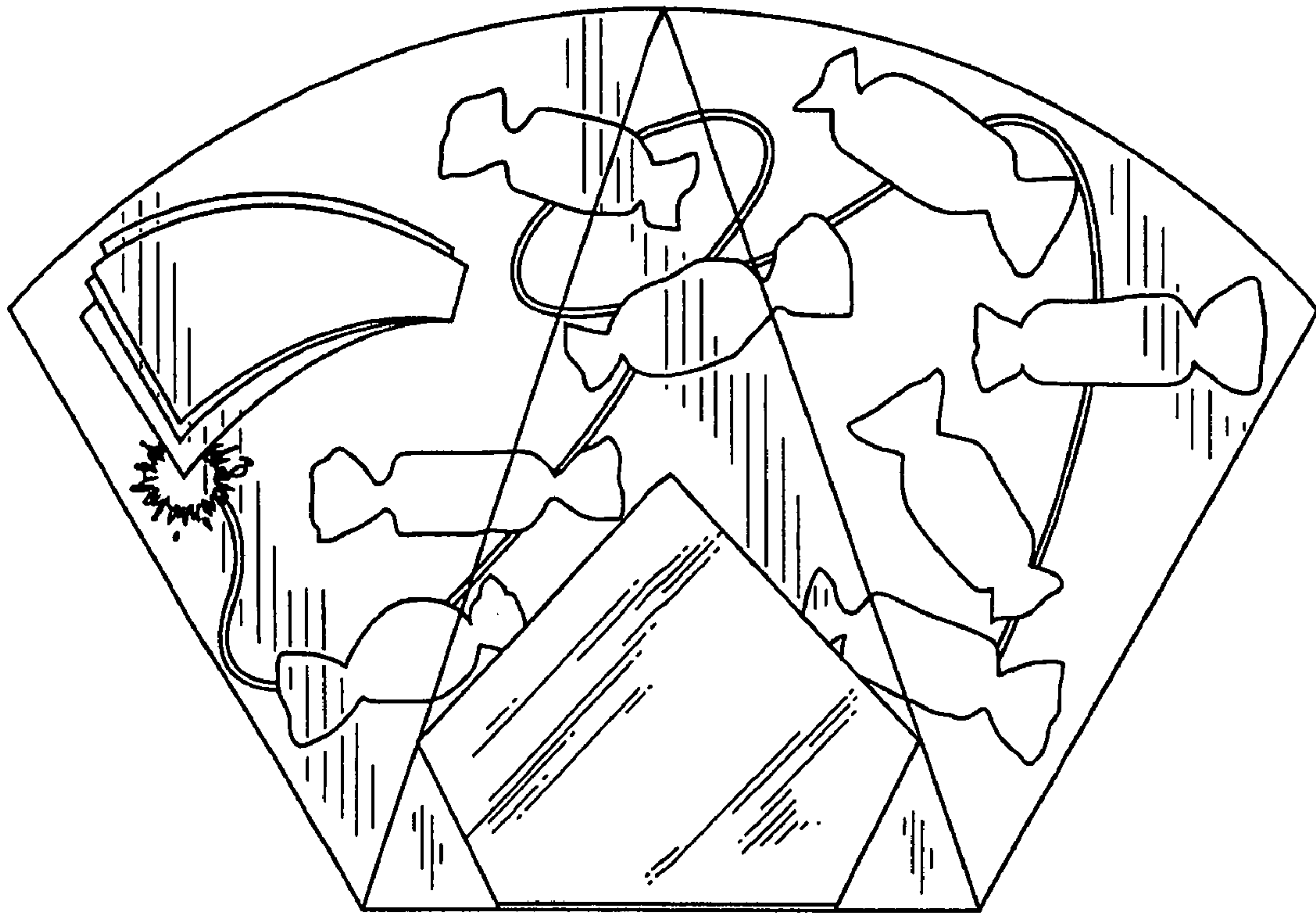

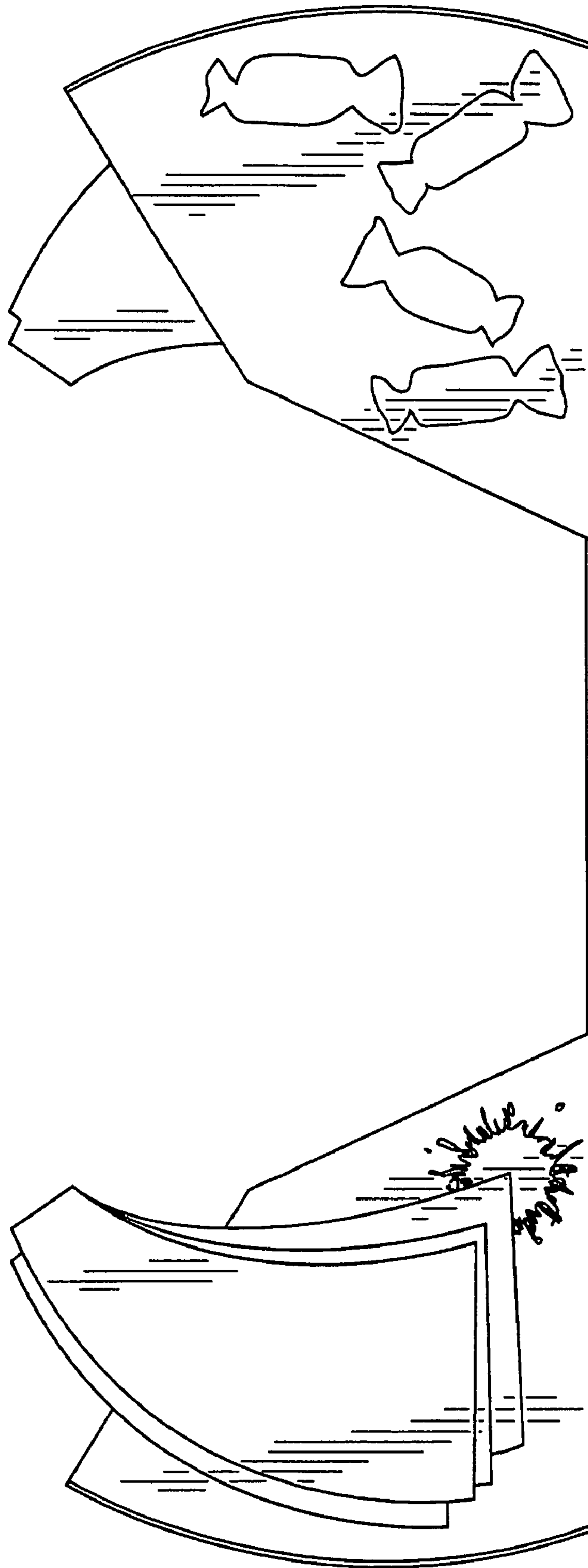
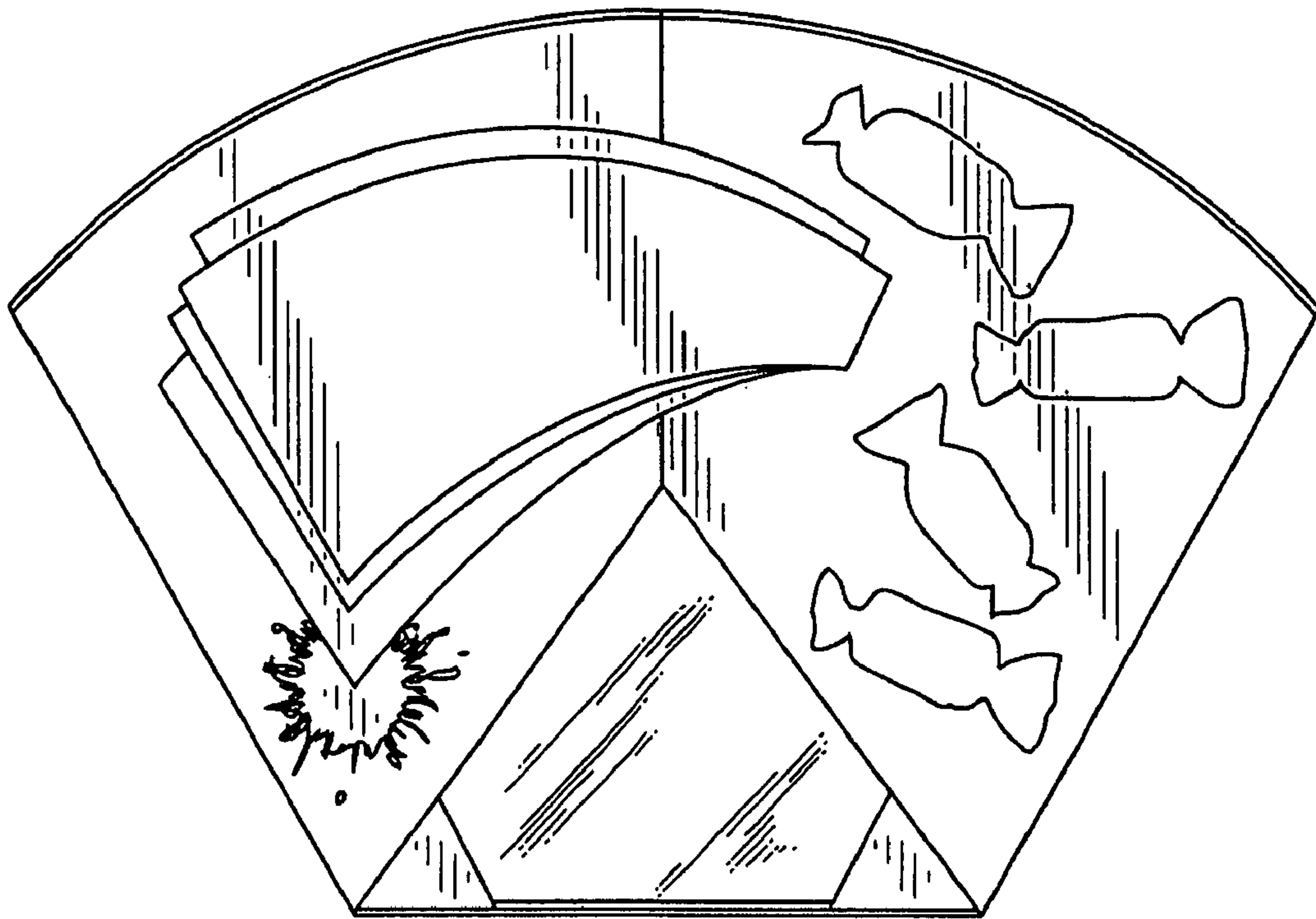

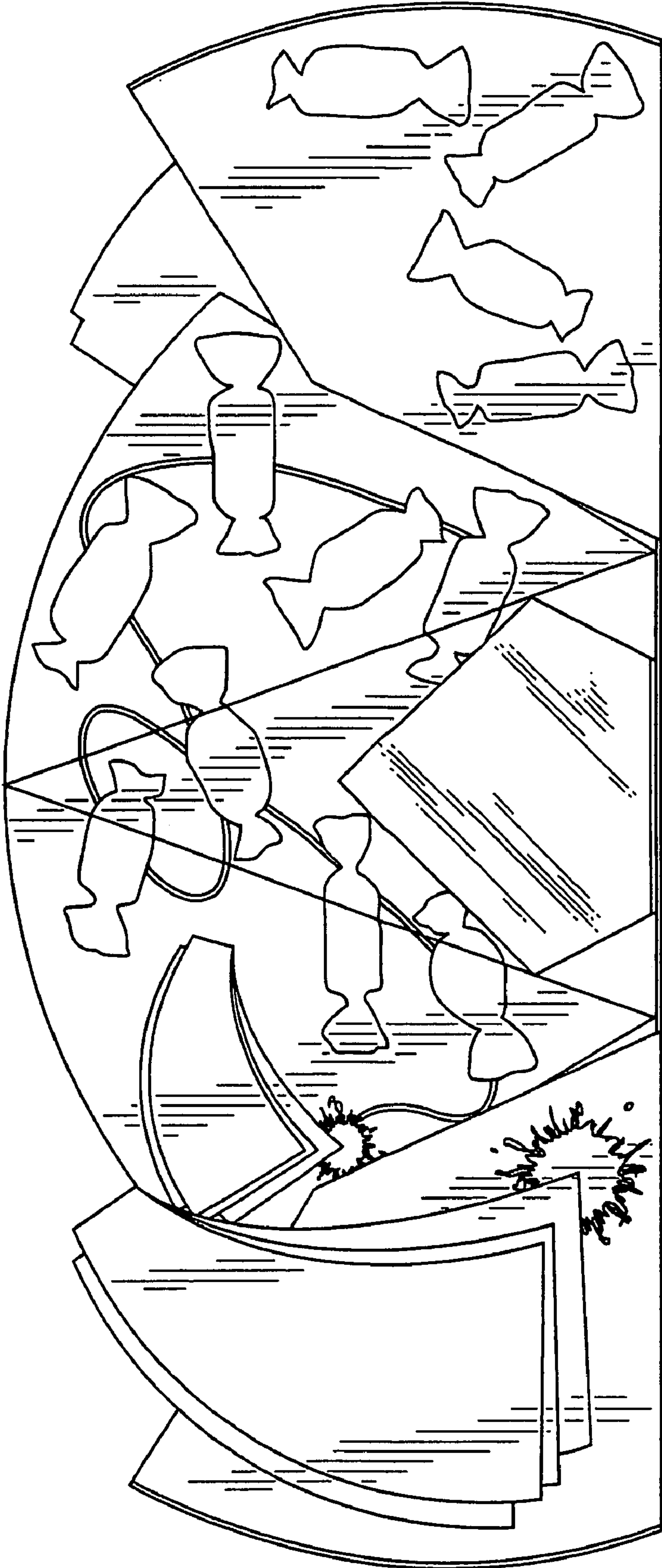

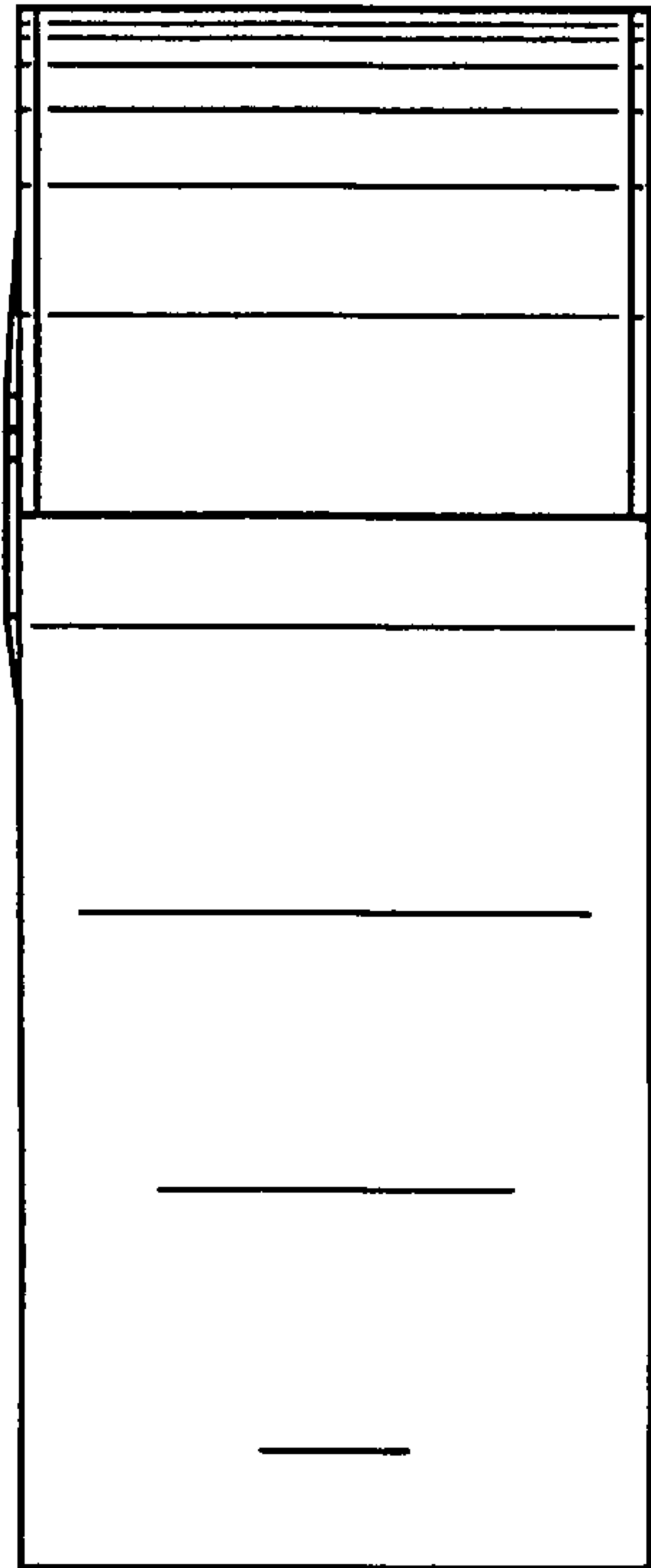

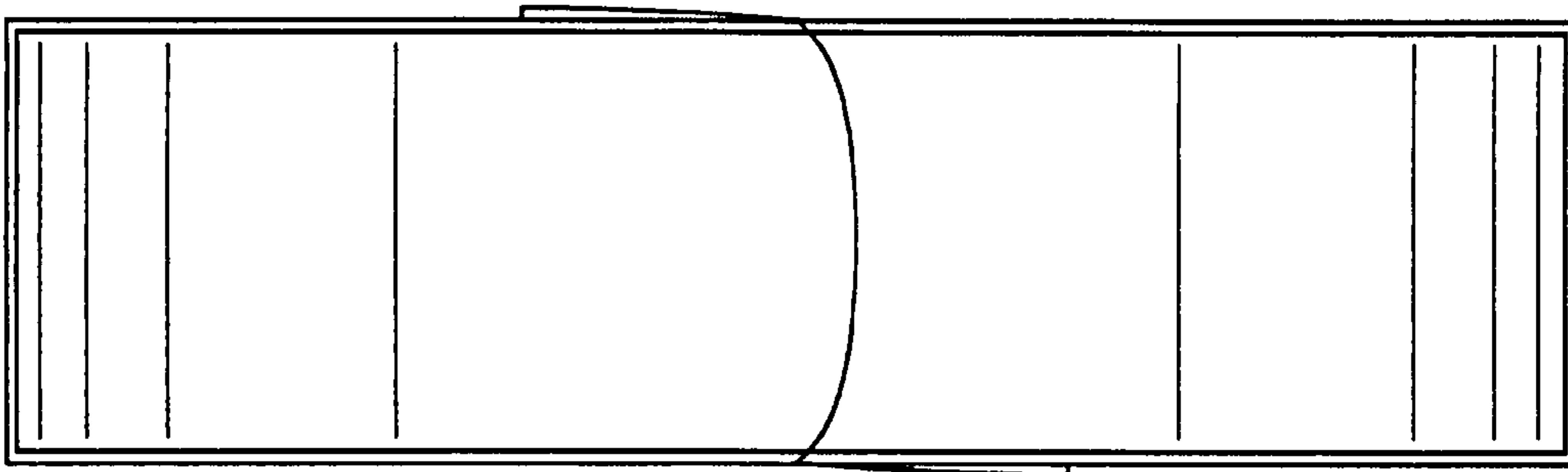
