DESCRIPTION

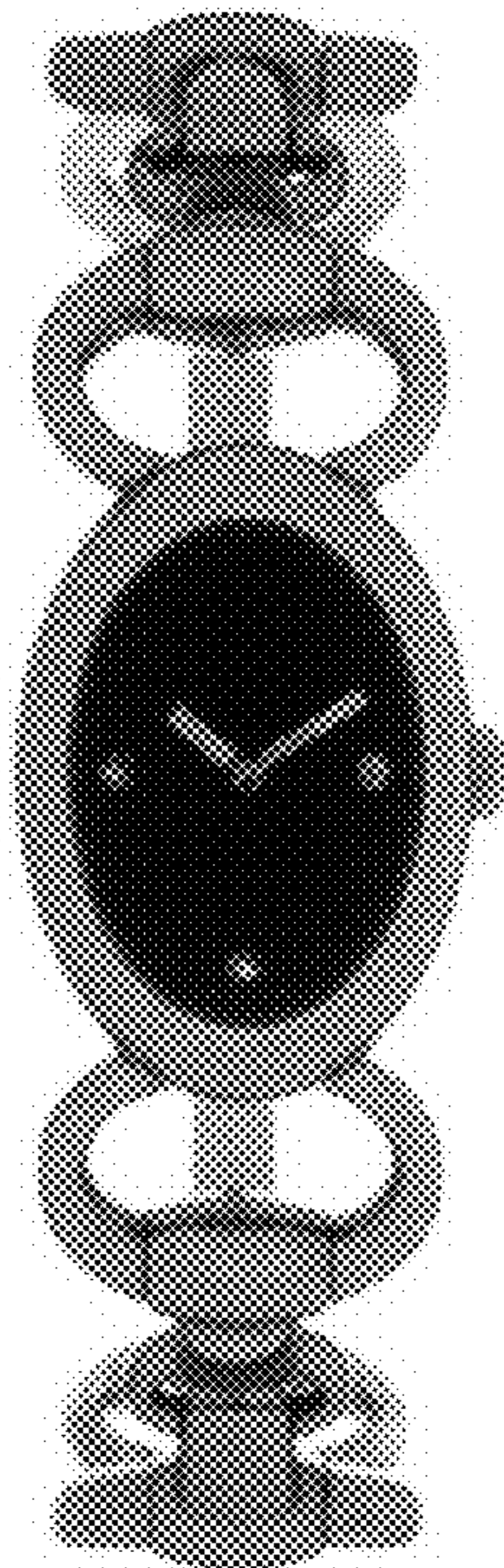

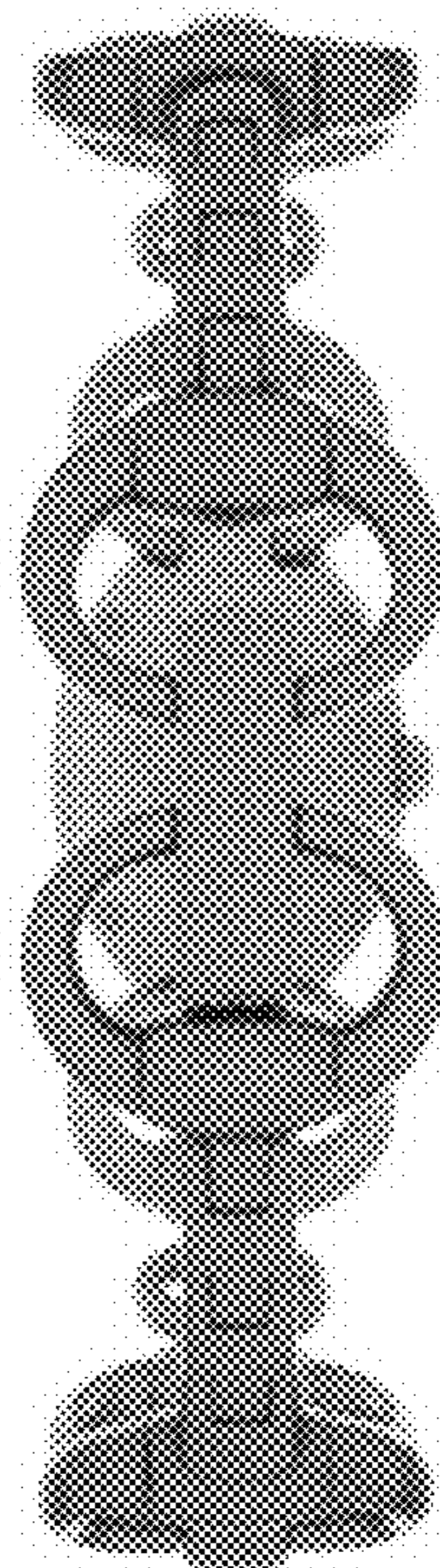

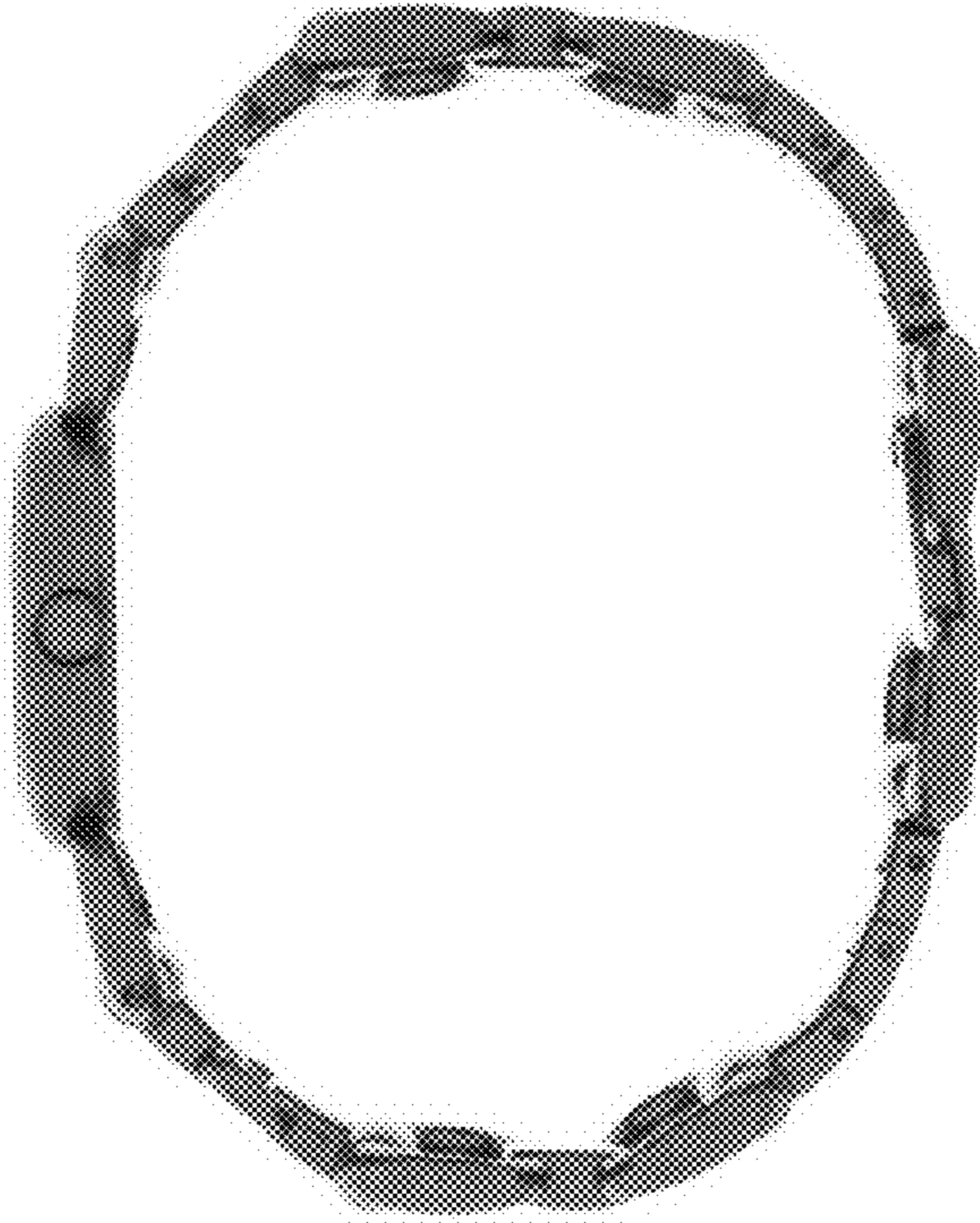

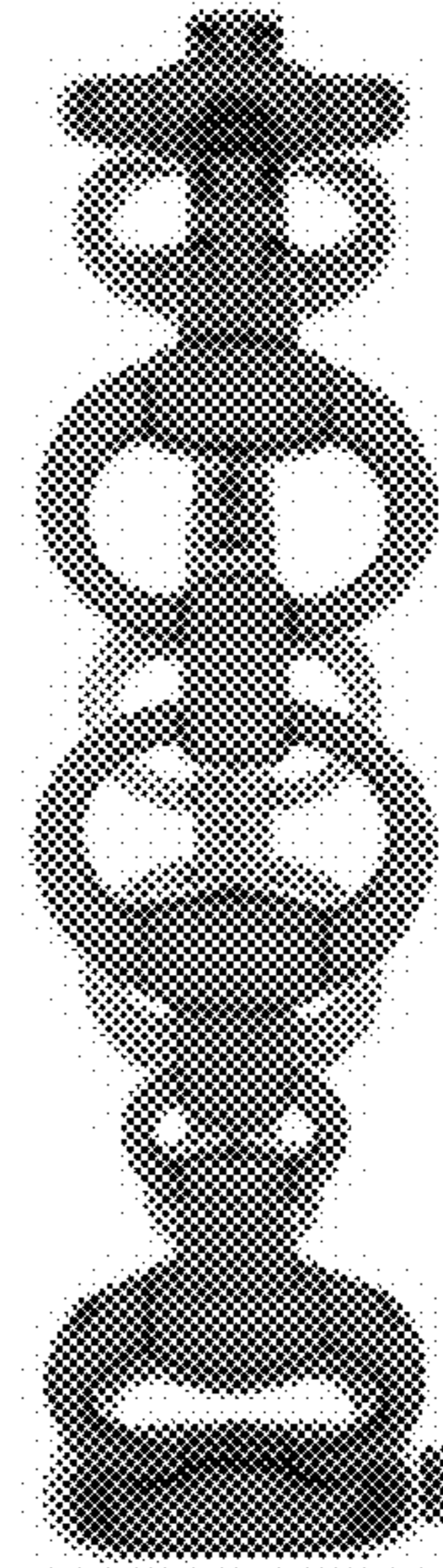

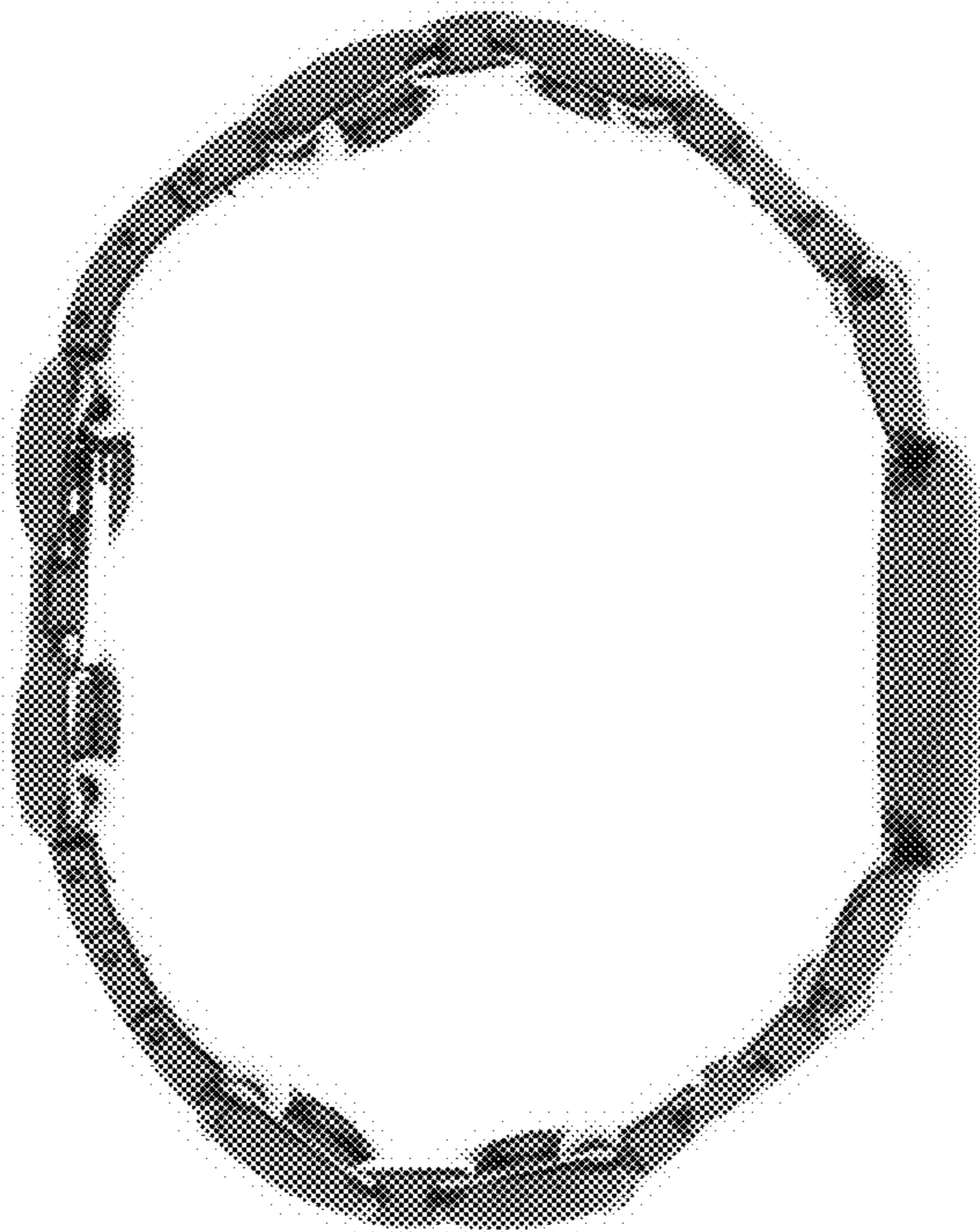
