(57) **CLAIM**

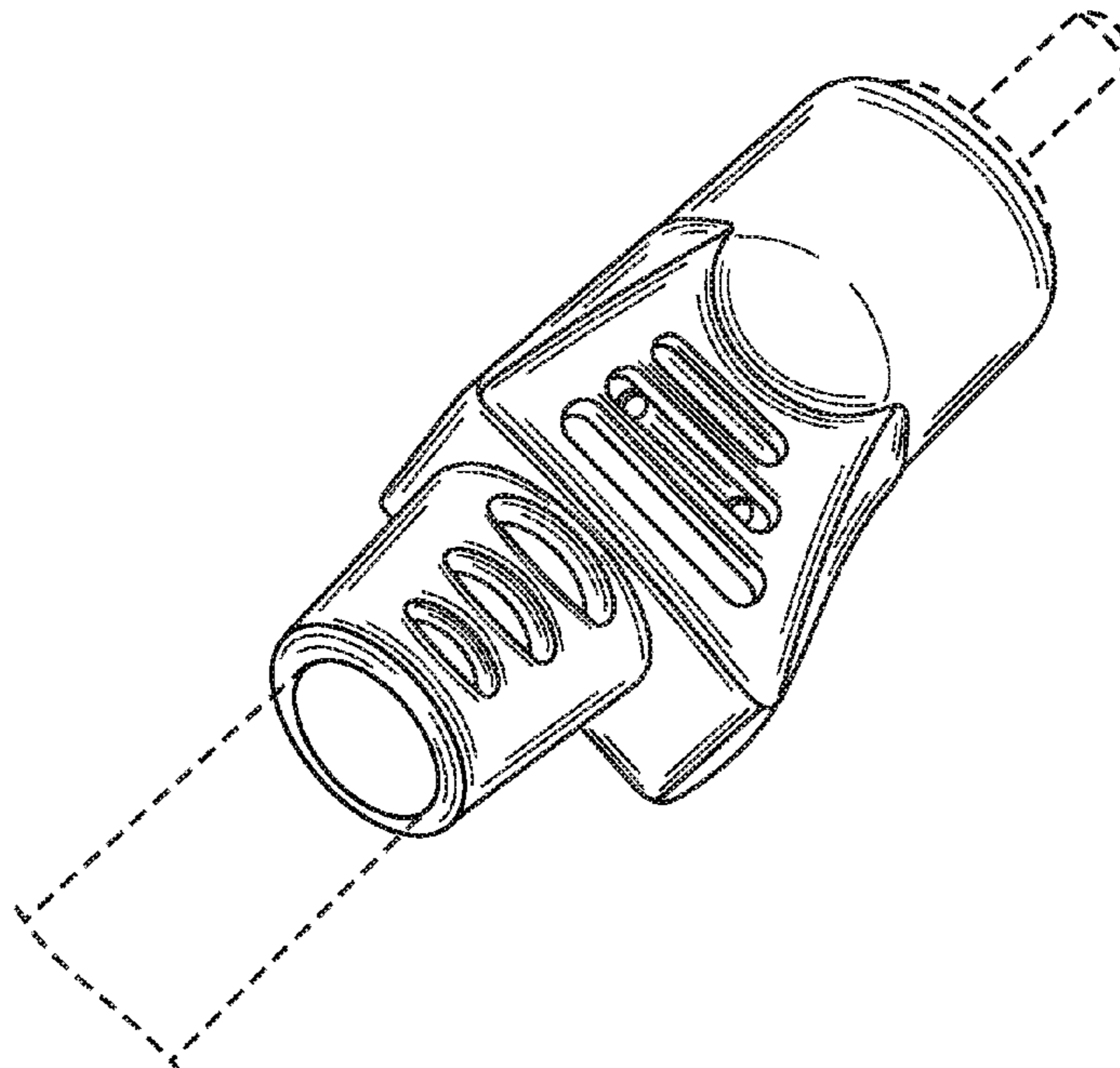
The ornamental design for a leveraged electronic plug, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a leveraged electronic plug, showing my new design;
 FIG. 2 is a top perspective view of the leveraged electronic plug shown in FIG. 1;
 FIG. 3 is a front perspective view of the leveraged electronic plug shown in FIG. 1;
 FIG. 4 is a top view of the leveraged electronic plug shown in FIG. 1; a bottom view of the leveraged electronic plug shown in FIG. 1 is a mirror image of the top view shown;
 FIG. 5 is a right side view of the leveraged electronic plug shown in FIG. 1;
 FIG. 6 is a left side view of the leveraged electronic plug shown in FIG. 1;
 FIG. 7 is a front view of the leveraged electronic plug shown in FIG. 1; and,
 FIG. 8 is a rear view of the leveraged electronic plug shown in FIG. 1.

The broken lines showing a pin and a head next to the pin in FIGS. 1 through 7 and a cable line in FIGS. 1 through 6 and 8 are for illustrative purposes only and form no part of the claimed design.

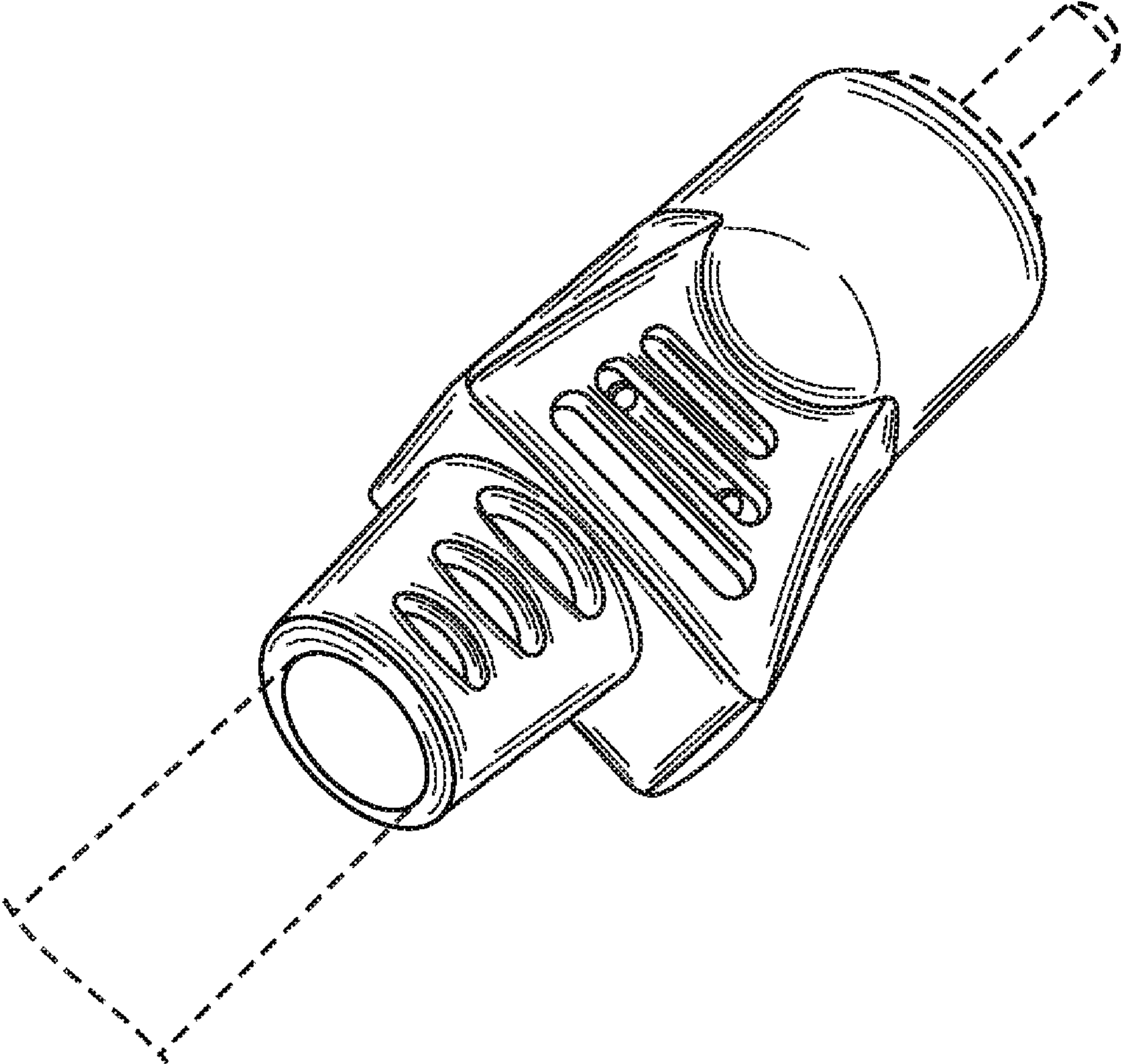

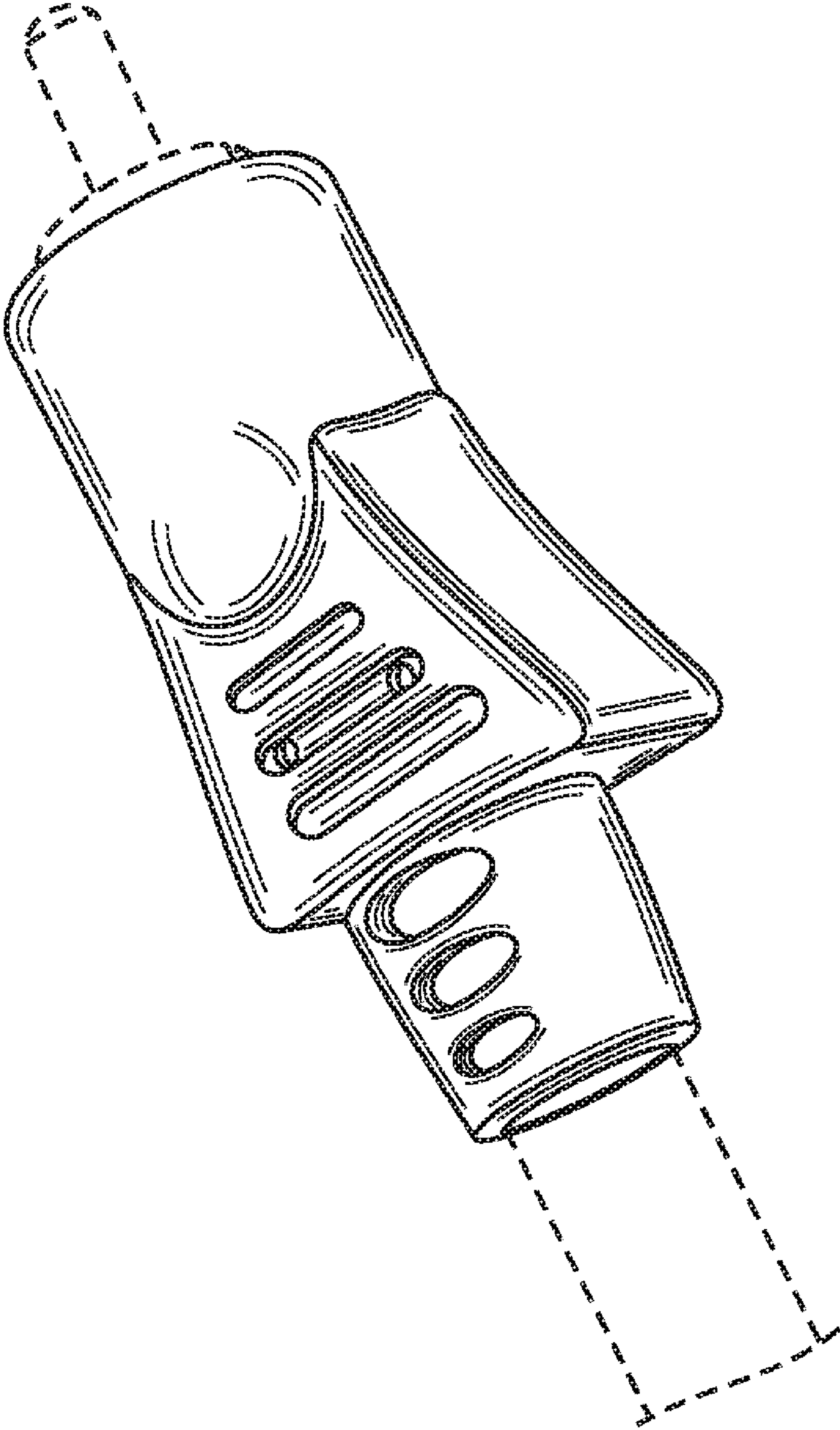

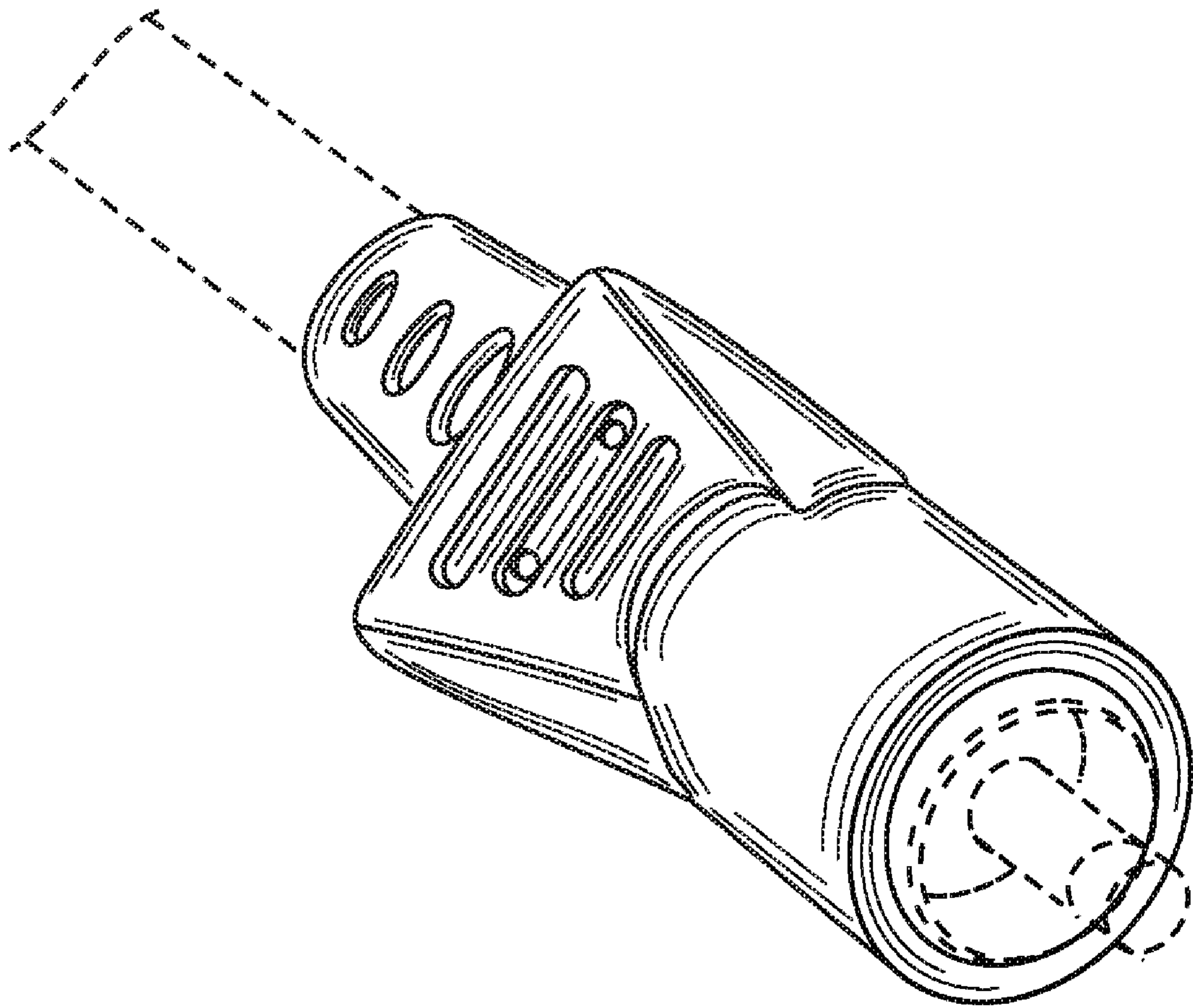

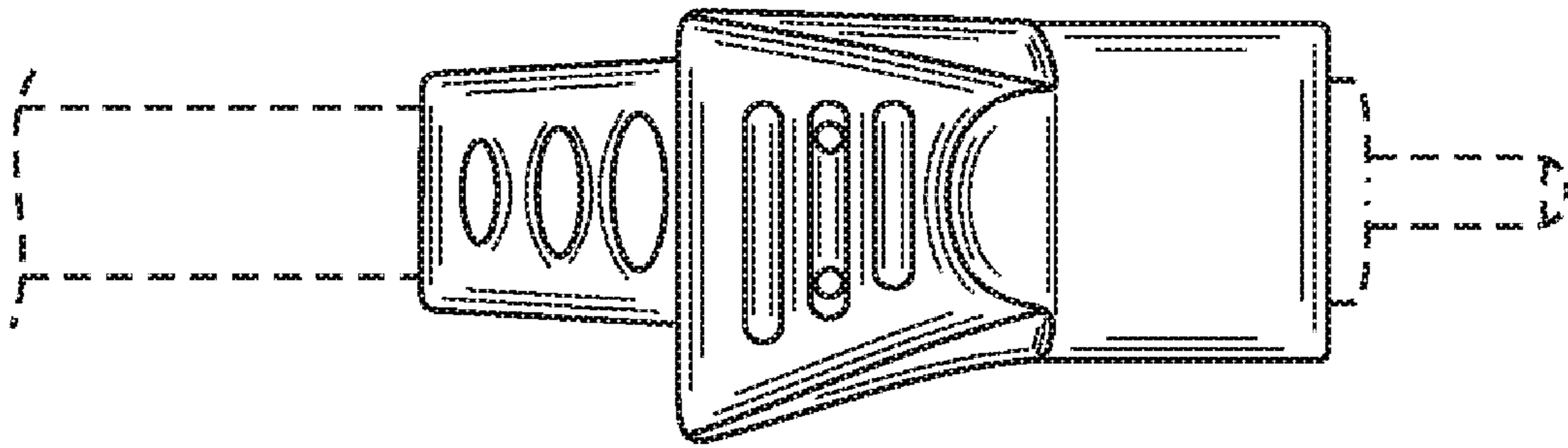

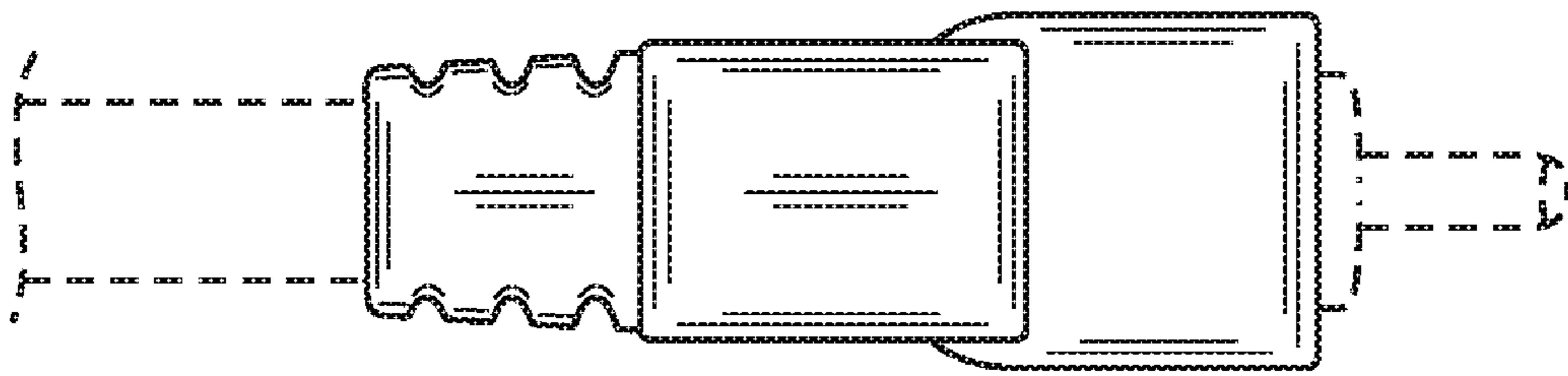

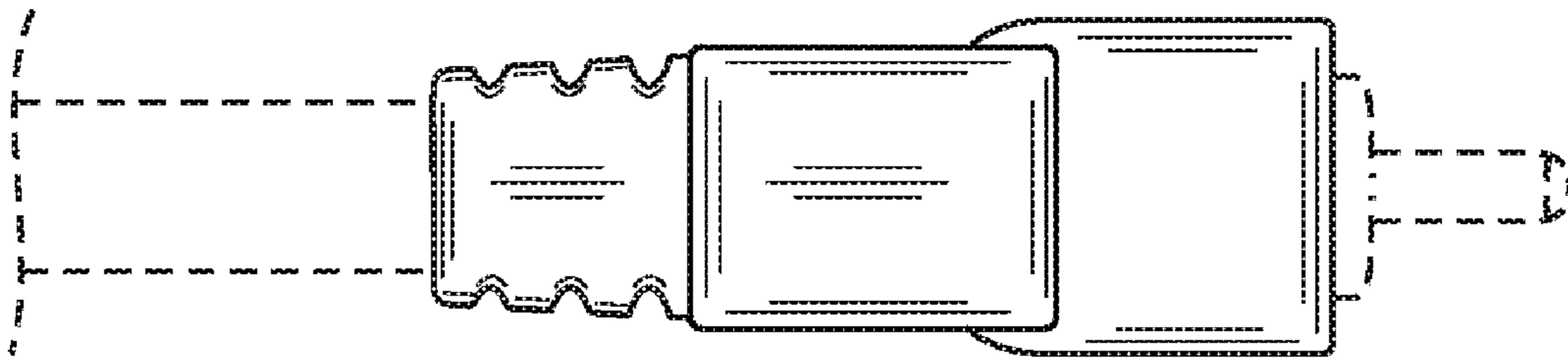

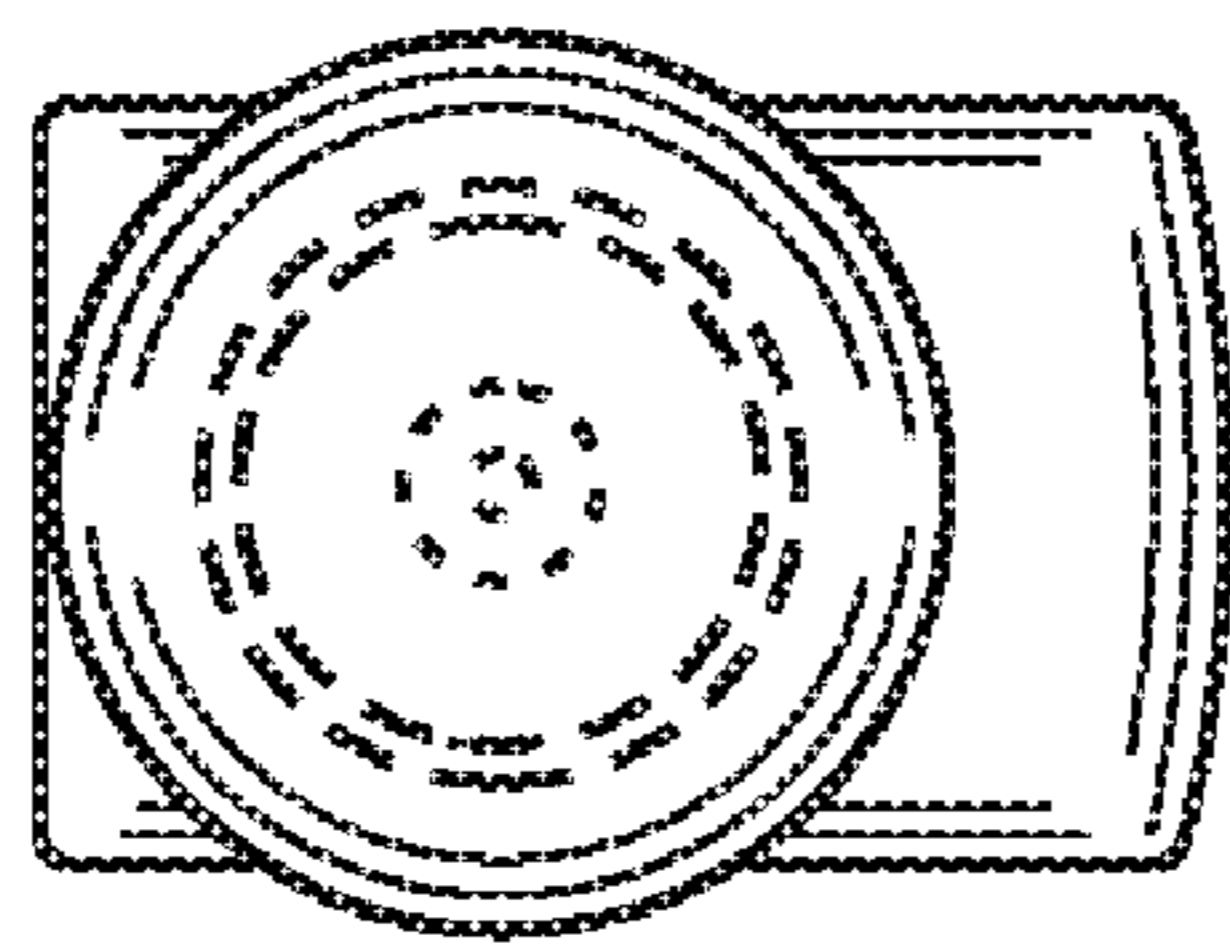

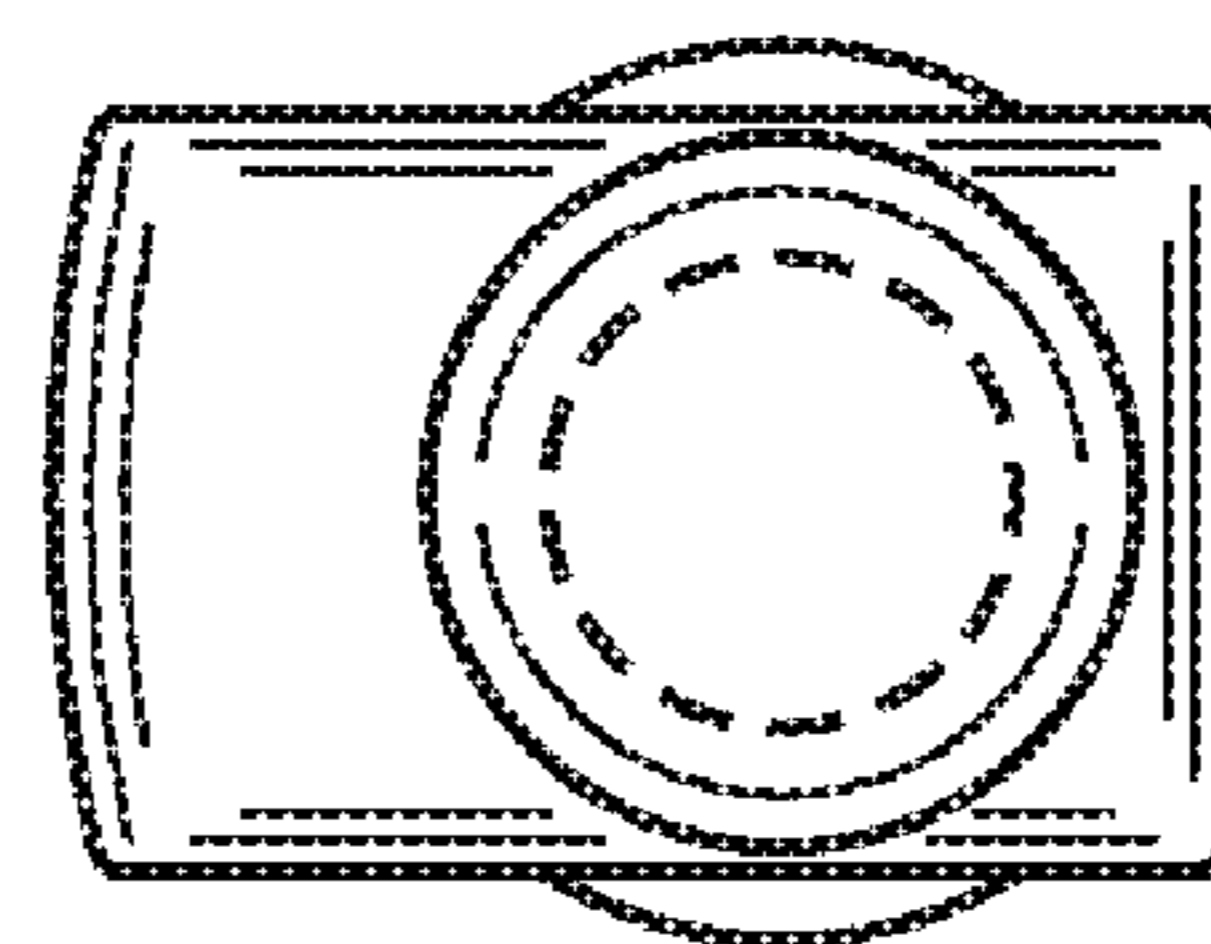
