FIG. 4 is a right side view thereof, the left side being a mirror image thereto;

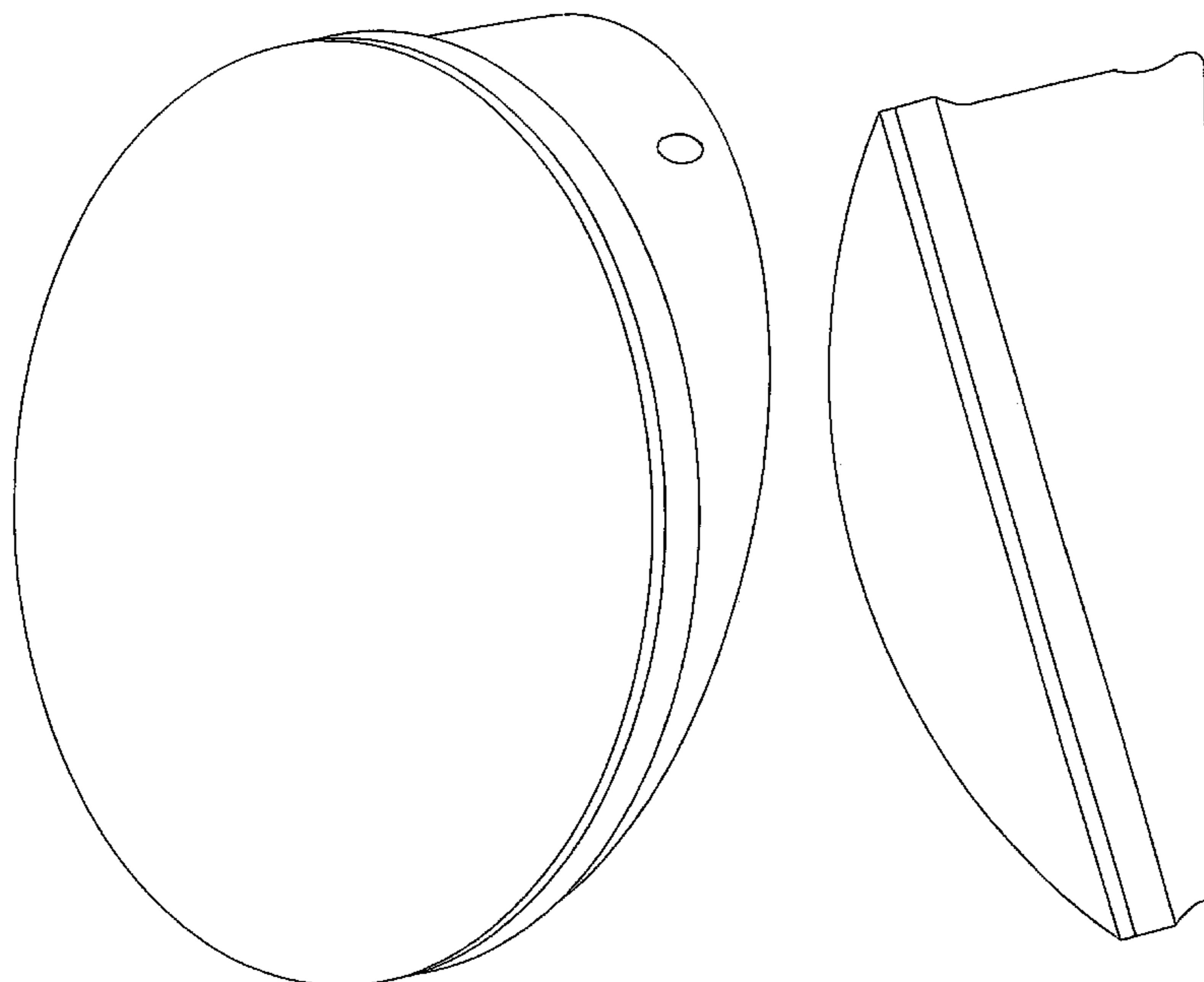
FIG. 5 is a rear view thereof;

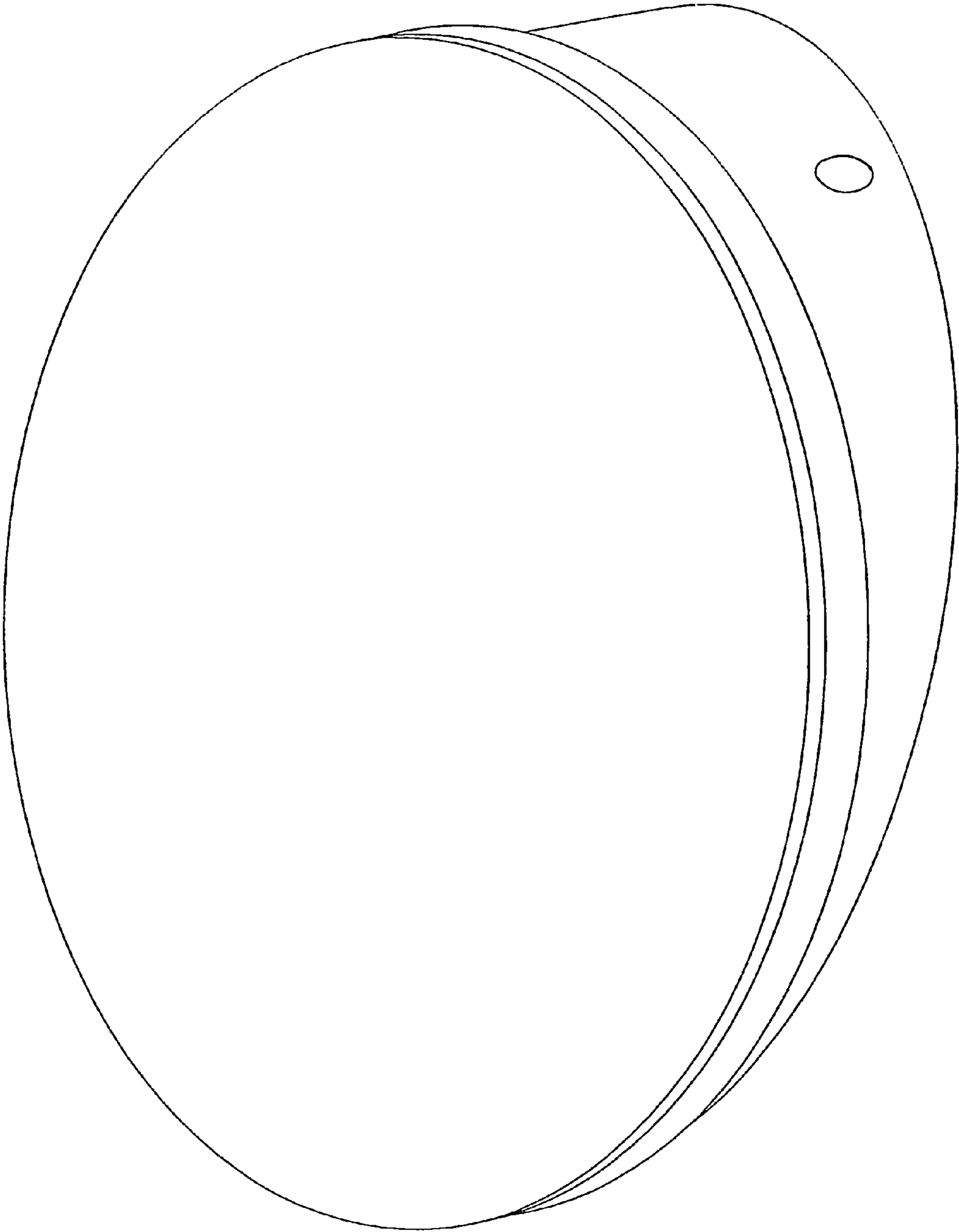

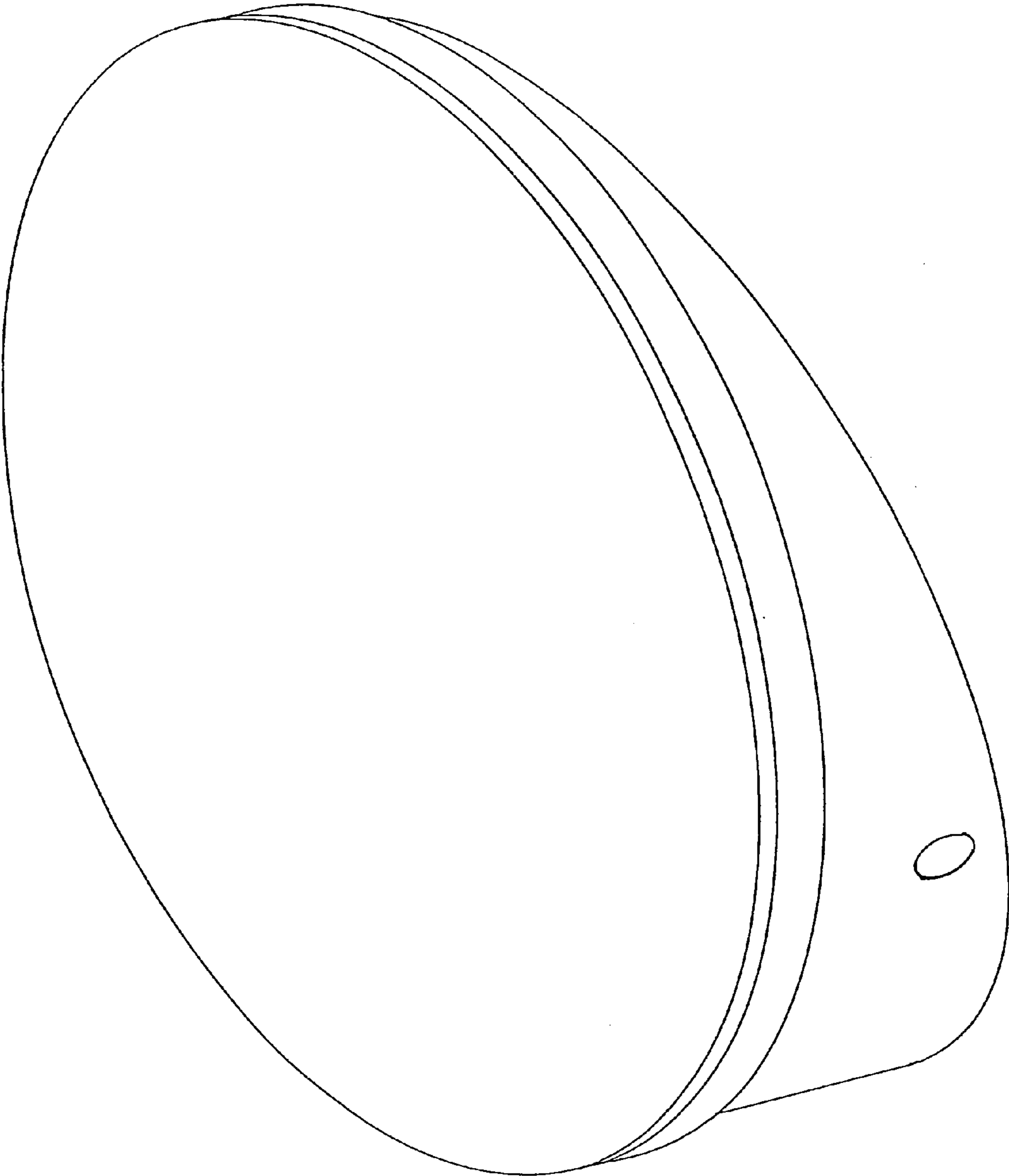

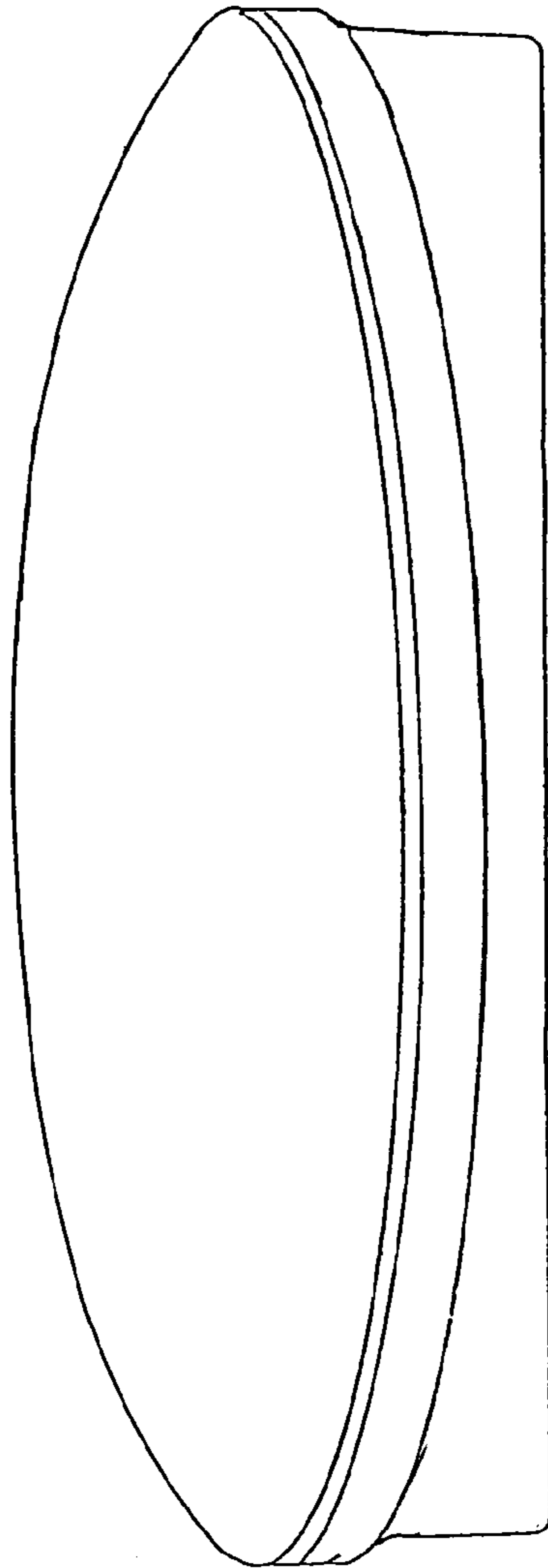

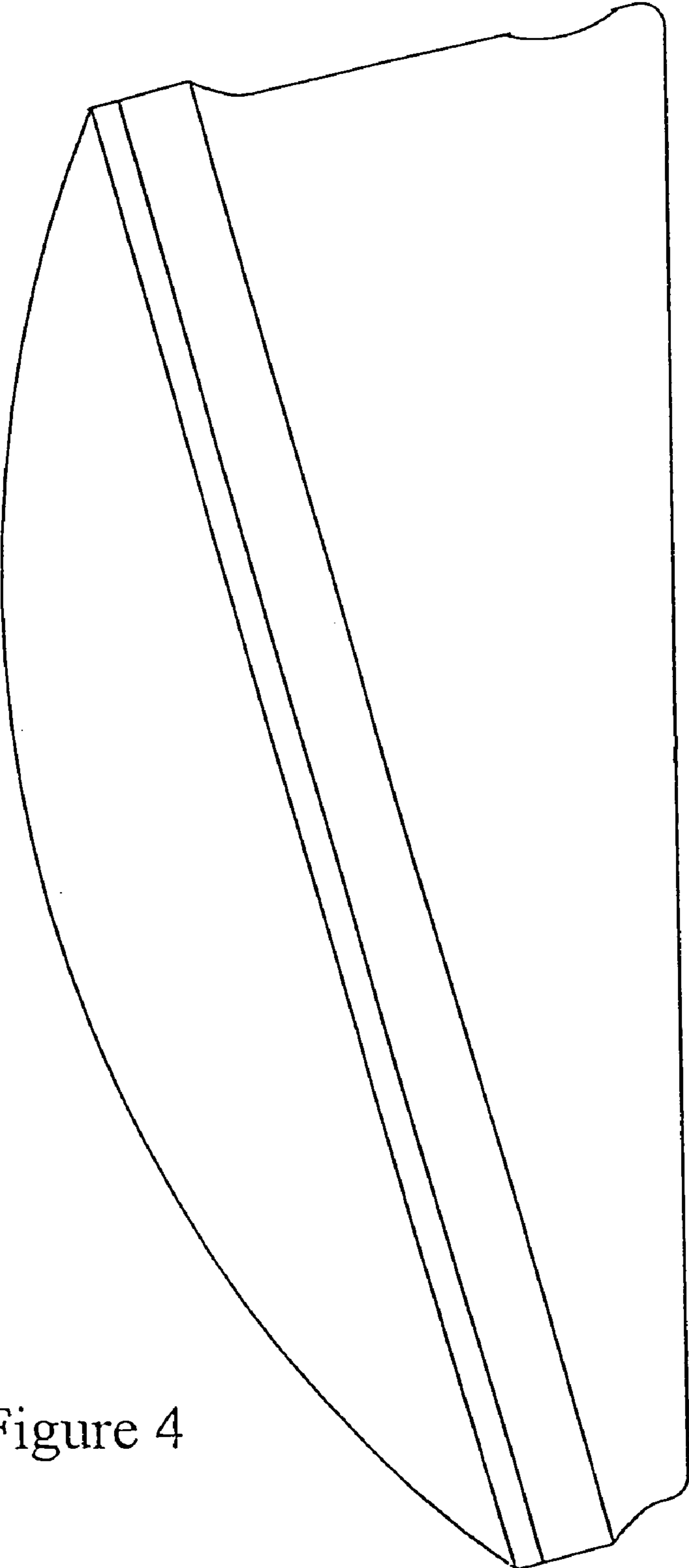

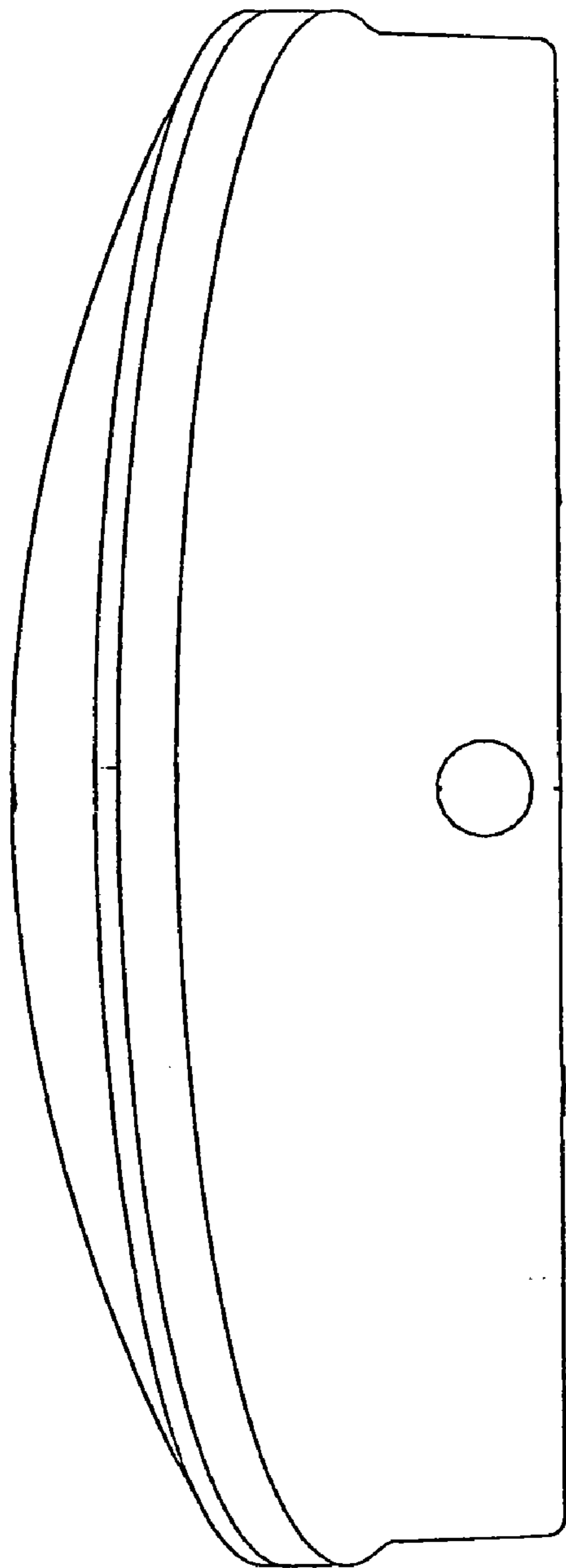

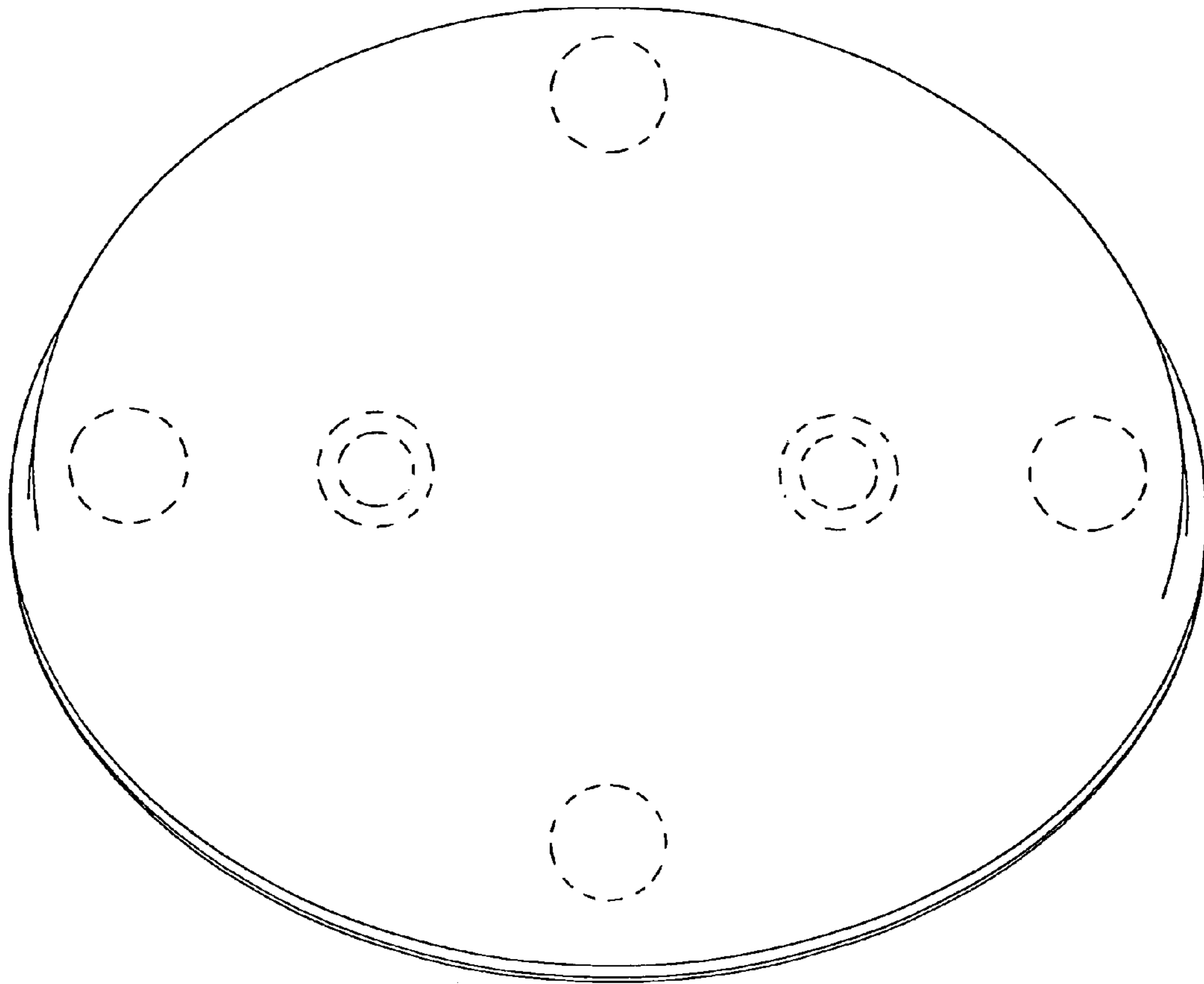

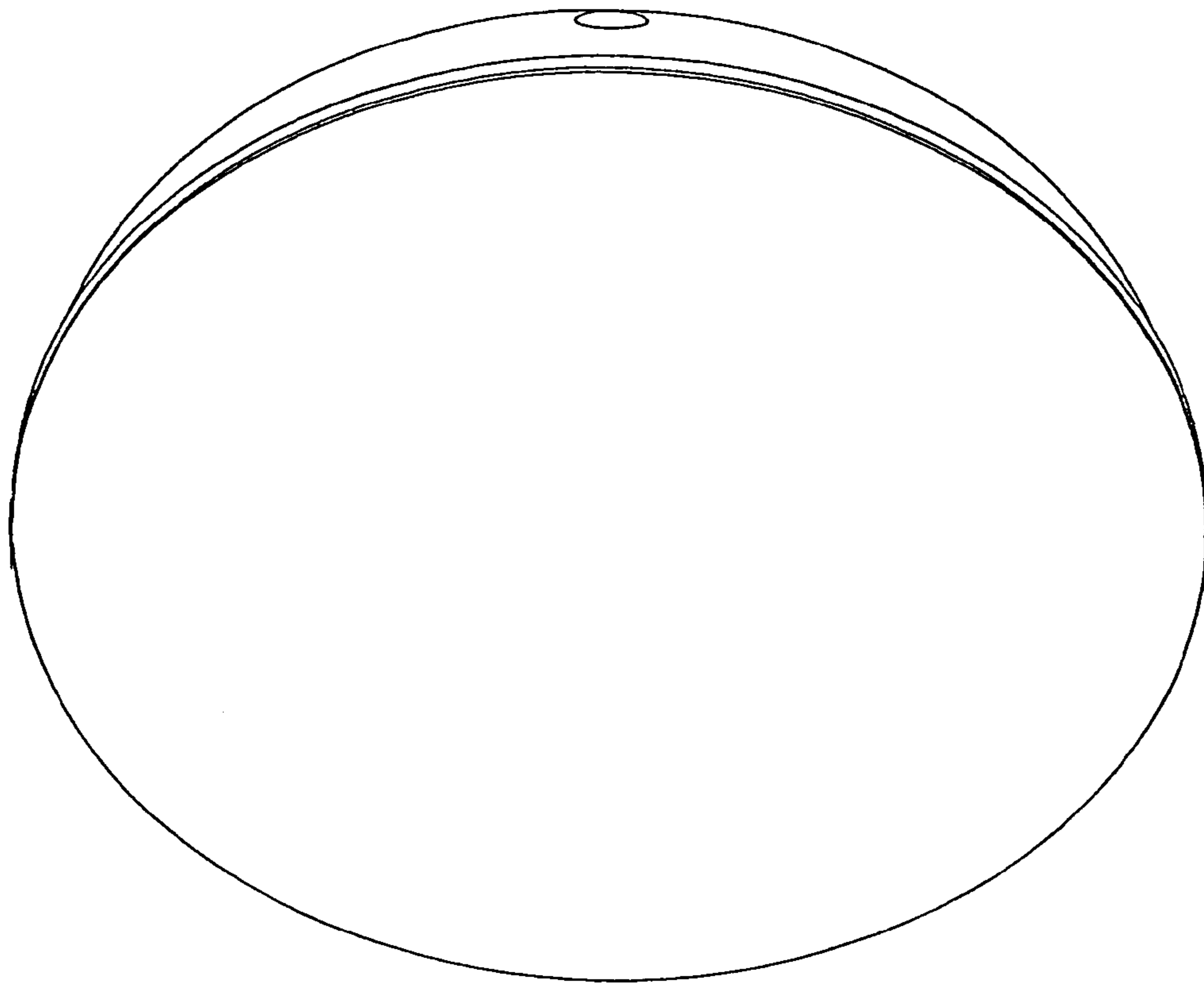
