1;

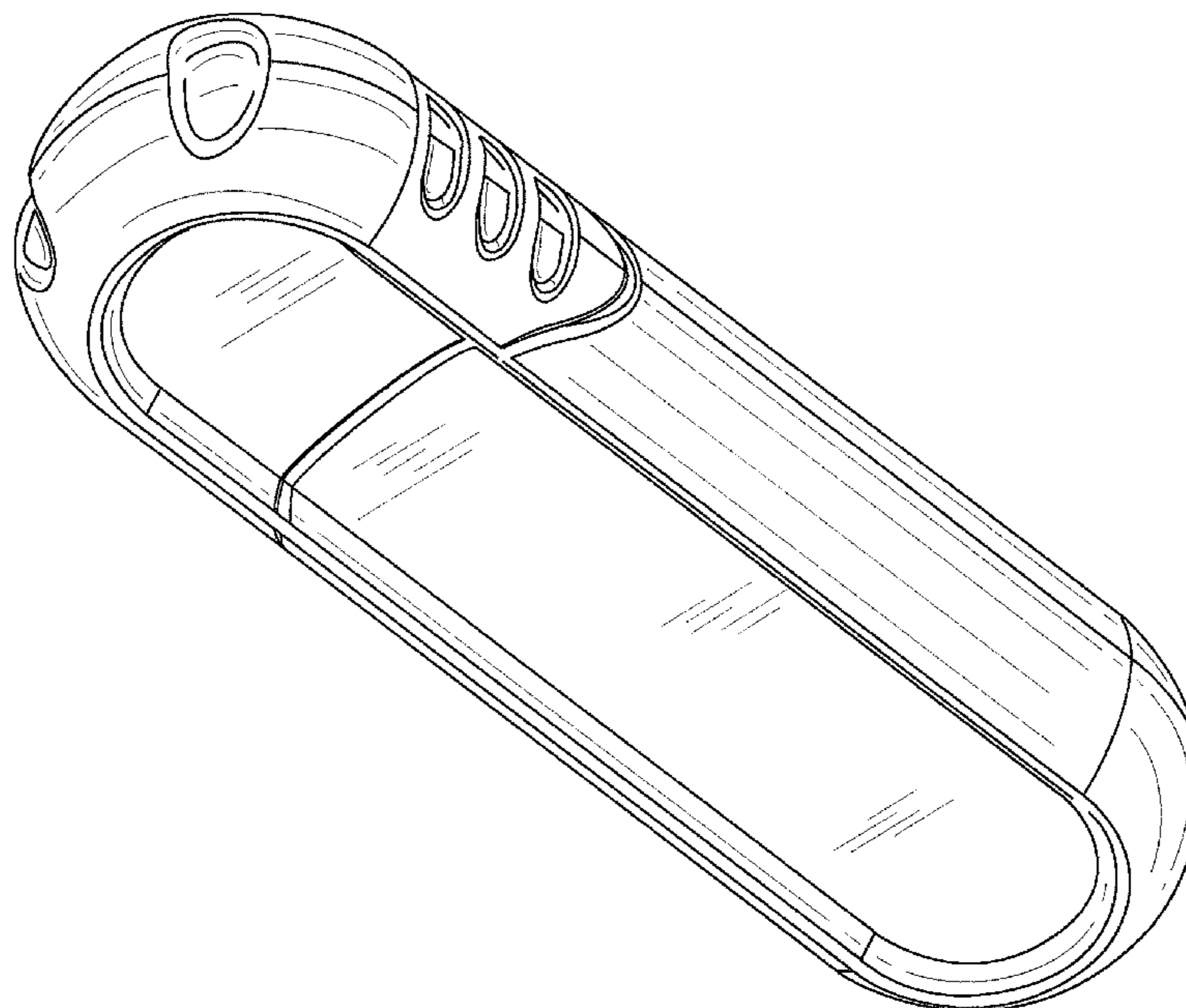
FIG. 5 is a left side elevation view of the storage device of

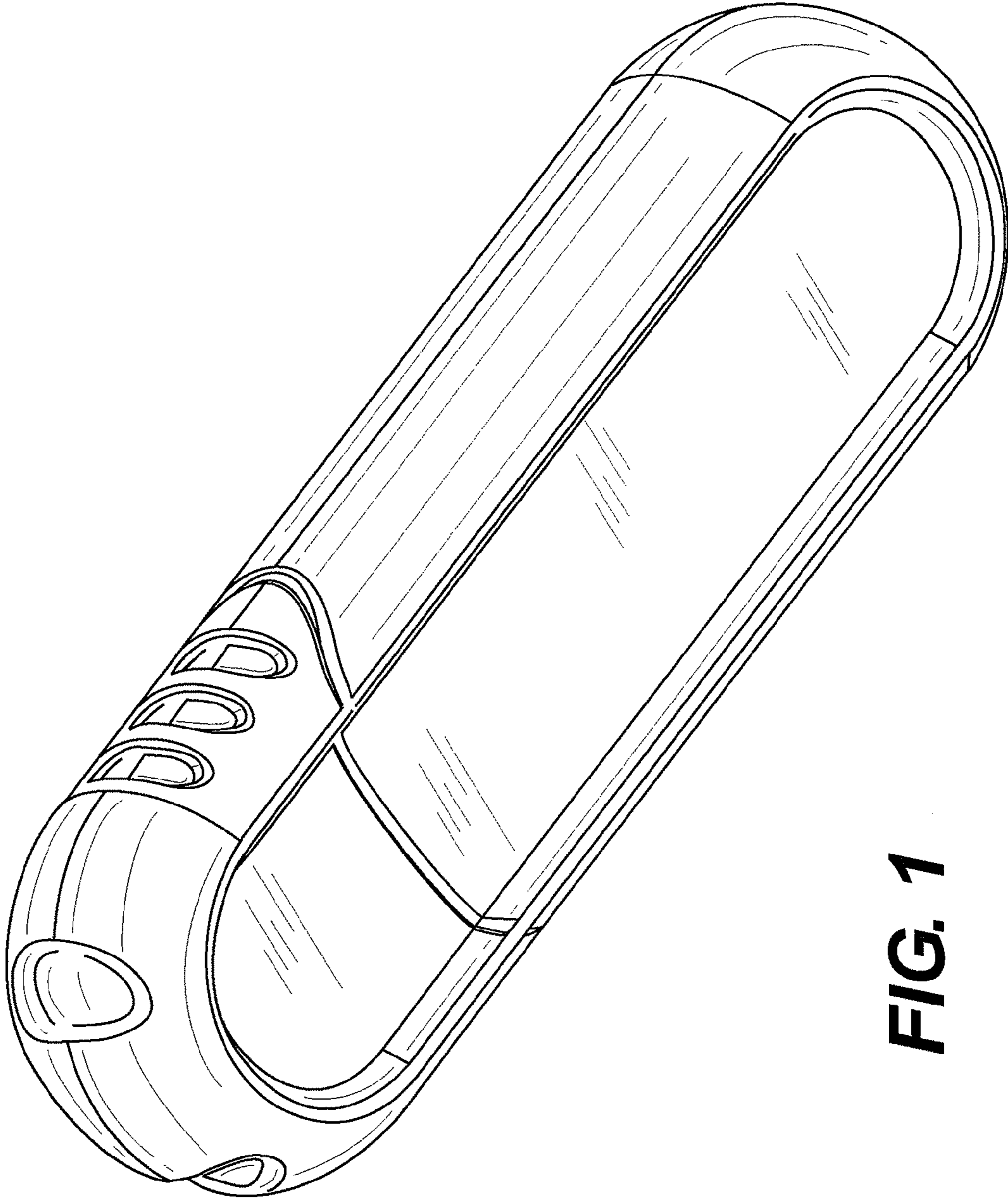

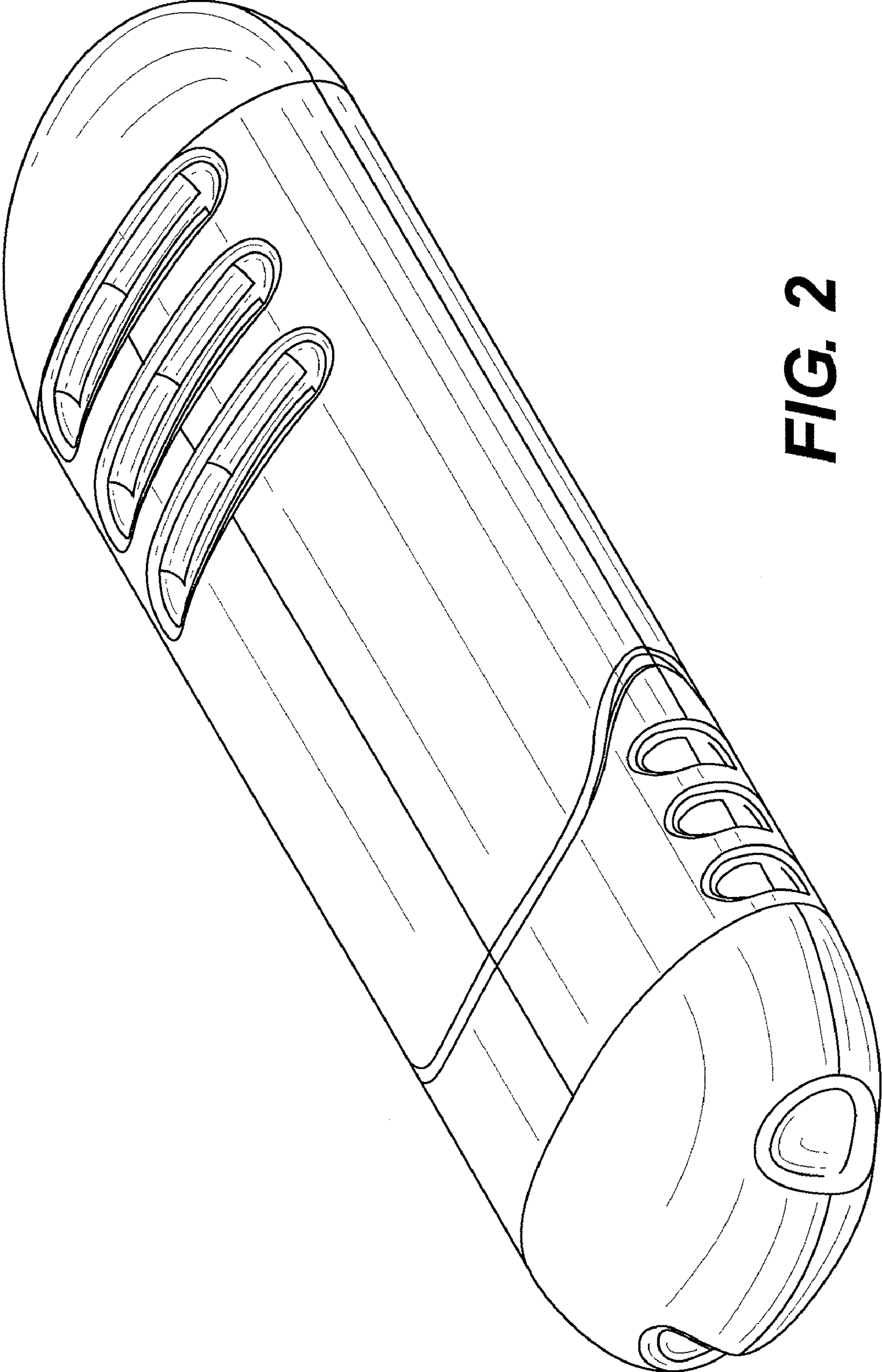

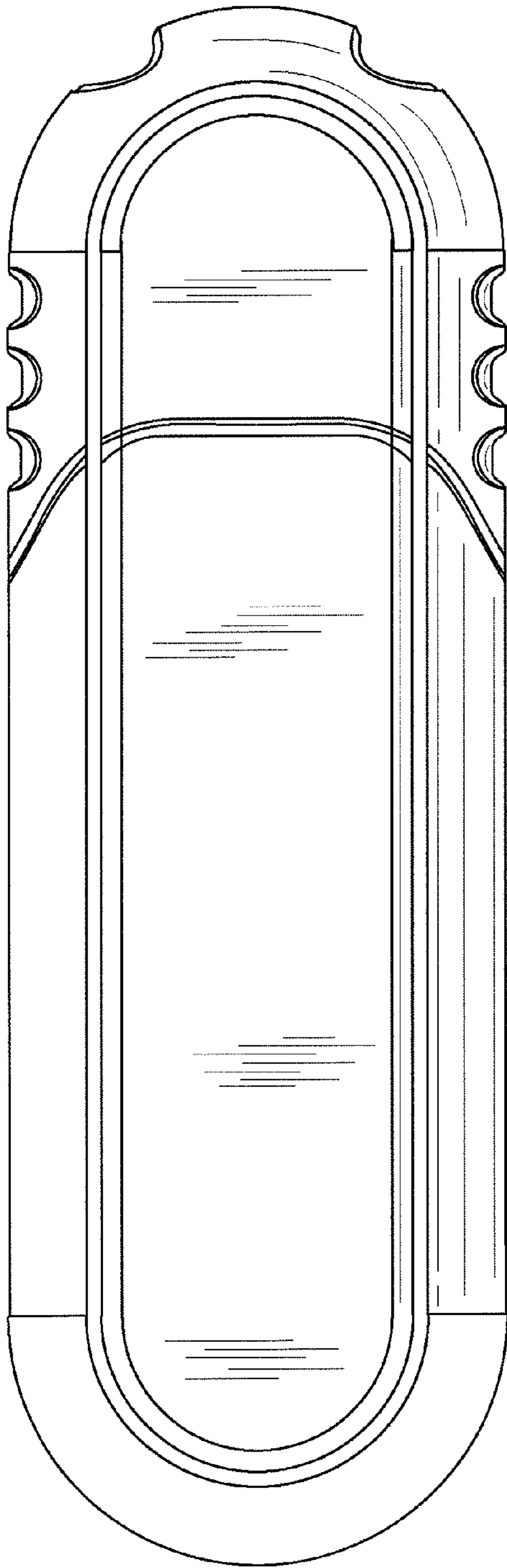

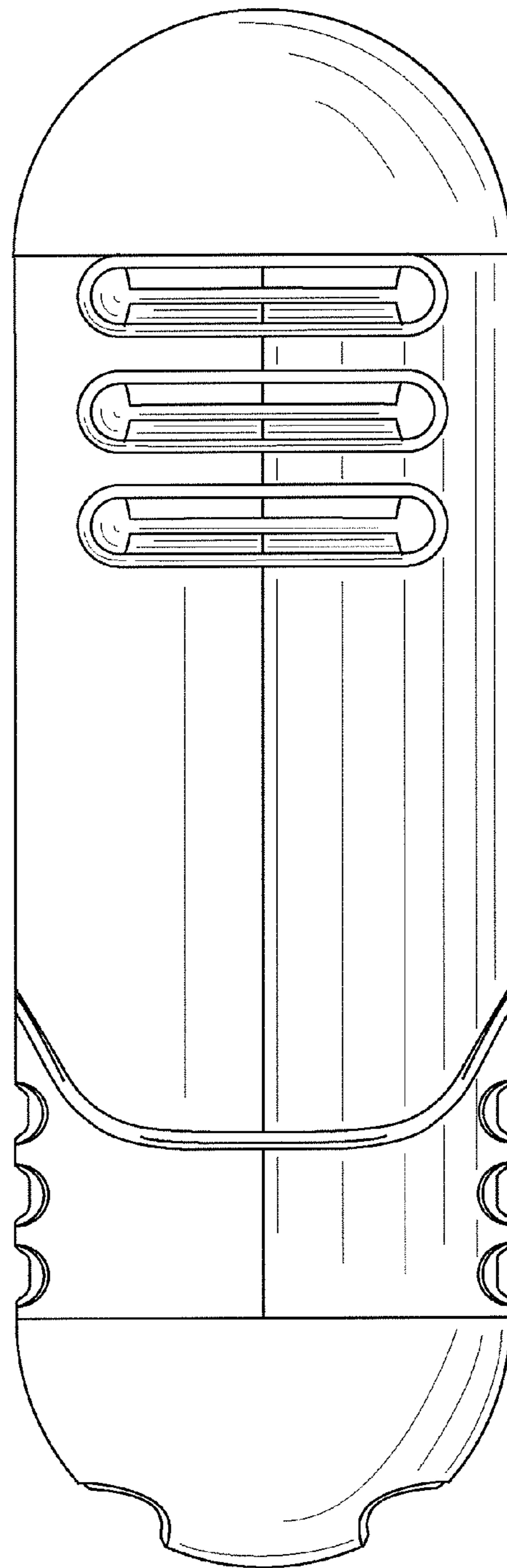

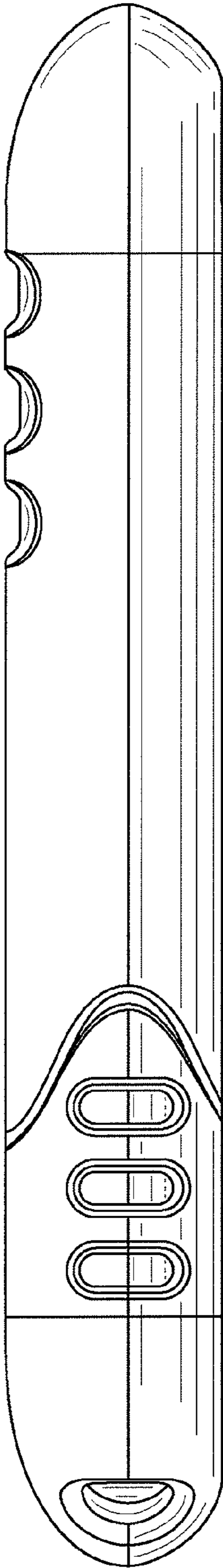

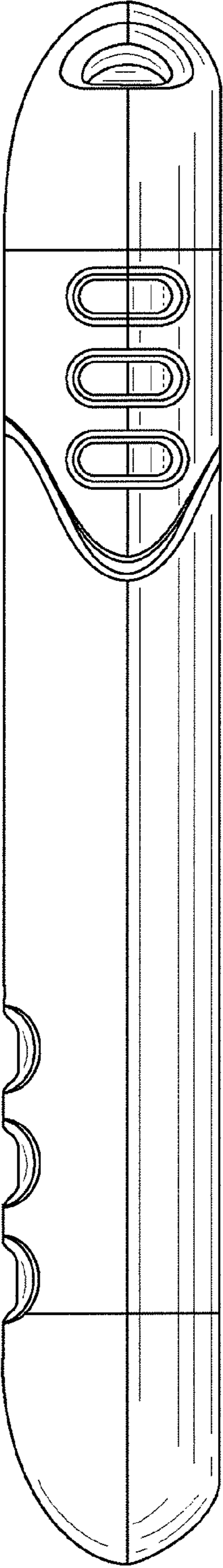

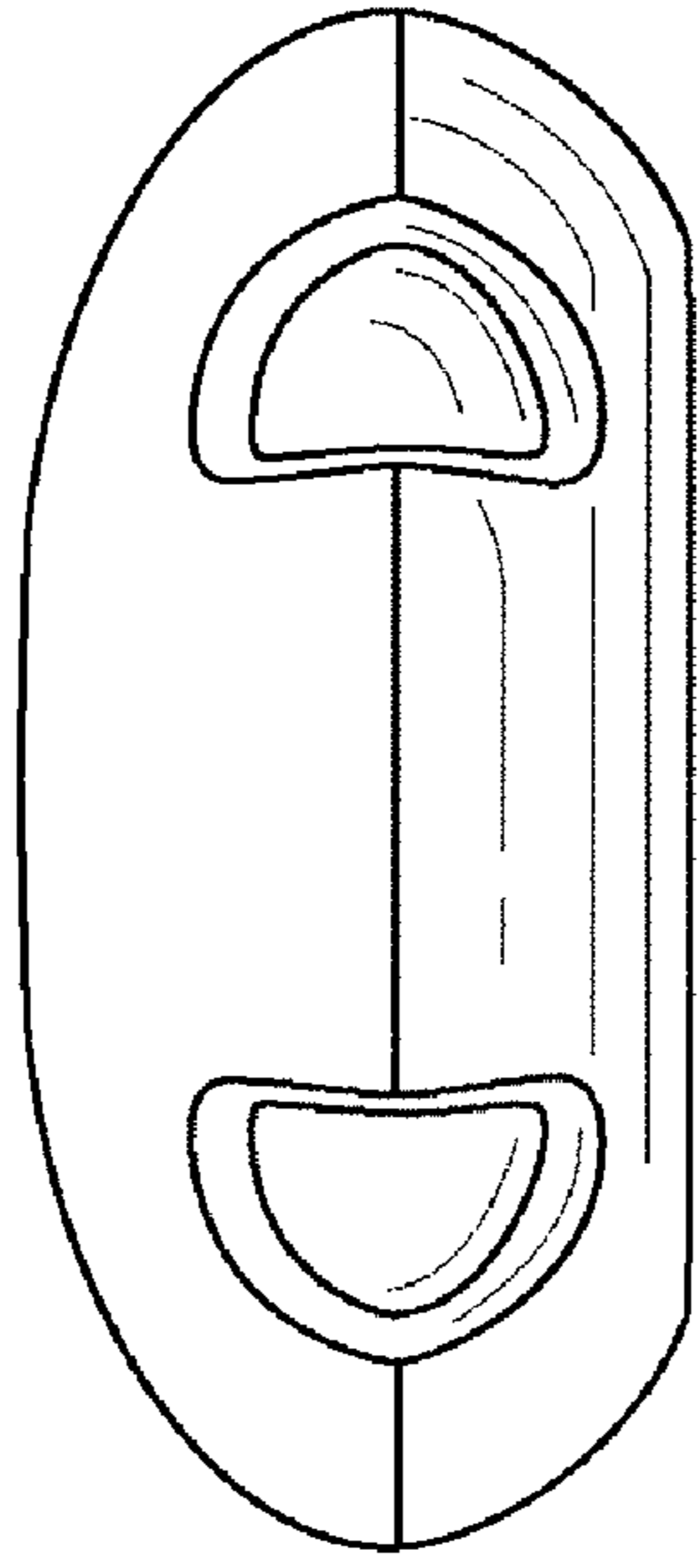

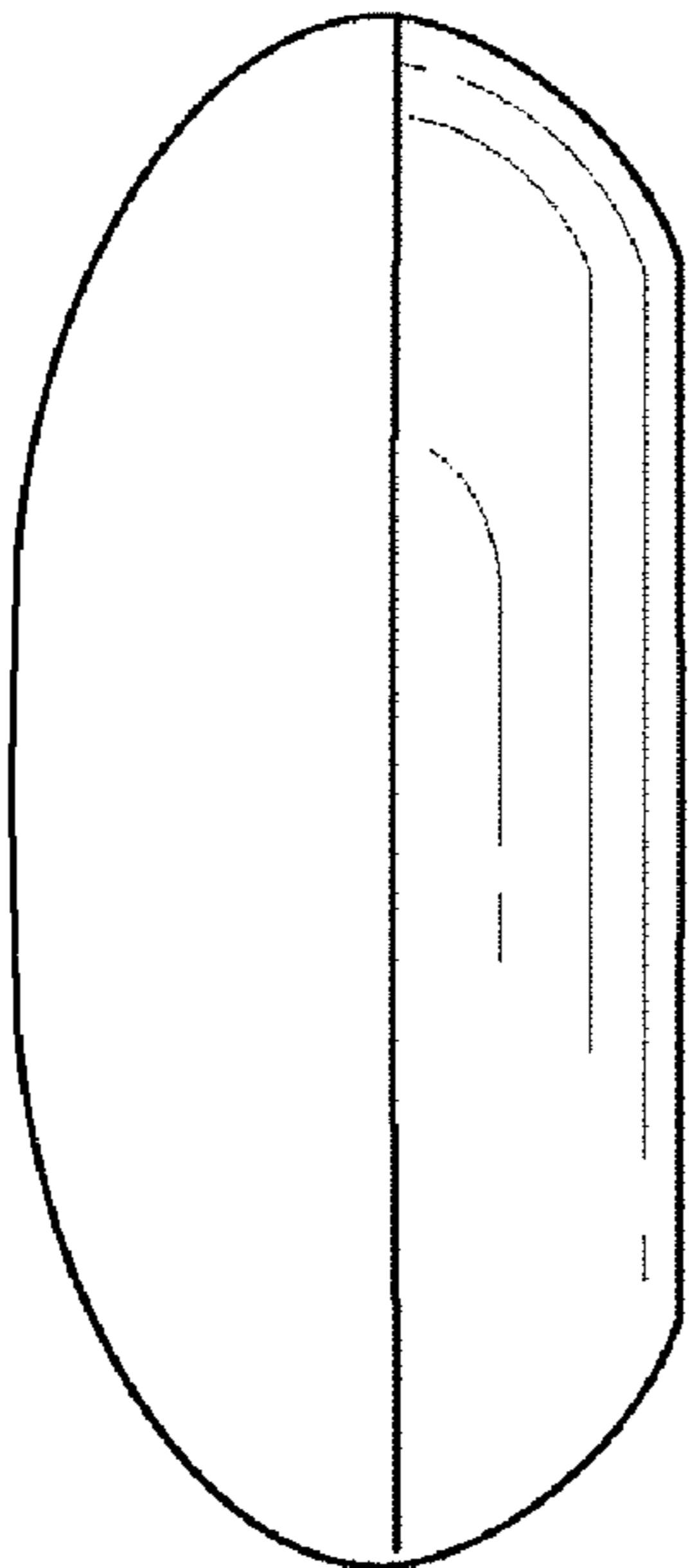
