(57) **CLAIM**

The ornamental design for a pocket folder, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a pocket folder, showing my new design;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a top, front, left side perspective view thereof;

FIG. 8 is a cross-sectional view taken along line 8—8 of FIG. 1;

FIG. 9 is a cross-sectional view taken along line 9—9 of FIG. 1;

FIG. 10 is a front elevational view of a pocket folder made of transparent material, showing my new design, the rear view being a mirror image thereof;

FIG. 11 is a left side elevational view thereof;

FIG. 12 is a right side elevational view being a mirror image thereof;

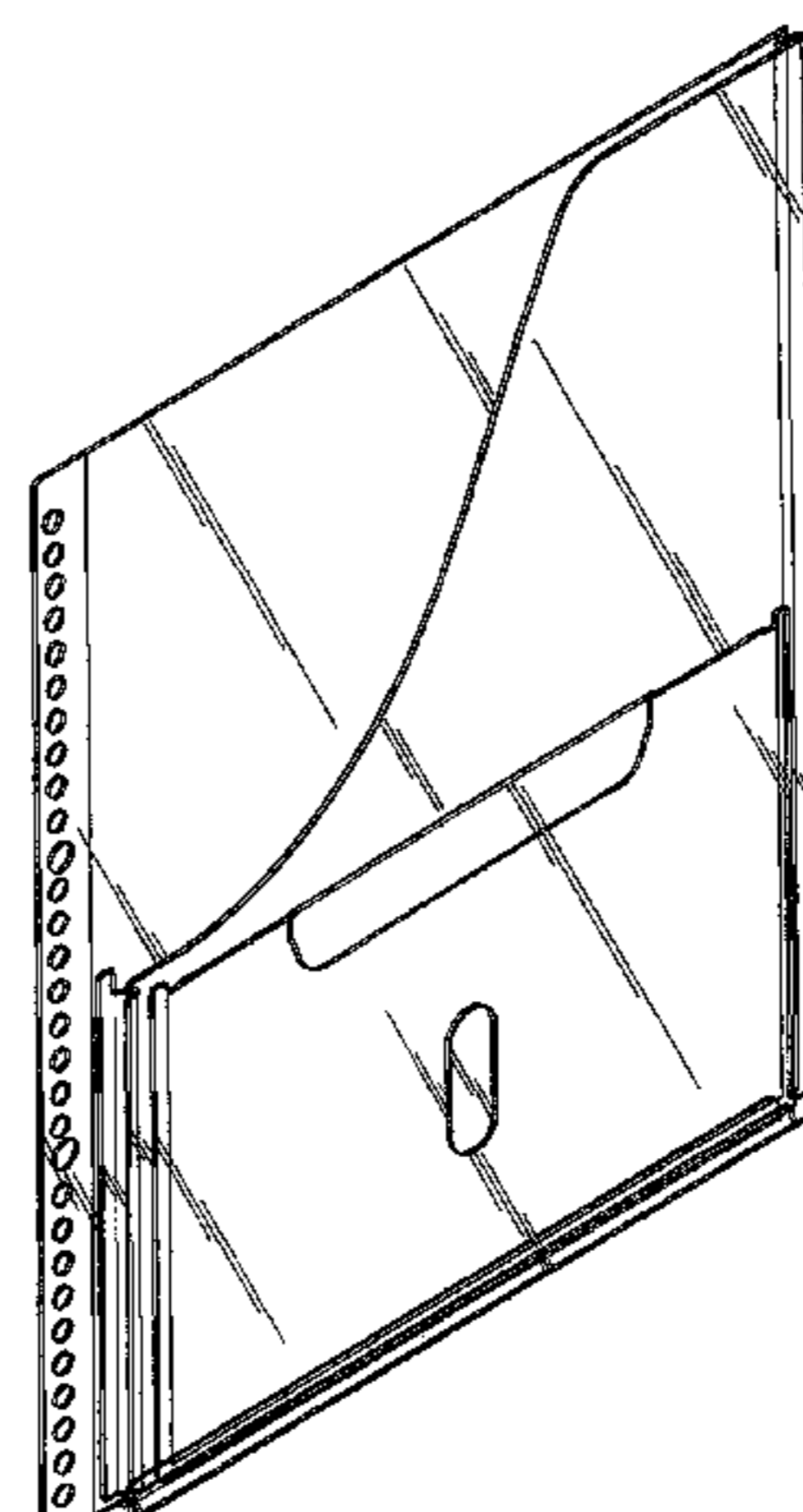
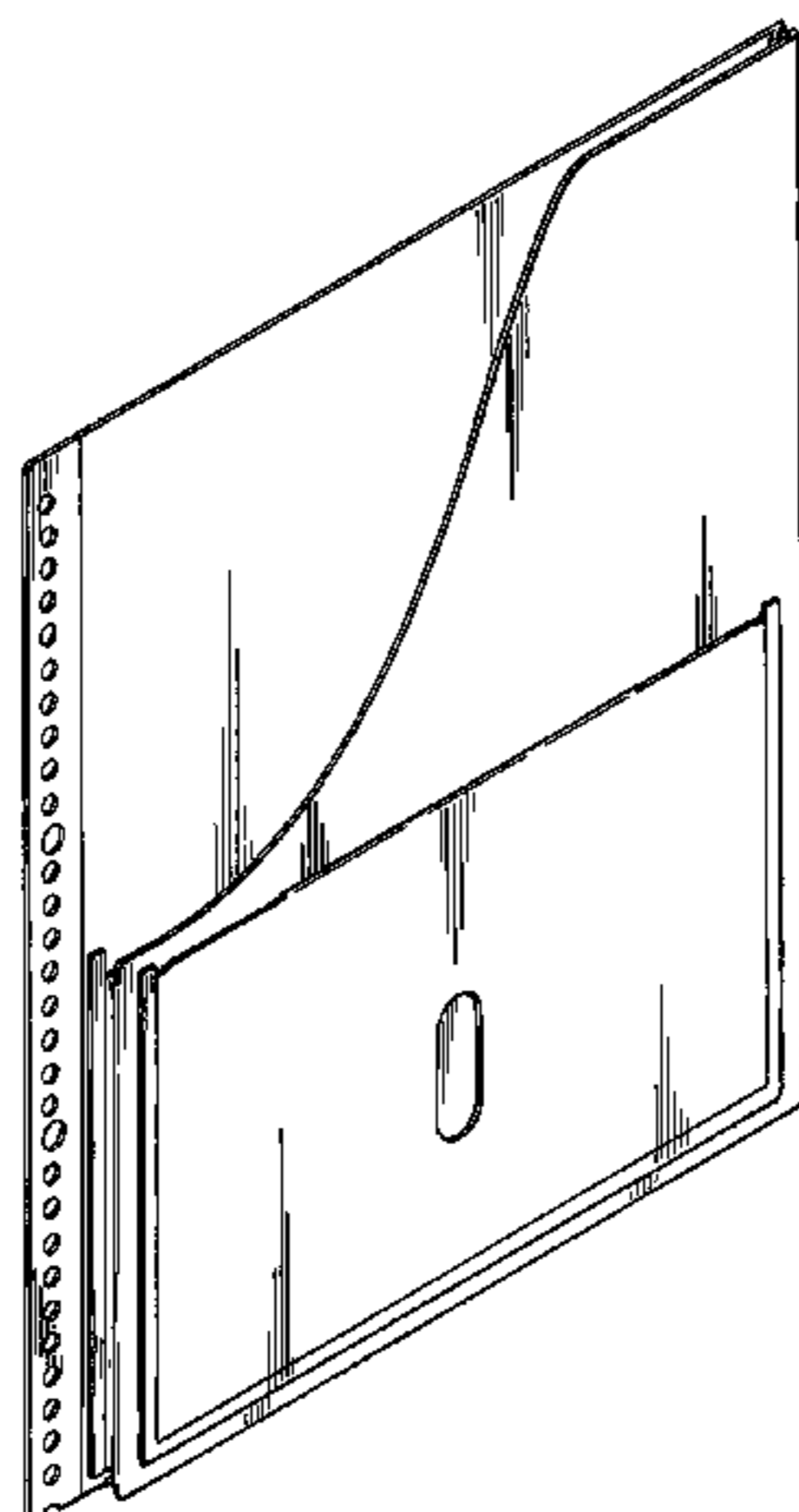
FIG. 13 is a rear elevational view thereof;

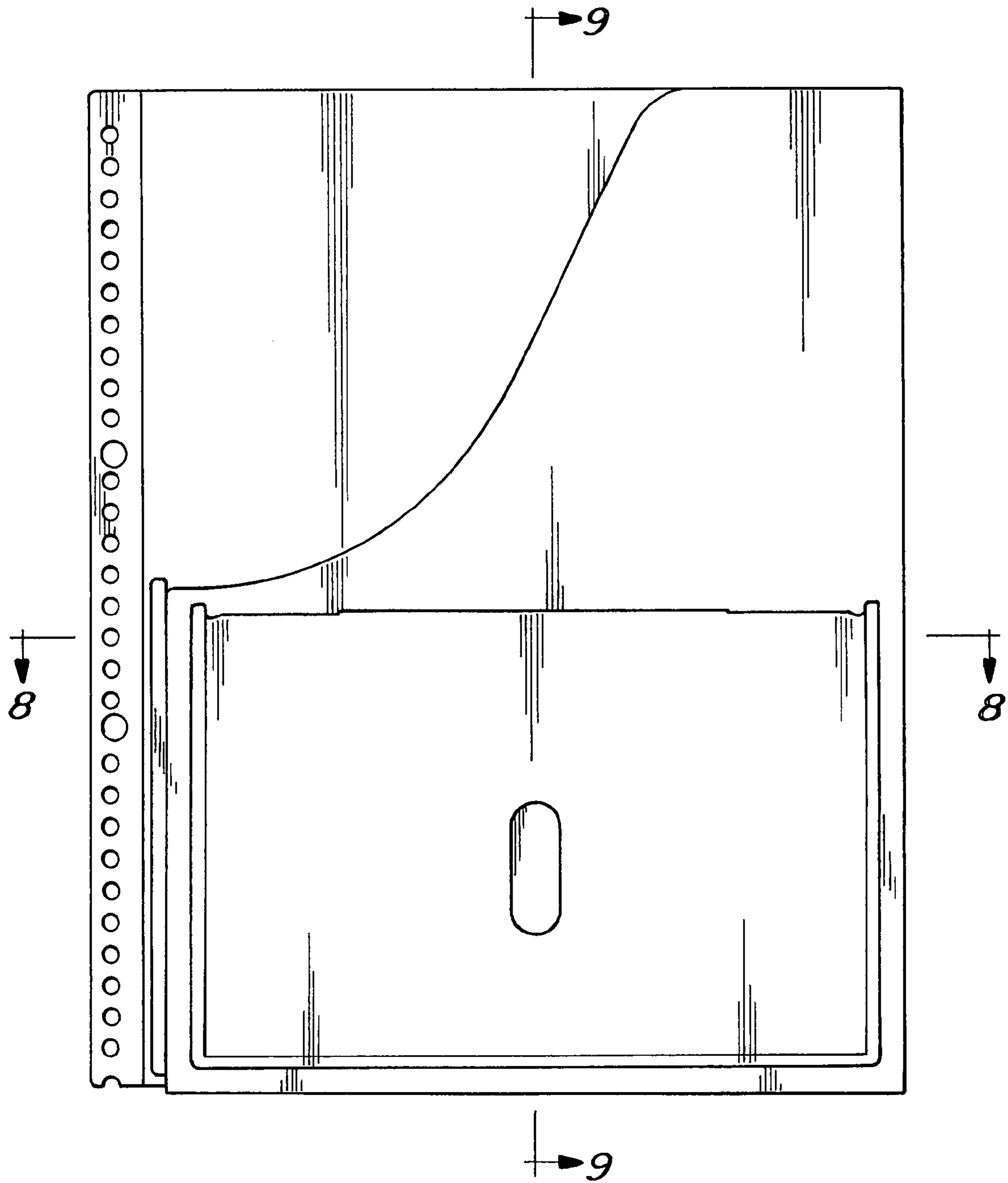

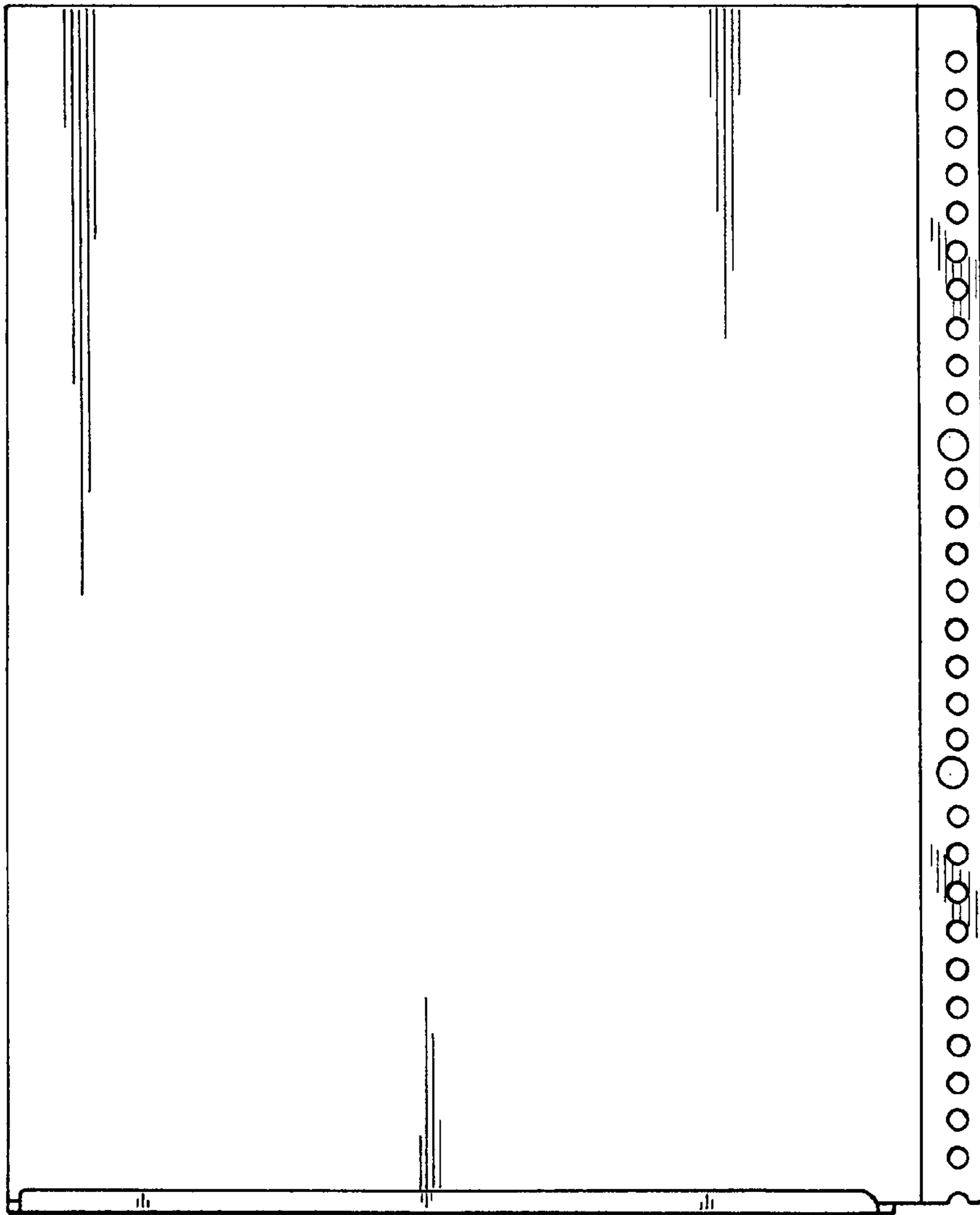

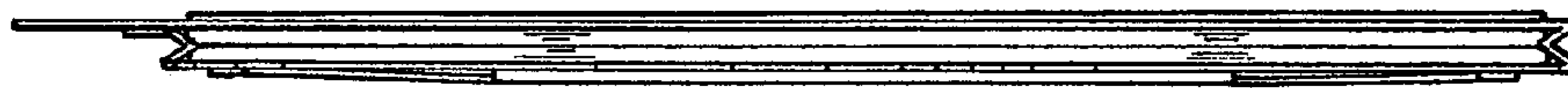

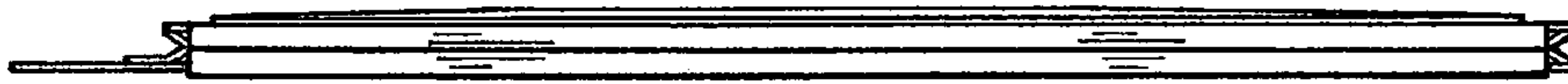

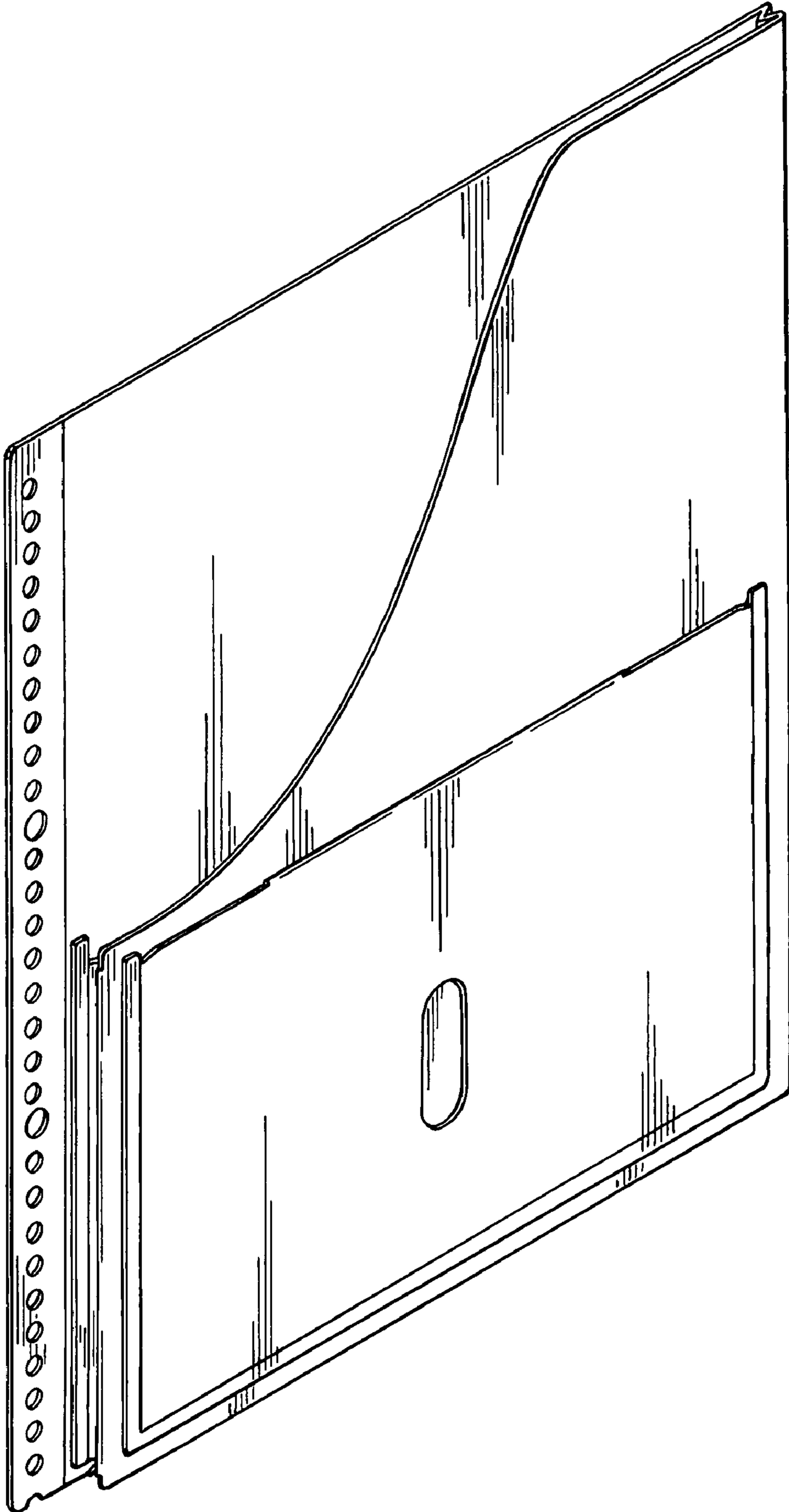

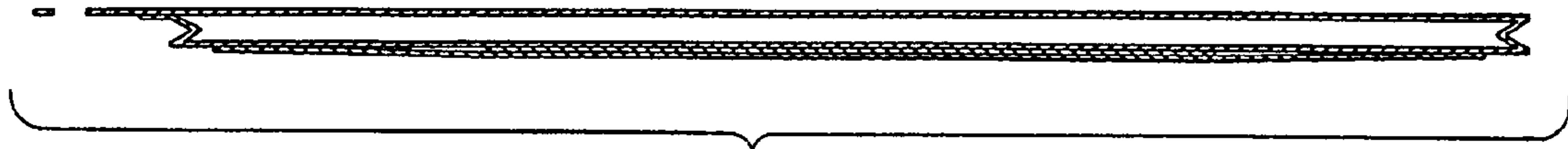

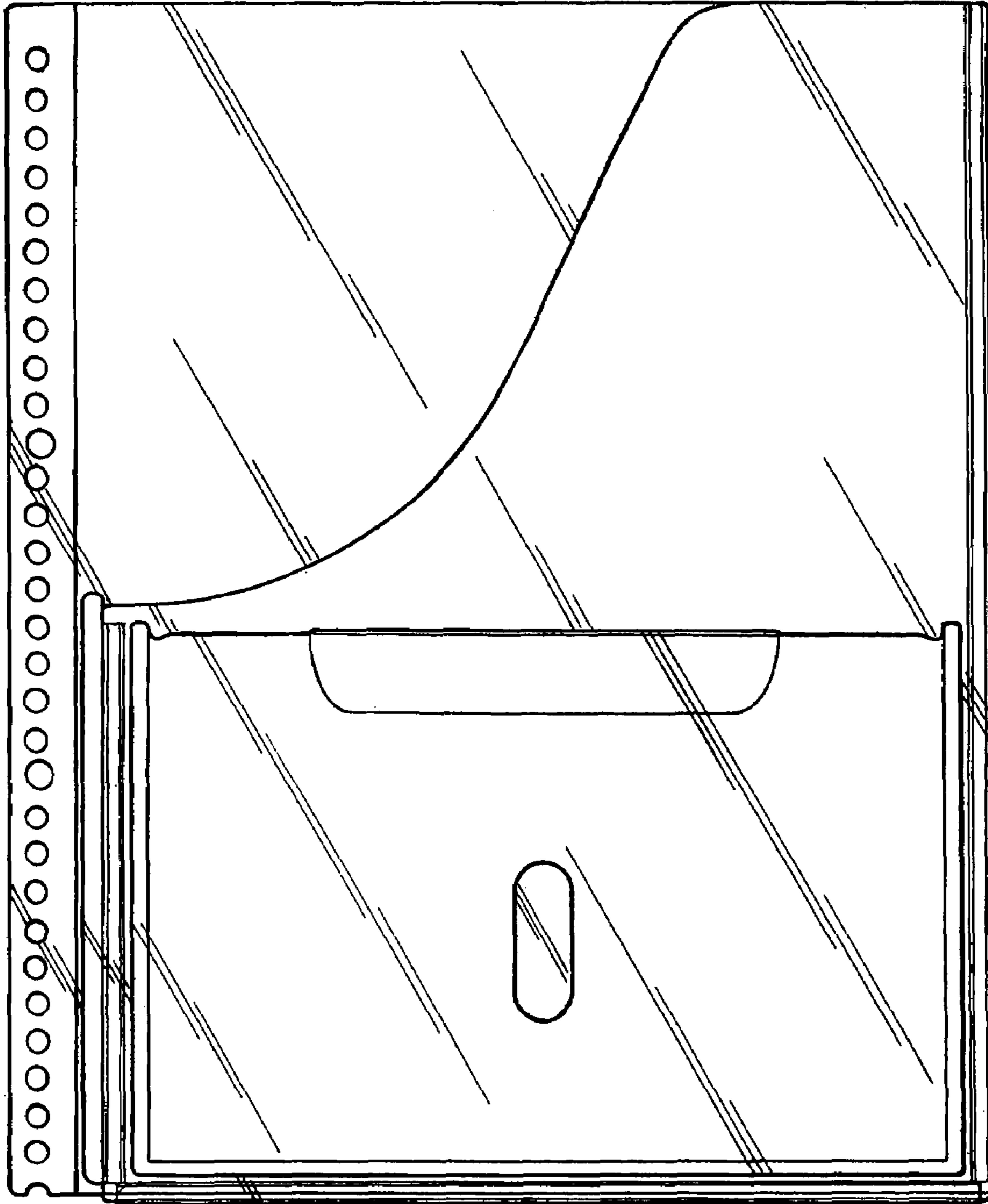

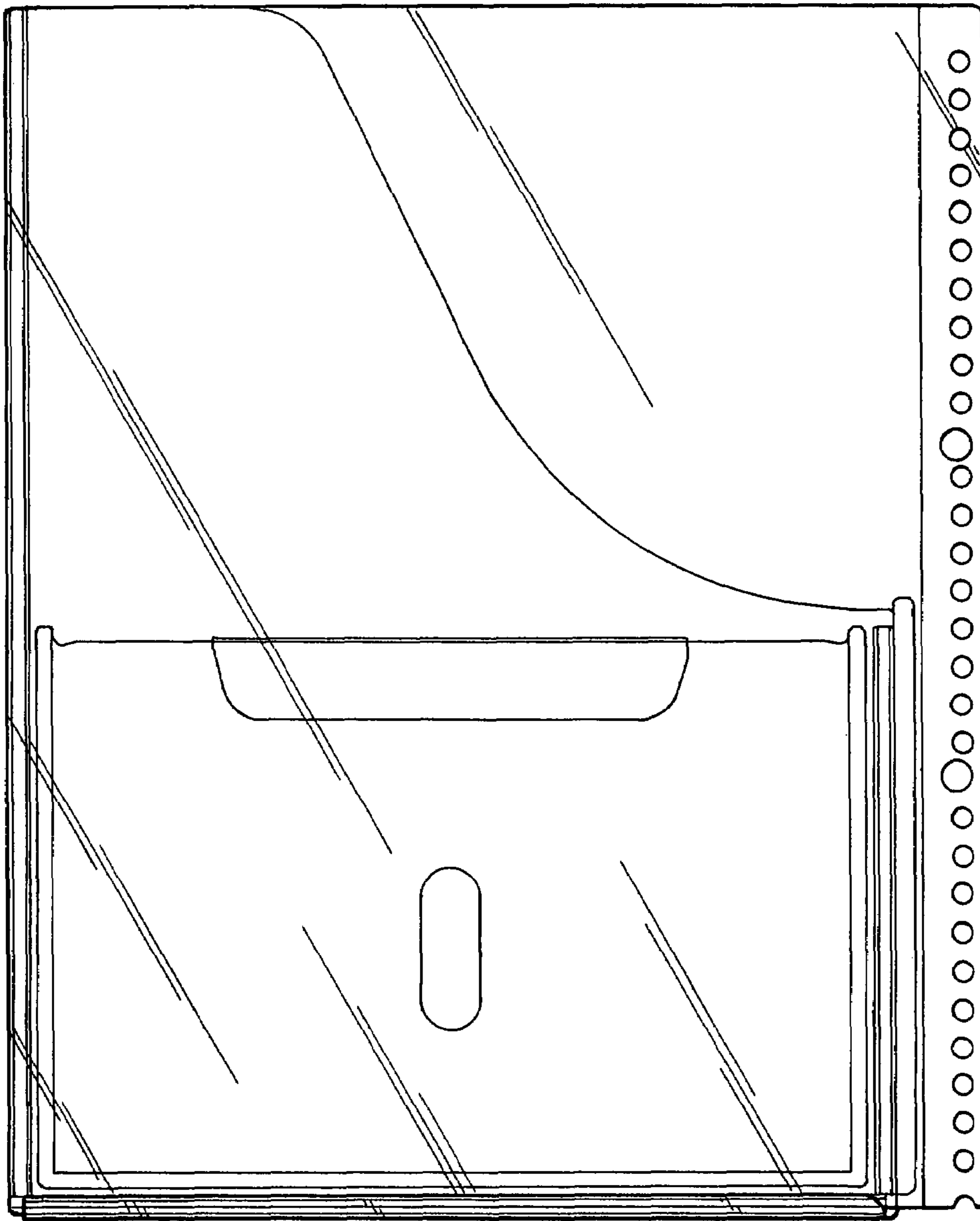

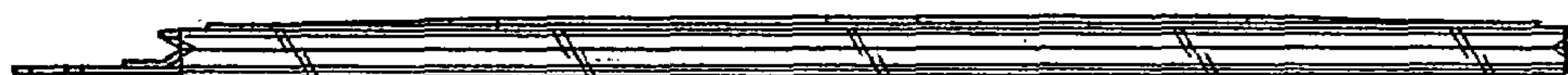

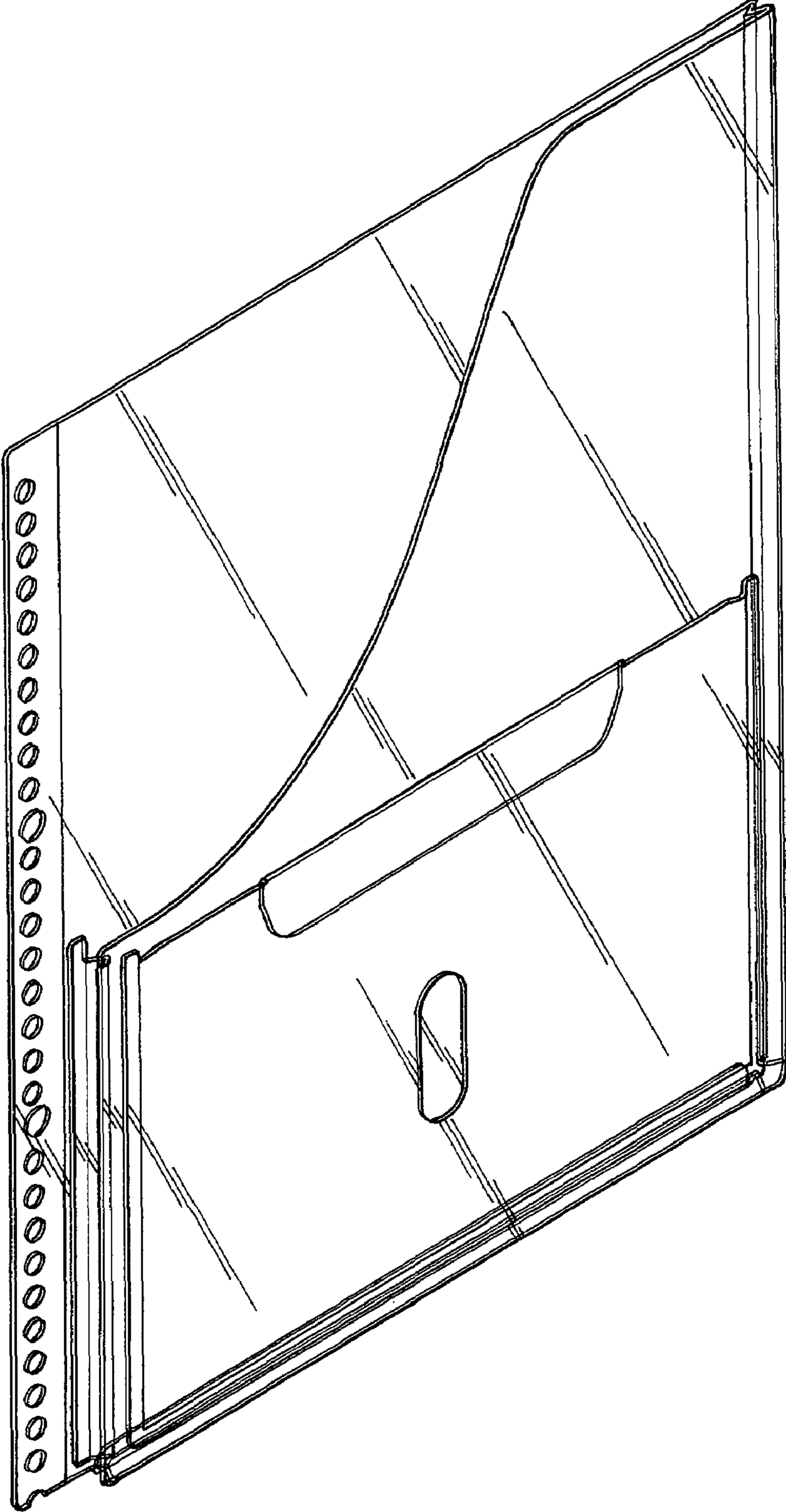
