DESCRIPTION

FIG. 1 is a right front perspective view of a hand held transfer tape dispenser showing my new design;

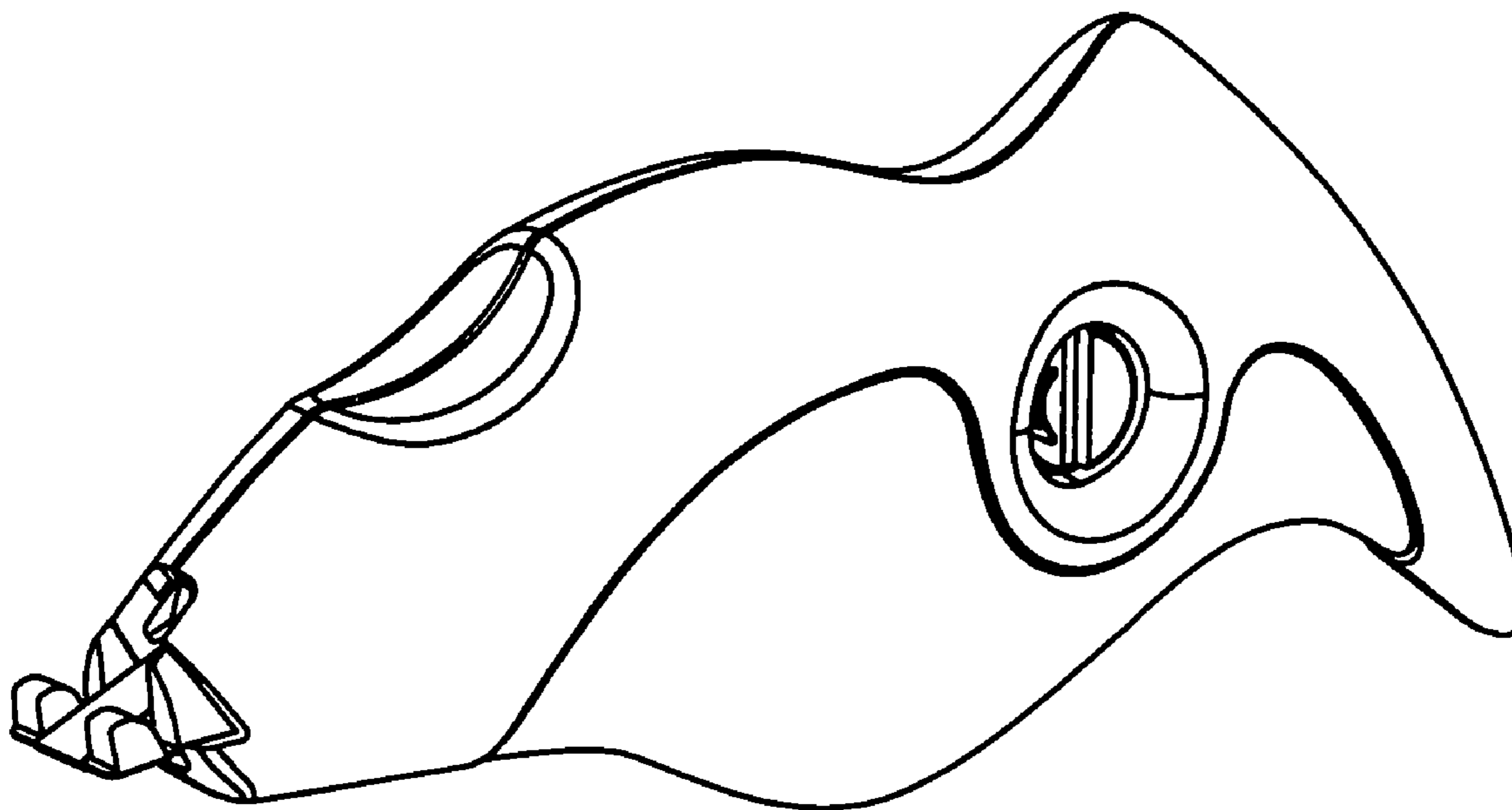

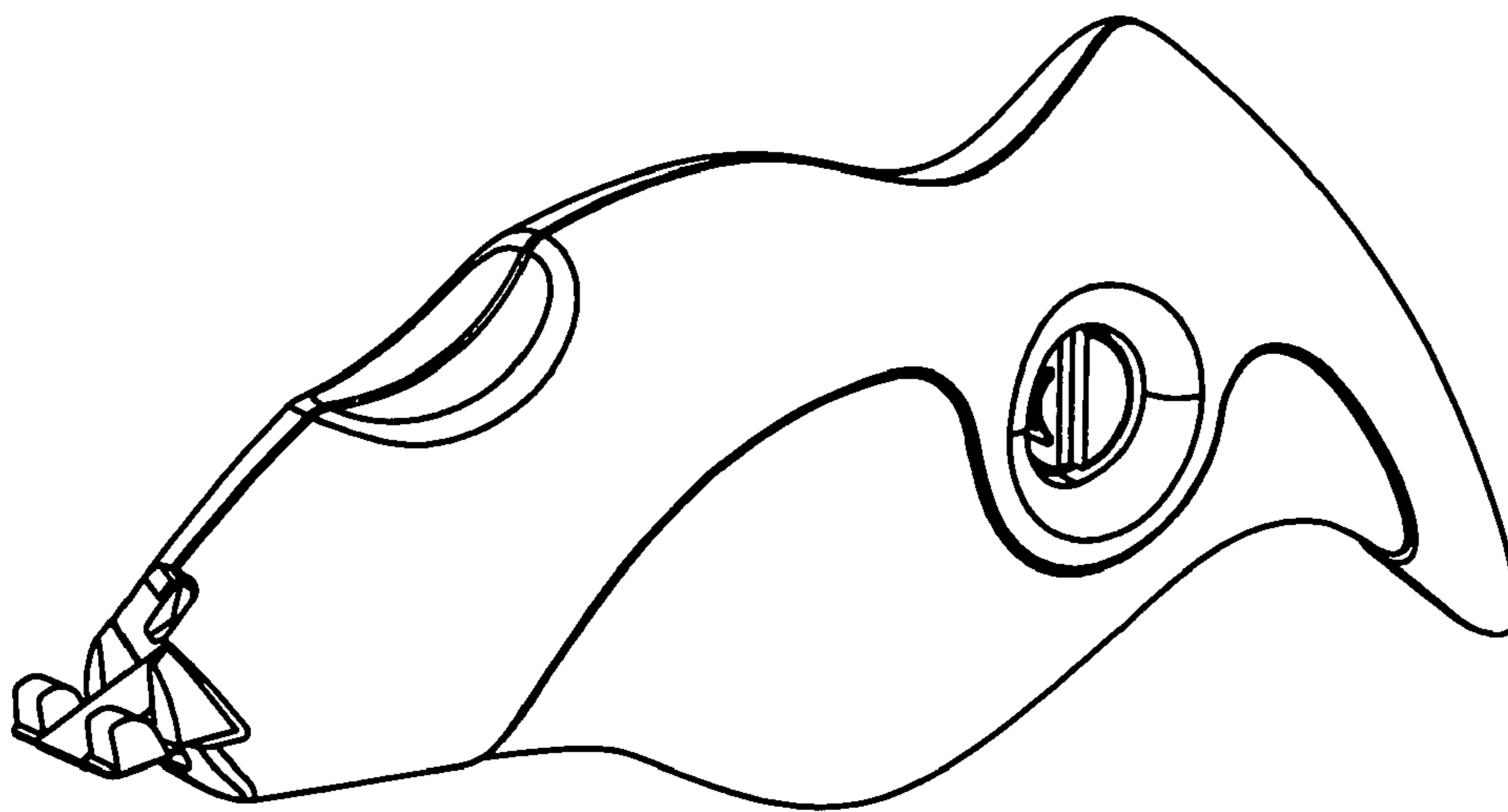

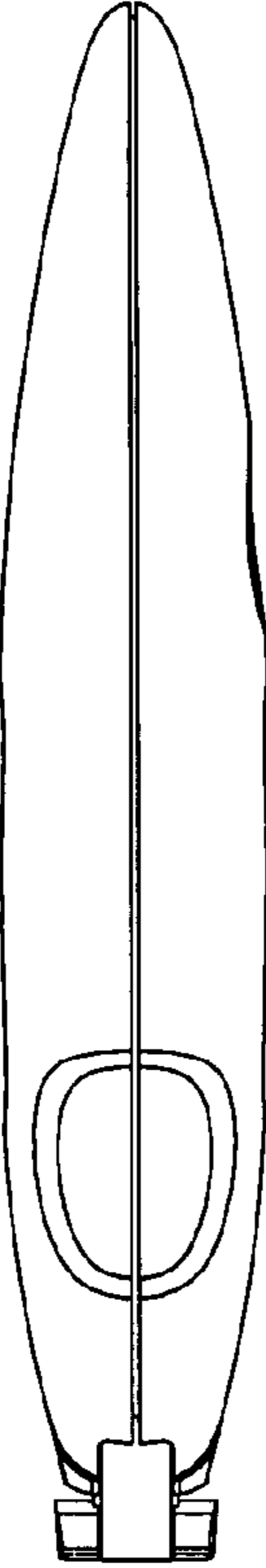

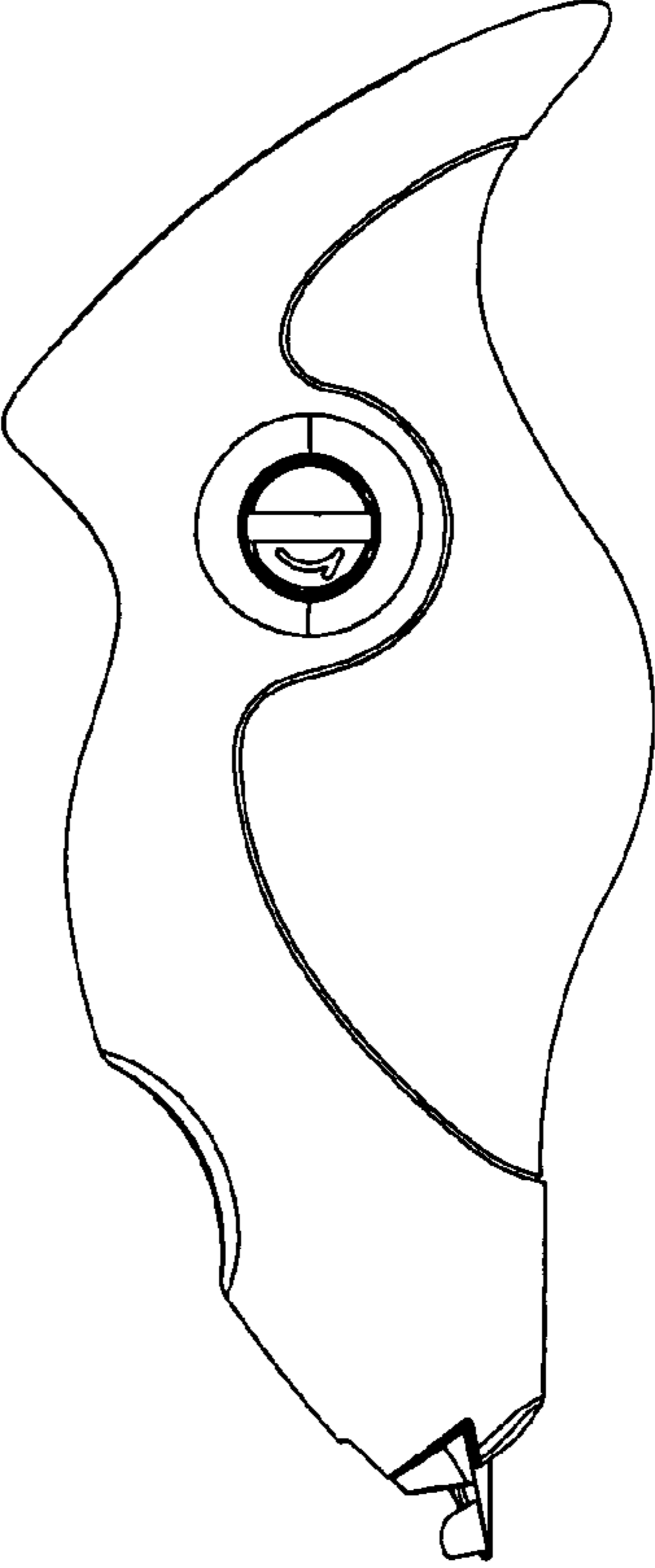

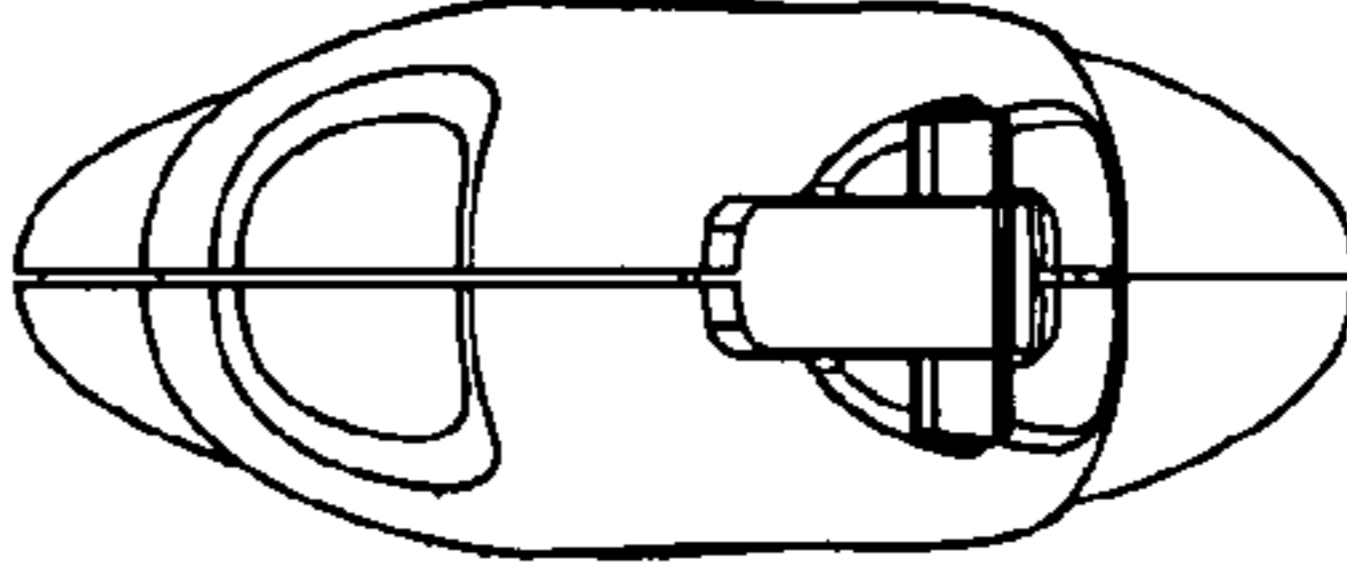

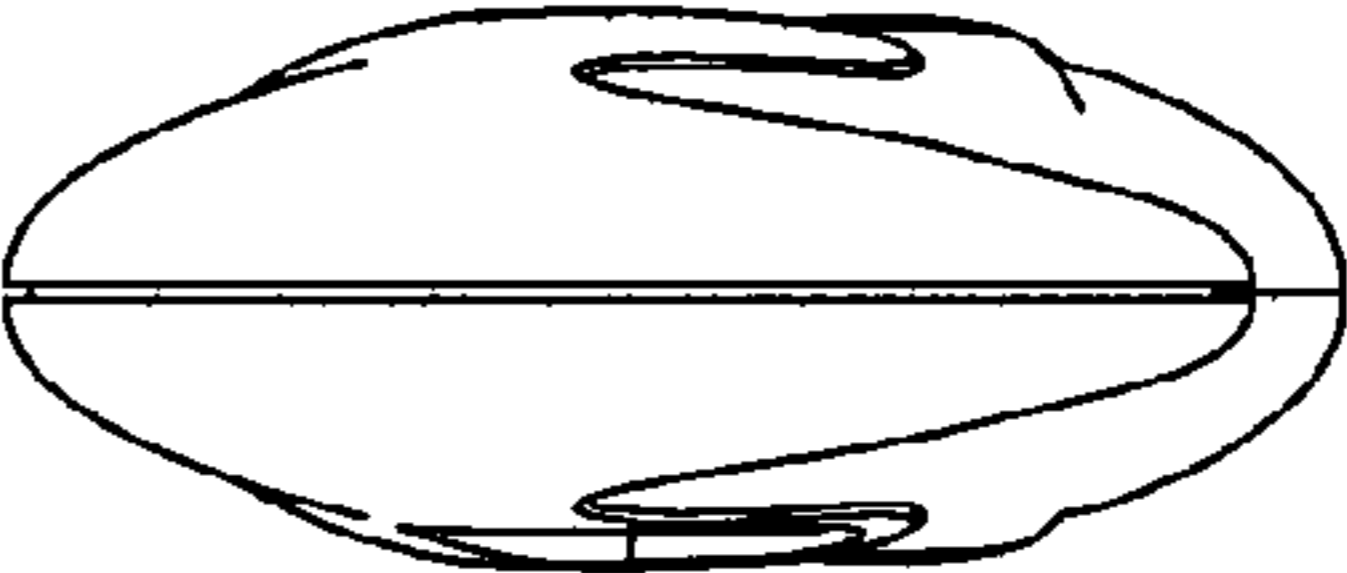

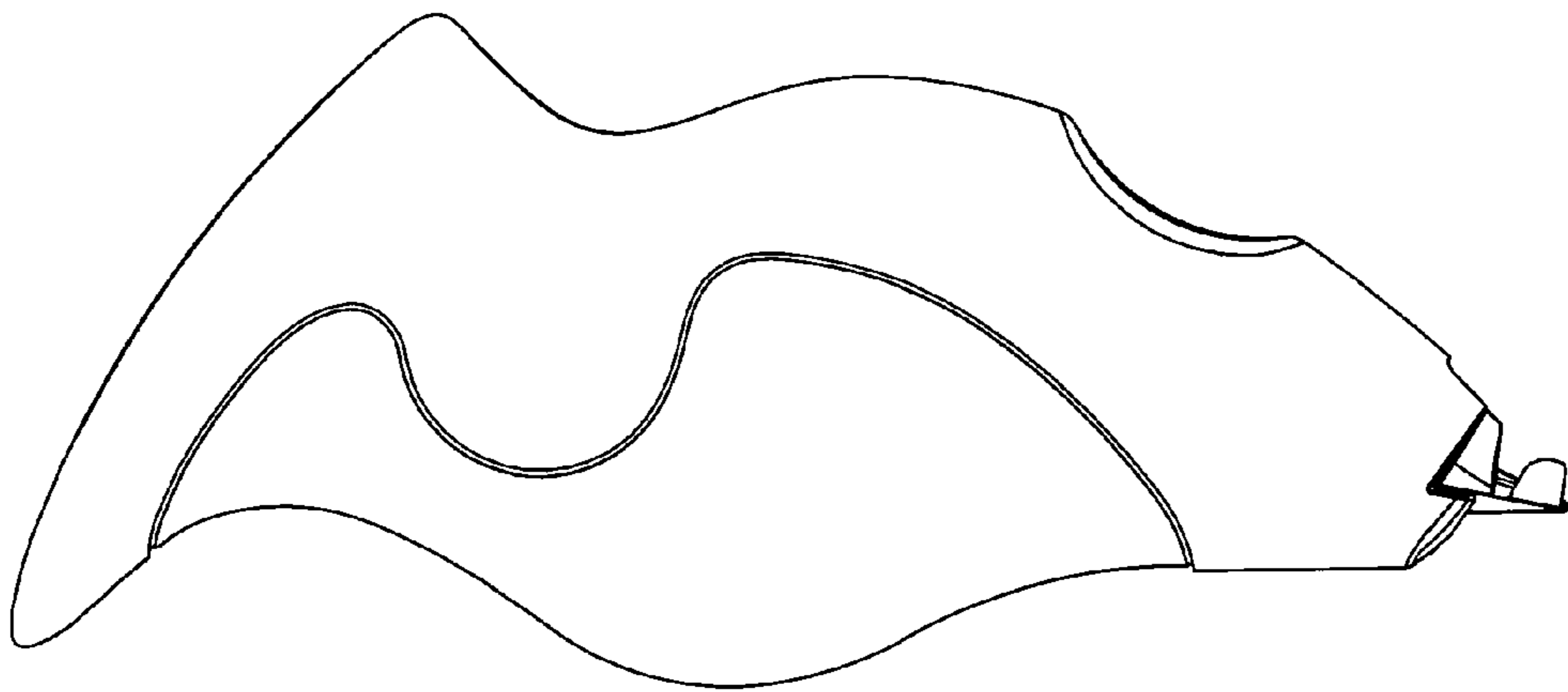
