The ornamental design for a water ride corkscrew feature, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a water ride corkscrew feature;

FIG. 2 is a top view of FIG. 1;

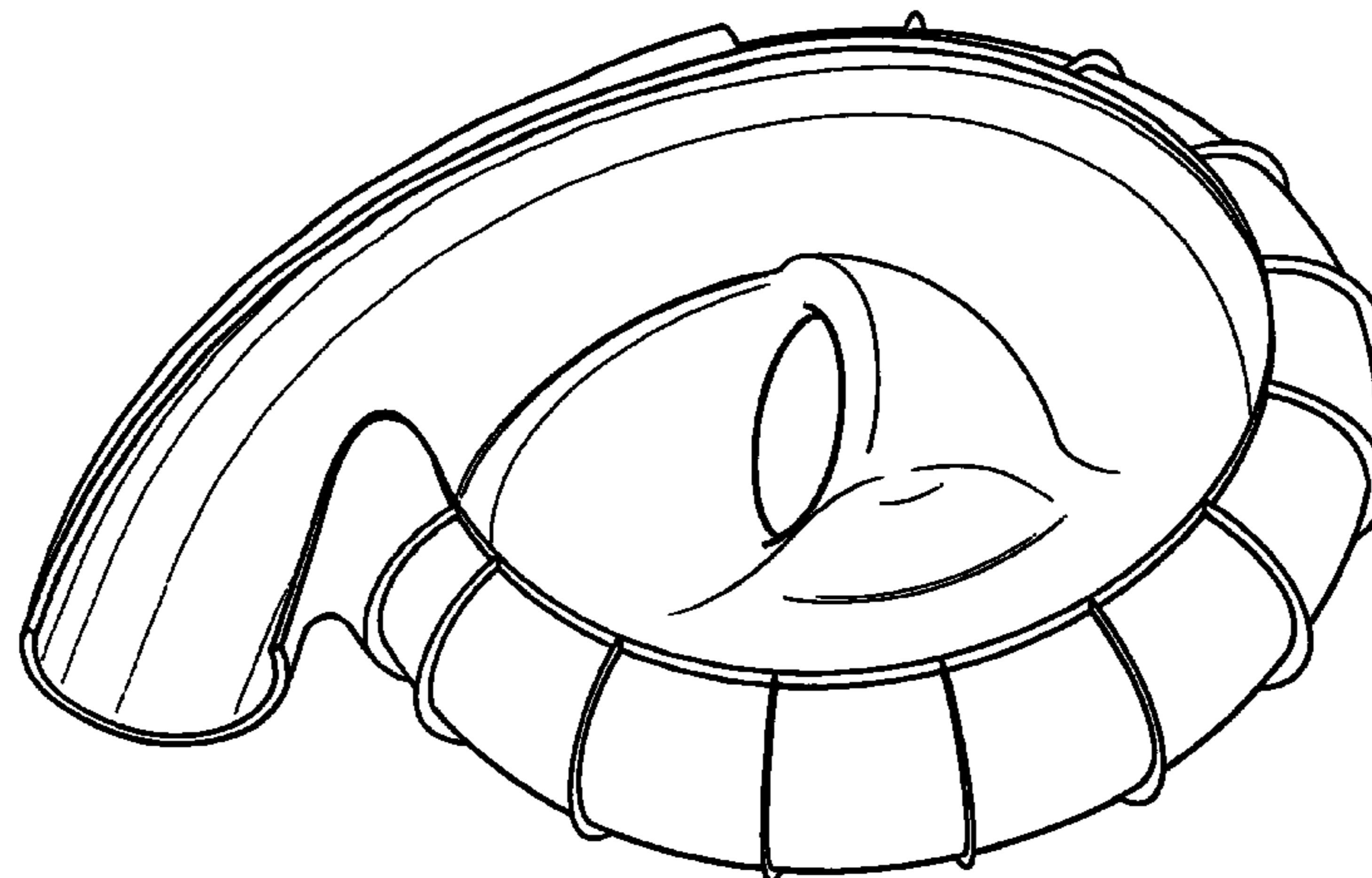
FIG. 3 is a bottom view of FIG. 1;

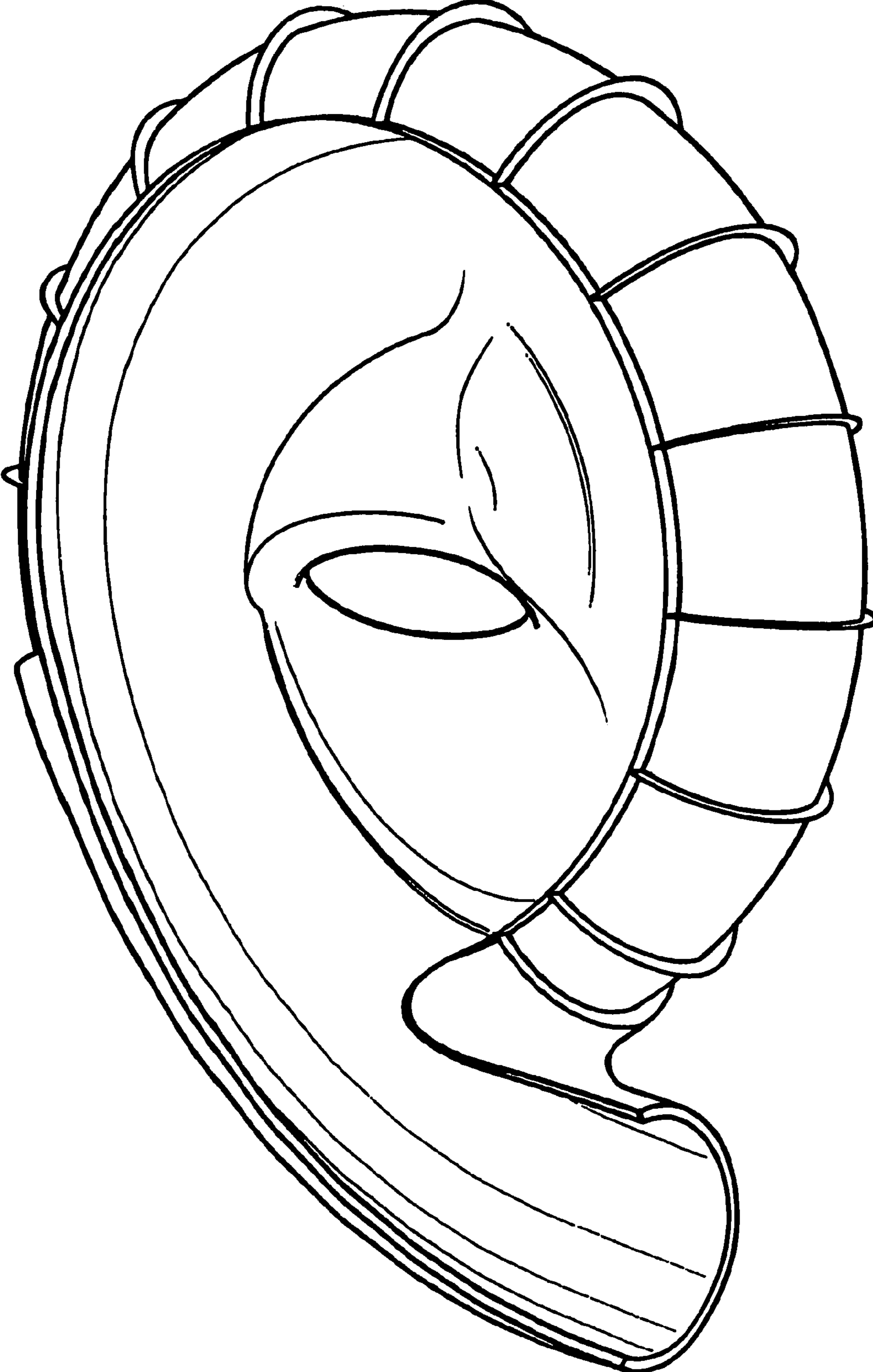

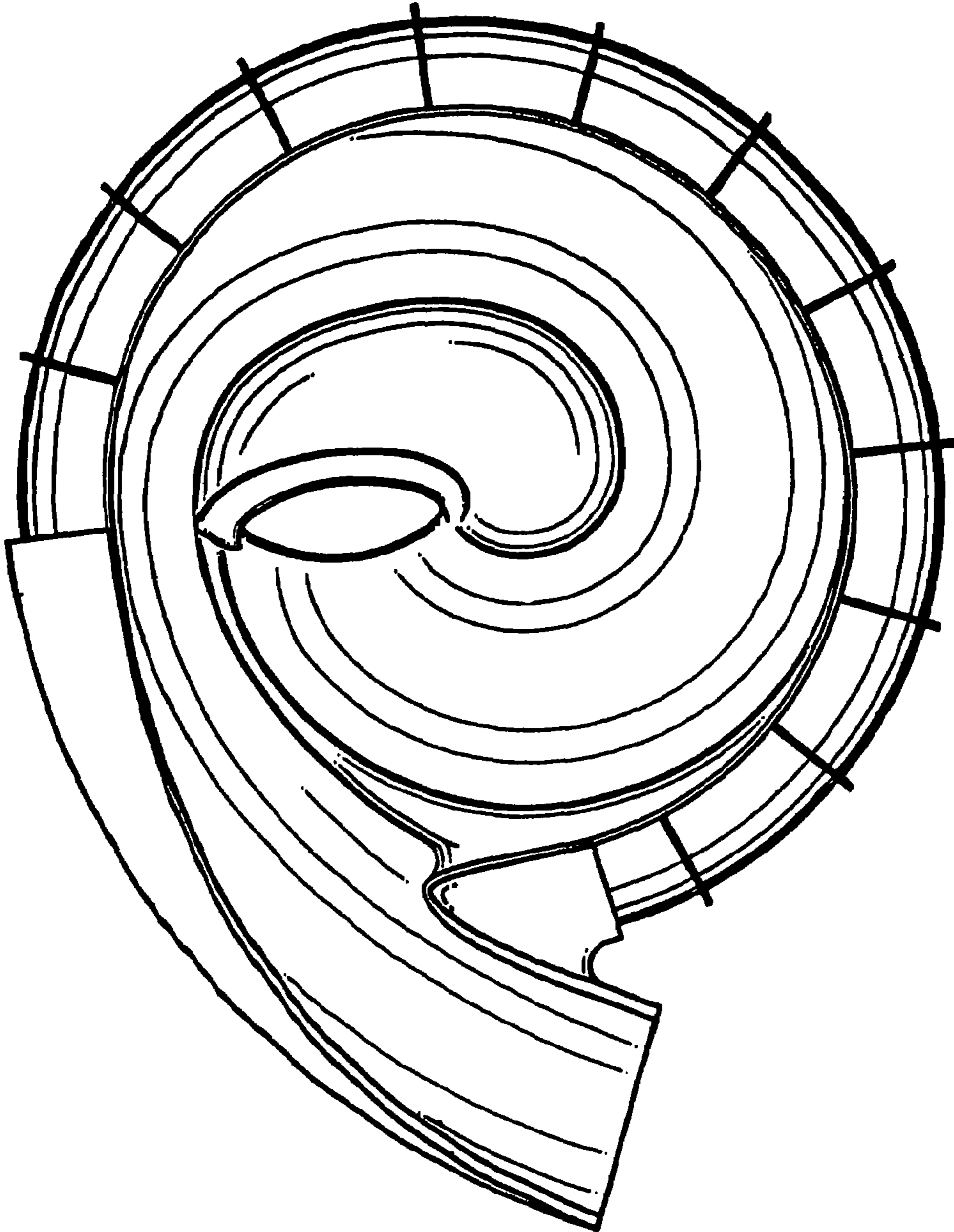

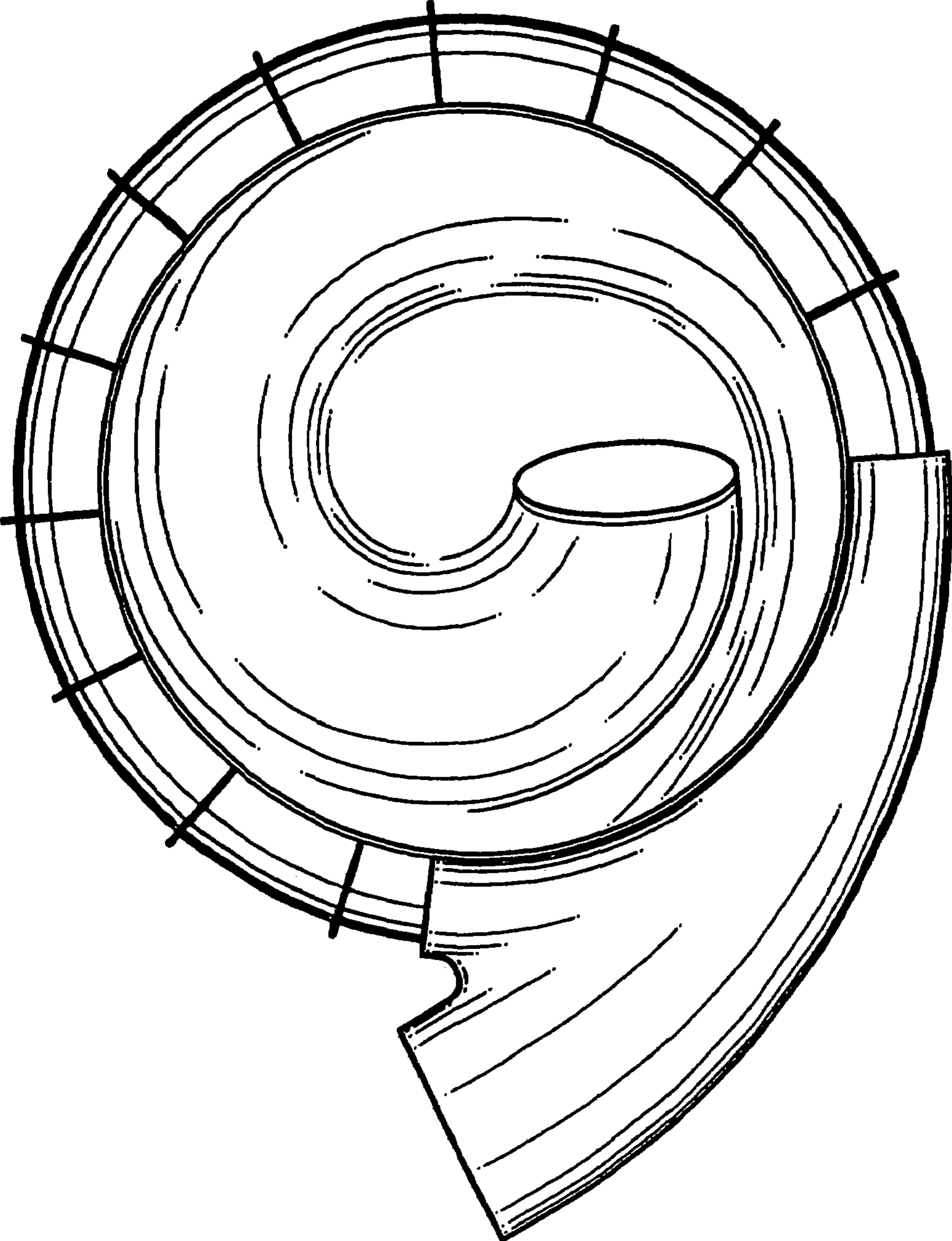

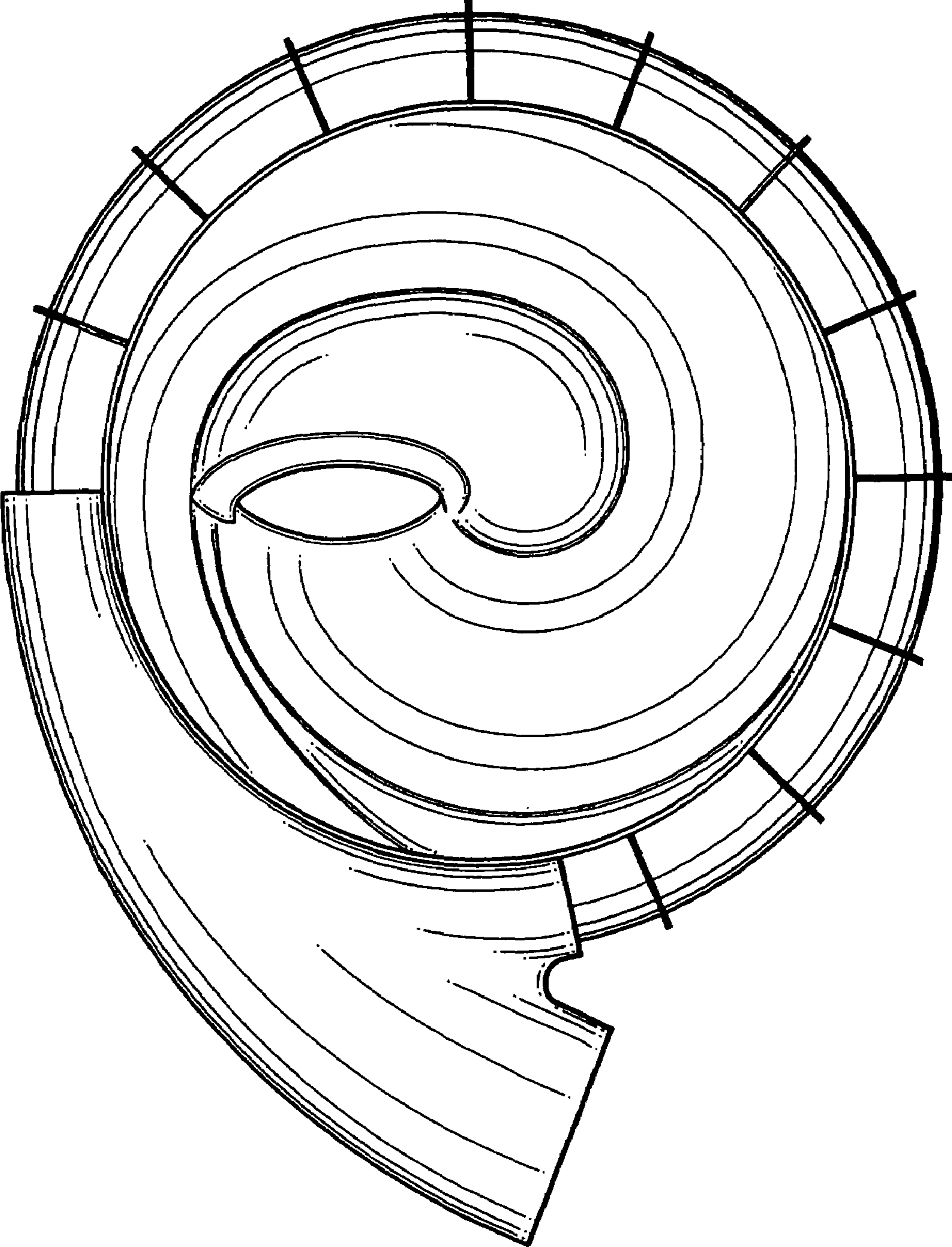

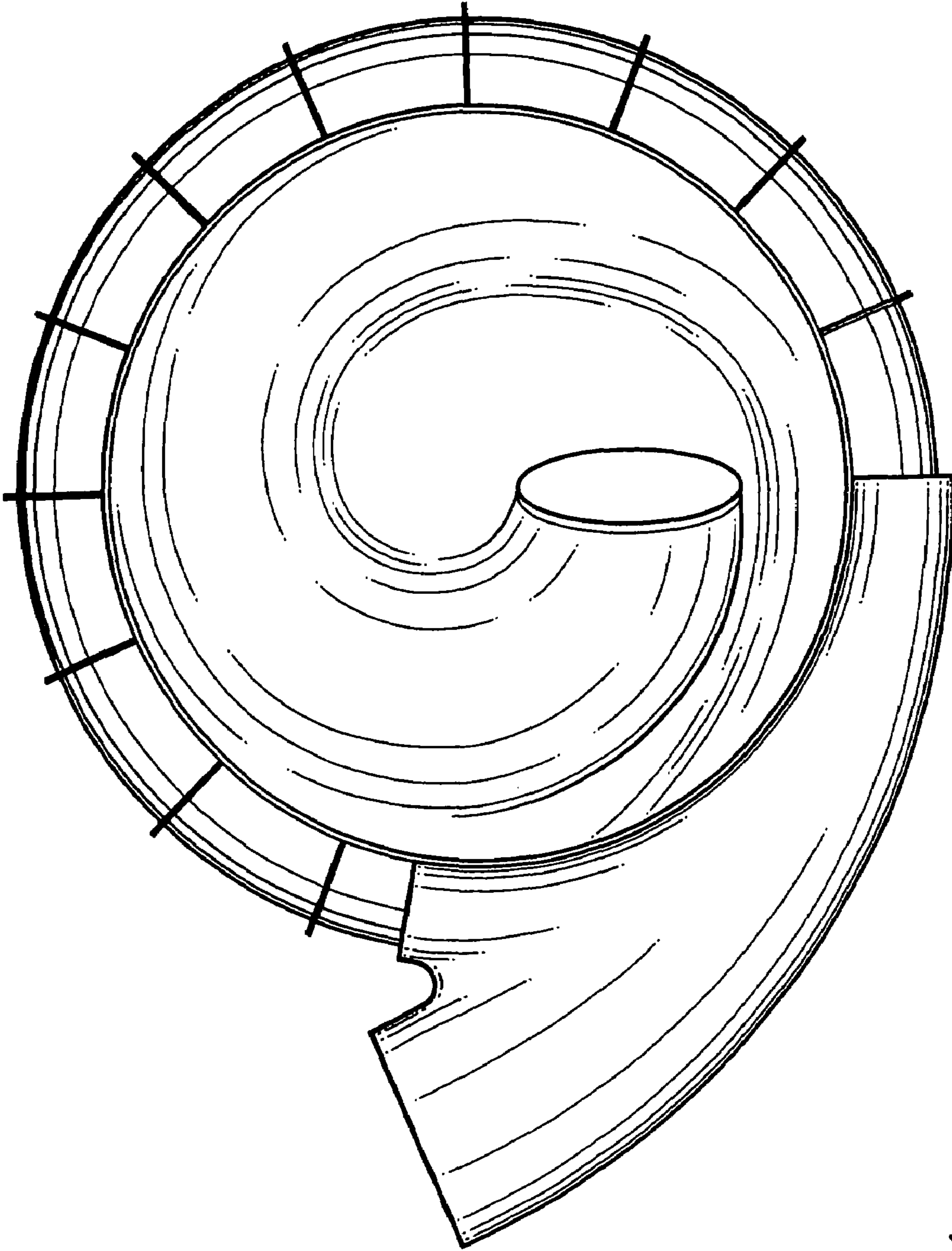
