(57) **CLAIM**

The ornamental design for a stylet, as shown and described.

DESCRIPTION

FIG. 1 a perspective view of a stylet showing my new design, with the stylet shown broken in the middle to indicate indeterminate length;

FIG. 2 is a front view thereof, which is identical to the back view, the top view and the bottom view;

FIG. 3 is a left side view thereof;

FIG. 4 is a right side view thereof;

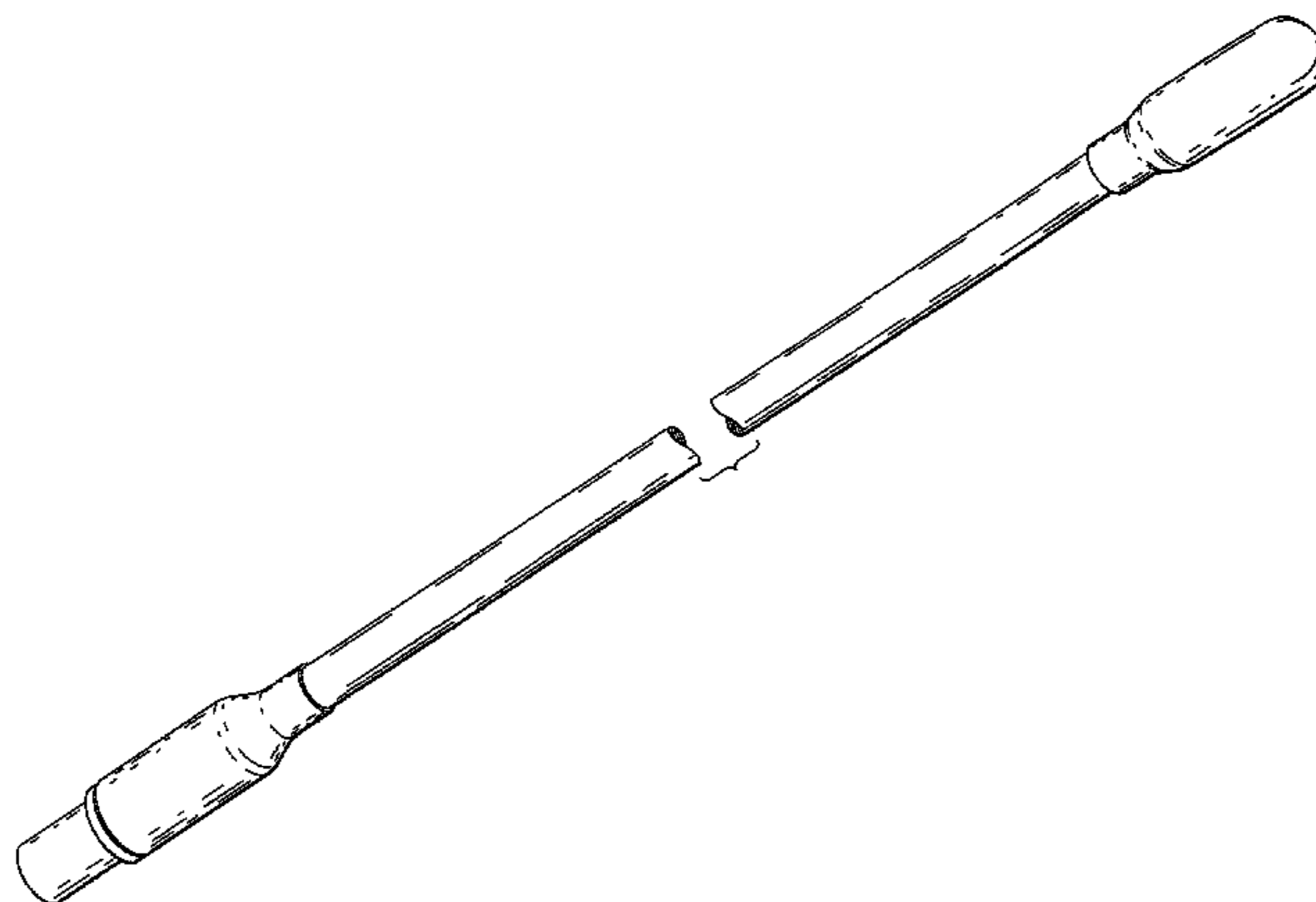
FIG. 5 is a perspective view of a second embodiment of a stylet with the stylet shown broken in the middle to indicate indeterminate length;

FIG. 6 is a front view thereof, which is identical to the back view, the top view and the bottom view;

FIG. 7 is a left side view thereof; and,

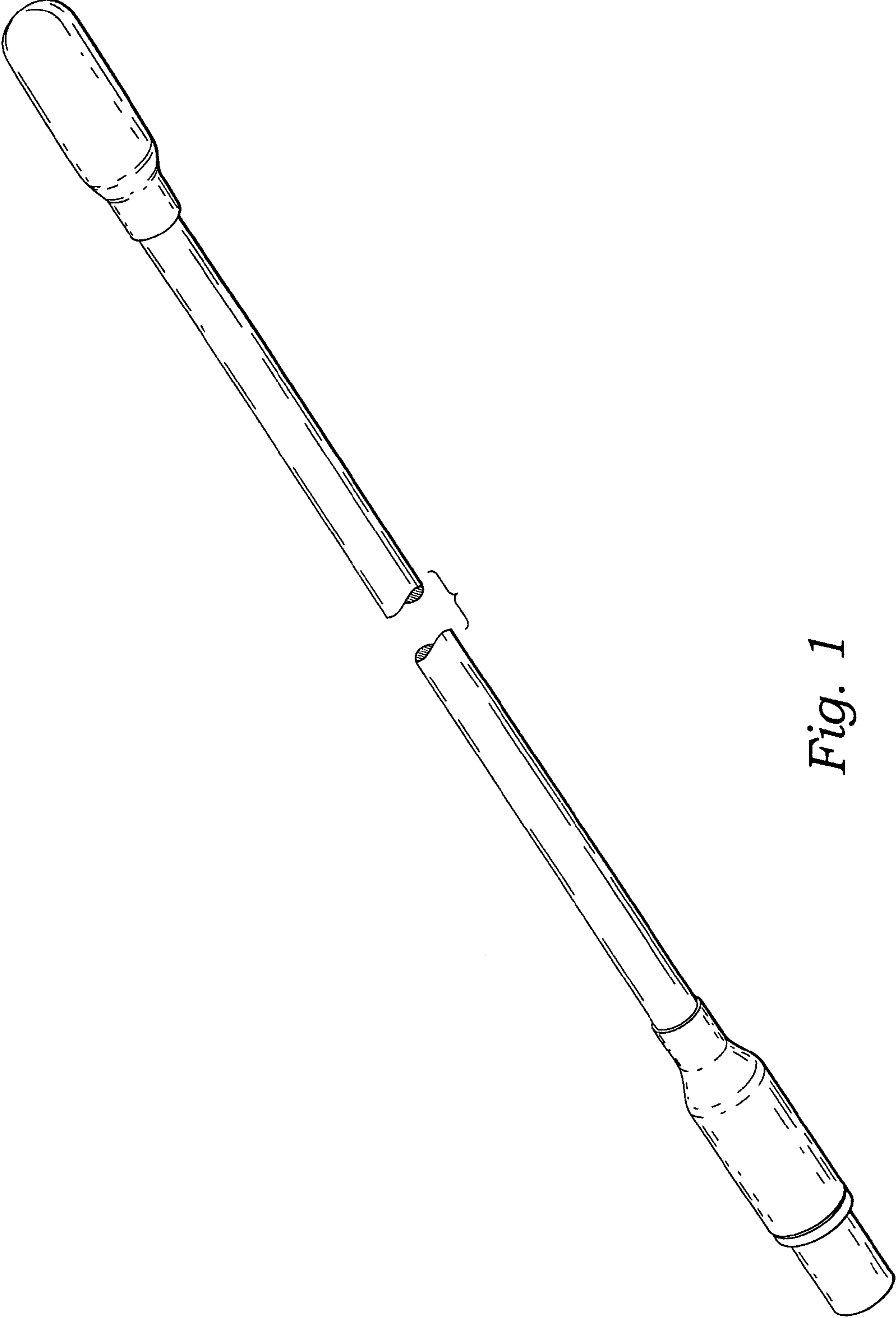

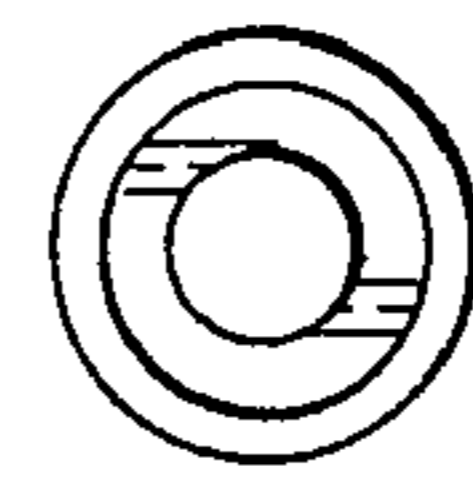

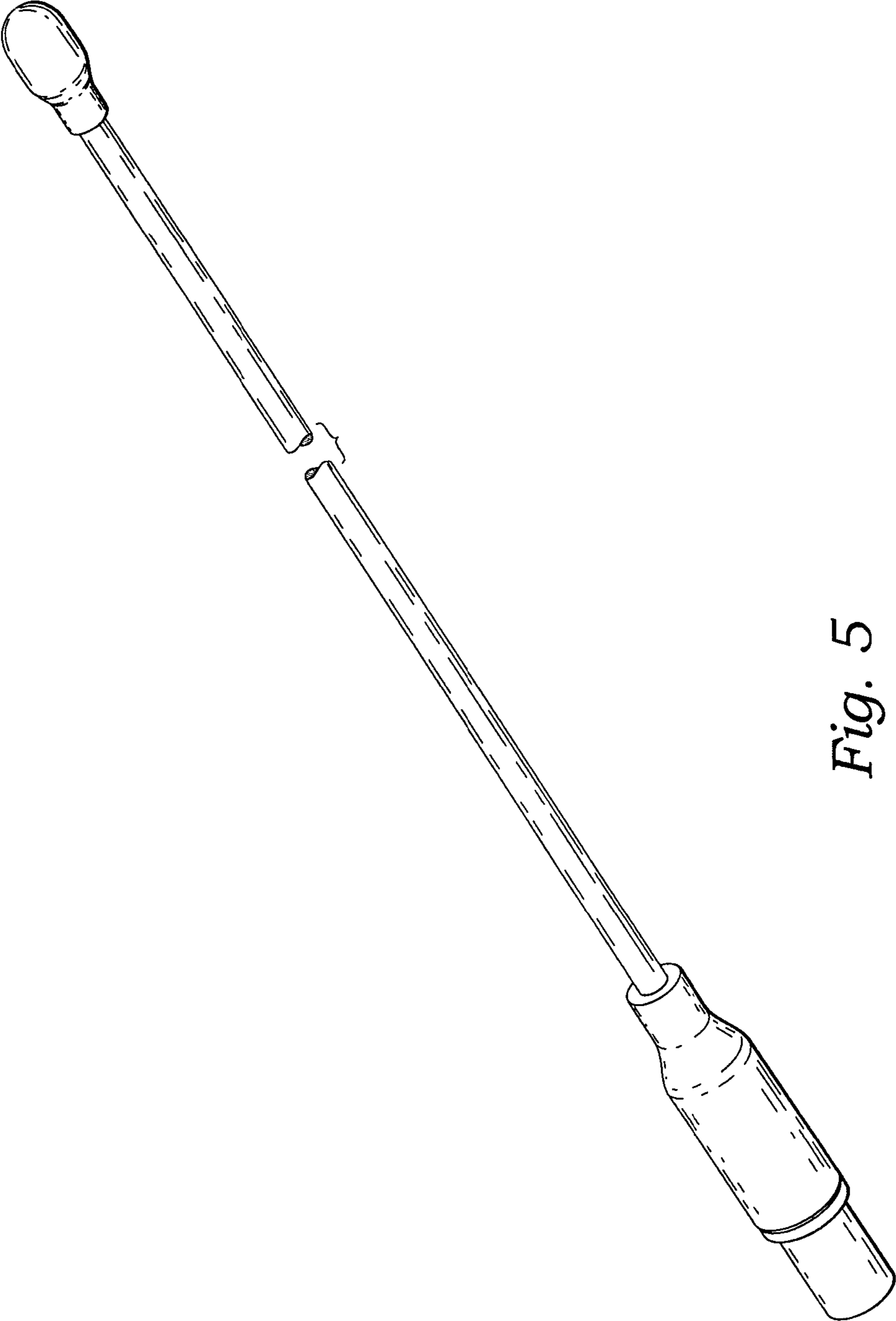

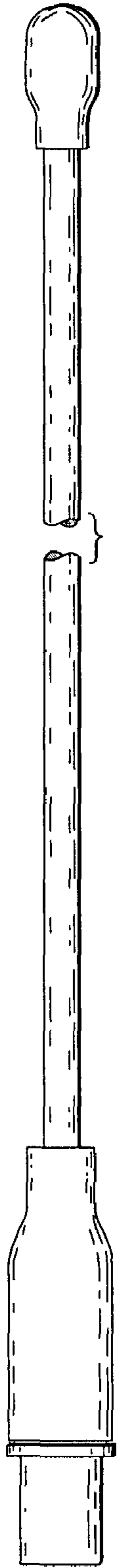
