(57) **CLAIM**

The ornamental design for a sanitary napkin with embossment pattern, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sanitary napkin with embossment pattern embodying my new design;

FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof;

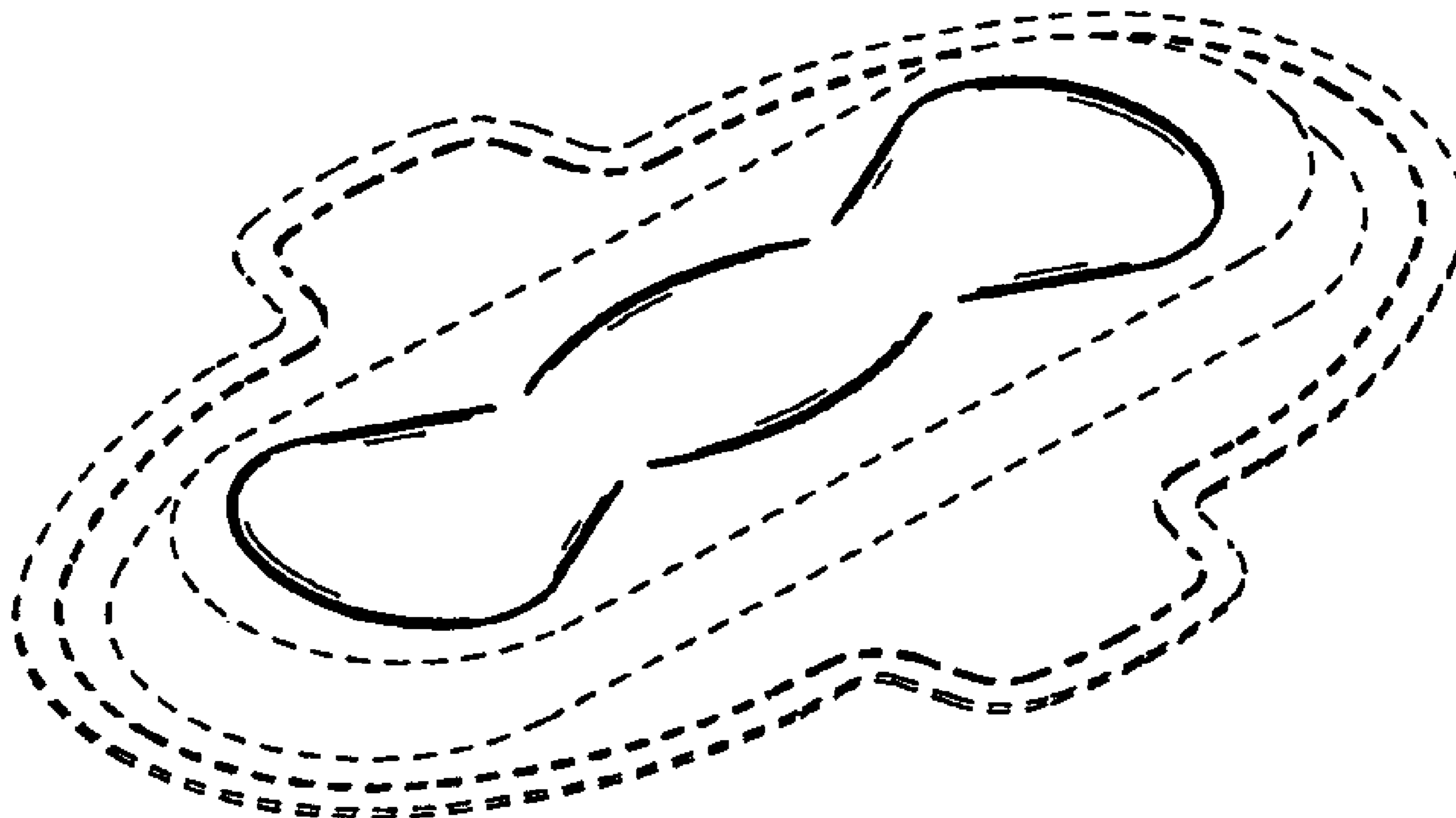
FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof; and,

FIG. 5 is a right side elevational view thereof, the left side being a mirror image thereof.

The broken line showing of the sanitary napkin with embossment pattern in FIGS. 1 through 5 is illustrative of the environmental structure only and forms no part of the claimed design.

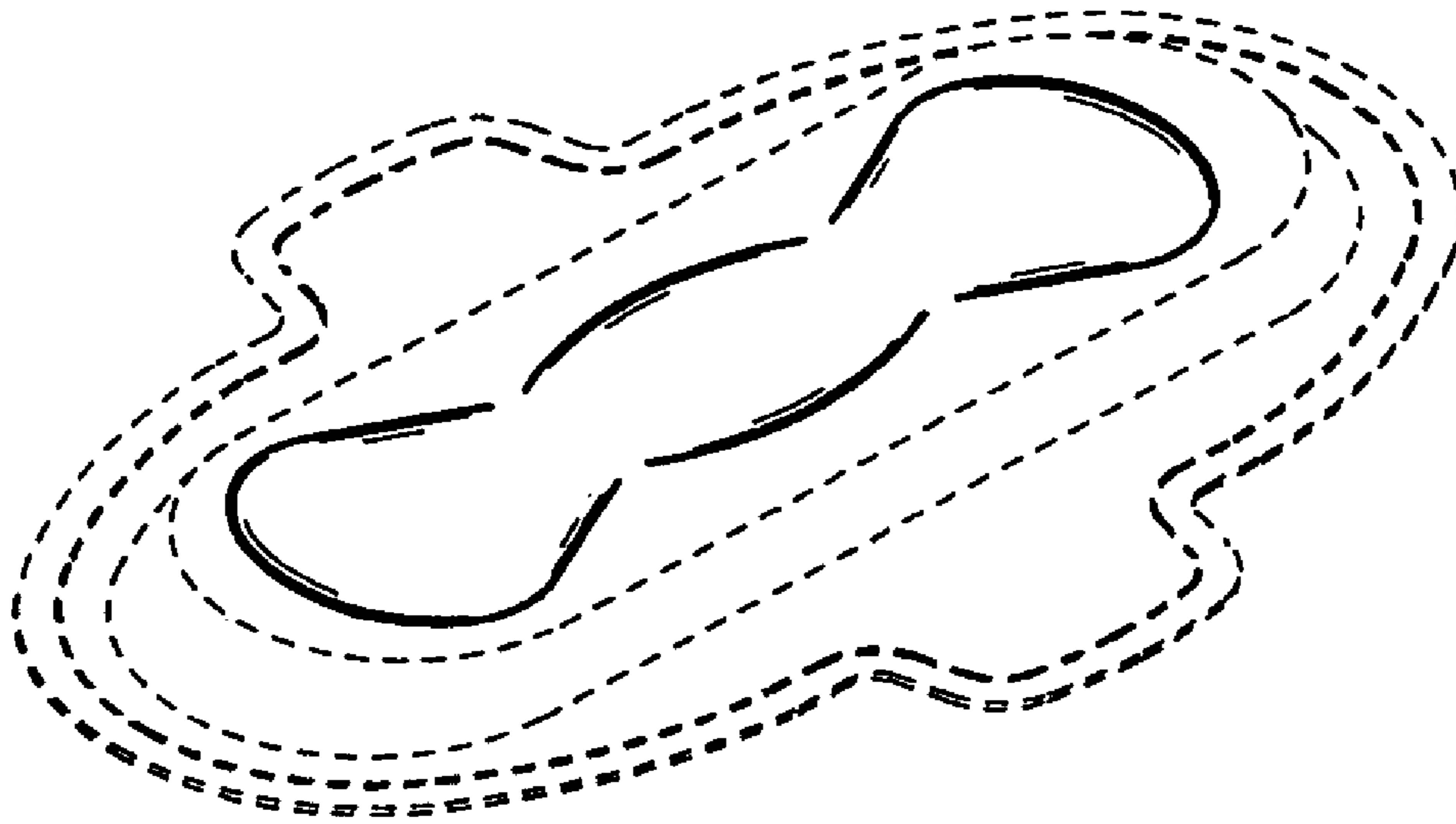

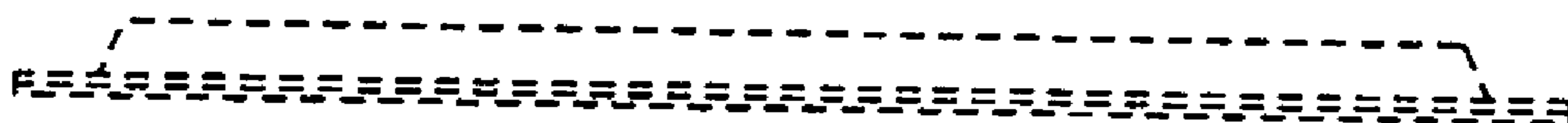

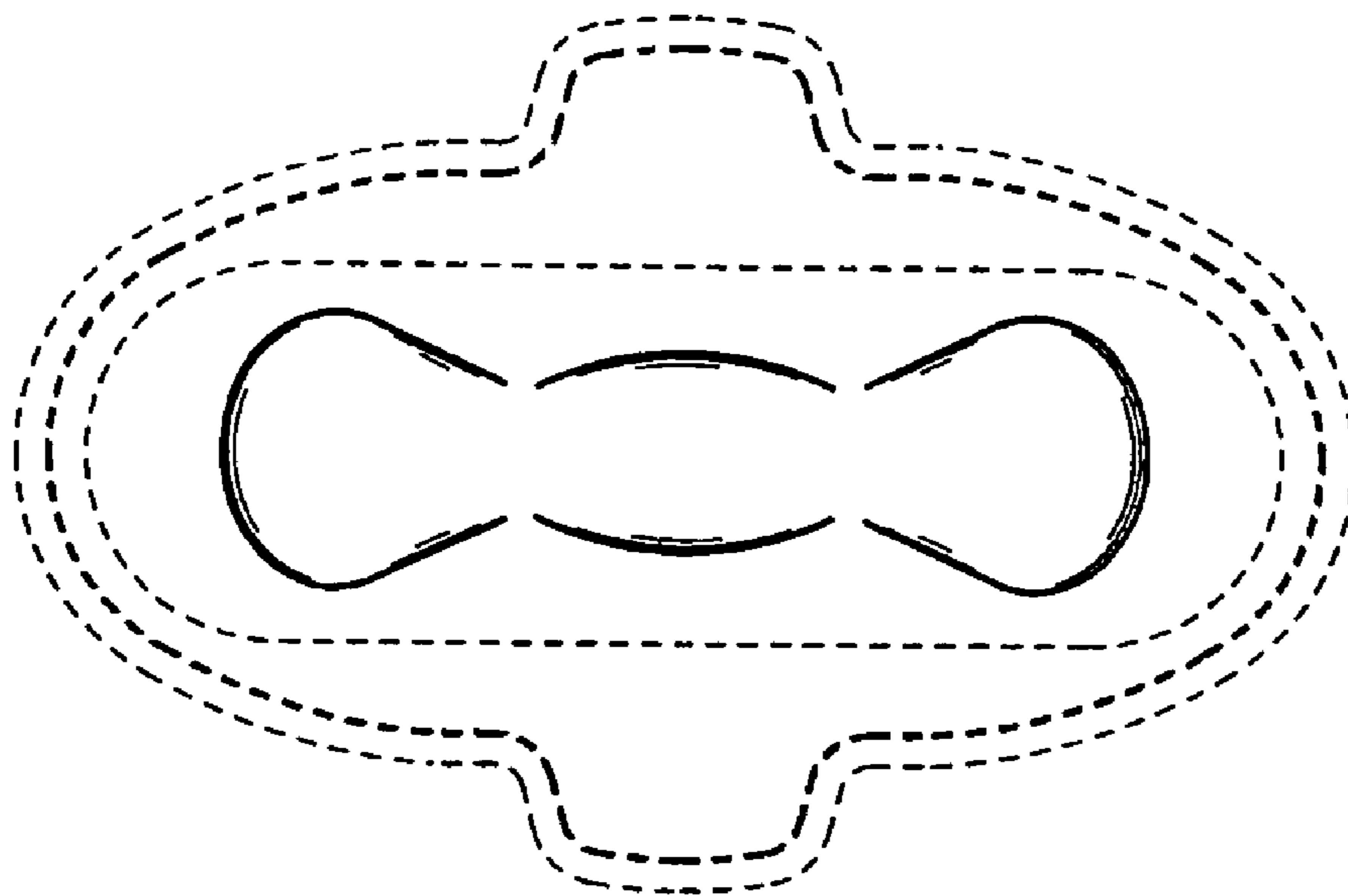

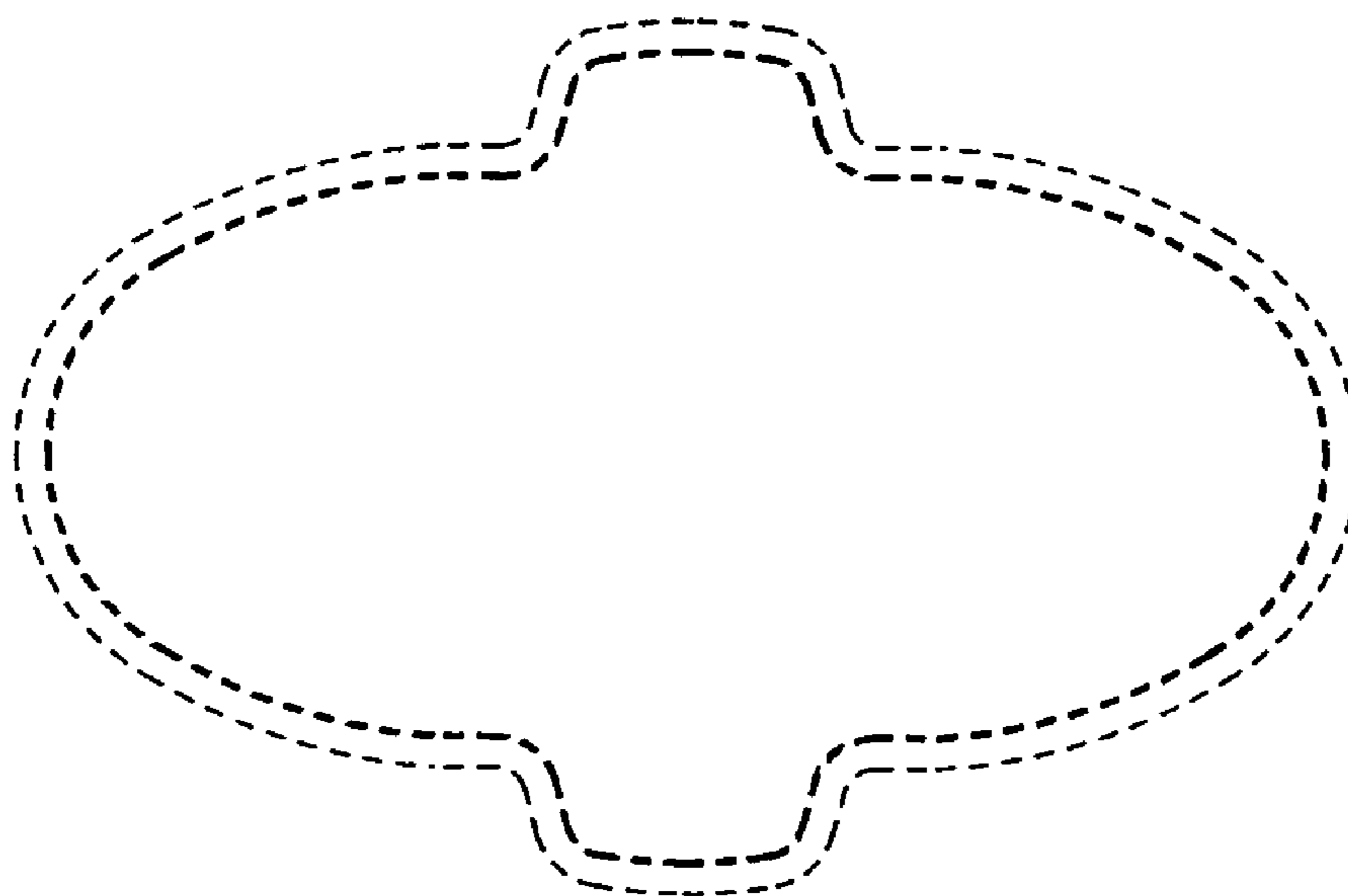
