(57) **CLAIM**

The ornamental design for a helmet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a helmet, showing my new design;

FIG. 2 is a bottom perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a perspective view similar to FIG. 1 with the visor removed;

FIG. 5 is a side elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is an opposite side elevational view thereof;

FIG. 8 is a front elevational view of the outer component of the helmet of FIGS. 1-7;

FIG. 9 is a bottom plan view thereof;

FIG. 10 is a rear elevational view thereof;

FIG. 11 is a top perspective view thereof;

FIG. 12 is a side elevational view thereof, the opposite side being identical;

FIG. 13 is a front elevational view of the inner component of the helmet of FIGS. 1-7;

FIG. 14 is a side elevational view thereof, the opposite side being identical;

FIG. 15 is a perspective view thereof;

FIG. 16 is a rear elevational view thereof;

FIG. 17 is a top perspective view thereof; and,

FIG. 18 is a bottom perspective view thereof.

FIGS. 8-12 (without the goggles) and 13-18 (without the face shield) are shown separately from FIGS. 1-7 for clarity of illustration only. The claim is directed to the entire combination shown in FIGS. 1-7.

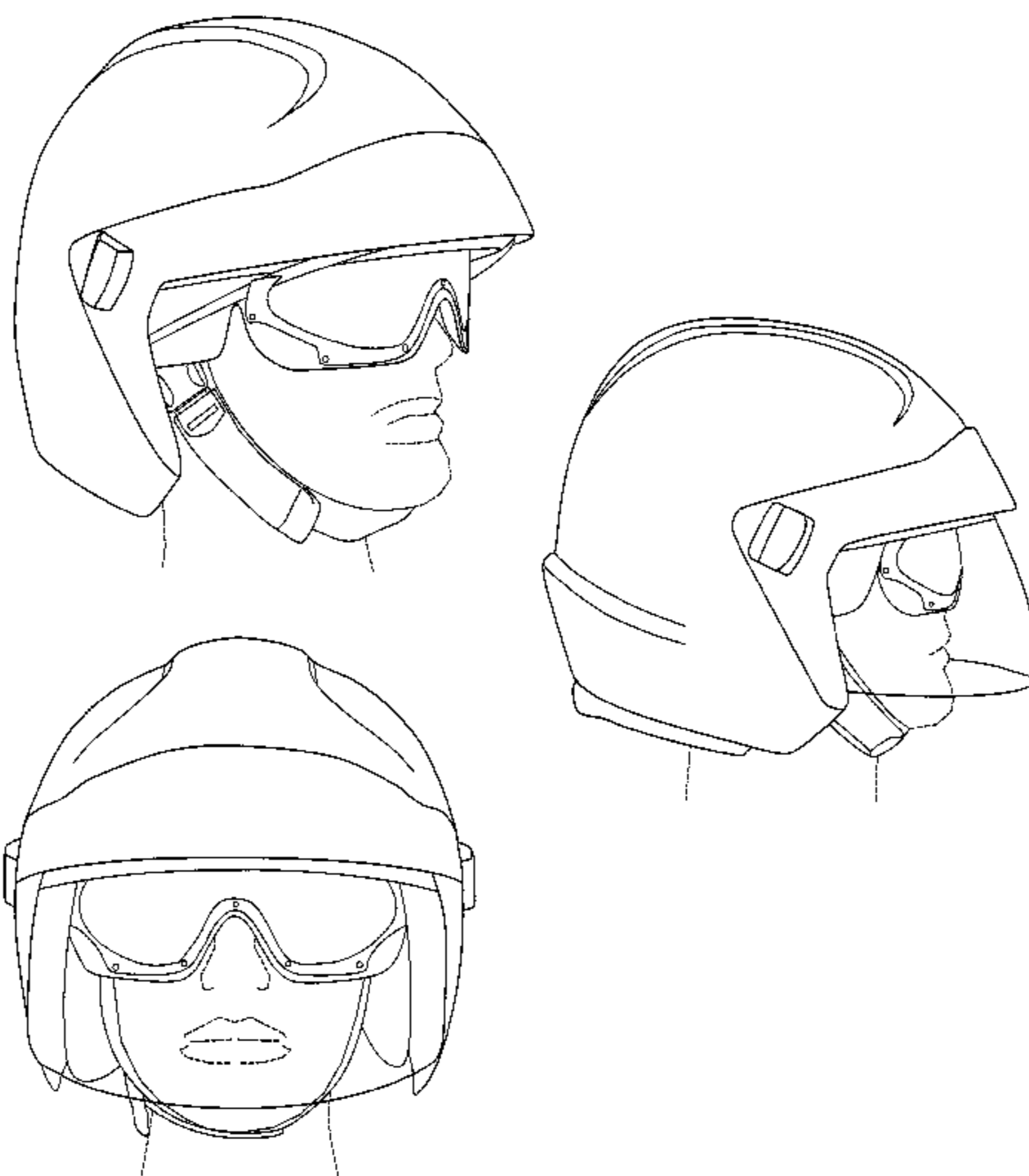

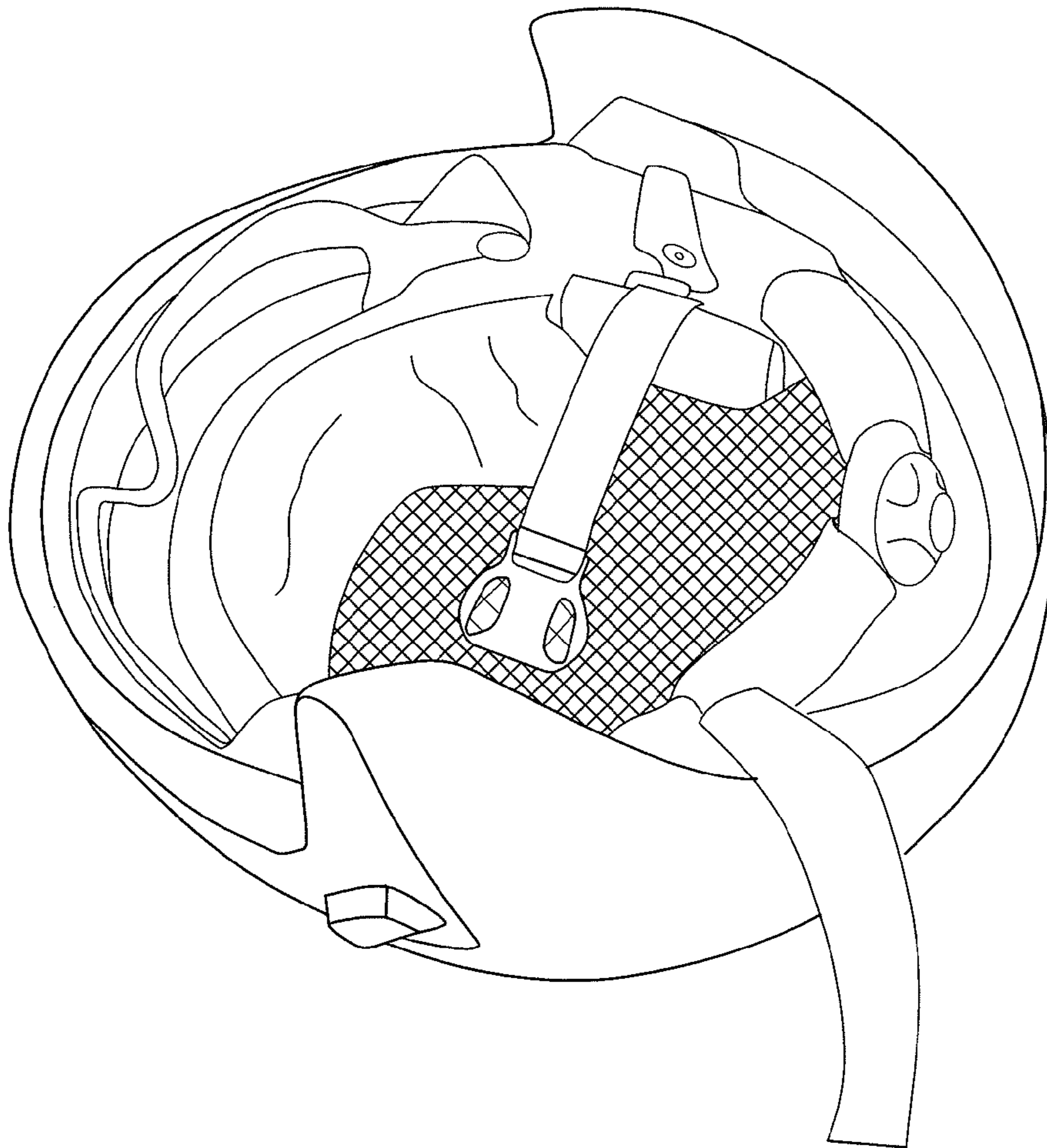

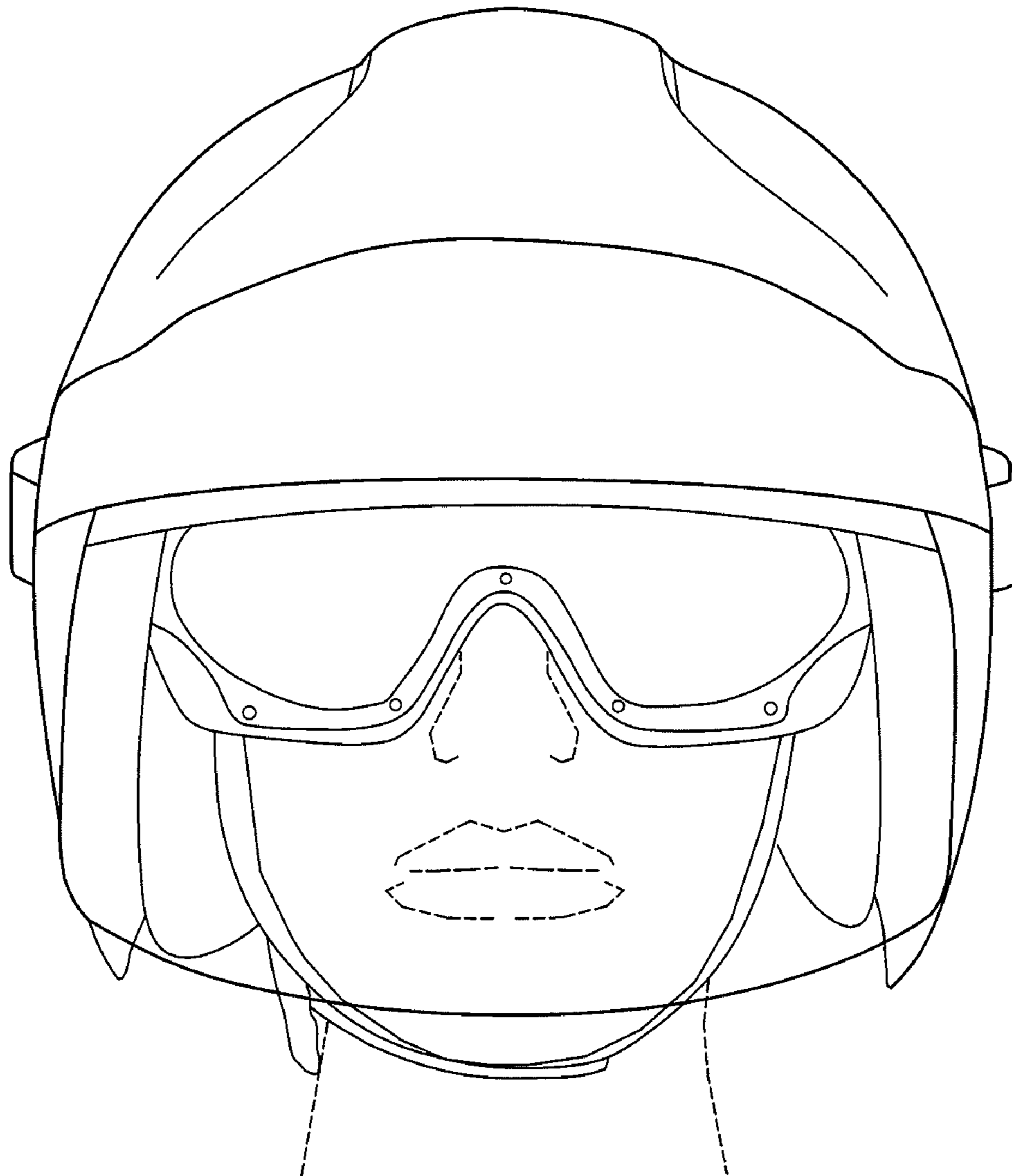

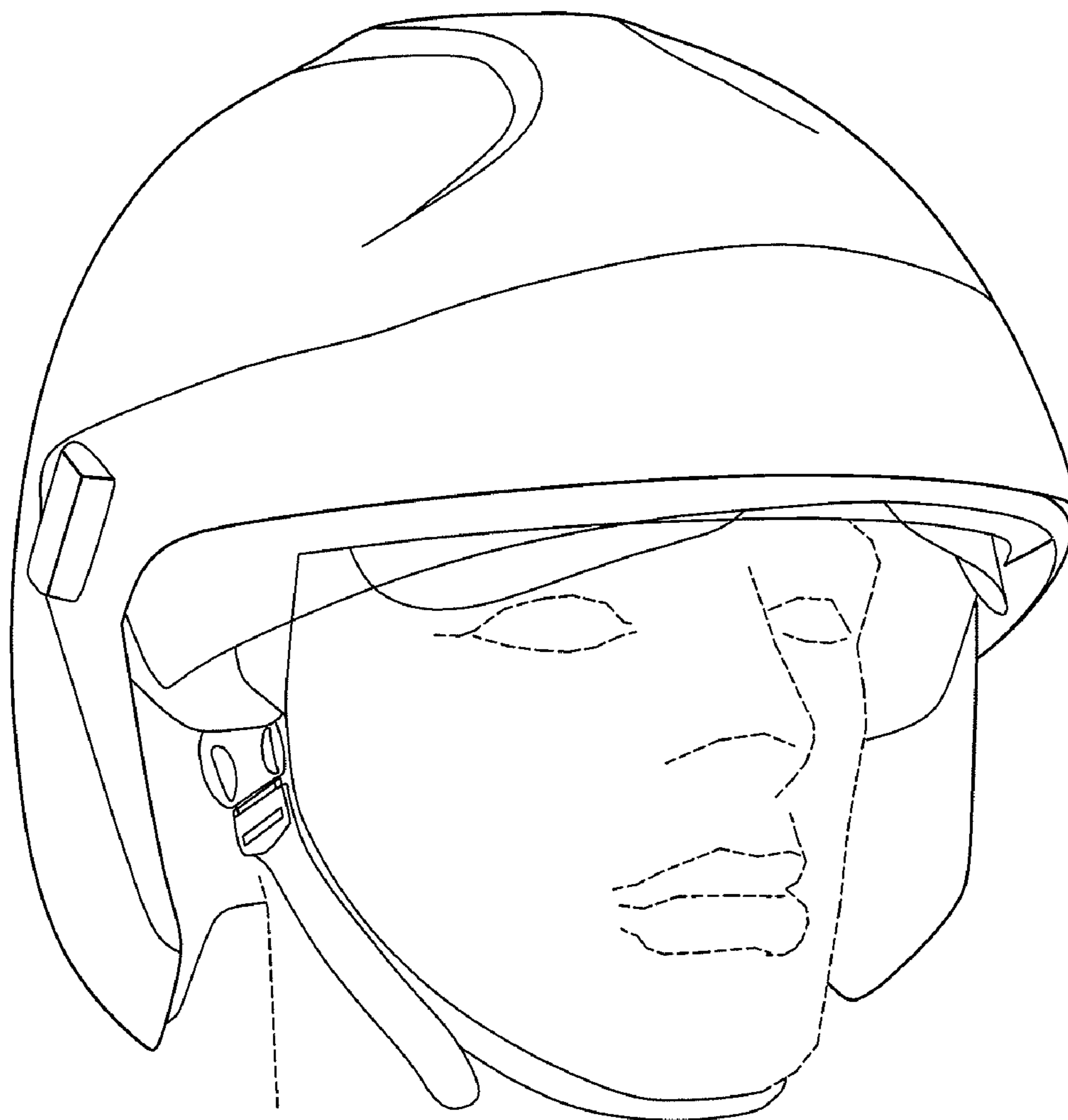

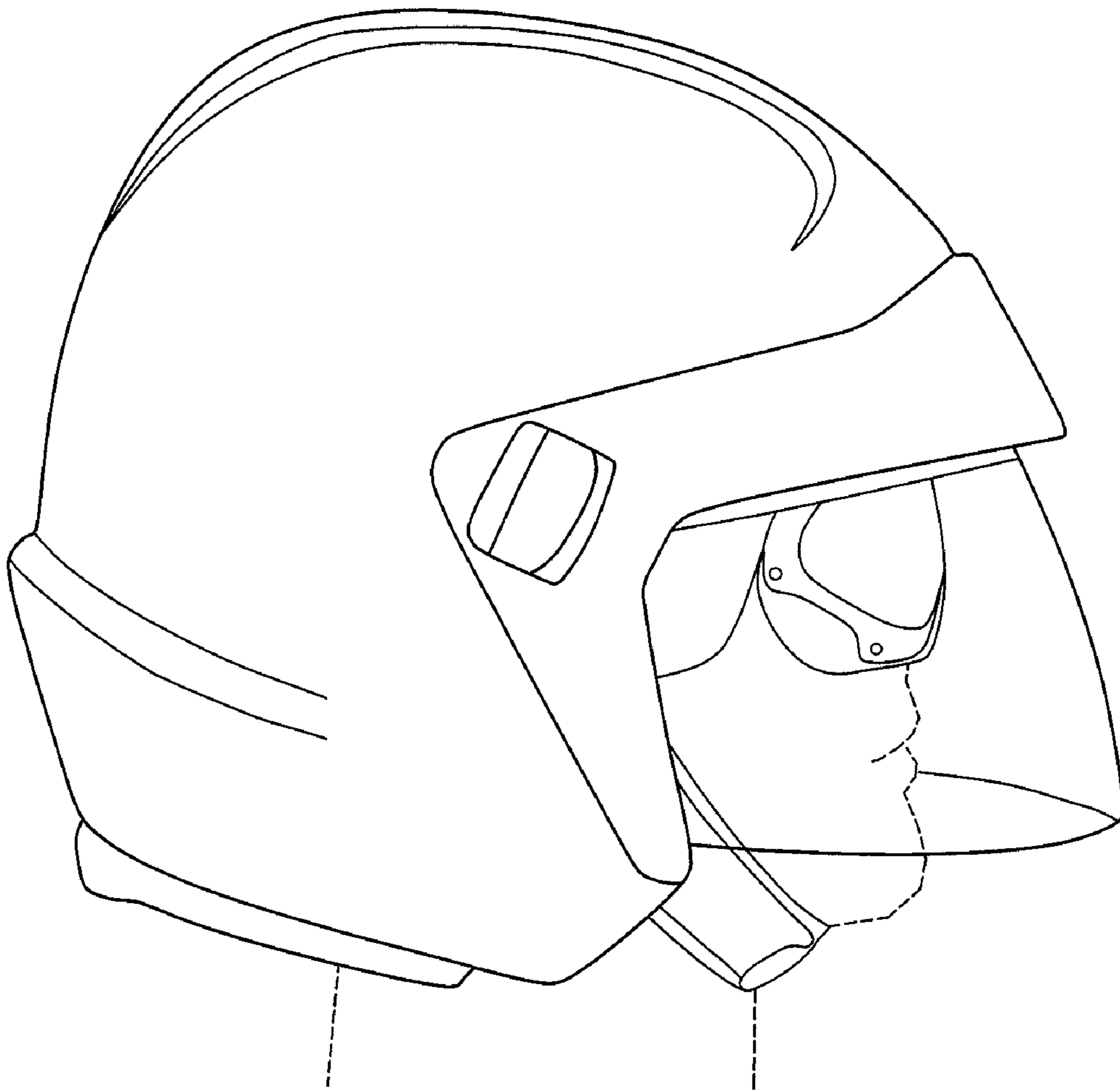

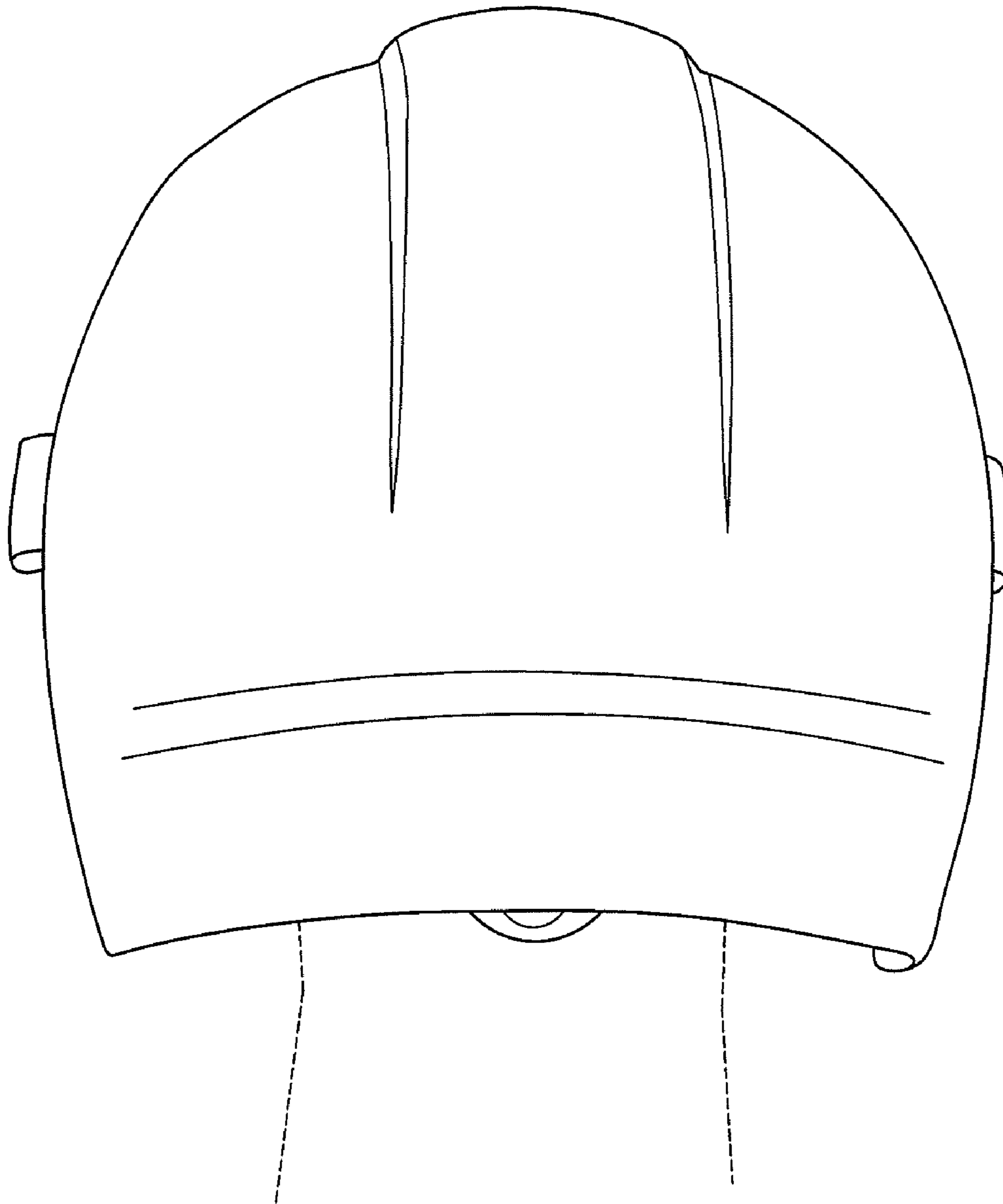

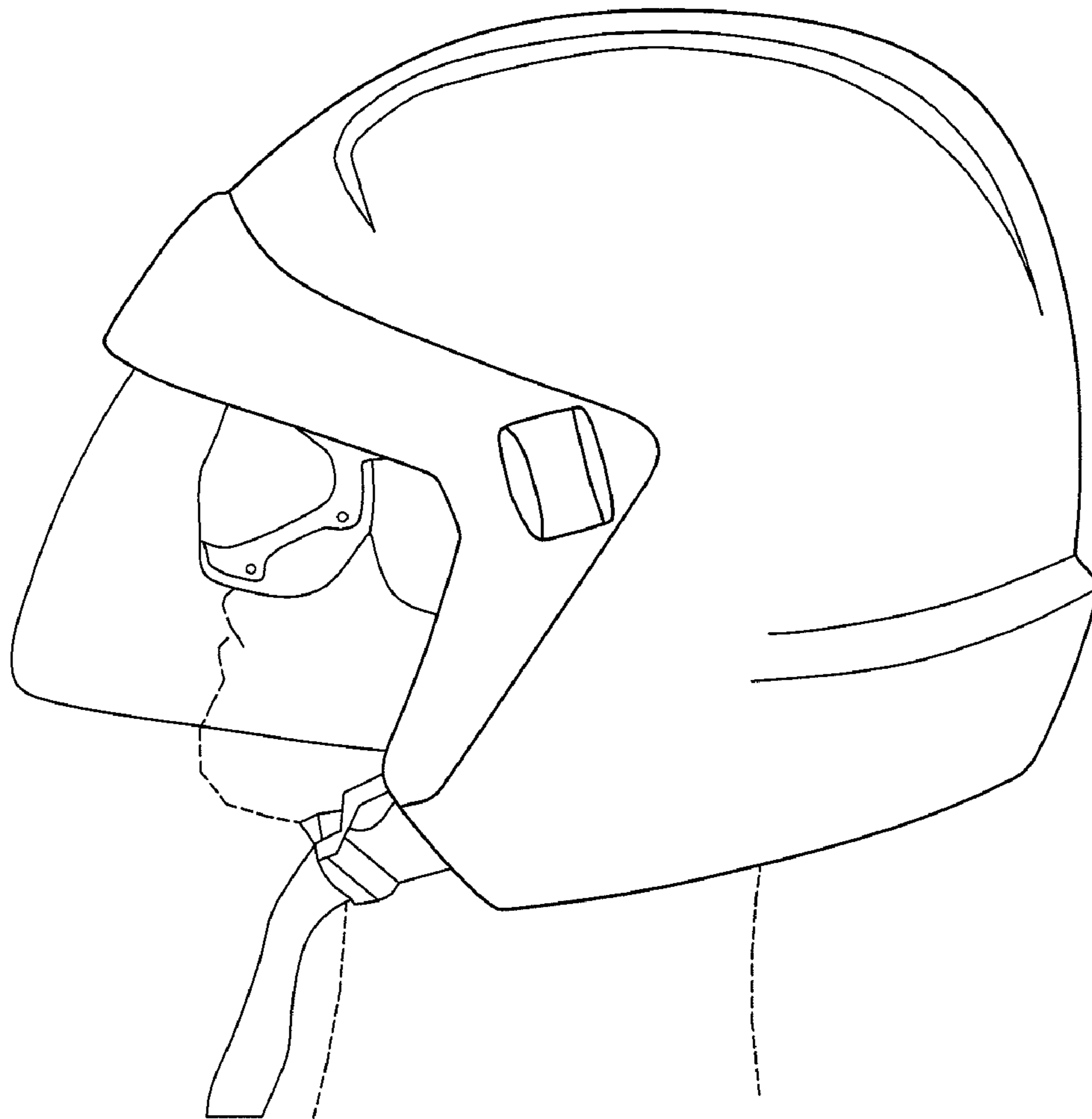

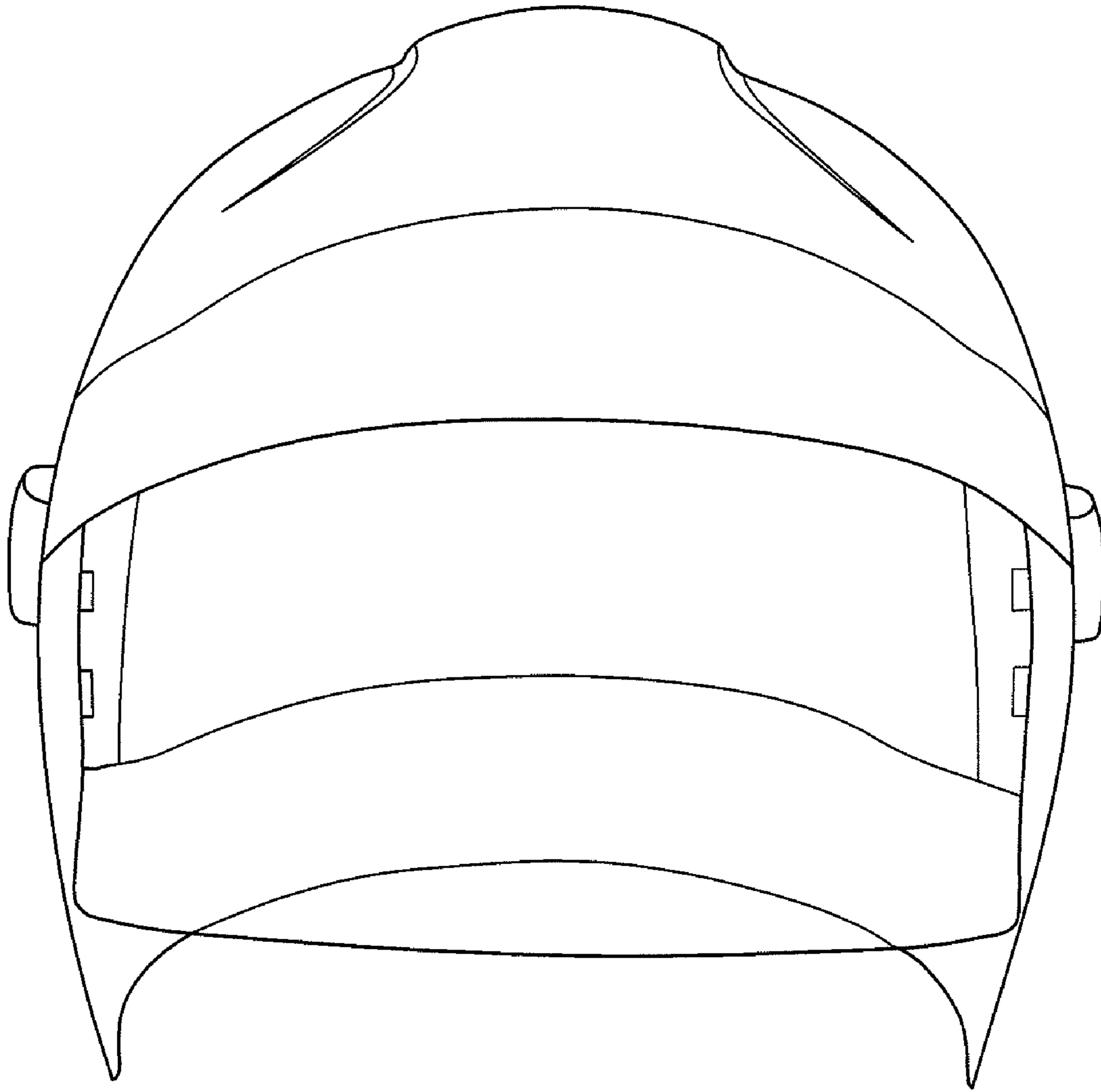

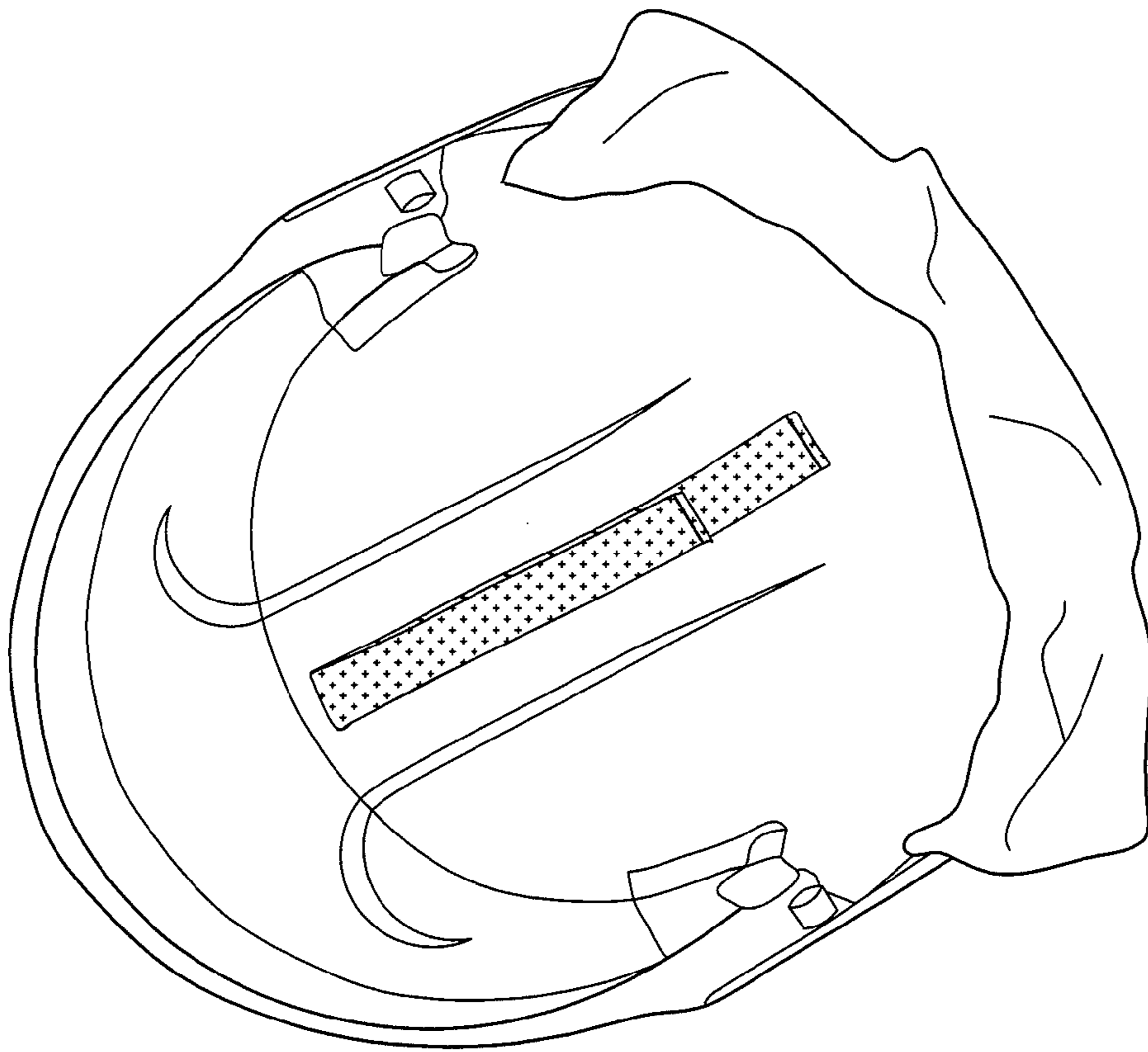

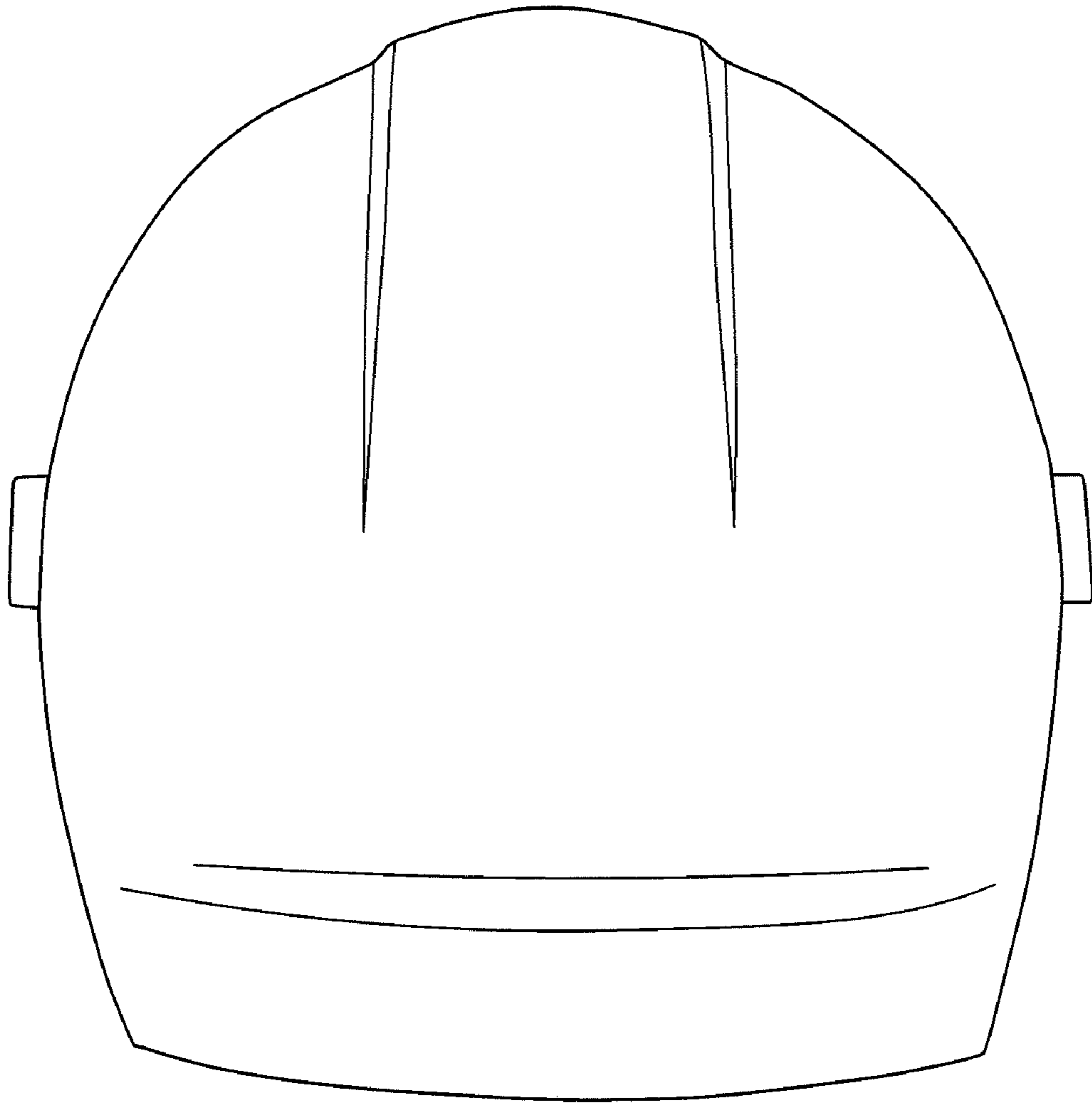

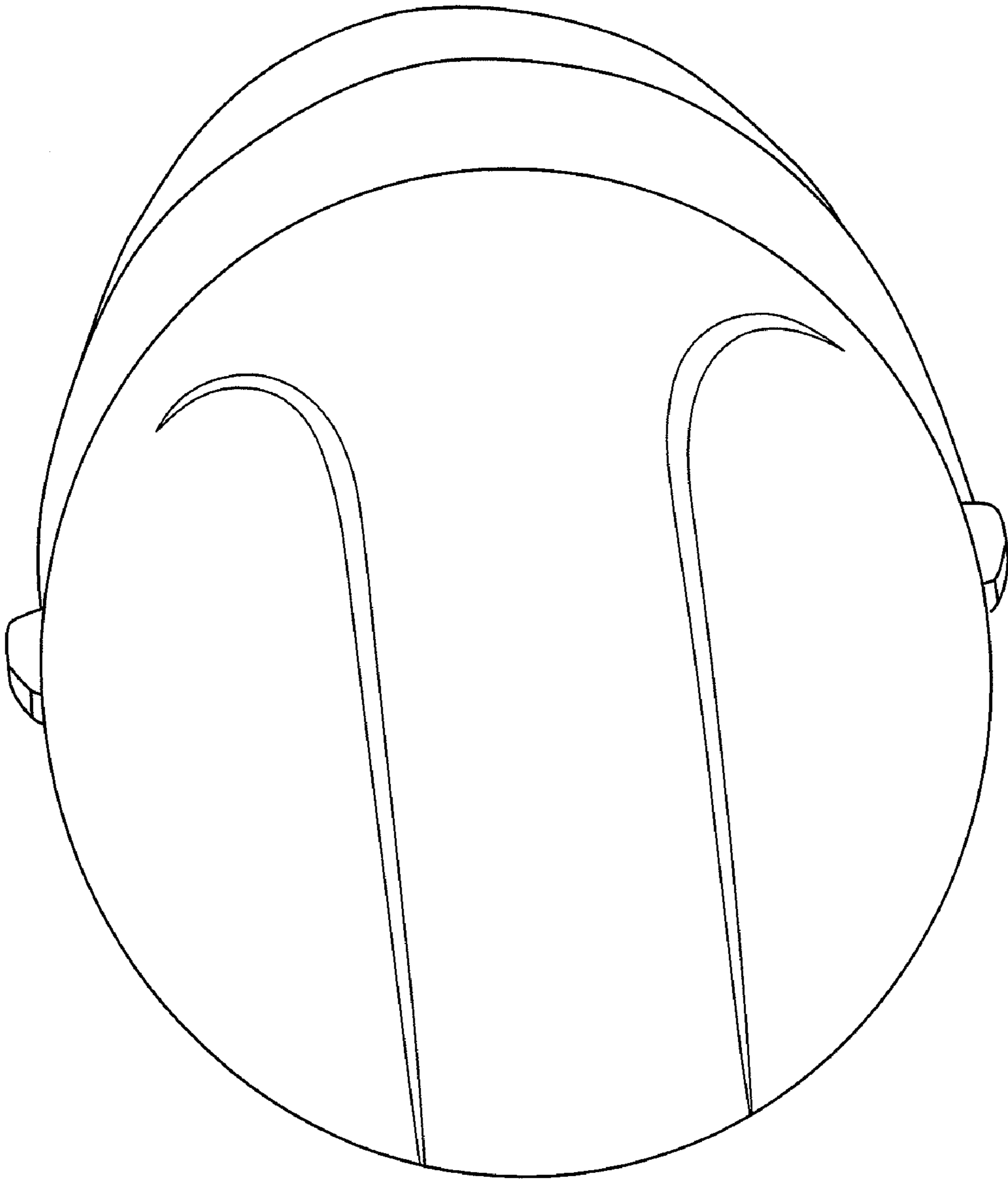

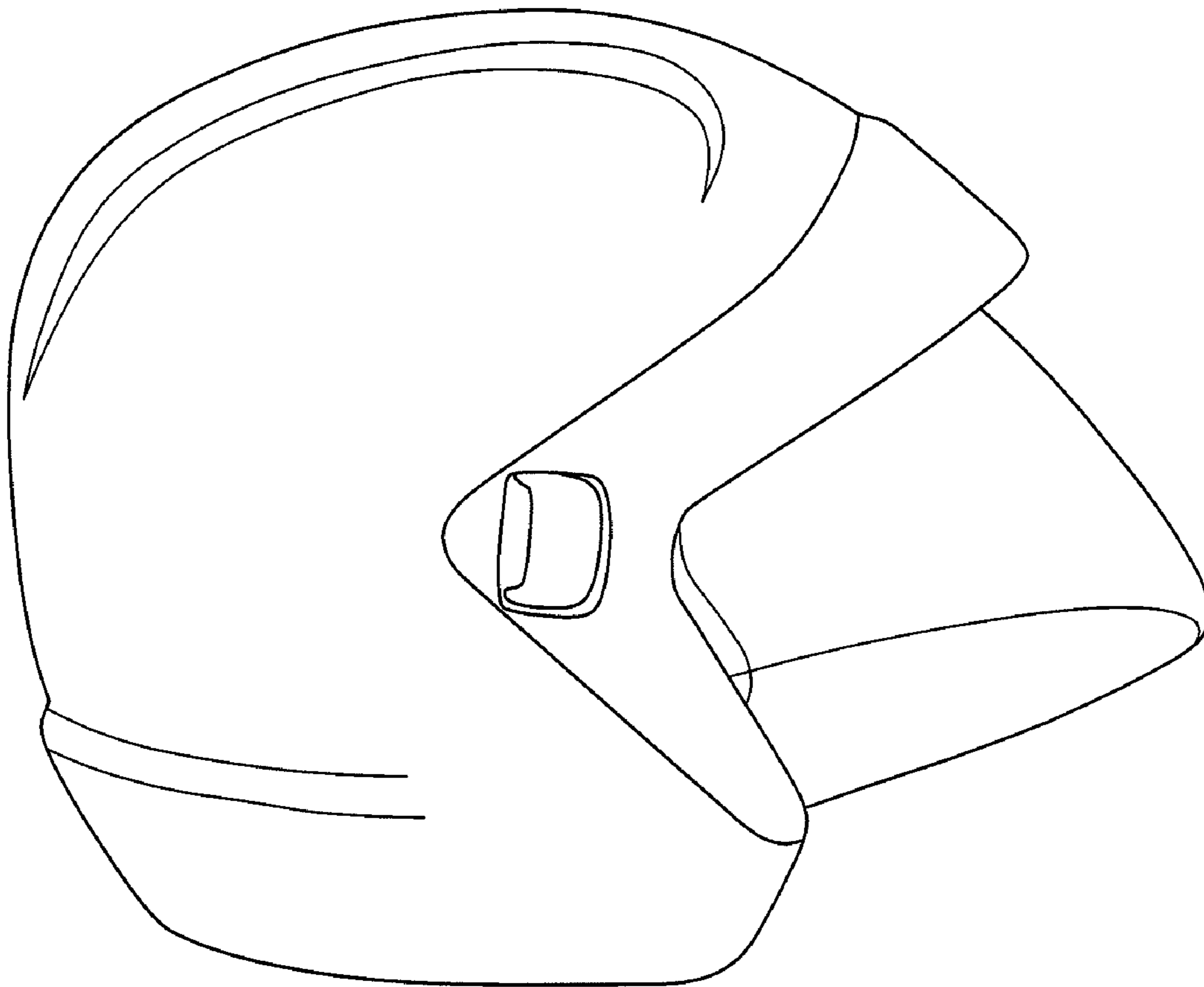

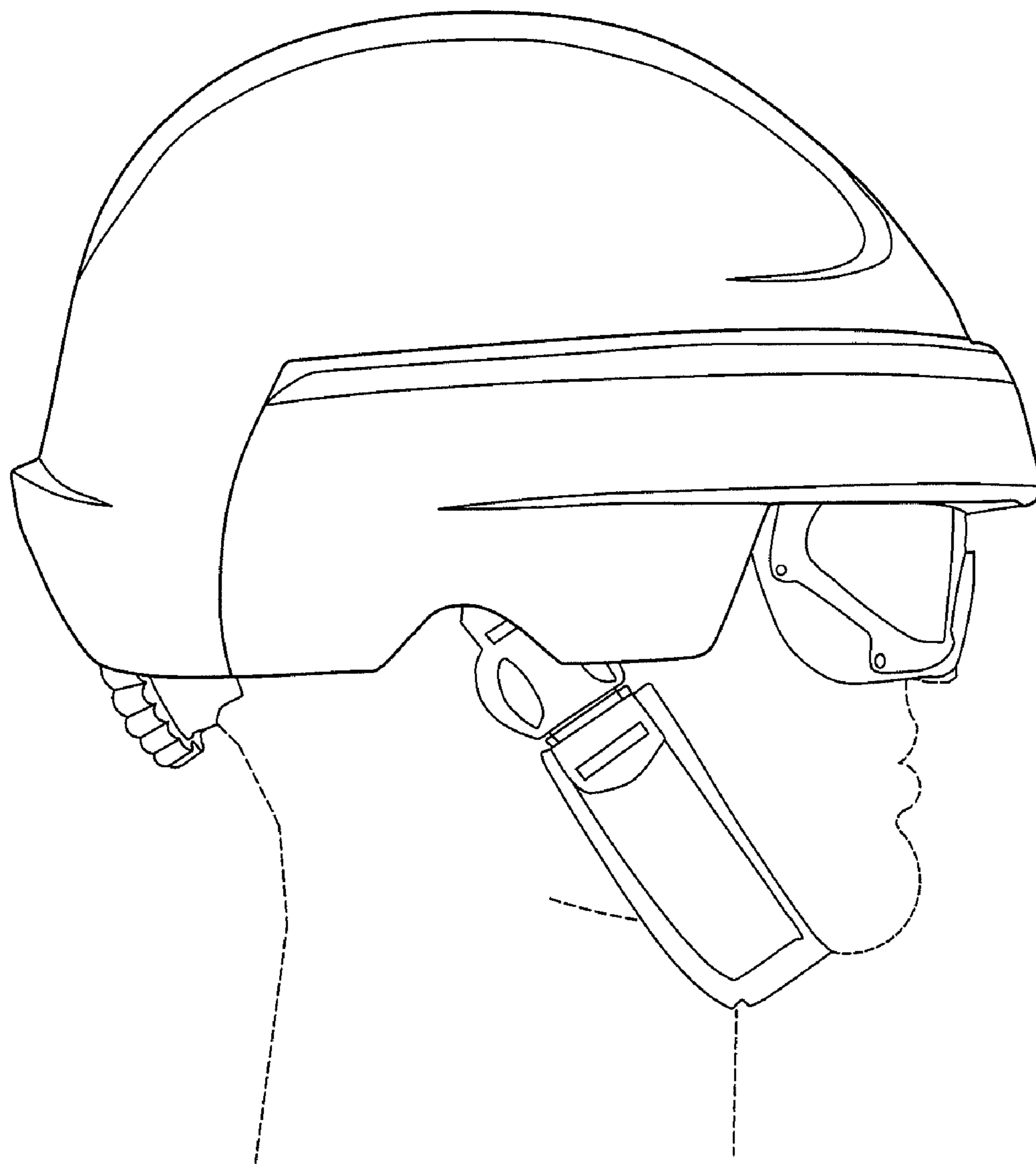

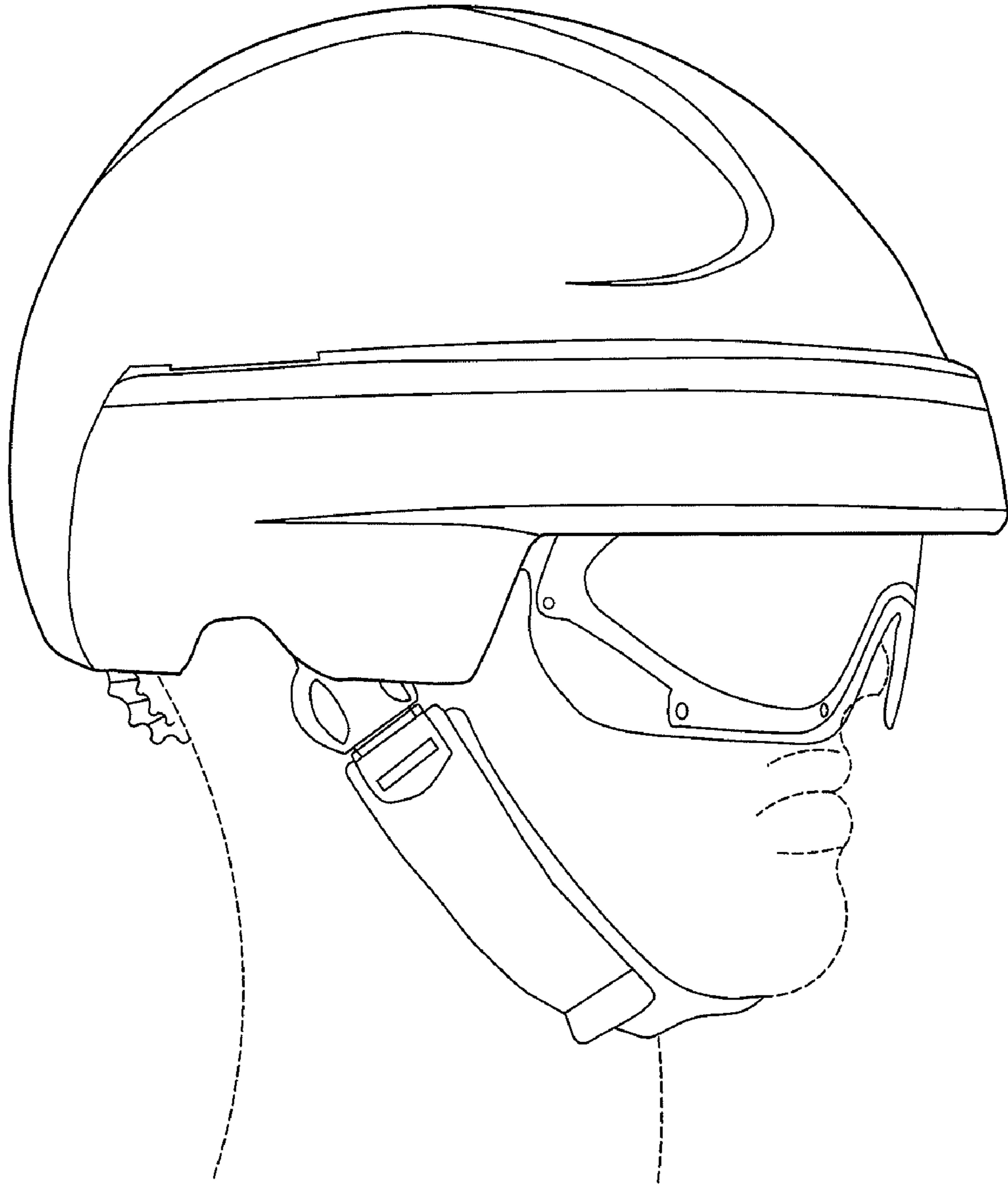

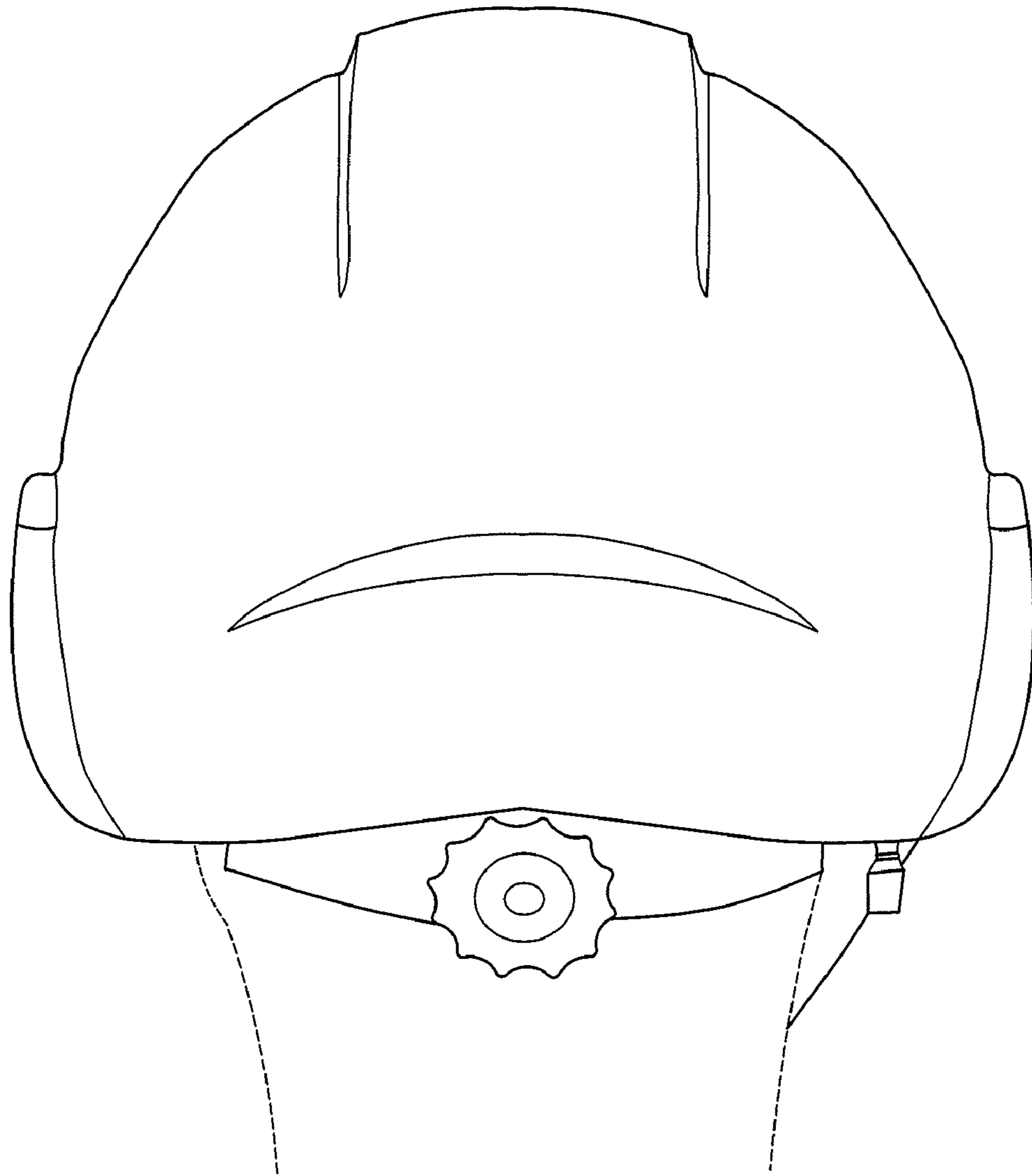

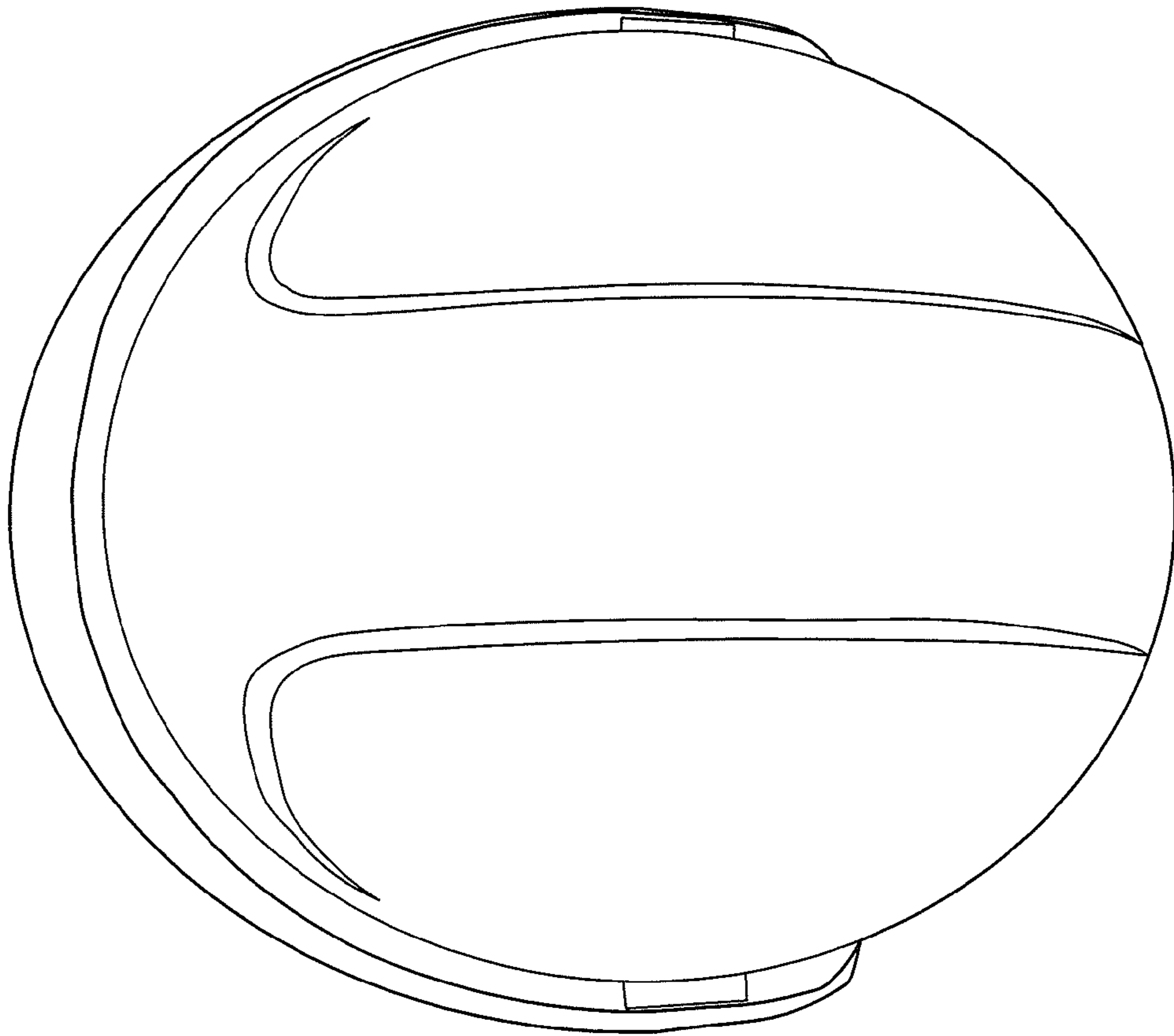

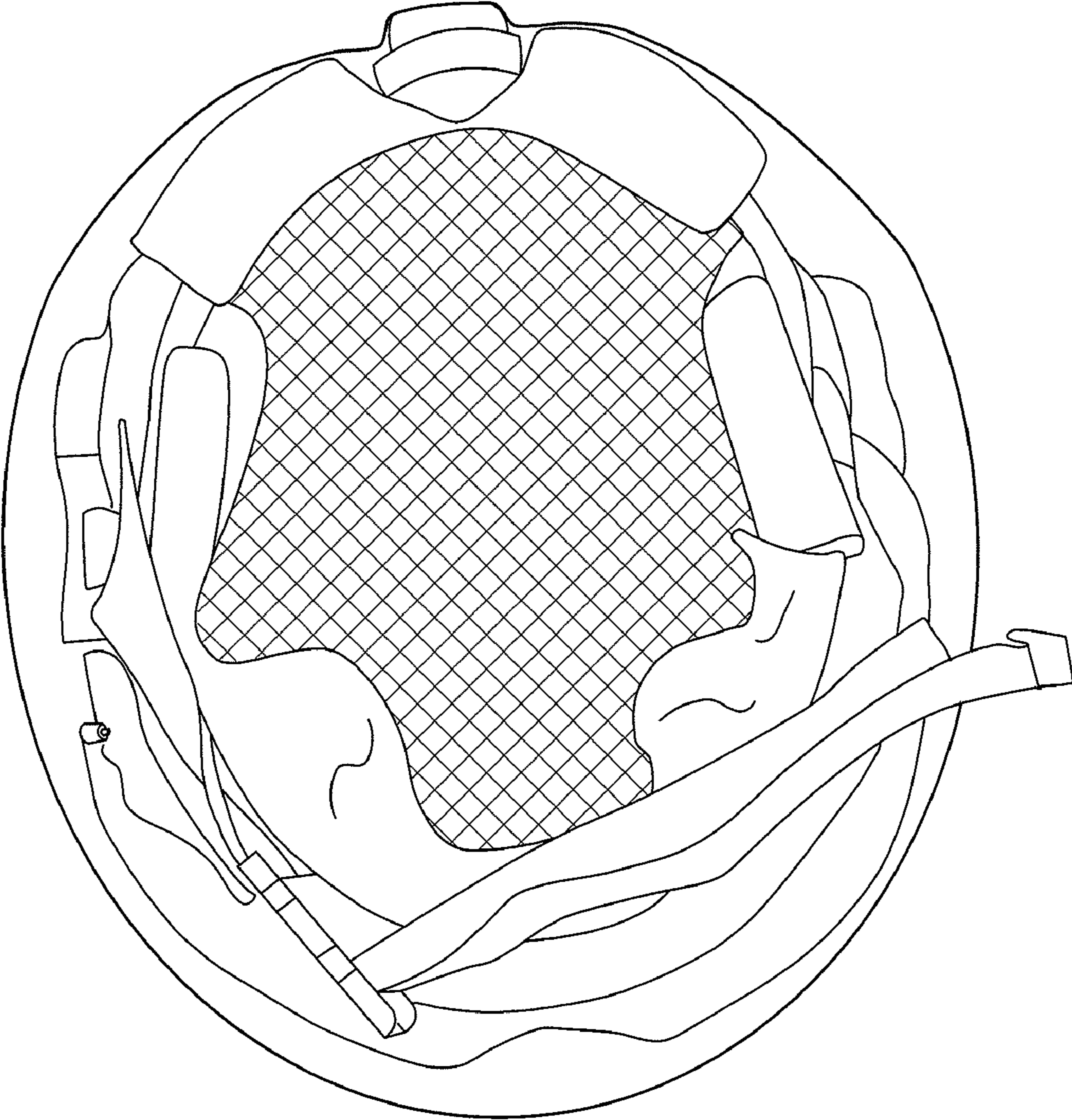
