DESCRIPTION

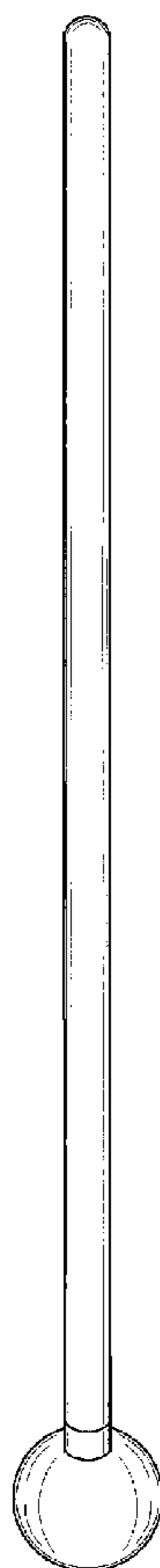
FIG. 1 is a front elevation view of a scuff remover device showing my new design;

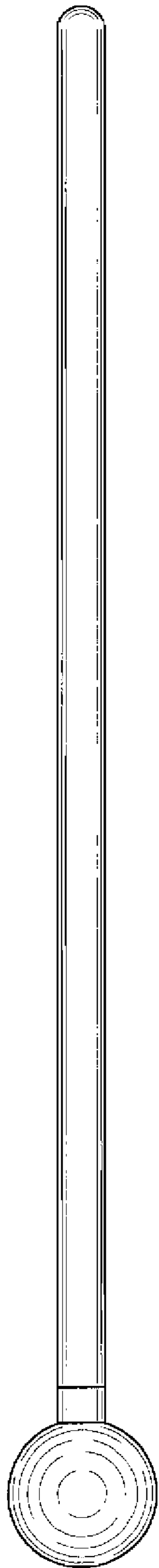

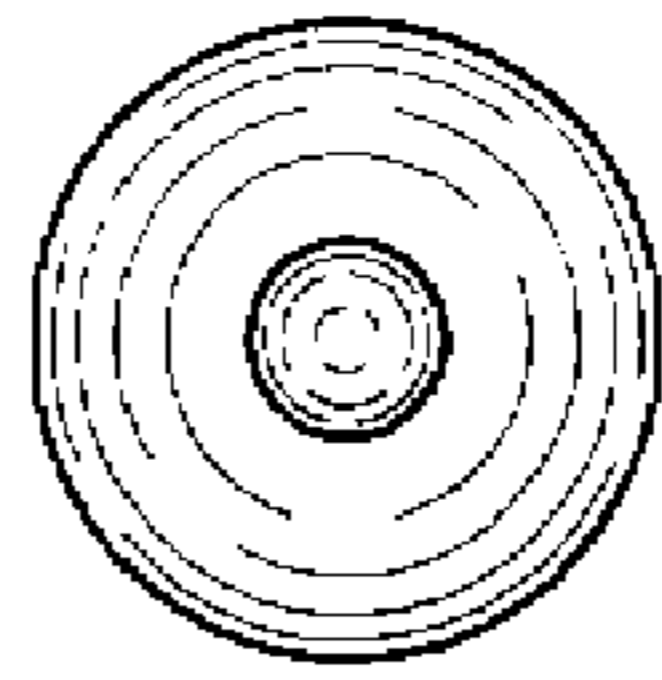

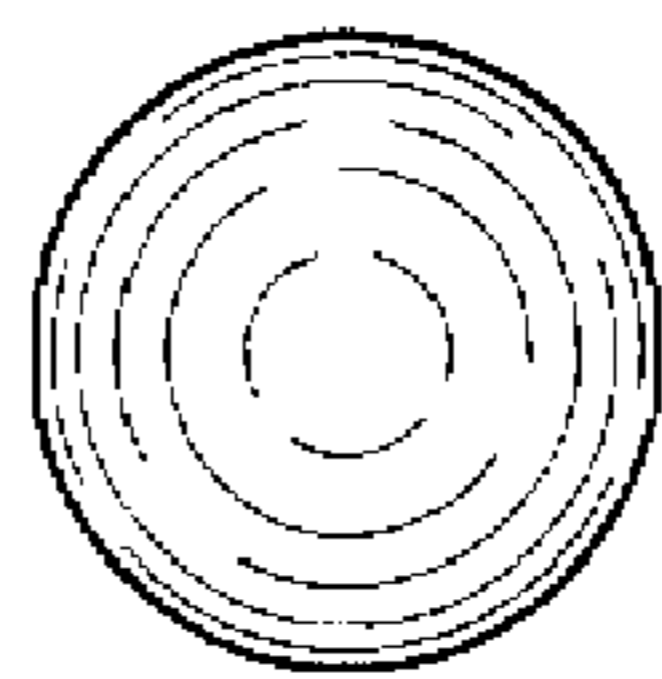

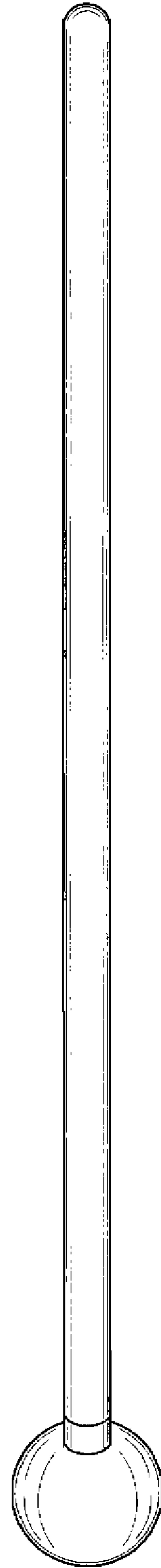
