(57) **CLAIM**

The ornamental design for a steam iron, as shown and described.

DESCRIPTION

FIG. 1 is a front, left, top perspective view of a steam iron, showing our new design in a closed heel position;

FIG. 2 is a front, left, top perspective view thereof, in an alternate, opened heel position;

FIG. 3 is a rear, left, top perspective view thereof, in the opened heel position;

FIG. 4 is a left view thereof; in the closed heel position;

FIG. 5 is a left view thereof, in the opened heel position;

FIG. 6 is a right view thereof, in the closed heel position;

FIG. 7 is a right view thereof, in the opened heel position;

FIG. 8 is a front view thereof, in the closed heel position;

FIG. 9 is a front view thereof, in the opened heel position;

FIG. 11 is a rear view thereof; in the opened heel position;

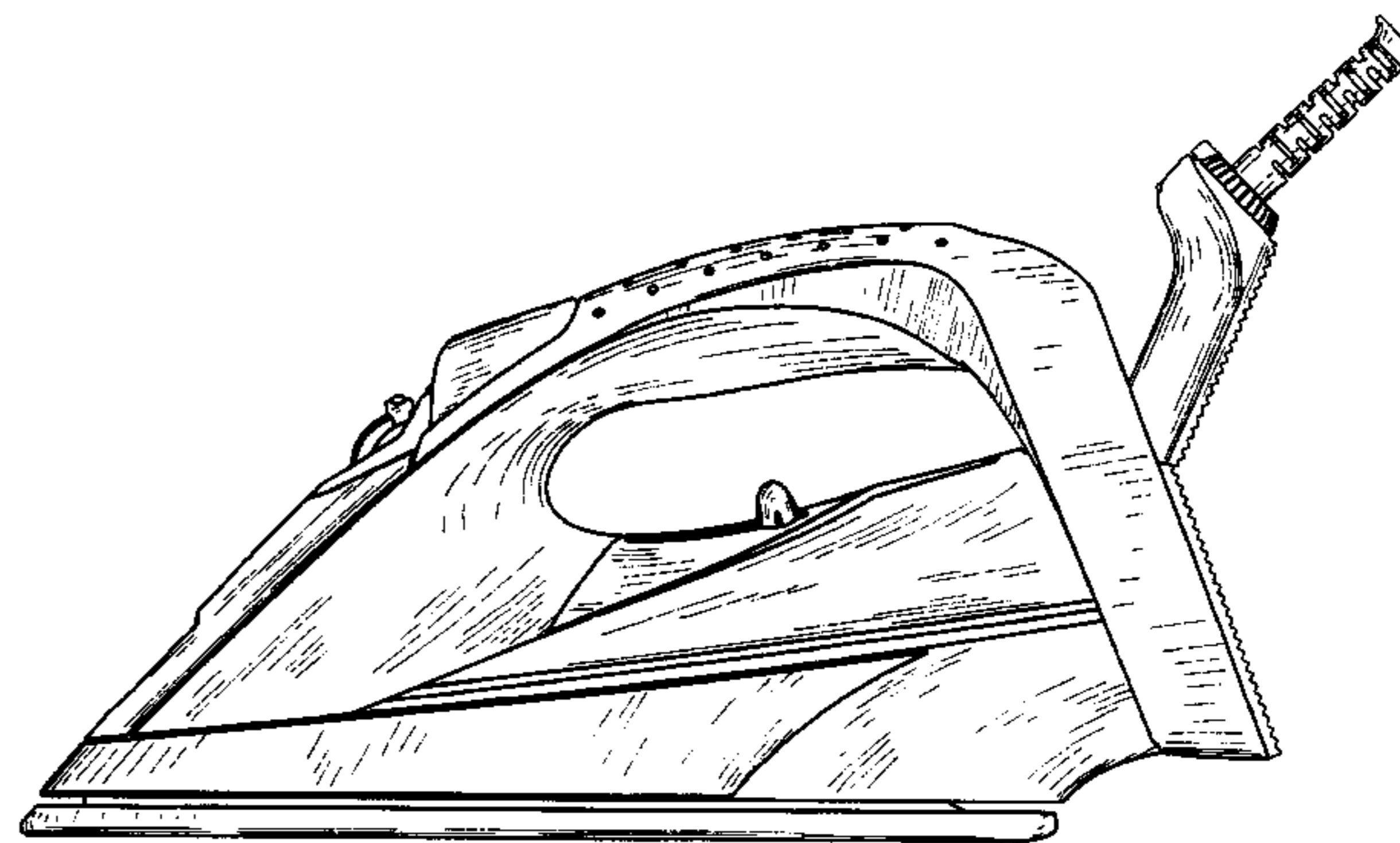
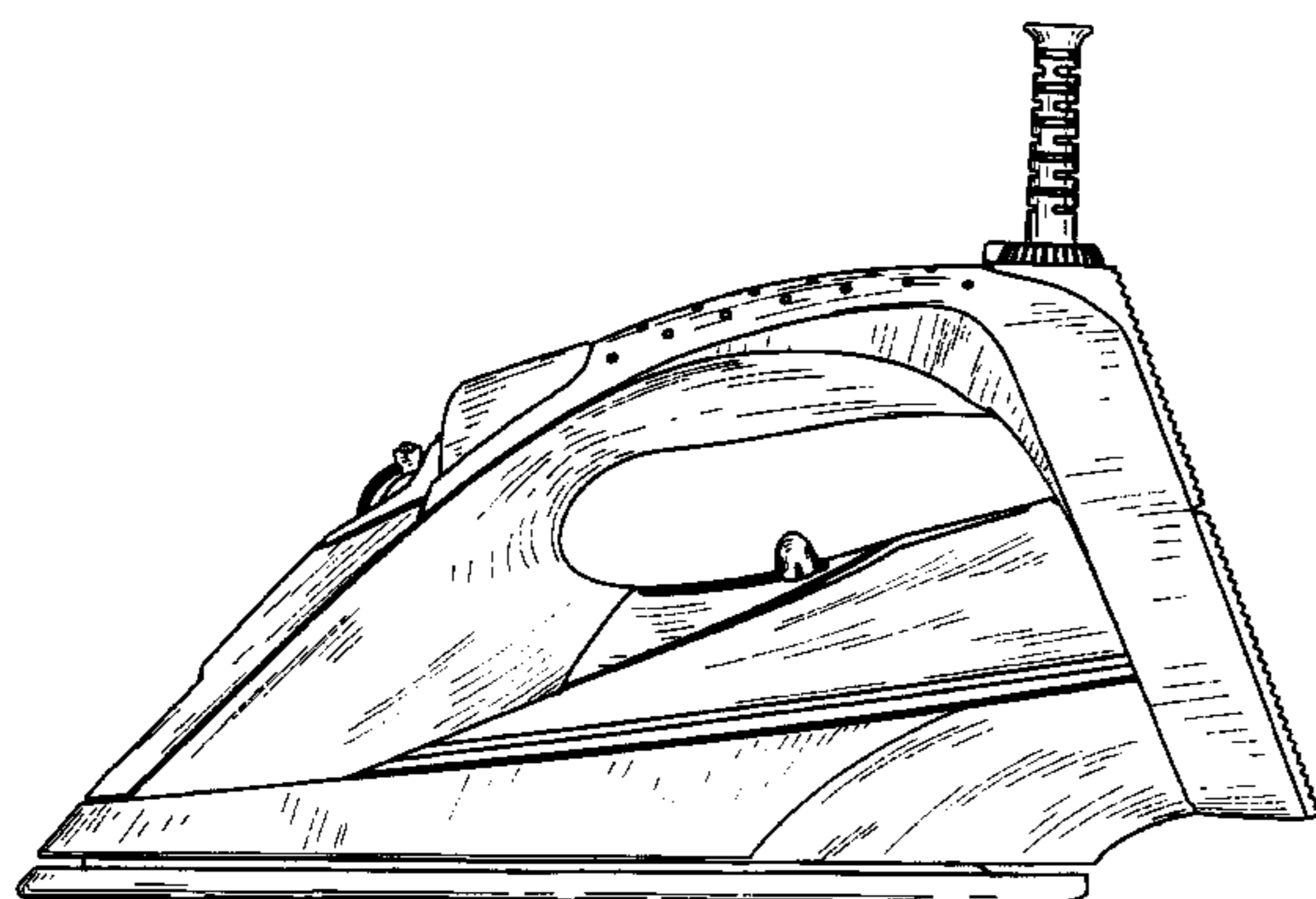
FIG. 12 is a top plan view thereof, in the closed heel position;

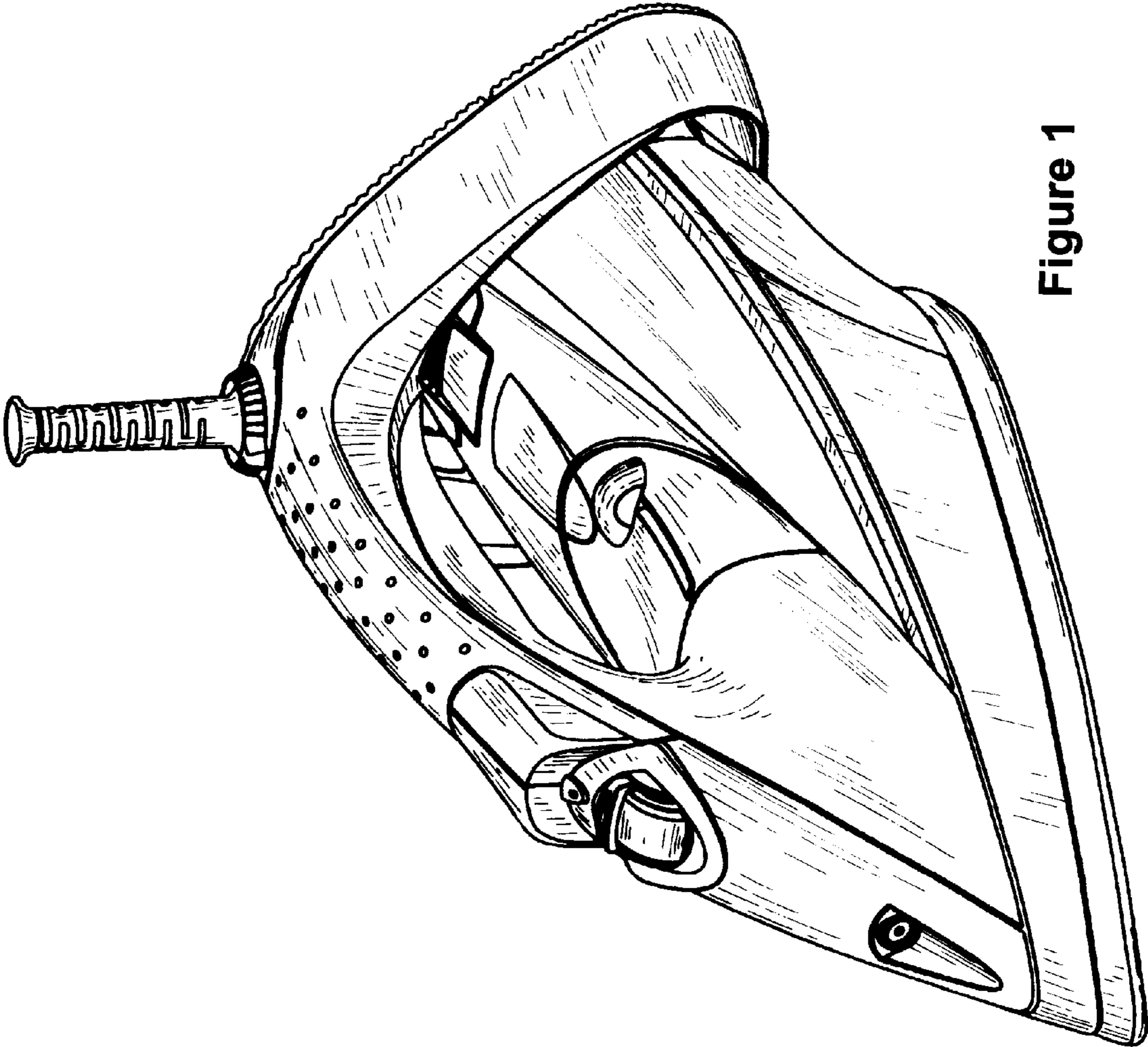

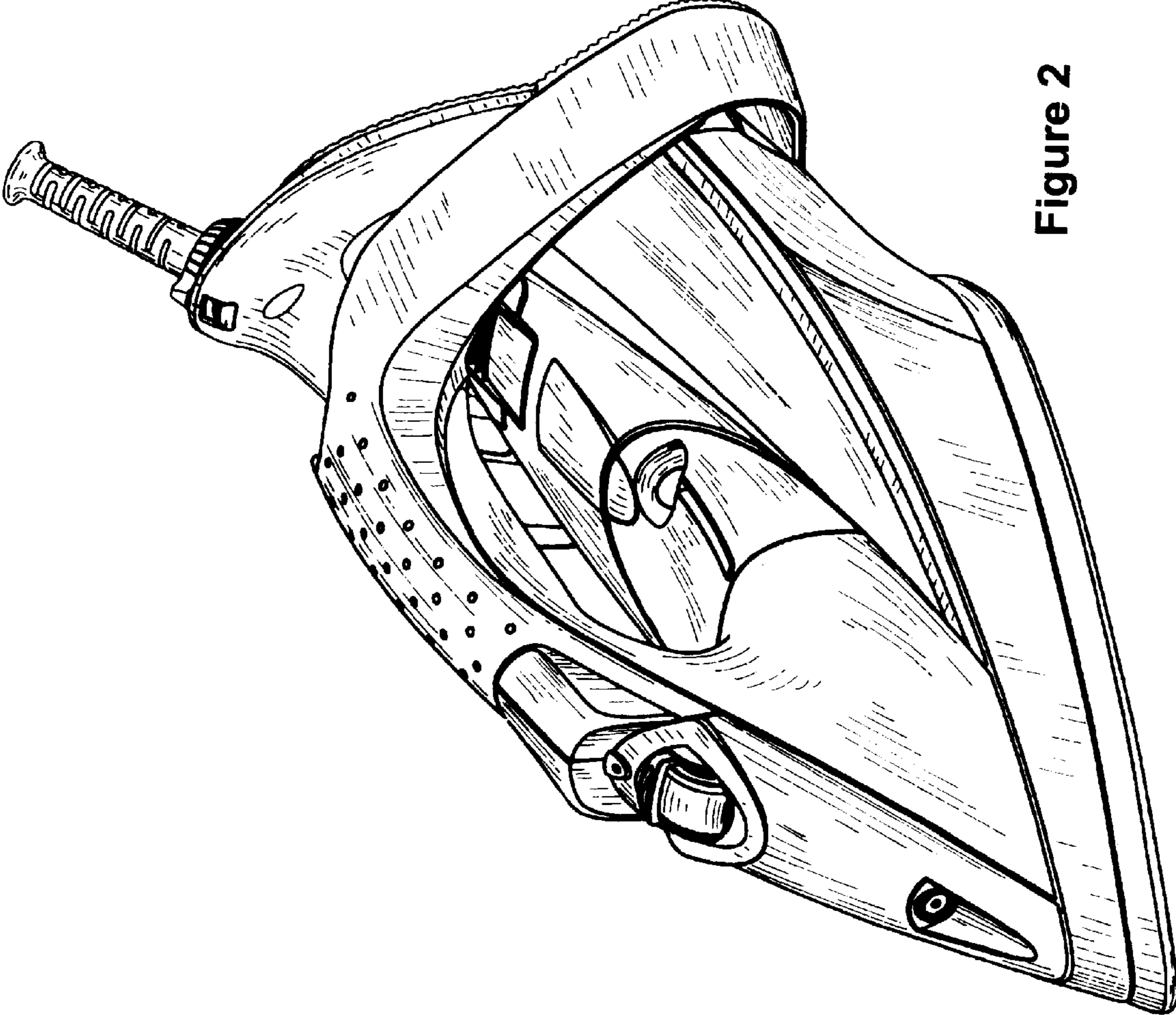

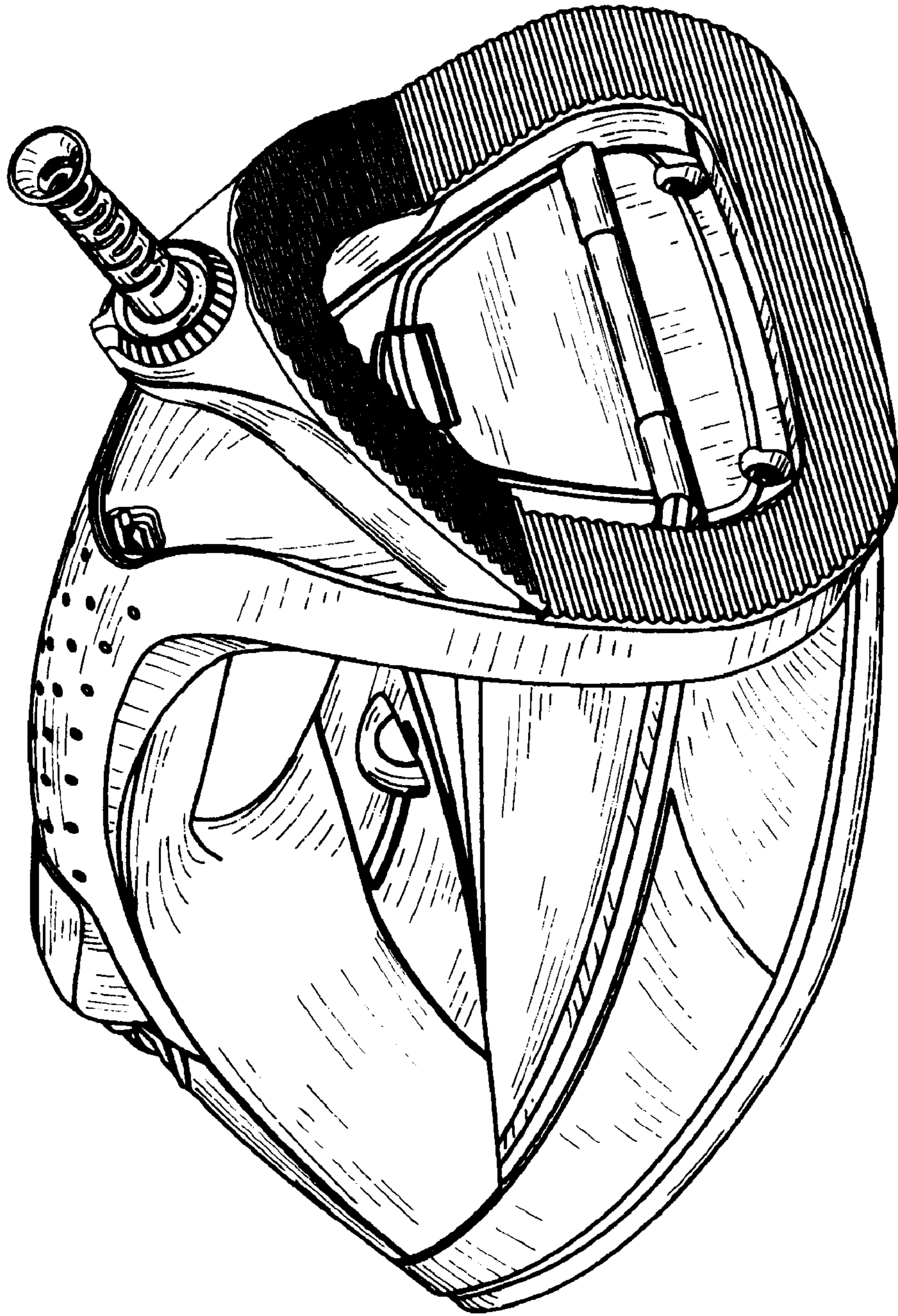

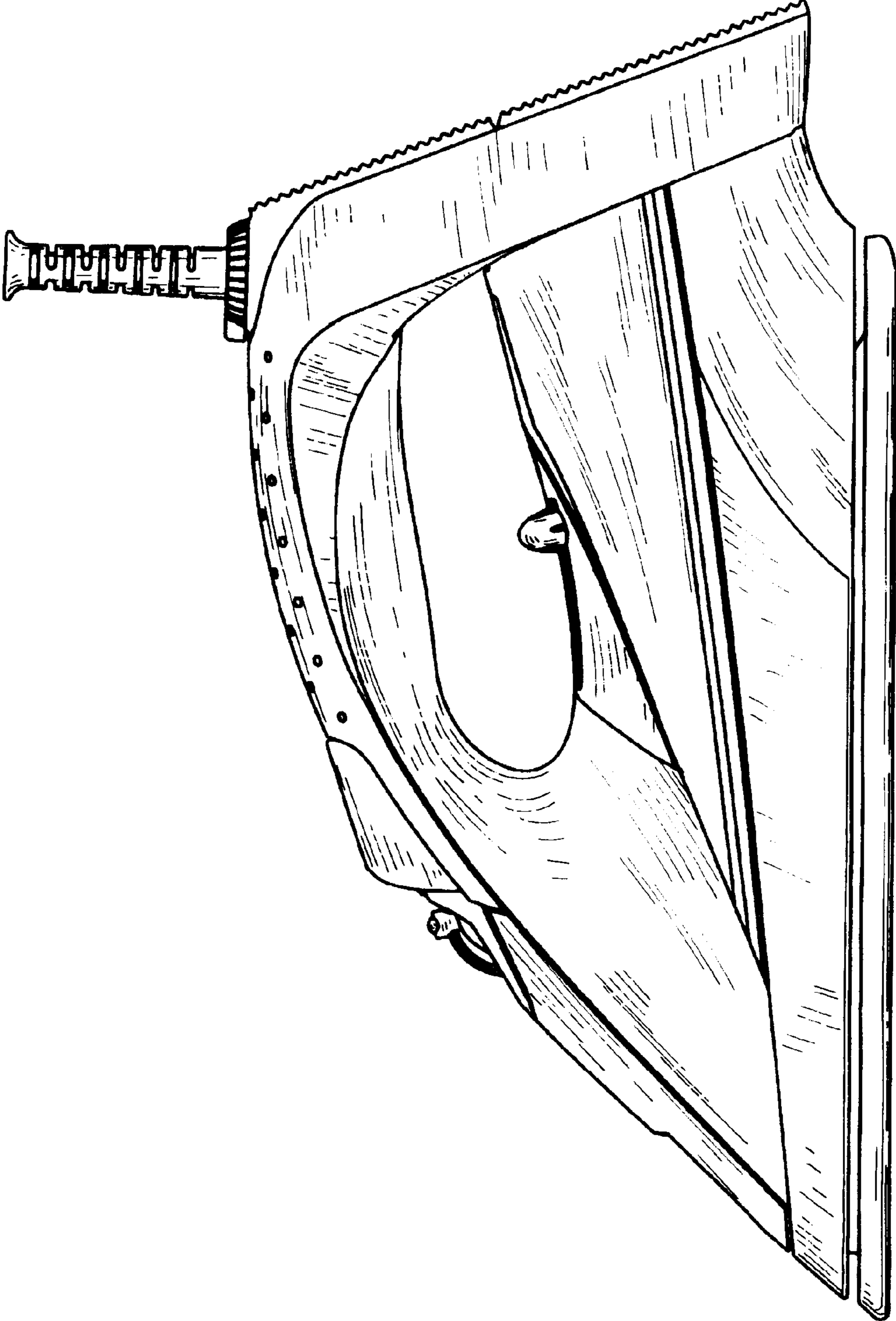

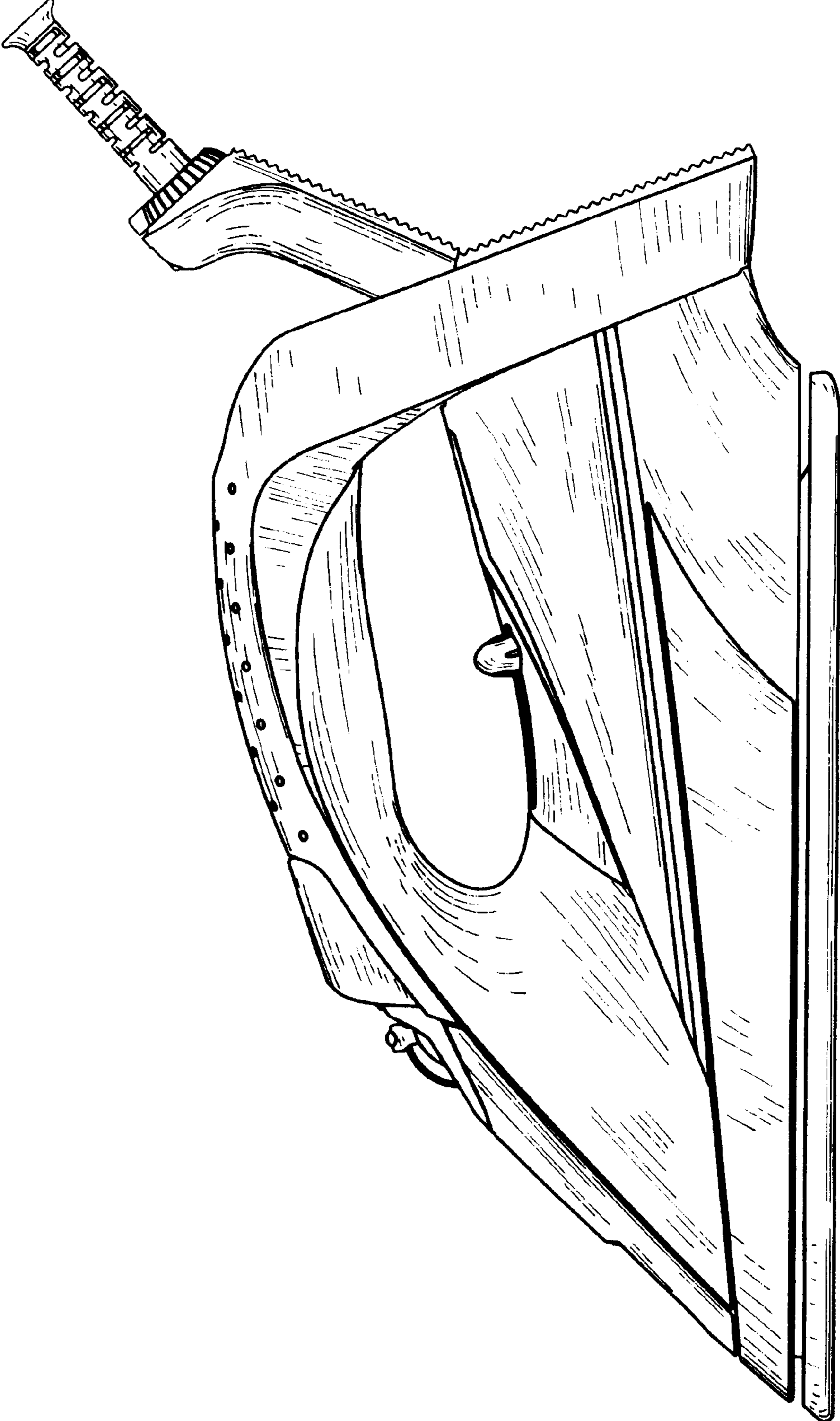

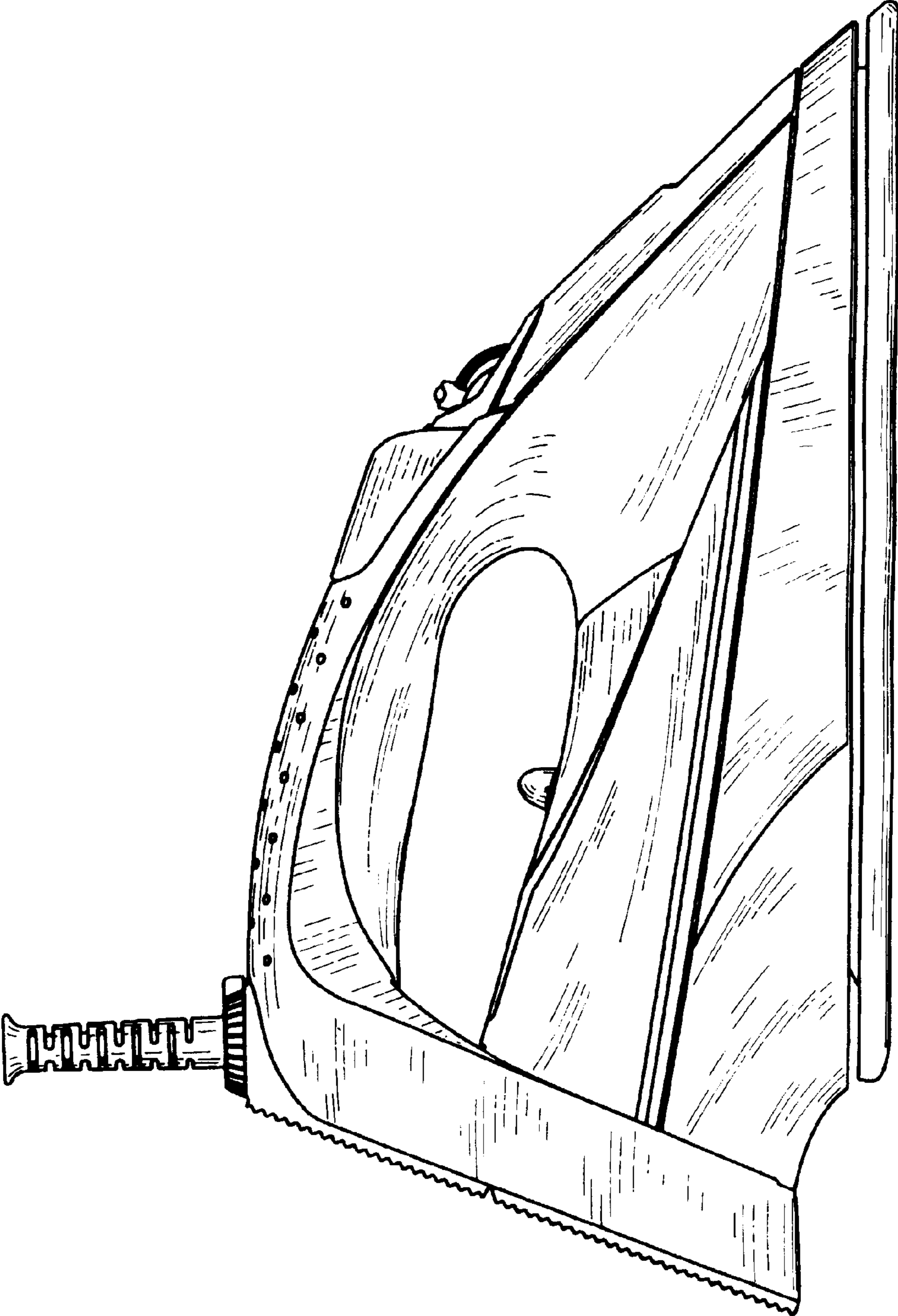

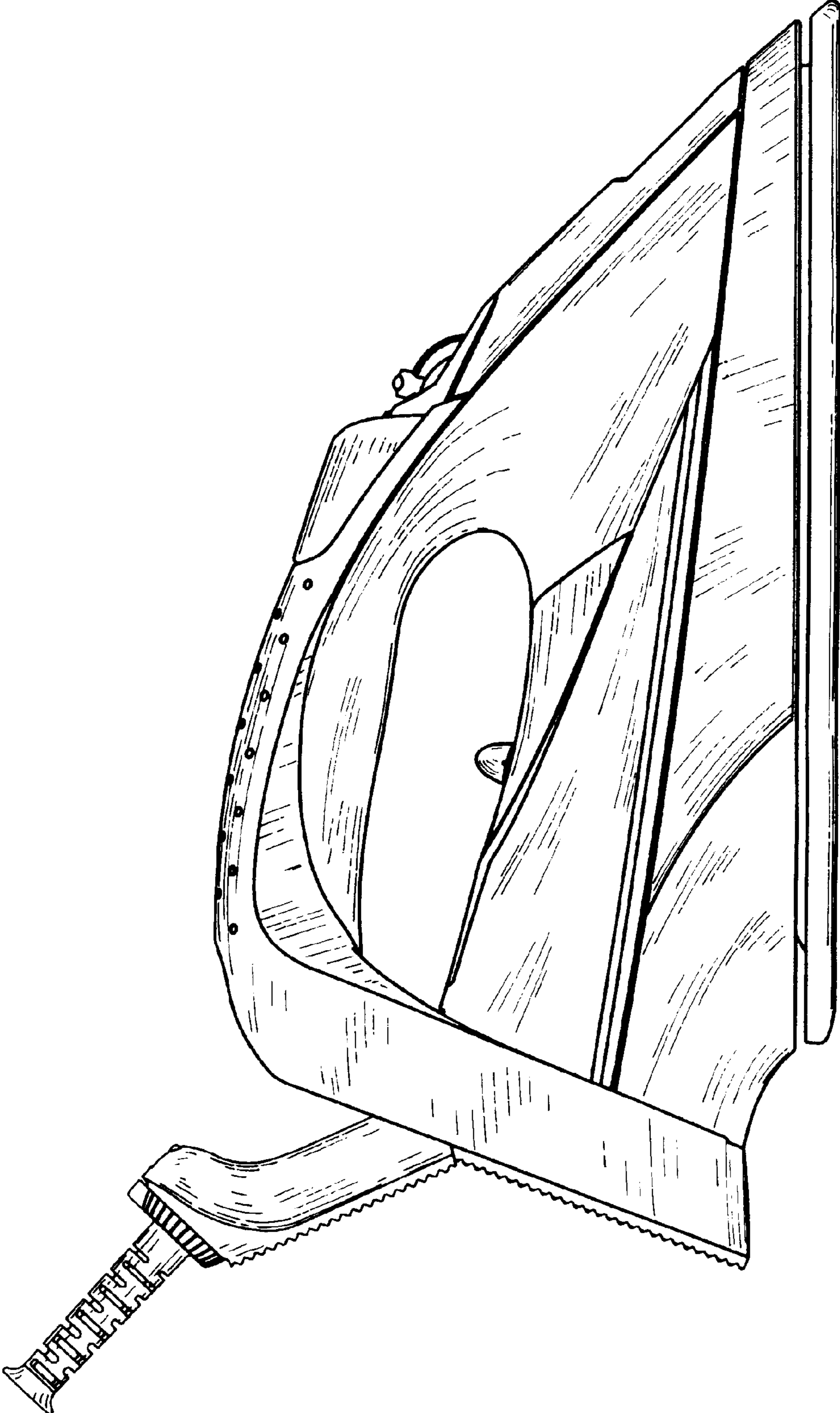

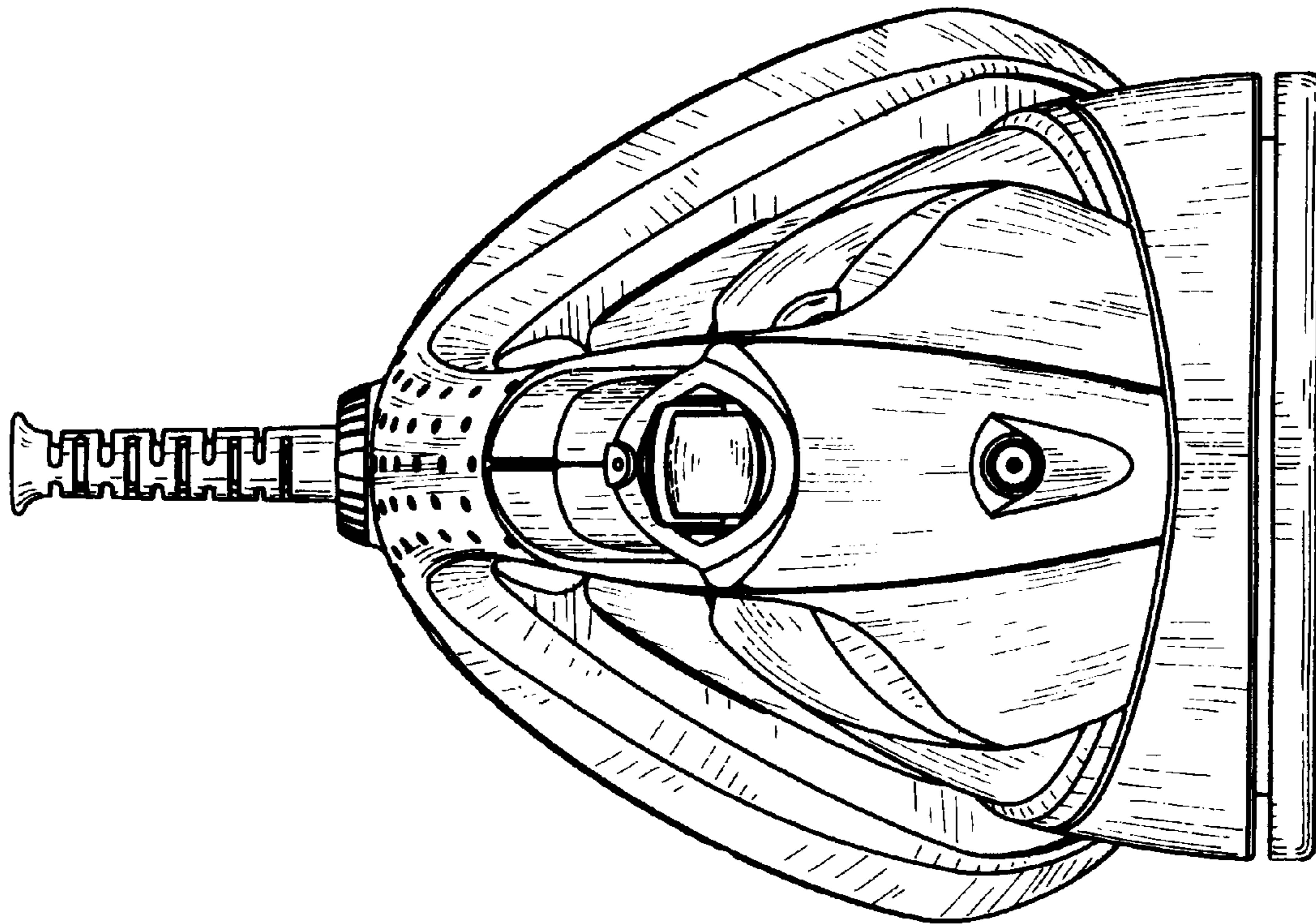

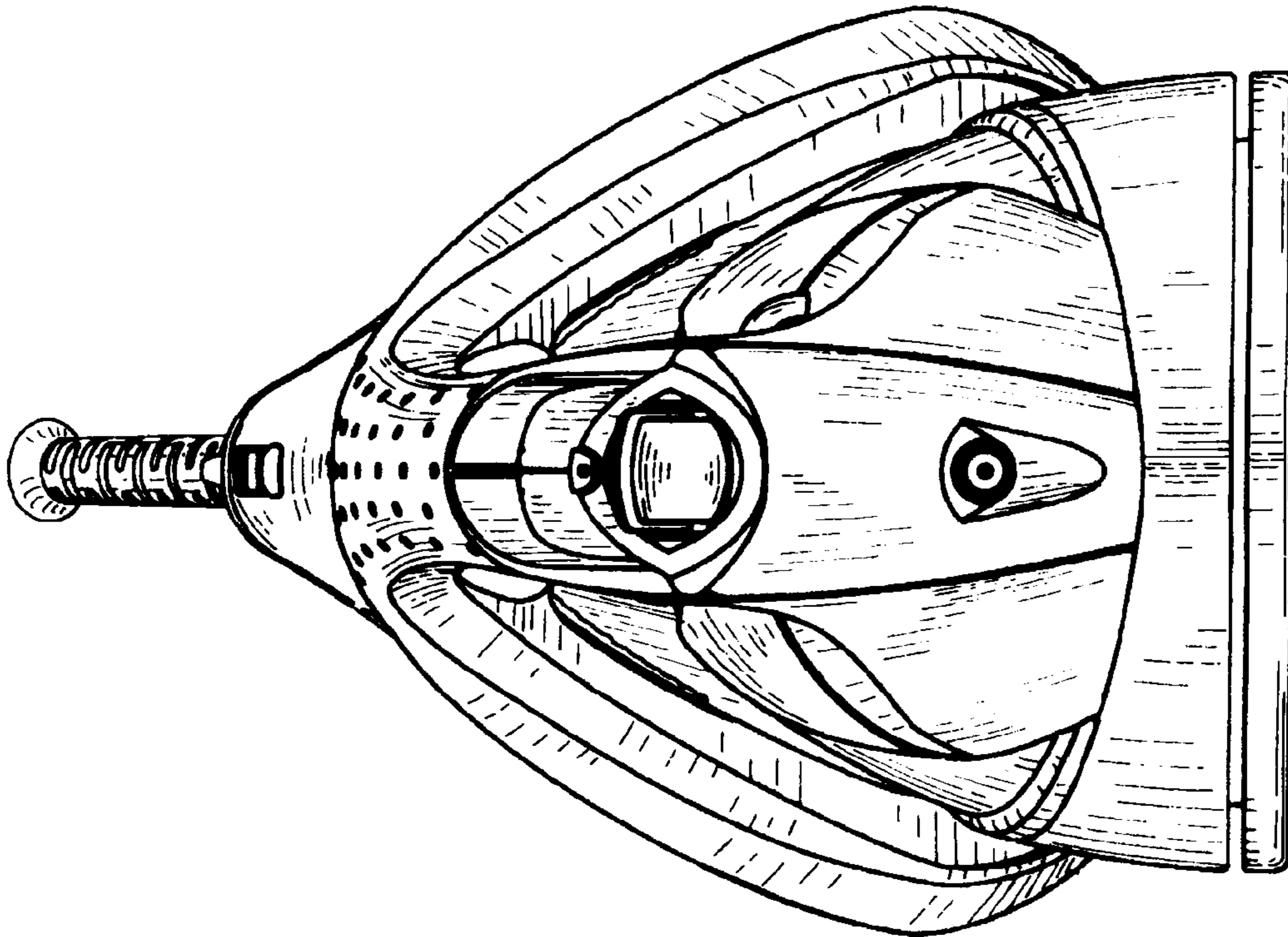

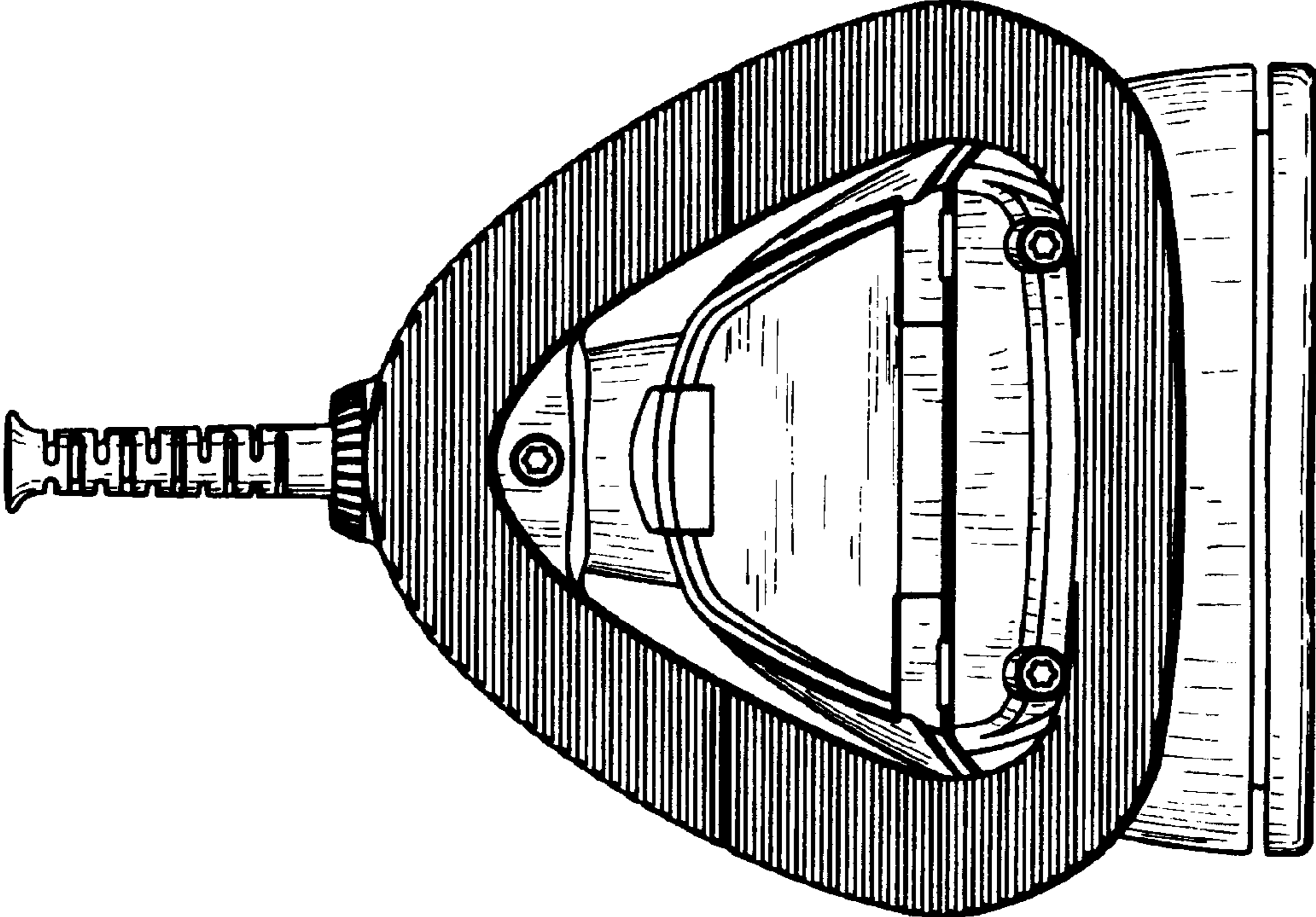

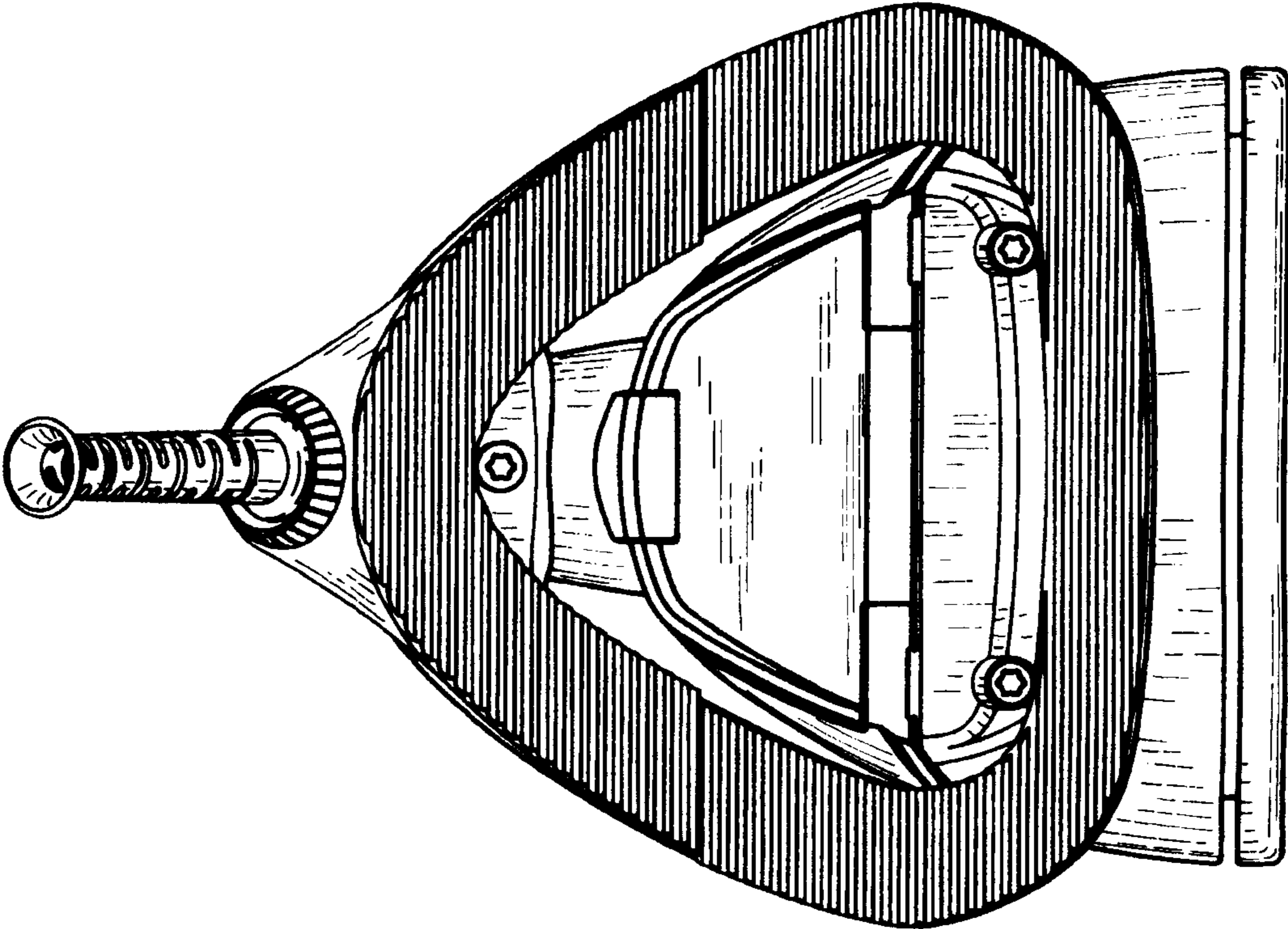

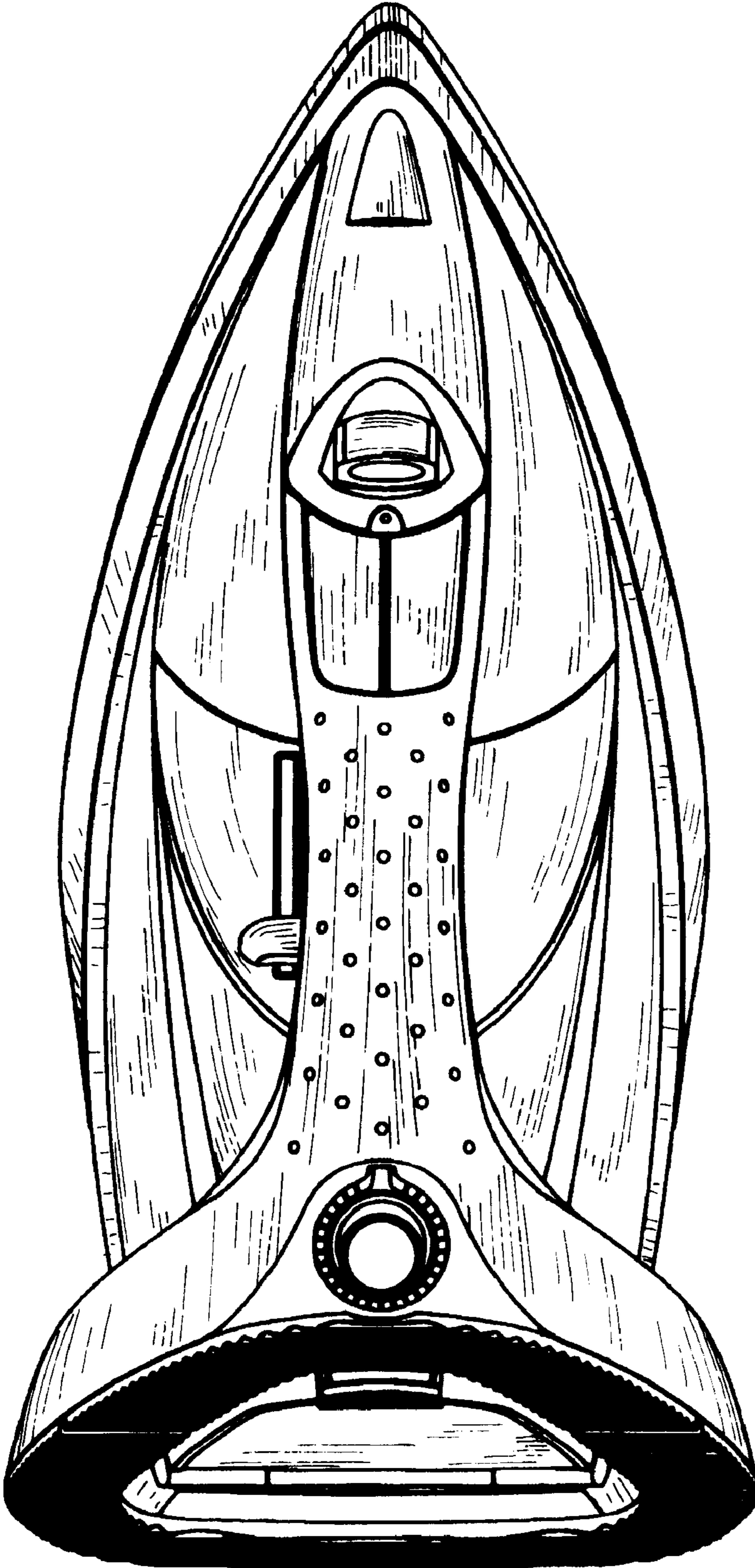

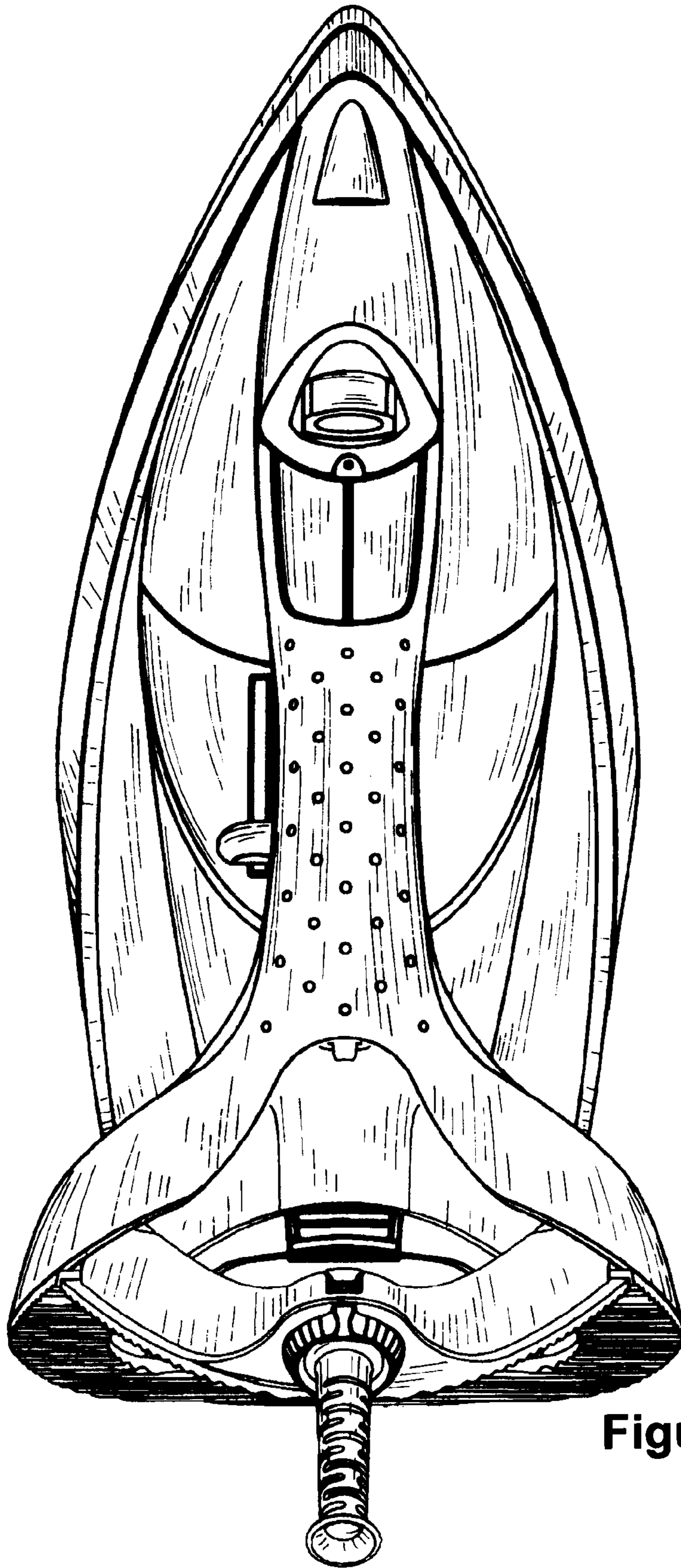

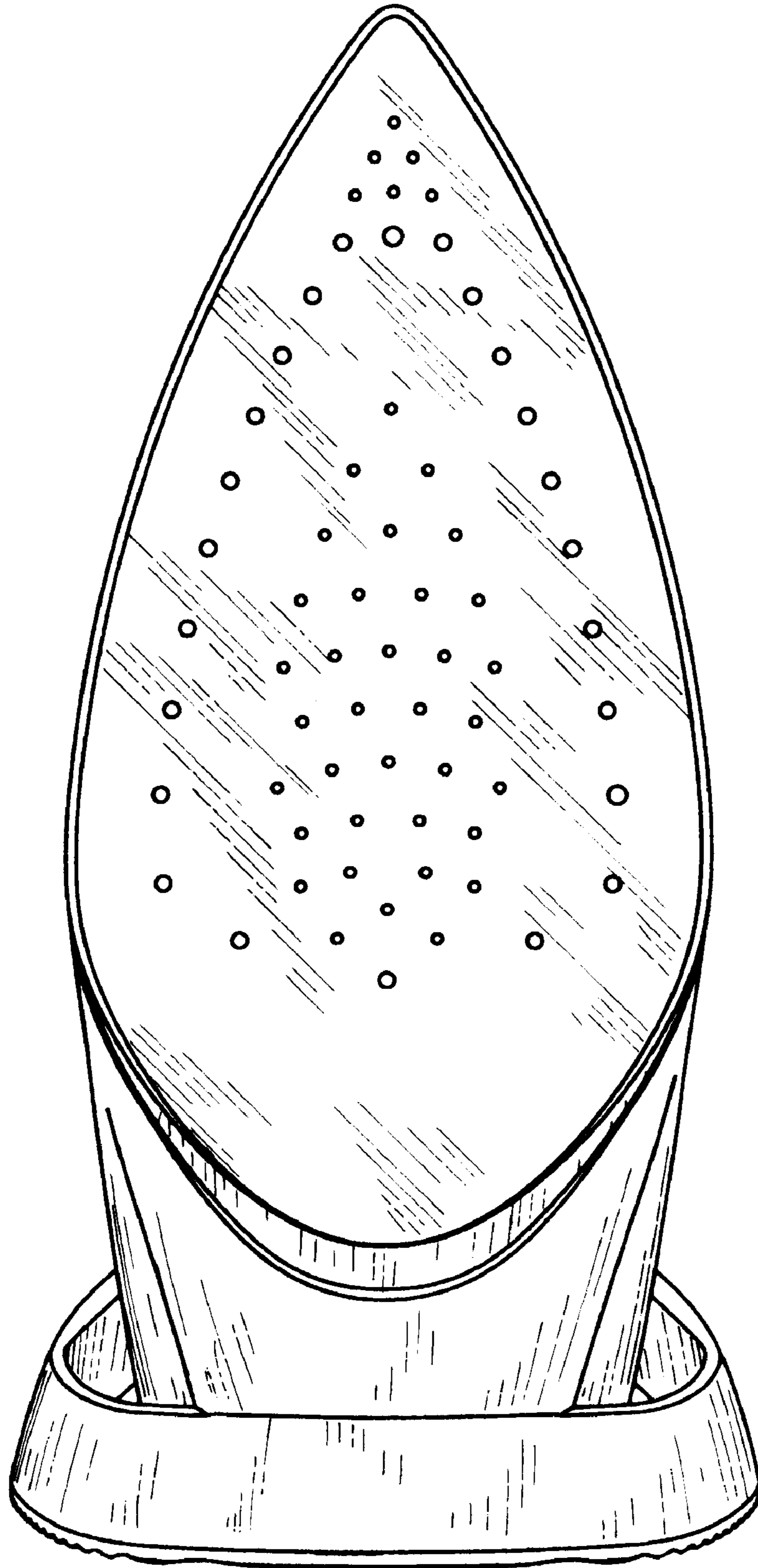

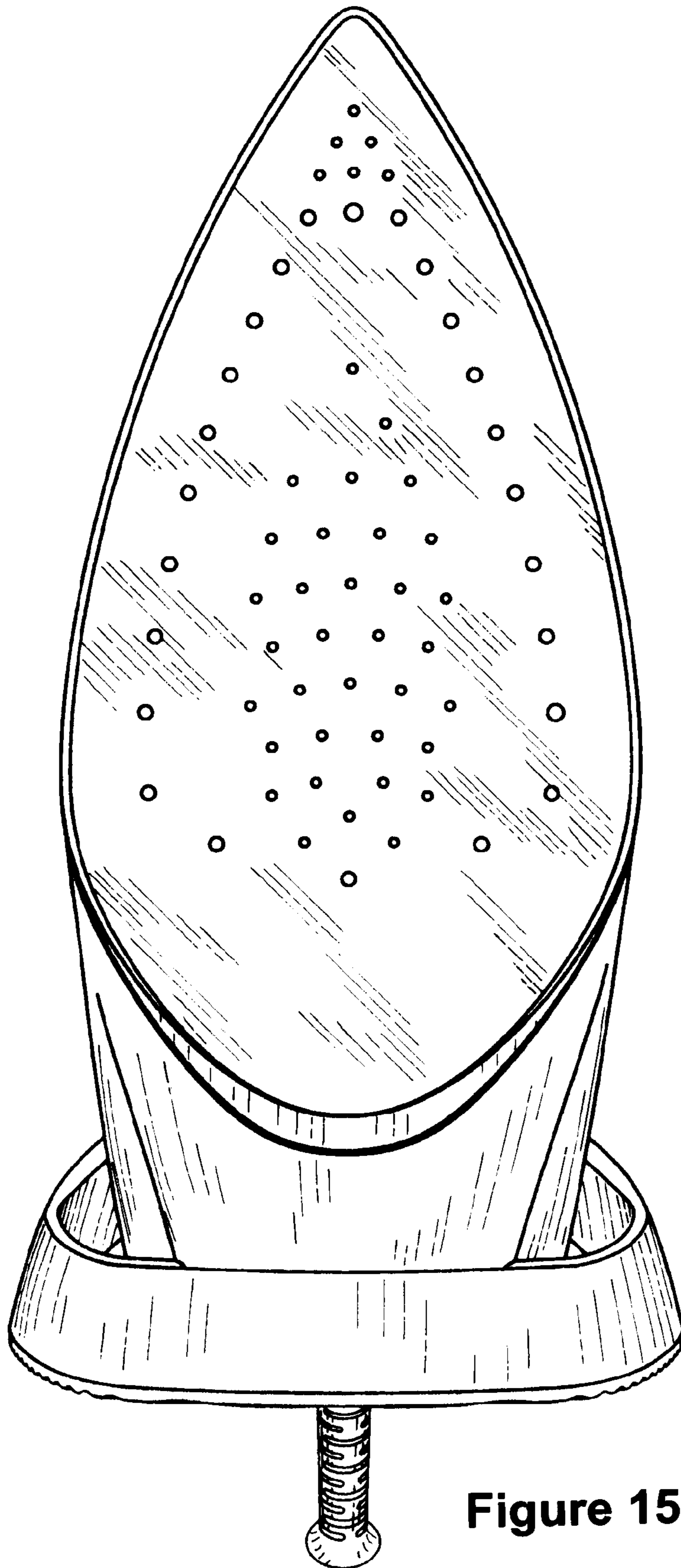
