(57) **CLAIM**

The ornamental design for a wheeled carrier and folding seat, as shown and described.

FIG. 1 is a front perspective view showing my new design of a wheeled carrier with folding seat.

FIG. 2 is a back perspective view thereof.

FIG. 3 is a front elevation thereof.

FIG. 4 is a back elevation view thereof.

FIG. 5 is a right side view thereof, the left side view being a mirror image thereof.

FIG. 6 is a top plan view thereof.

FIG. 7 is a bottom plan view thereof.

FIG. 8 is a perspective view of the folding seat as stored in the carrier in a collapsed condition but shown removed therefrom.

FIG. 9 is a perspective view of the folding seat in an assembled condition.

FIG. 10 is a right side view thereof, the left side view being identical thereto.

FIG. 11 is a front elevation thereof, the back elevation view being identical thereto.

FIG. 12 is a bottom plan view thereof; and,

FIG. 13 is a top plan view thereof.

The folding seat is shown alone in FIGS. 8 through 13 for convenience of illustration.

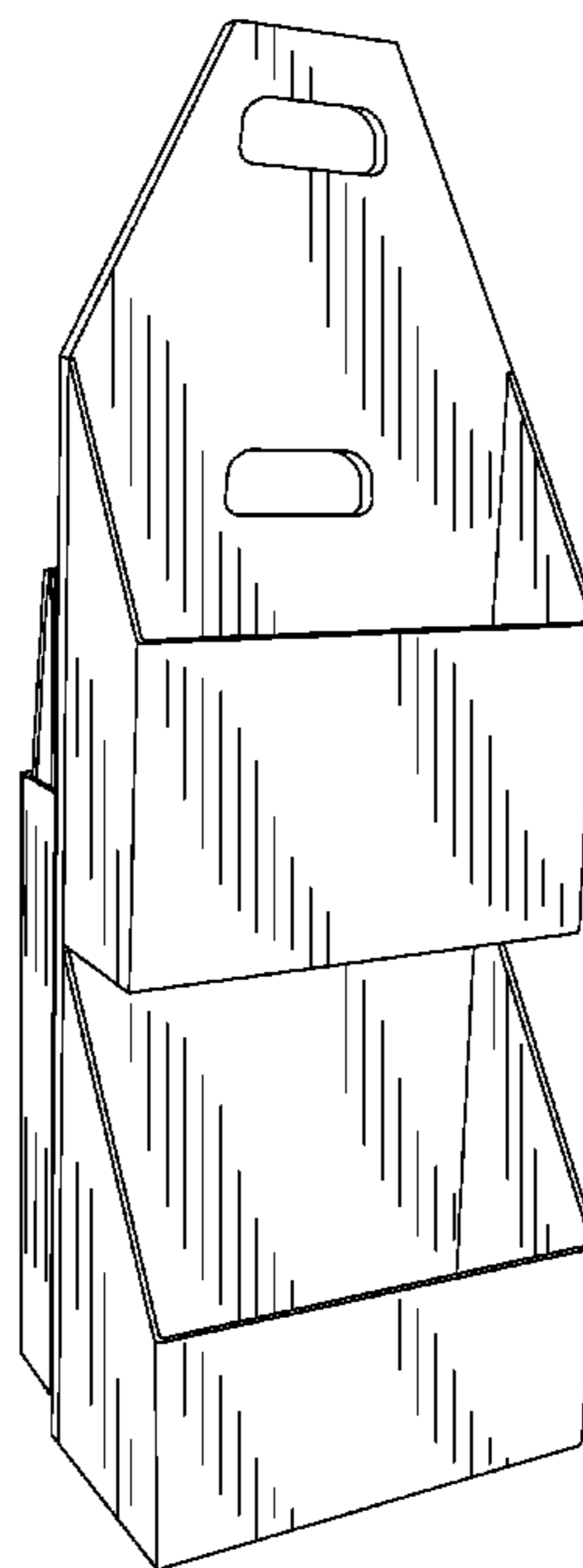

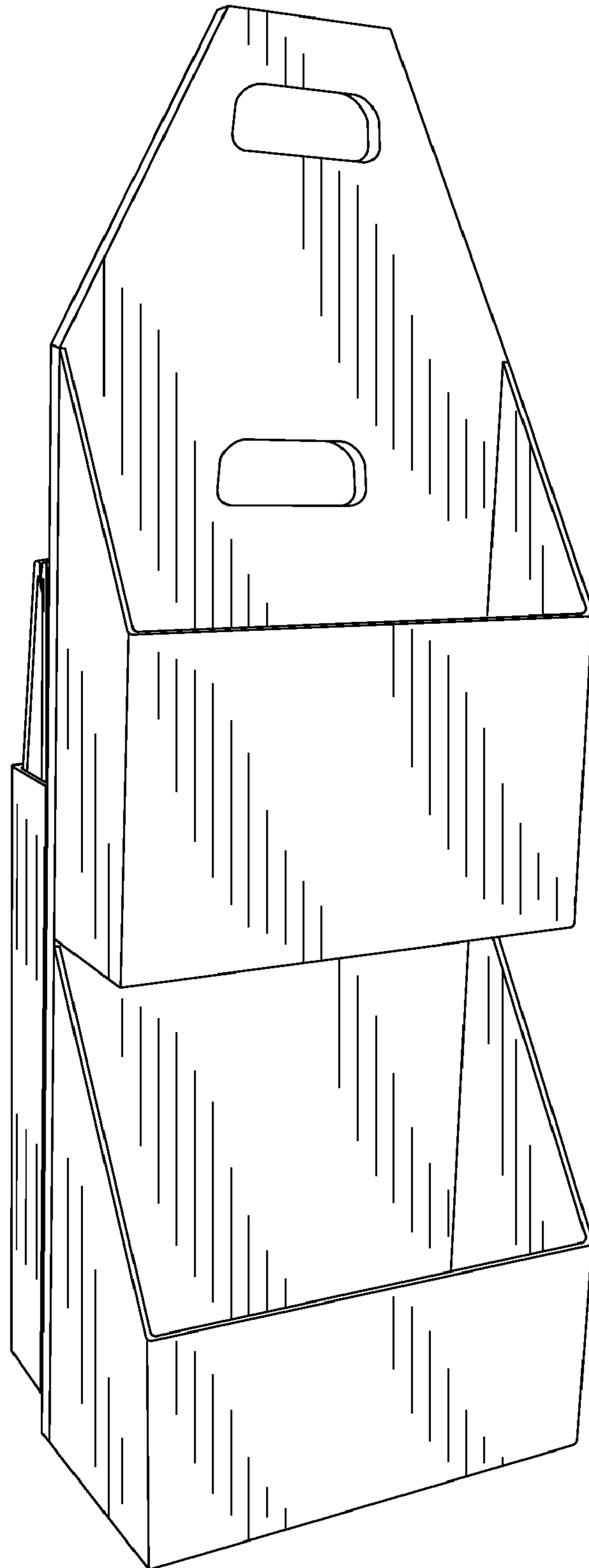

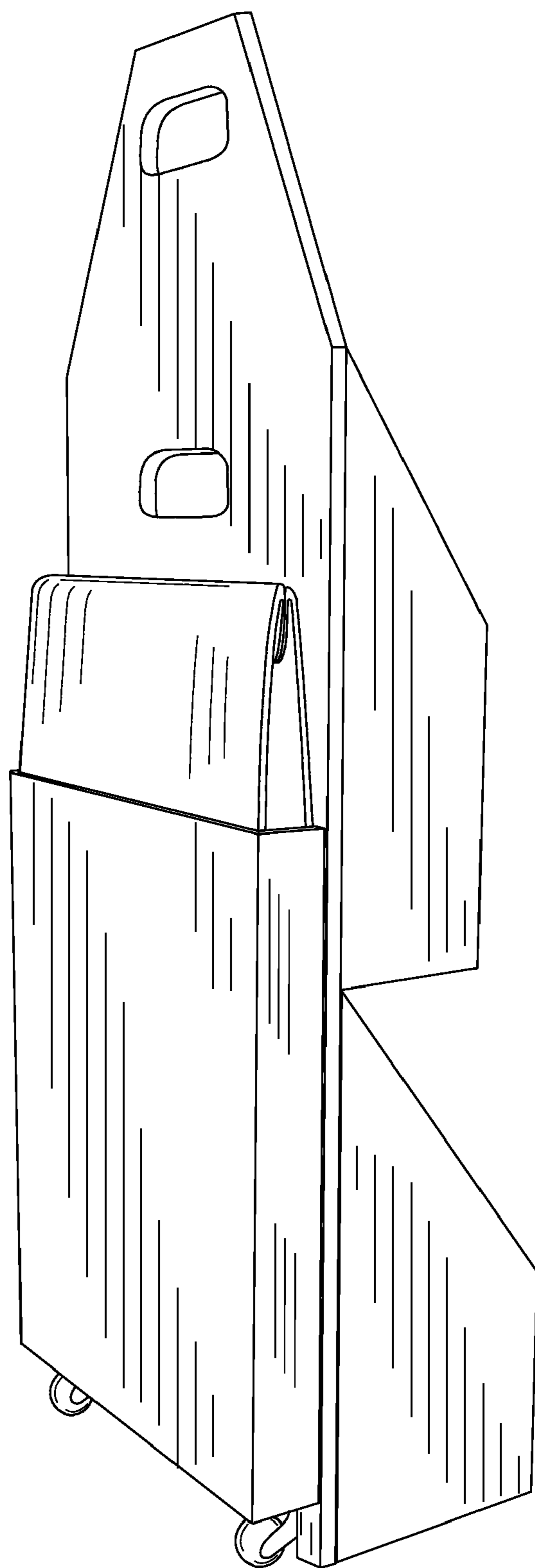

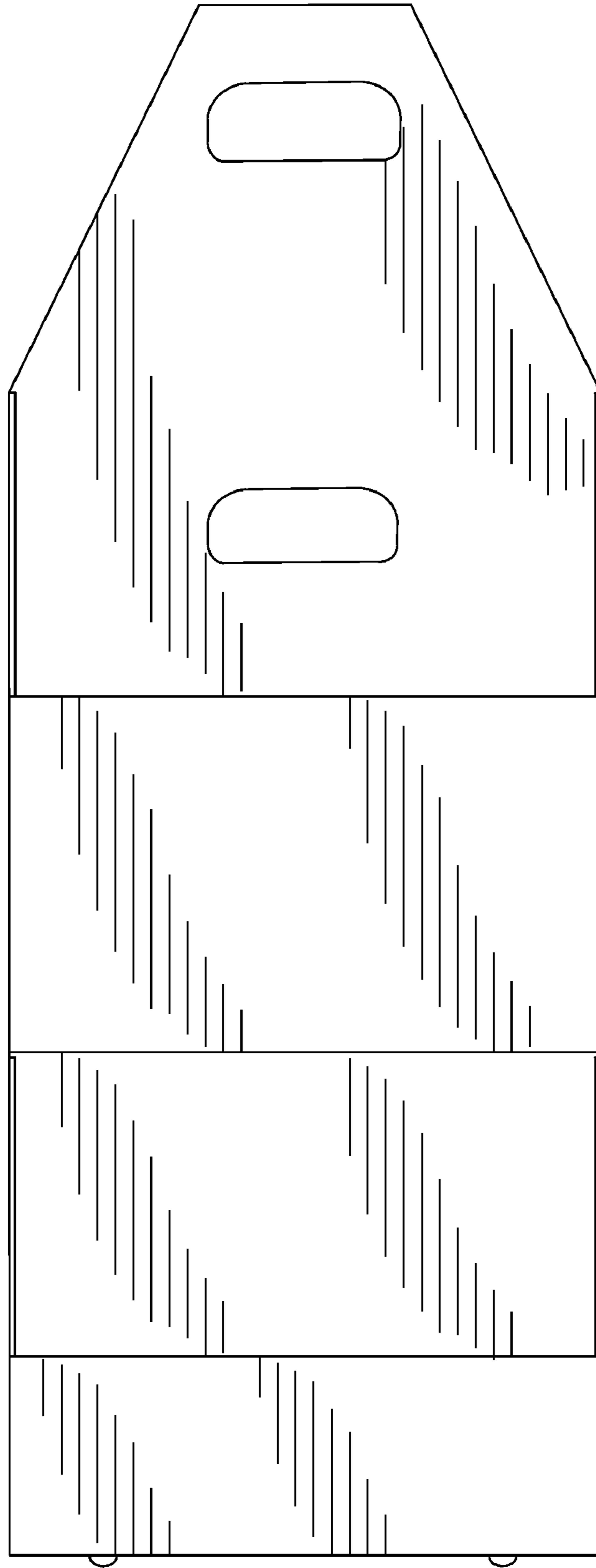

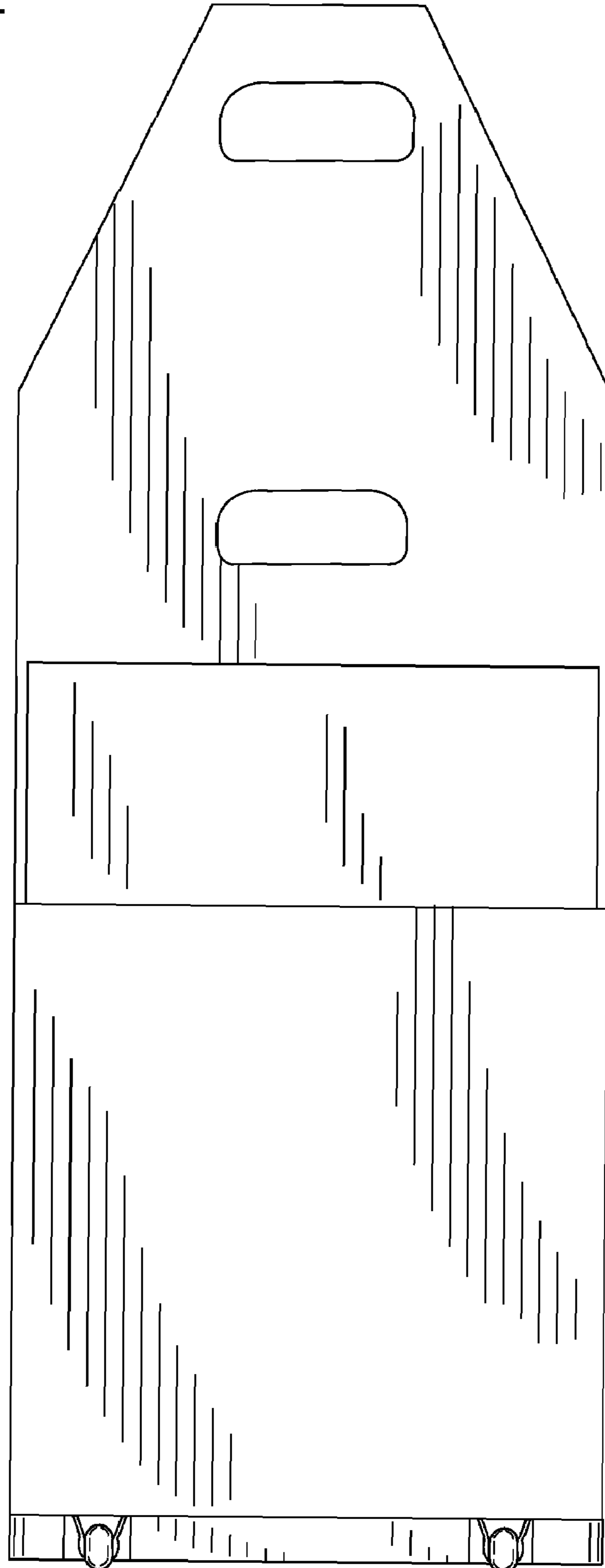

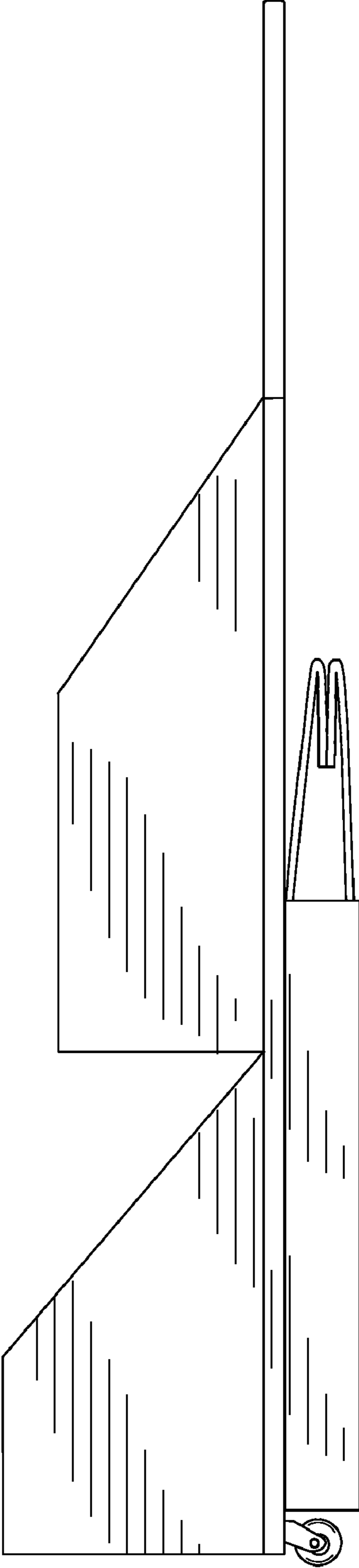

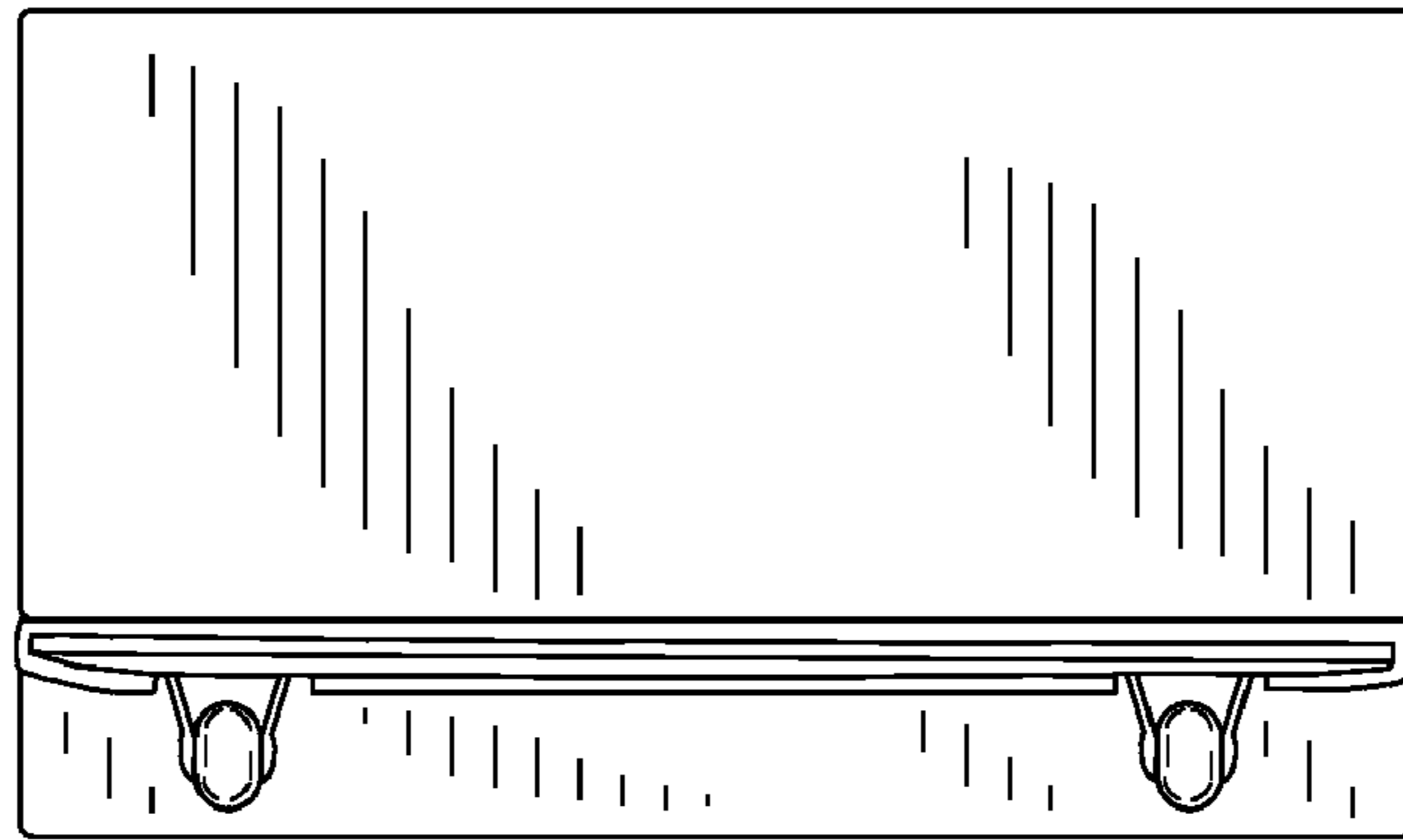

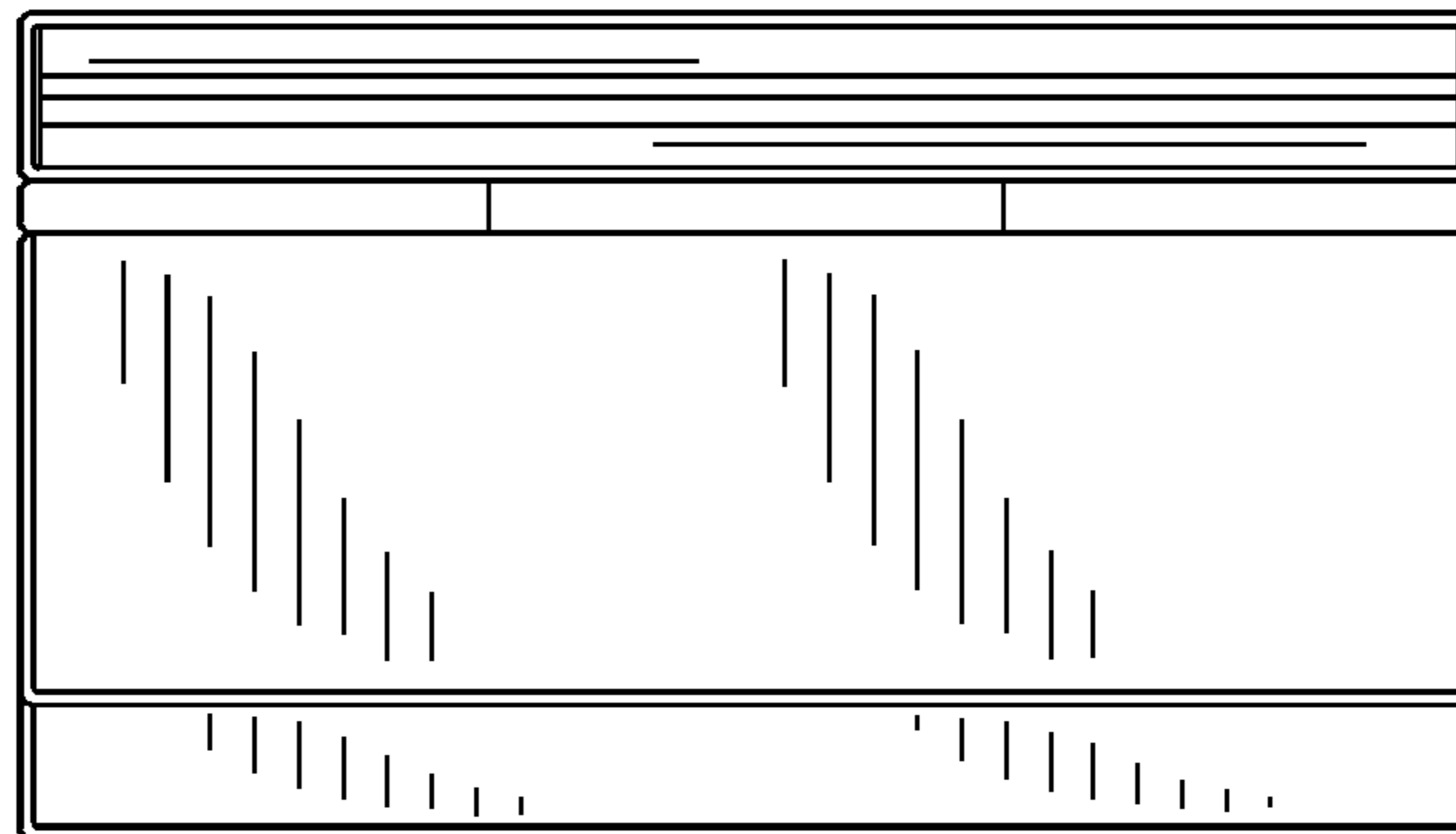

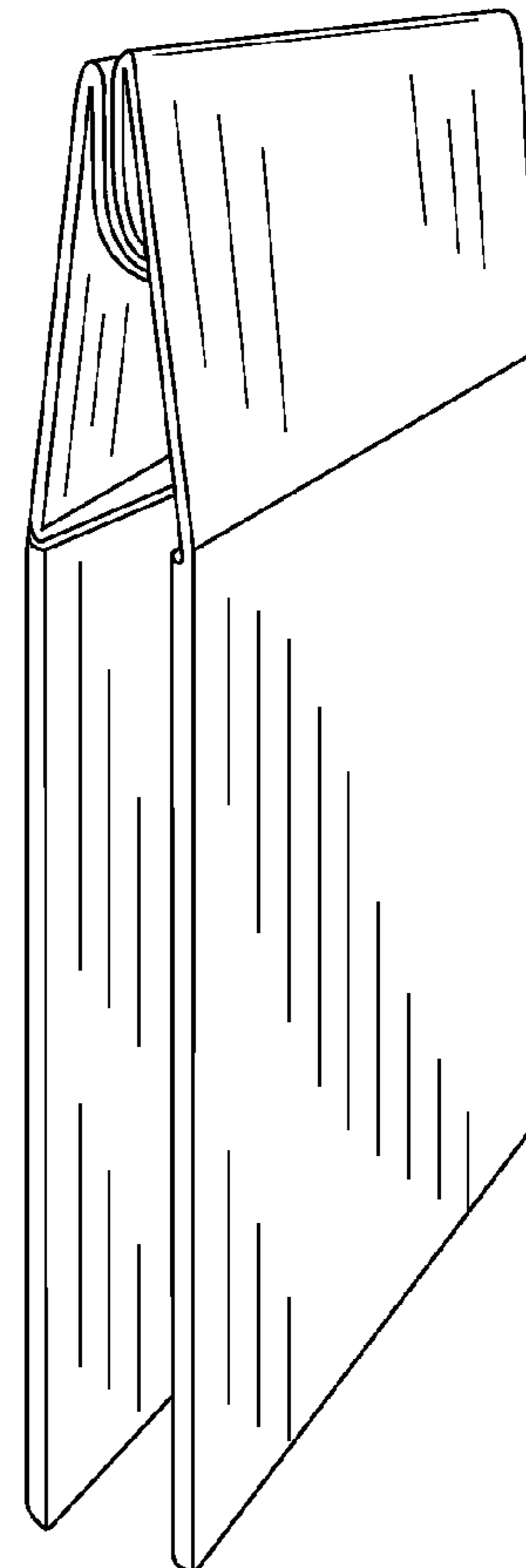

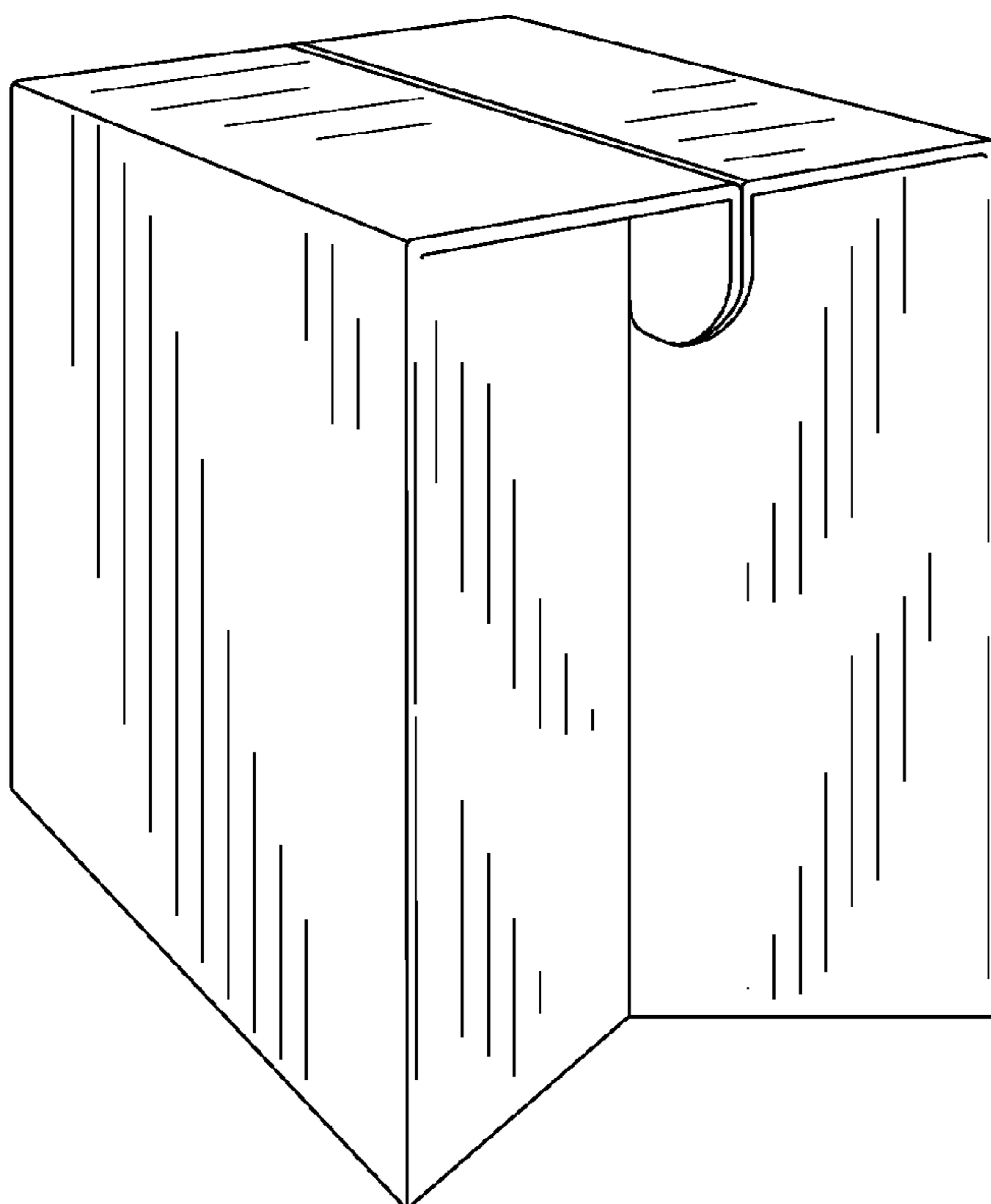

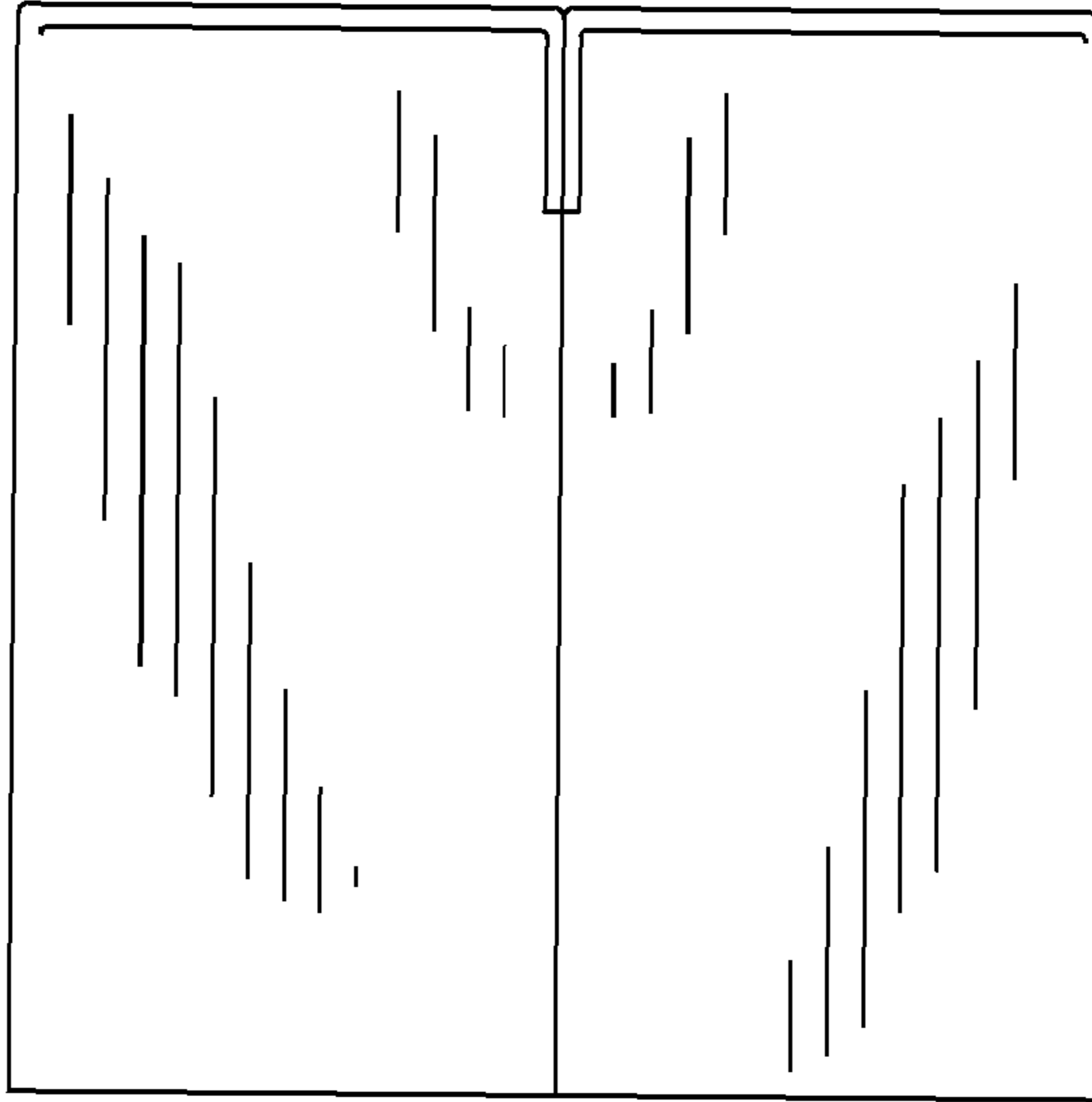

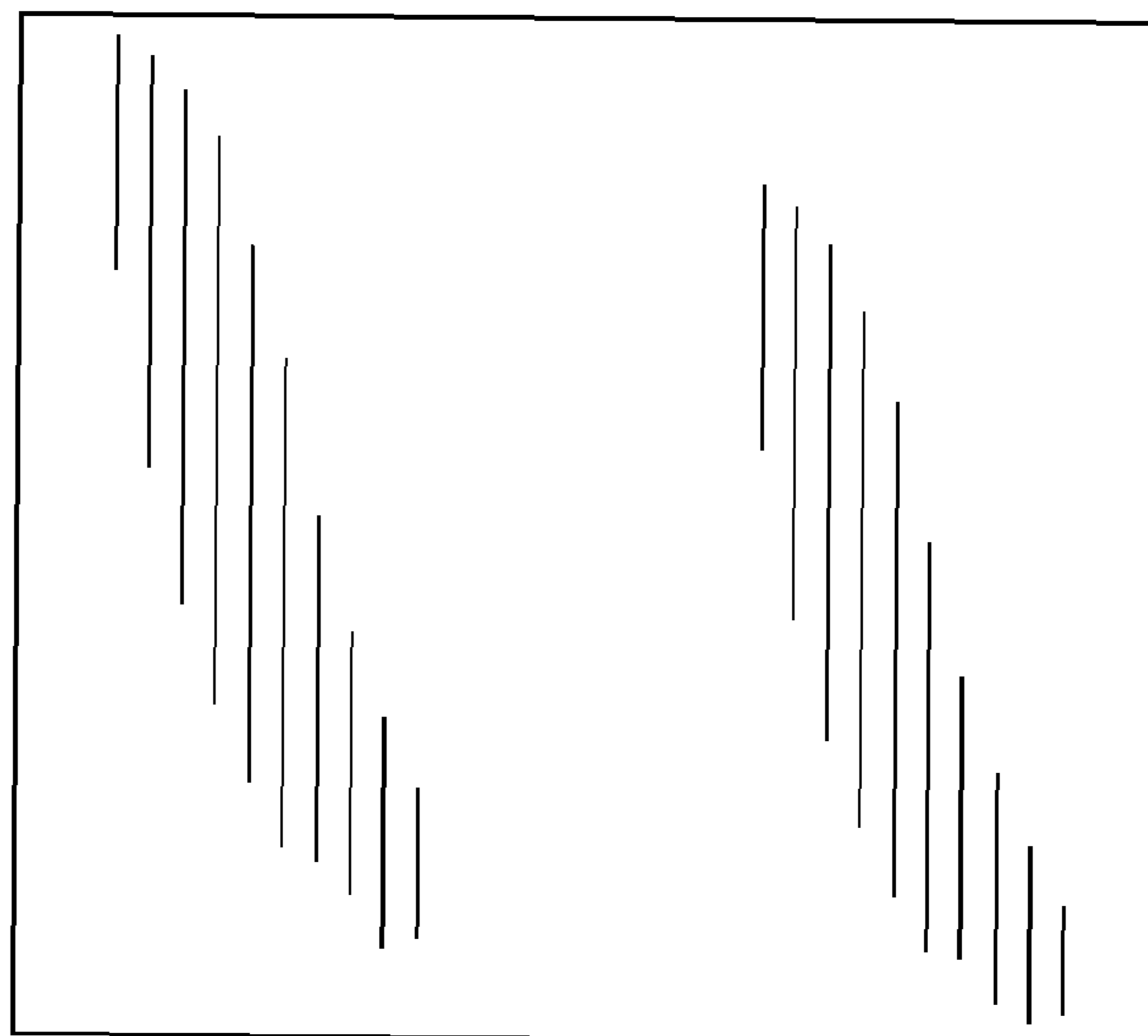

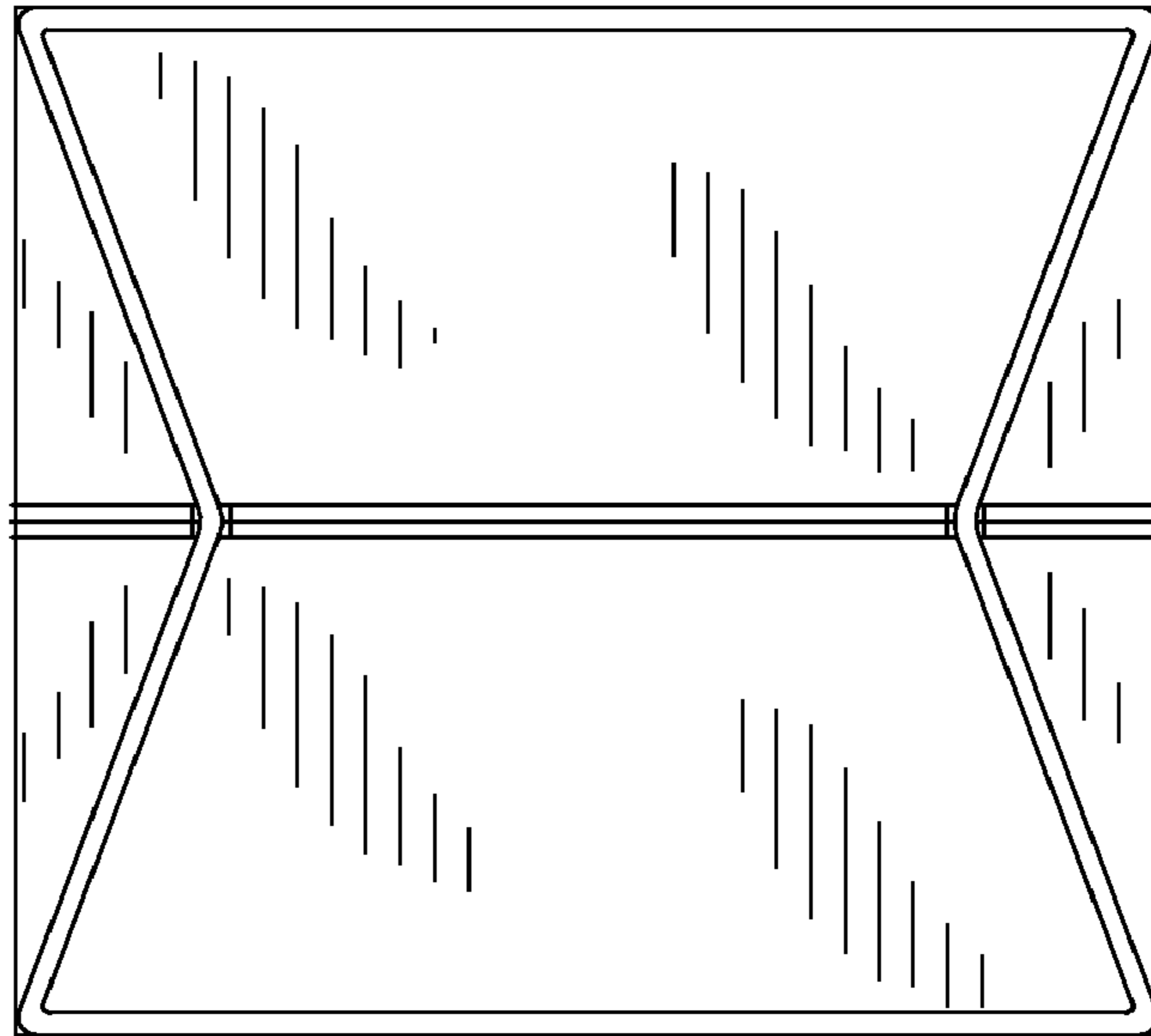
