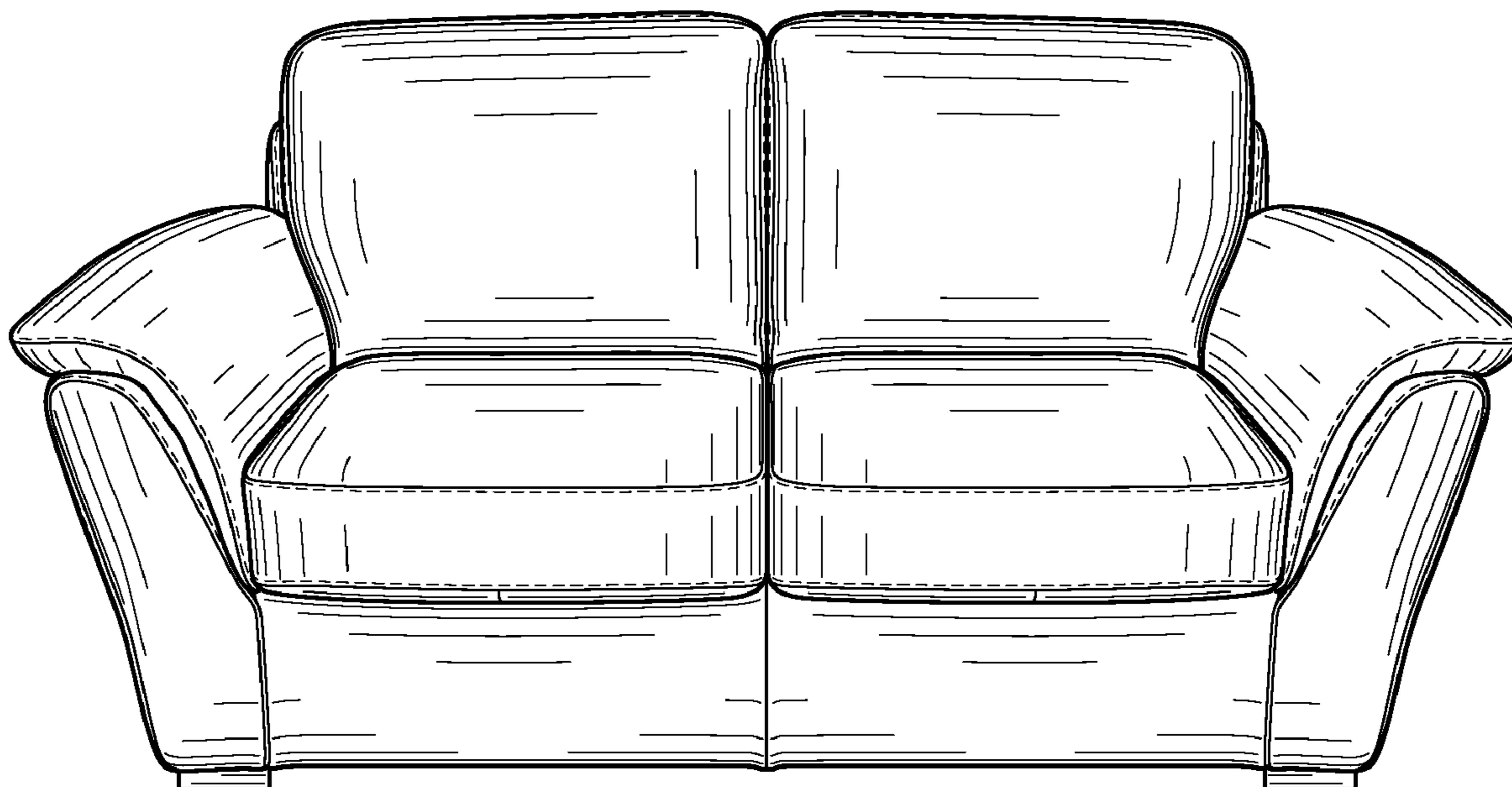

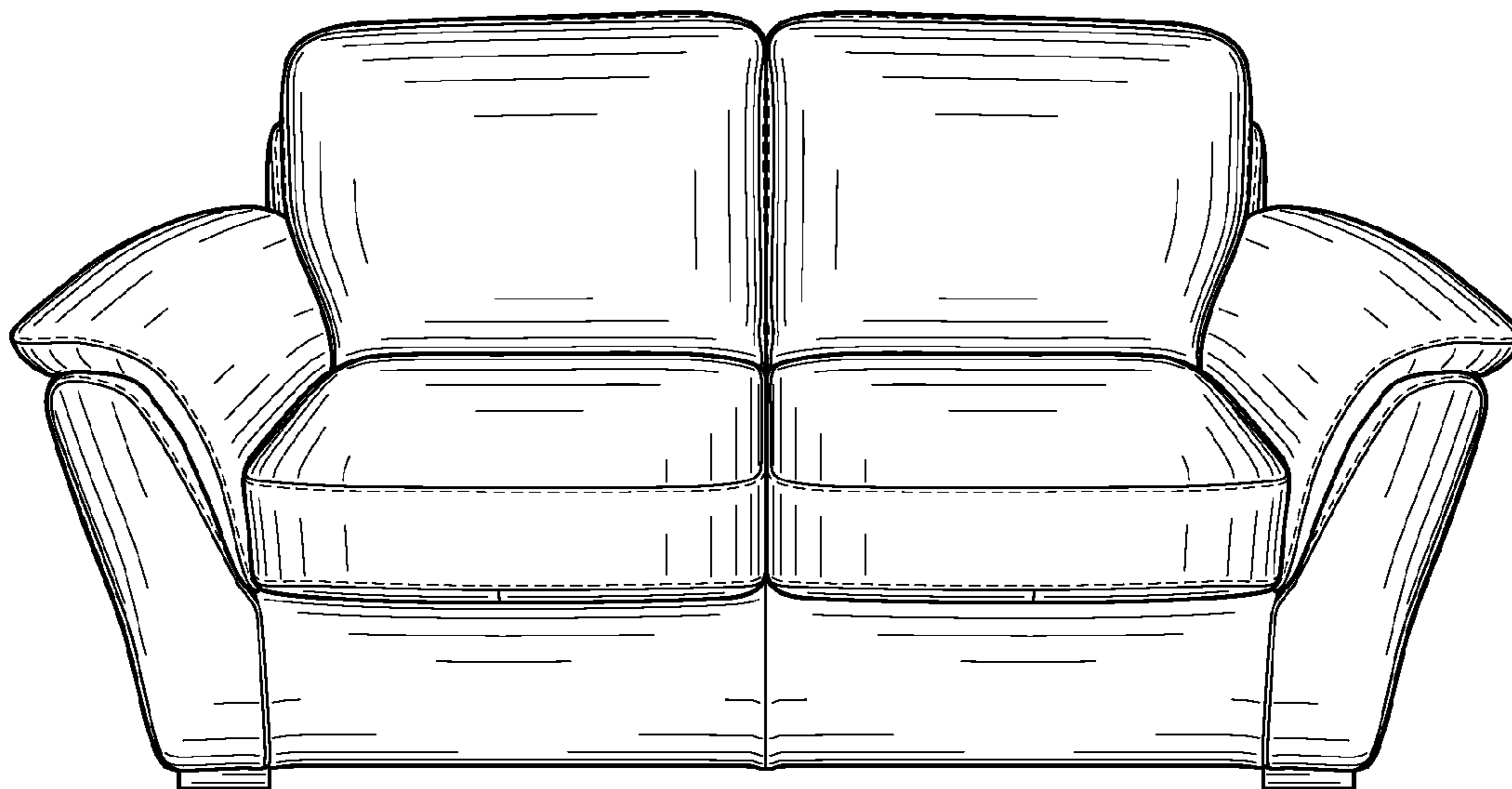
The ornamental design for a sofa, as shown and described.

**DESCRIPTION**

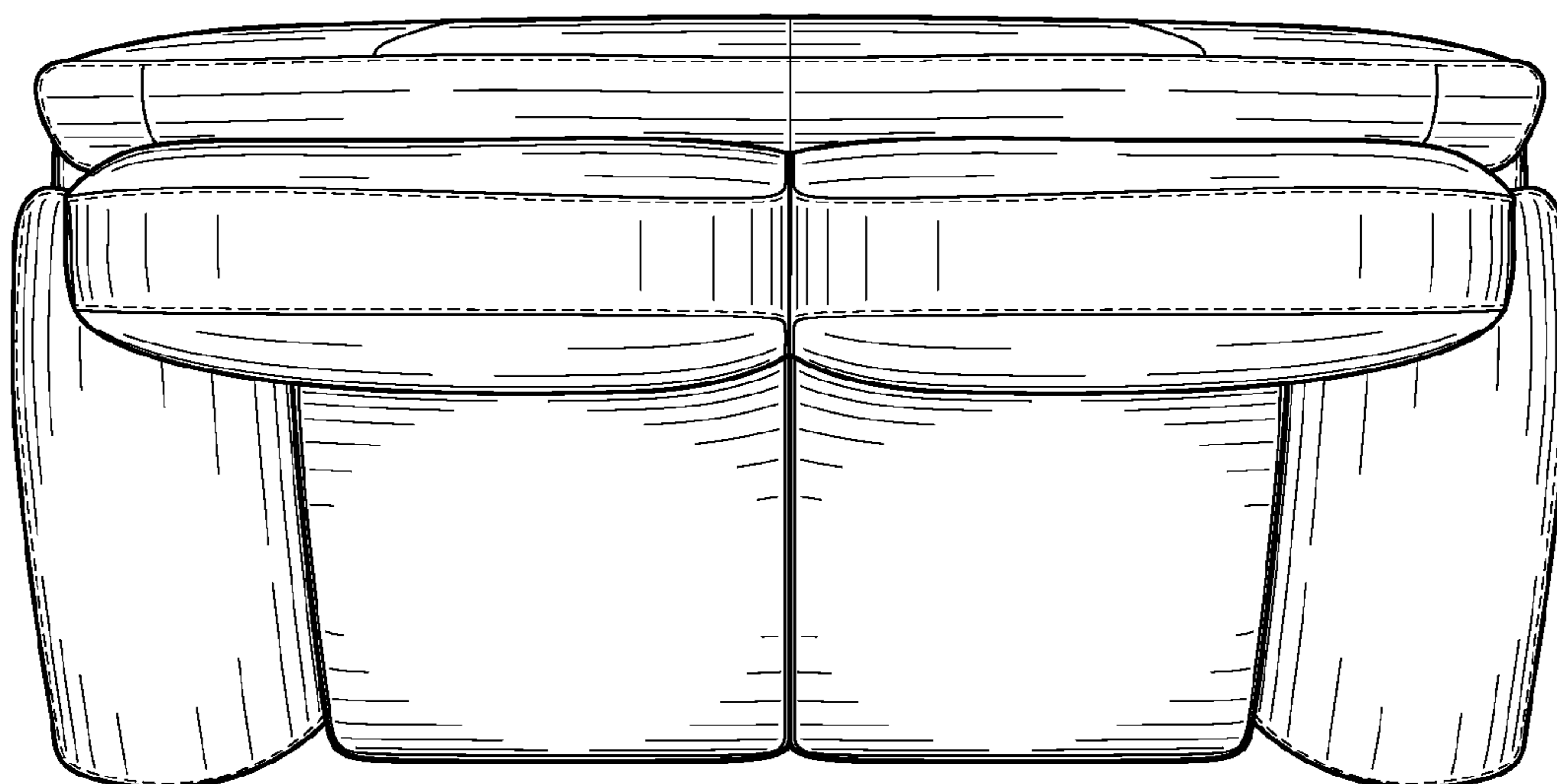
FIG. 1 is a front perspective view of the sofa showing my new design;

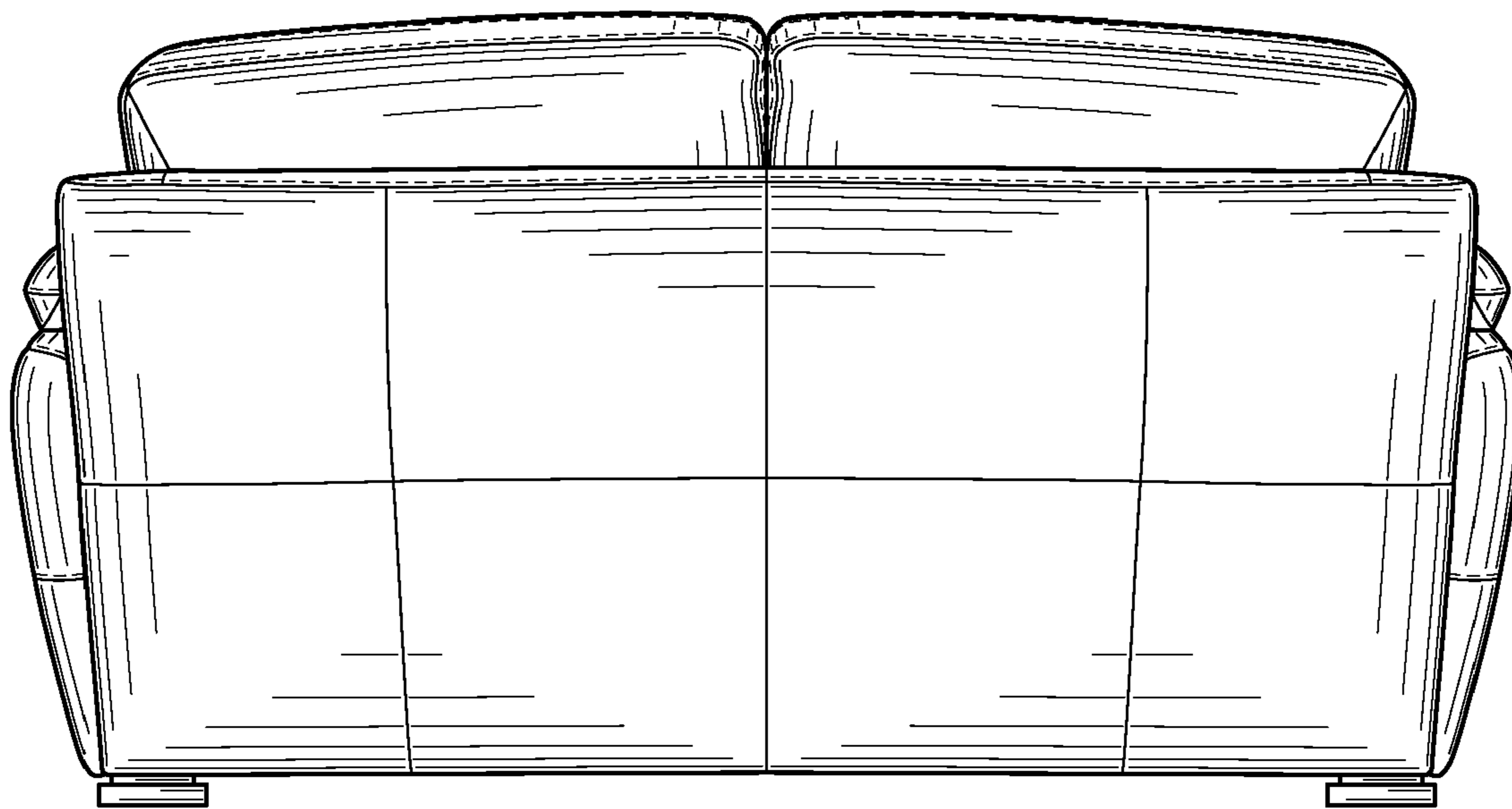




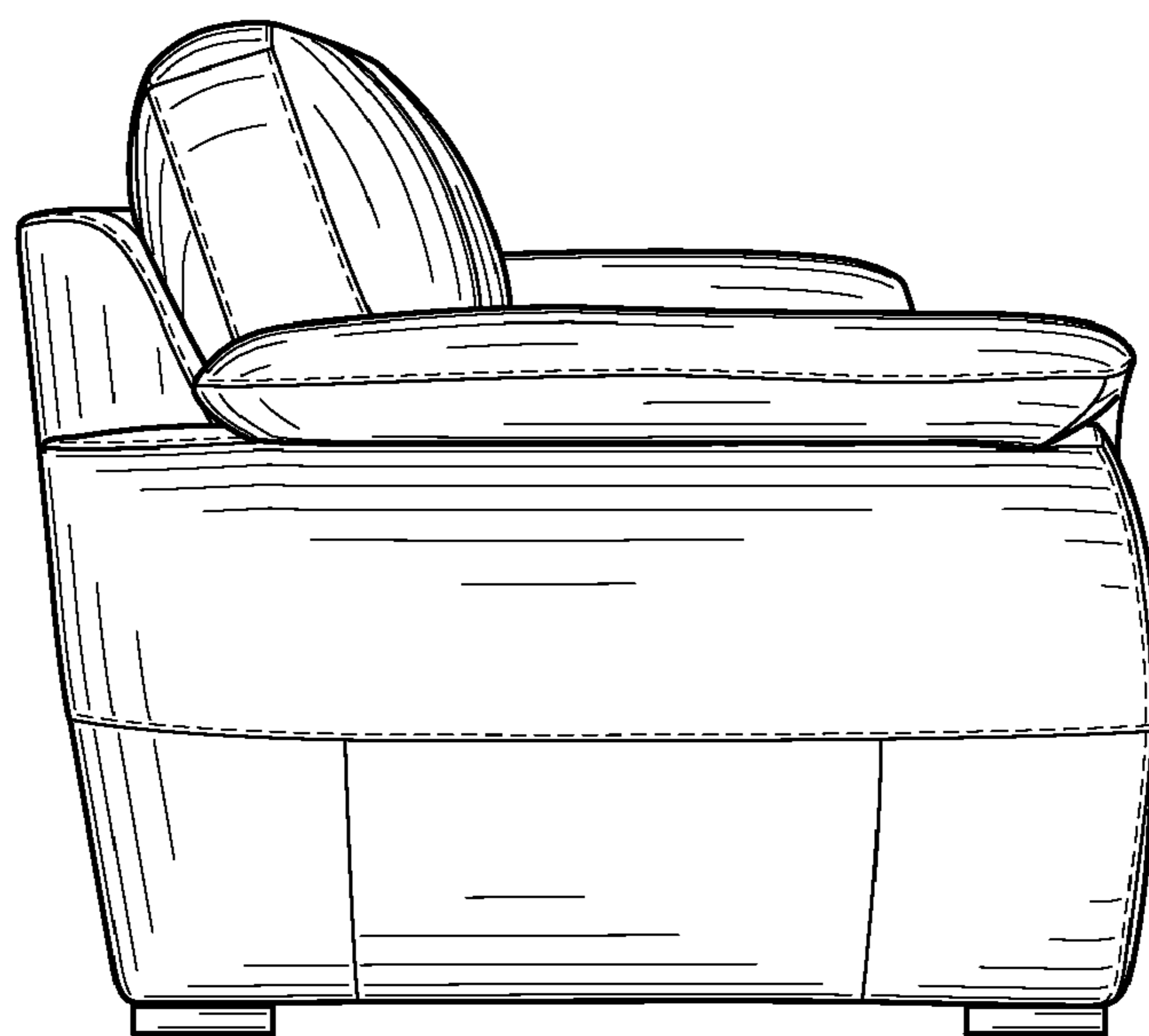
