The ornamental design for a decorative stand for a shot glass in the shape of a rattlesnake head, as shown and described.

FIG. 4 is a left side view thereof;

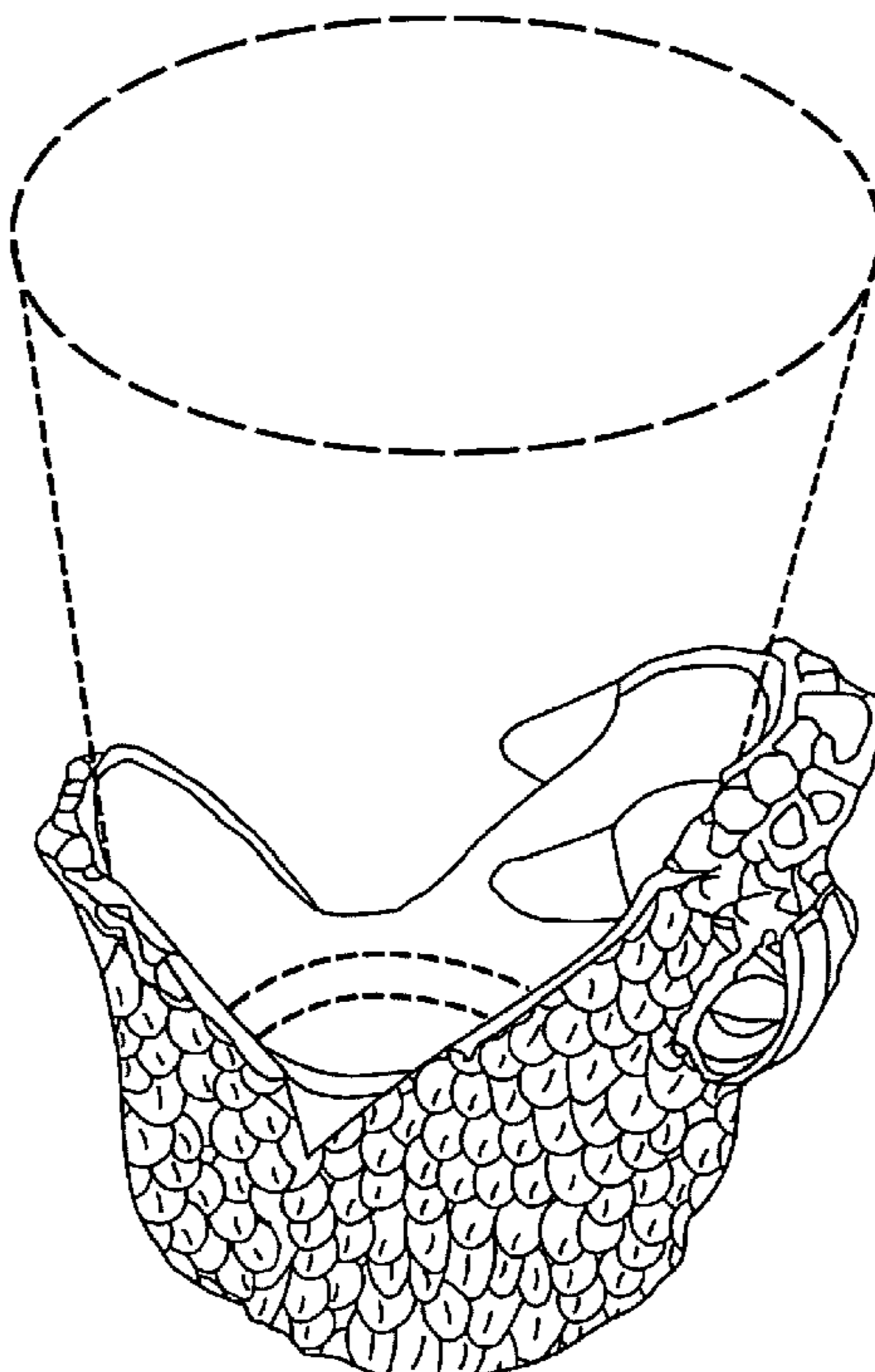
FIG. 5 is a right side view thereof;

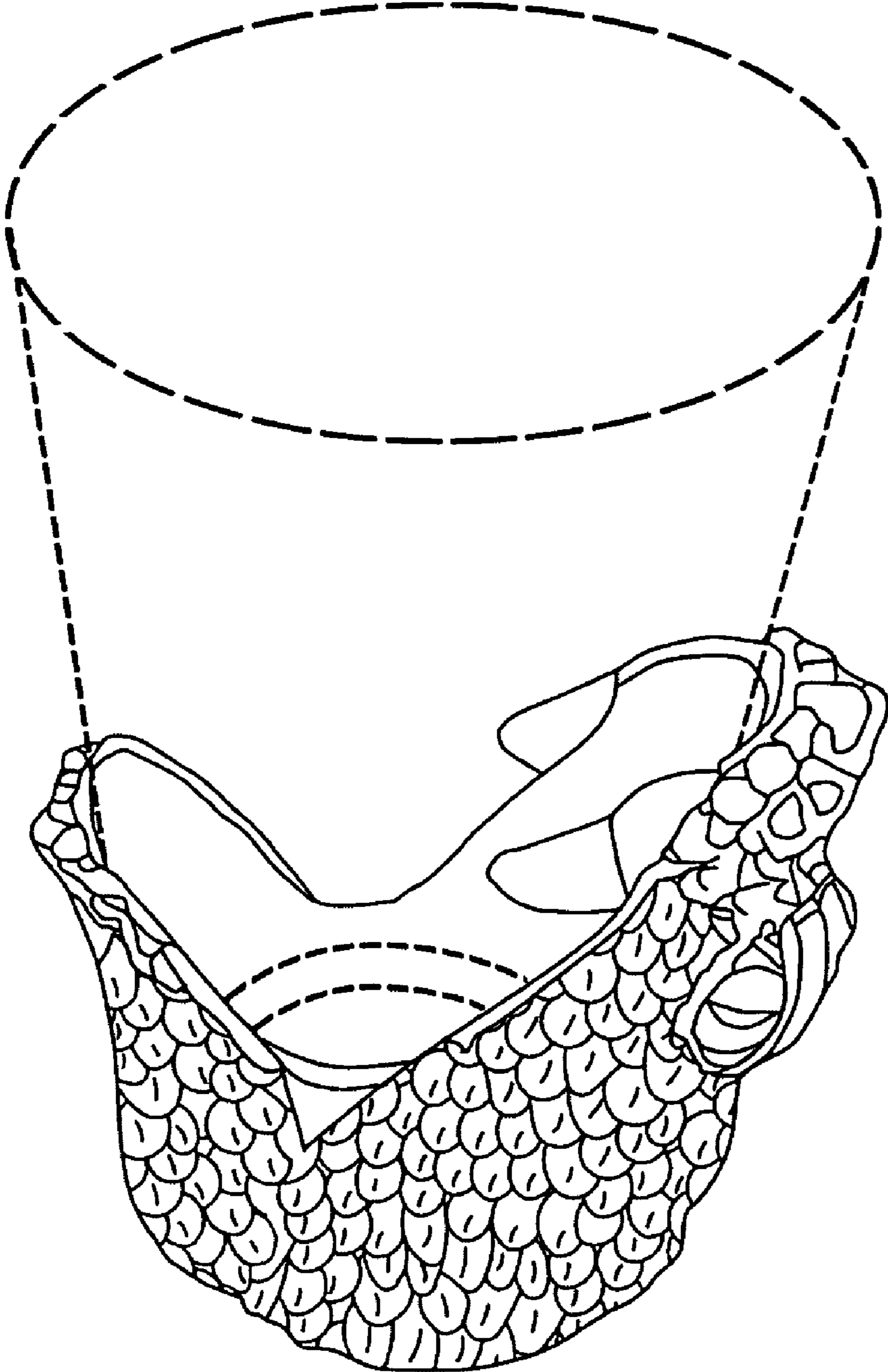

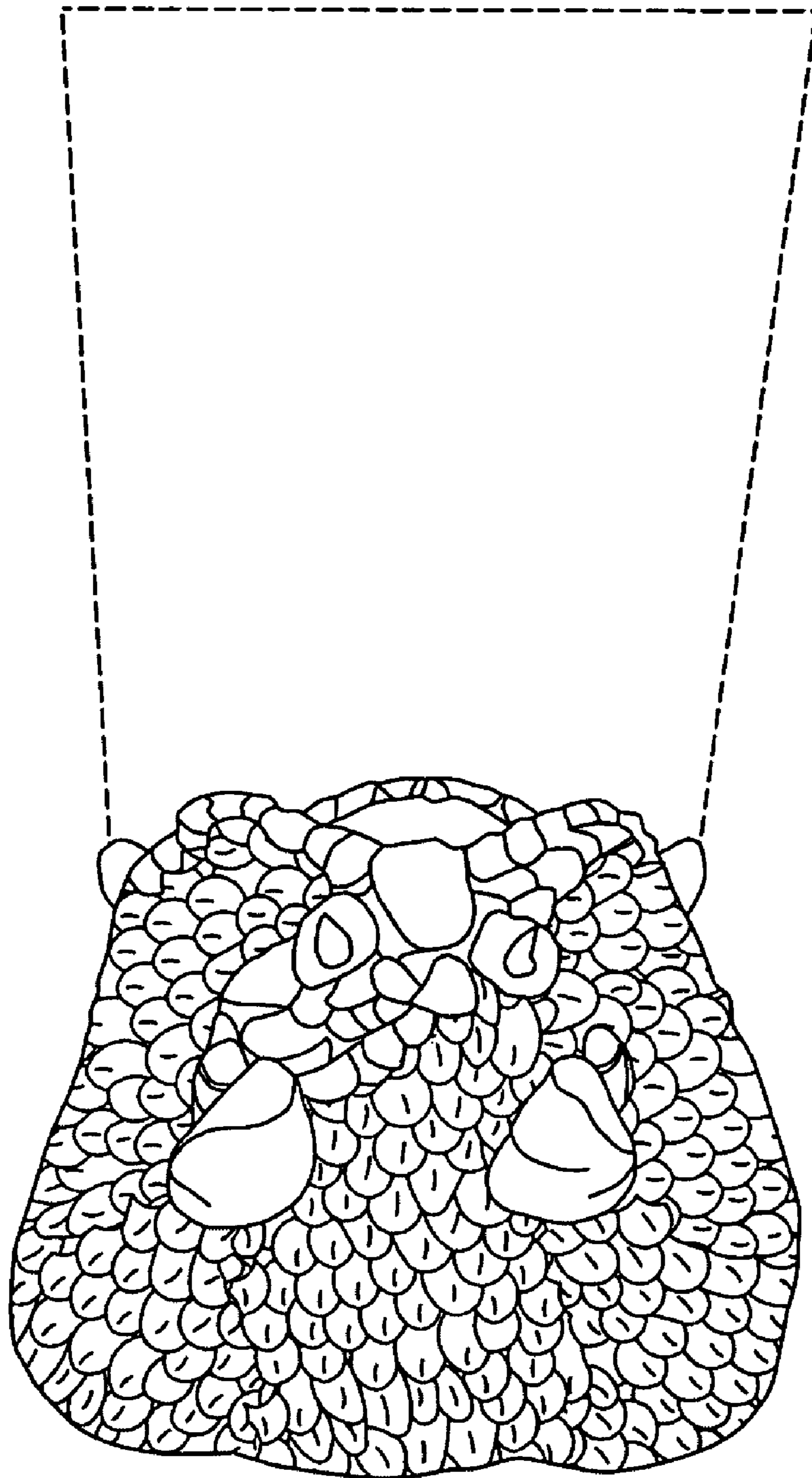

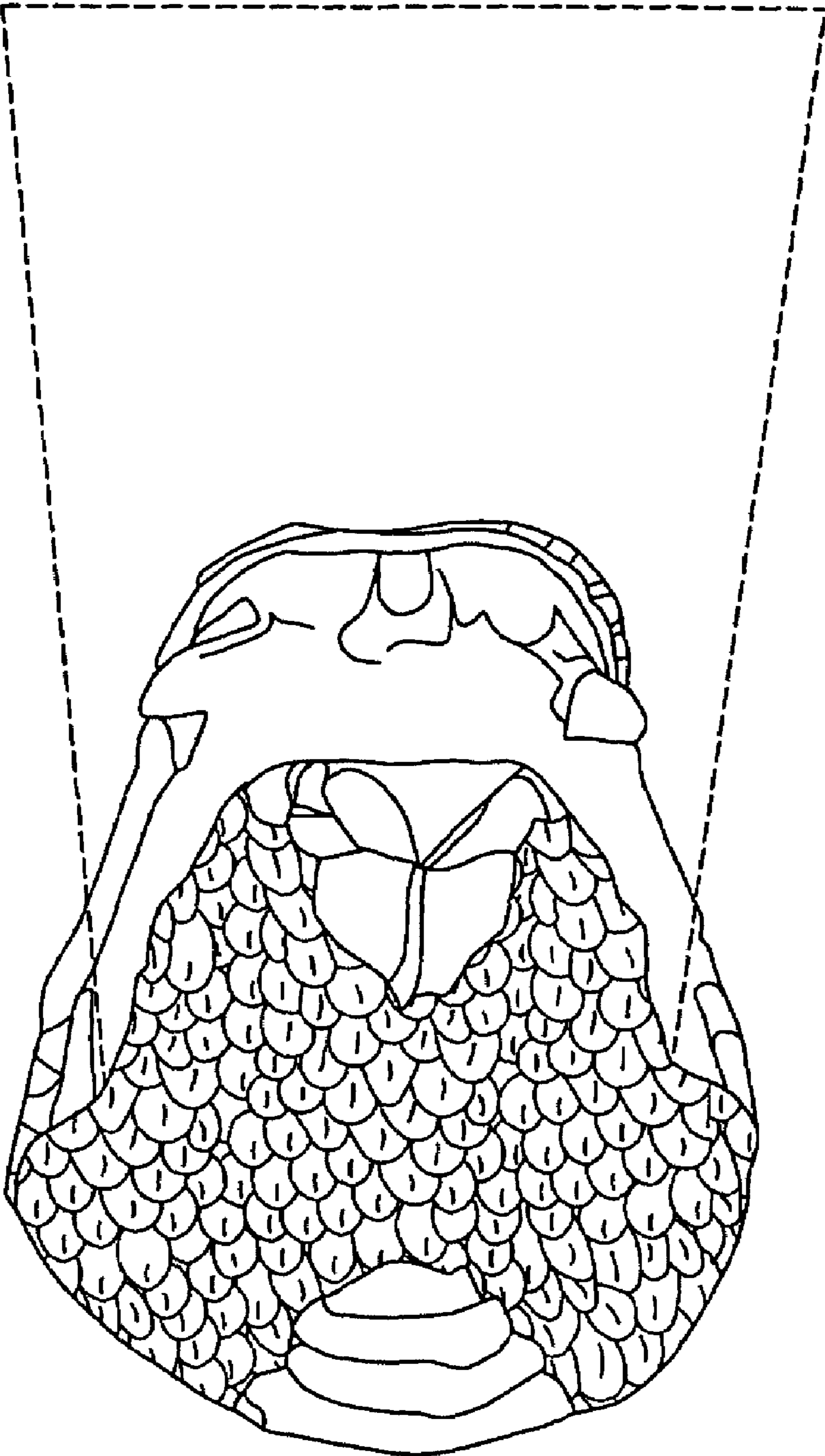

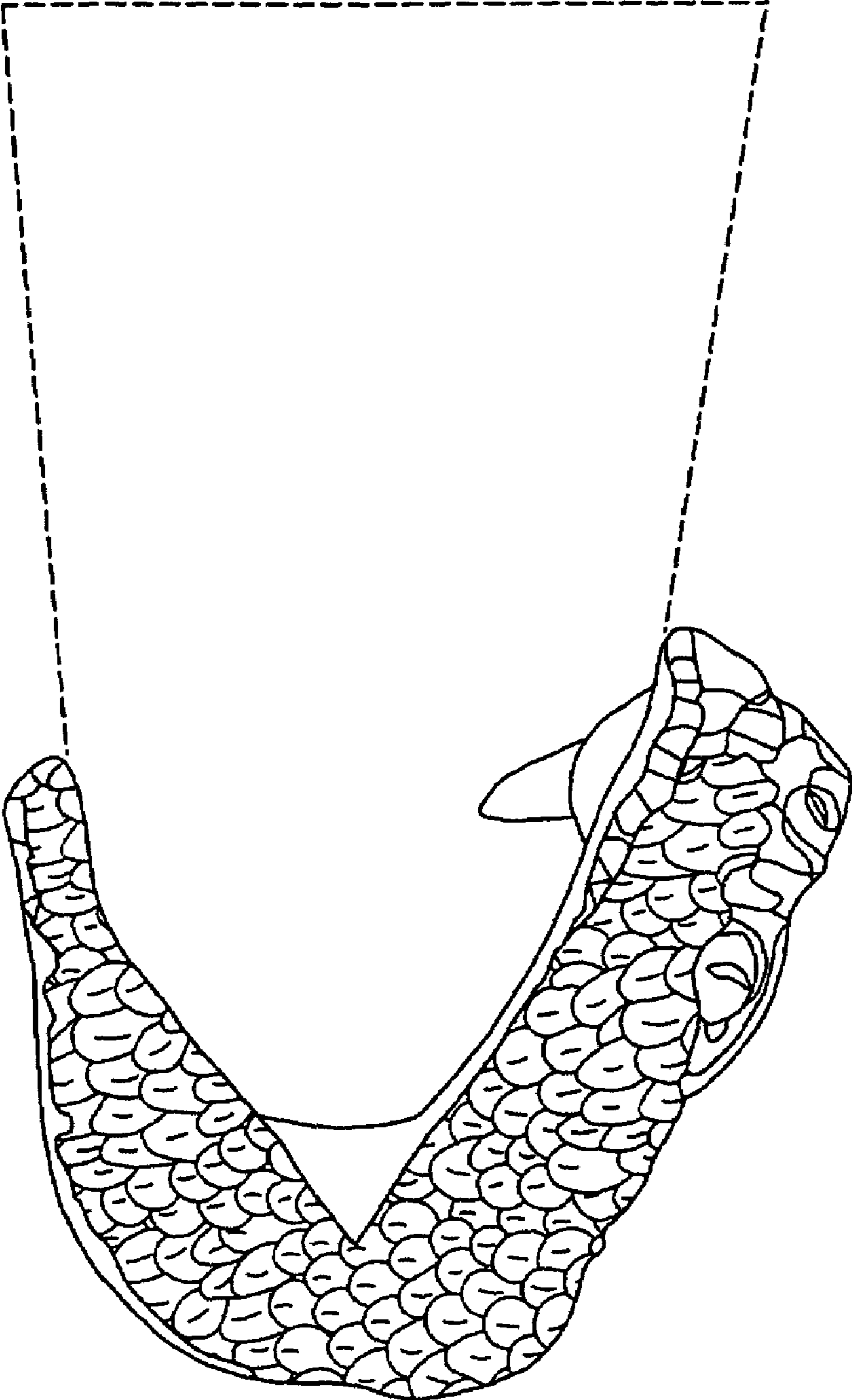

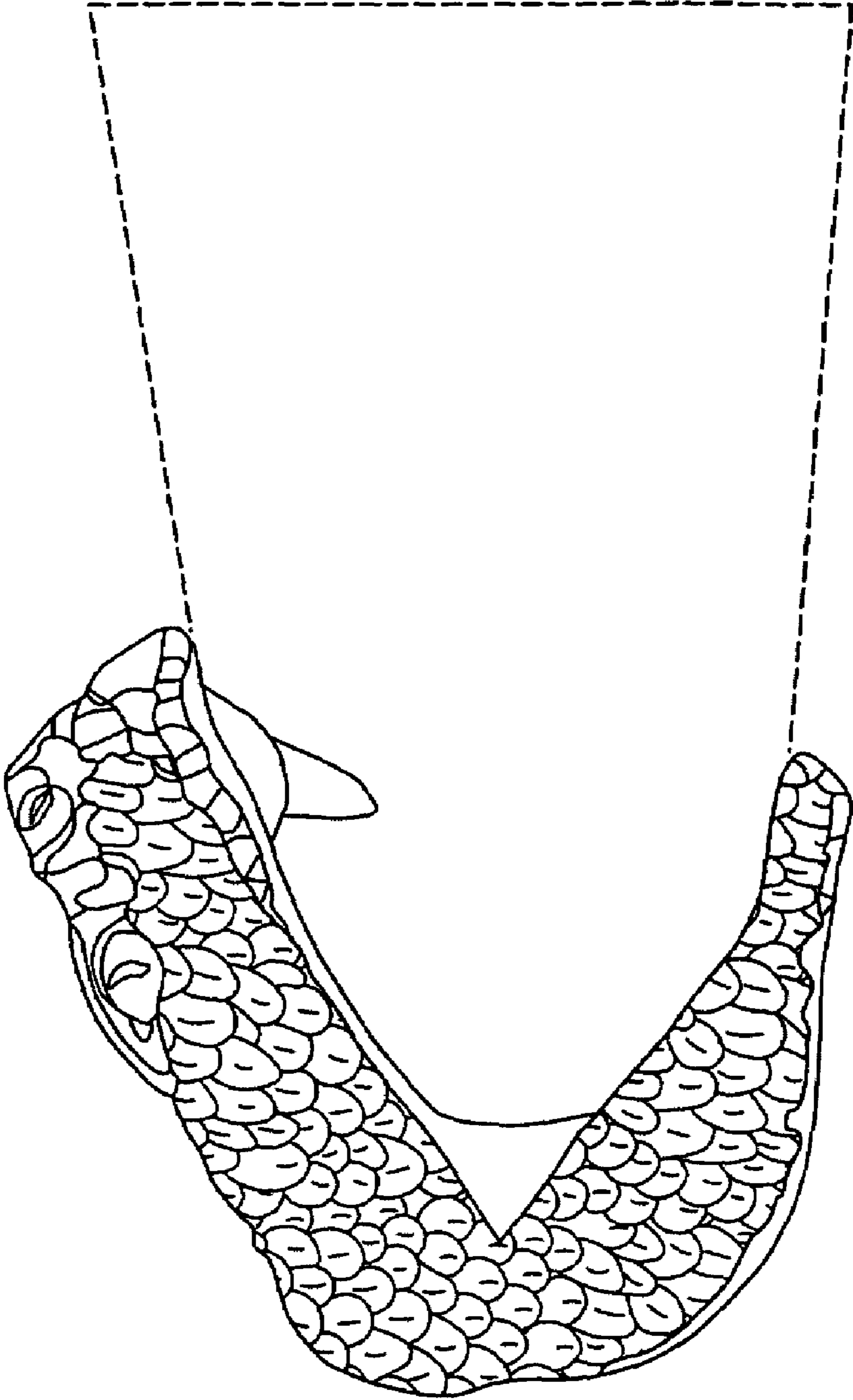

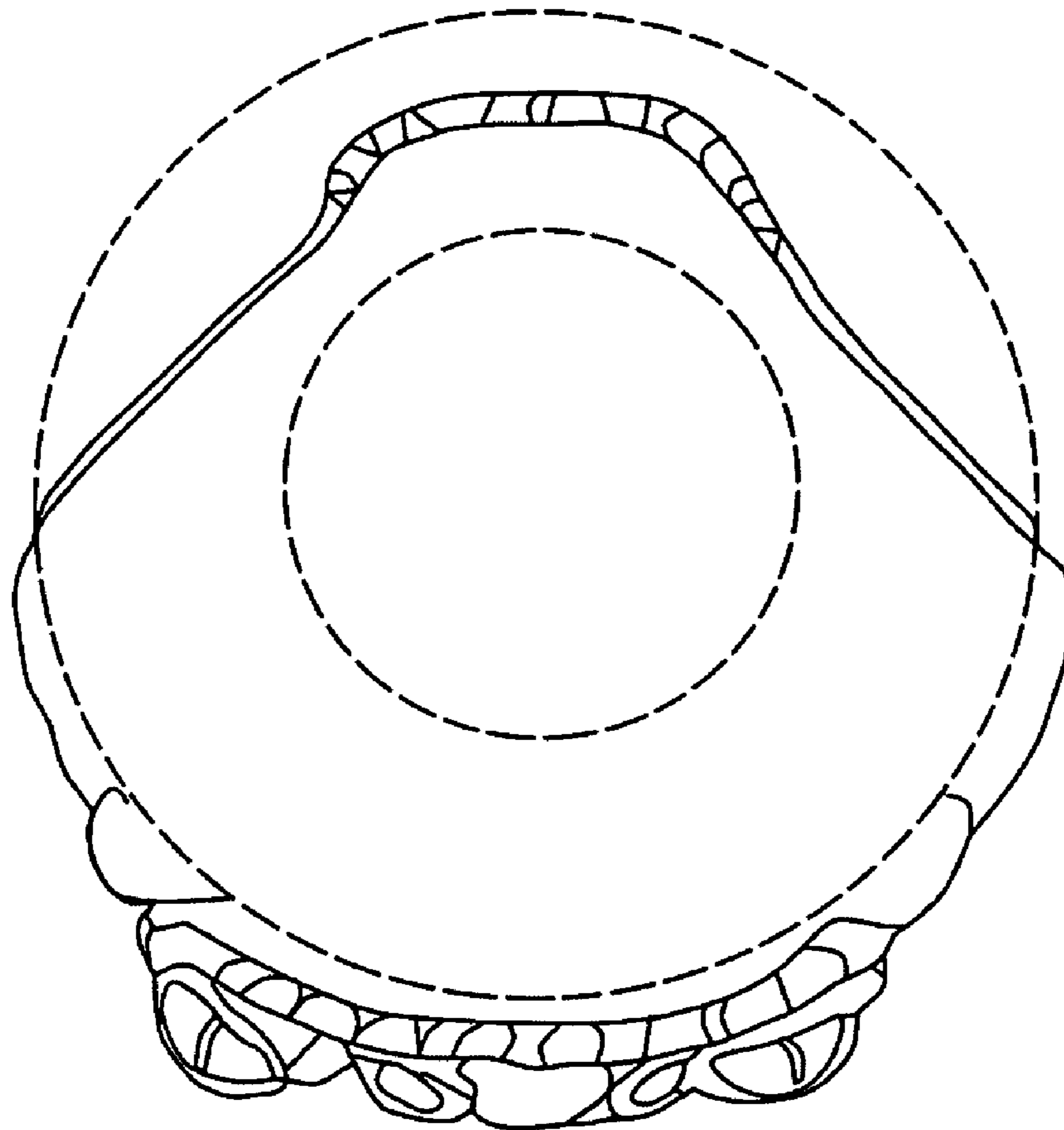

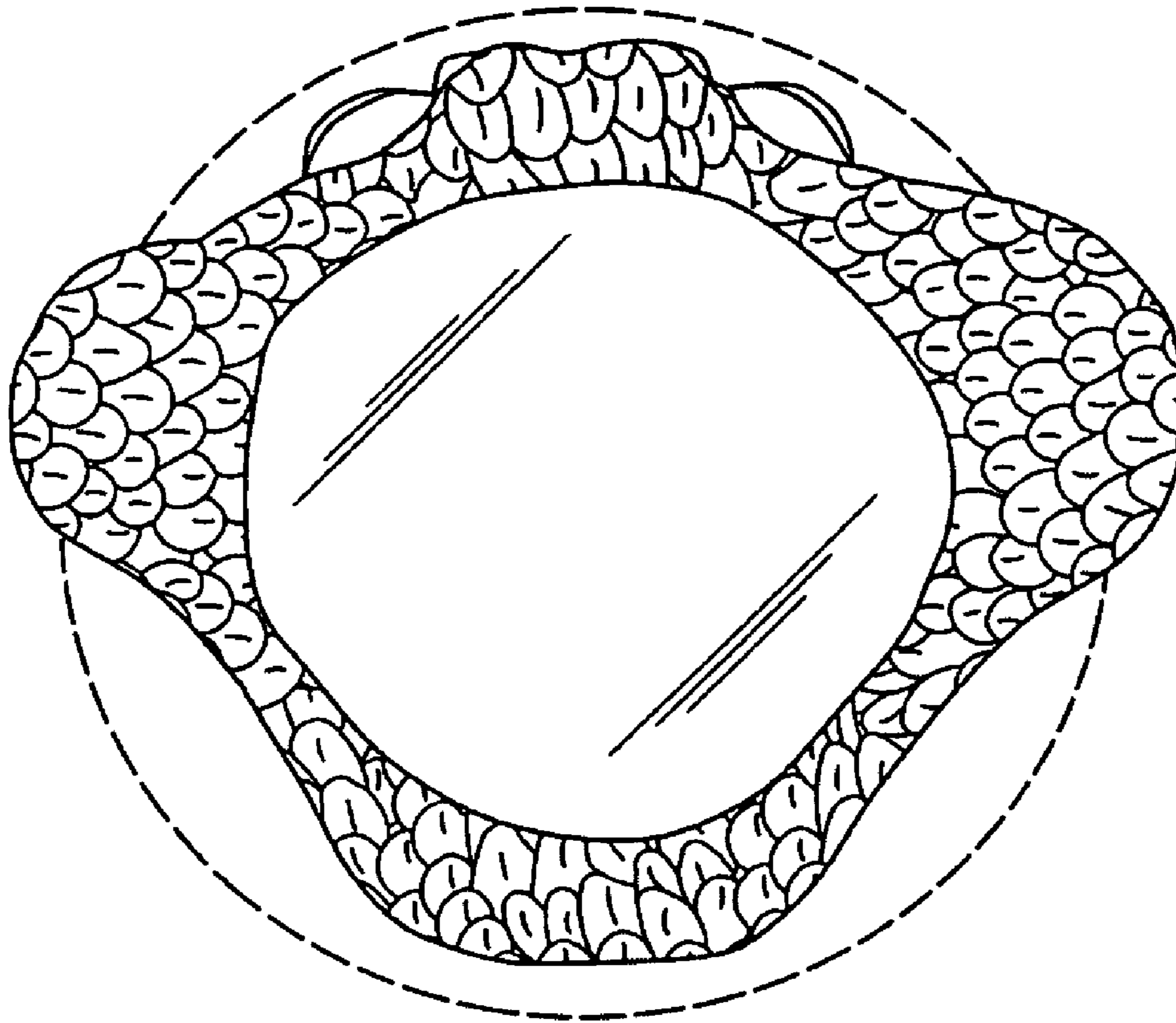
