(57) **CLAIM**

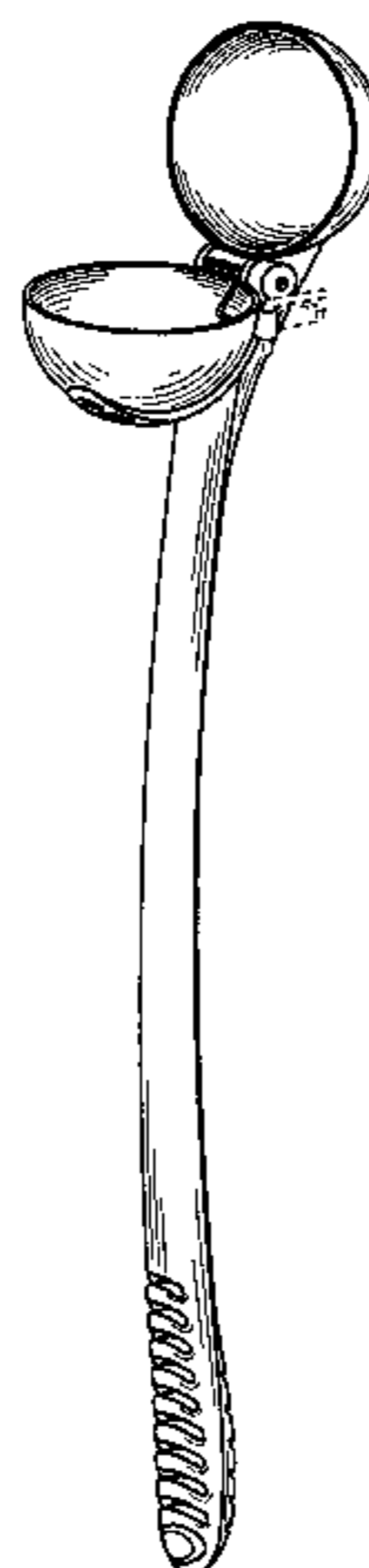
The ornamental design for snowball former and launcher, as shown and described.

DESCRIPTION

FIG. 1 is a front, right-side perspective view of a snowball former/launcher according to the invention;
FIG. 2 is a front plan view thereof;
FIG. 3 is a right-side plan view thereof;
FIG. 4 is a left-side plan view thereof;
FIG. 5 is a rear plan view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

The broken line showing of portions of the snowball former and launcher are included for the purpose of illustrating environmental structure and forms no part of the claimed design.

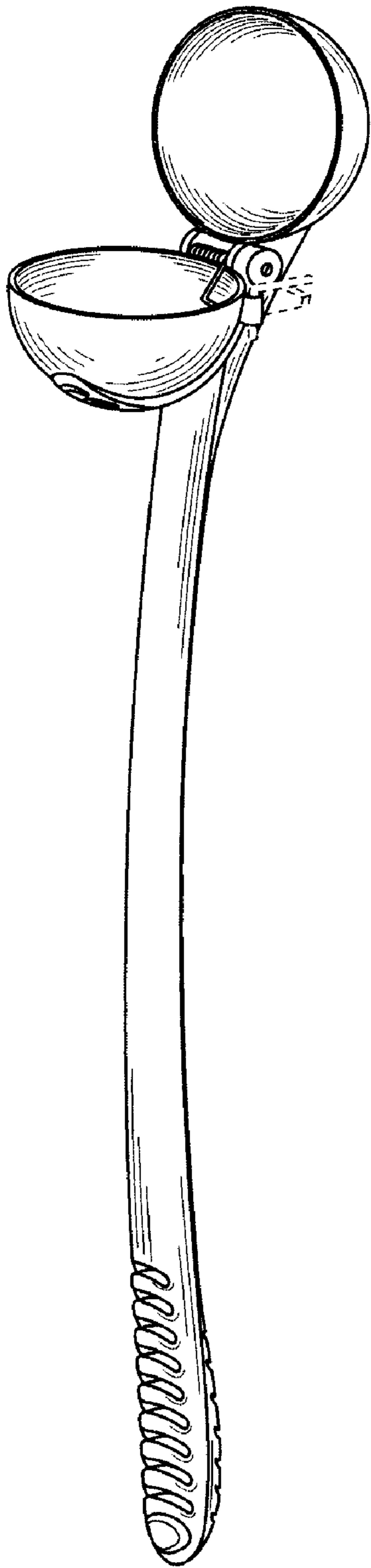

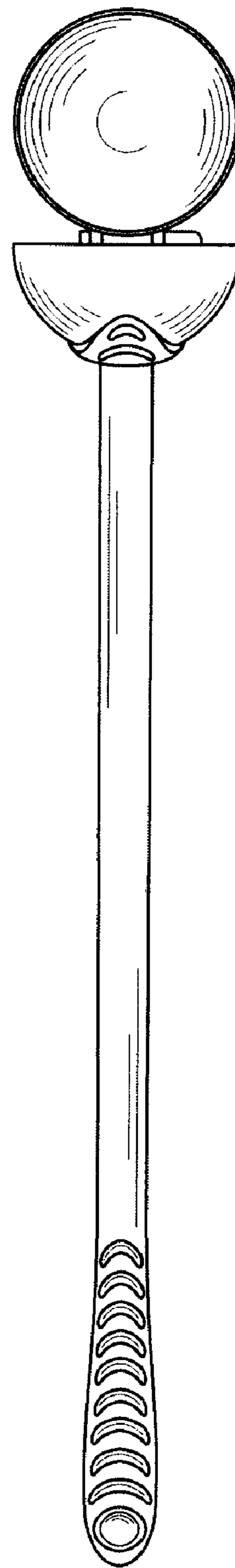

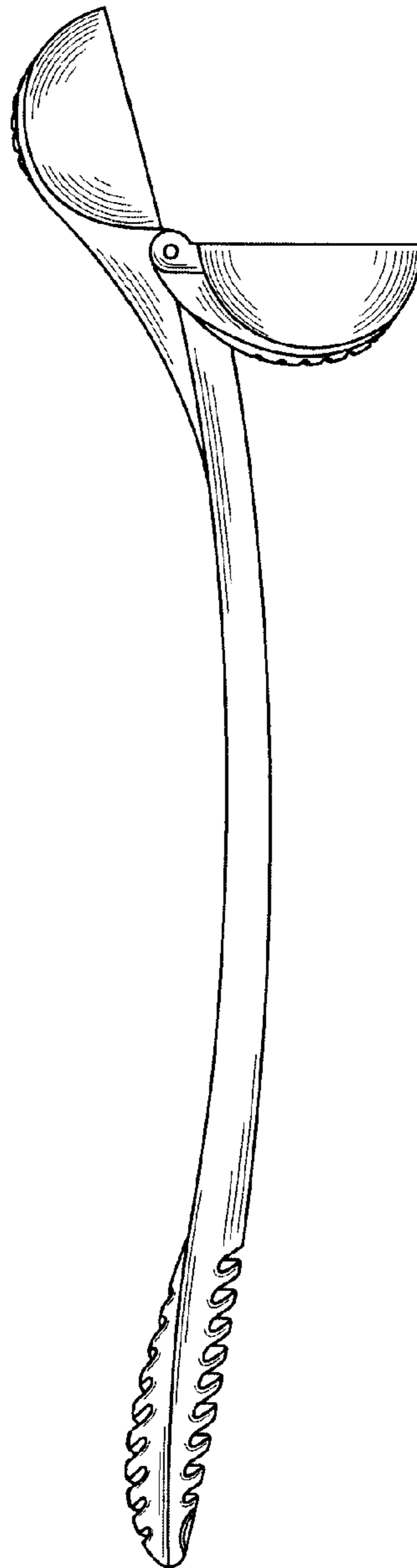

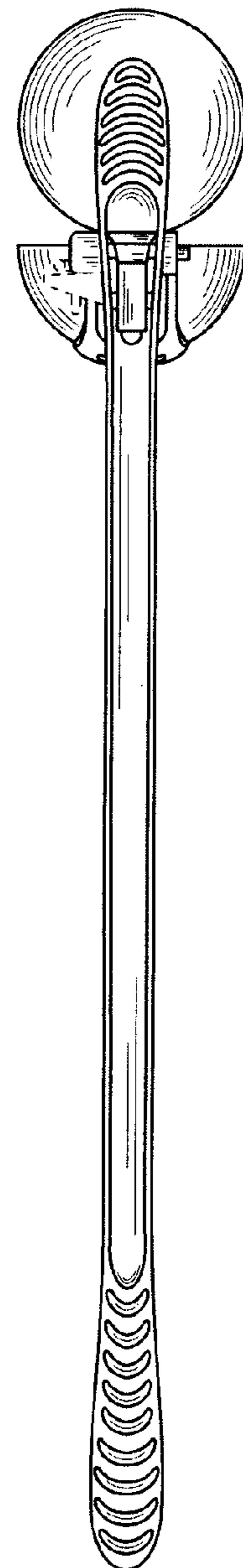

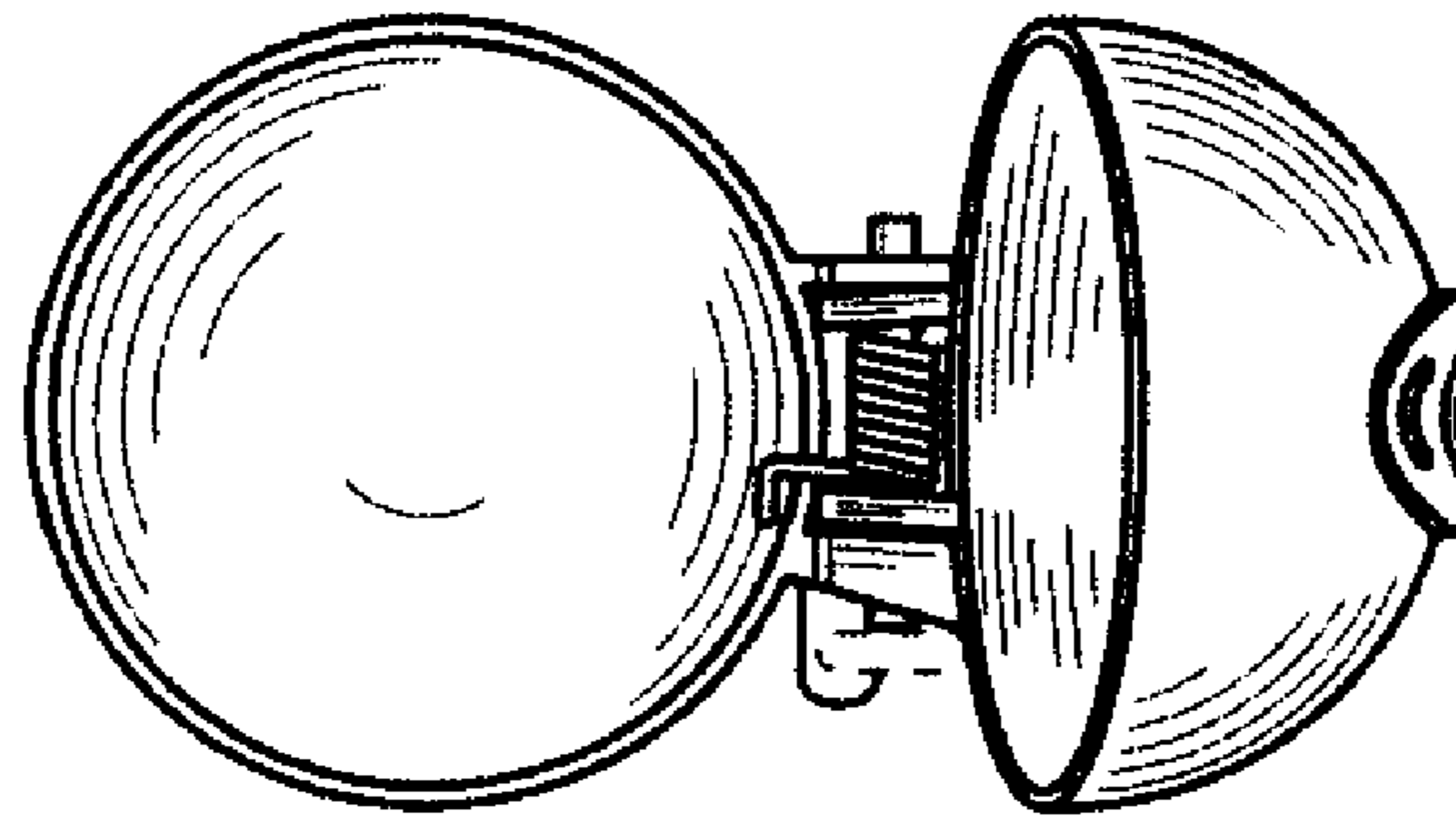

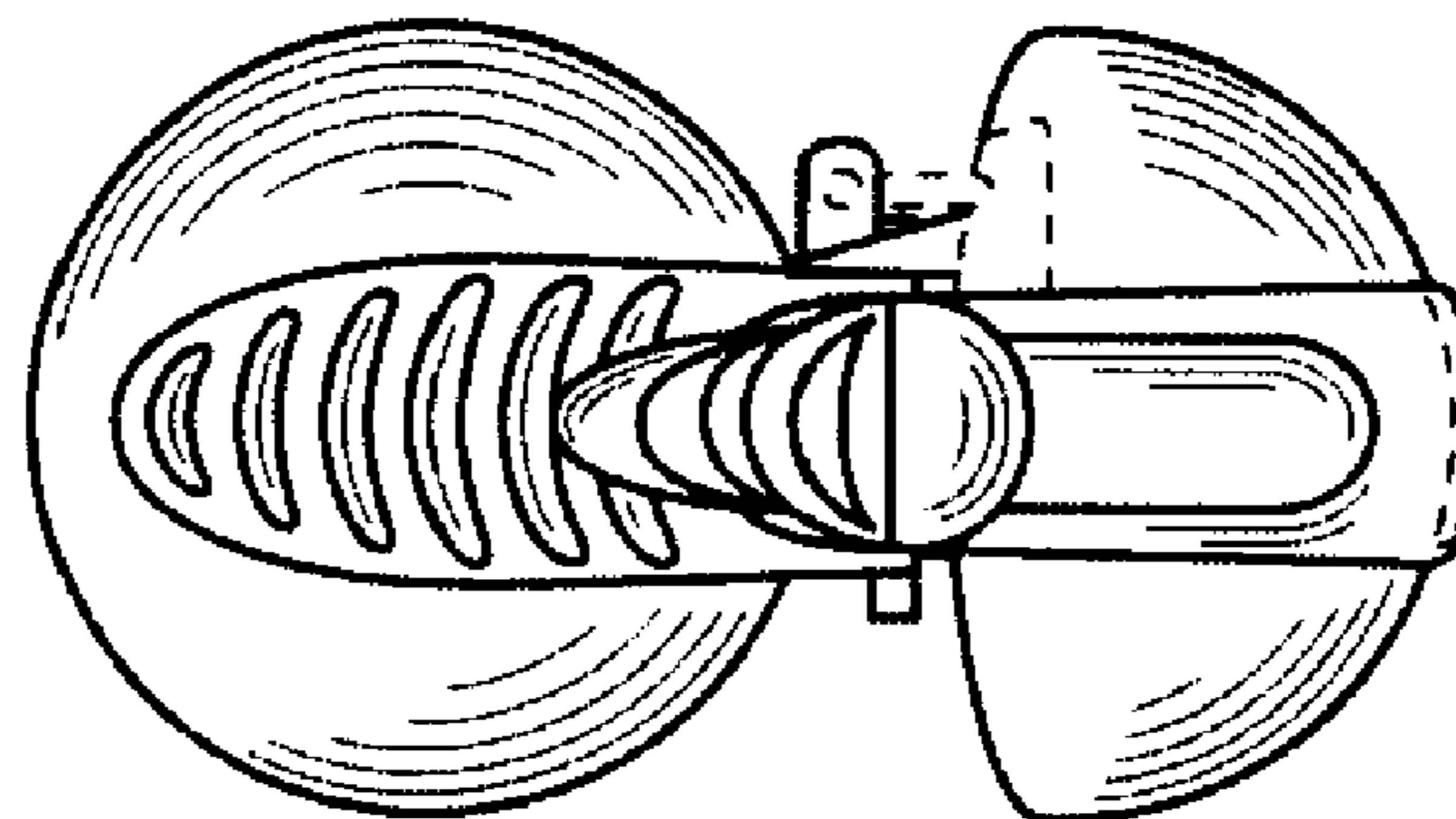
