(57) **CLAIM**

The ornamental design for a self-venting microwaveable reclosable standup pouch, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a self-venting microwaveable reclosable standup pouch showing my new design;

FIG. 2 is a front side elevational view thereof;

FIG. 3 is a rear side elevational view thereof;

FIG. 4 is a left side elevational view thereof, the opposite side view being a mirror image thereof;

FIG. 5 is a top plan view thereof;

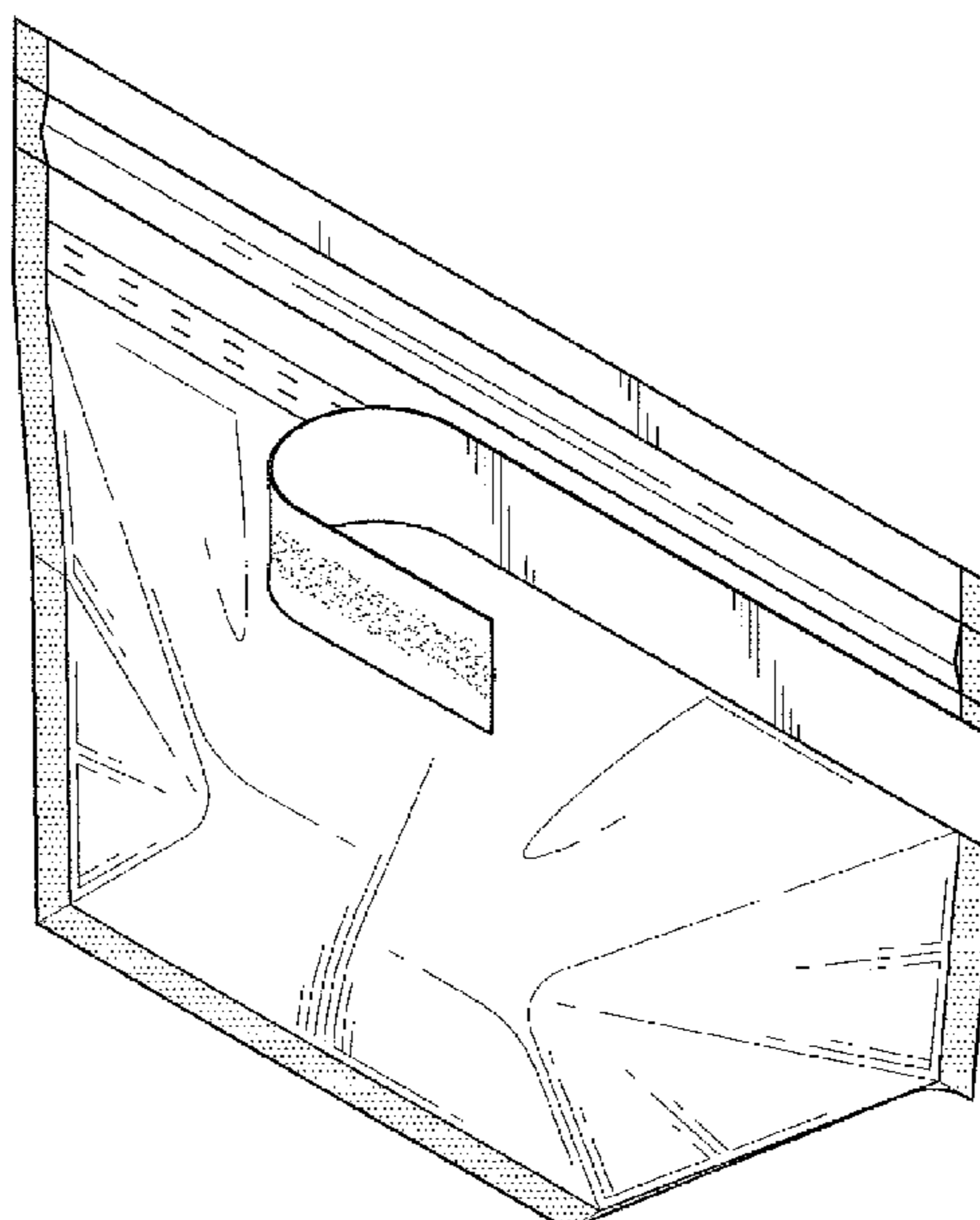
FIG. 6 is a bottom plan view thereof;

FIG. 7 is a perspective view of the a self-venting microwaveable reclosable standup pouch showing a tab on a venting zone being released;

FIG. 8 is an enlarged view of the portion of FIG. 4 indicated by a dashed circle 8; and,

FIG. 9 is an enlarged view of the portion of FIG. 4 indicated by a dashed circle 9.

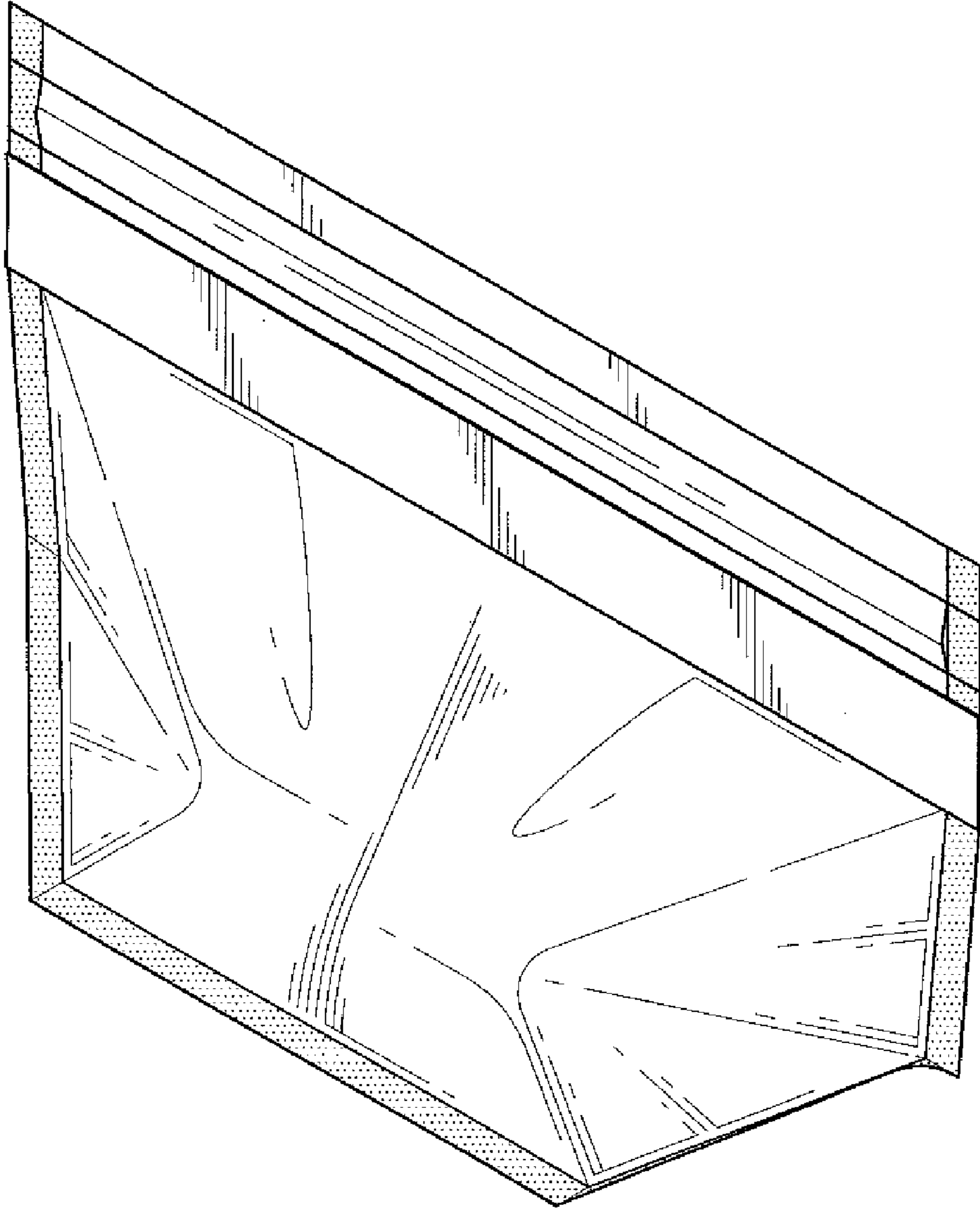

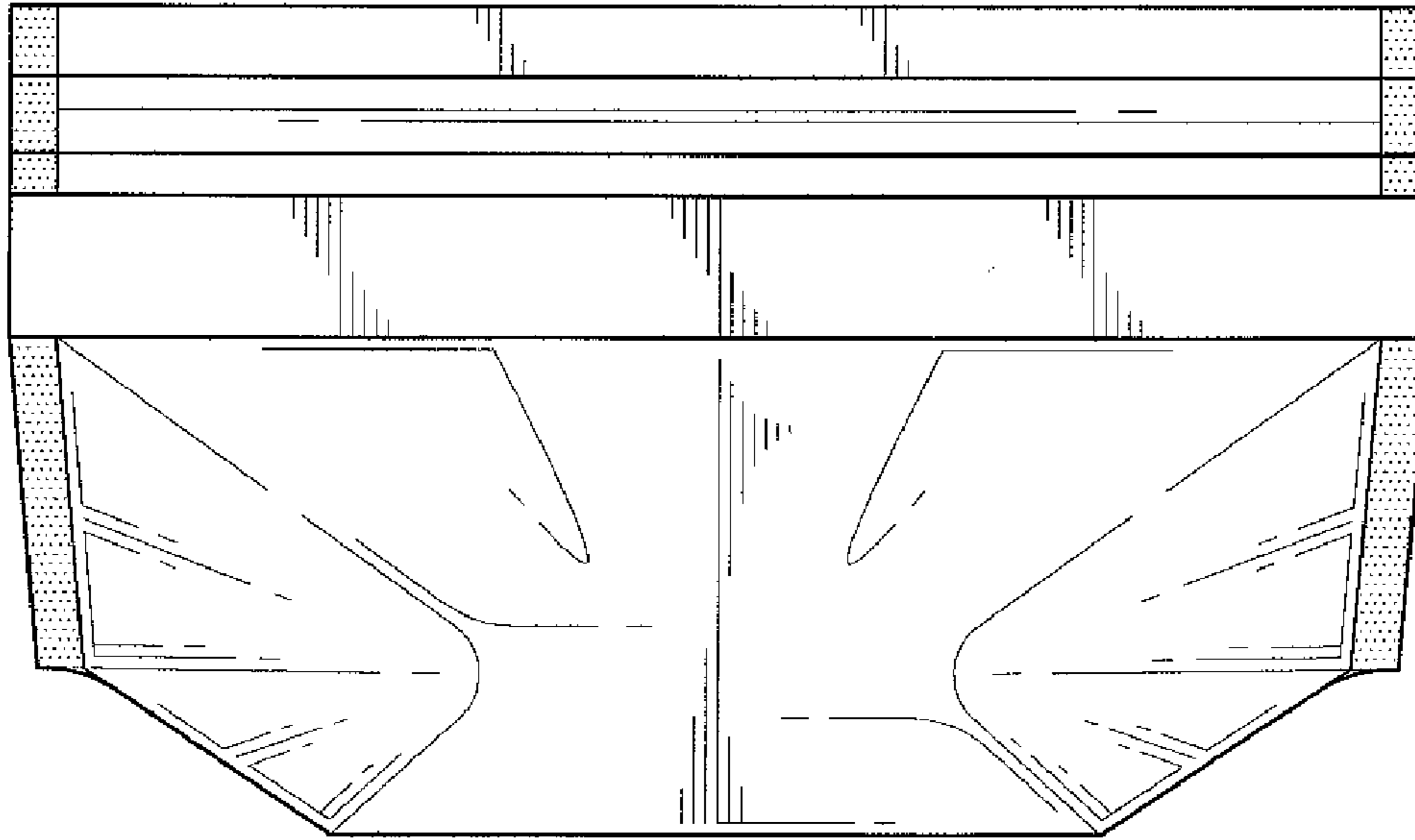

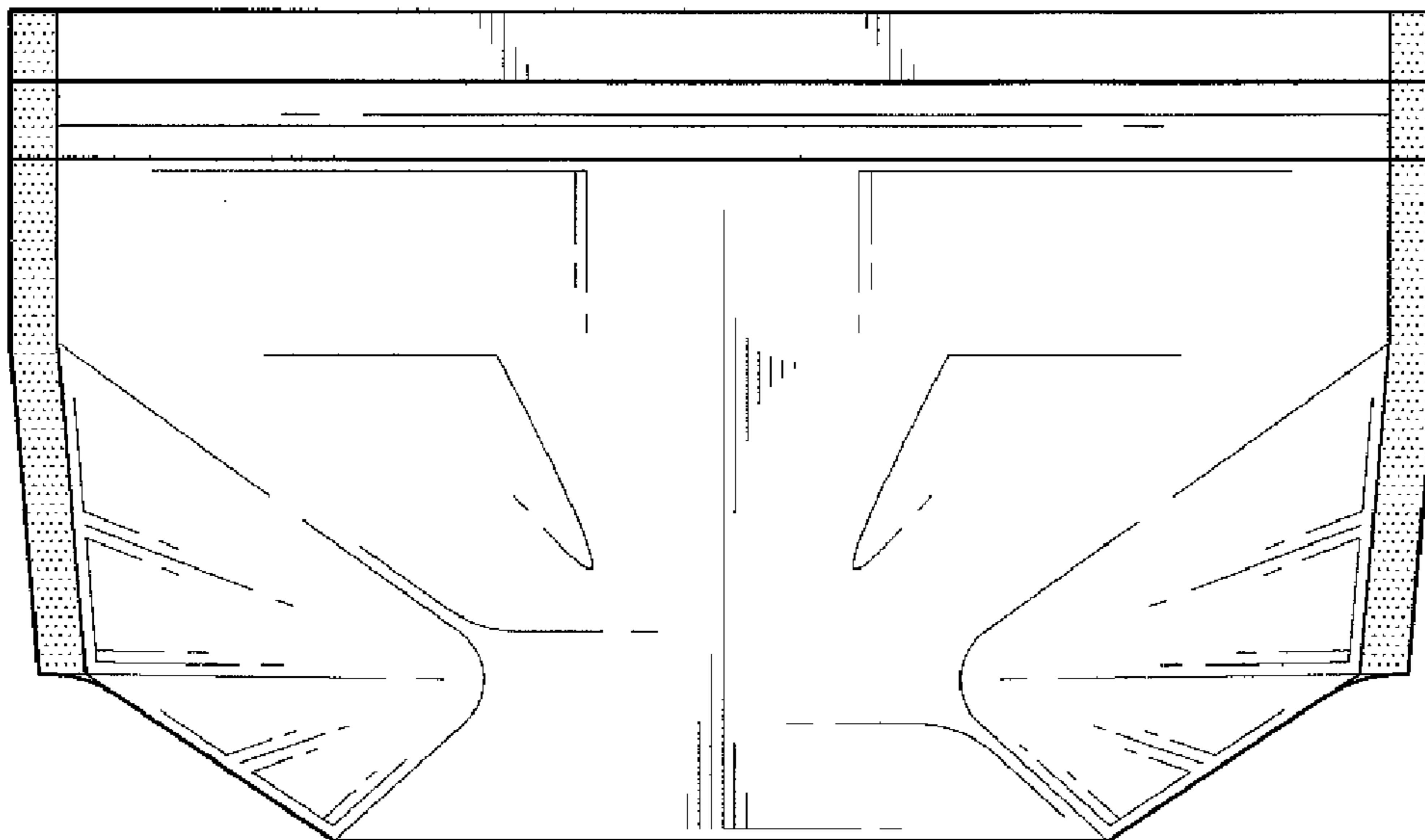

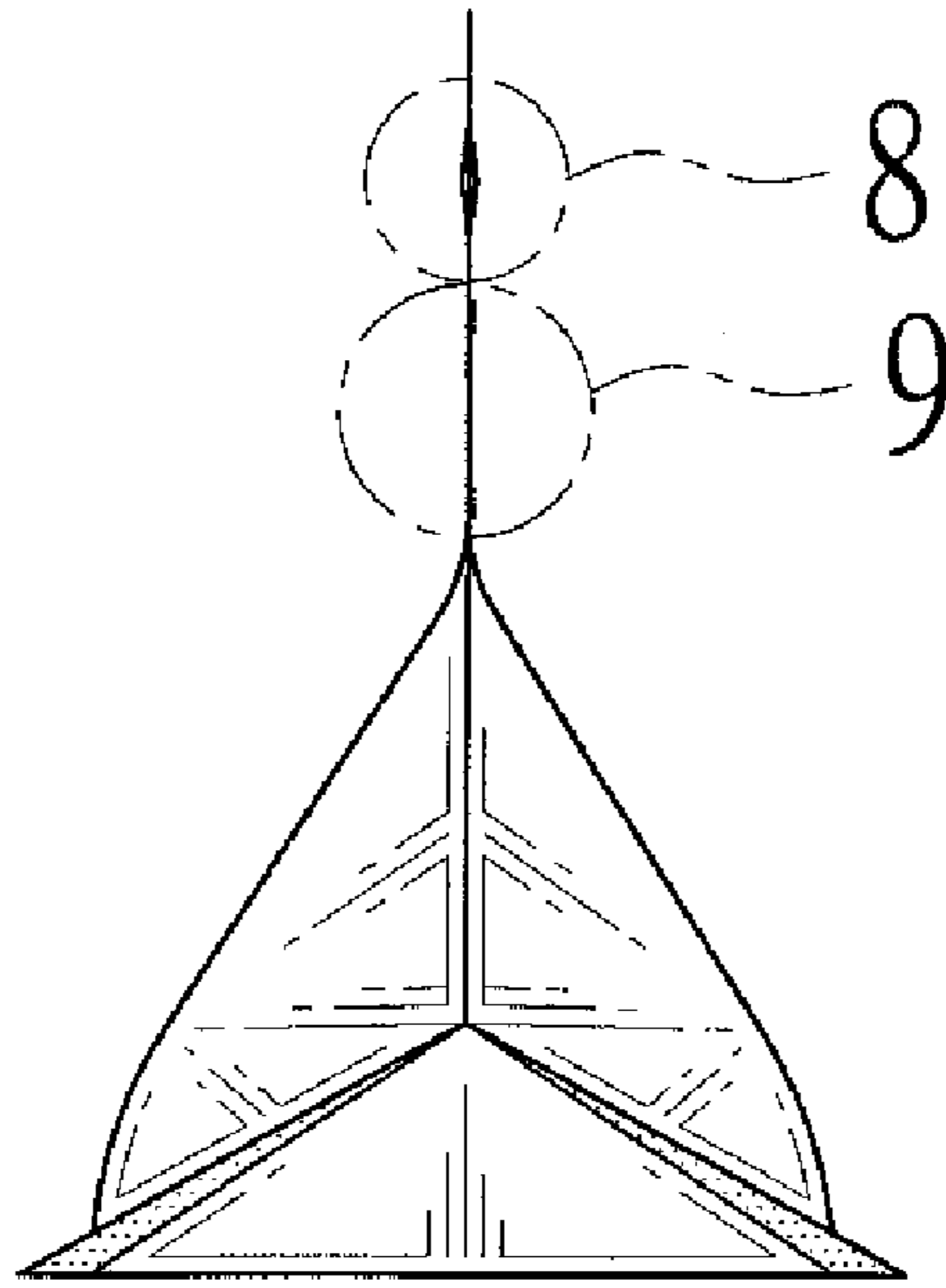

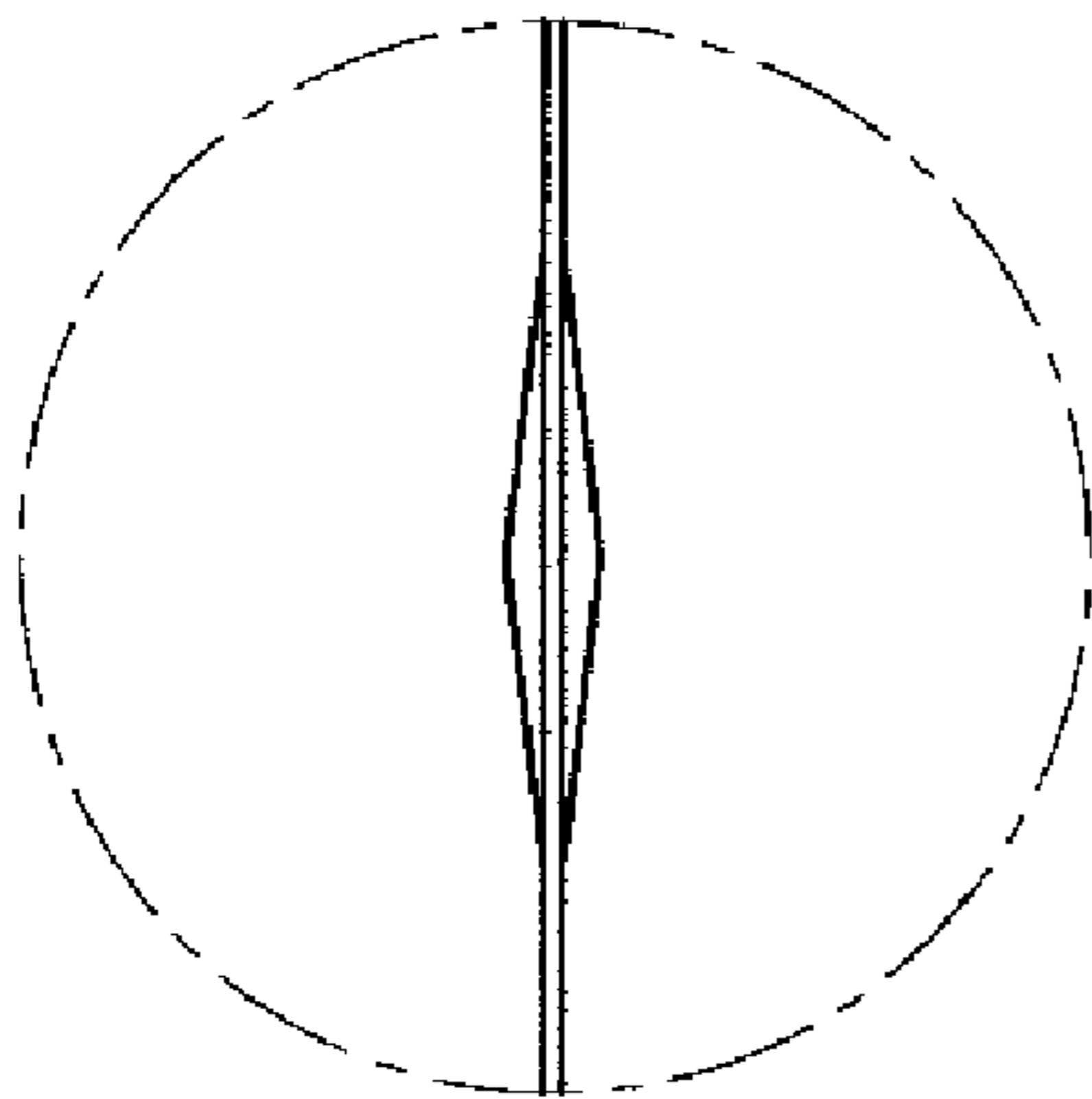

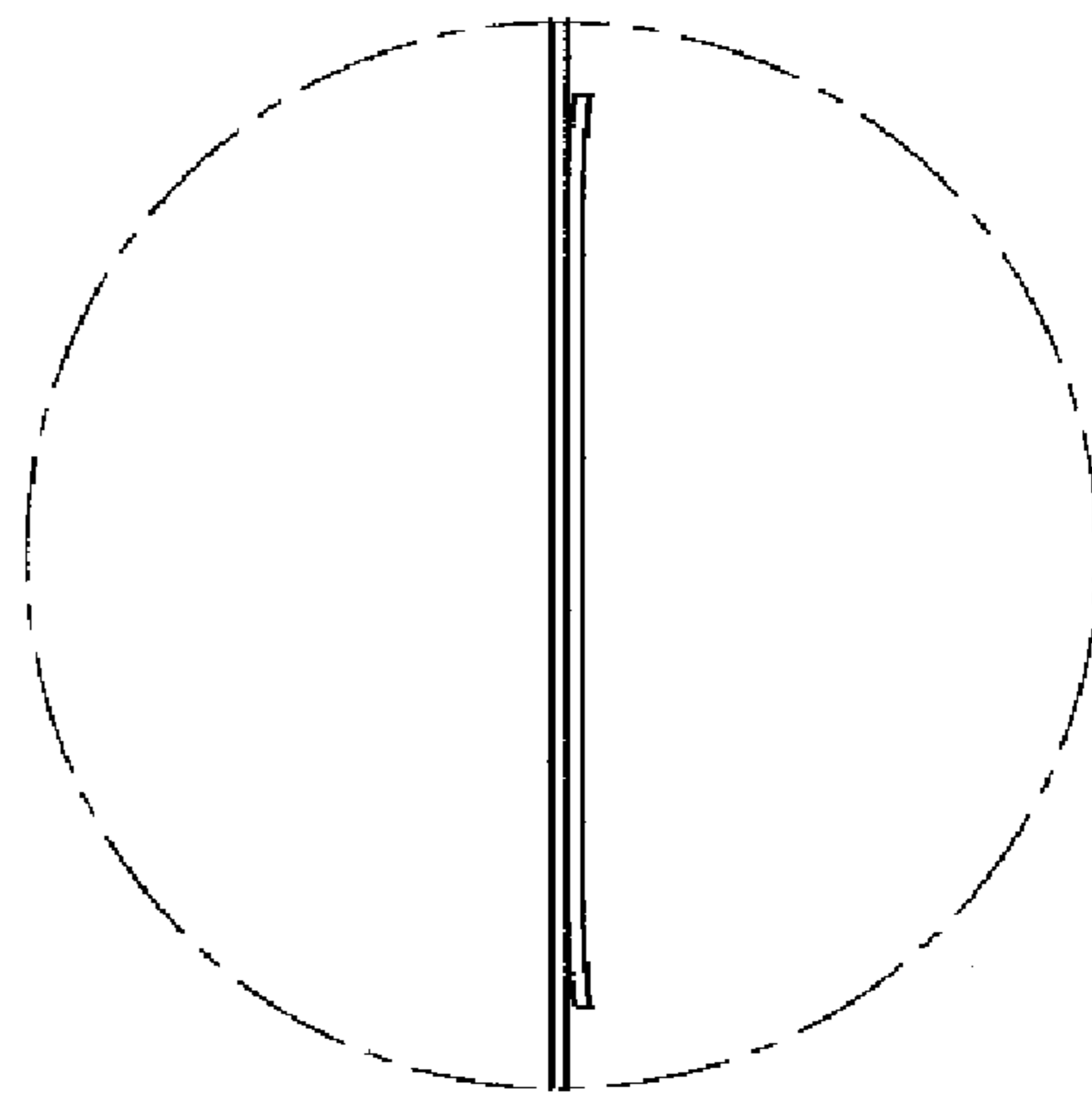

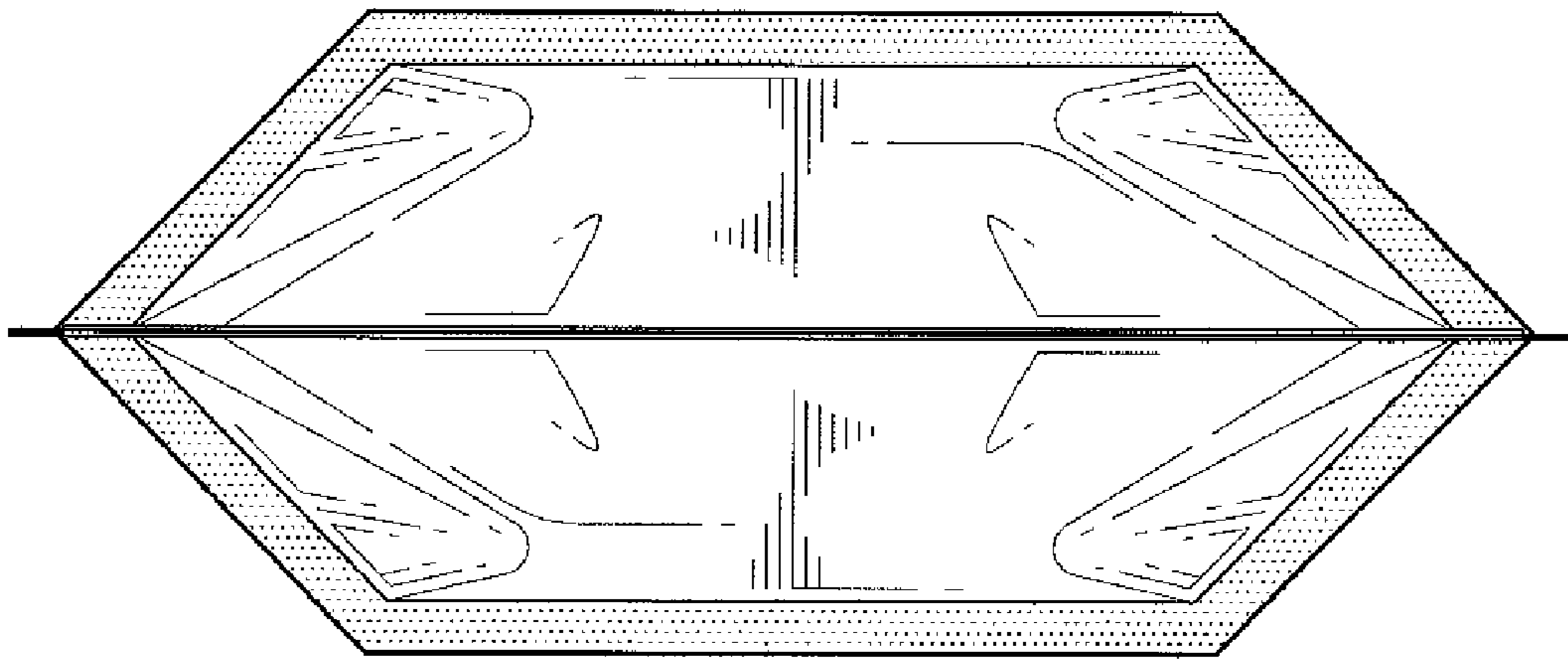

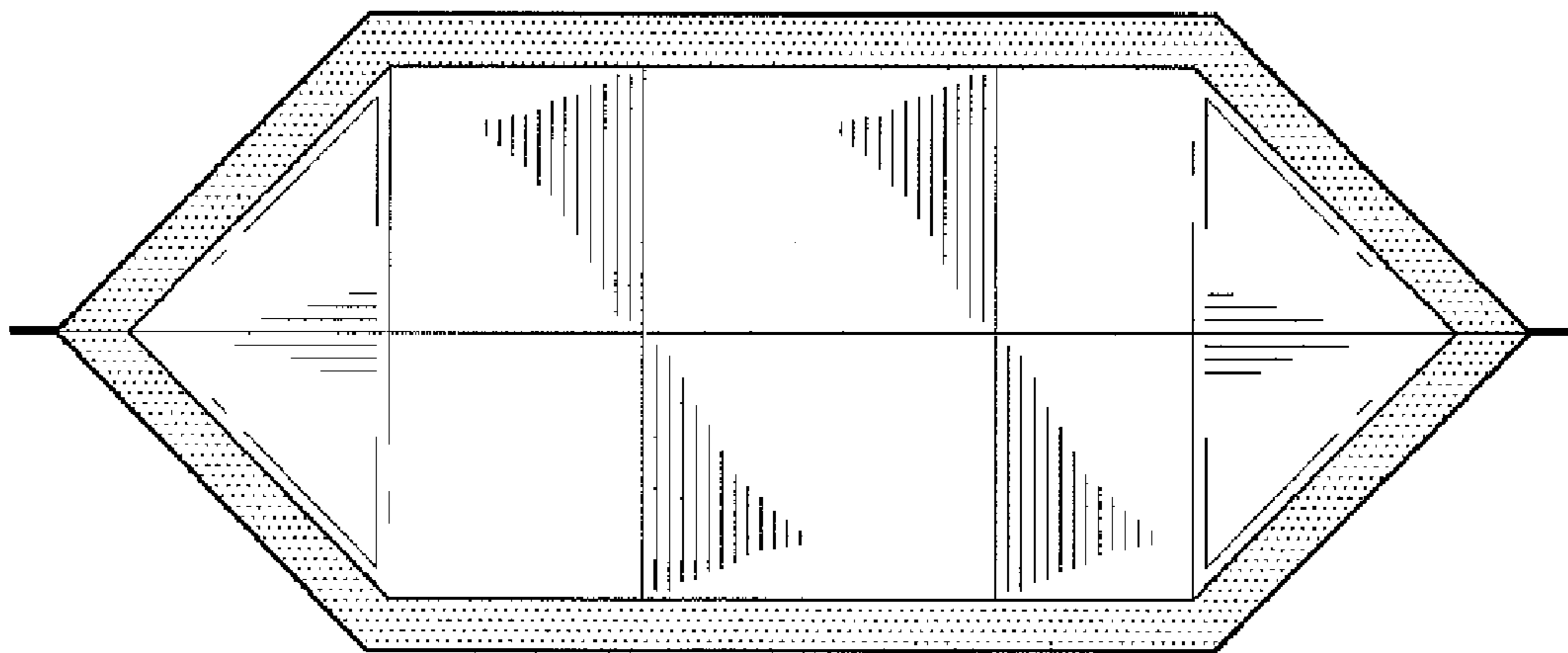

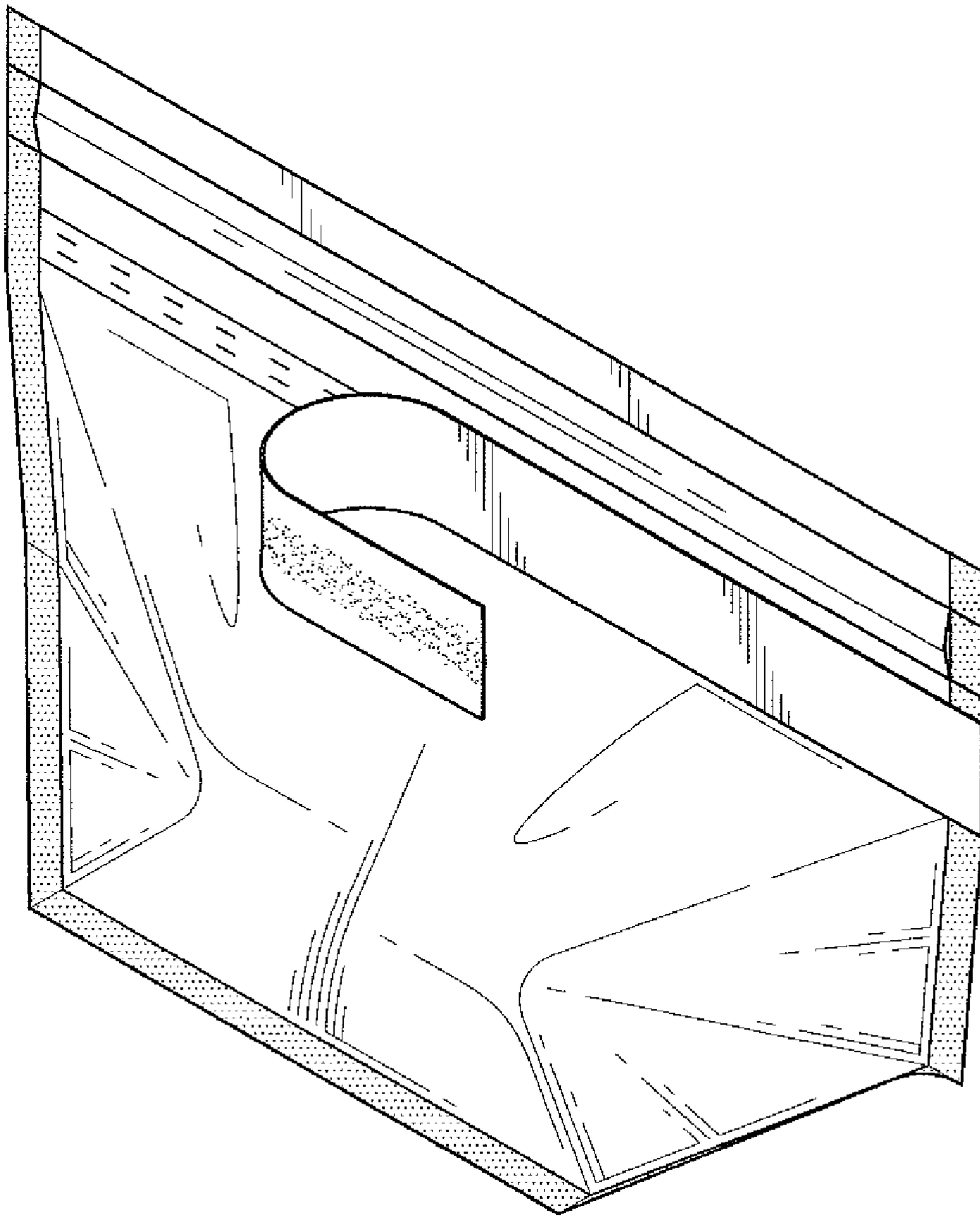
