The ornamental design for eyewear, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of eyewear showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a top plan view thereof;

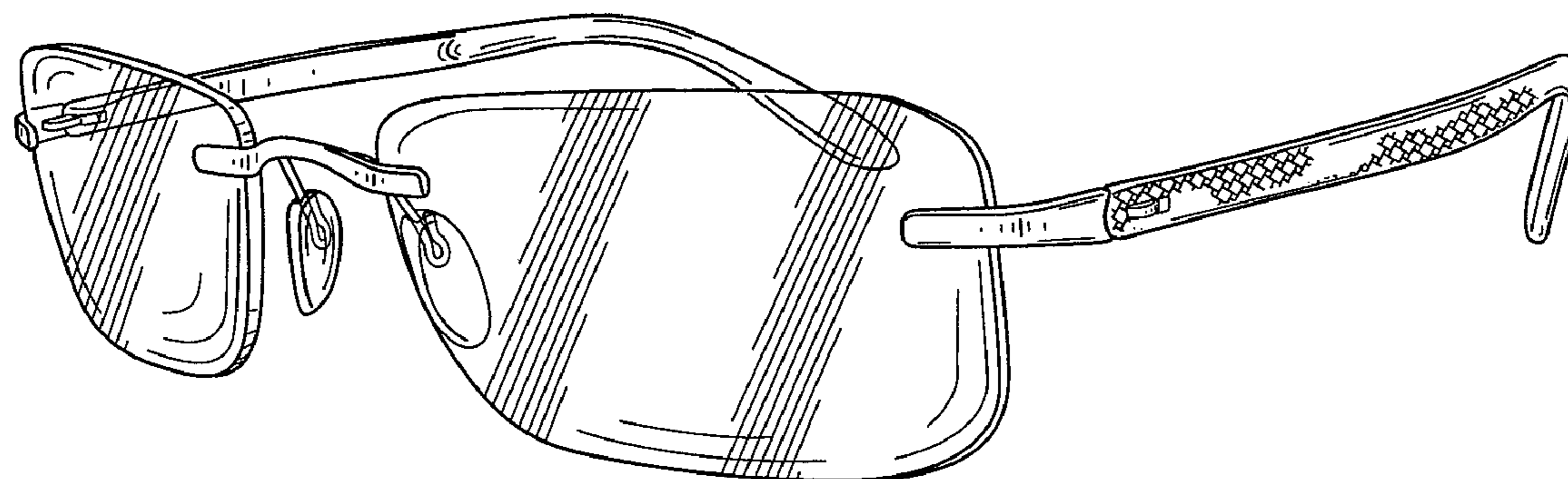
FIG. 5 is a bottom plan view thereof;

FIG. 6 is a right side perspective view thereof, the left side perspective view being a mirror image thereof, and,

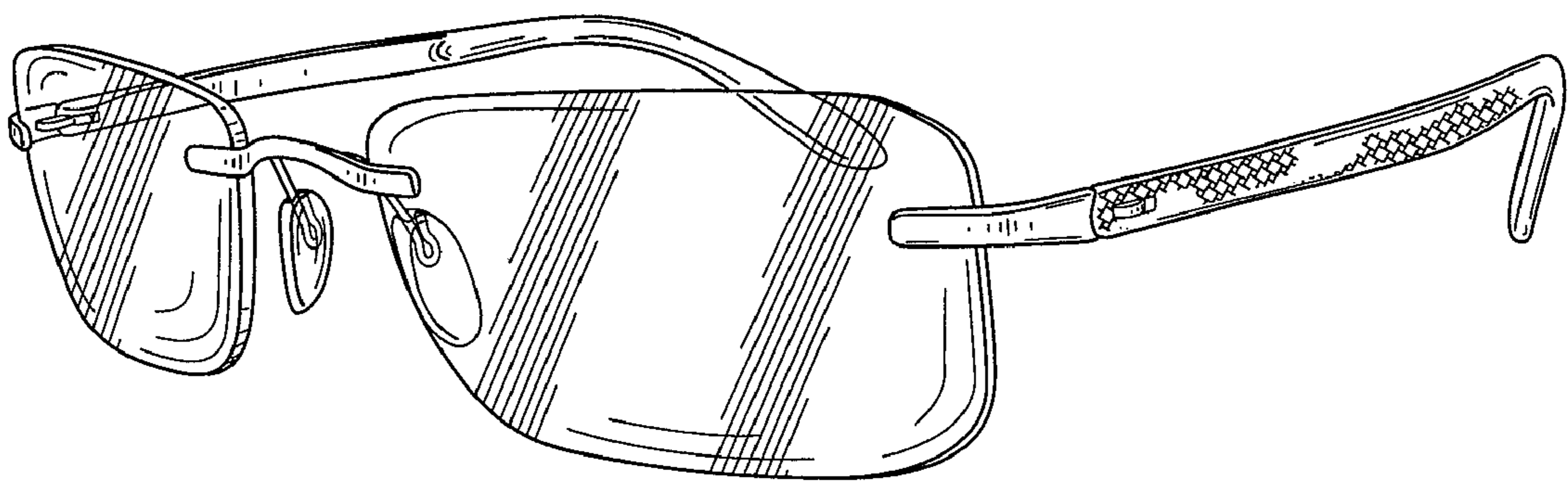

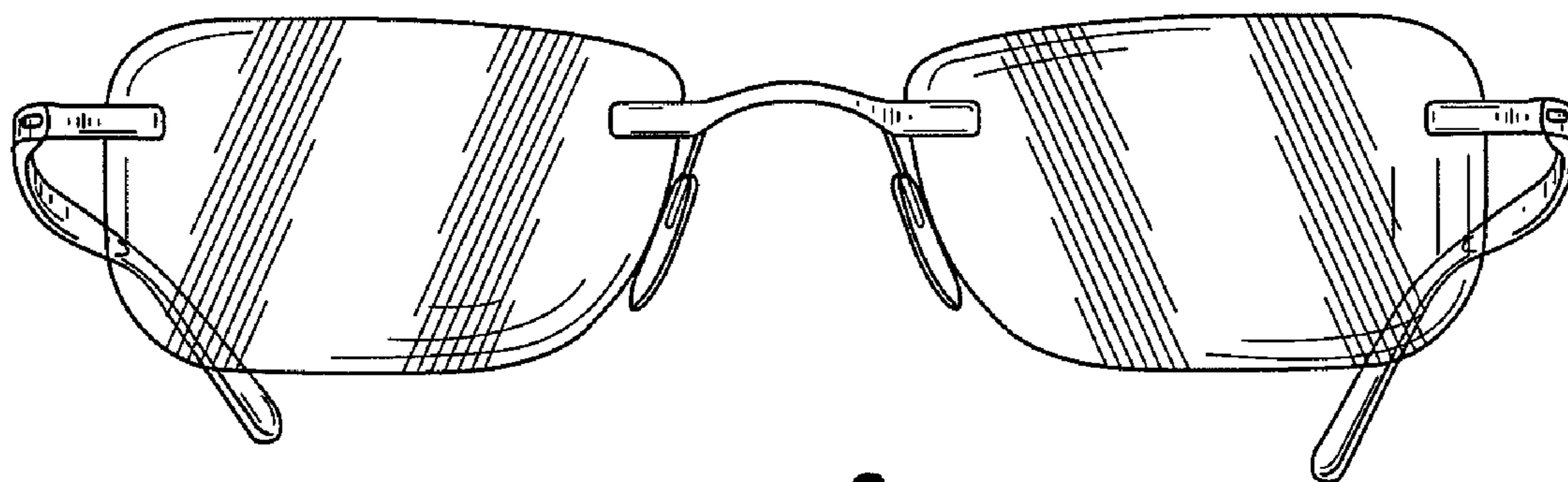

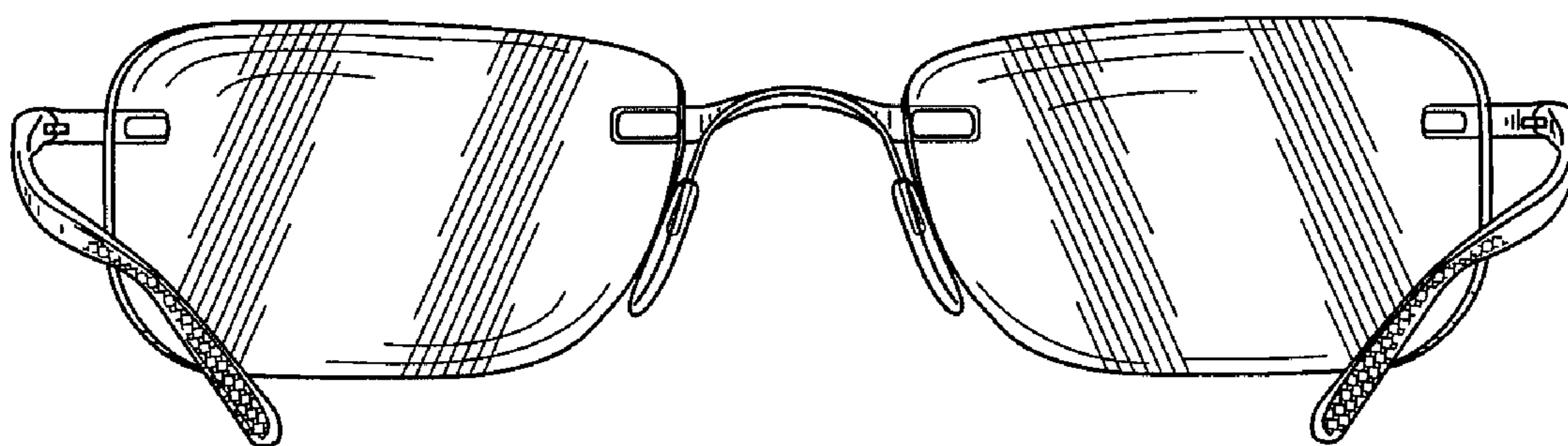

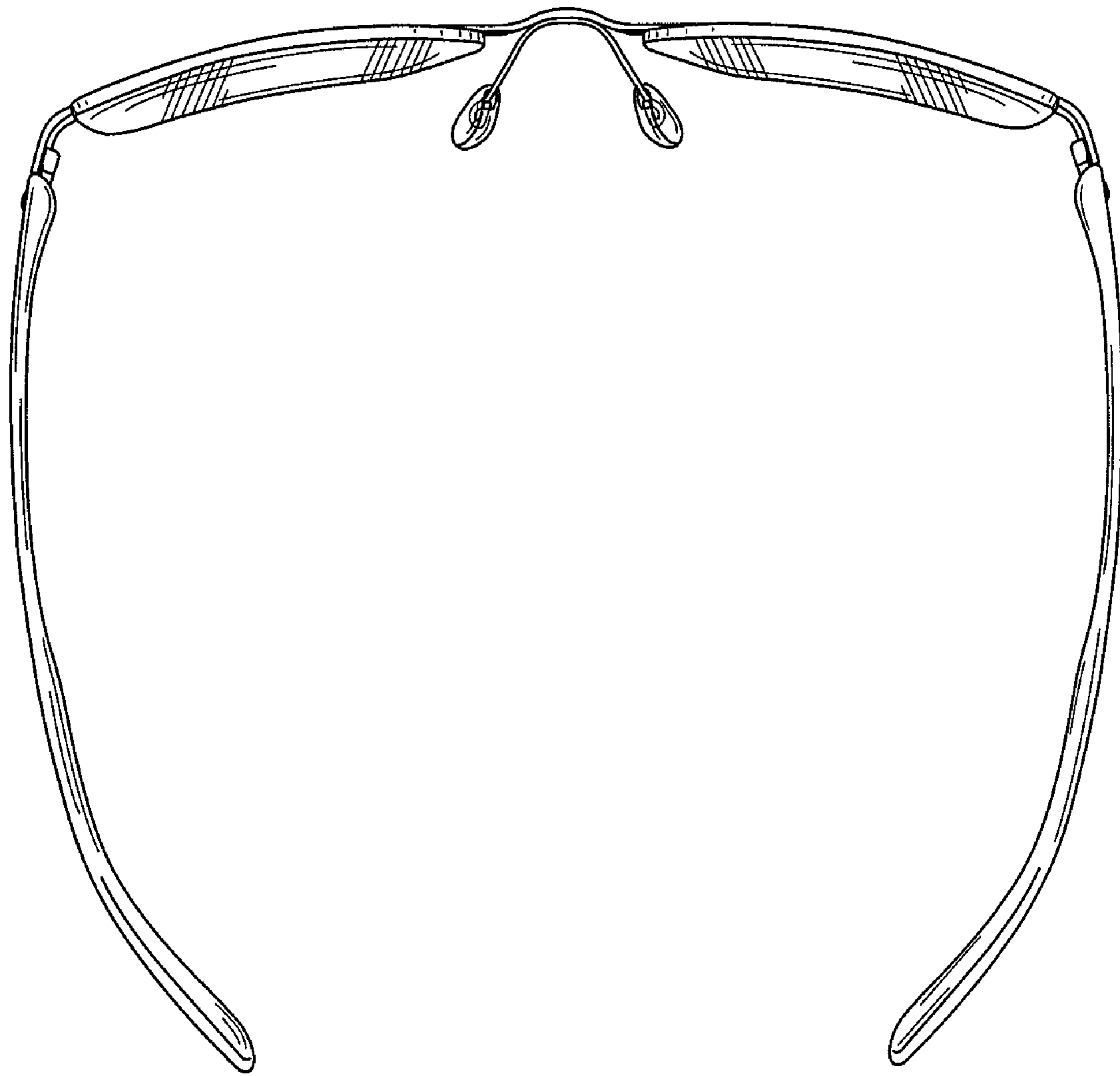

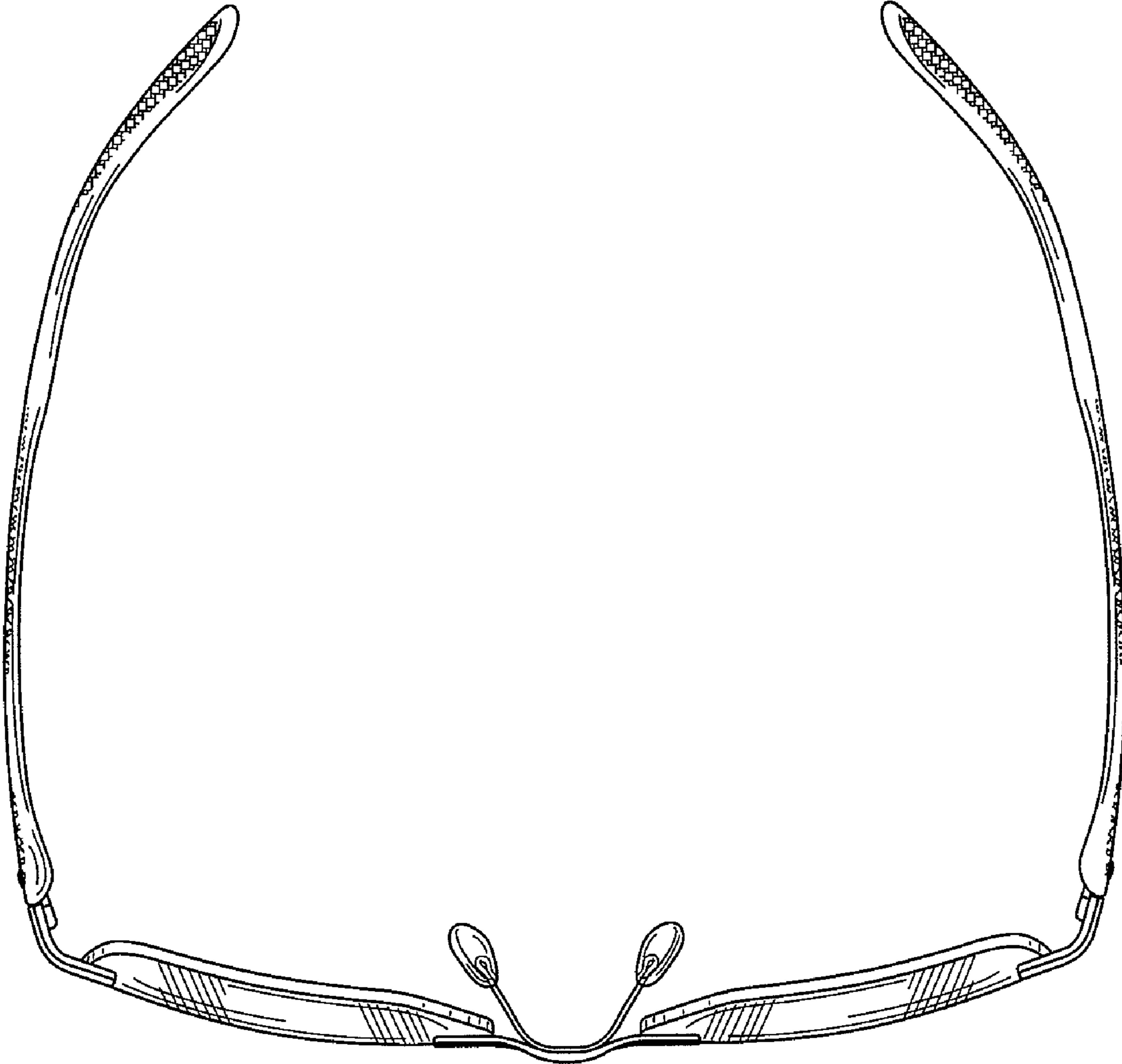

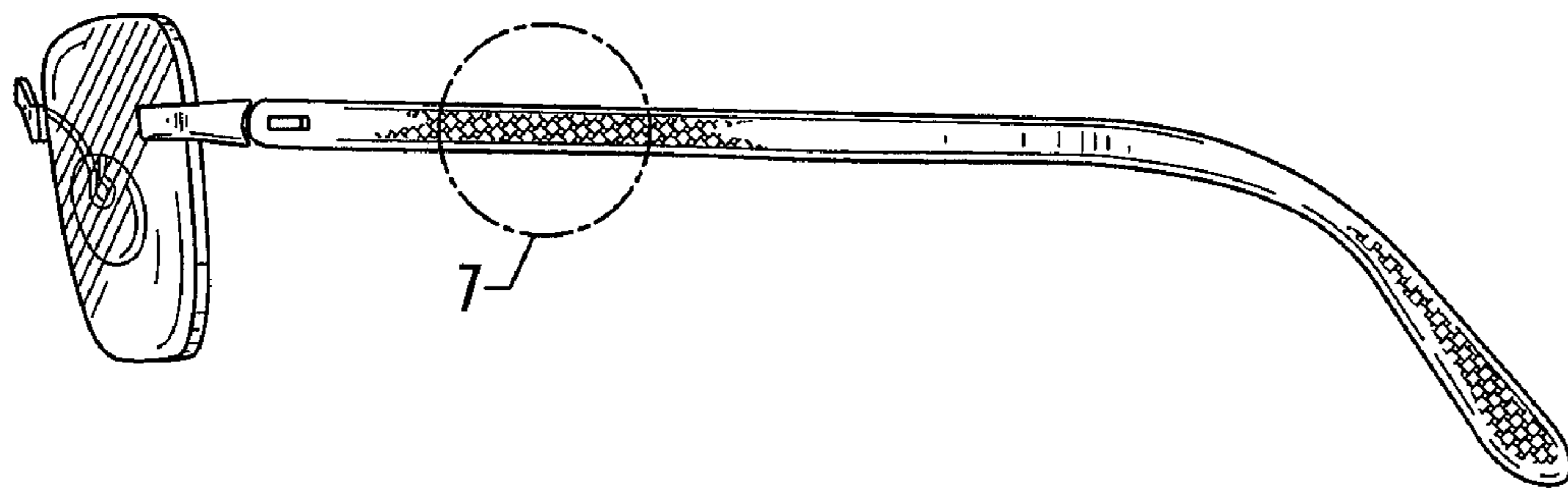

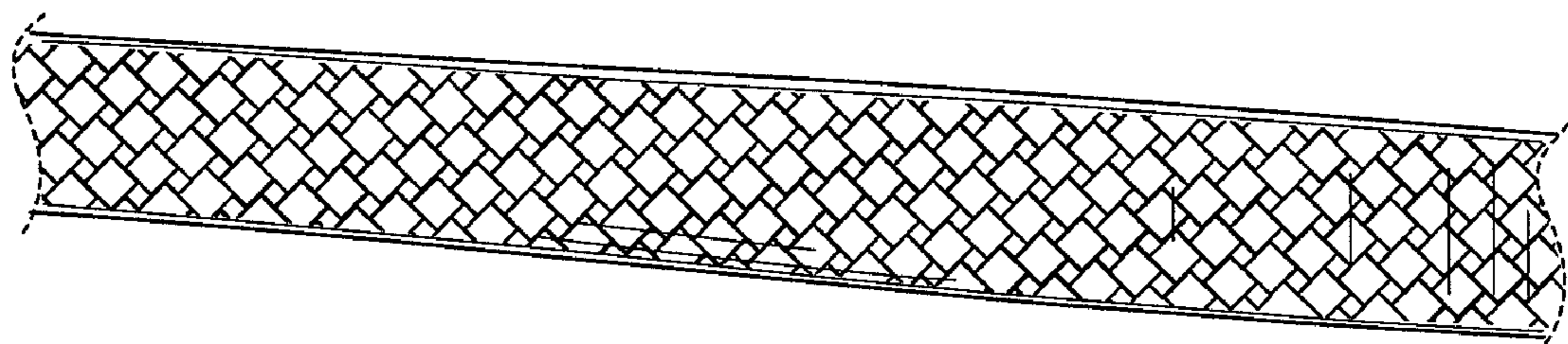
