The design for a roller pen, as shown and described.

DESCRIPTION

FIG. 1 is a top left perspective view of a roller pen according to the new design;

FIG. 2 is a left elevation view thereof;

FIG. 3 is a right elevation view thereof;

FIG. 4 is a front elevation view thereof;

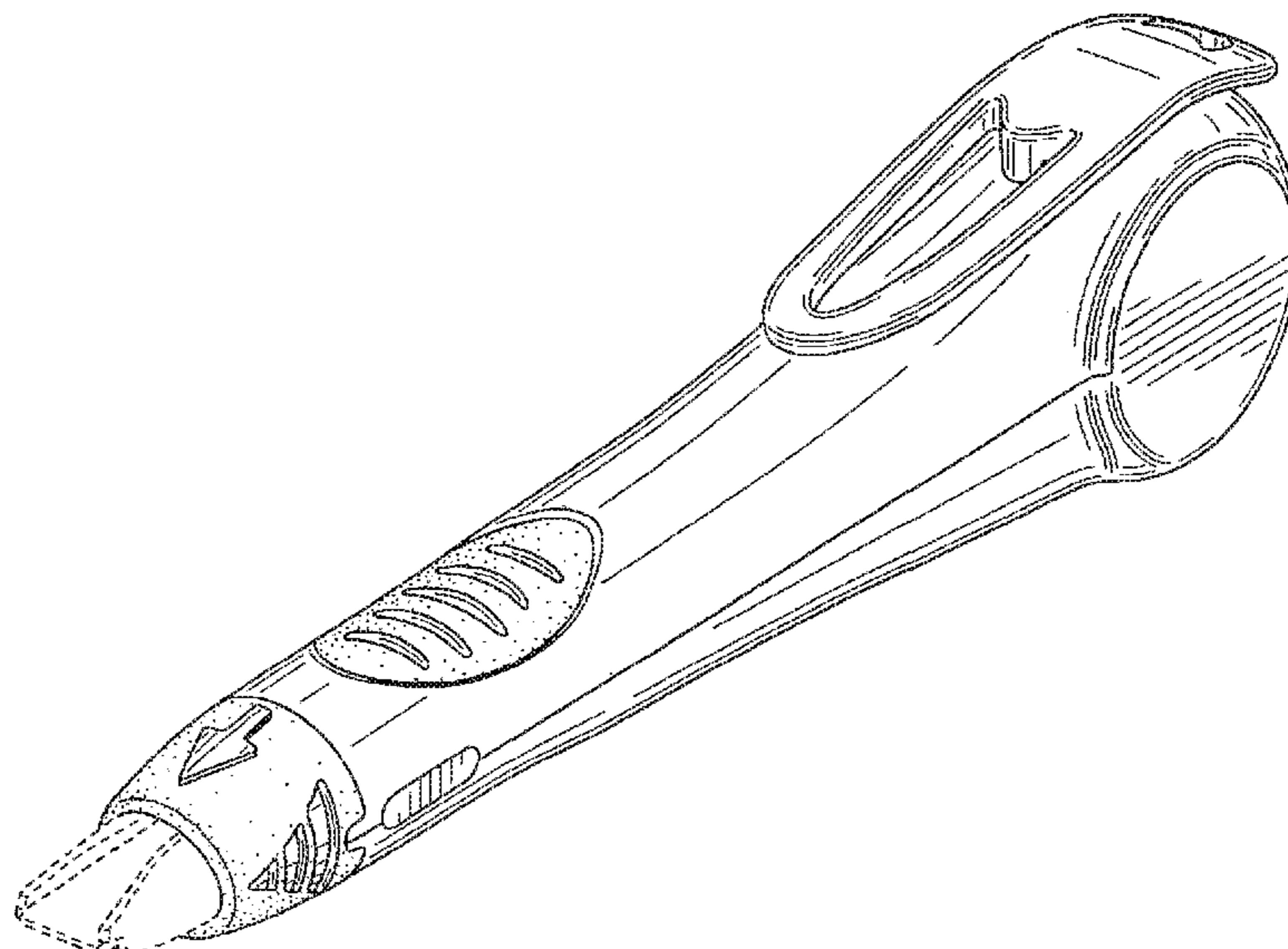
FIG. 5 is a rear elevation view thereof;

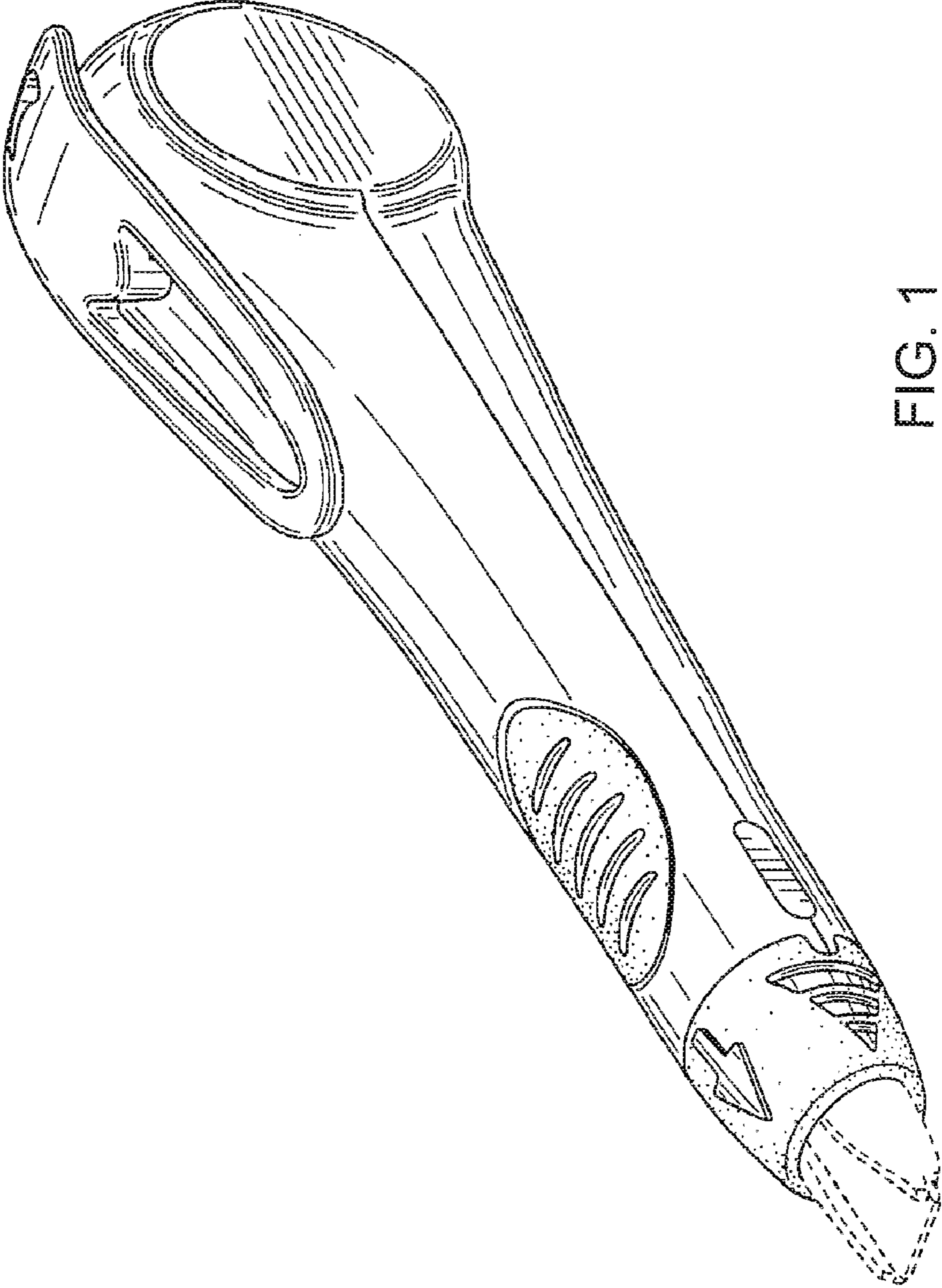

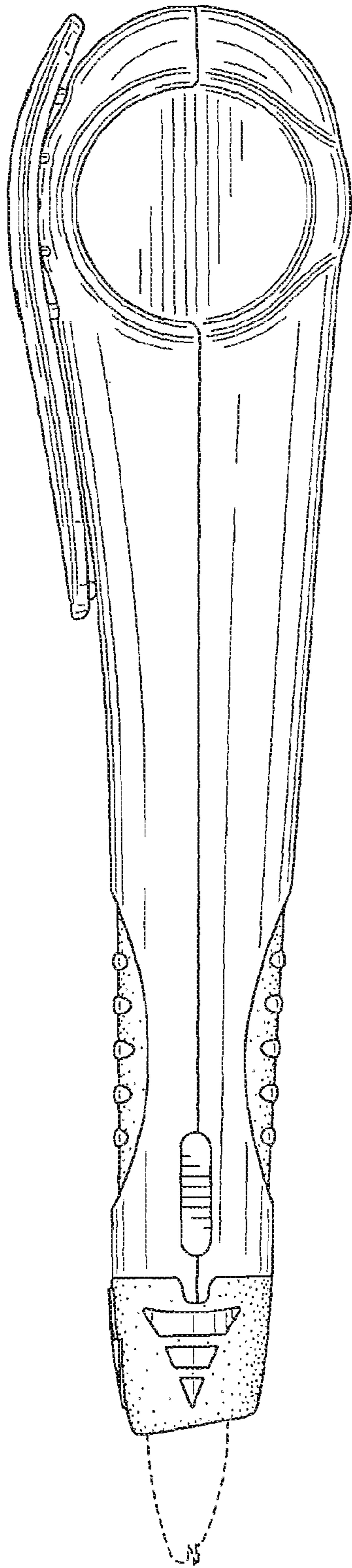

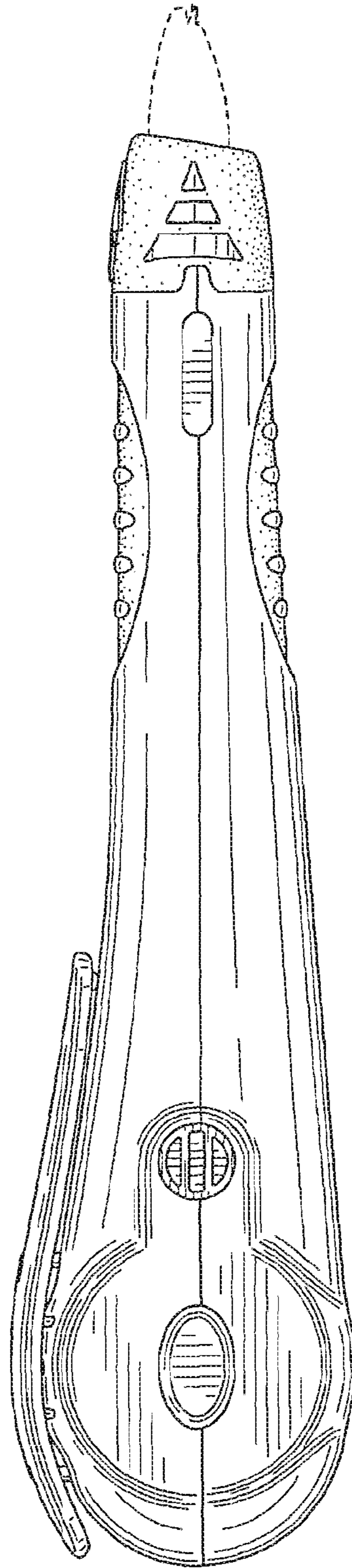

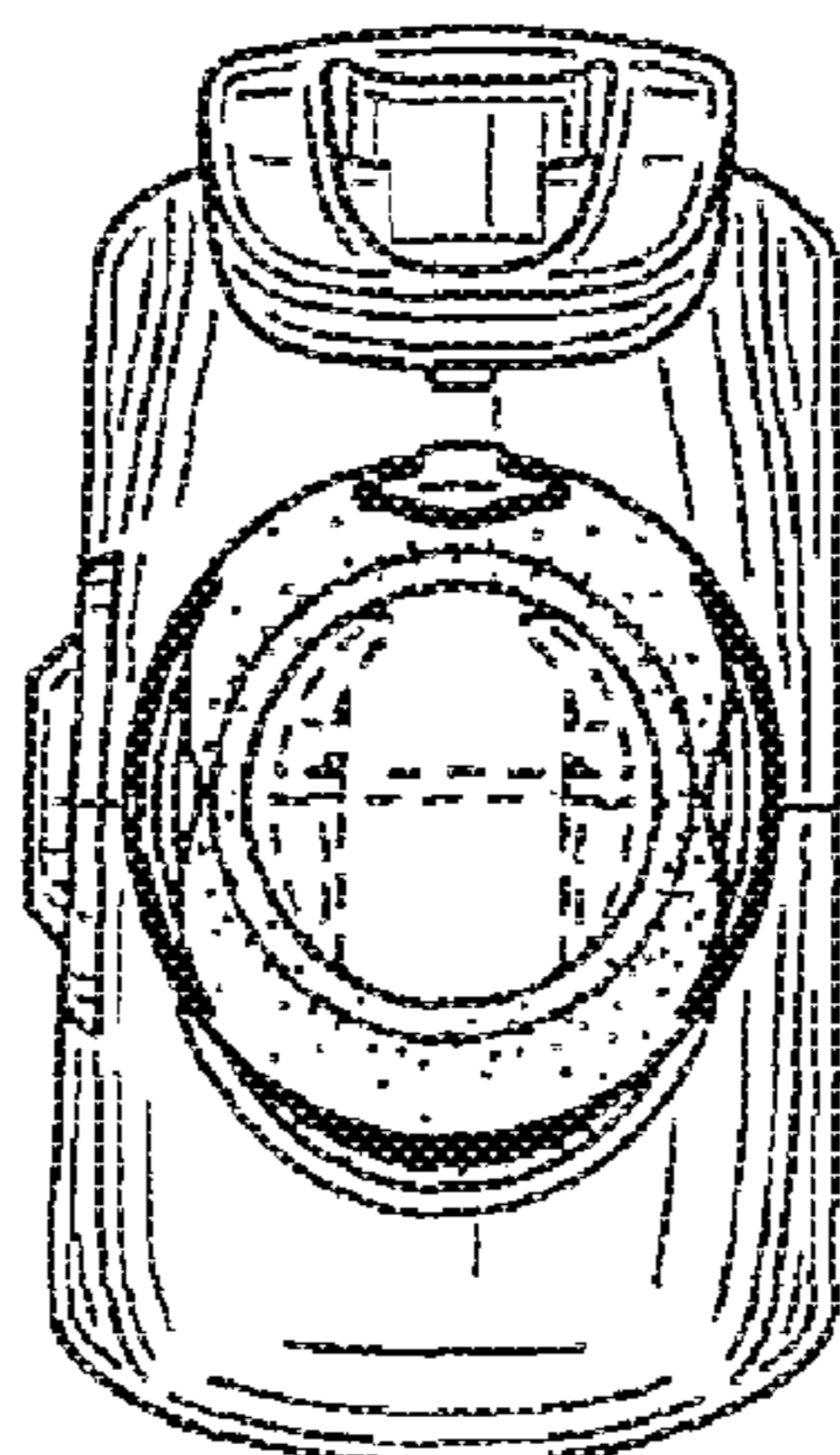

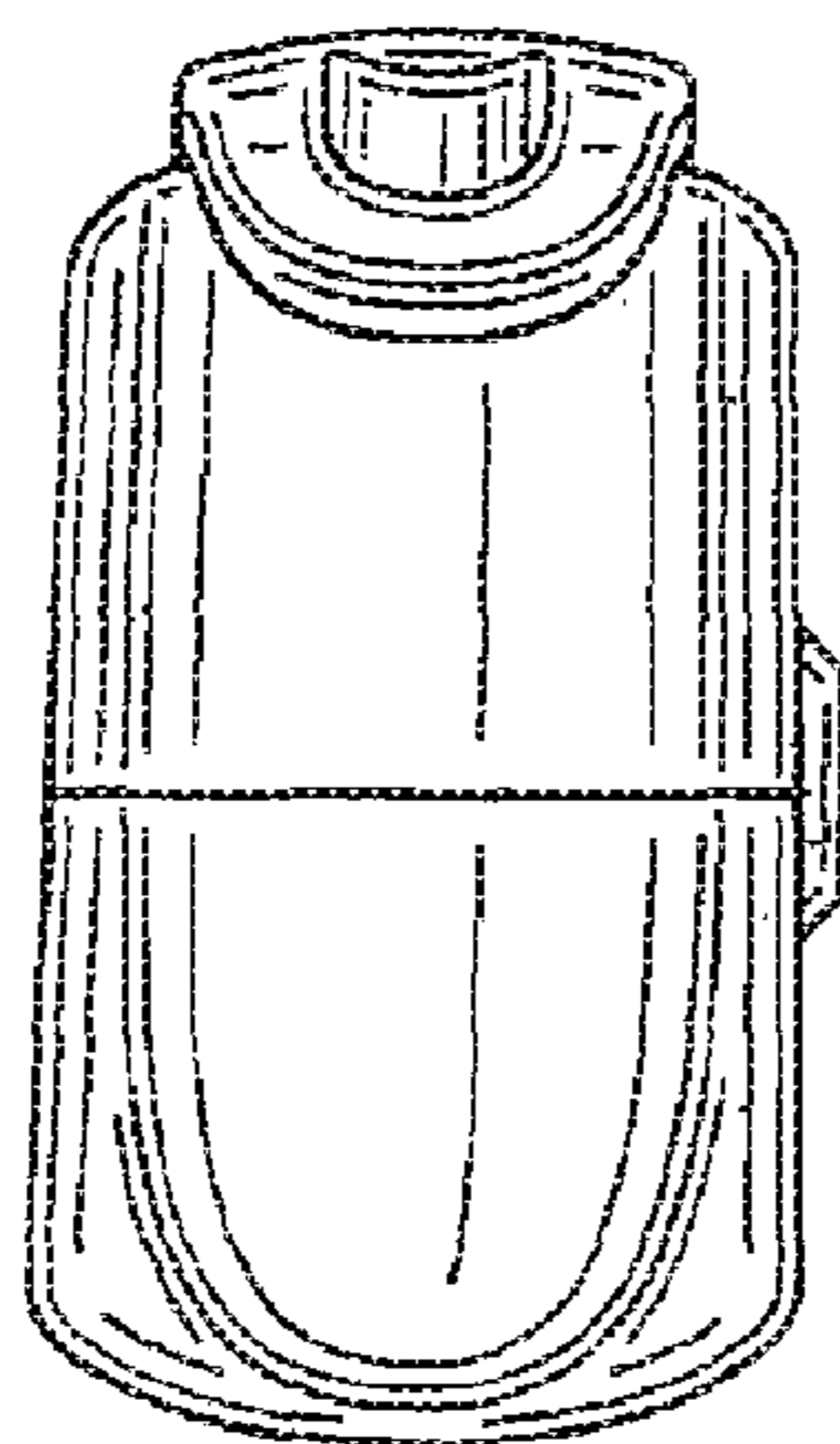

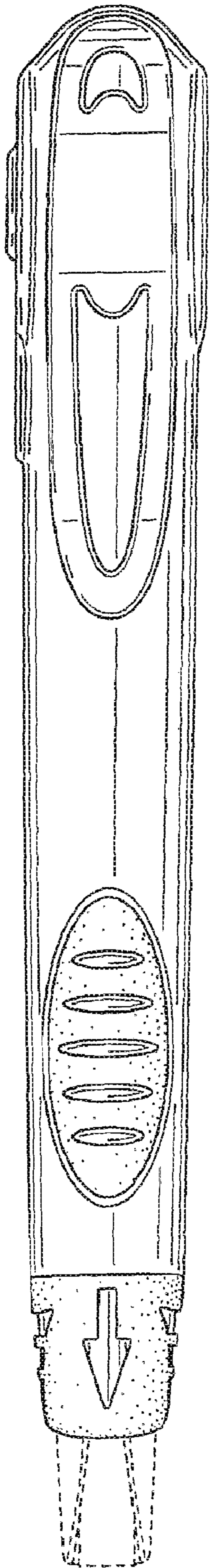

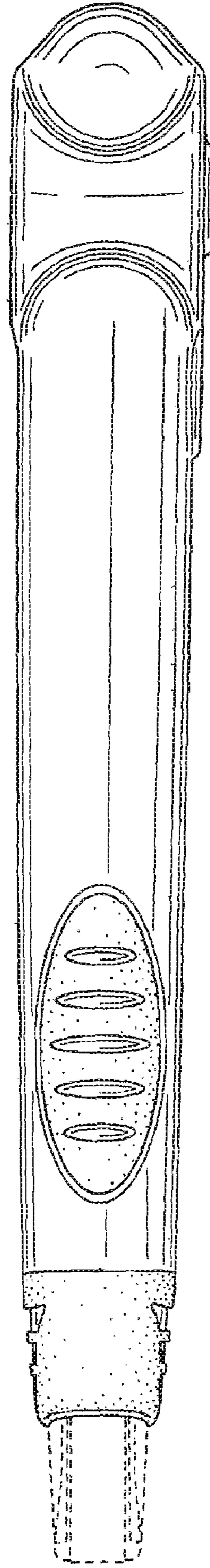
