FIG. 3 is a left side view of the advertising device of my new design;

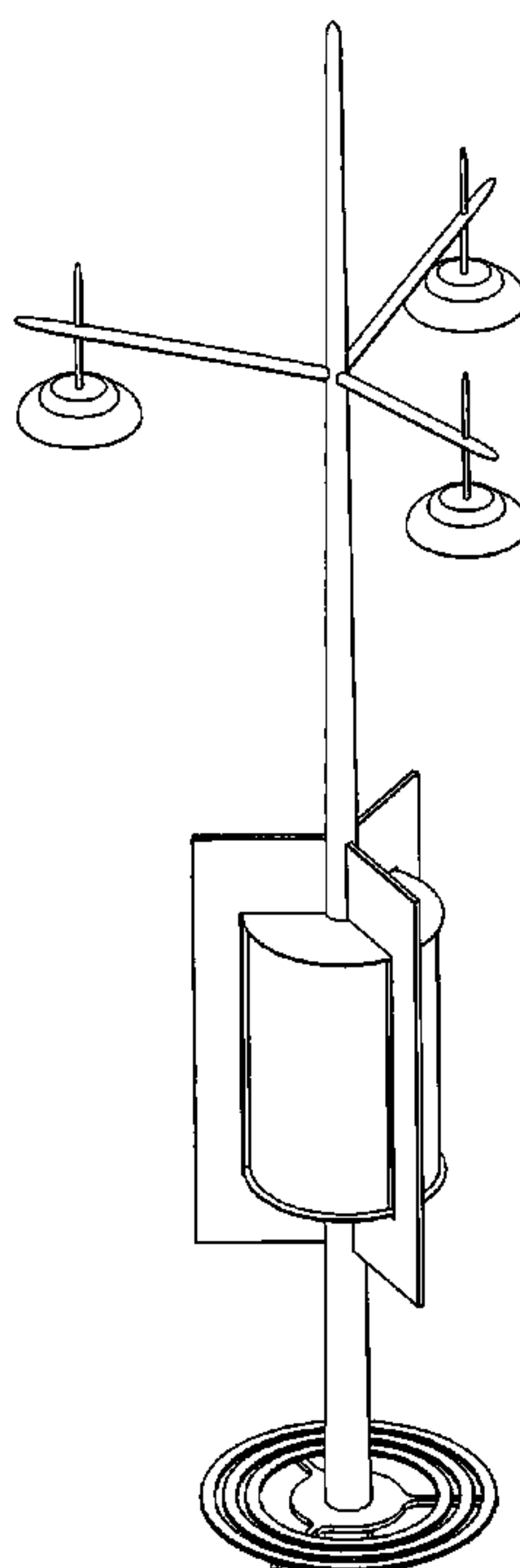
FIG. 4 is a front end view of the advertising device of my new design;

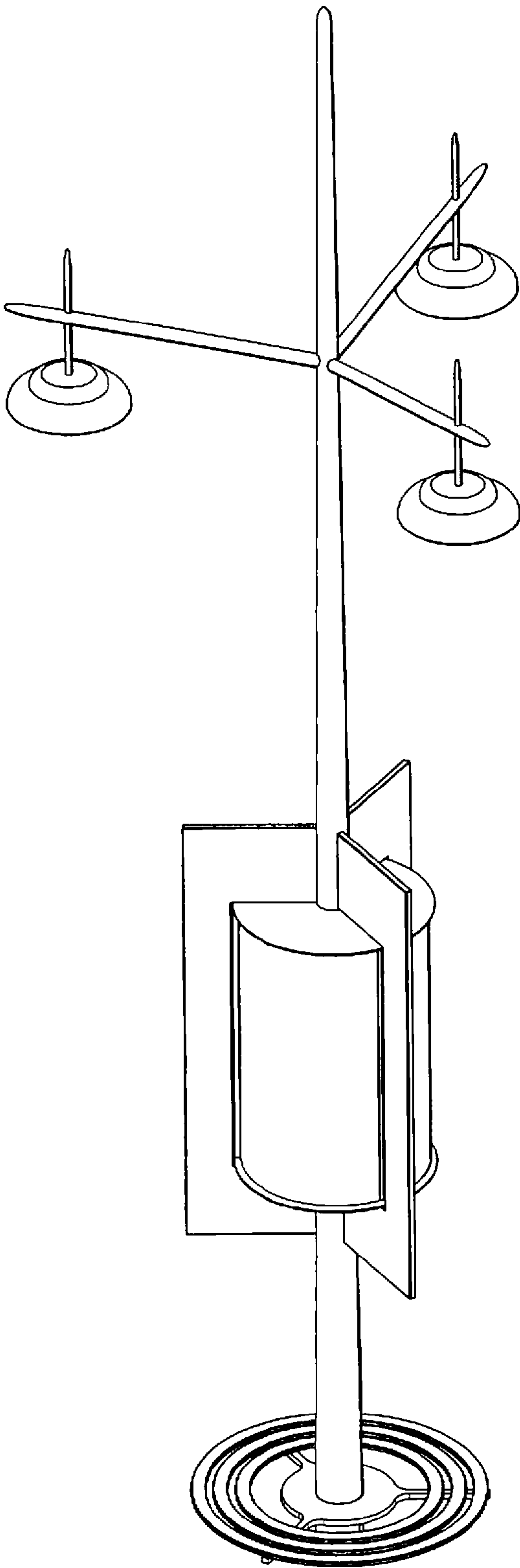

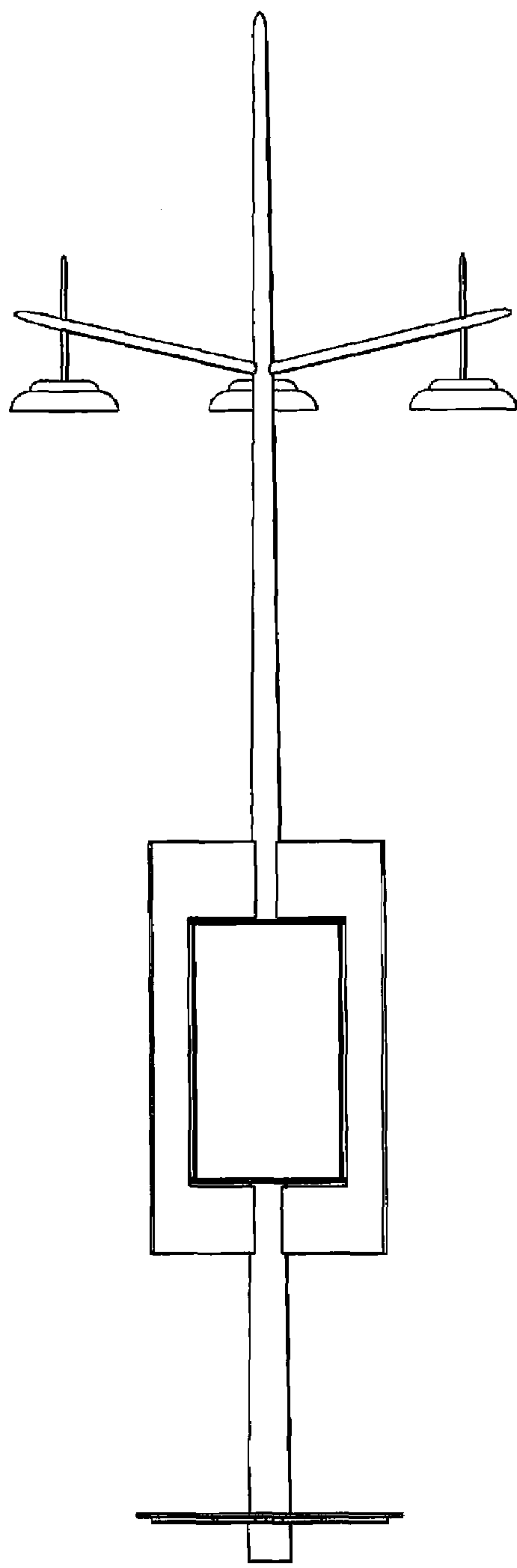

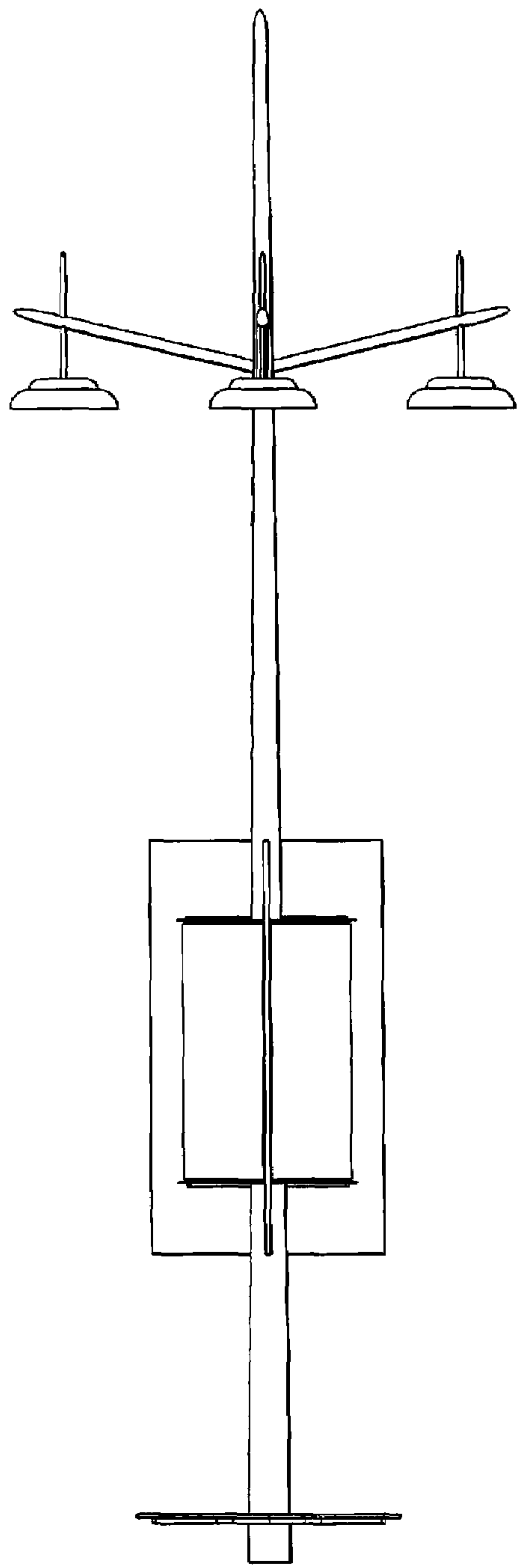

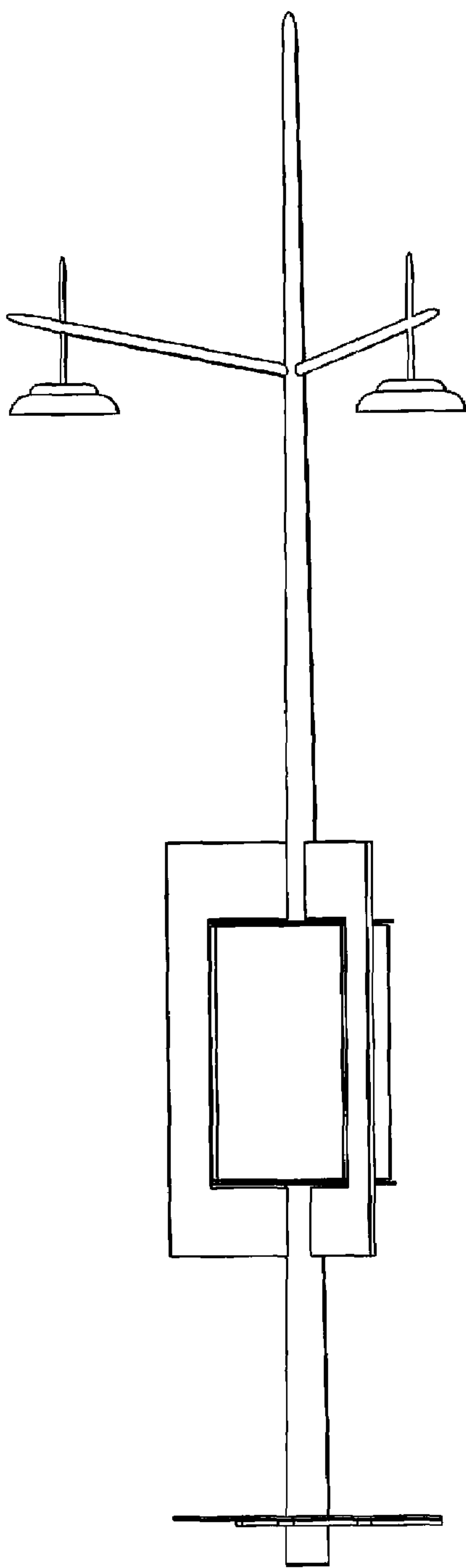

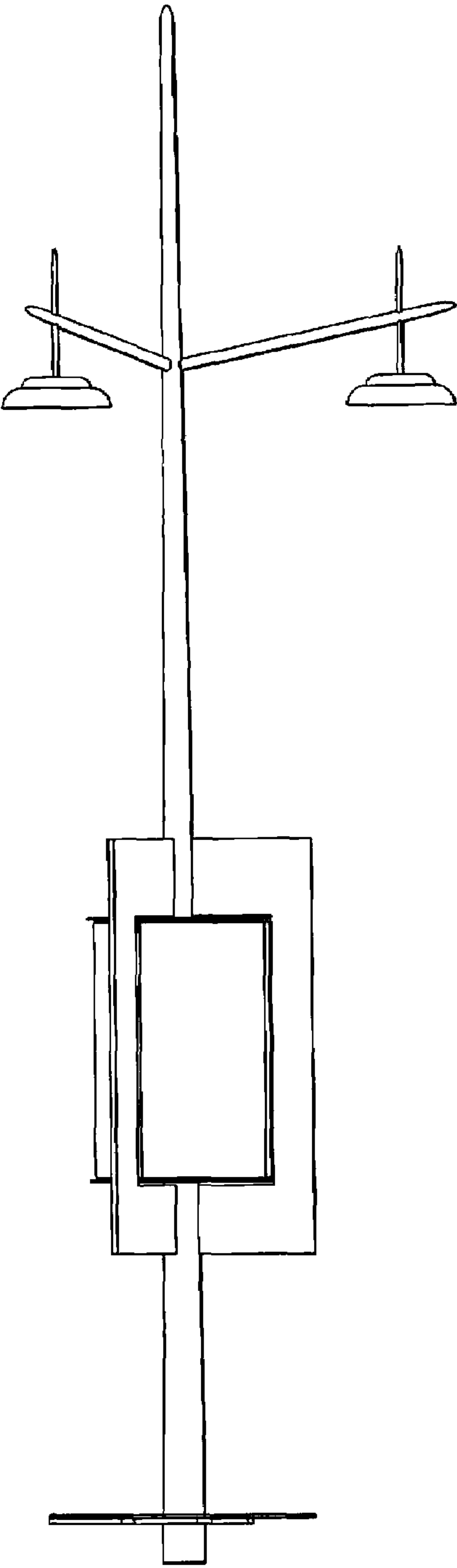

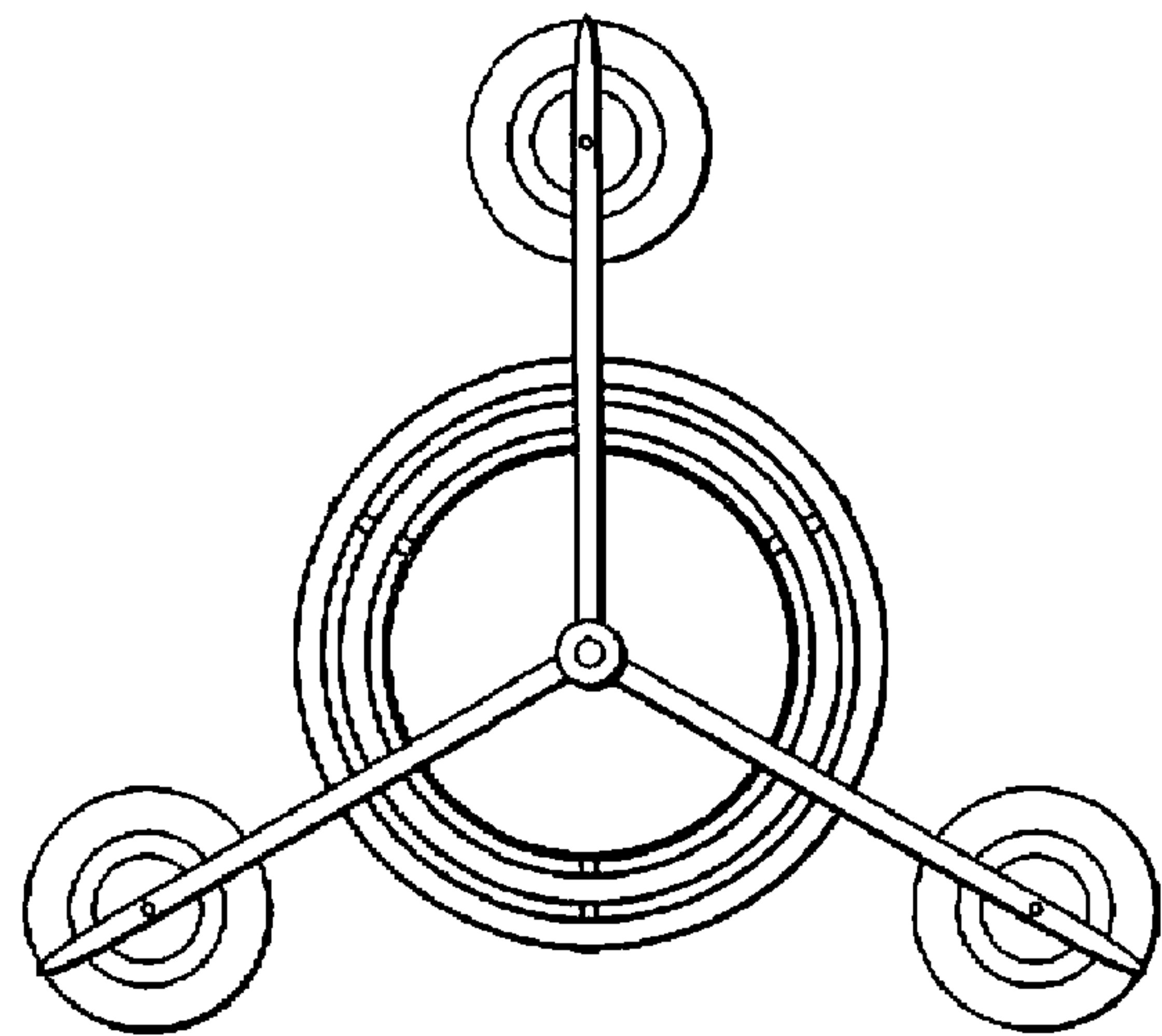

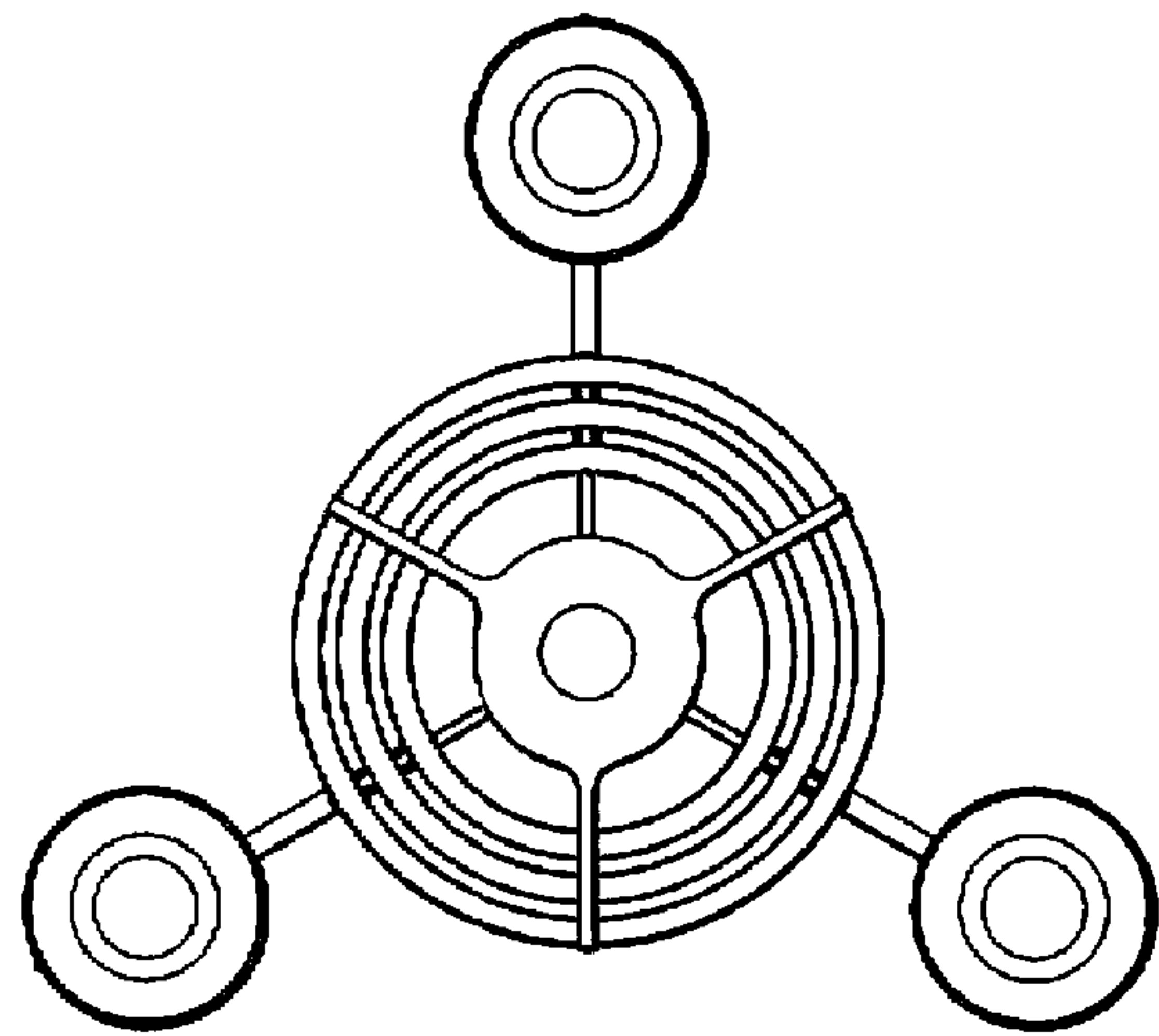
