FIG. 4 is a right side elevation of the electronic control device of FIG. 1;

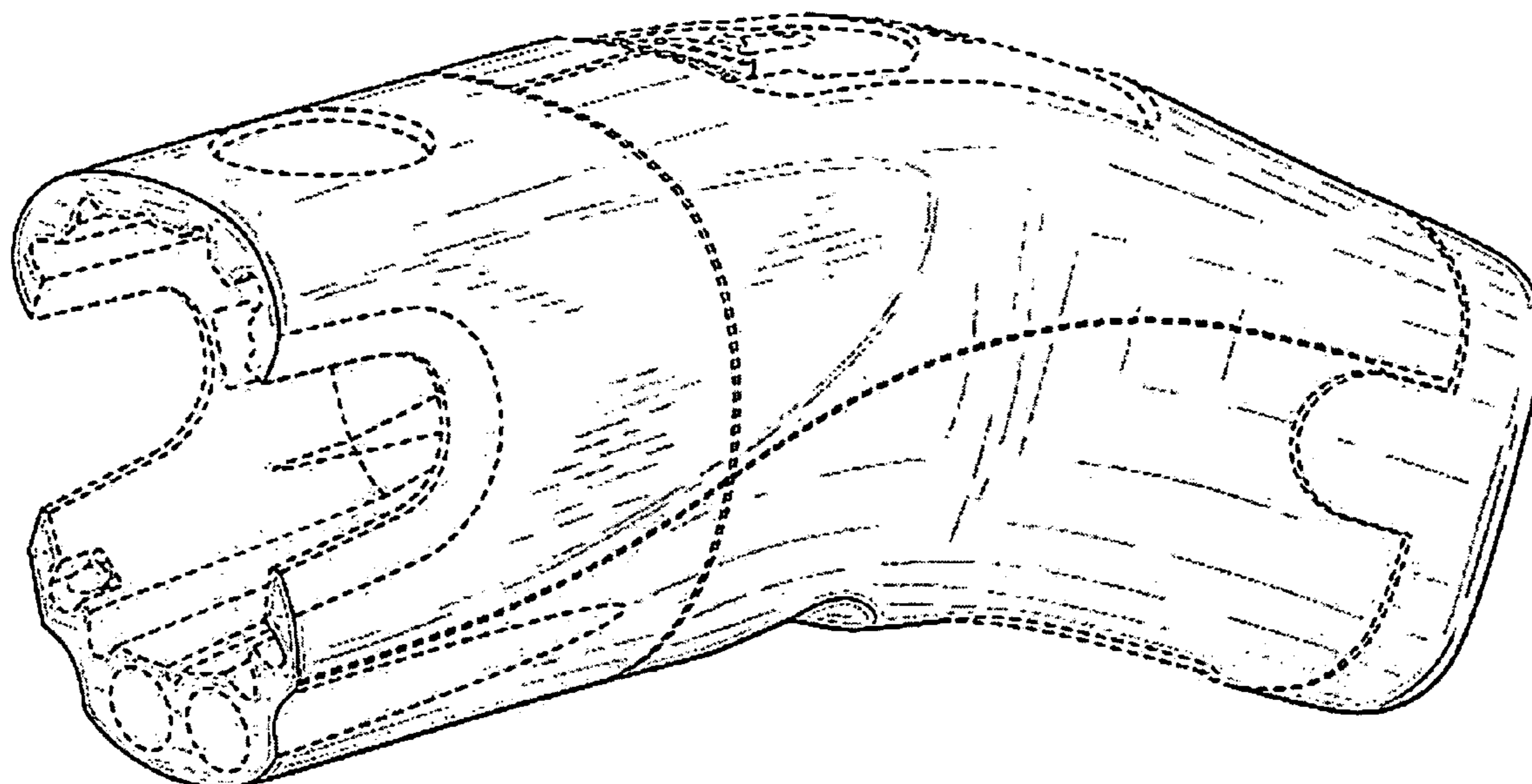
FIG. 5 is a left side elevation of the electronic control device of FIG. 1;

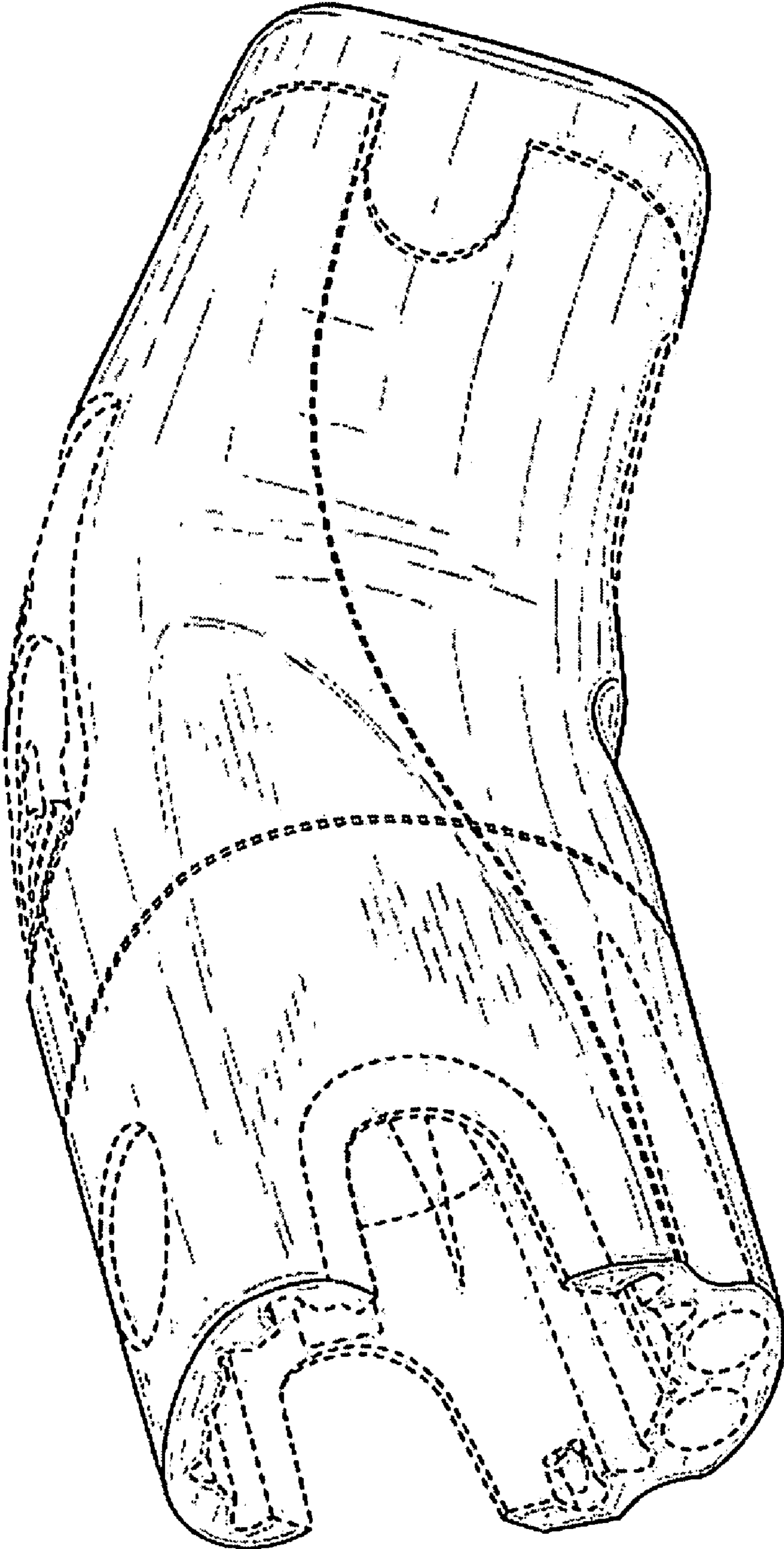

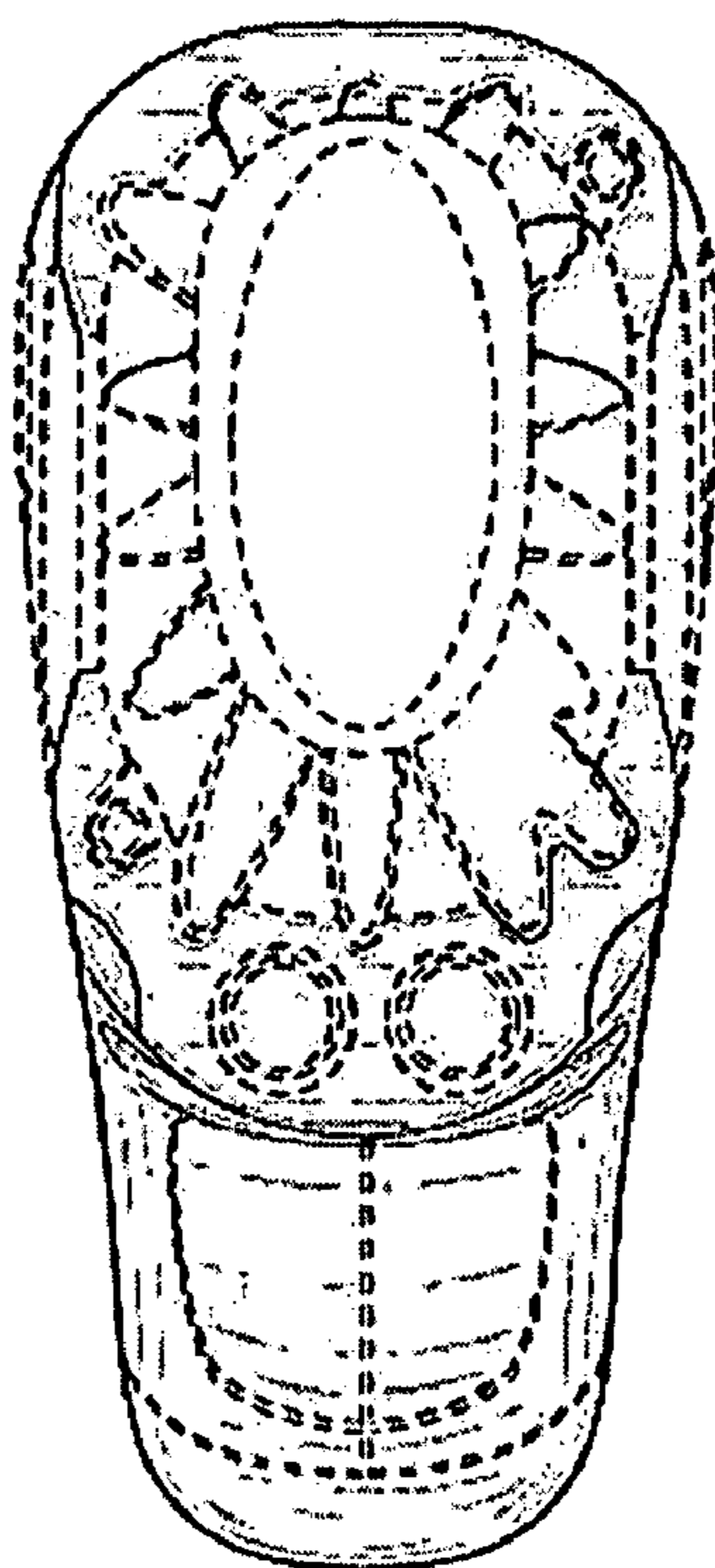

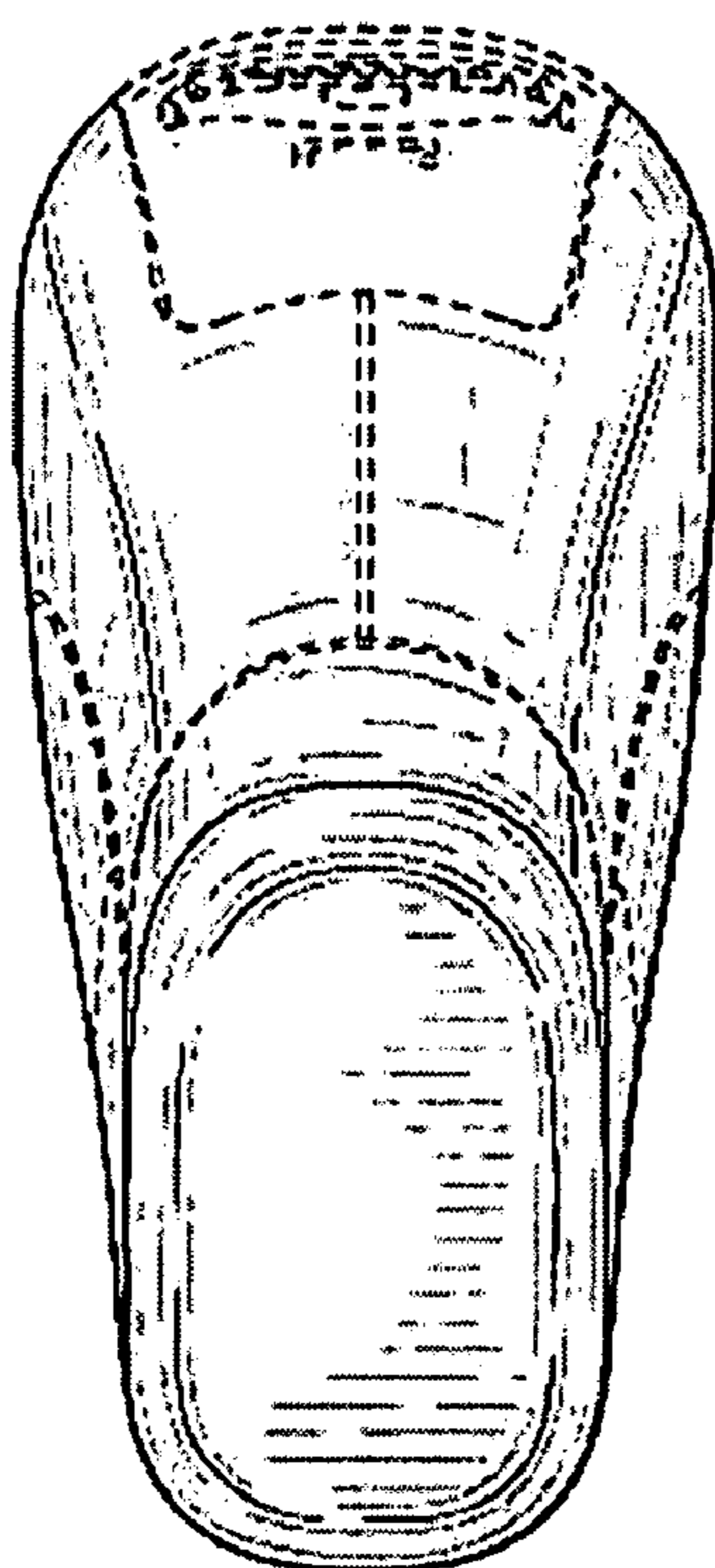

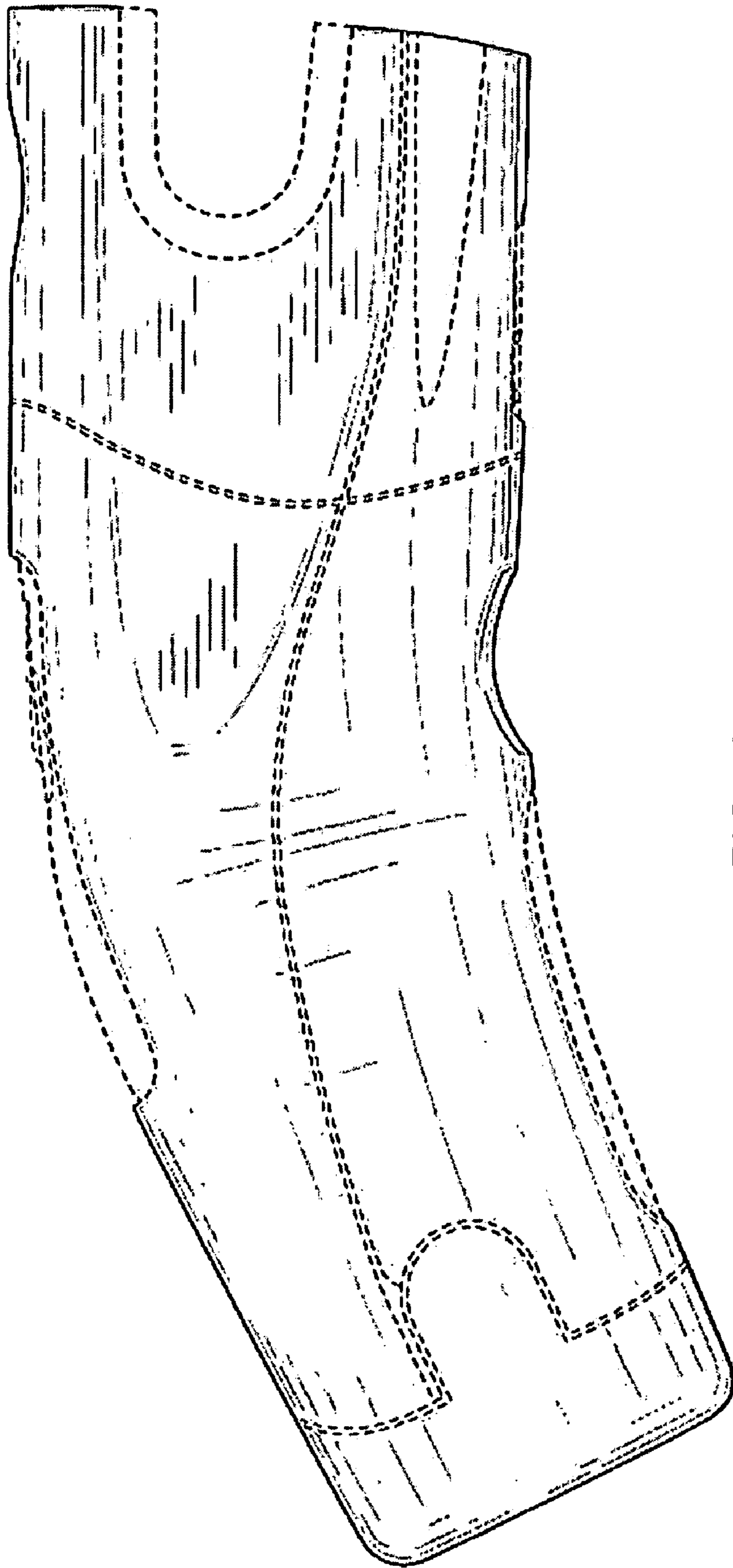

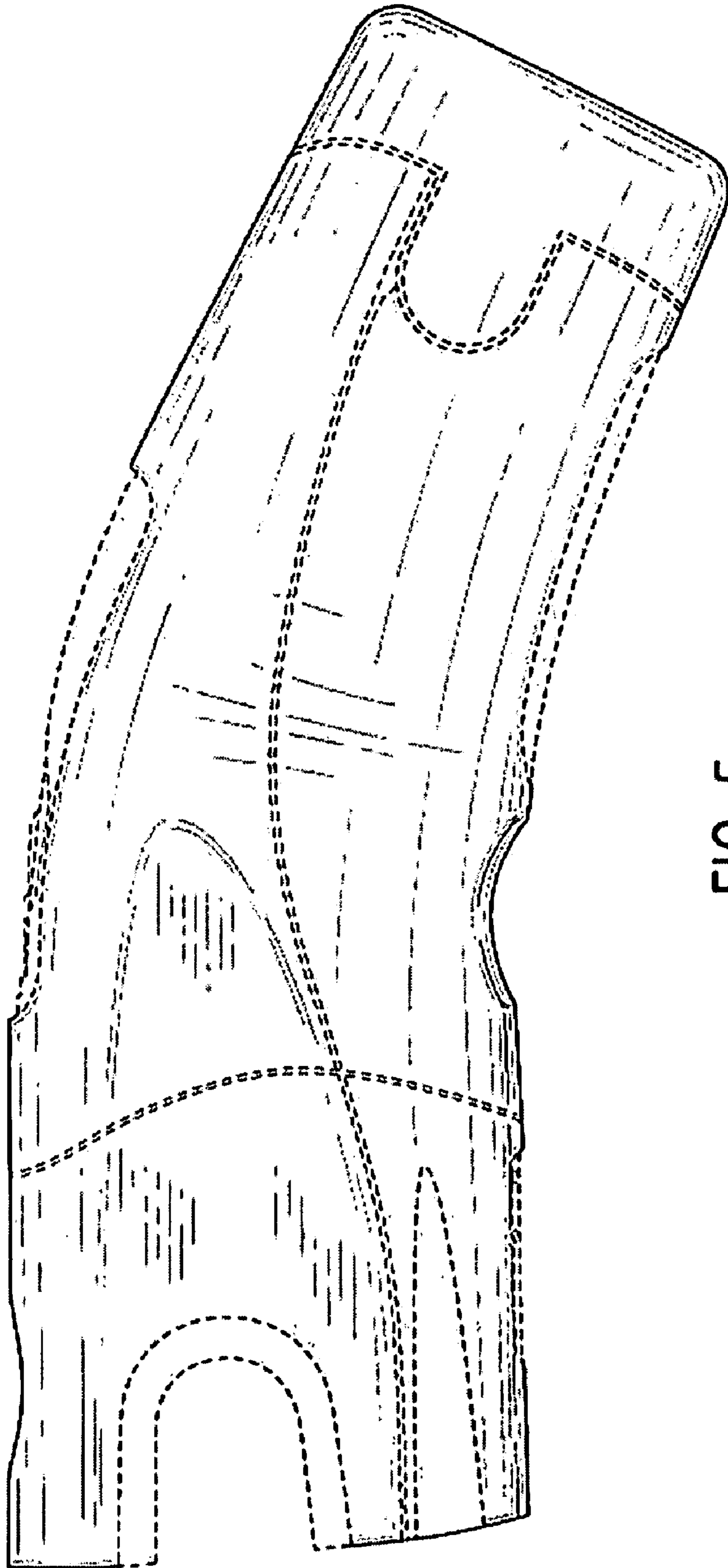

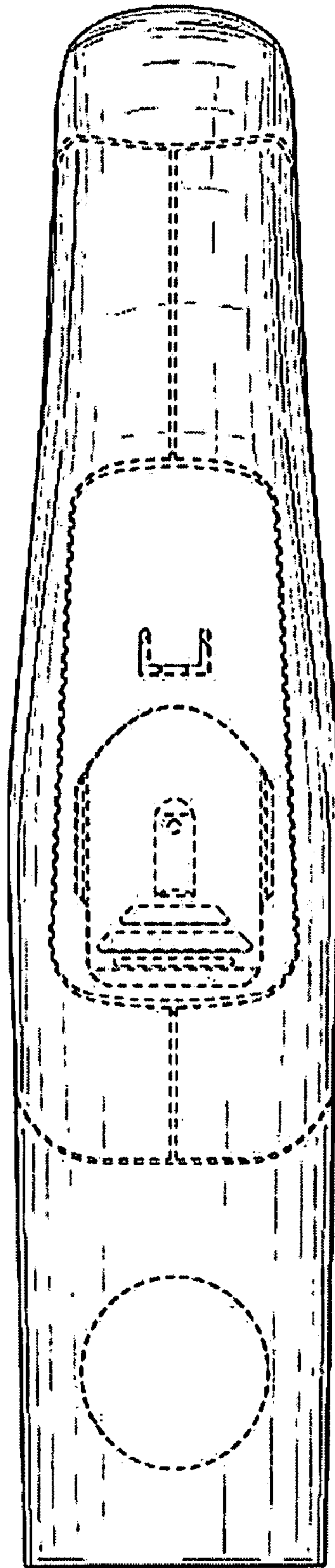

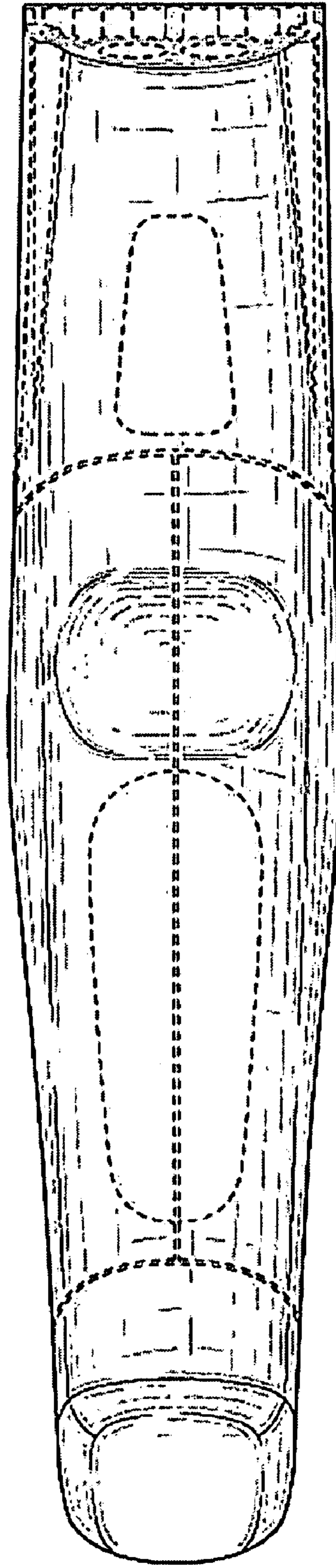
