FIG. 3 is an elevation view of the rear thereof;

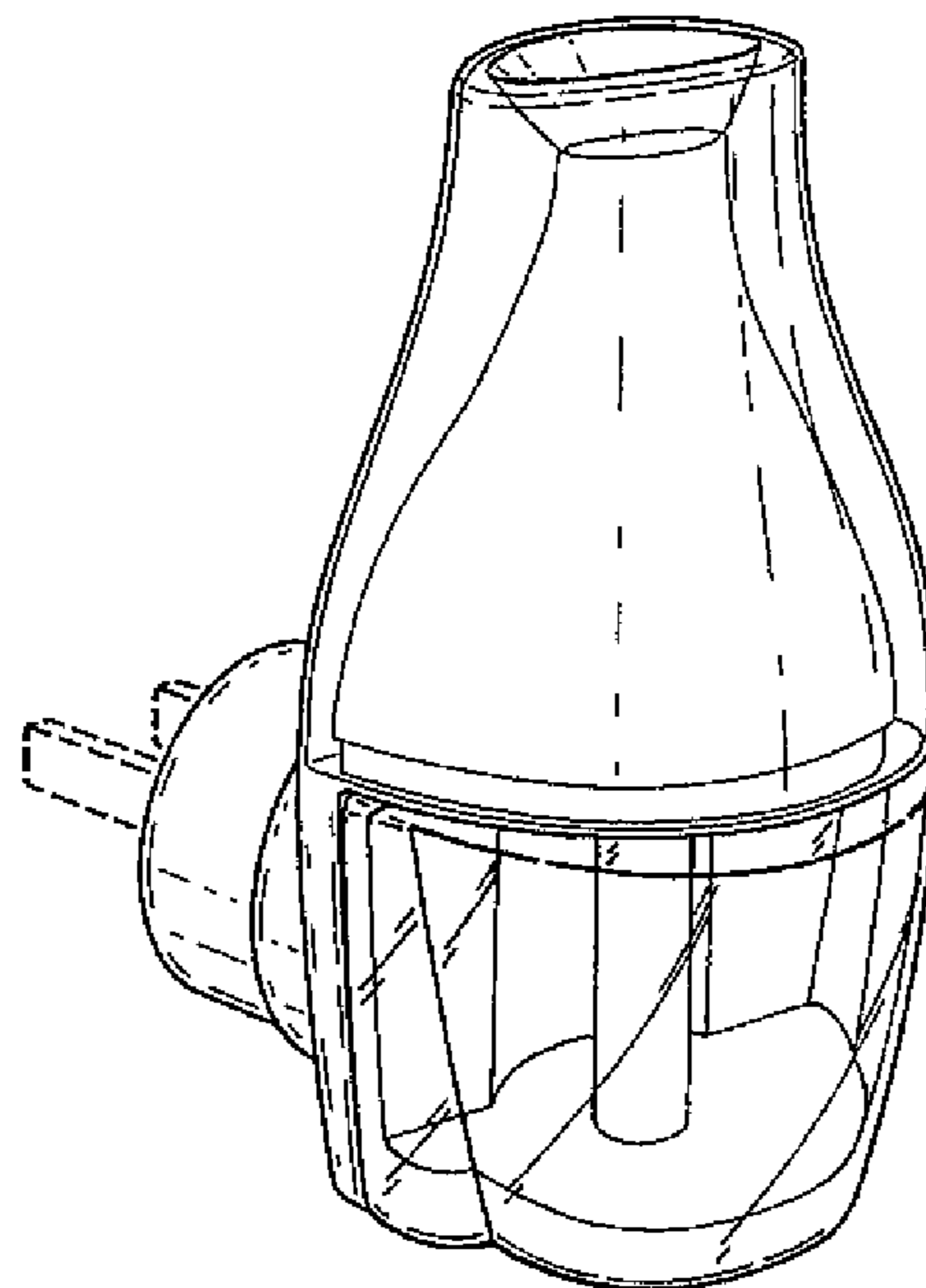
FIG. 4 is an elevation view of the left side thereof;

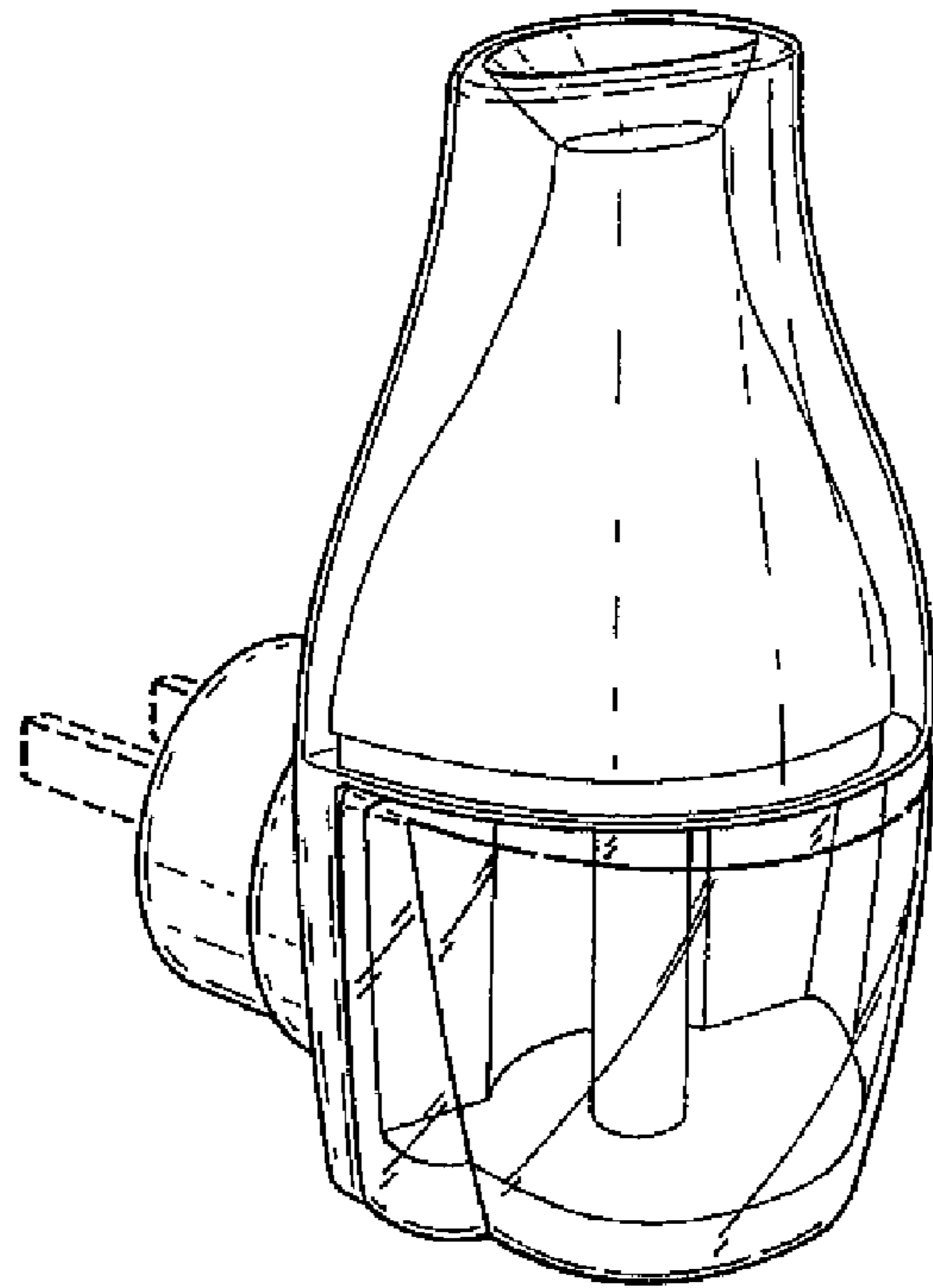

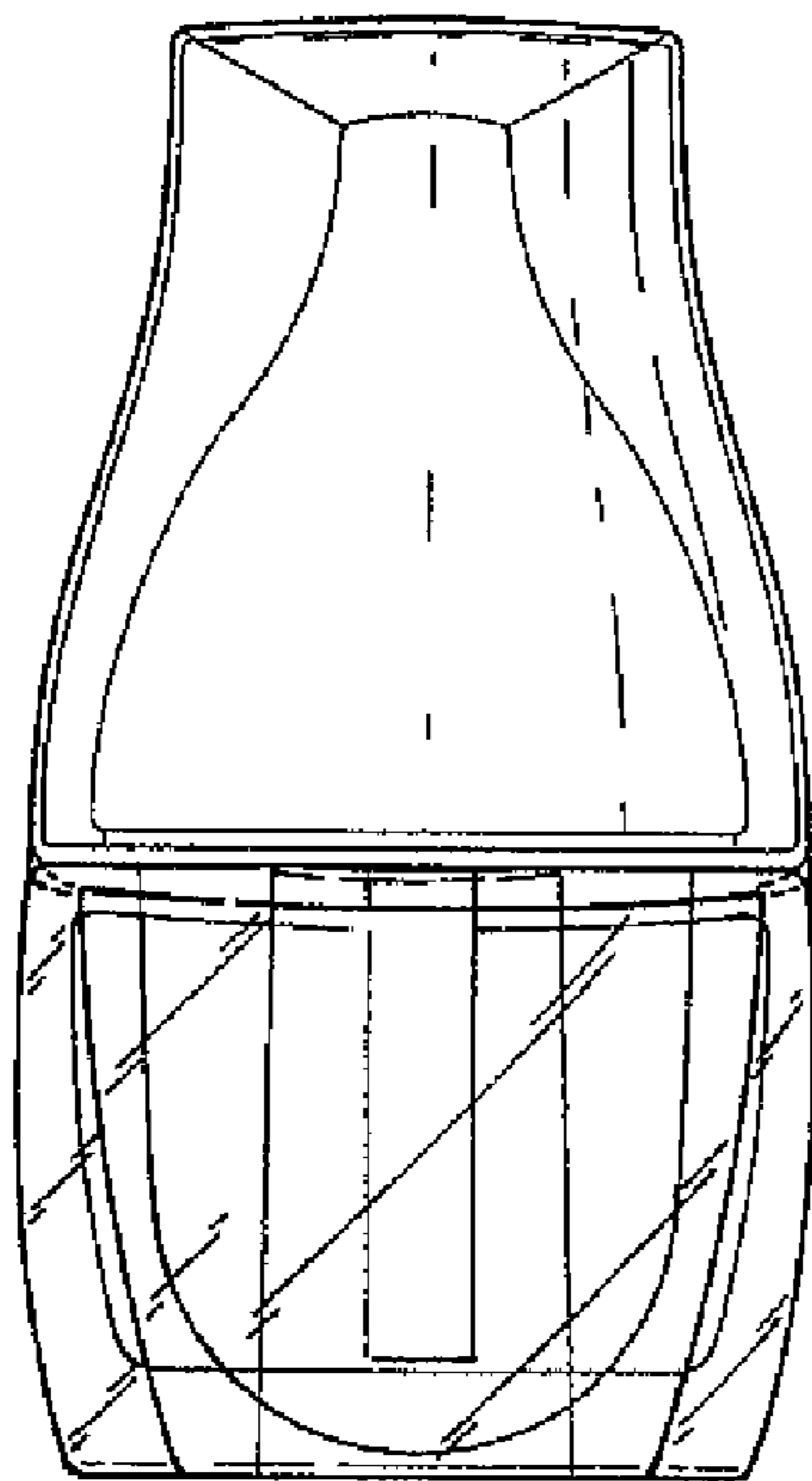

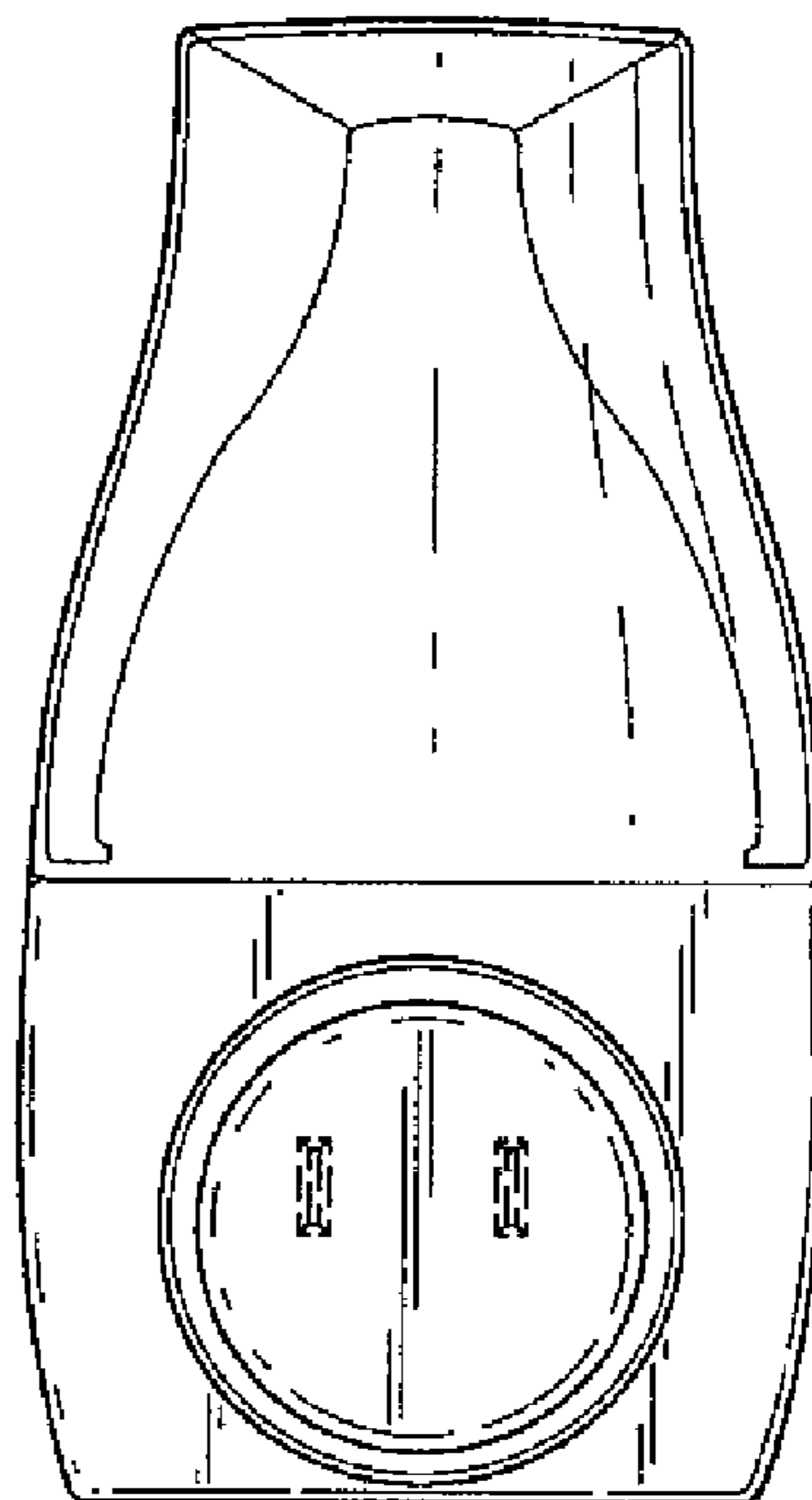

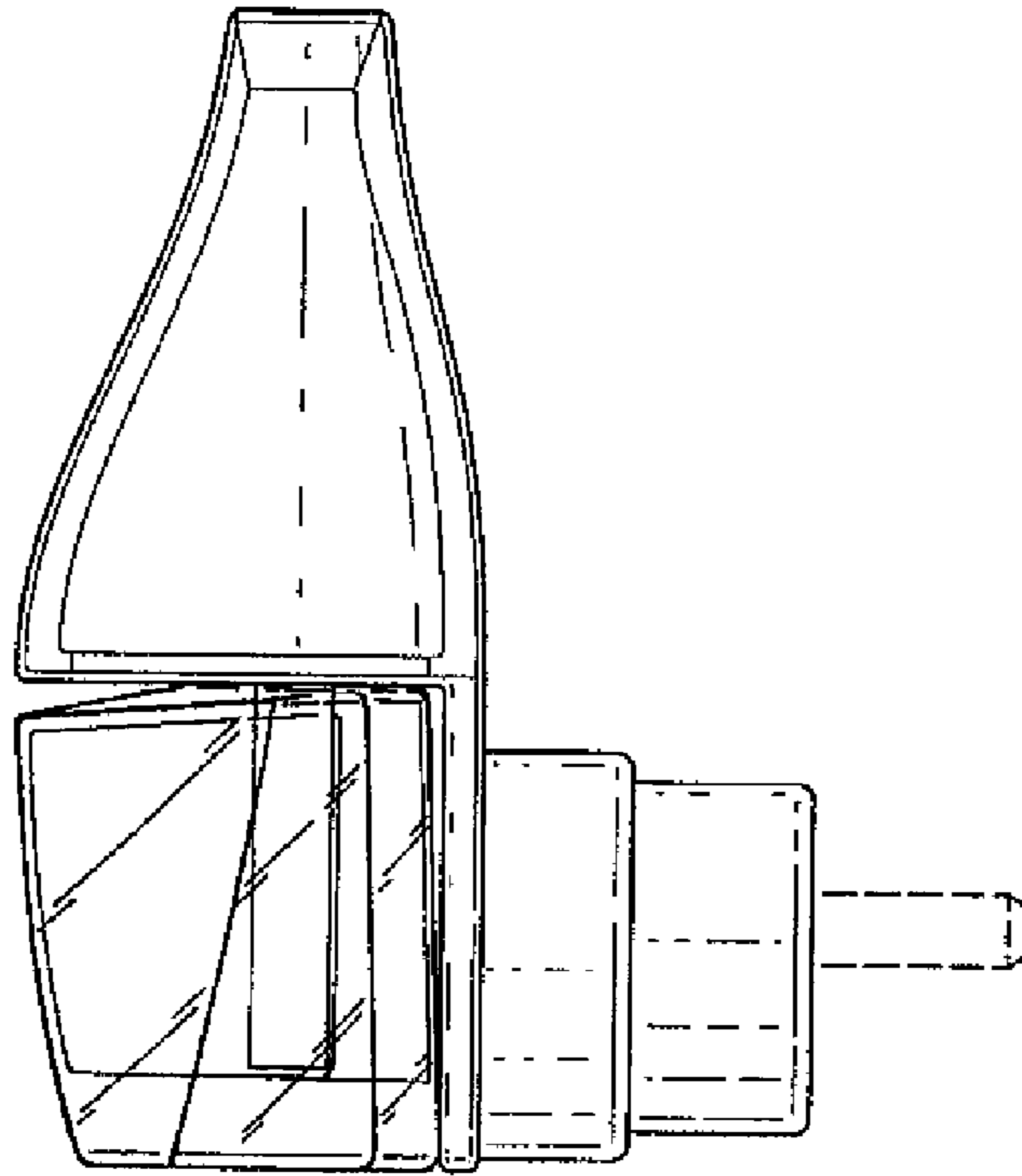

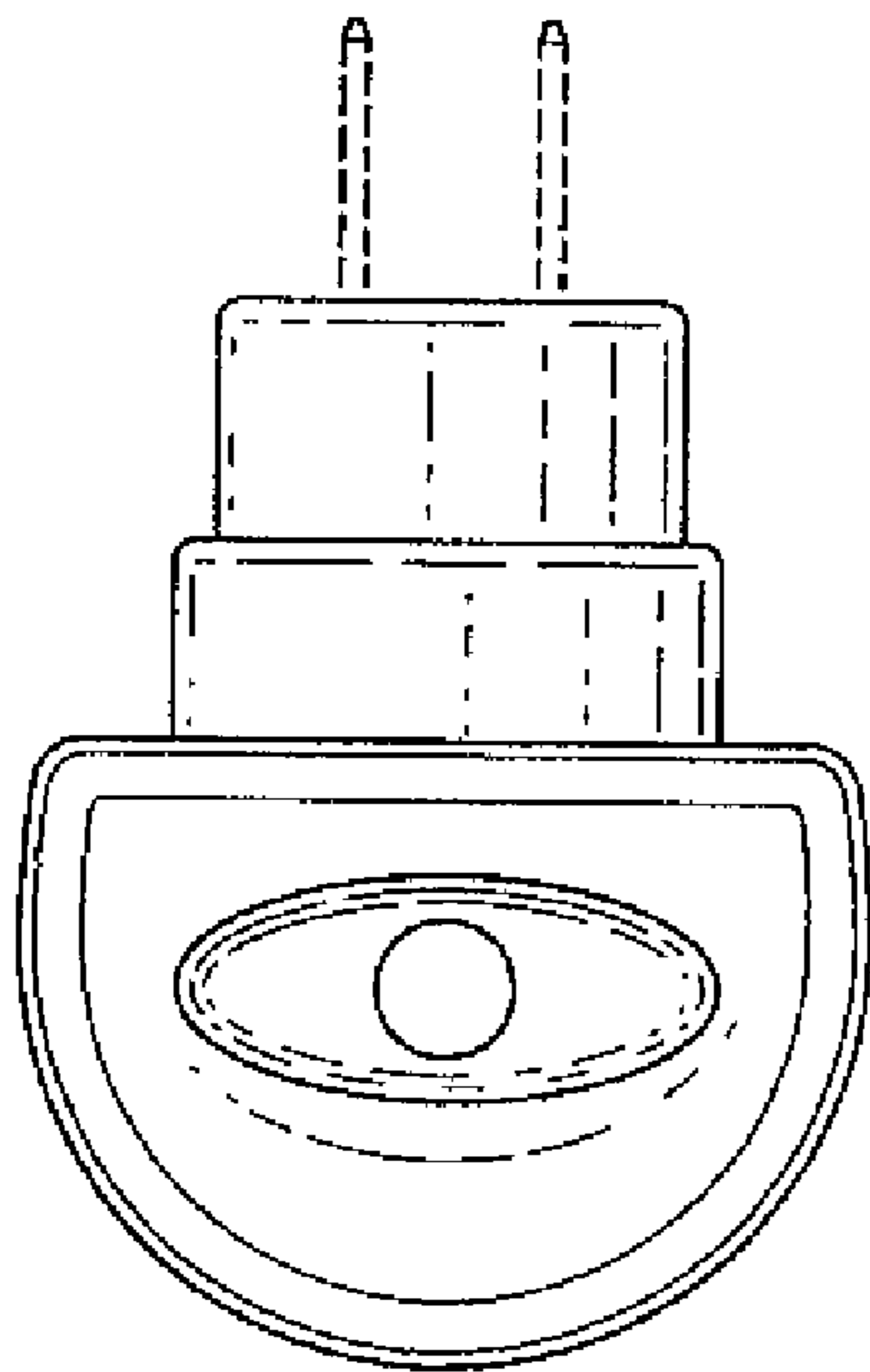

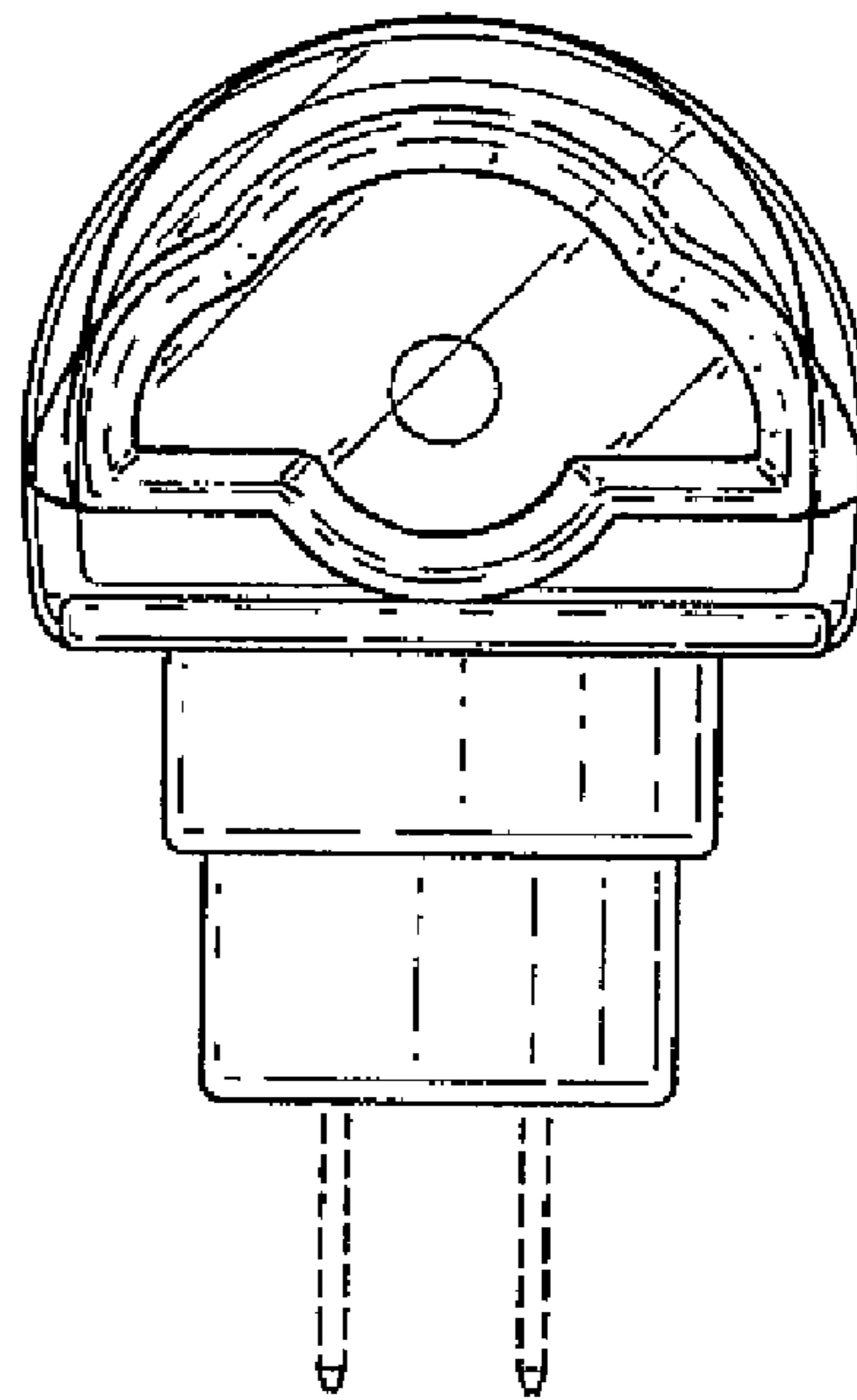
