(57) **CLAIM**

The ornamental design for an air freshener in the shape of a football jersey, as shown and described.

DESCRIPTION

The present design can be displayed in any location where the placement of an air freshener would be beneficial, though a person may consider the design to be worthy of display virtually anywhere.

FIG. 2 is a front elevational view of an air freshener in the shape of a football jersey.

FIG. 4 is a top view.

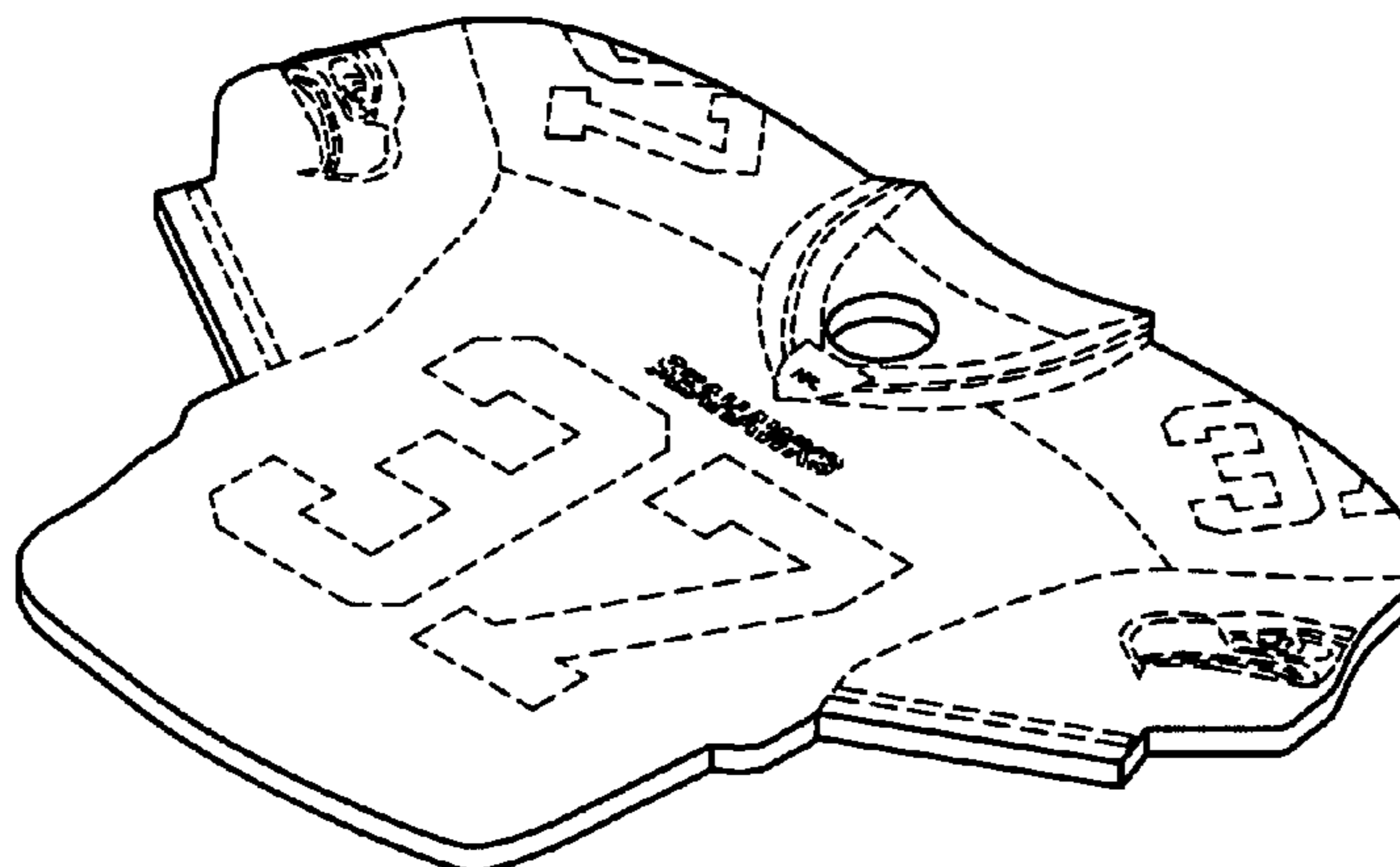
FIG. 5 is a bottom view.

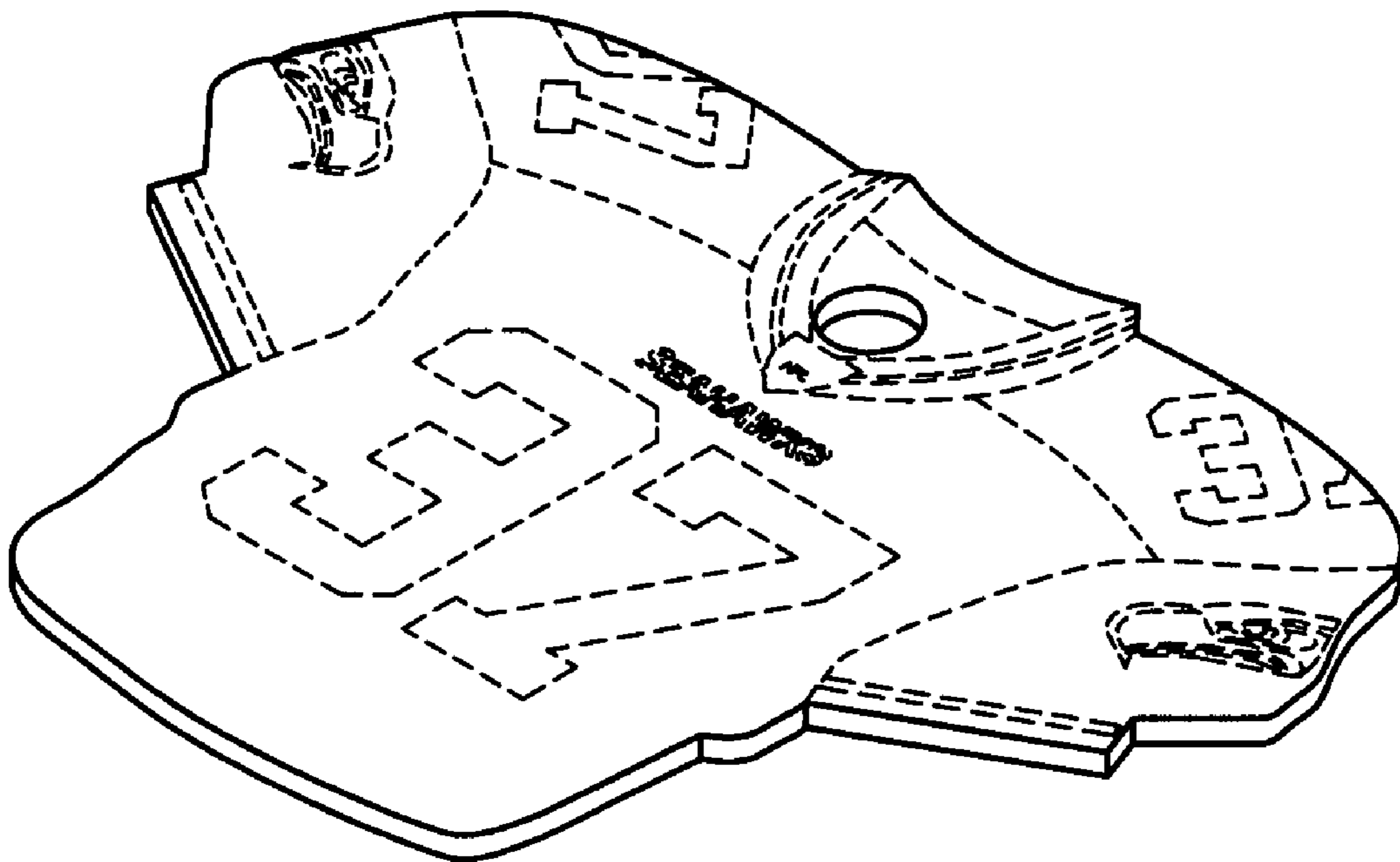

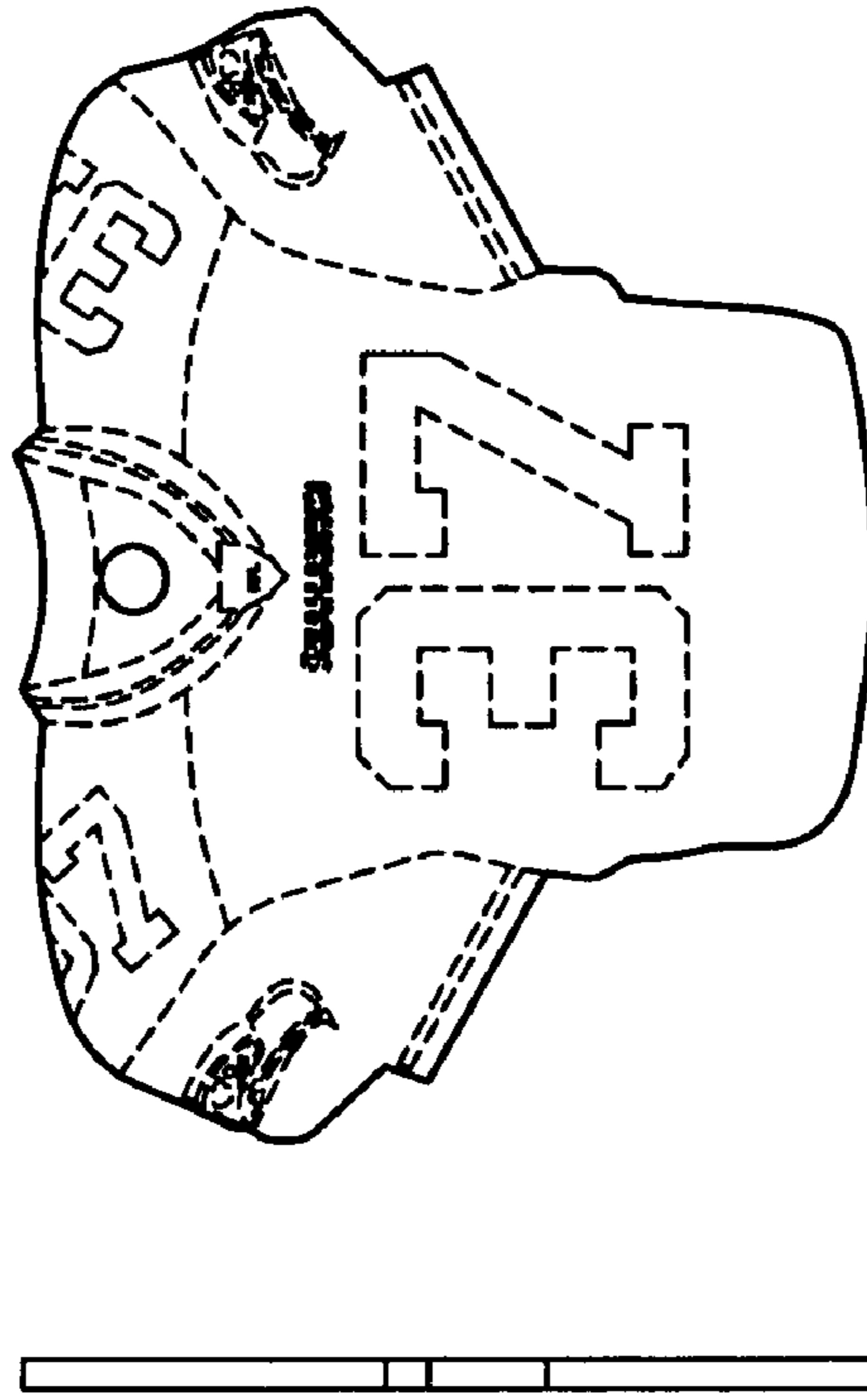

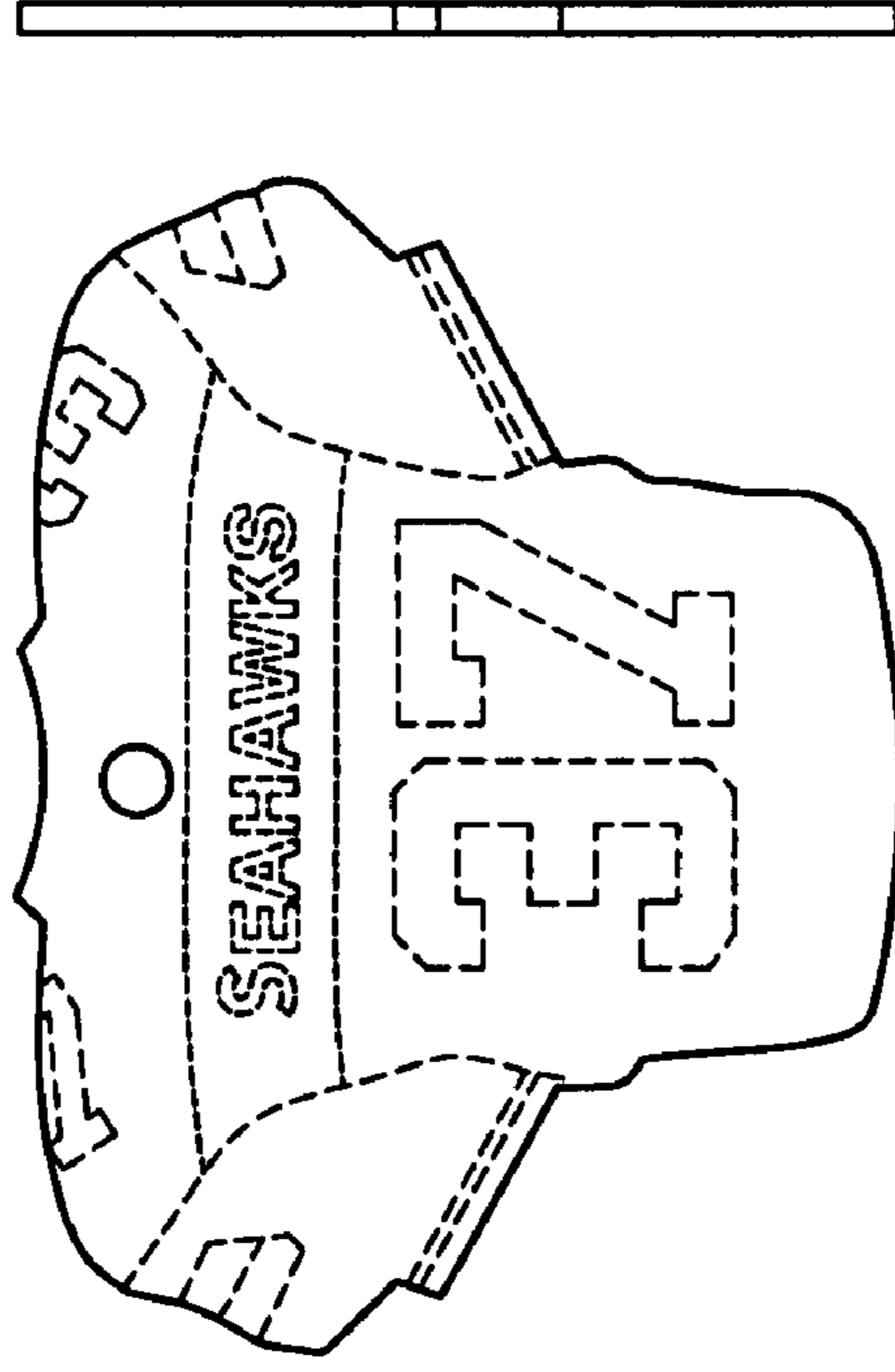
