The ornamental design for a syringe, as shown and described.

DESCRIPTION

FIG. 1 is a top end perspective view of a syringe showing my new design.

FIG. 2 is a bottom end perspective view thereof.

FIG. 3 is a right side elevational view thereof.

FIG. 4 is a rear side elevational view thereof.

FIG. 5 is a left side elevational view thereof.

FIG. 6 is a front side elevational view thereof.

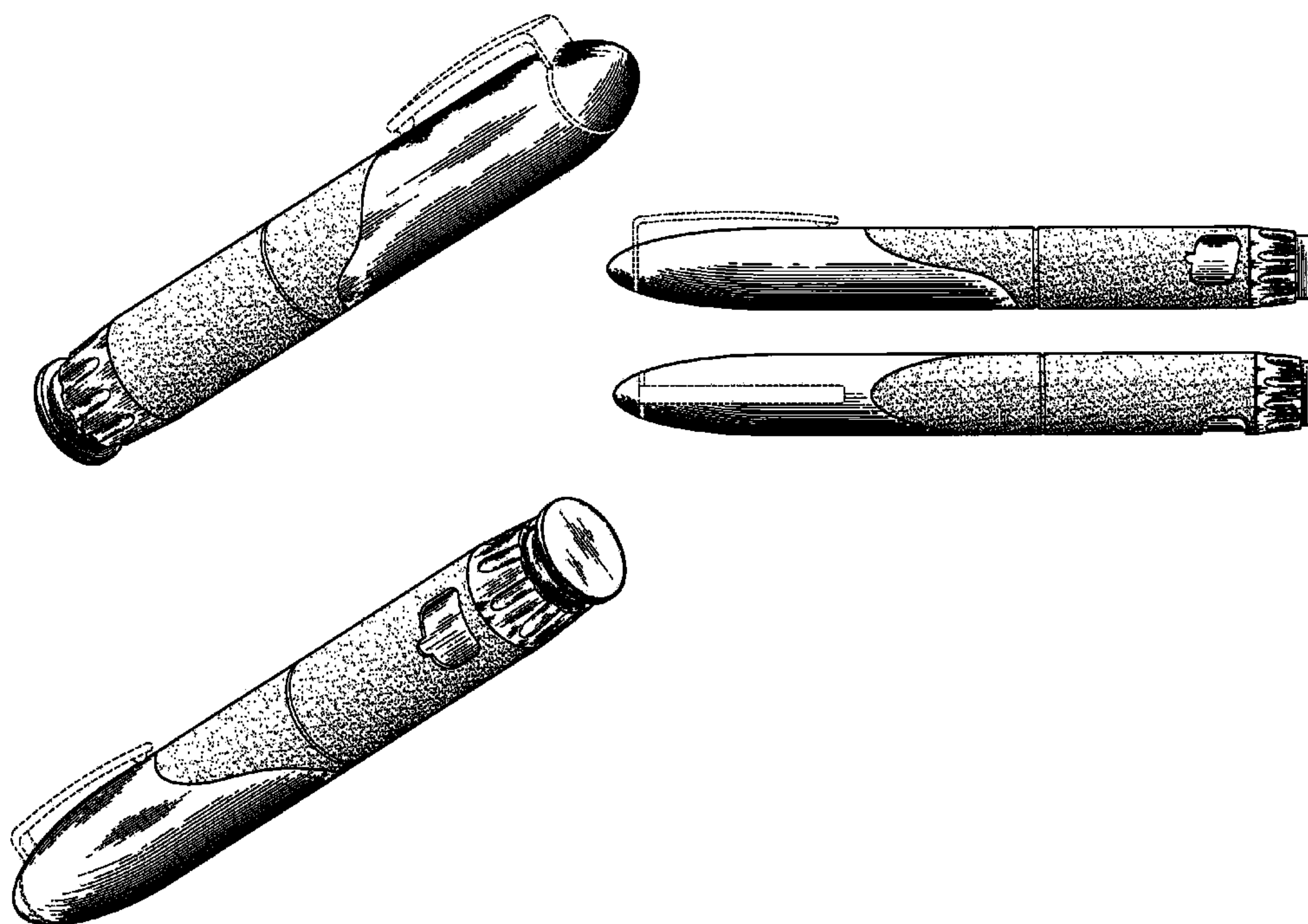
FIG. 7 is a bottom end plan view thereof; and,

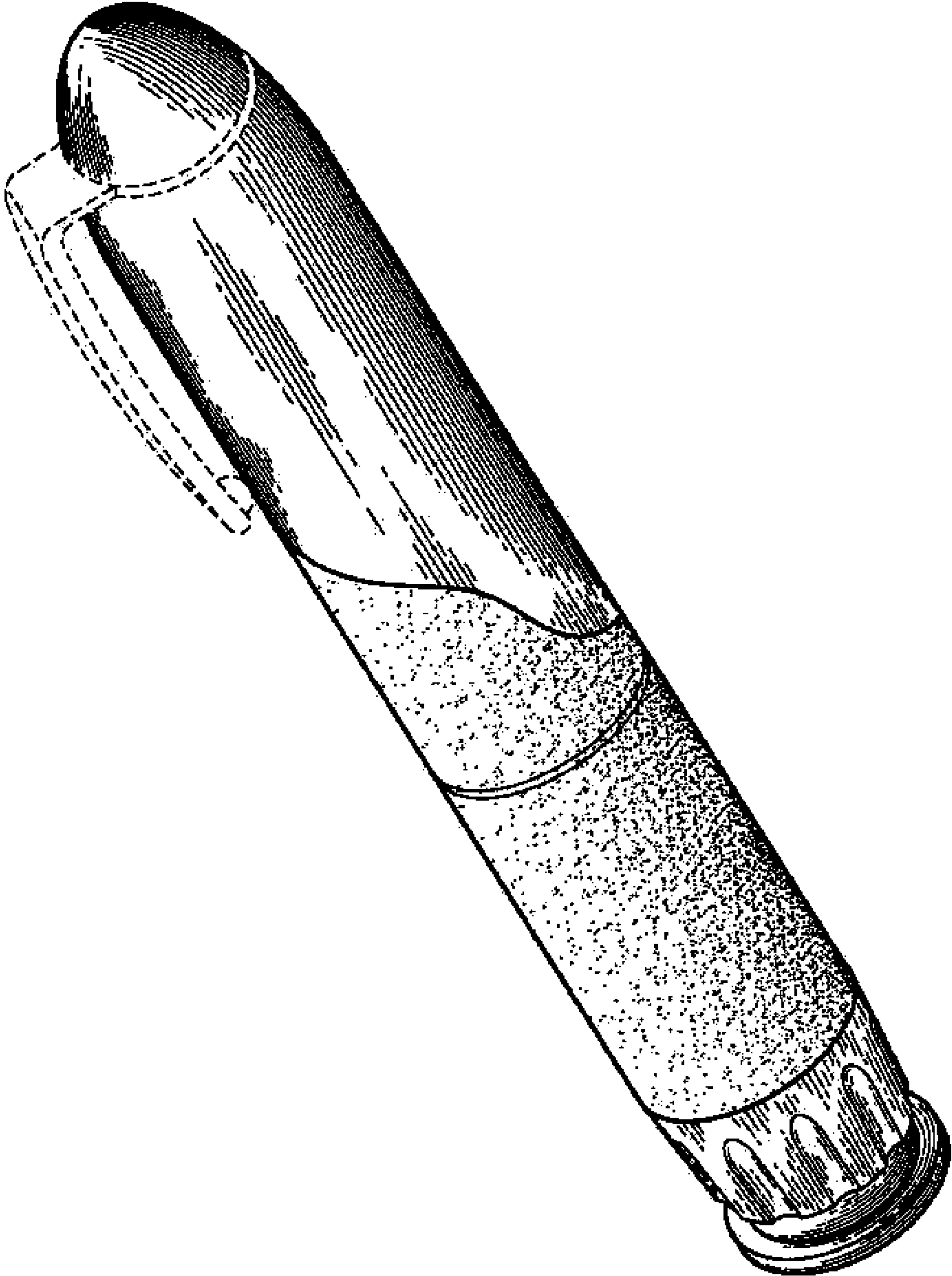

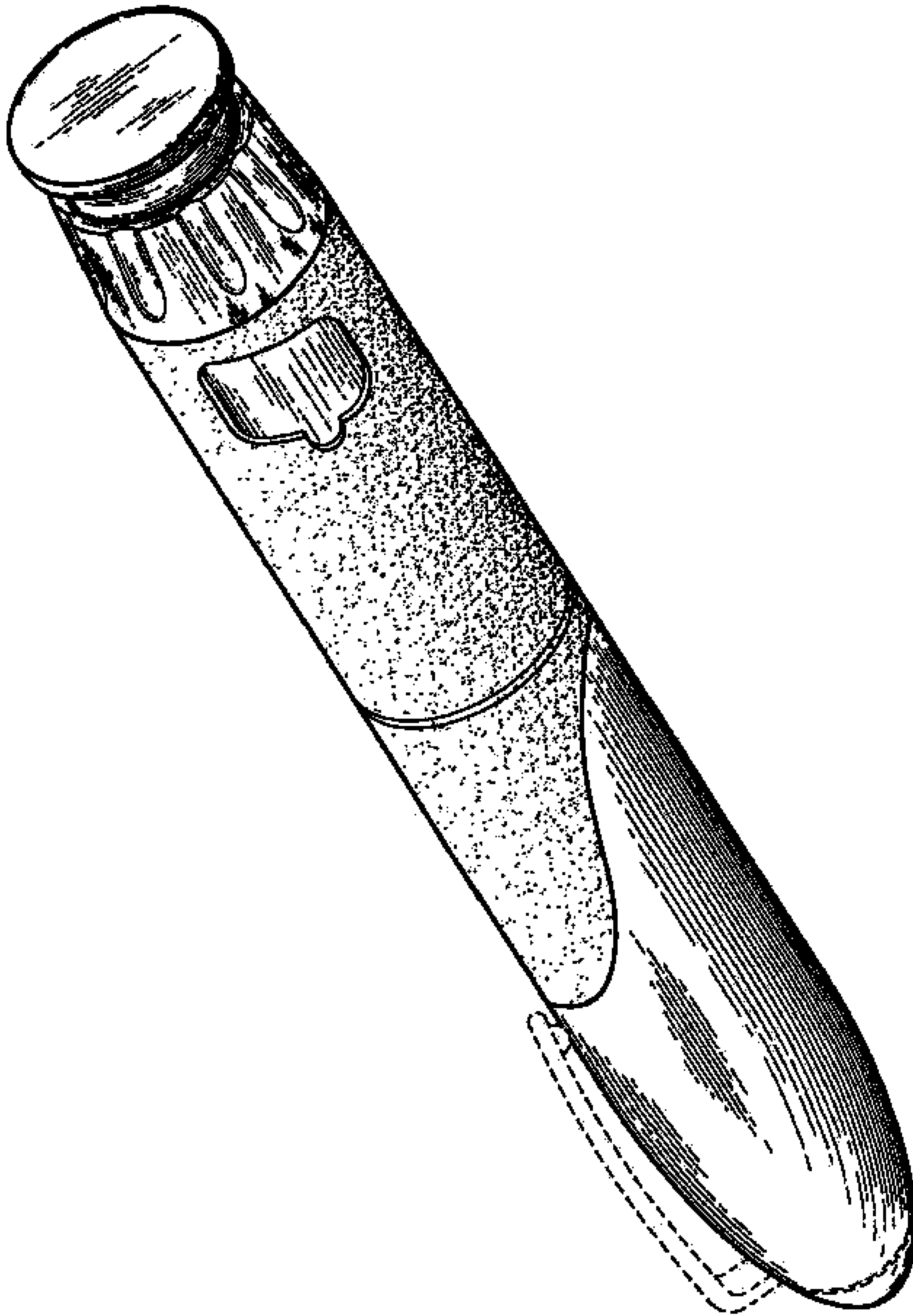

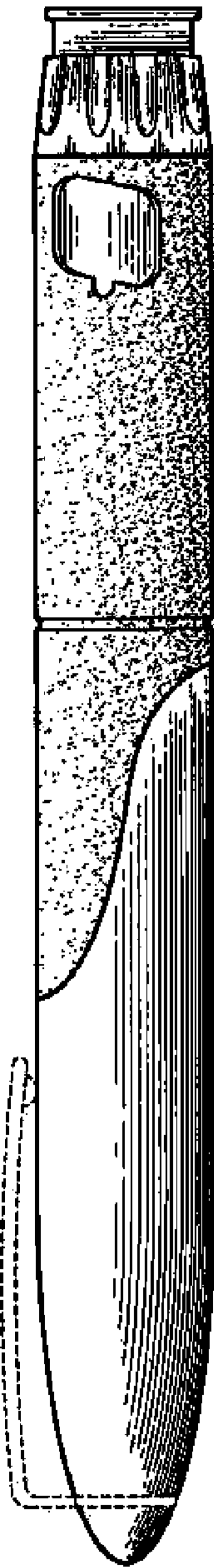

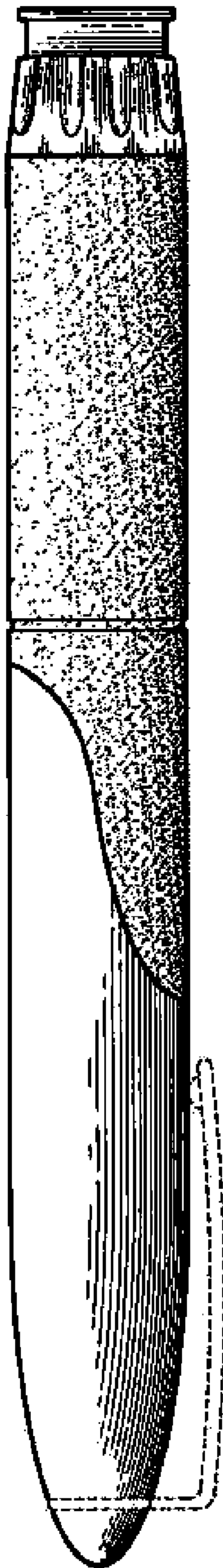

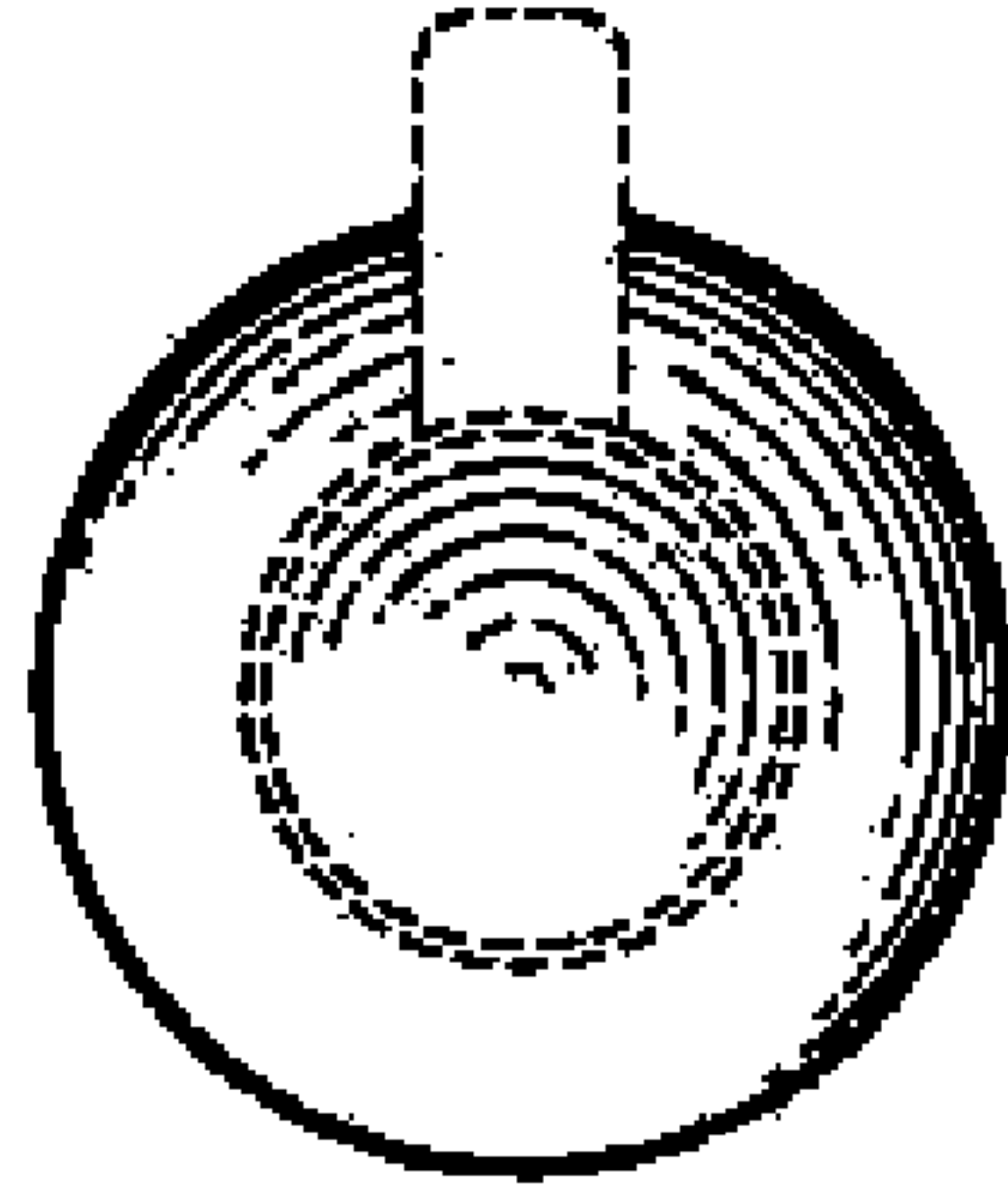
