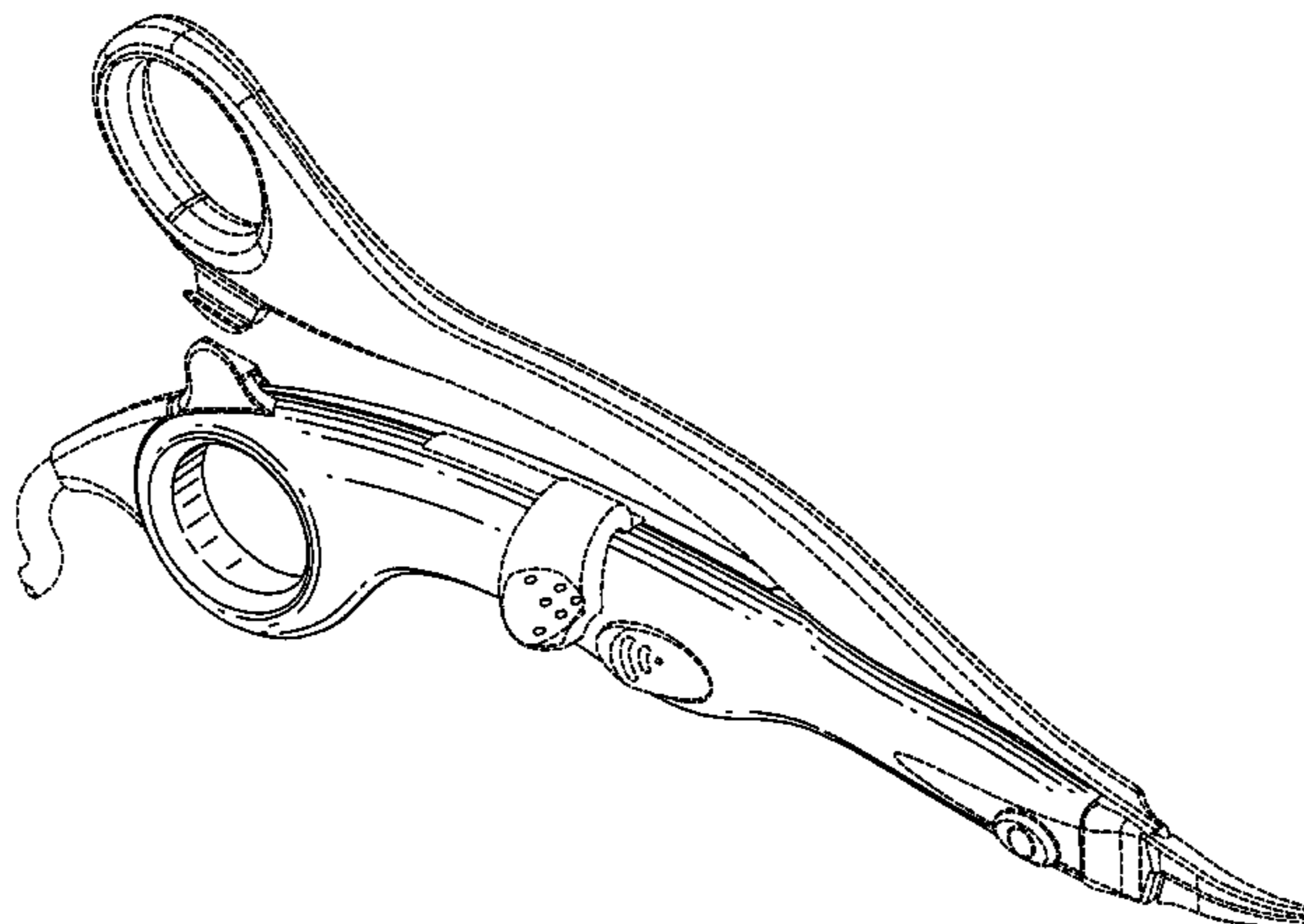
(57) **CLAIM**

We claim the ornamental design for an over-ratchet safety for a vessel sealing instrument, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of an over-ratchet safety for a vessel sealing instrument showing our new design;  
FIG. 2 is a rear perspective view thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is top view thereof;  
FIG. 7 is a front view thereof;

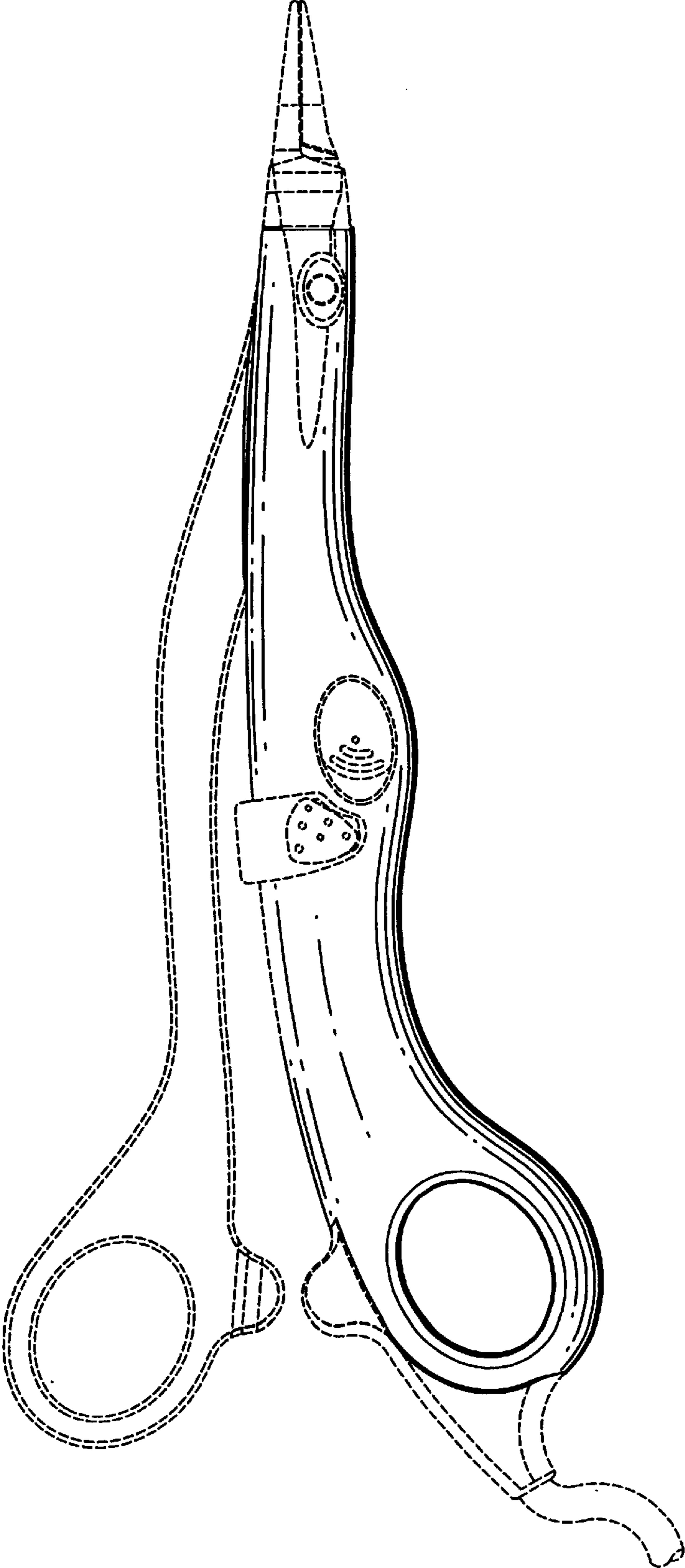
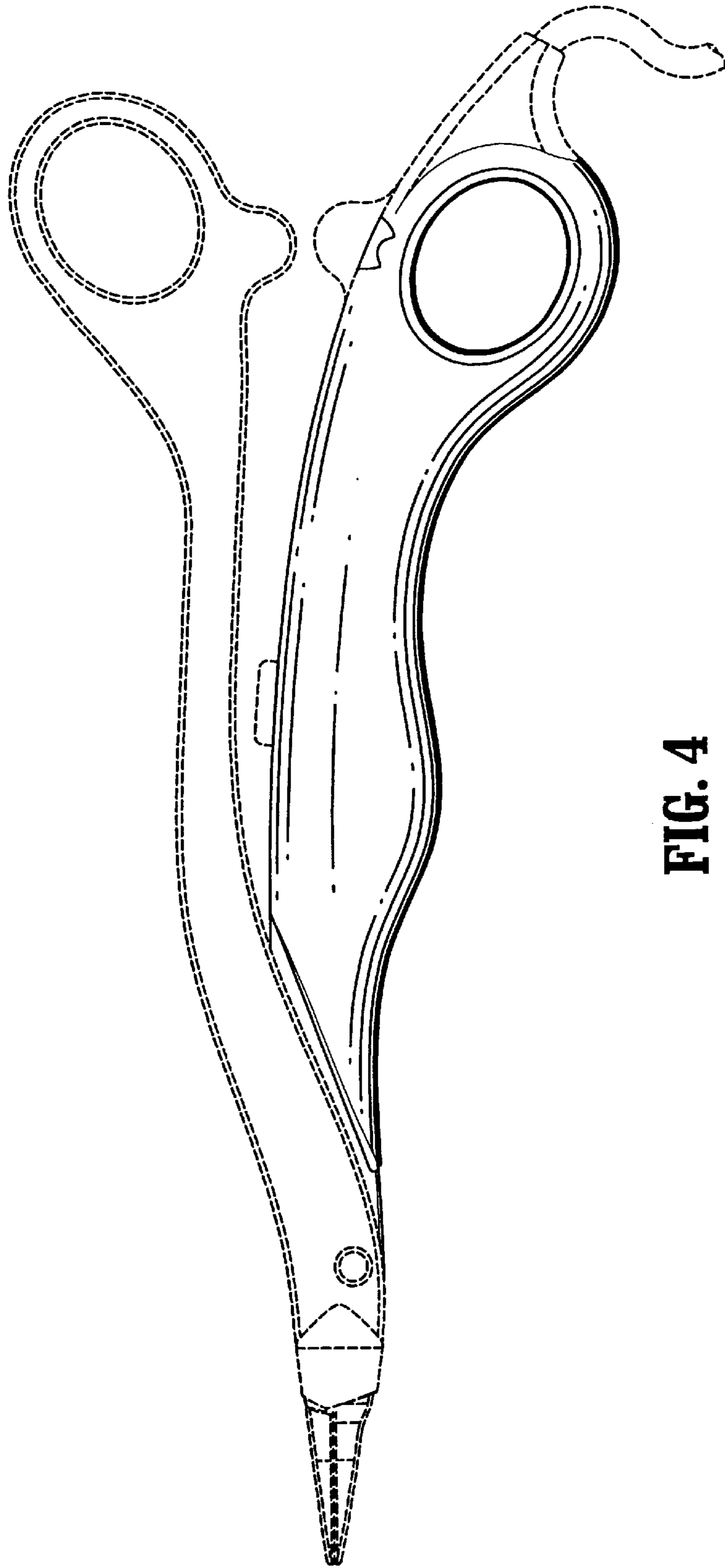
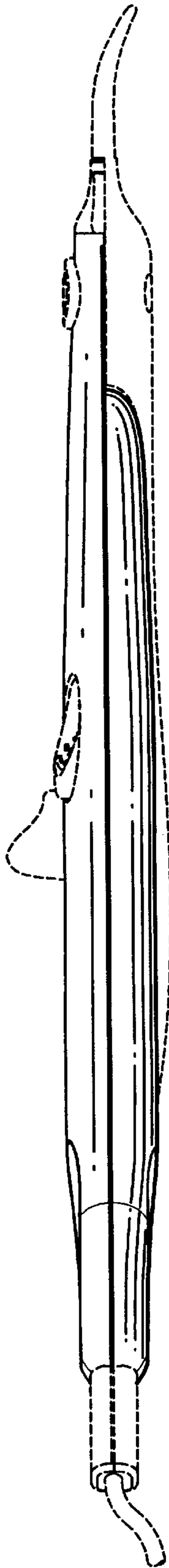

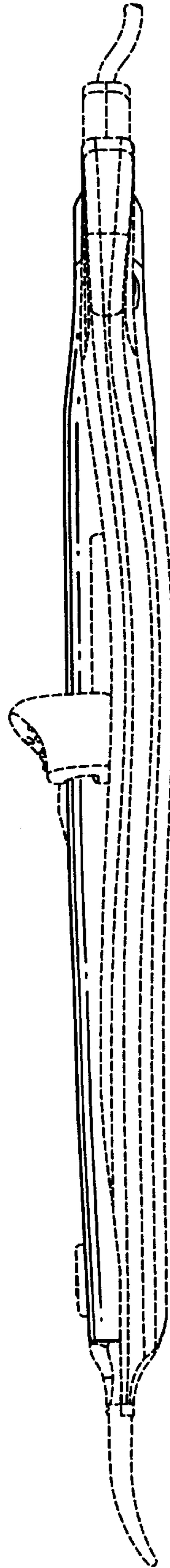




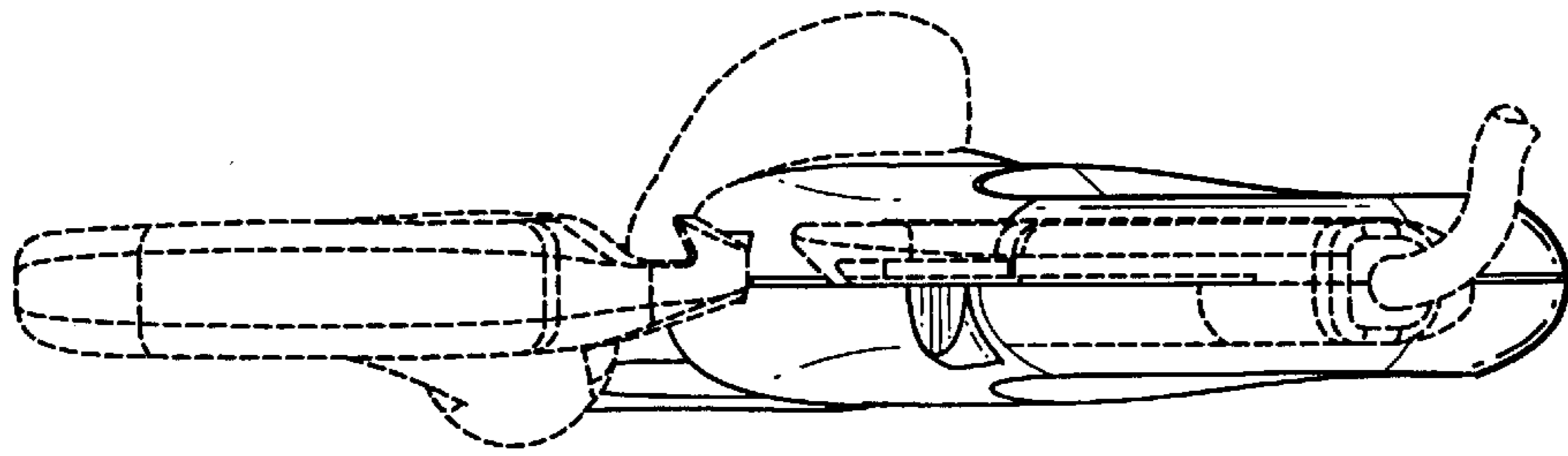

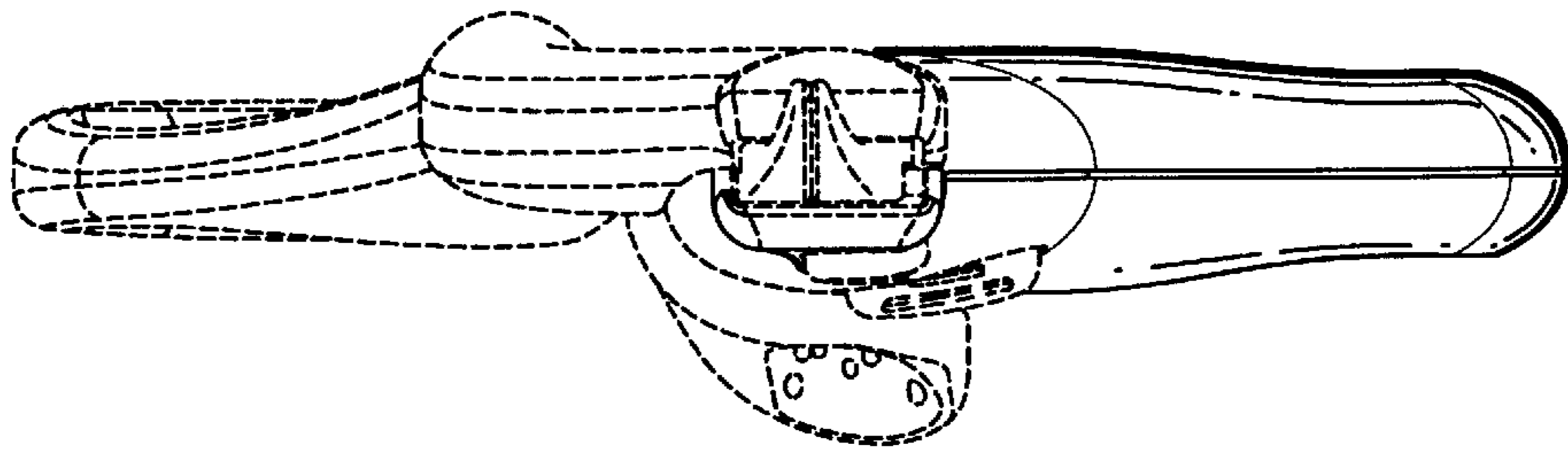
