(57) **CLAIM**

The ornamental design for a tube for chemical supply pump, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tube for chemical supply pump showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a right side elevational view thereof; the left side view being identical;

FIG. 7 is a sectional view taken along line A—A of FIG. 6; and,

FIG. 8 is a sectional view taken along line B—B of FIG. 2.

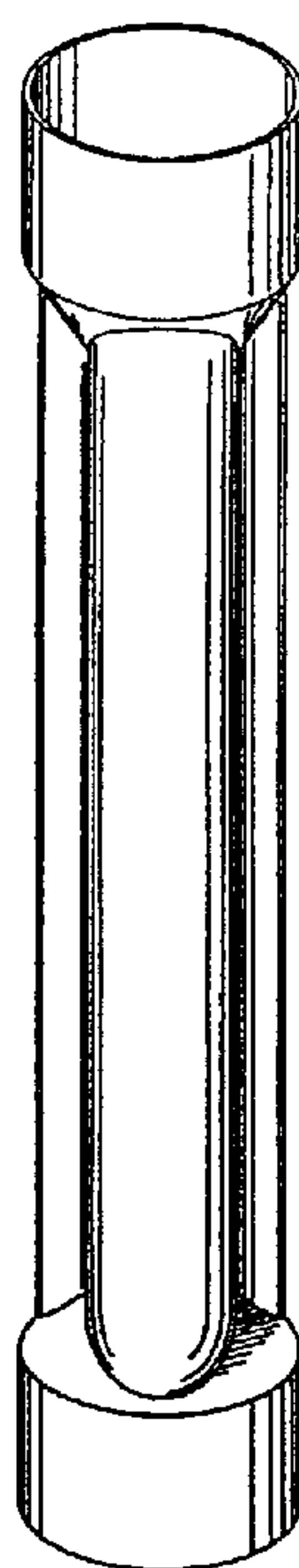

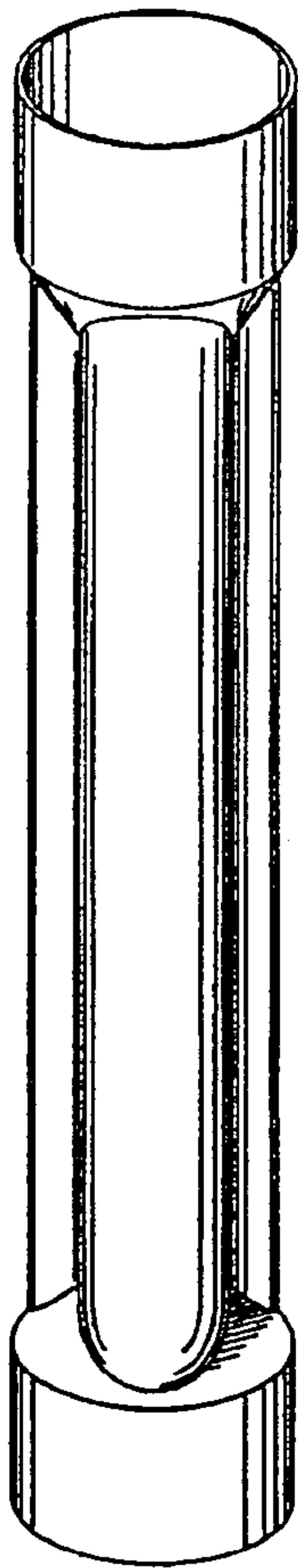

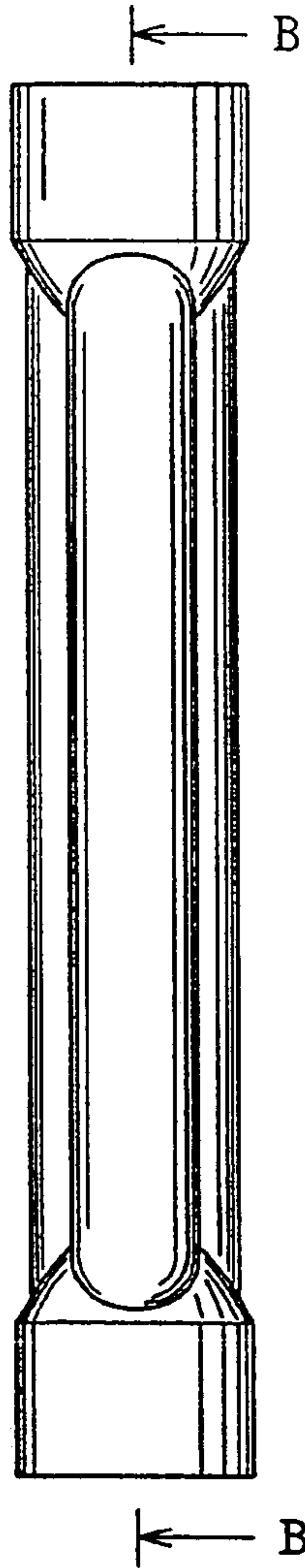

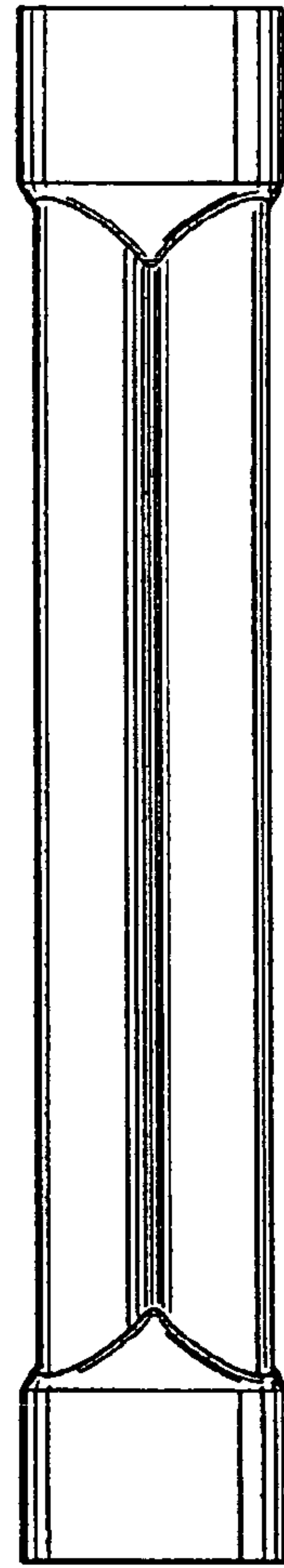

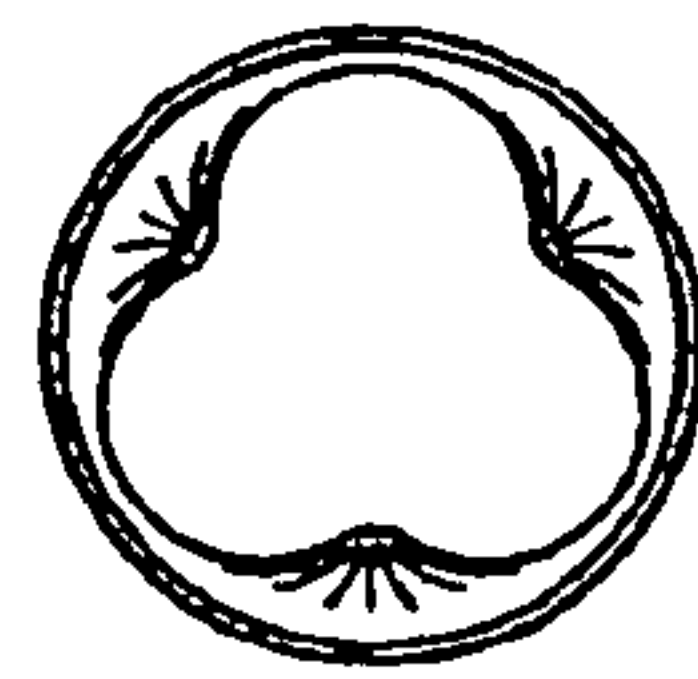

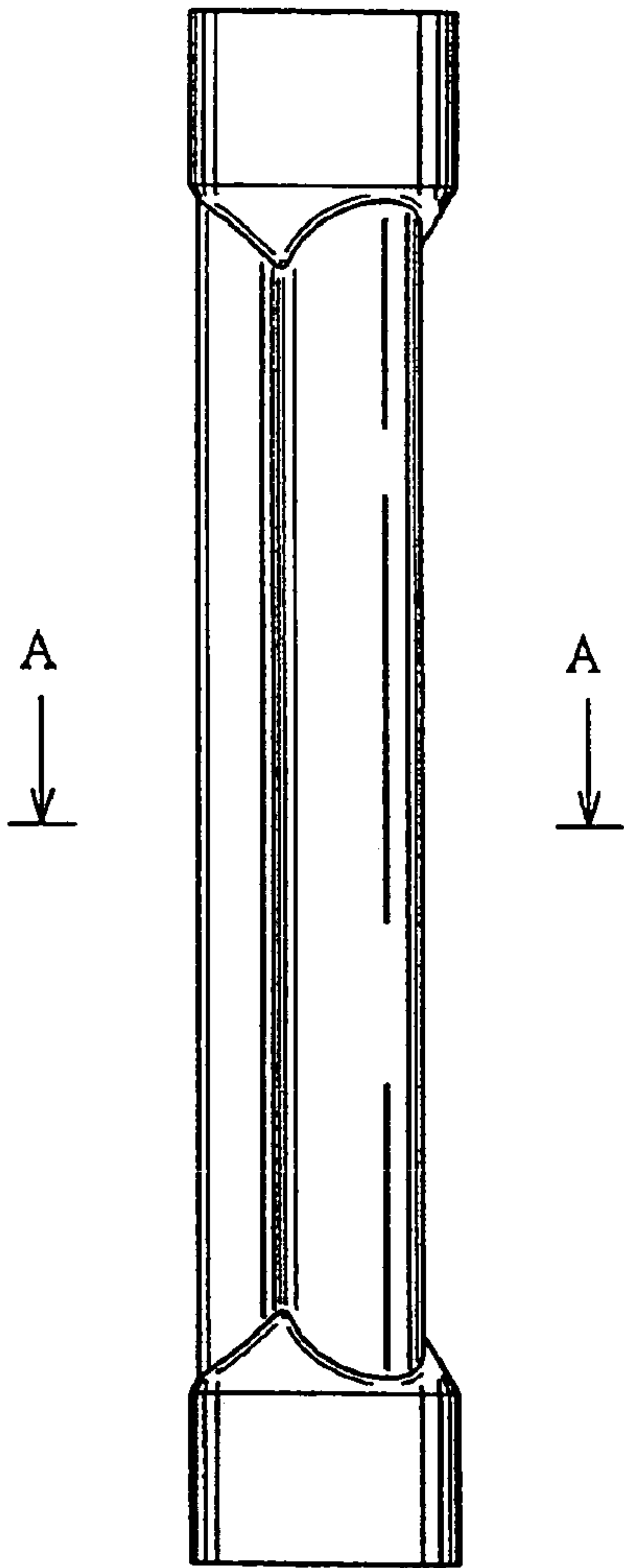

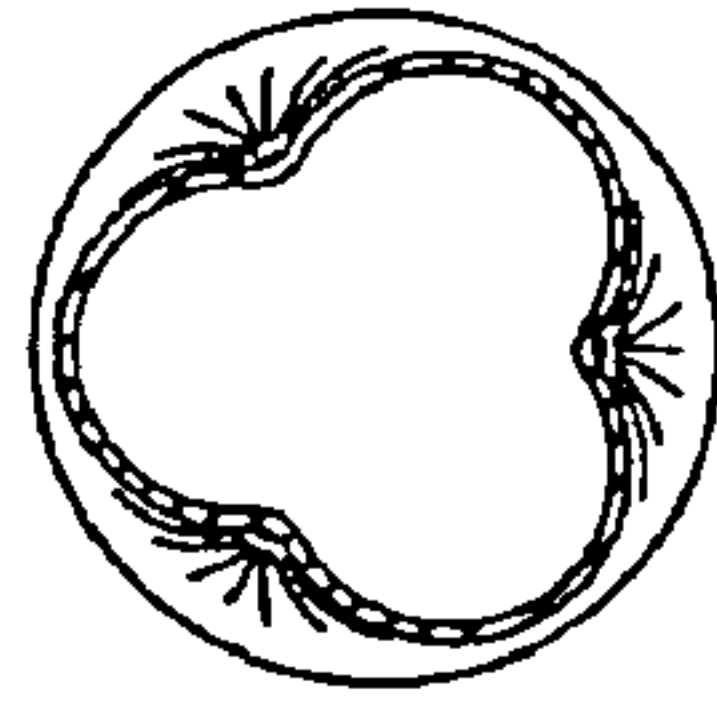
