(57) **CLAIM**

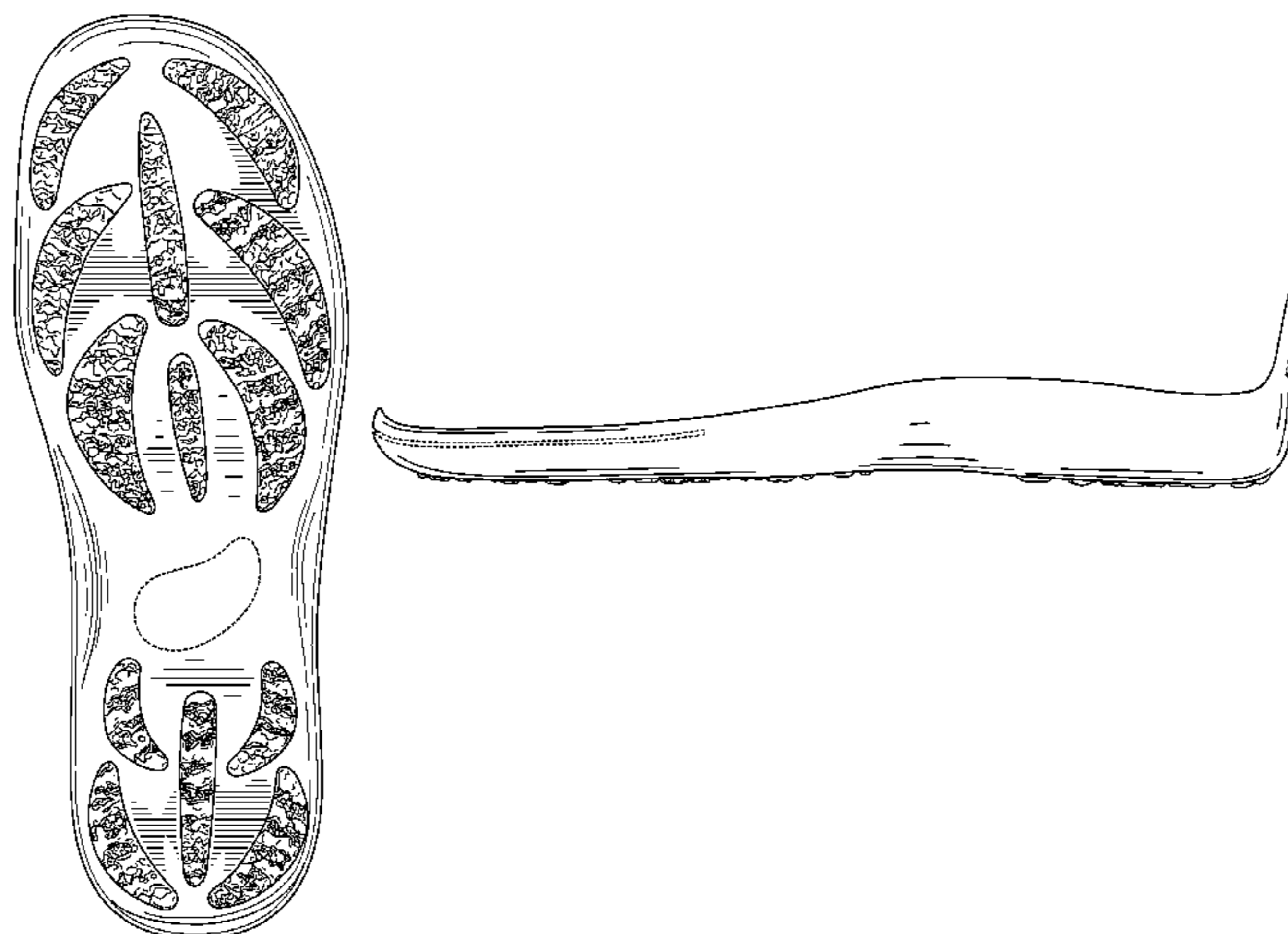
I claim the ornamental design for an outsole for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of an outsole for a shoe in accordance with the new design;
FIG. 2 is bottom view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a front view thereof; and,
FIG. 6 is a rear view thereof.

The broken line showing a curvilinear shape in the arch area of FIGS. 1 & 2, along with the parallel broken lines in the toe and heel areas of FIGS. 1 & 3-6 represent the boundaries of the design; with neither the lines themselves, nor the areas within them forming any part of the claim.

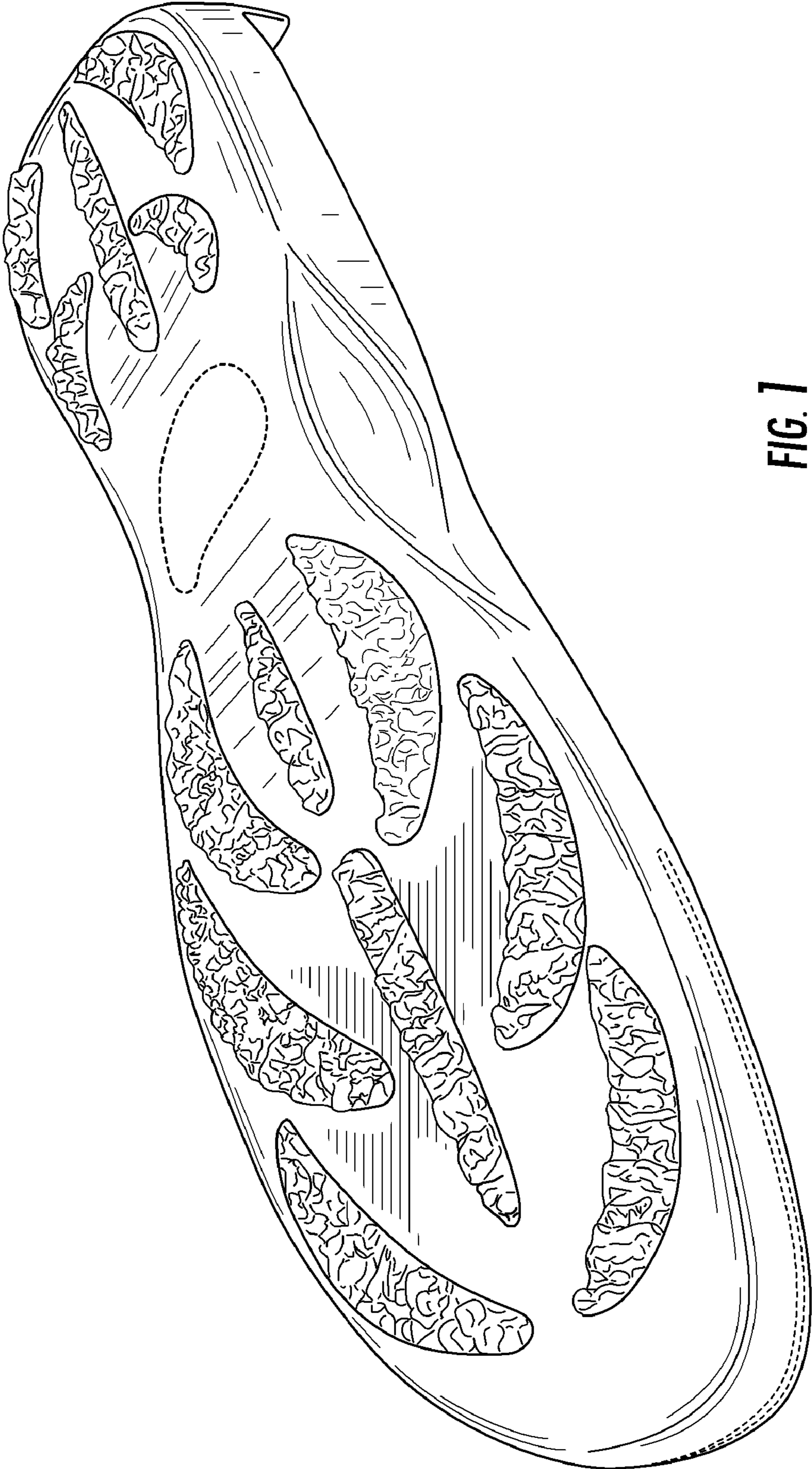

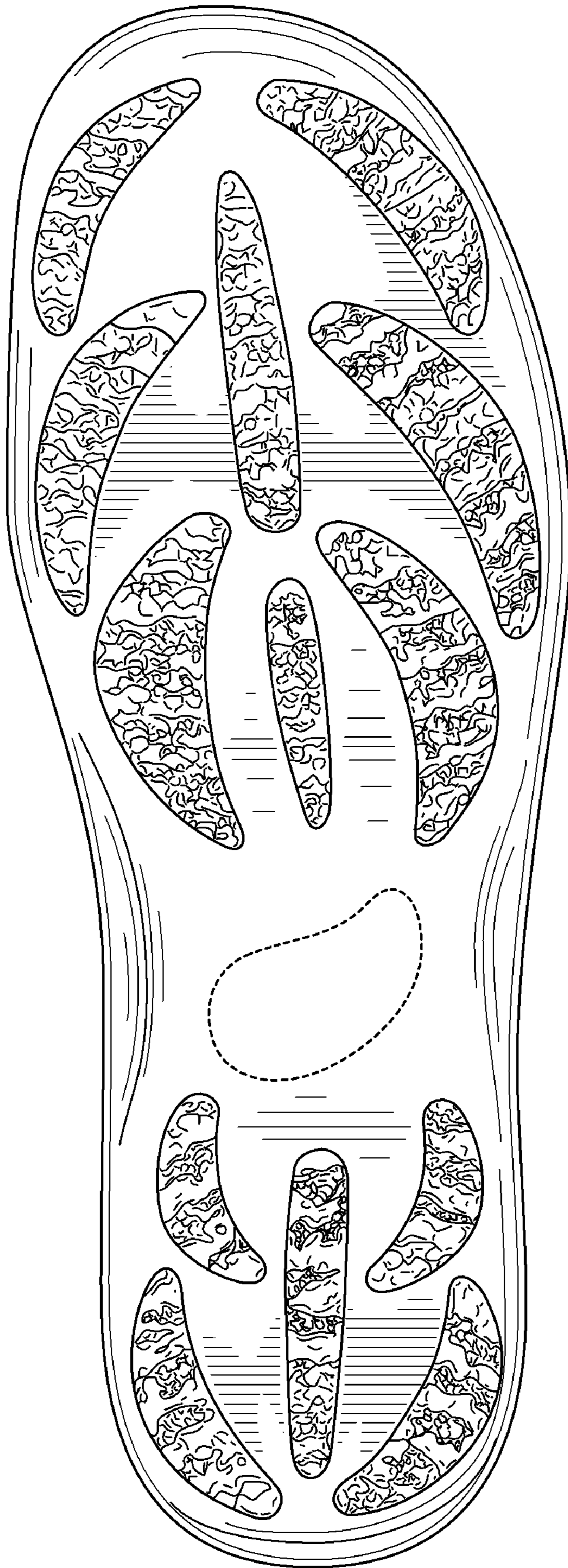

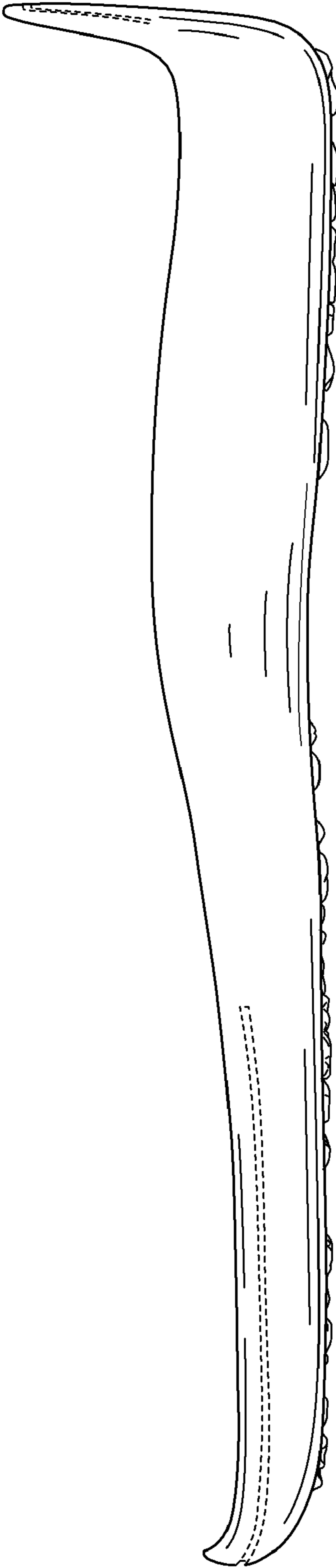

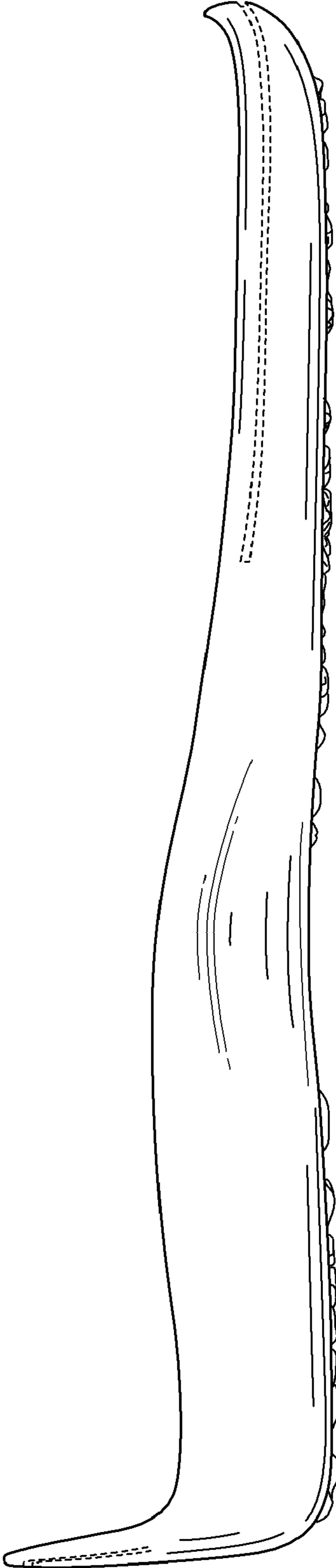

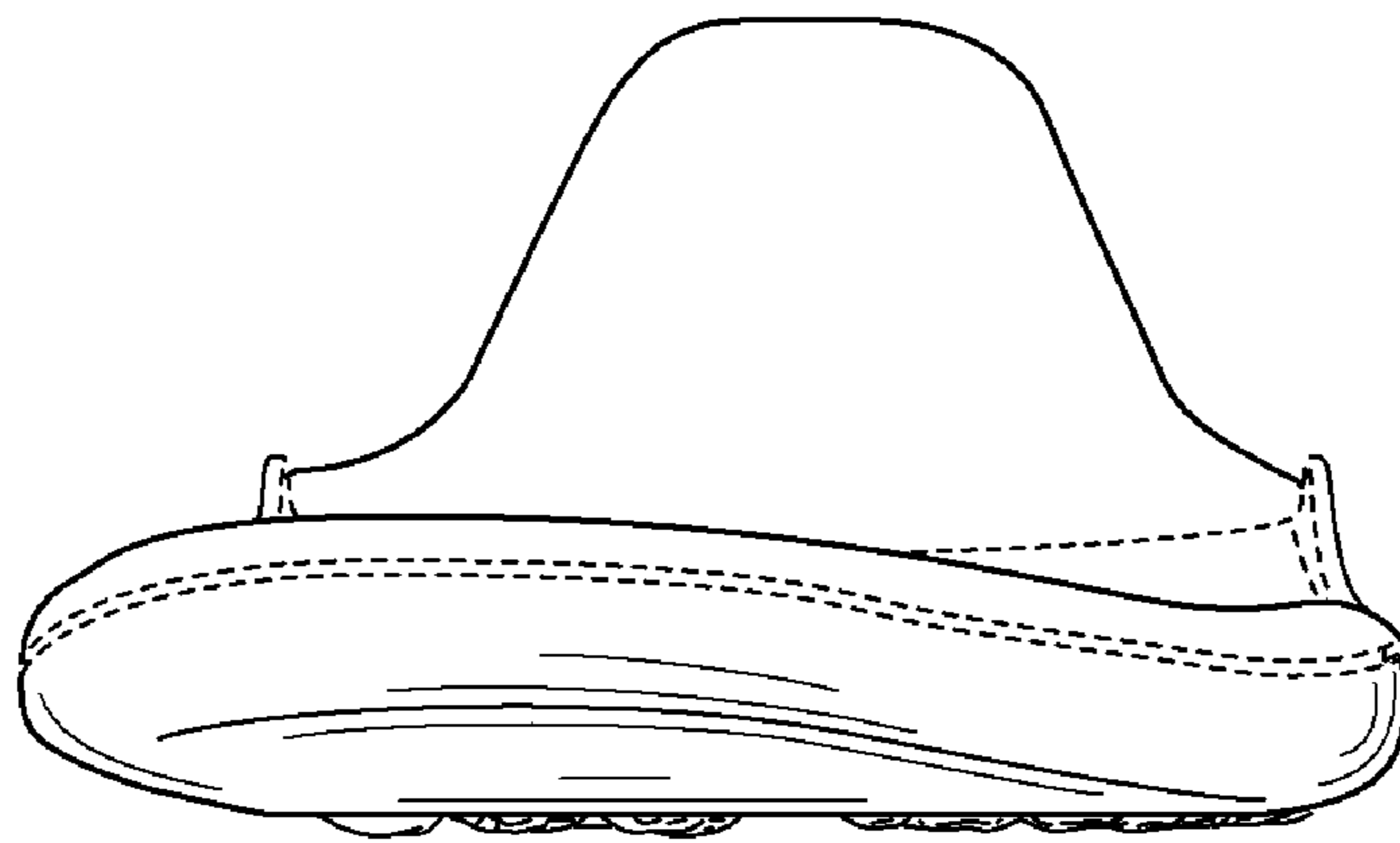

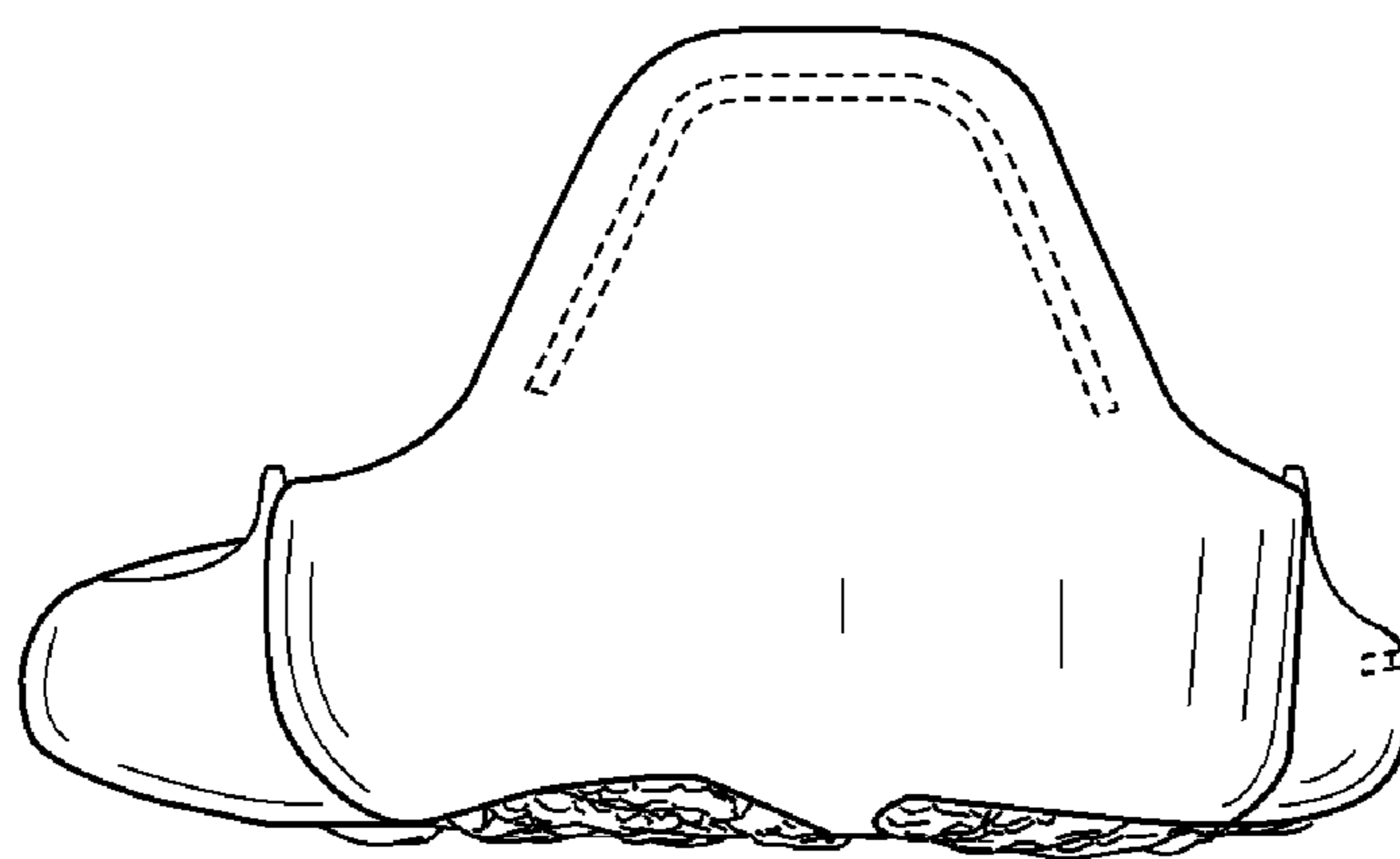
