(57) **CLAIM**

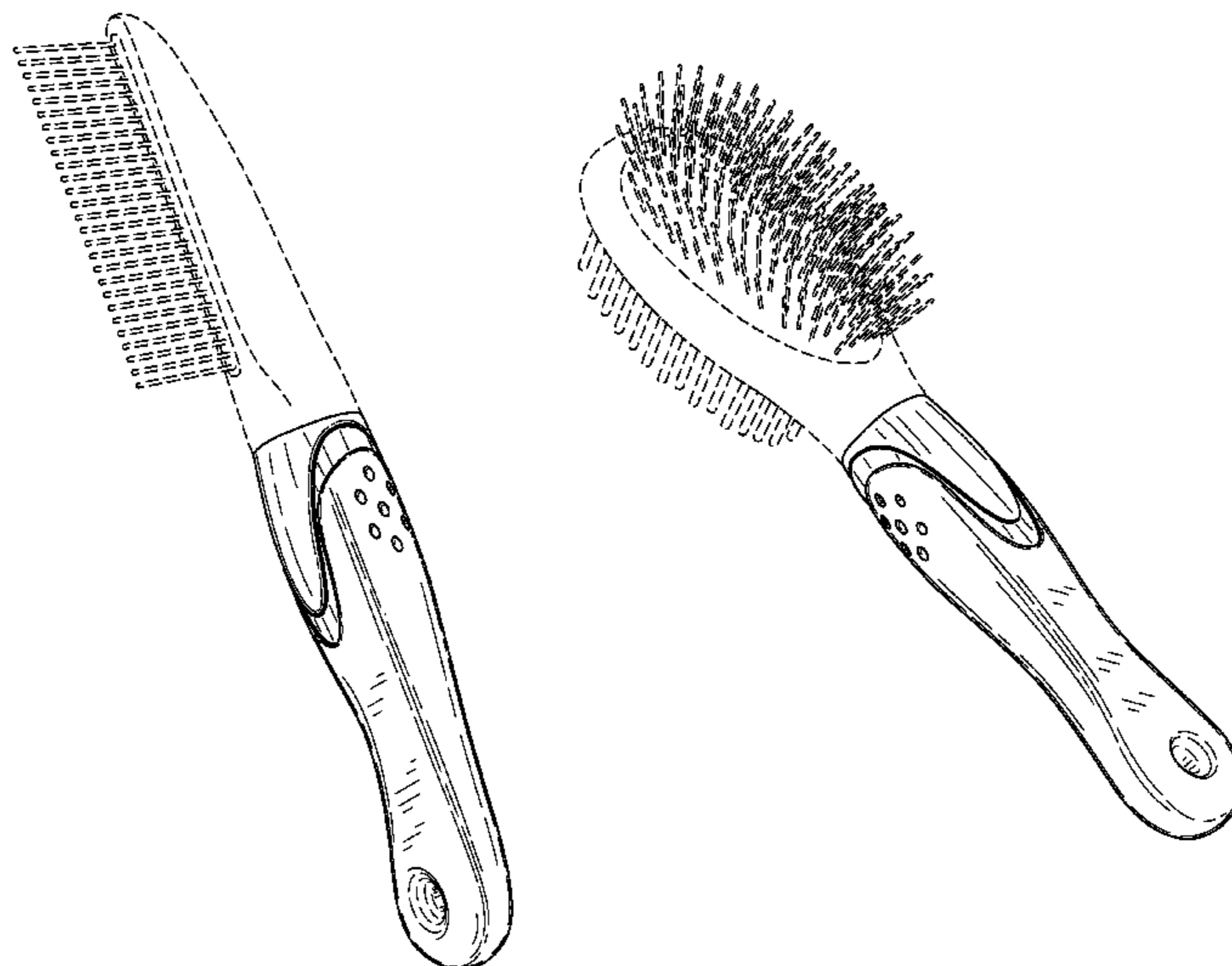
The ornamental design for a tool handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the tool handle;
 FIG. 2 is a front view of the tool handle of FIG. 1;
 FIG. 3 is a rear view of the tool handle of FIG. 1;
 FIG. 4 is a view of the right side of the tool handle of FIG. 1;
 FIG. 5 is a view of the left side of the tool handle of FIG. 1;
 FIG. 6 is a top view of the tool handle of FIG. 1;
 FIG. 7 is a bottom view of the tool handle of FIG. 1;
 FIG. 8 is a perspective view of a second embodiment of the tool handle of FIG. 1, the only difference being the angle of the tool handle, it being understood that the surfaces of the tool handle are otherwise the same as those in the embodiment of FIG. 1;
 FIG. 9 is a view of the tool handle of FIG. 8;
 FIG. 10 is a rear view of the tool handle of FIG. 8;
 FIG. 11 is a view of the right side of the tool handle of FIG. 8;
 FIG. 12 is a view of the left side of the tool handle of FIG. 8;
 FIG. 13 is a top view of the tool handle of FIG. 8; and,
 FIG. 14 is a bottom view of the tool handle of FIG. 8.

The broken lines showing a comb head in FIG. 1 and a brush head in FIG. 8 are included for the purpose of illustrating environmental structure that forms no part of the claimed design.

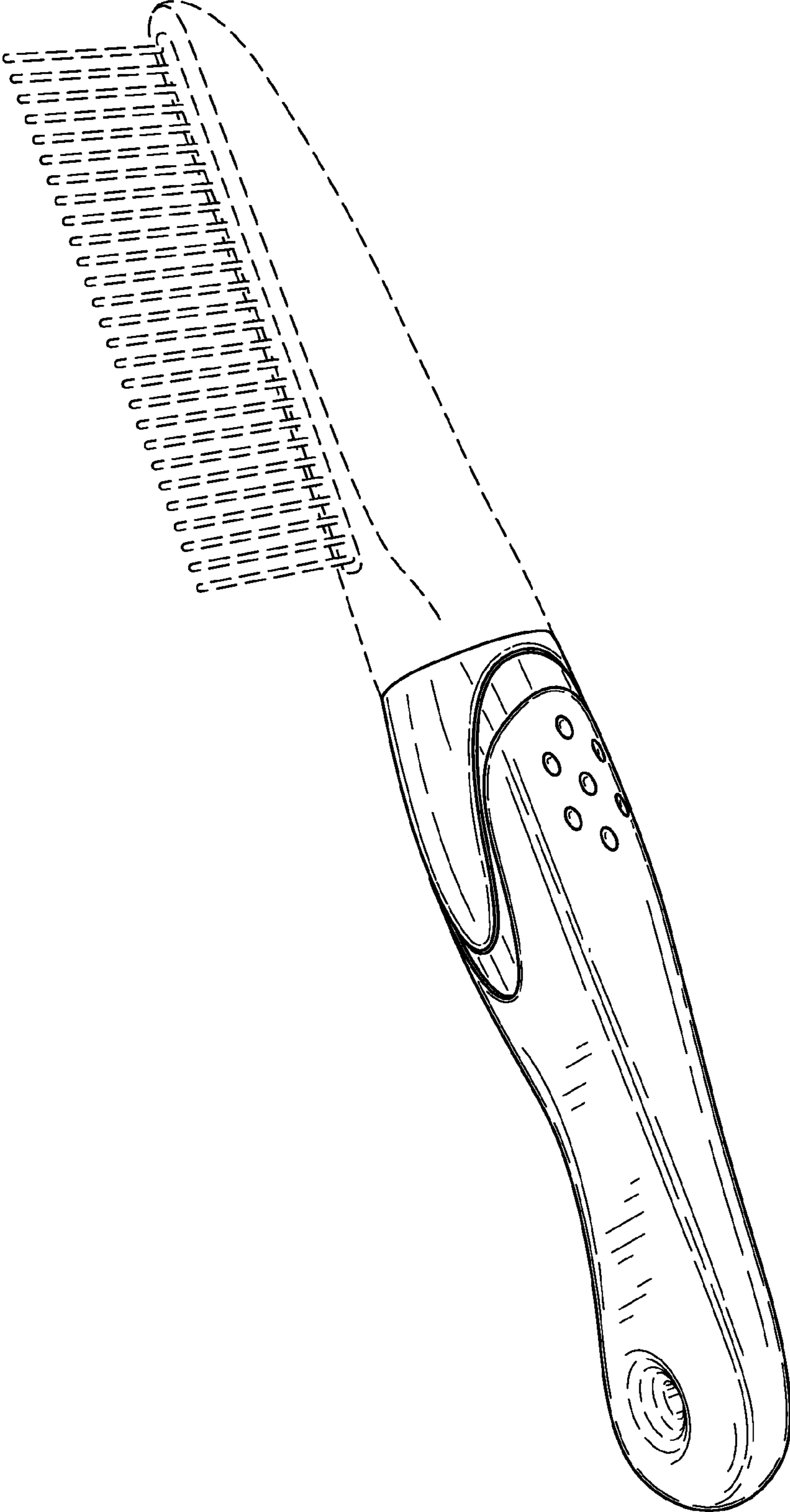

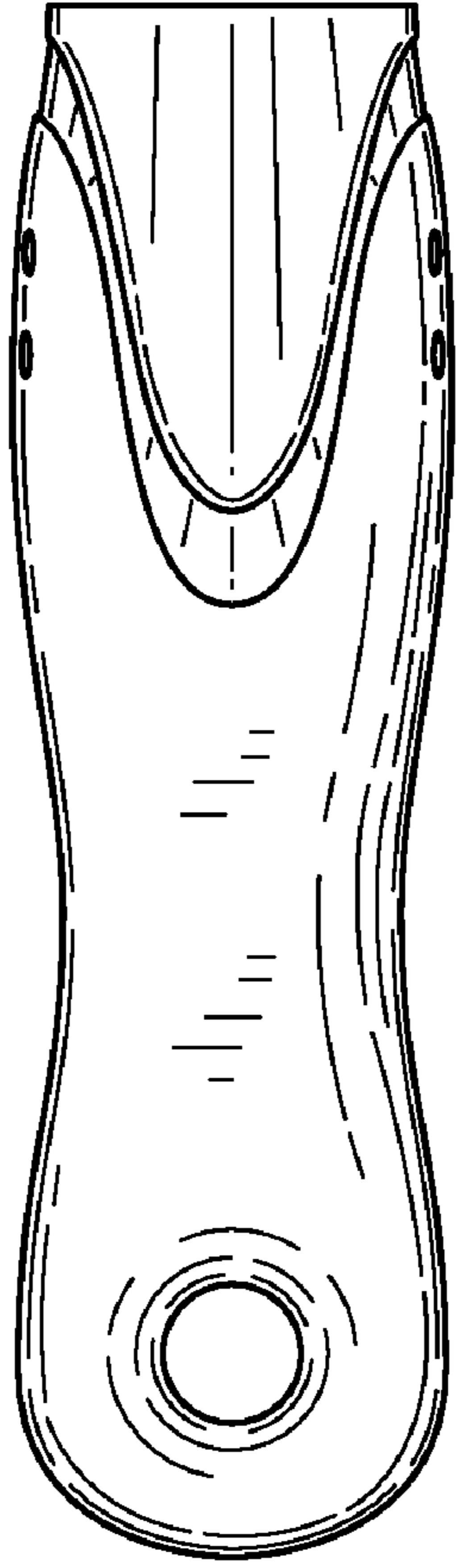

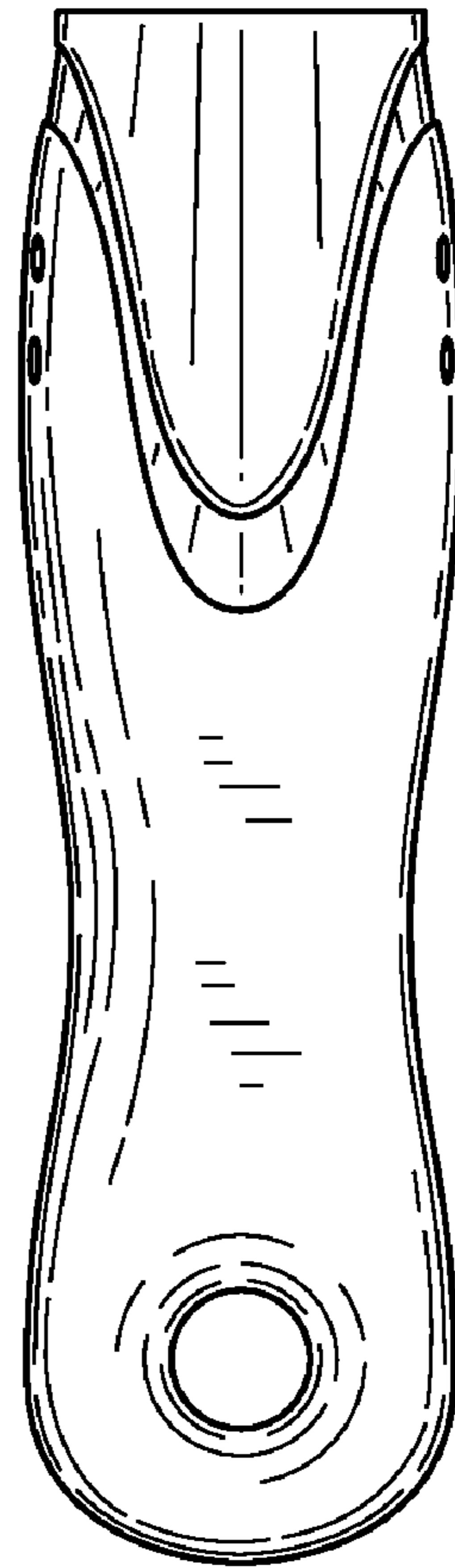

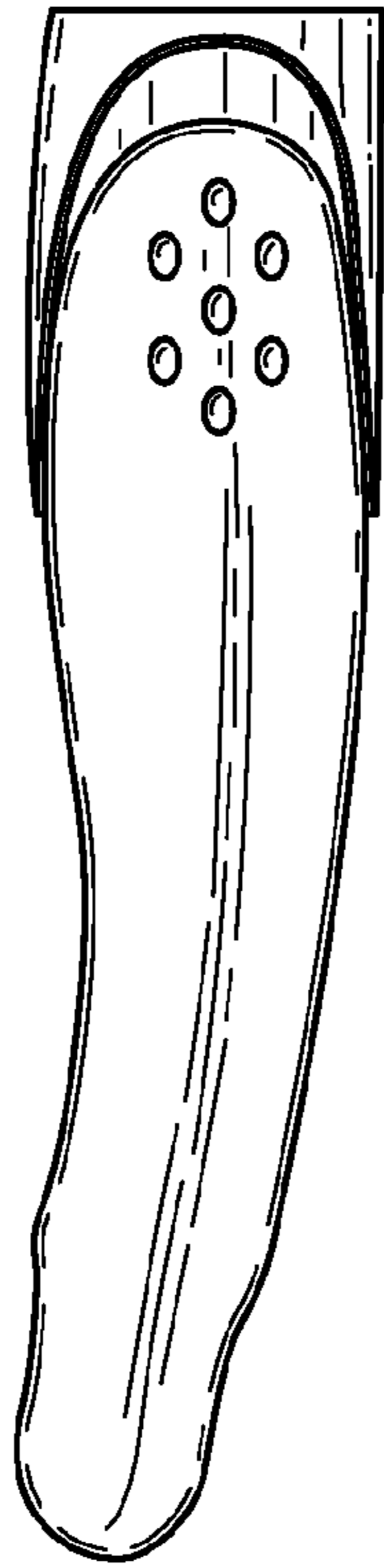

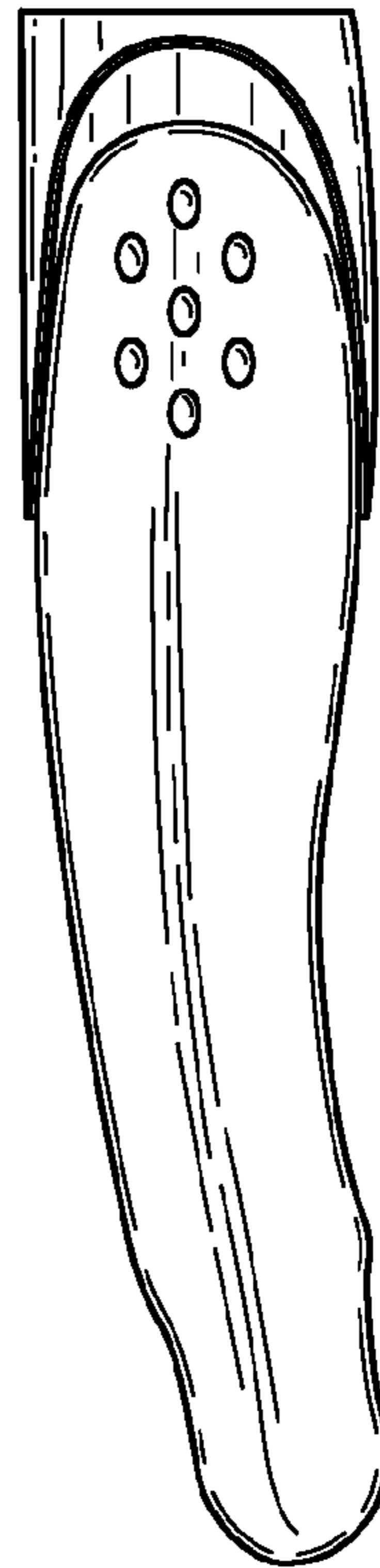

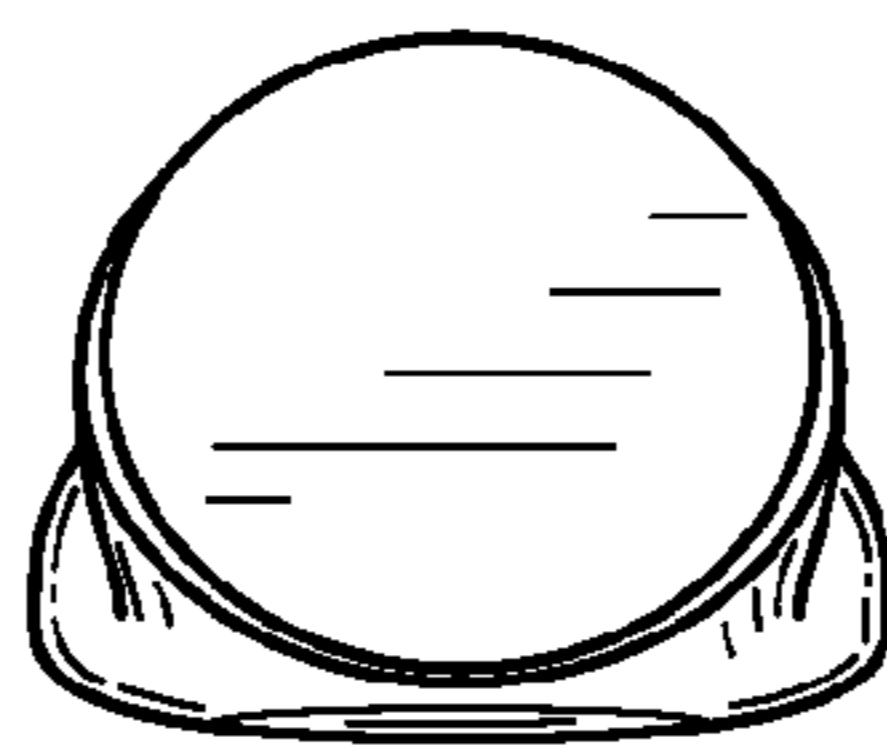

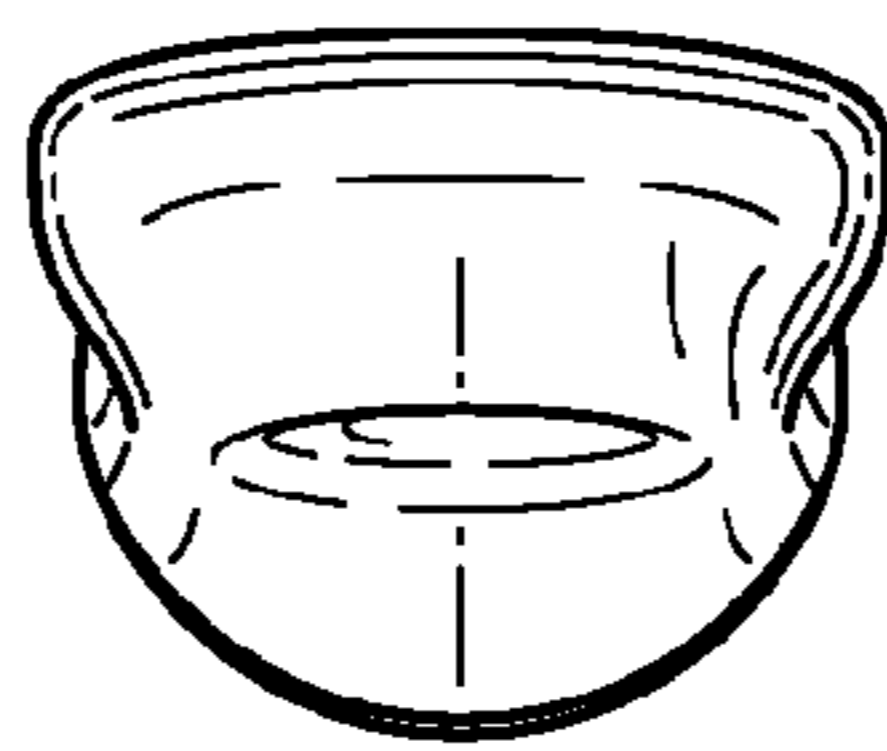

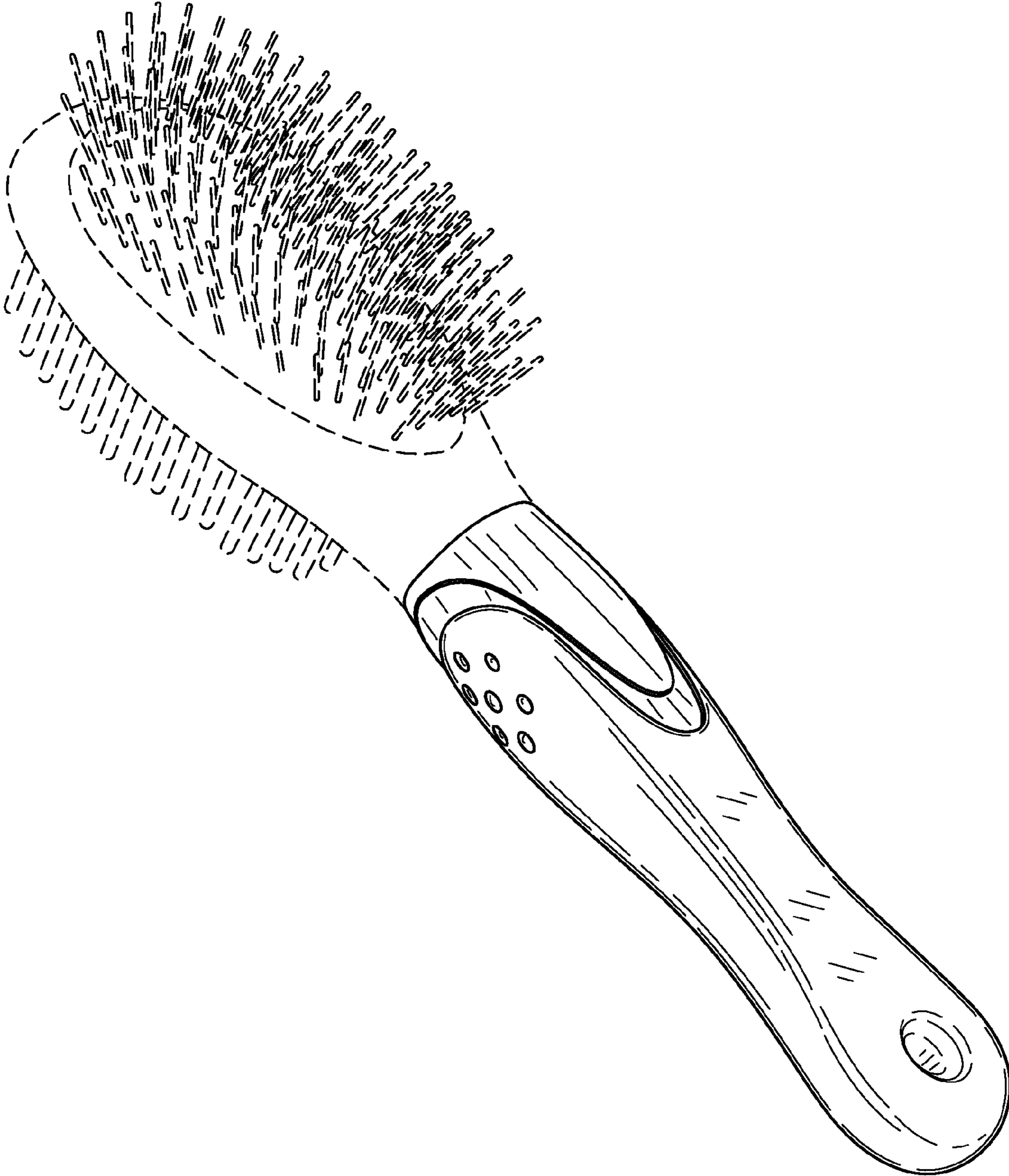

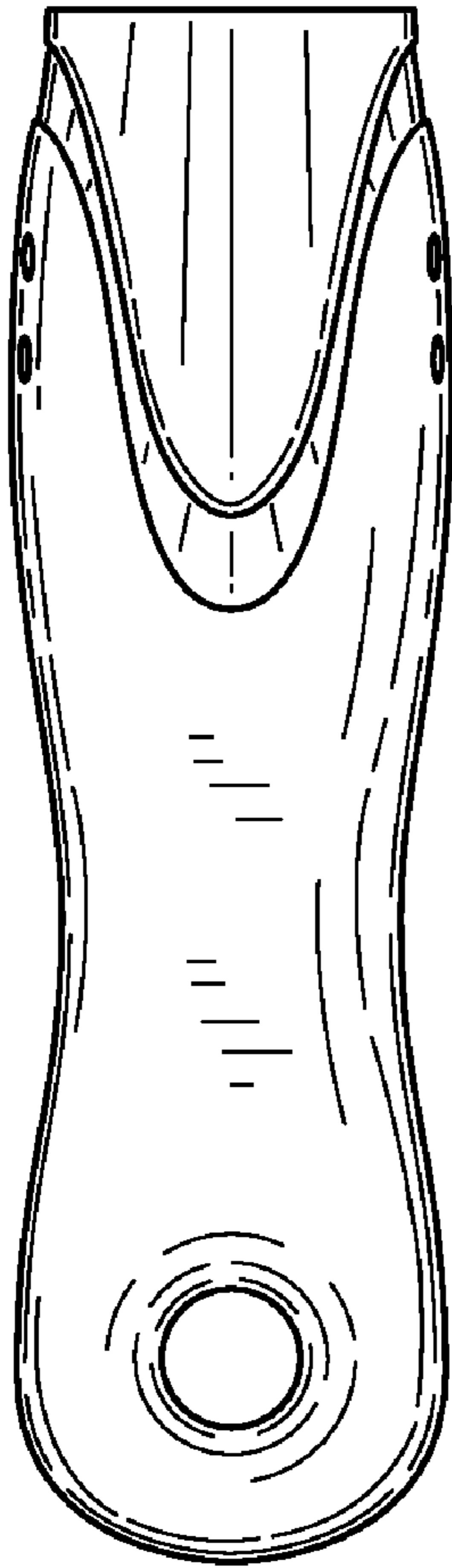

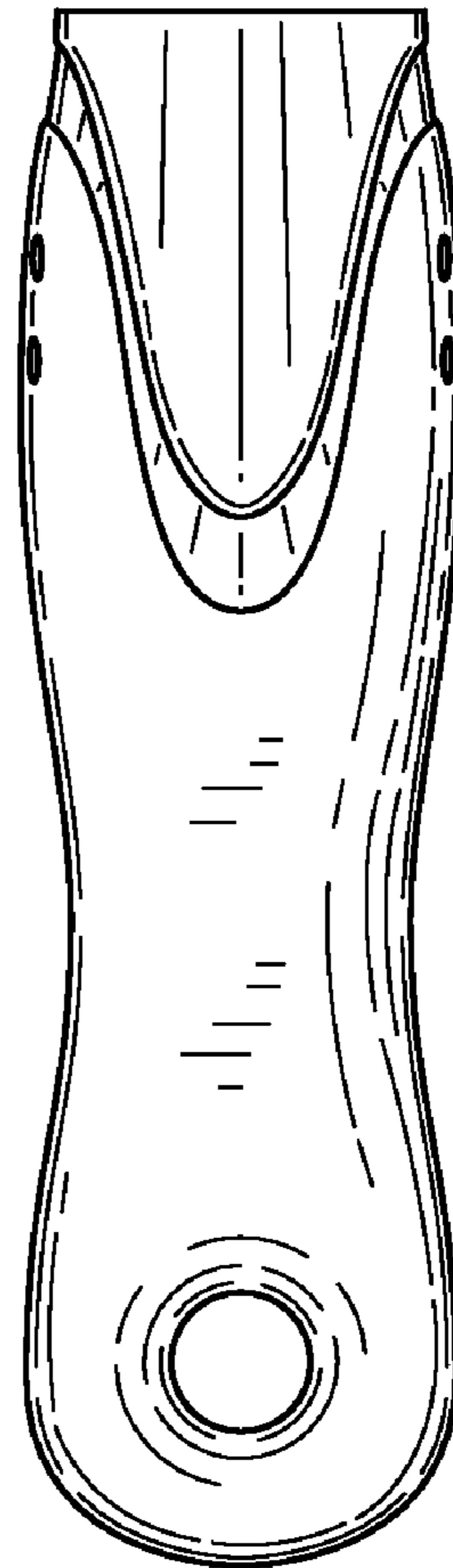

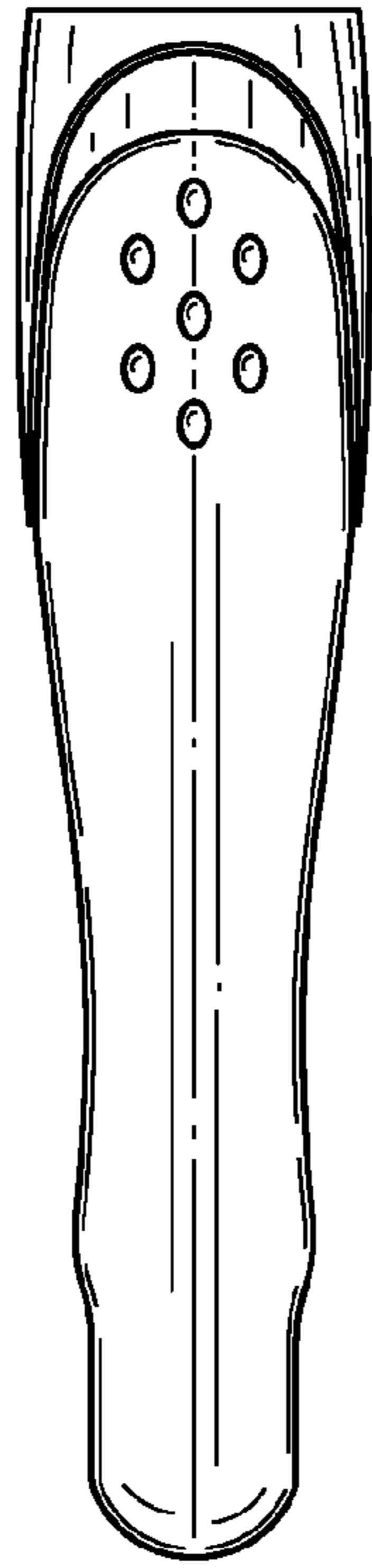

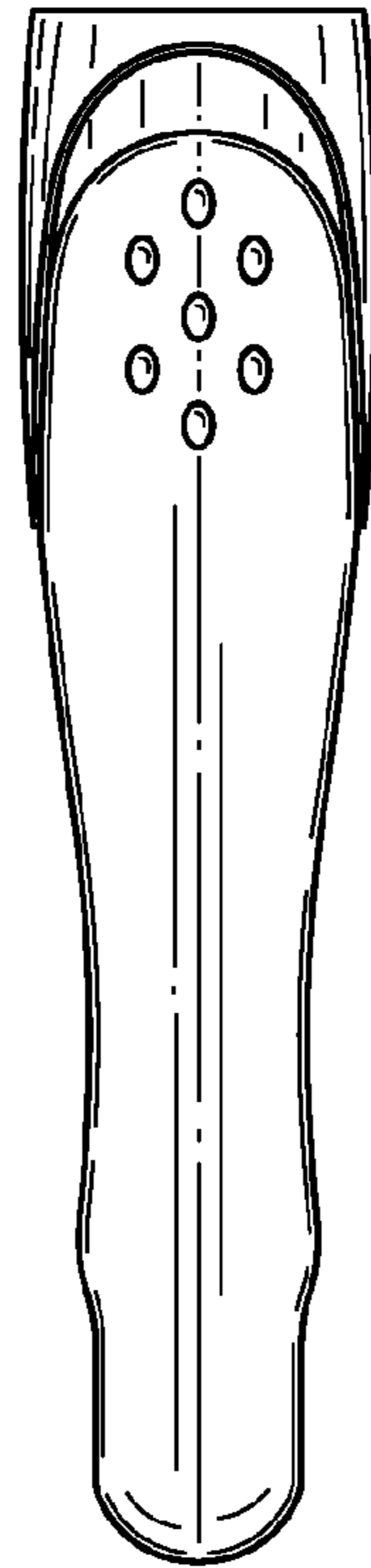

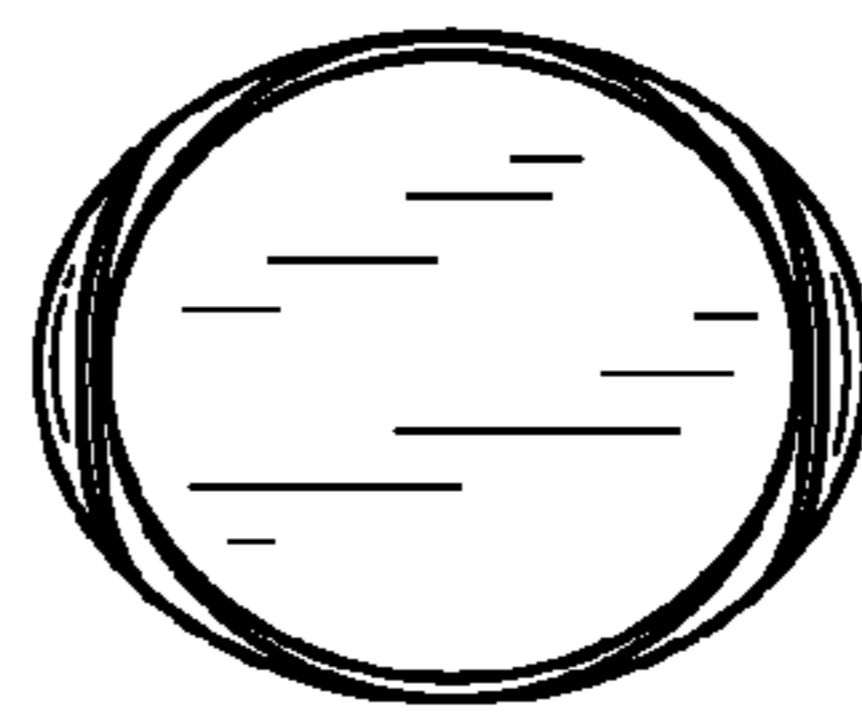

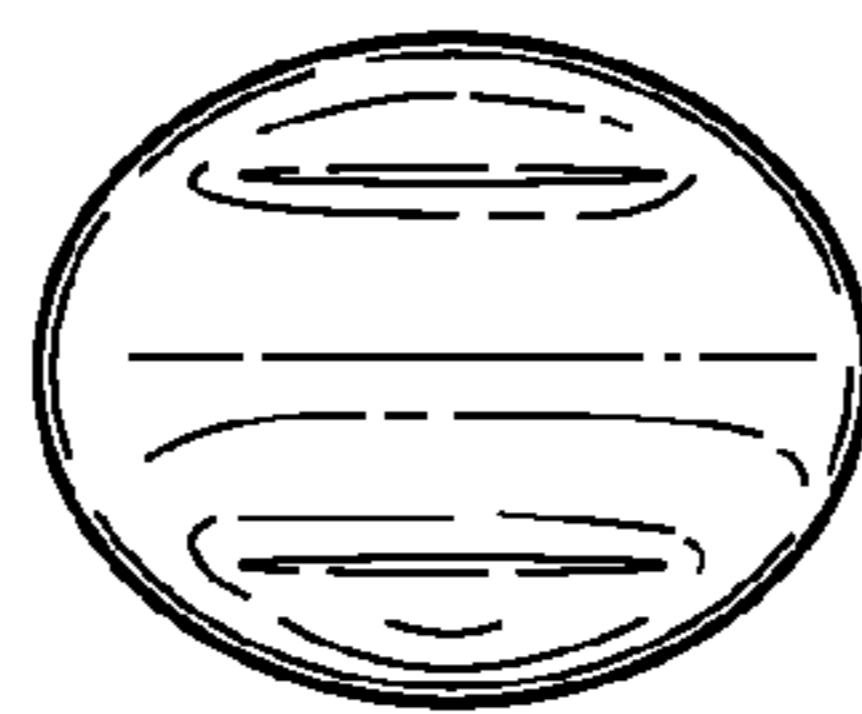
