The ornamental design for a “sock storage rack,” as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the sock storage rack, showing my new design;

FIG. 2 is a rear perspective view of the sock storage rack;

FIG. 3 is a front elevational view thereof;

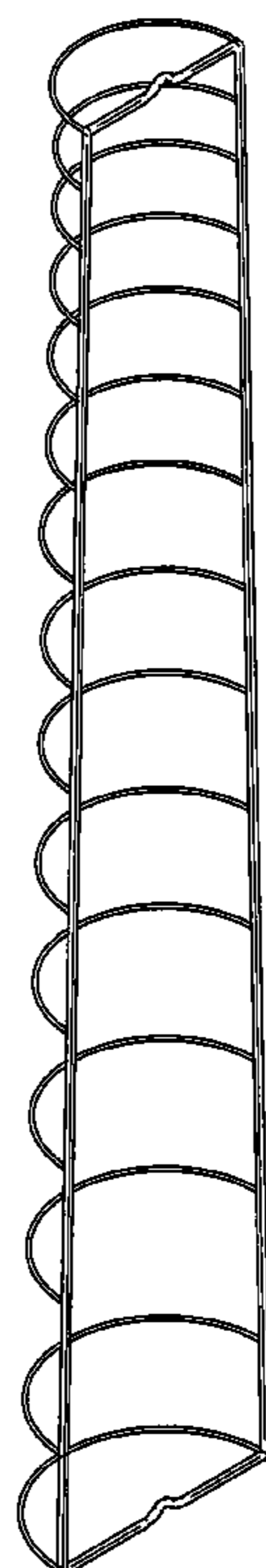
FIG. 4 is a rear elevational view thereof;

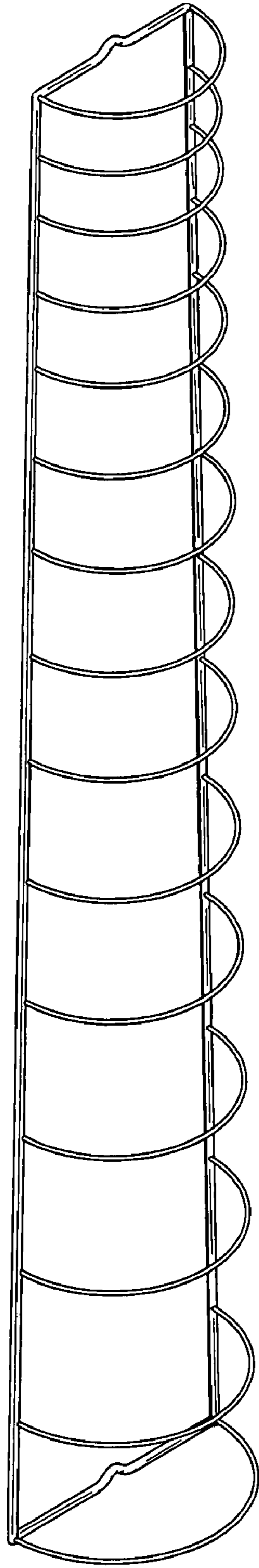

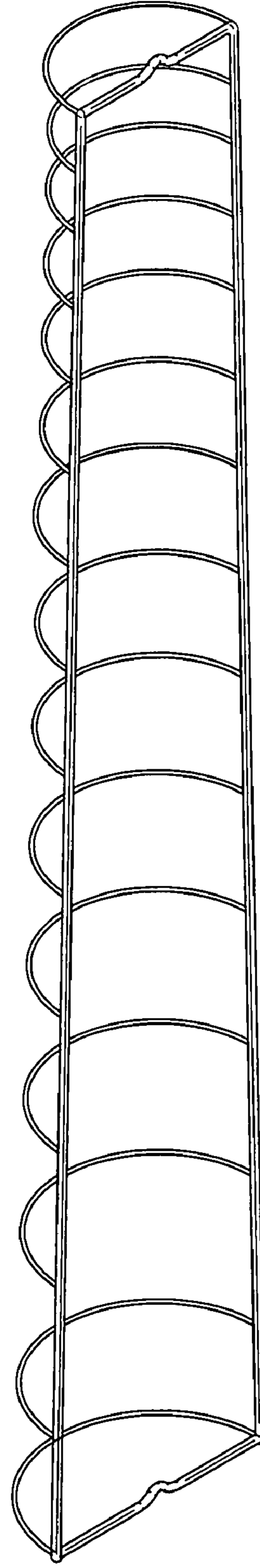

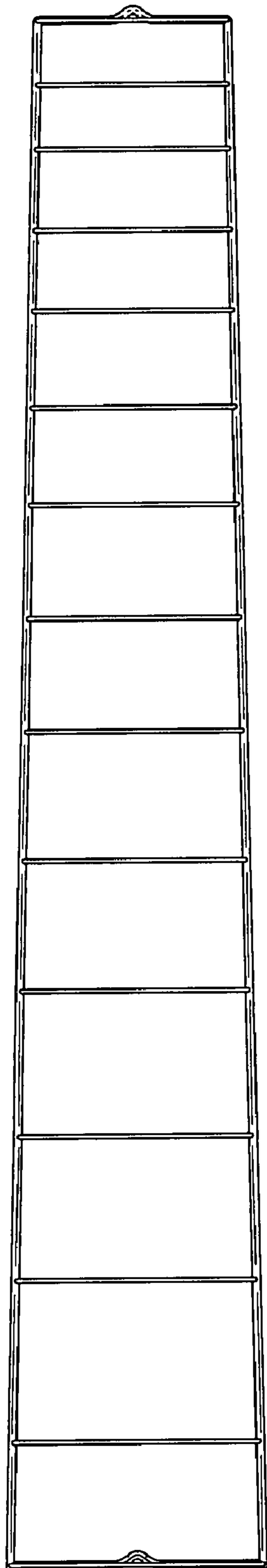

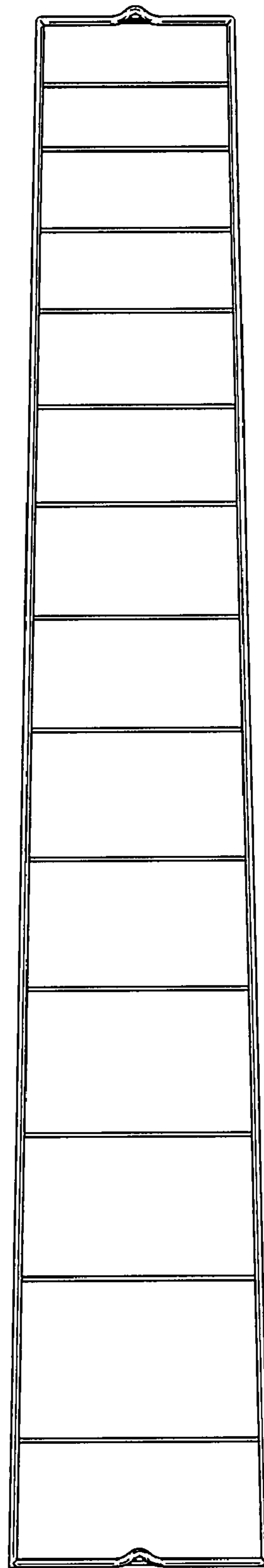

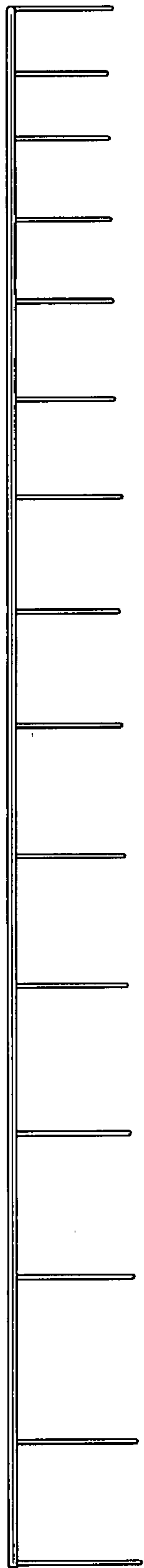

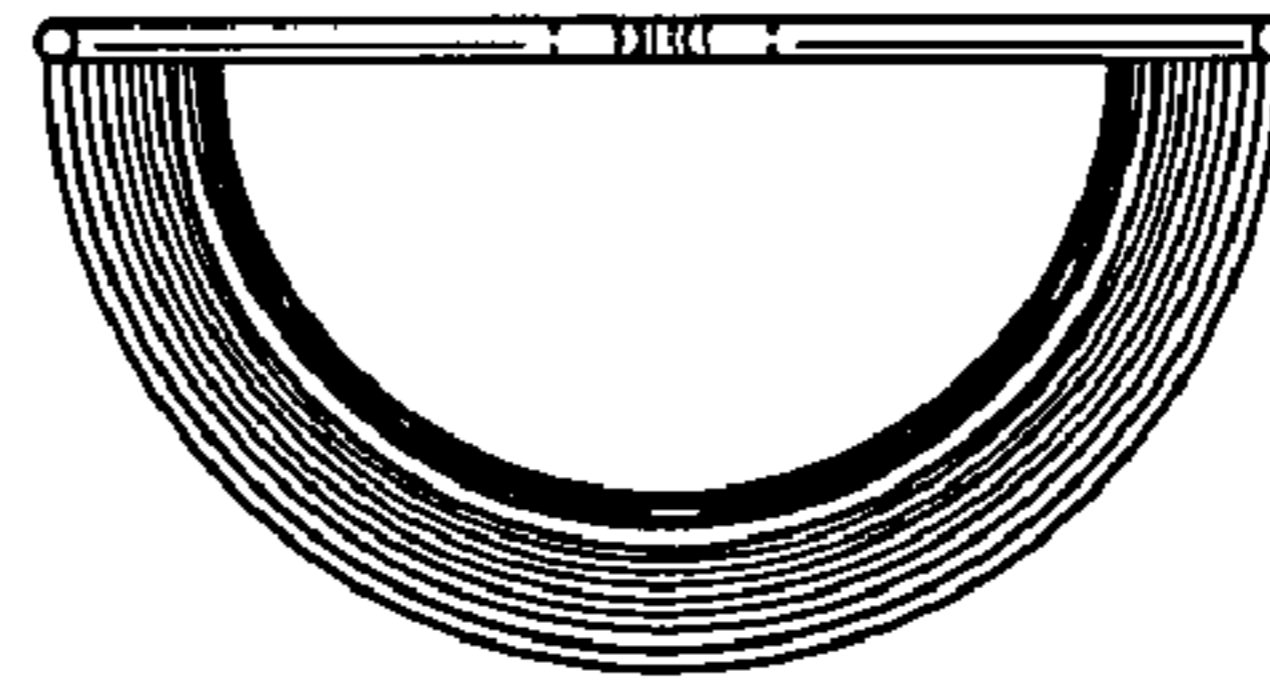

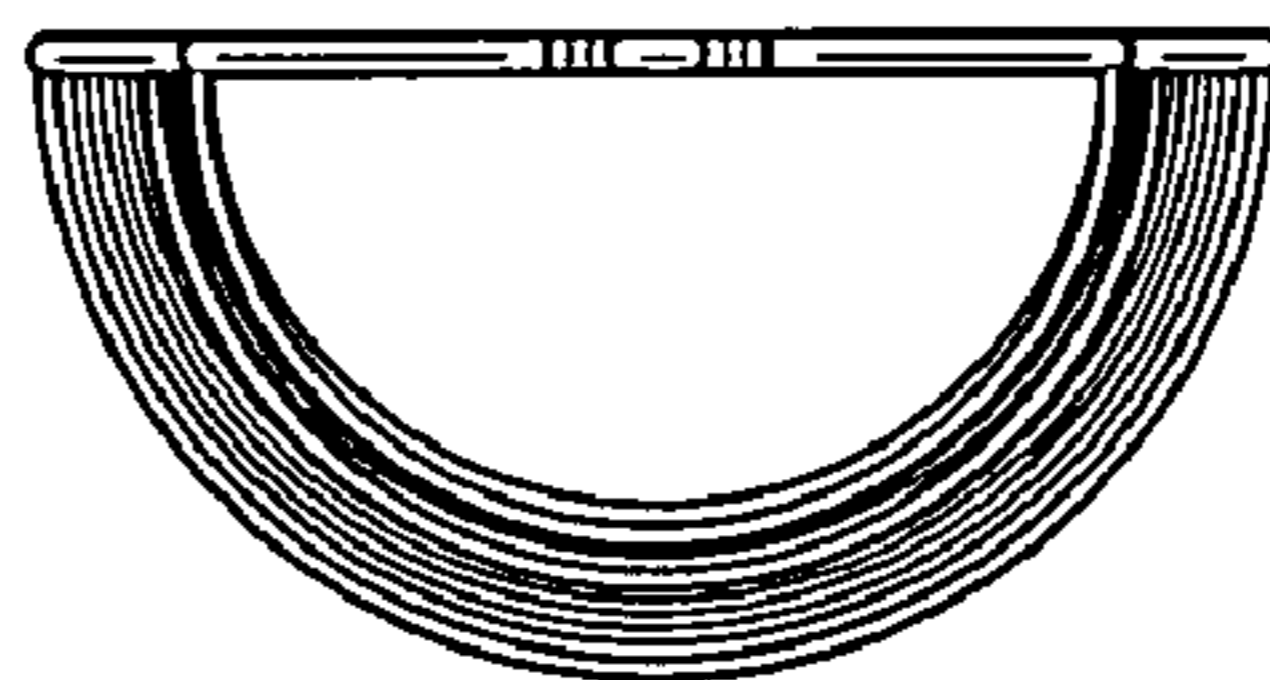
