FIG. 2 is a front elevation view thereof, the rear elevation view being identical thereto;

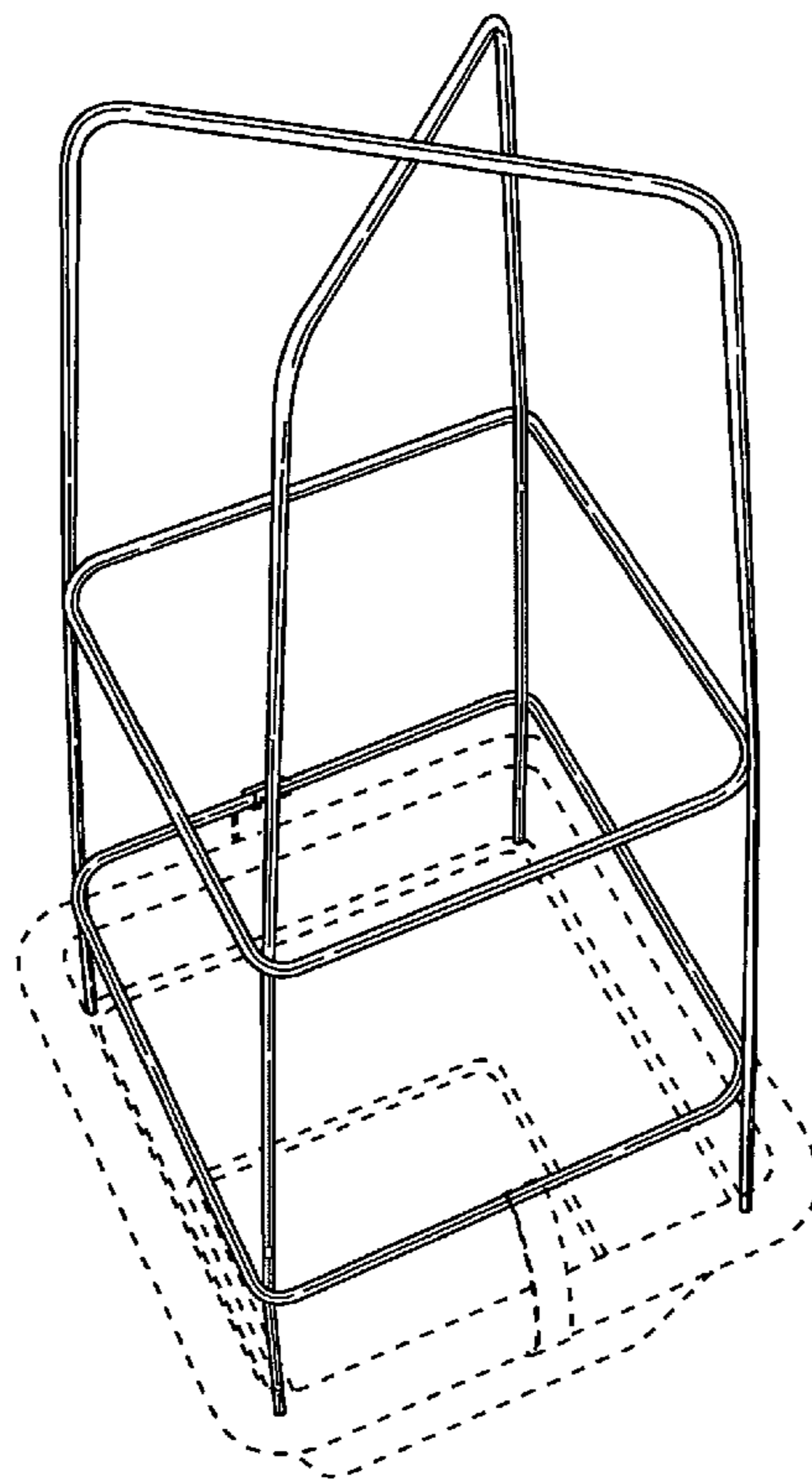
FIG. 3 is a right side elevation view thereof, the left side elevation view being identical thereto;

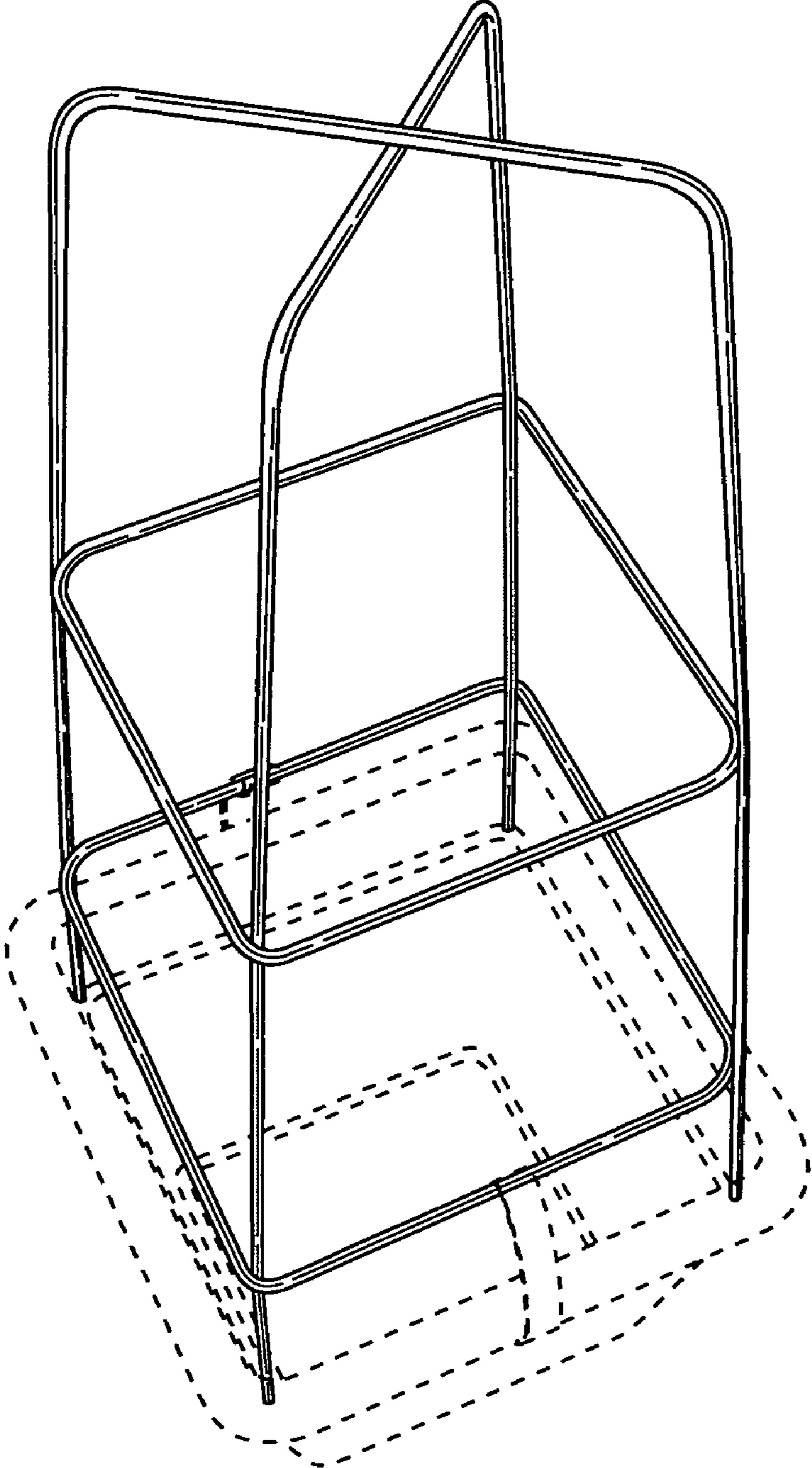

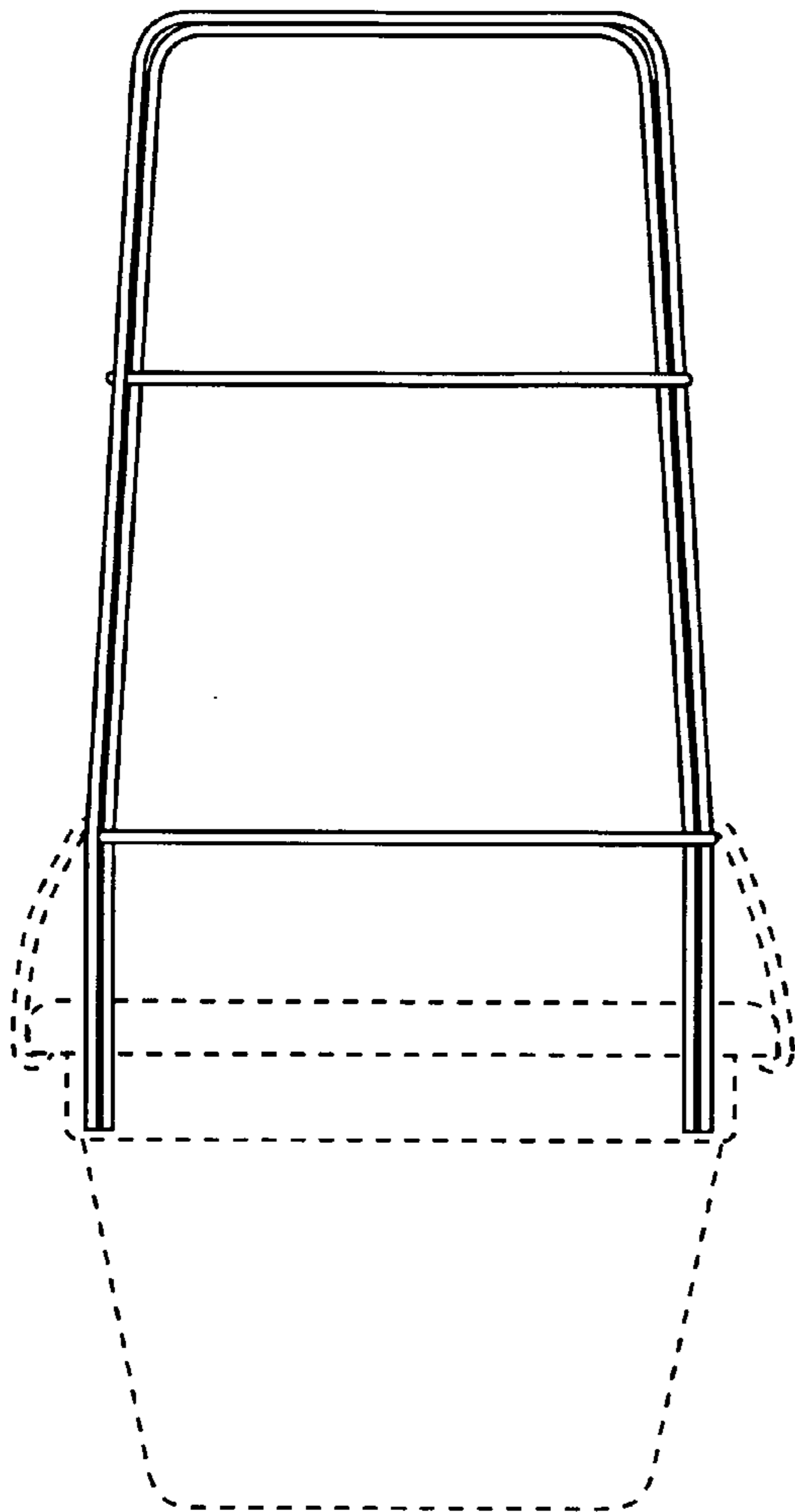

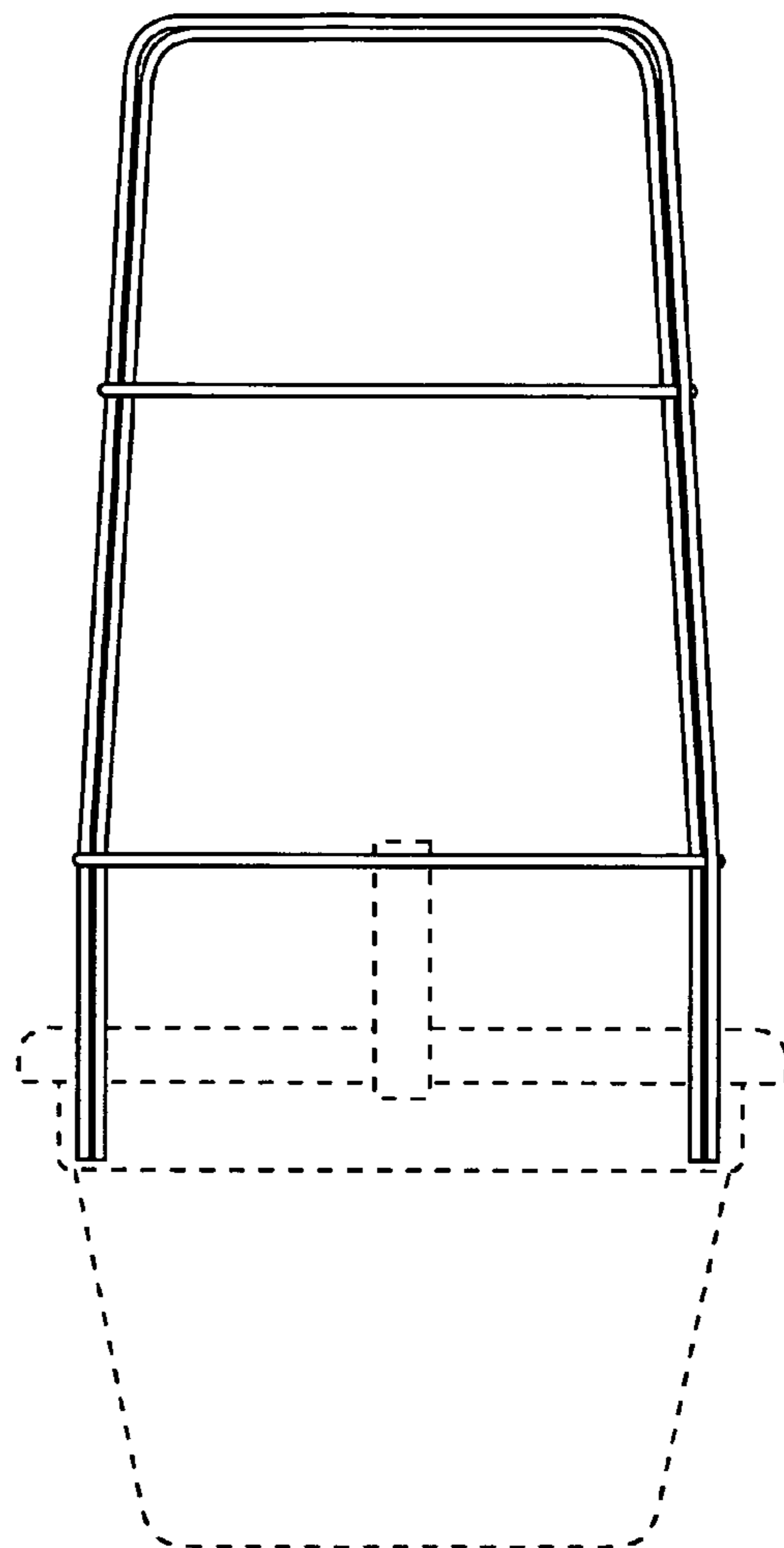

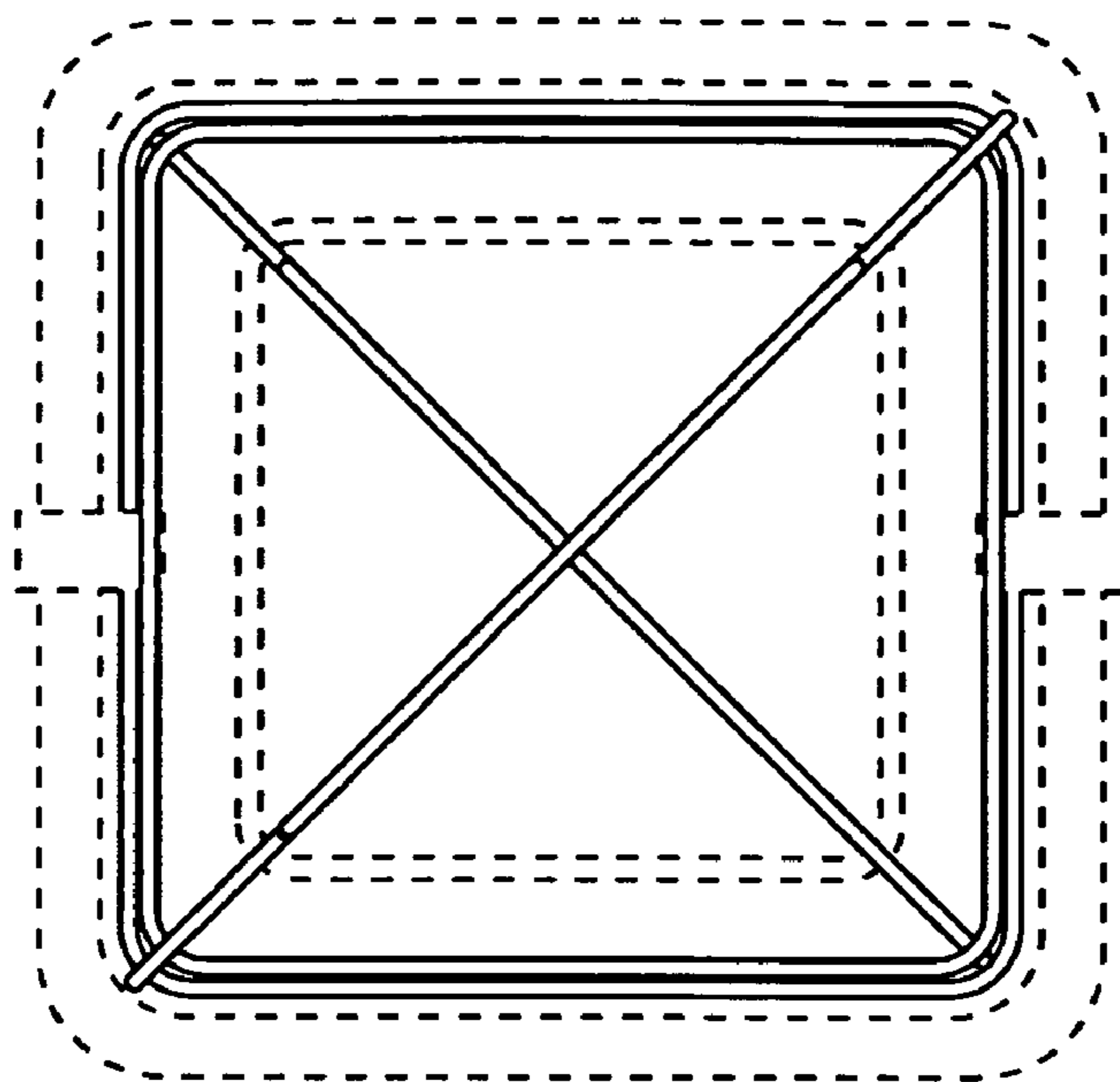

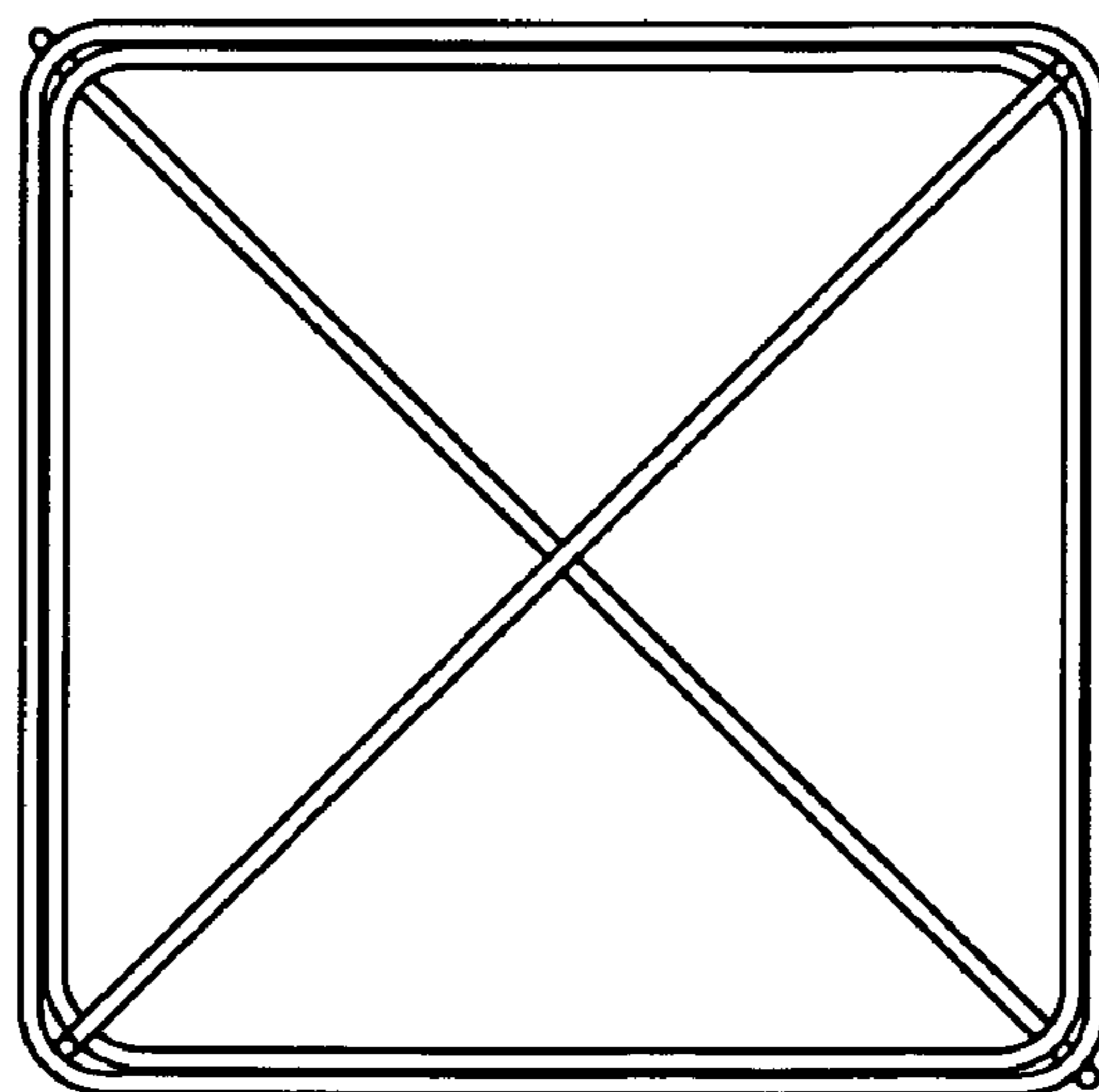
