FIG. 2 is a front view of a chair arm embodying our design; FIG. 3 is a left side view of a chair arm embodying our design;

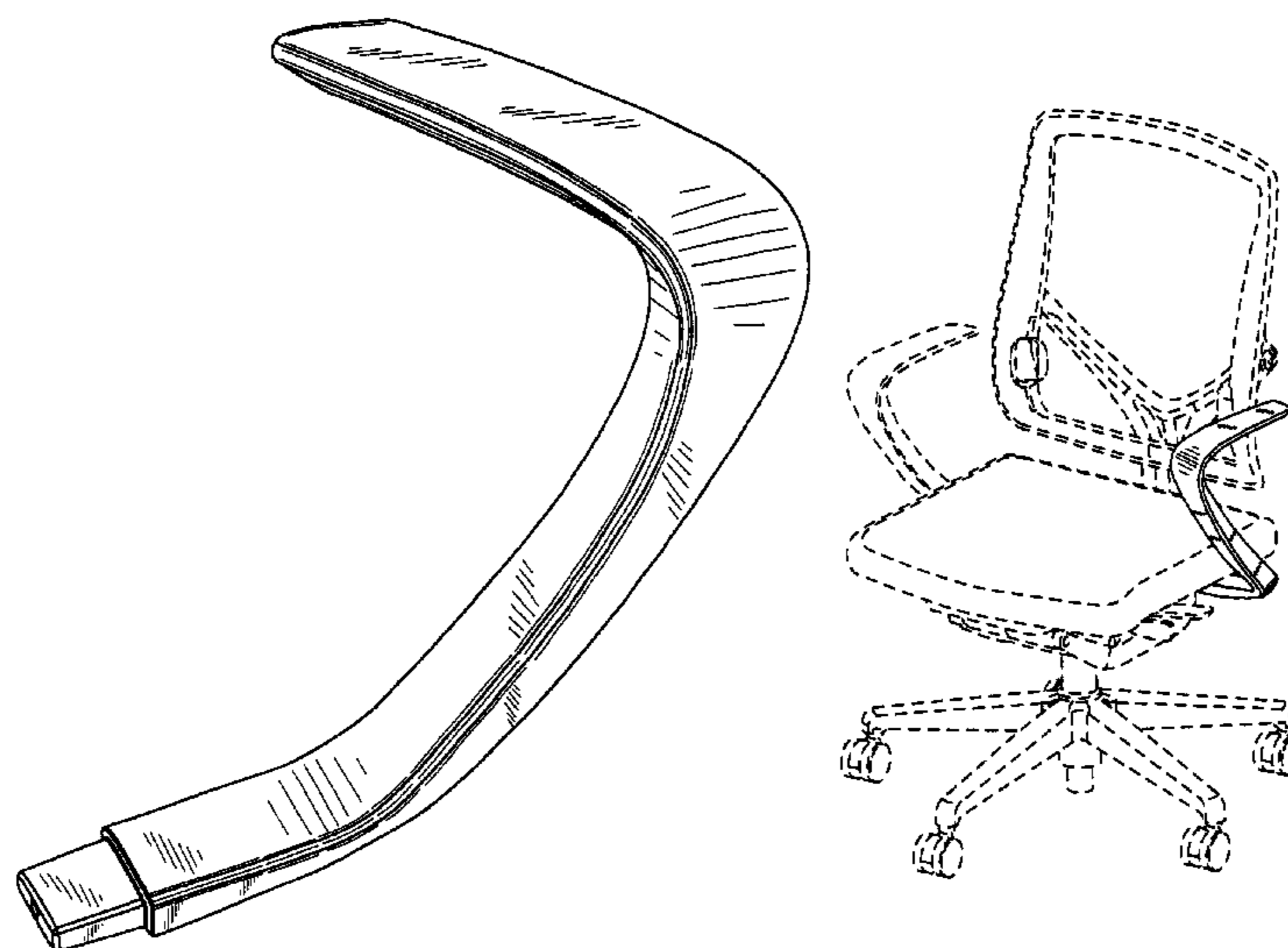
FIG. 4 is a rear view of a chair arm embodying our design; FIG. 5 is a right side view of a chair arm embodying our design;

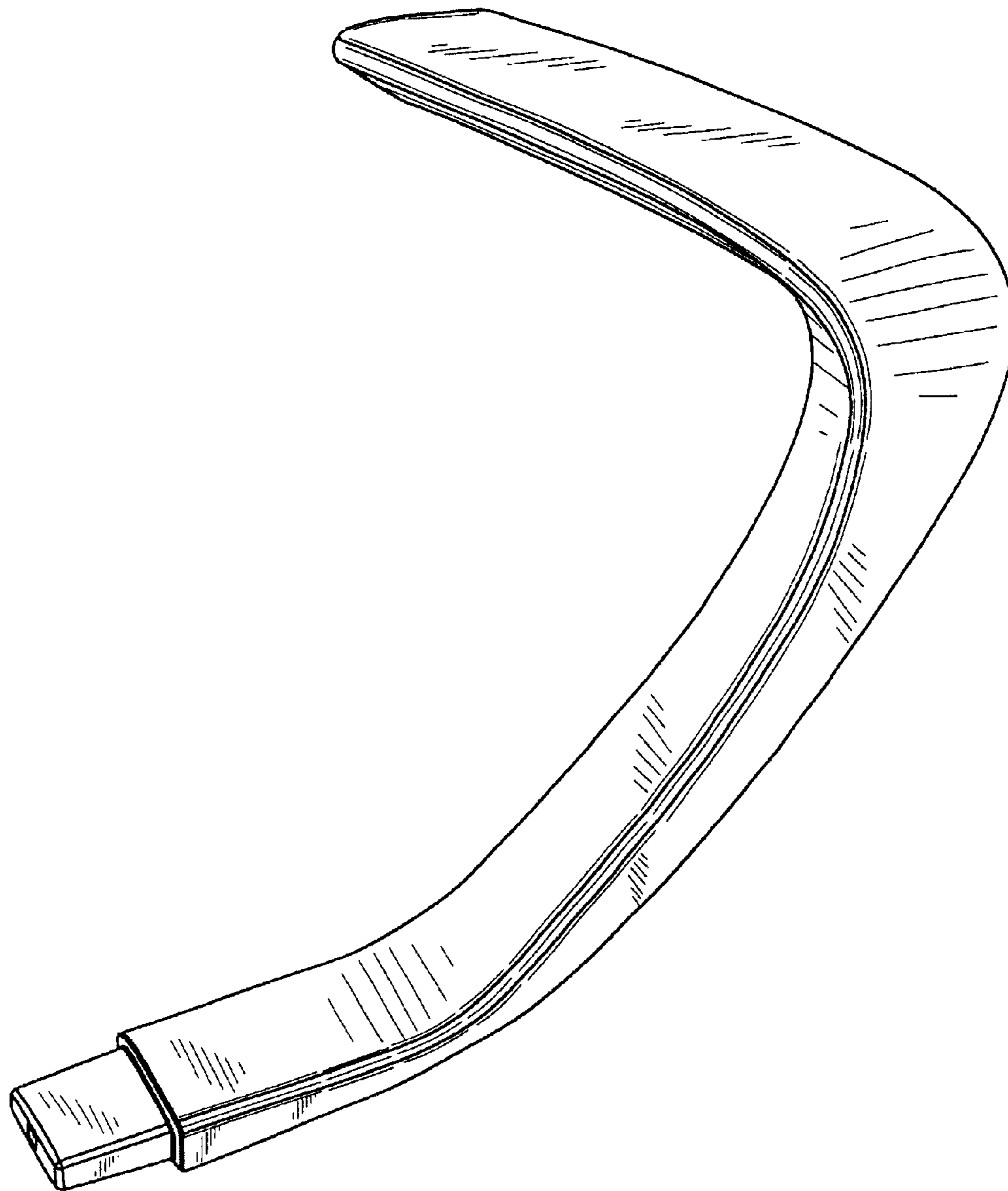

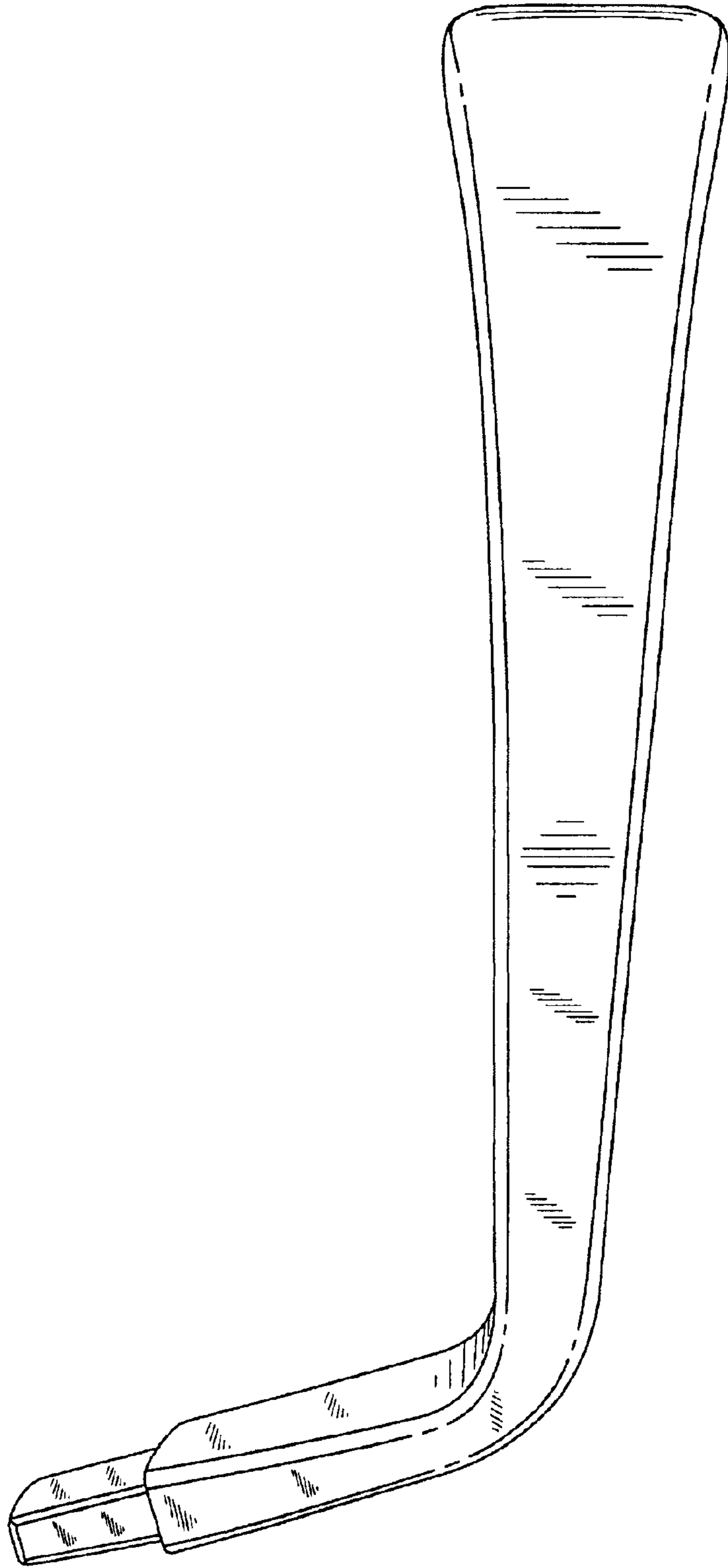

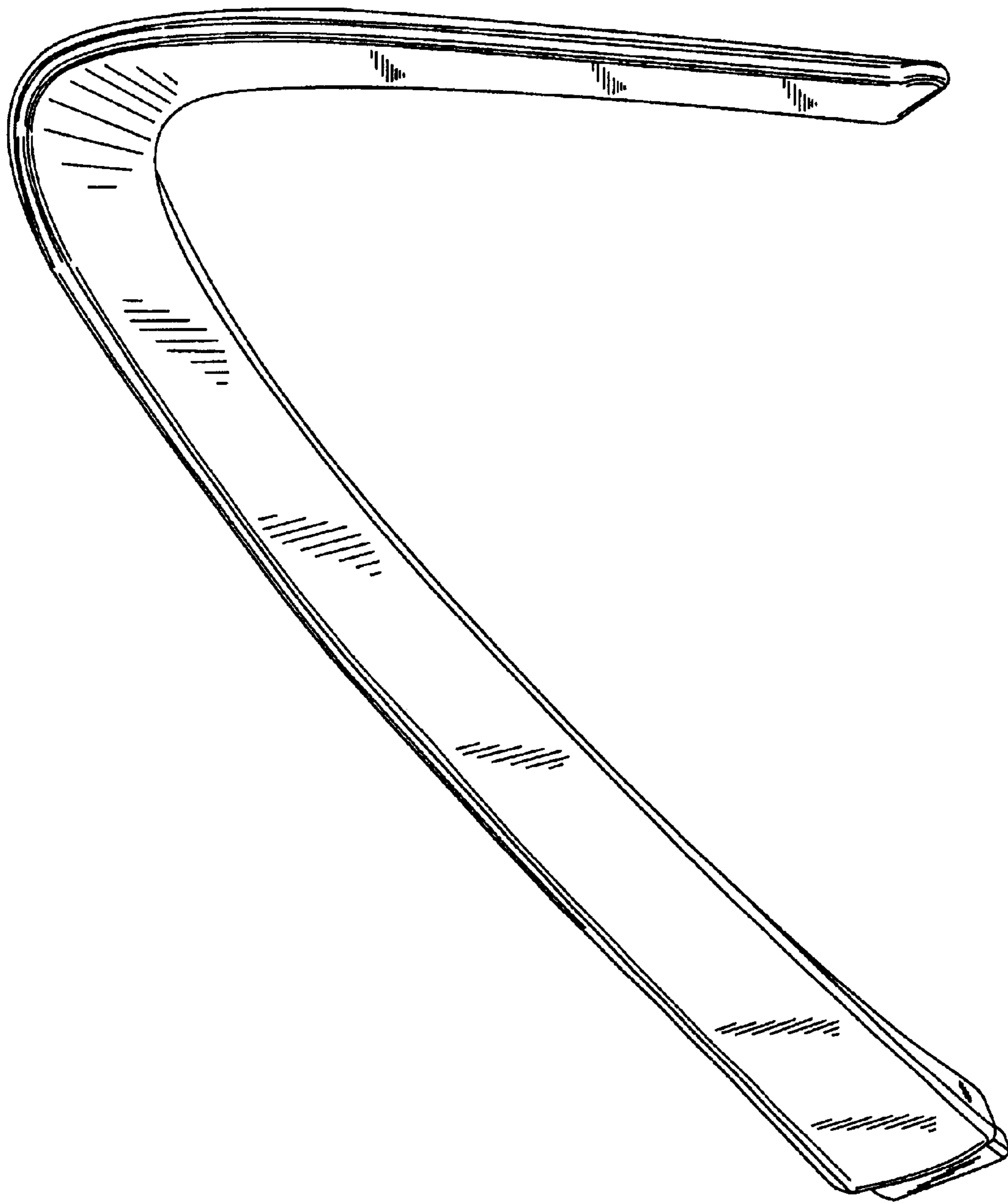

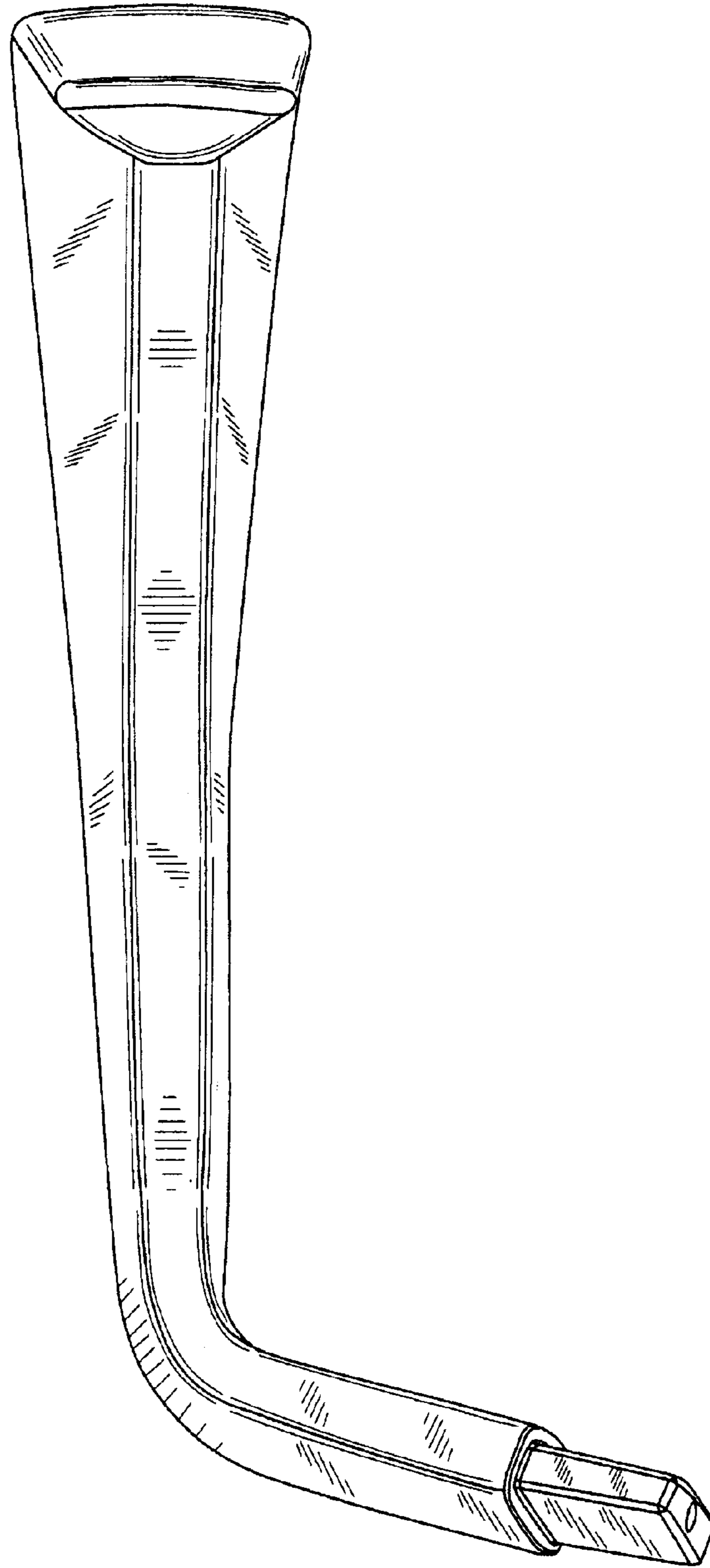

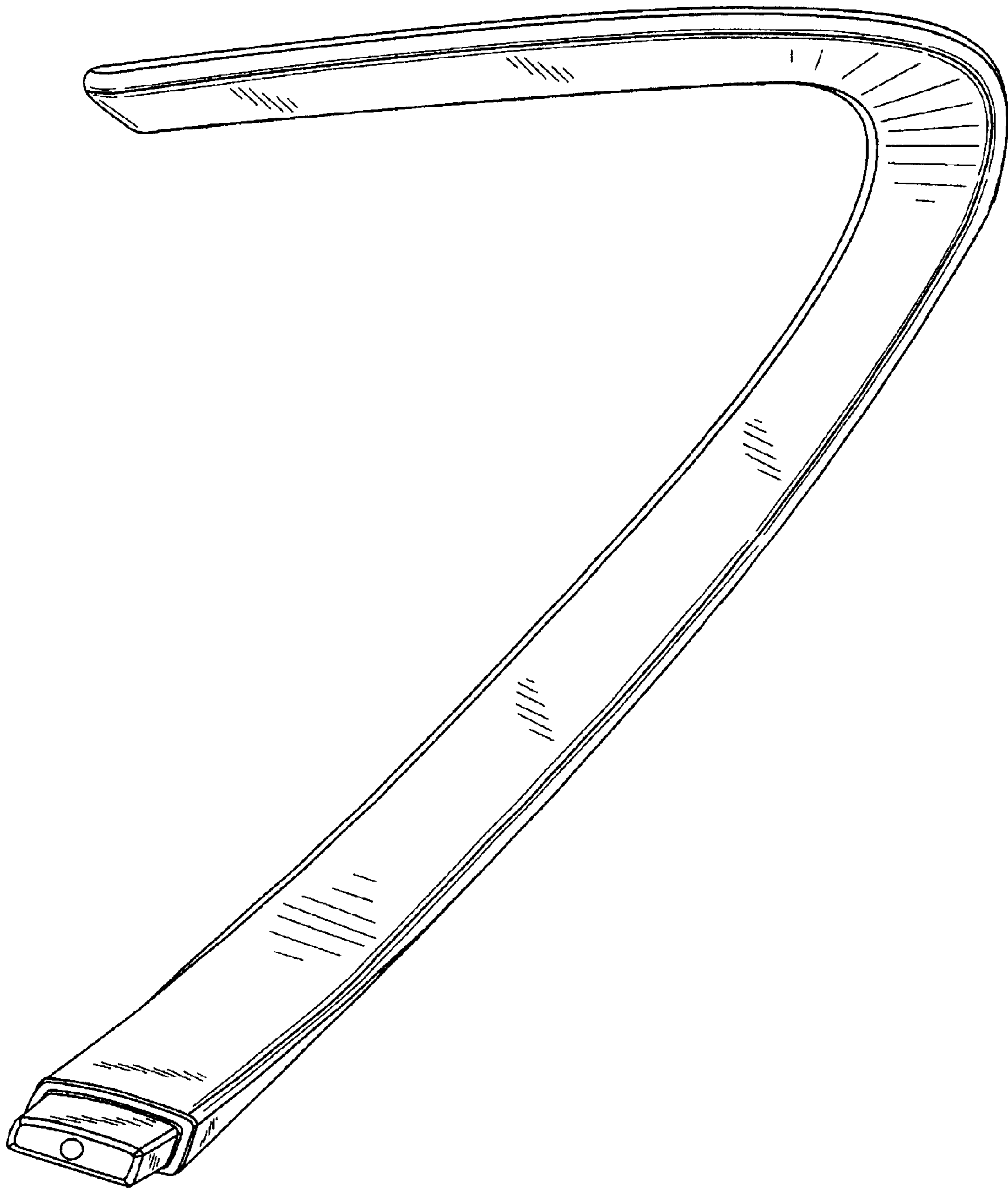

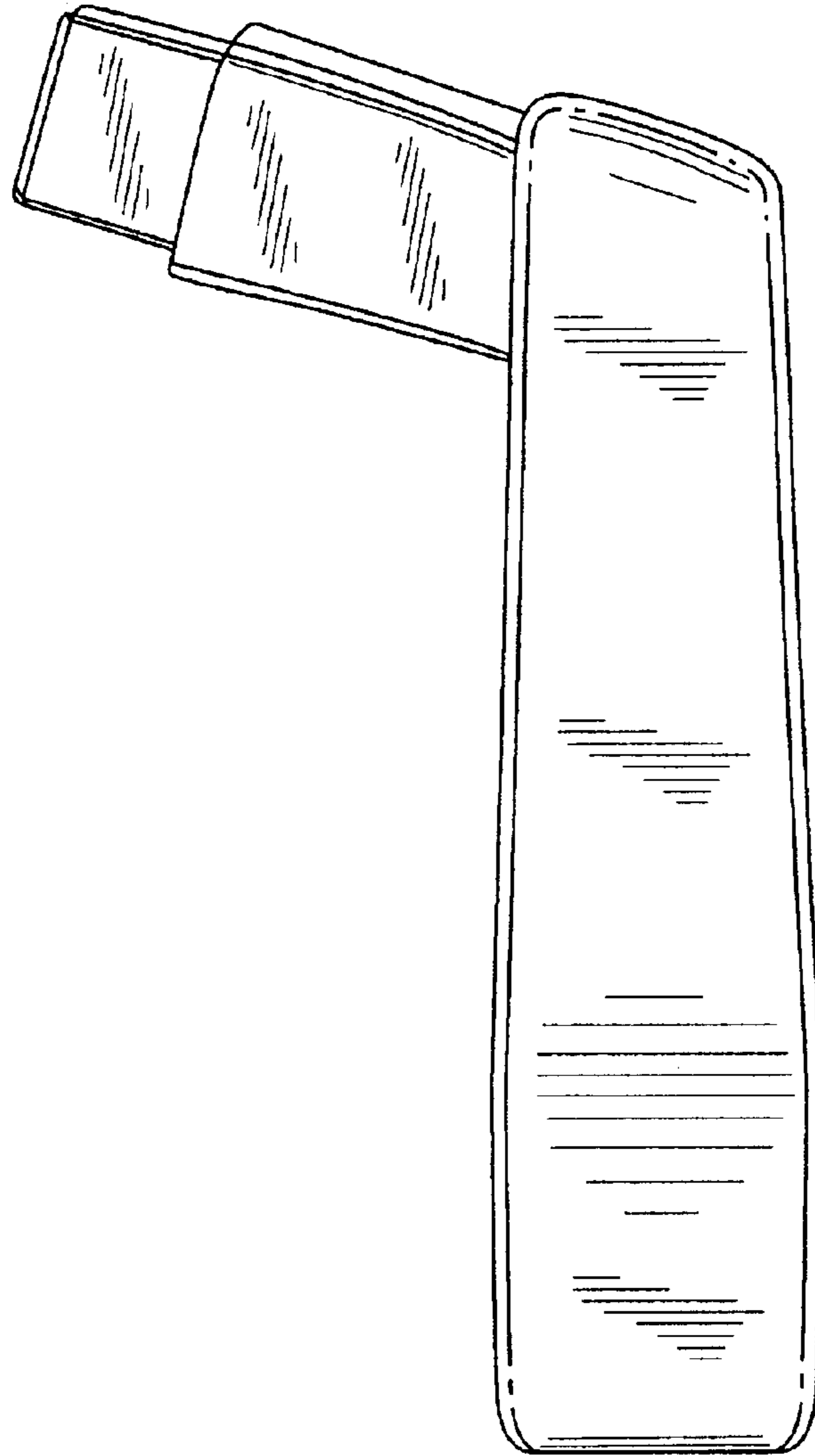

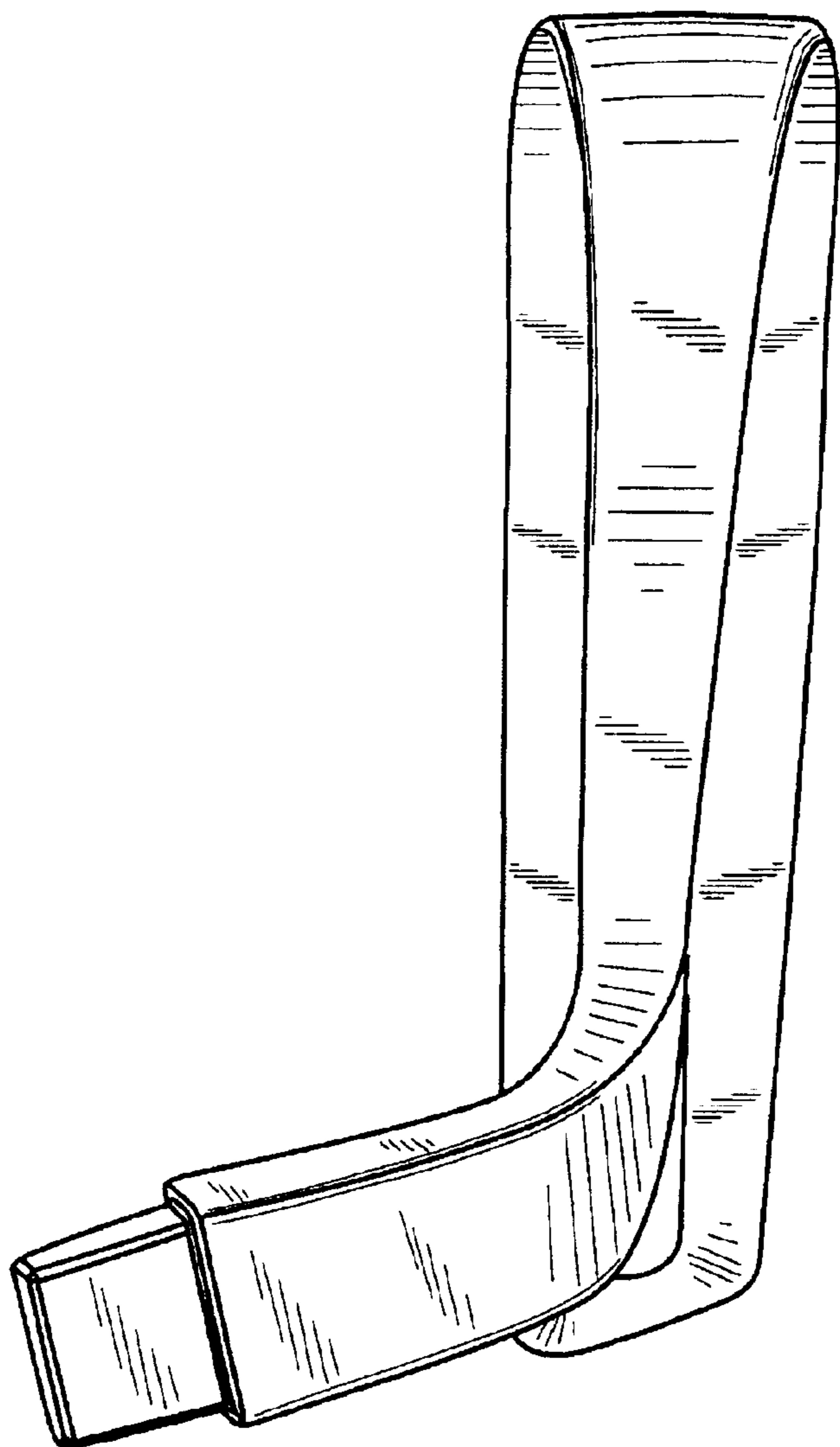

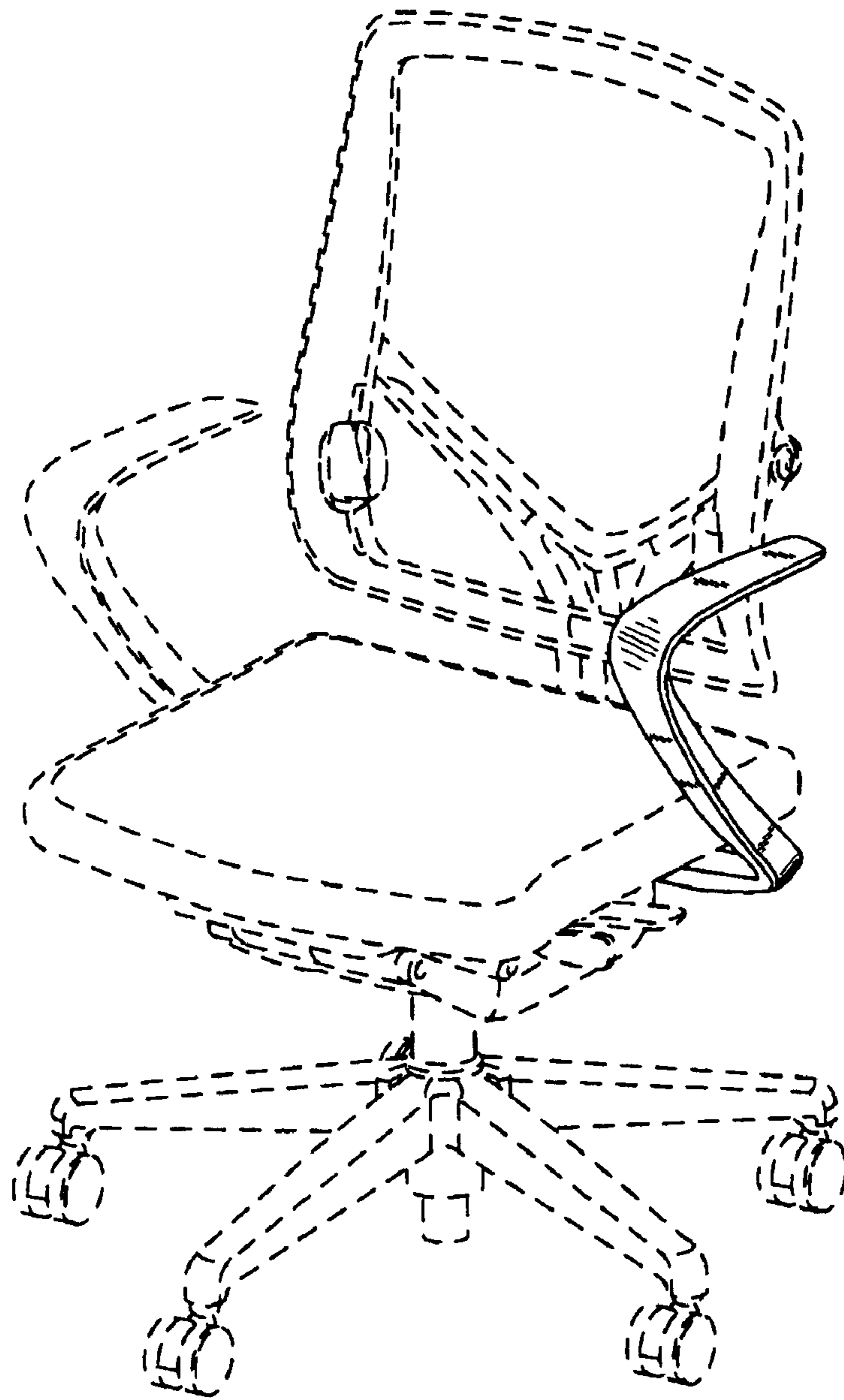
