FIG. 1 is a side view of the drawer knob in accordance with the present invention.

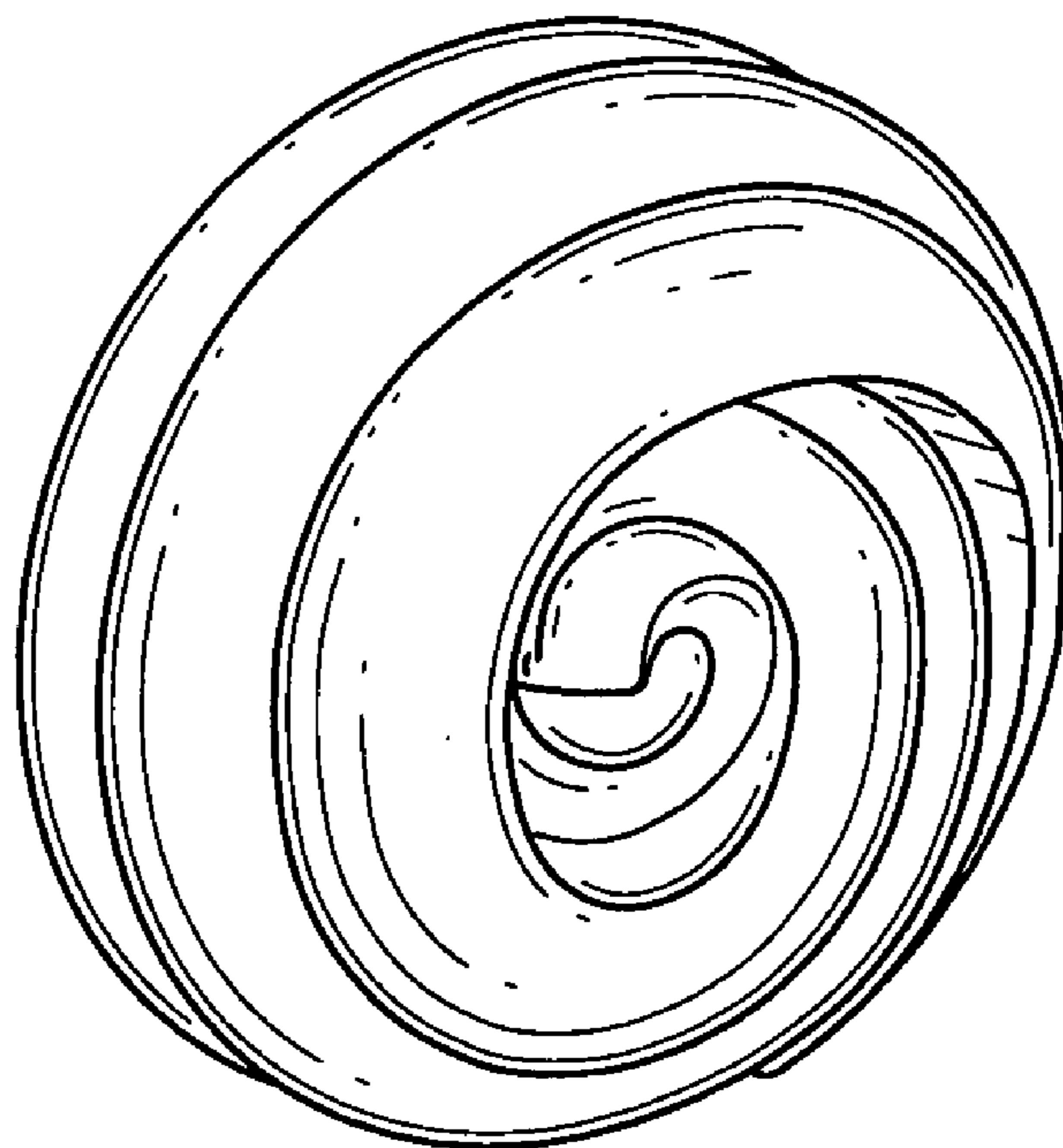
FIG. 2 is a back view of the drawer knob in accordance with the present invention.

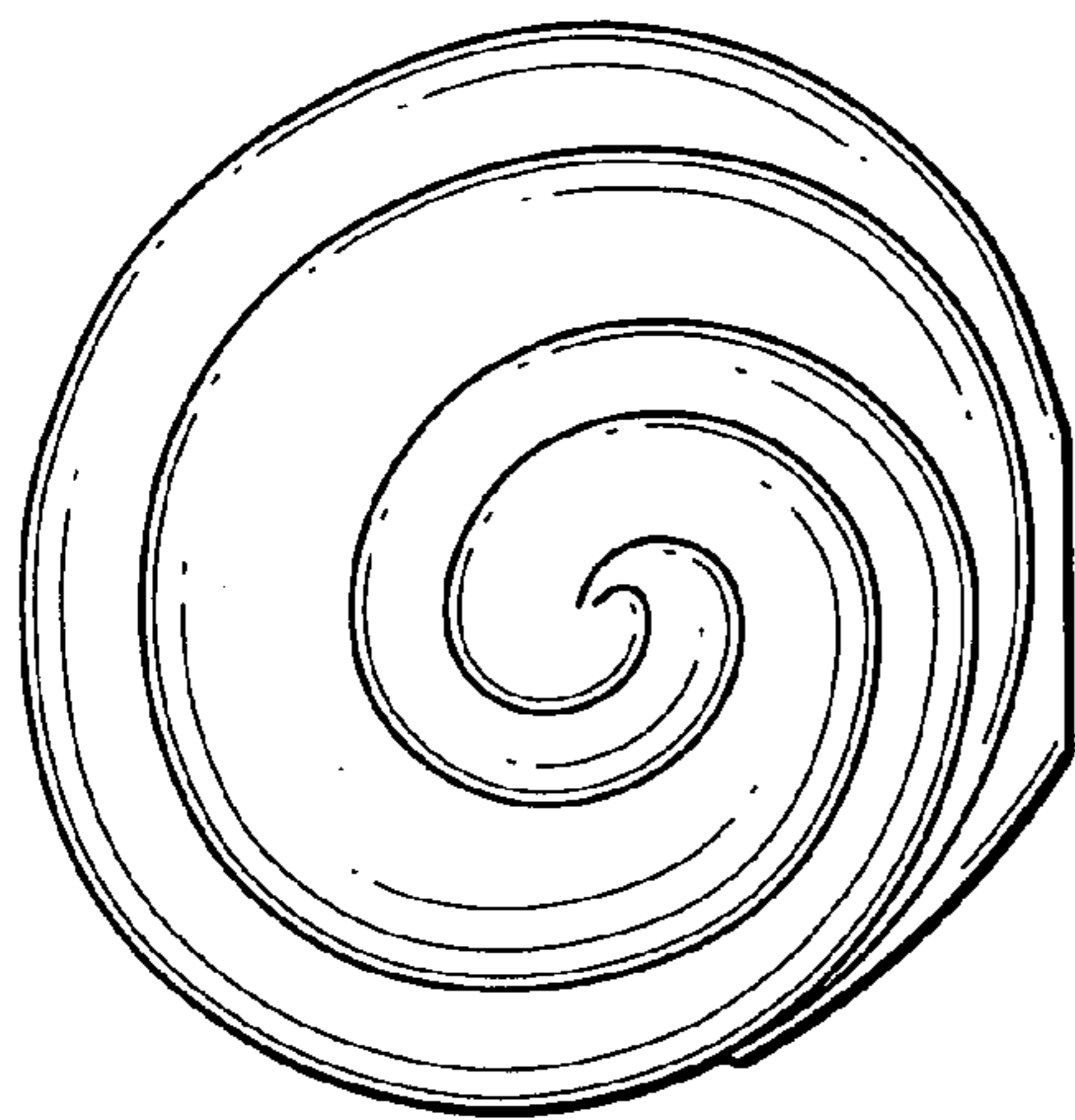
FIG. 3 is a front view of the drawer knob in accordance with the present invention; and,

FIG. 4 is an isometric view of the drawer knob in accordance with the present invention.

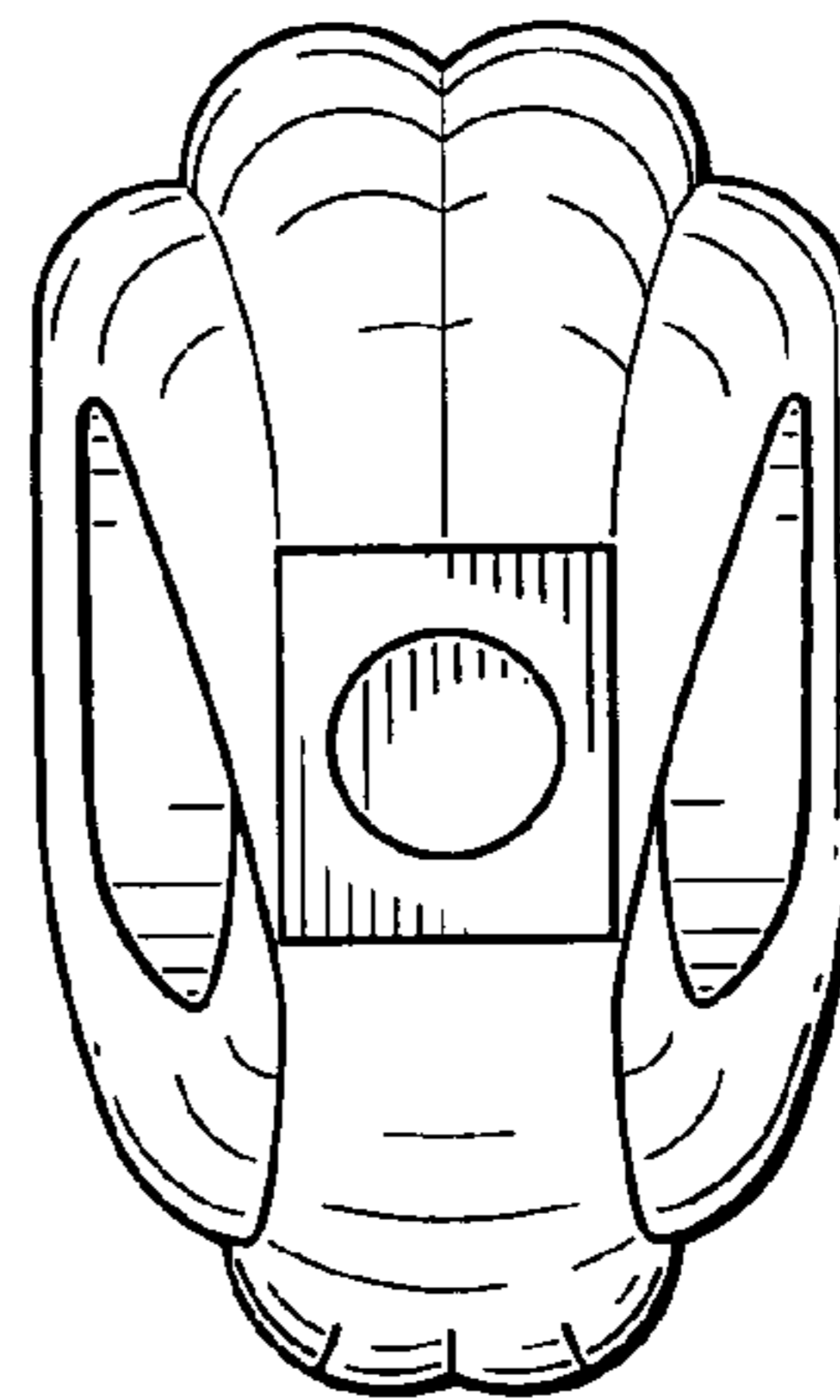

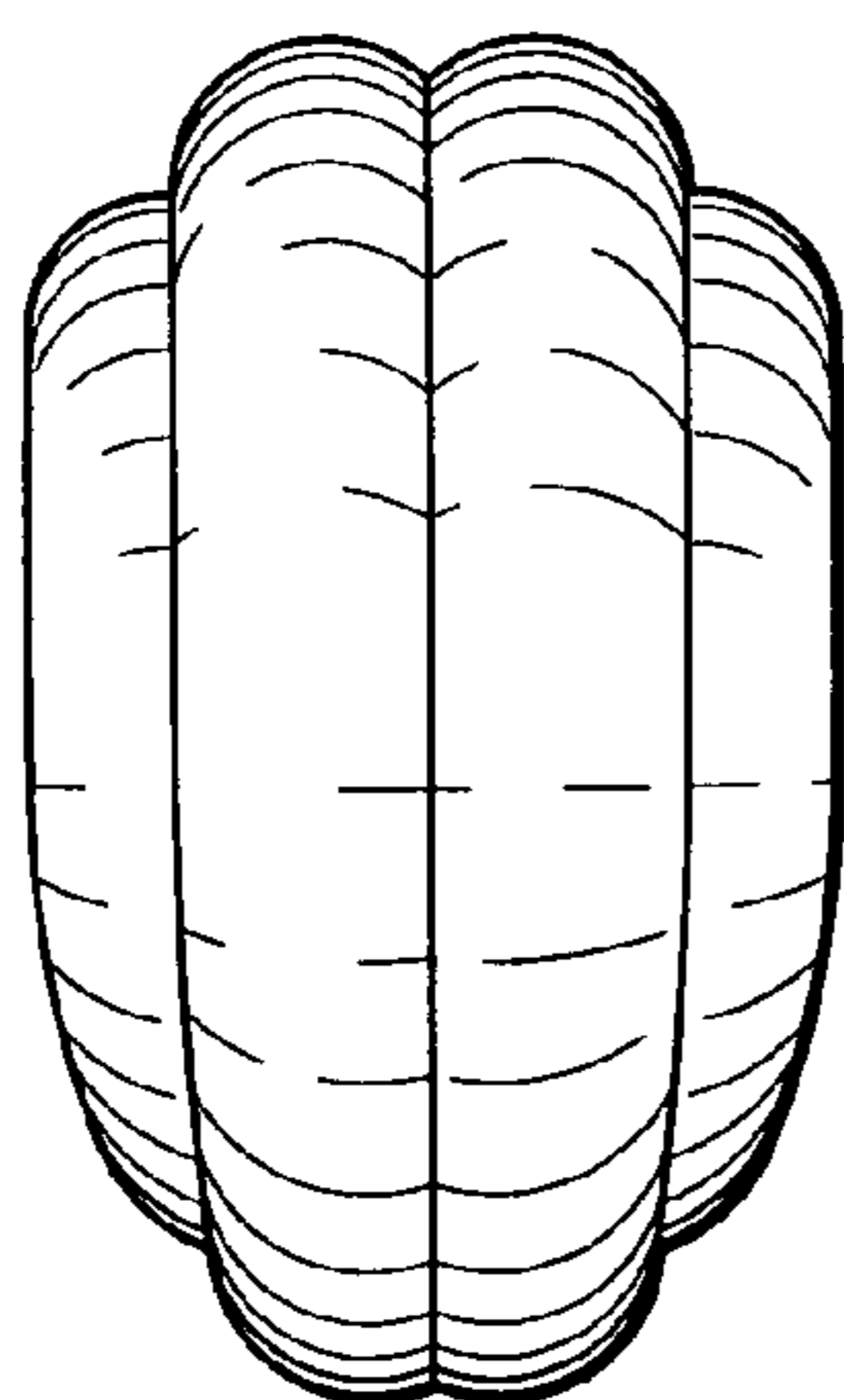




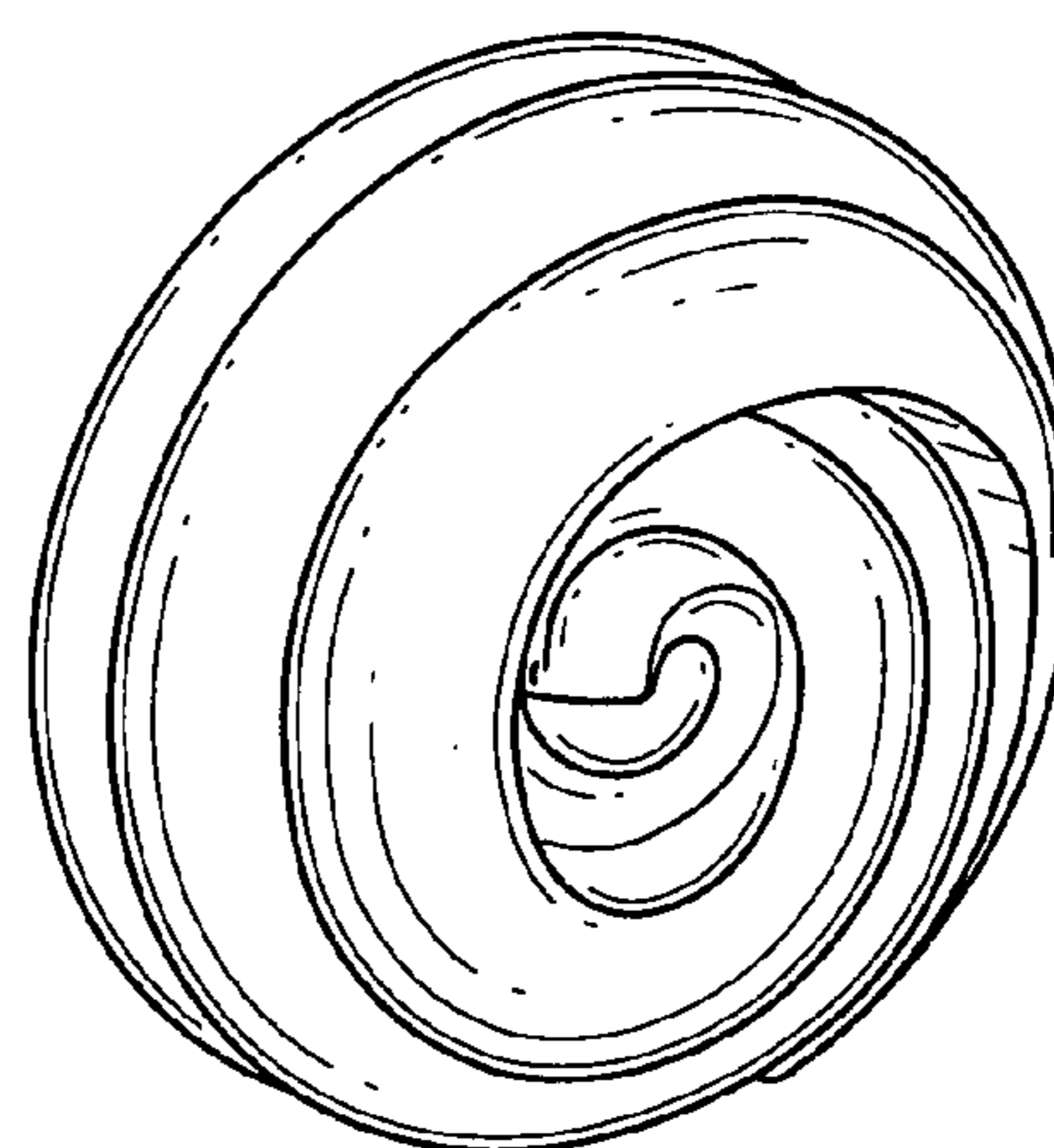
