DESCRIPTION

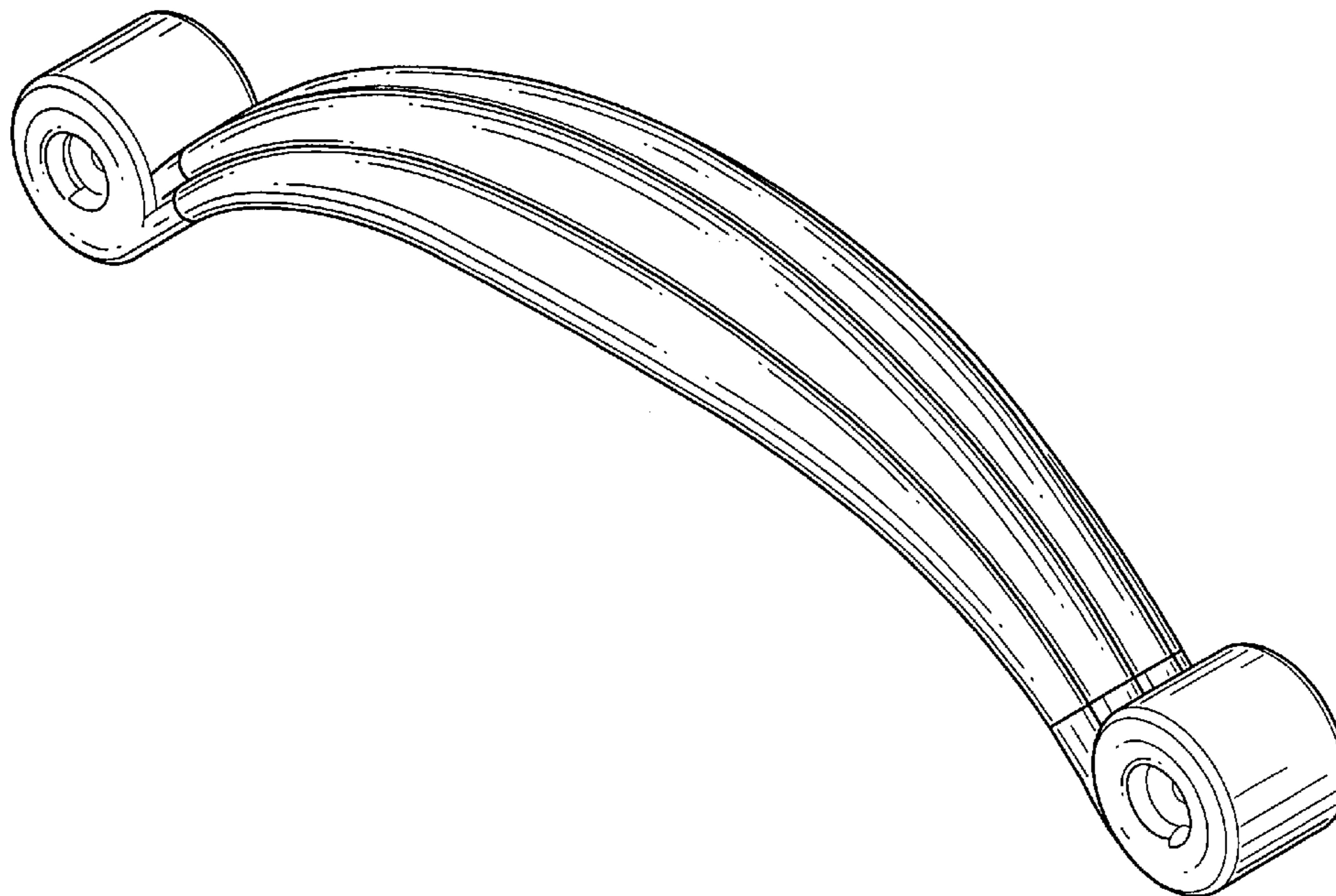

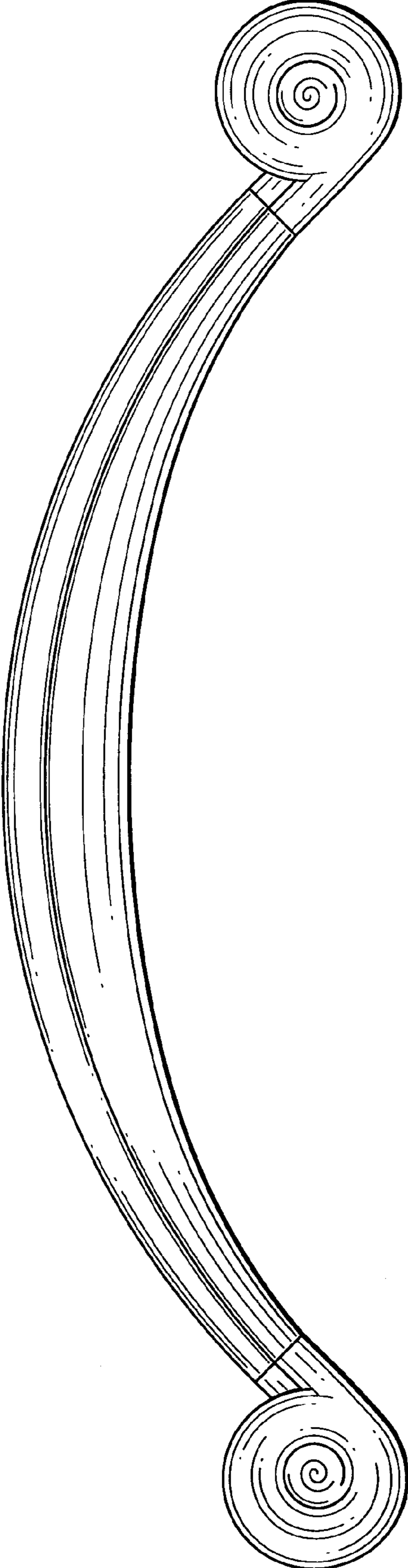
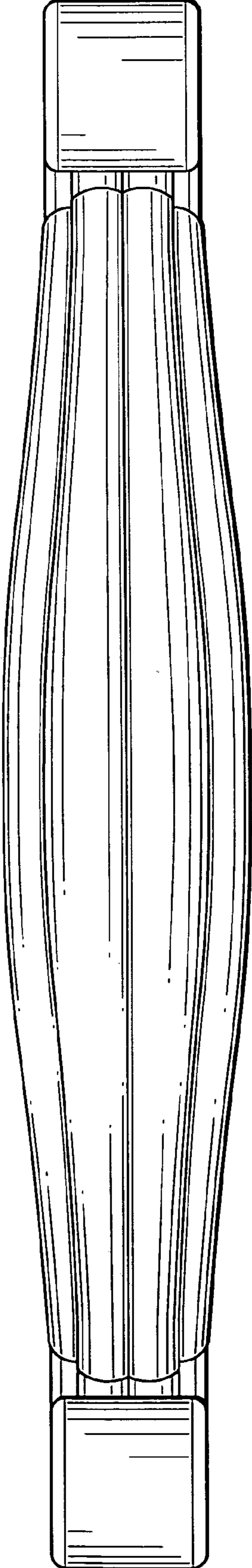

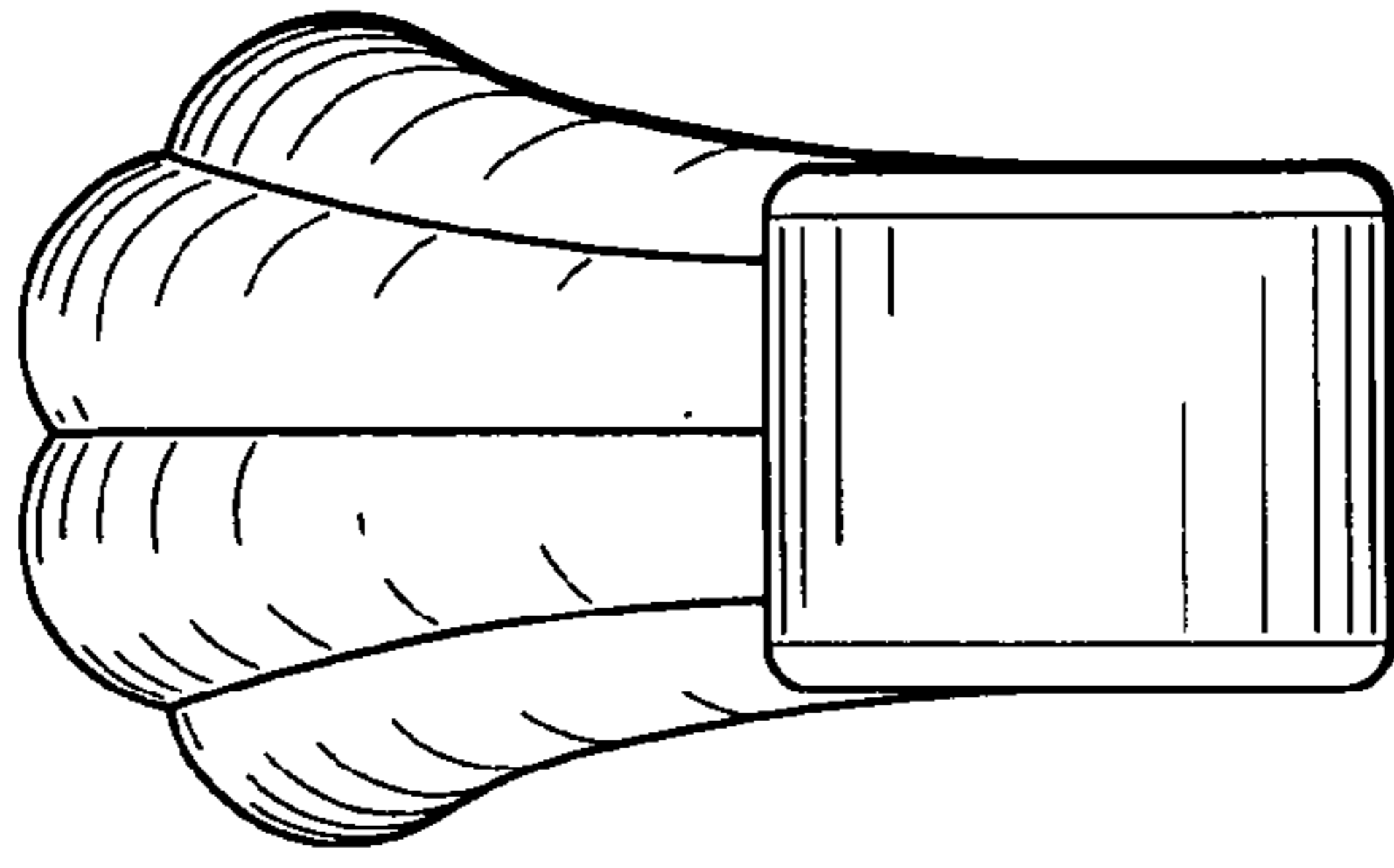

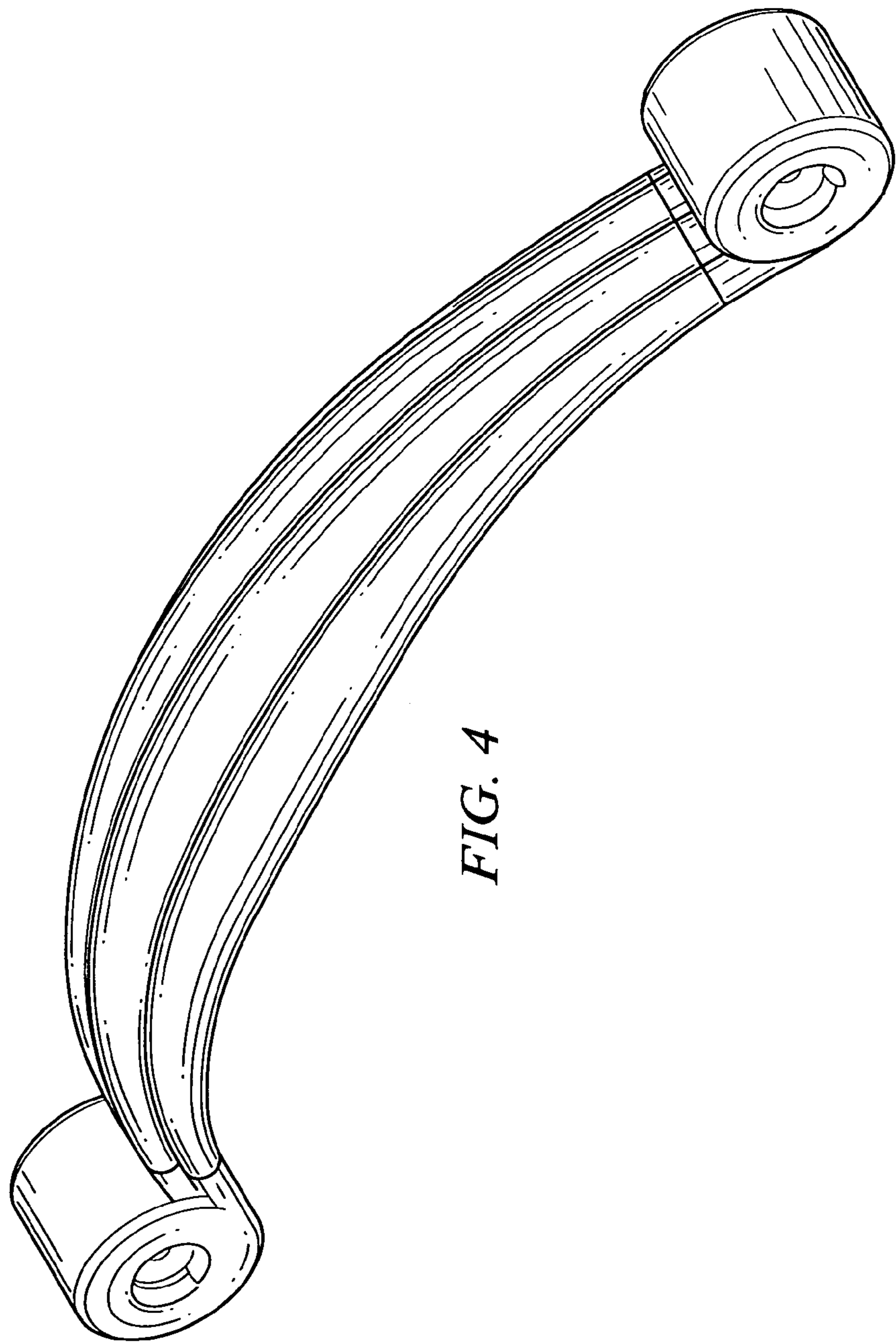
