FIG. 2 is a front perspective view of FIG. 1 shown in an alternate position;

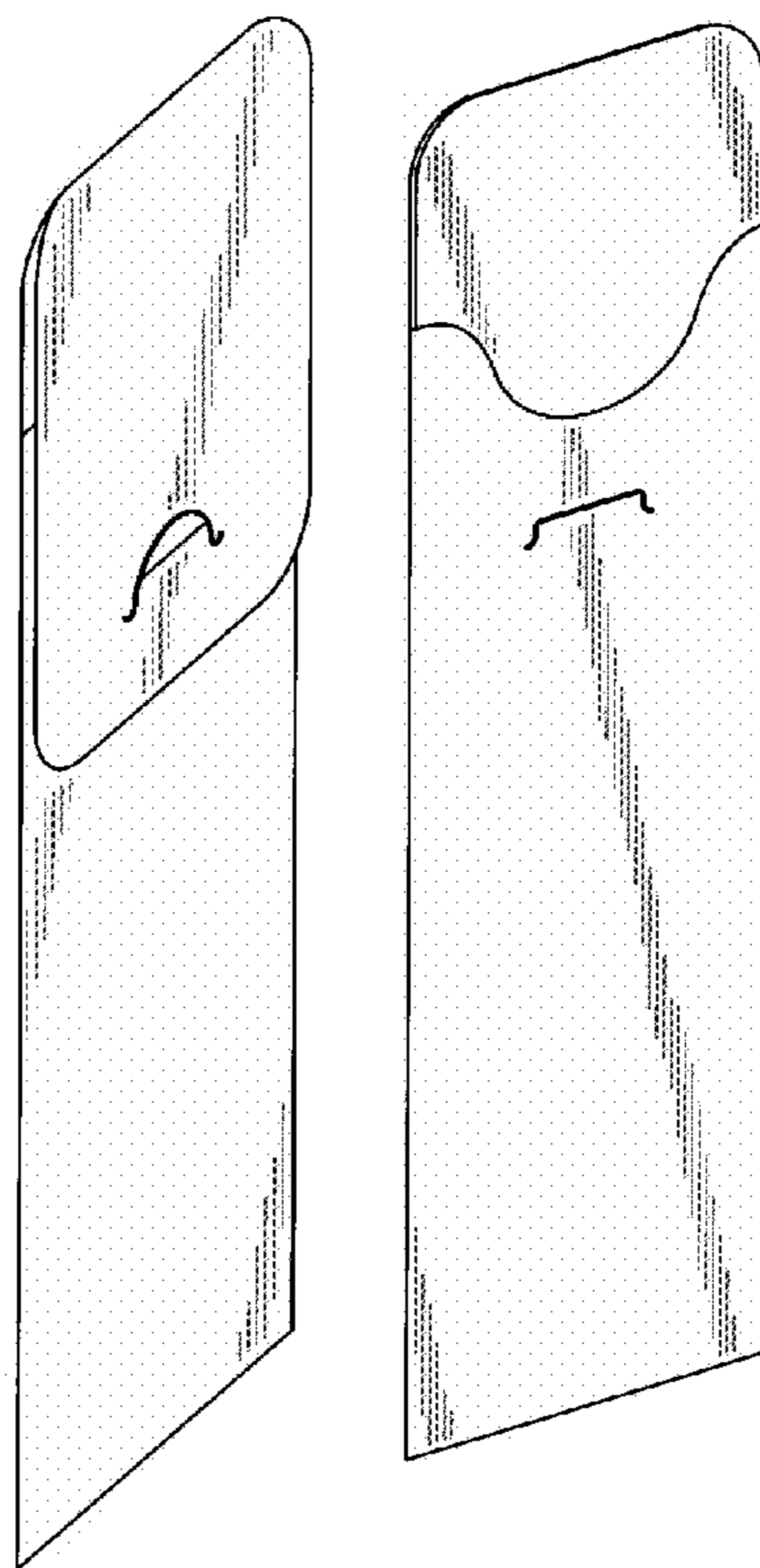
FIG. 3 is a front perspective view of FIG. 2 shown in condition of use;

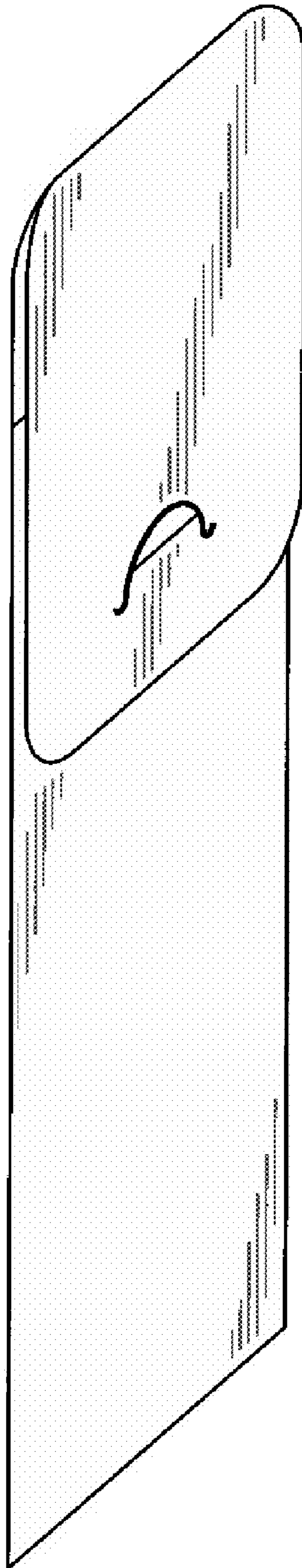
FIG. 4 is a front view of FIG. 1 shown in an open position; and,

FIG. 5 is a rear view of FIG. 4.

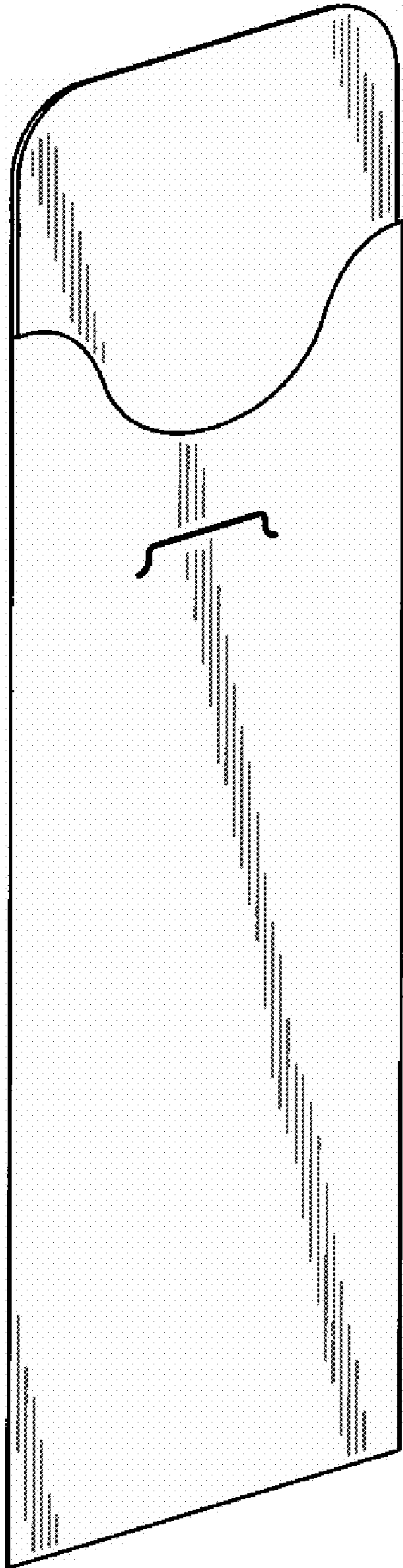

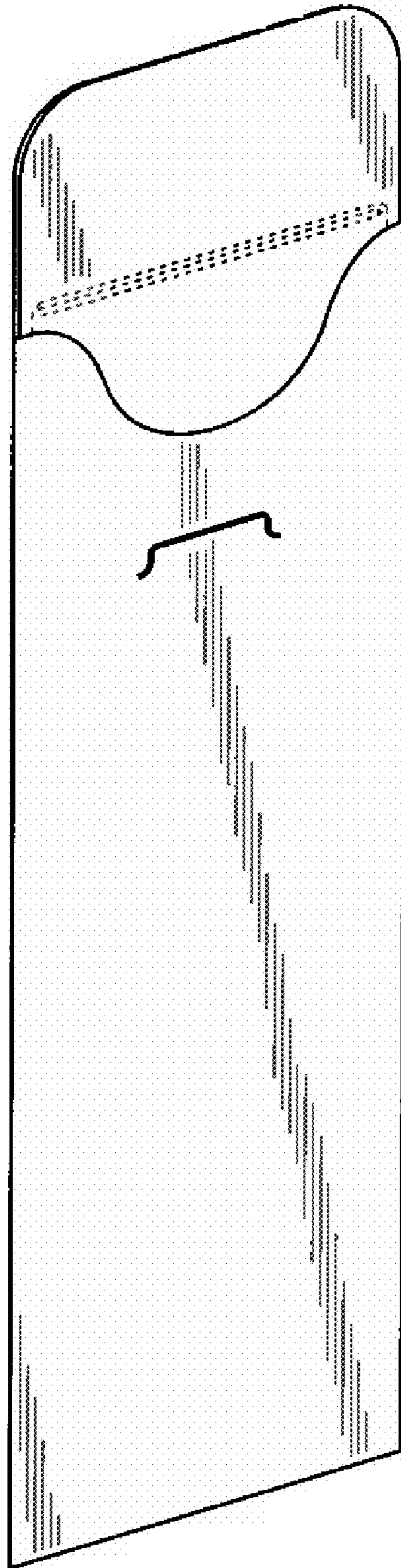




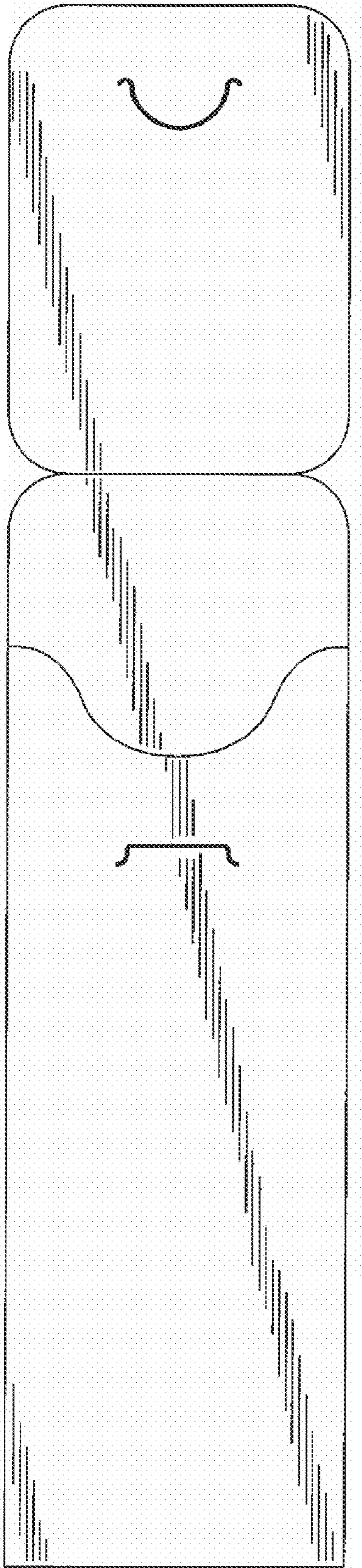

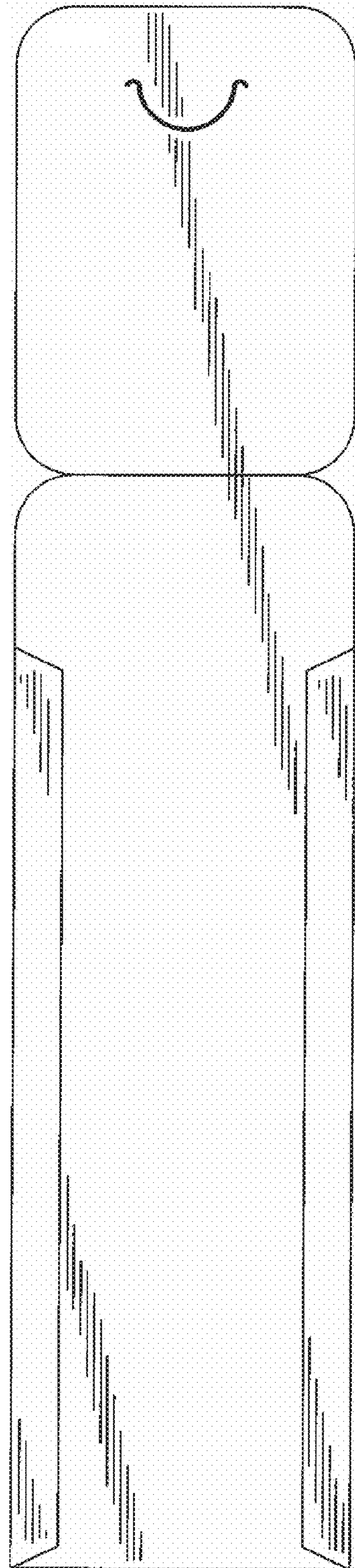
